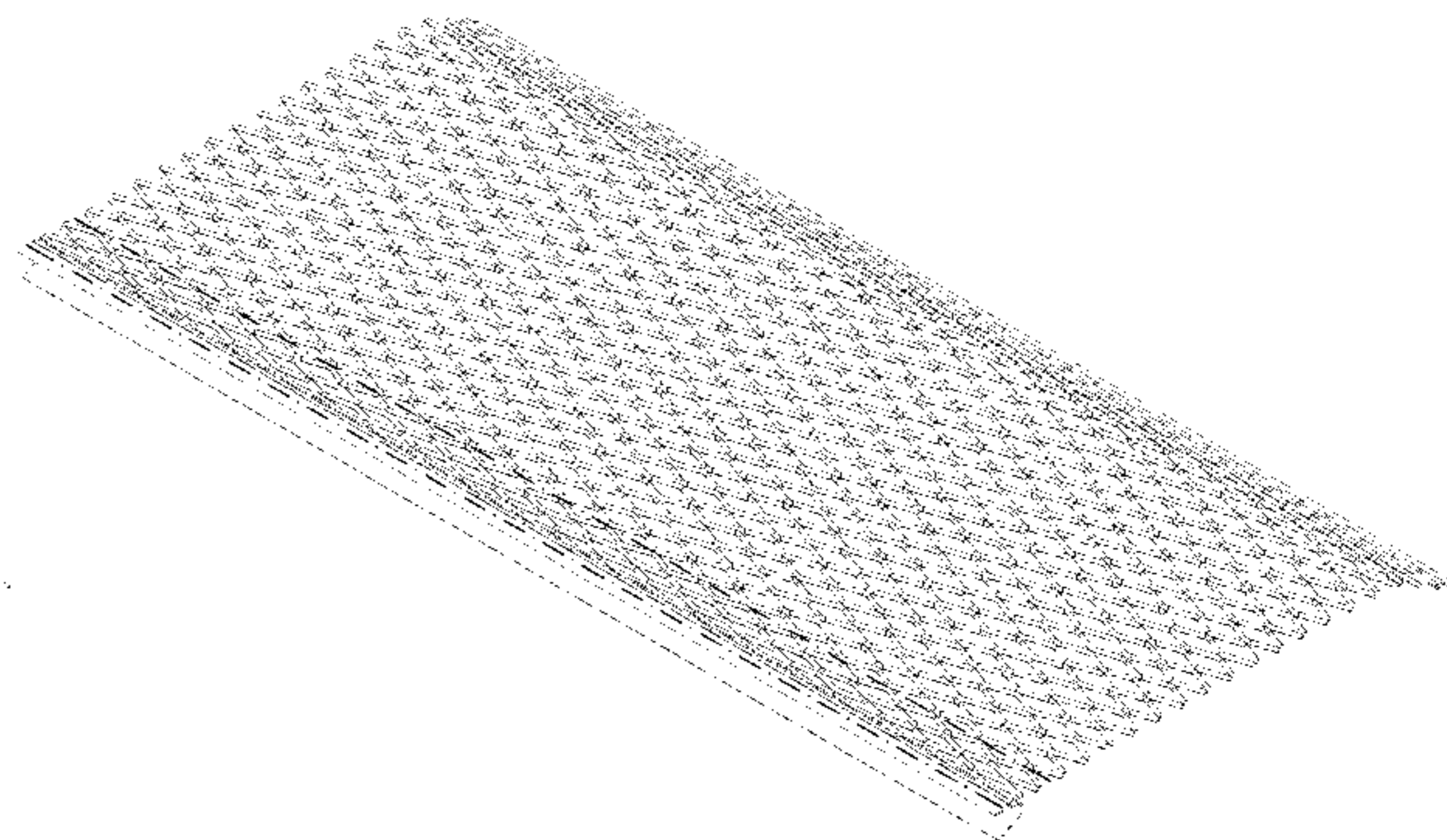
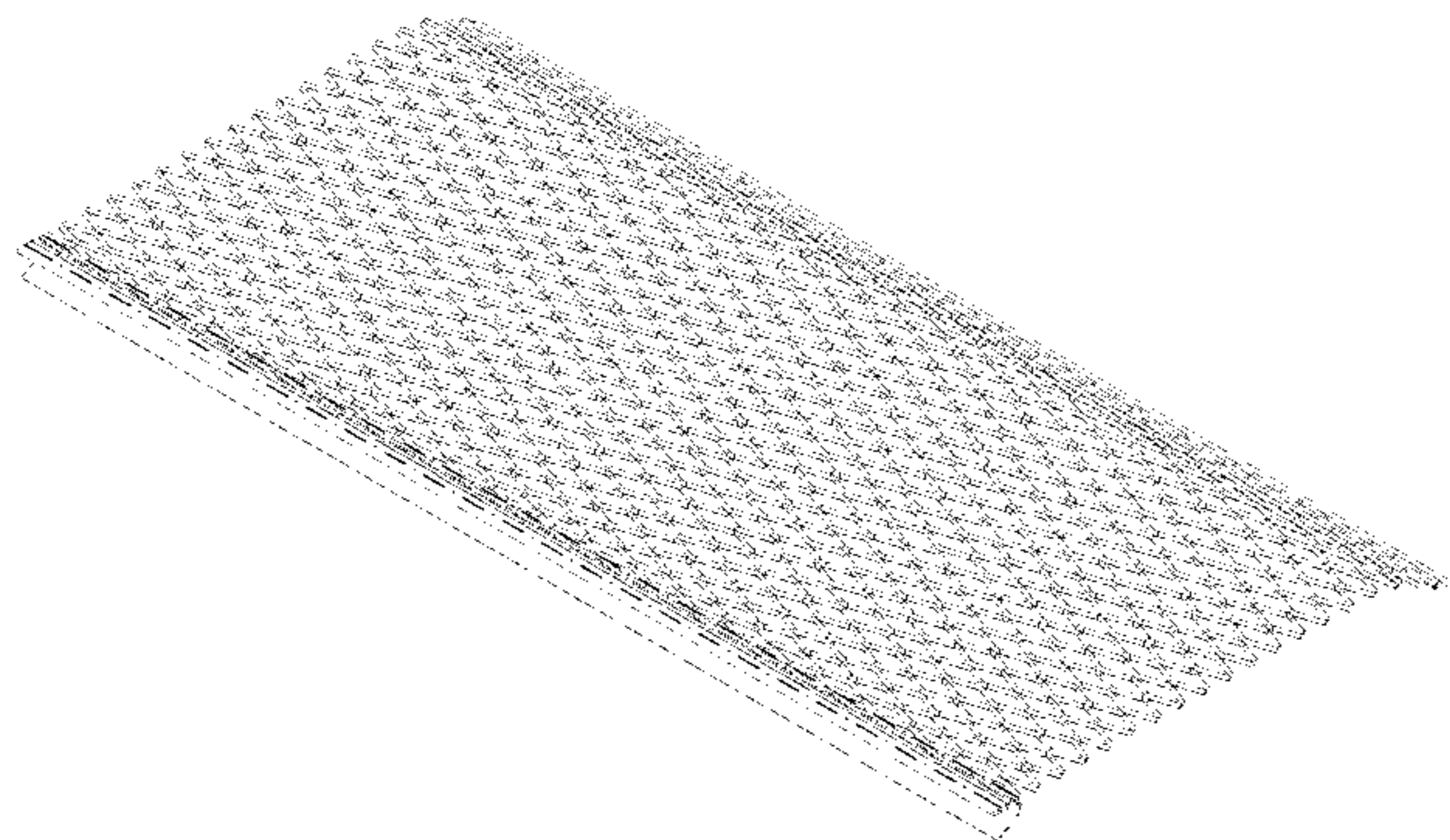
(57) **CLAIM**

The ornamental design for the gutter cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a gutter cover showing my design; and, FIG. 2 is a top plan view of FIG. 1. FIG. 3 is a perspective view of a second embodiment of a gutter cover showing my design; and, FIG. 4 is a top plan view of FIG. 3. The dot-dash lines in FIGS. 1-4 represent boundary lines between claimed subject matter shown in solid lines from unclaimed subject matter shown in dash-dash lines.

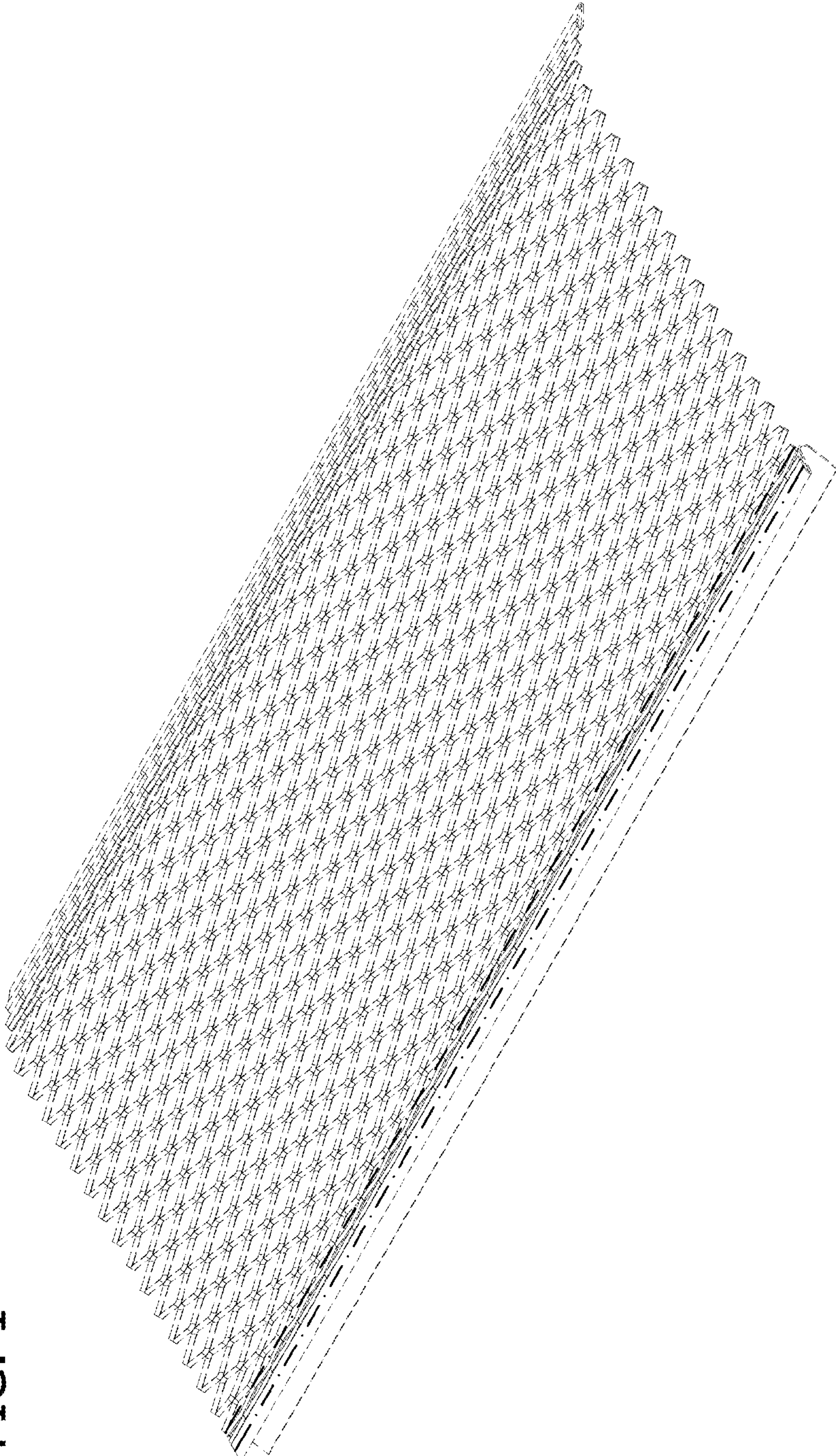

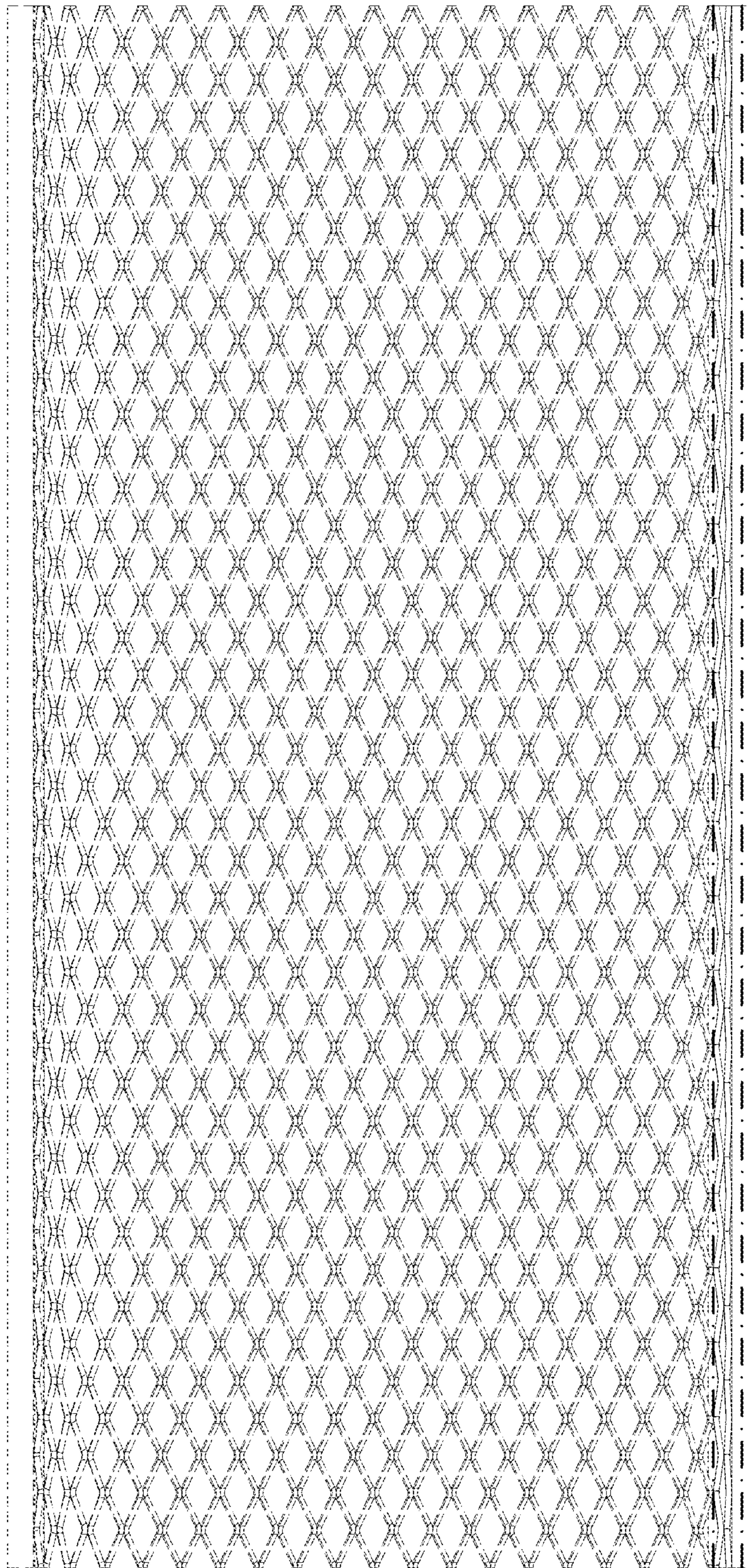

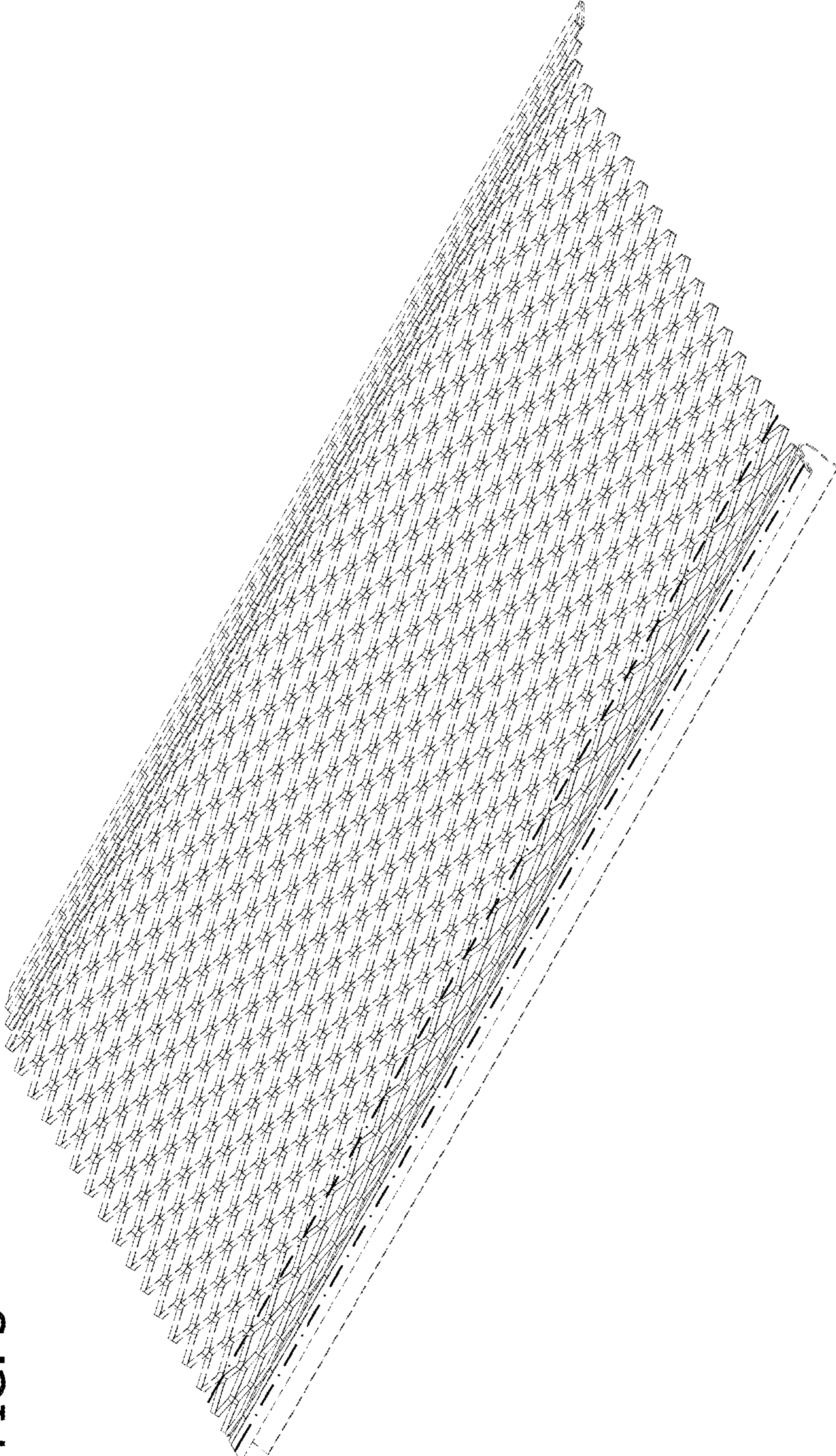
