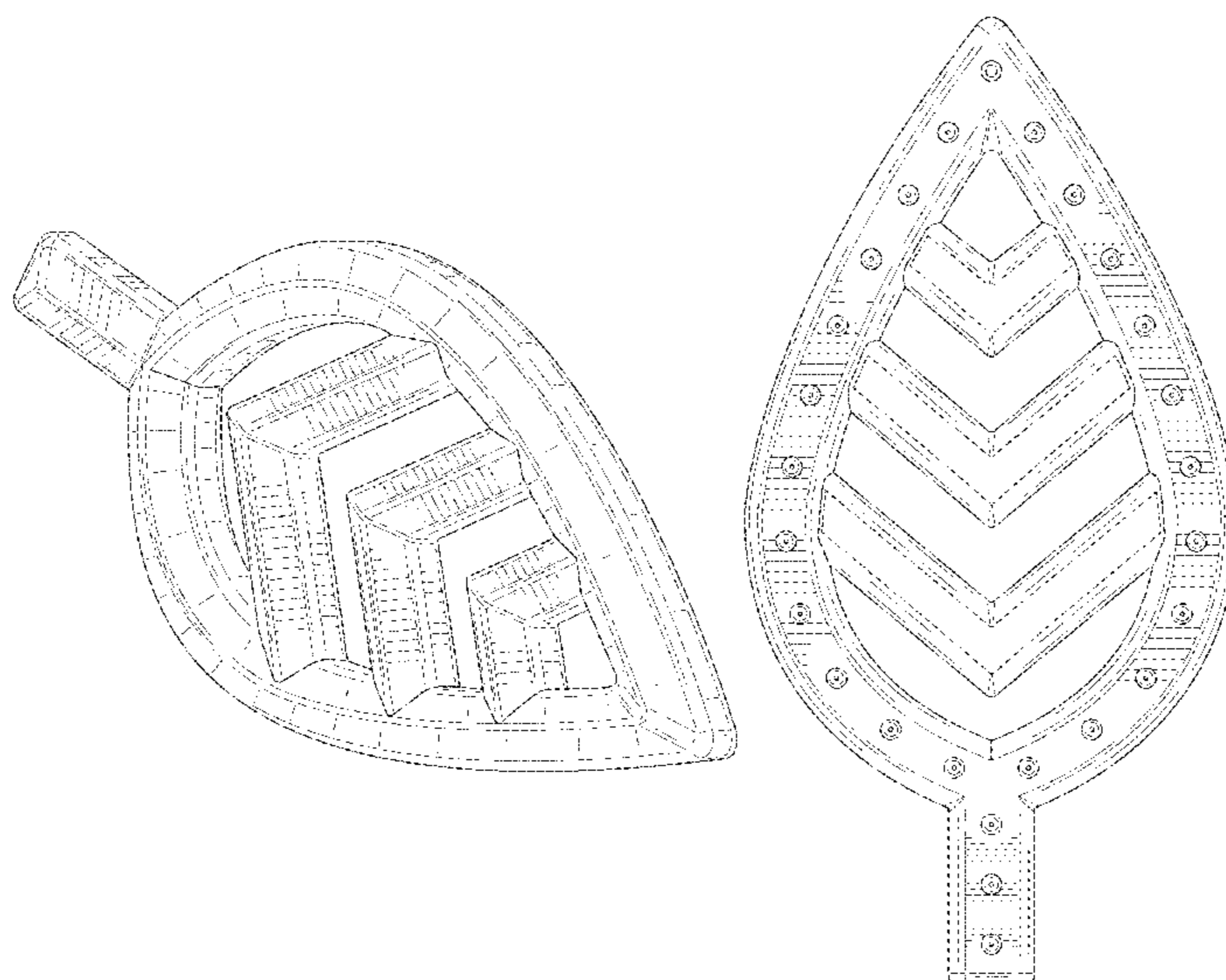
(57) **CLAIM**

The ornamental design for a teether, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a teether, showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a back elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a top plan view thereof.
The broken lines in FIG. 3 depict portions of the teether that form no part of the claimed design.

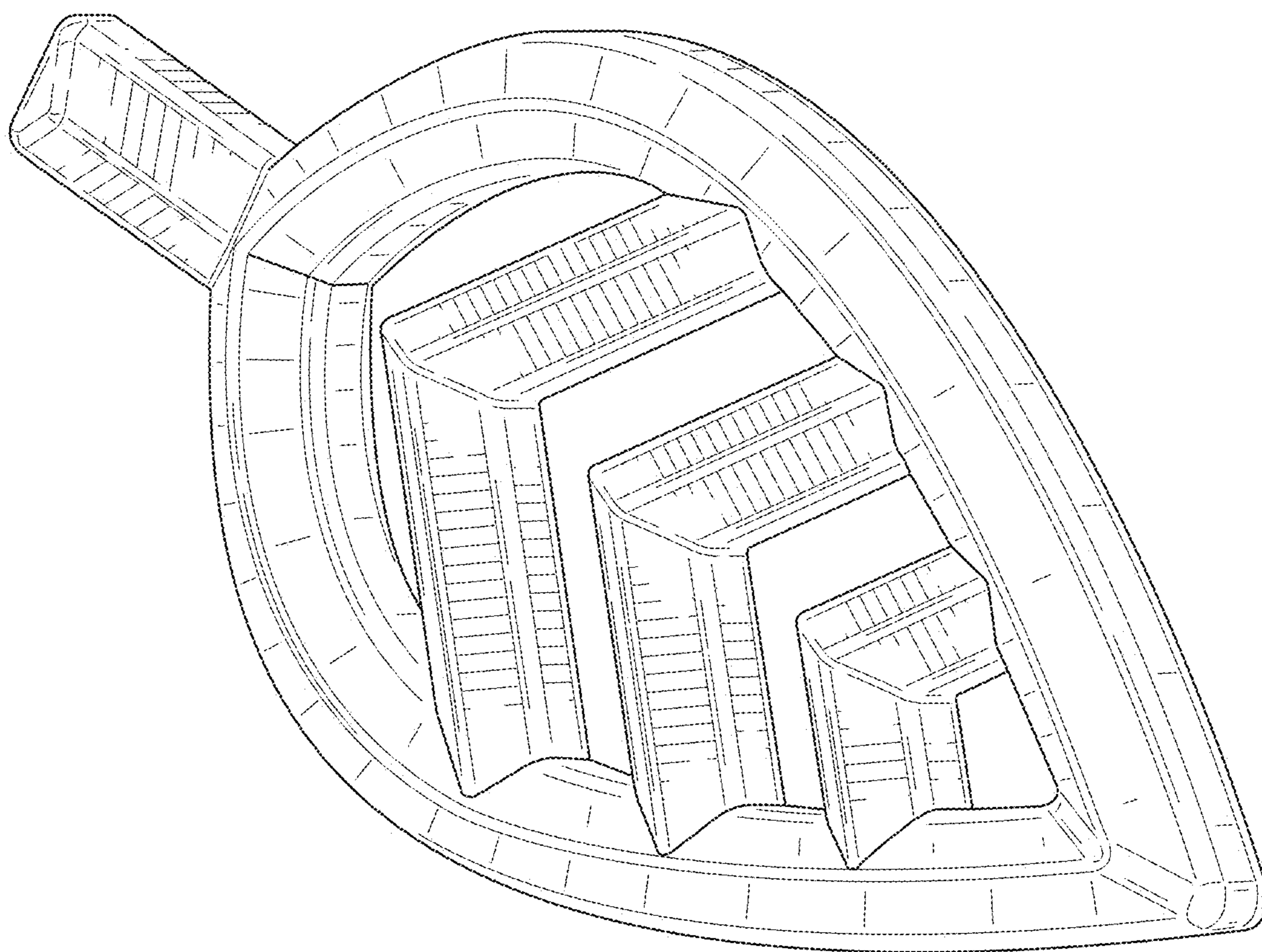

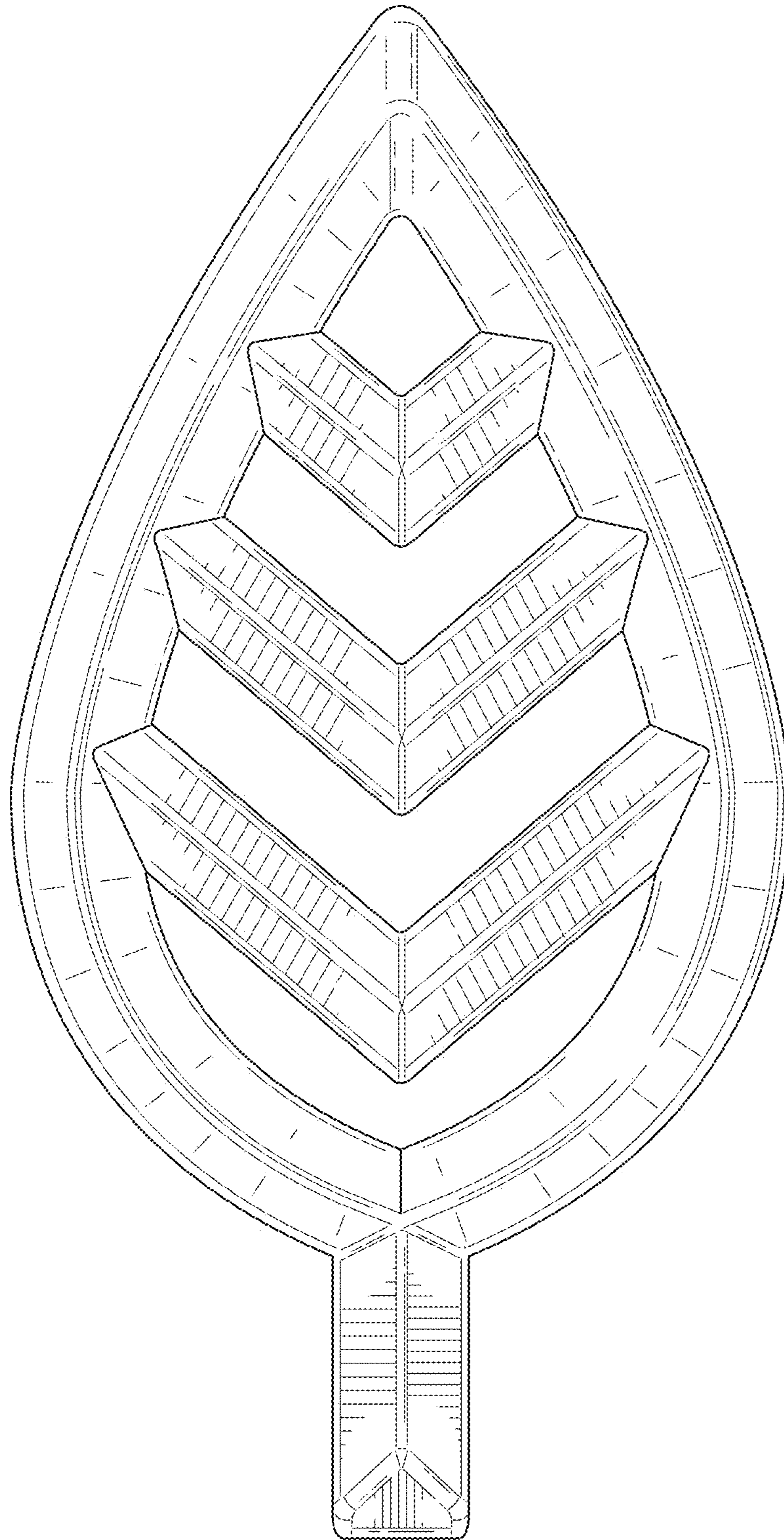

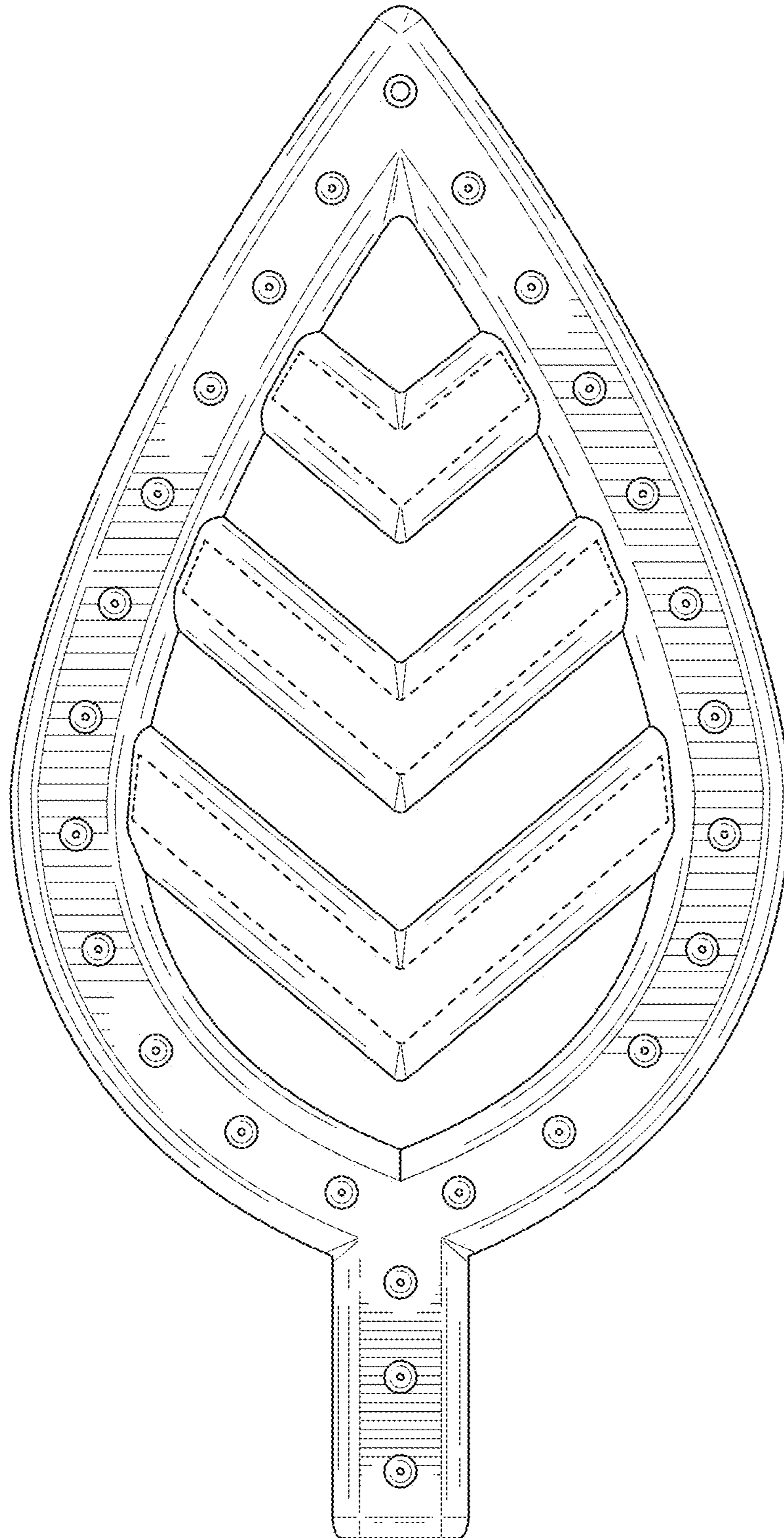

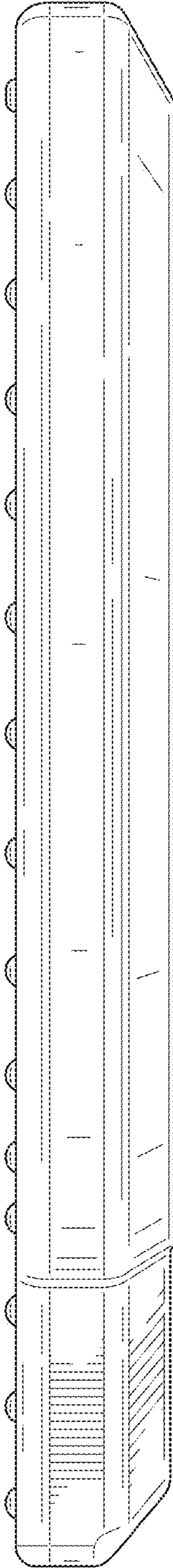

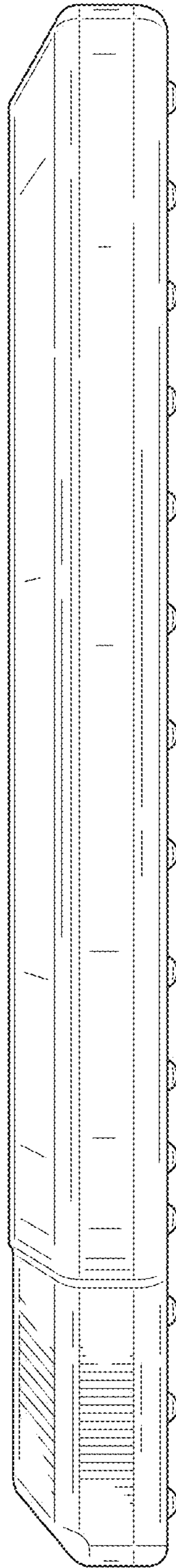

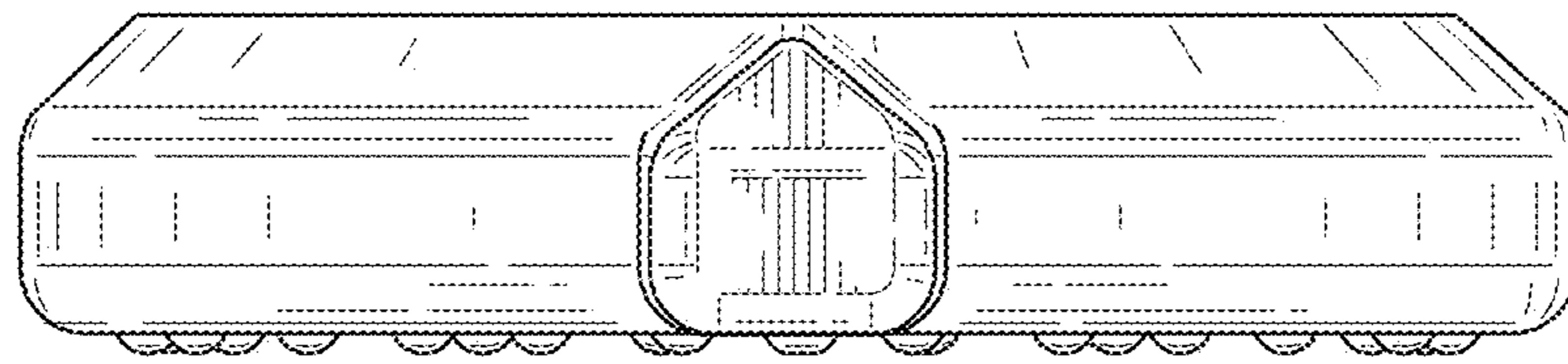

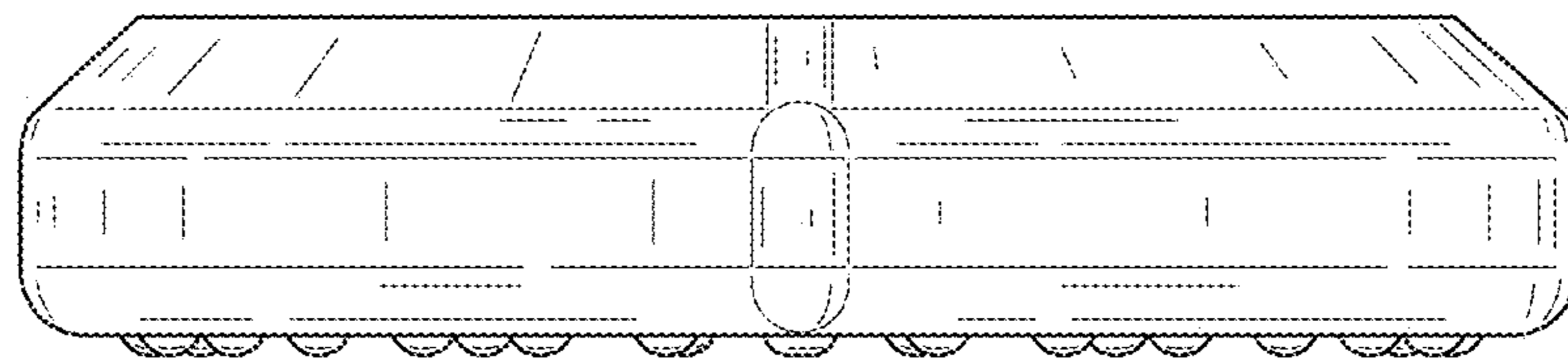
