We claim the ornamental design for a candle, as shown and described.

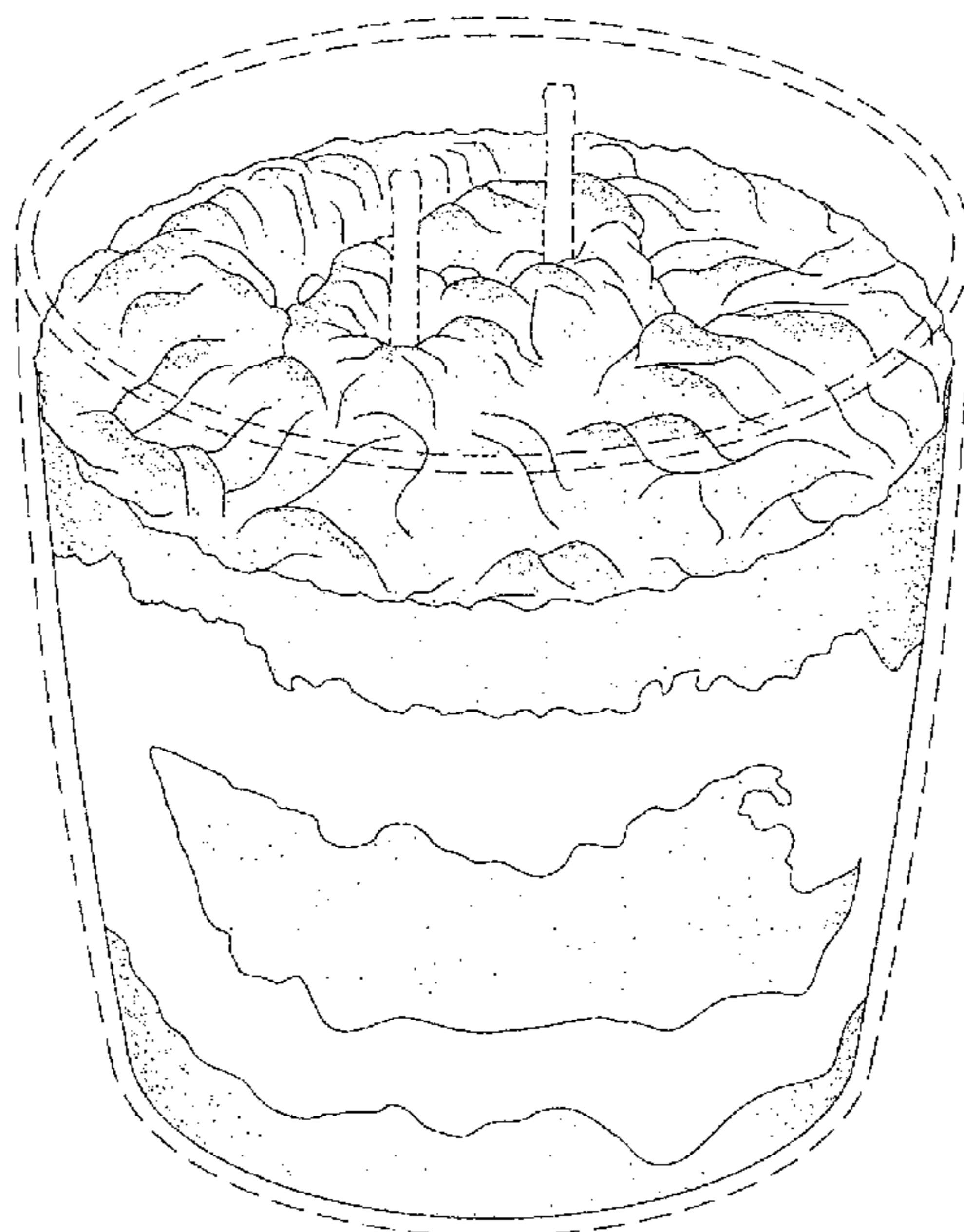
DESCRIPTION

FIG. 1 is a top perspective view of a candle showing our new candle;
FIG. 2 is a front view of the candle design of FIG. 1;
FIG. 3 is a rear view of the candle design of FIG. 1;
FIG. 4 is a right side view of the candle design of FIG. 1;
FIG. 5 is a left side view of the candle design of FIG. 1; and,
FIG. 6 is a top view of the candle design of FIG. 1.

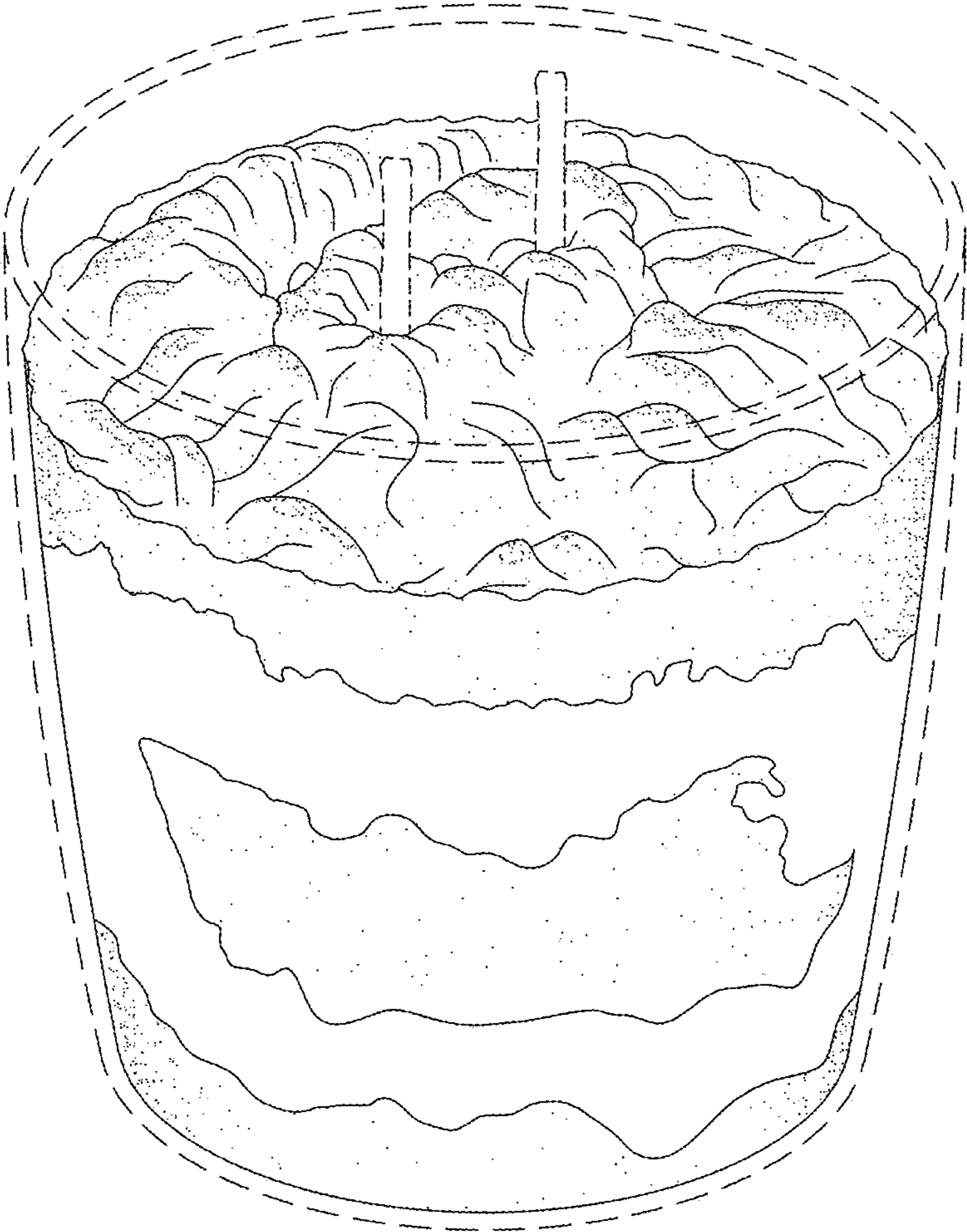

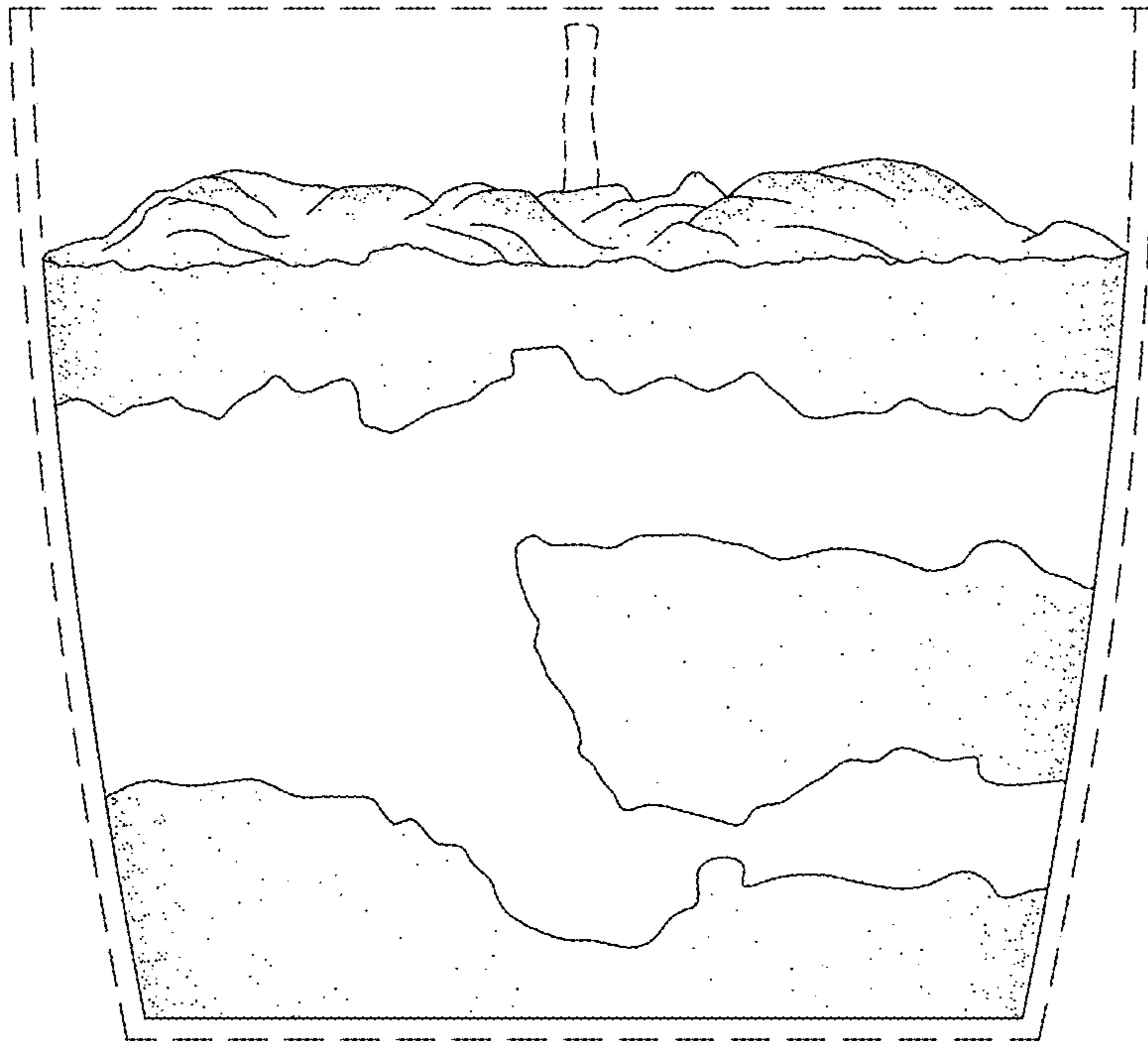

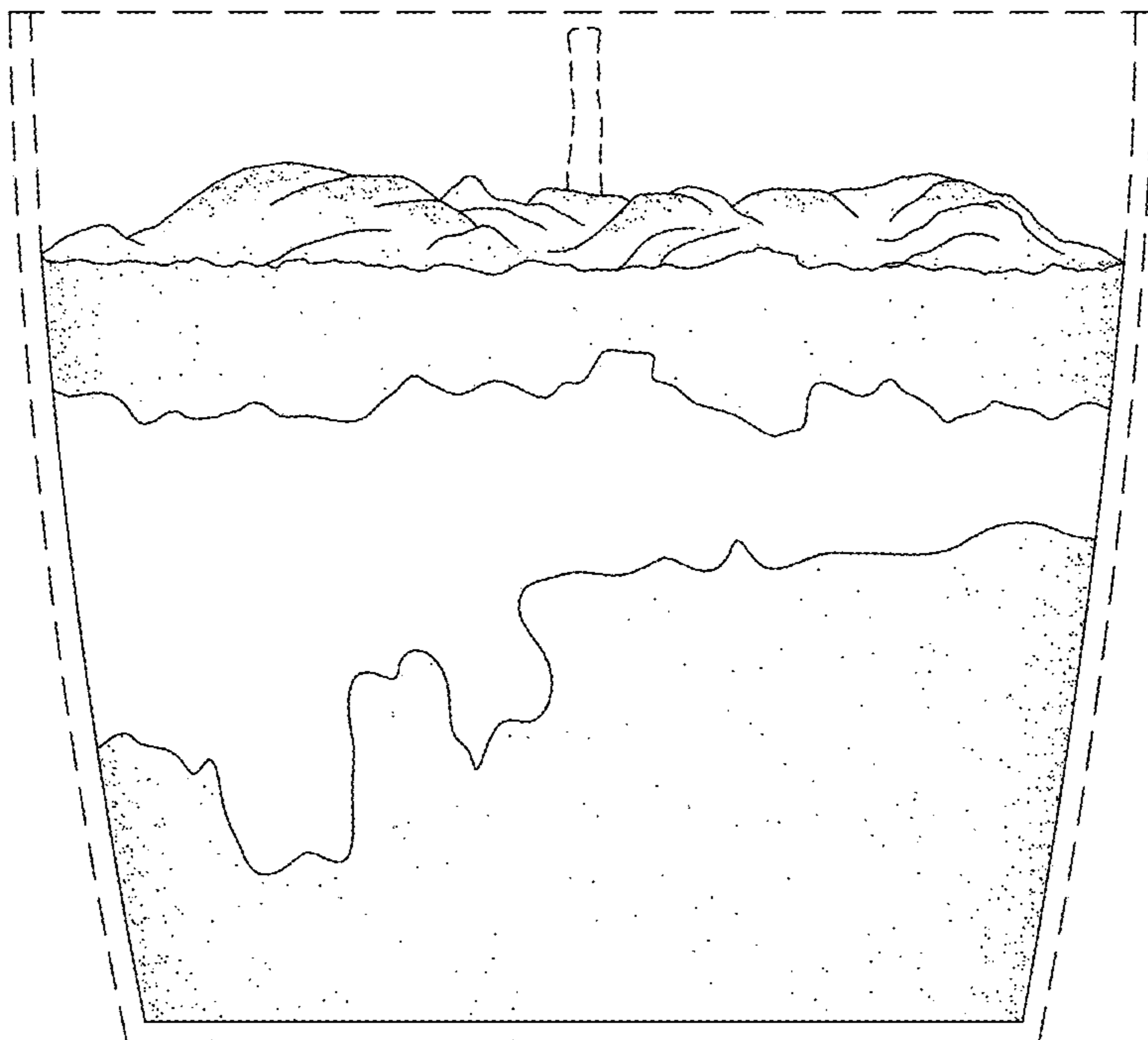

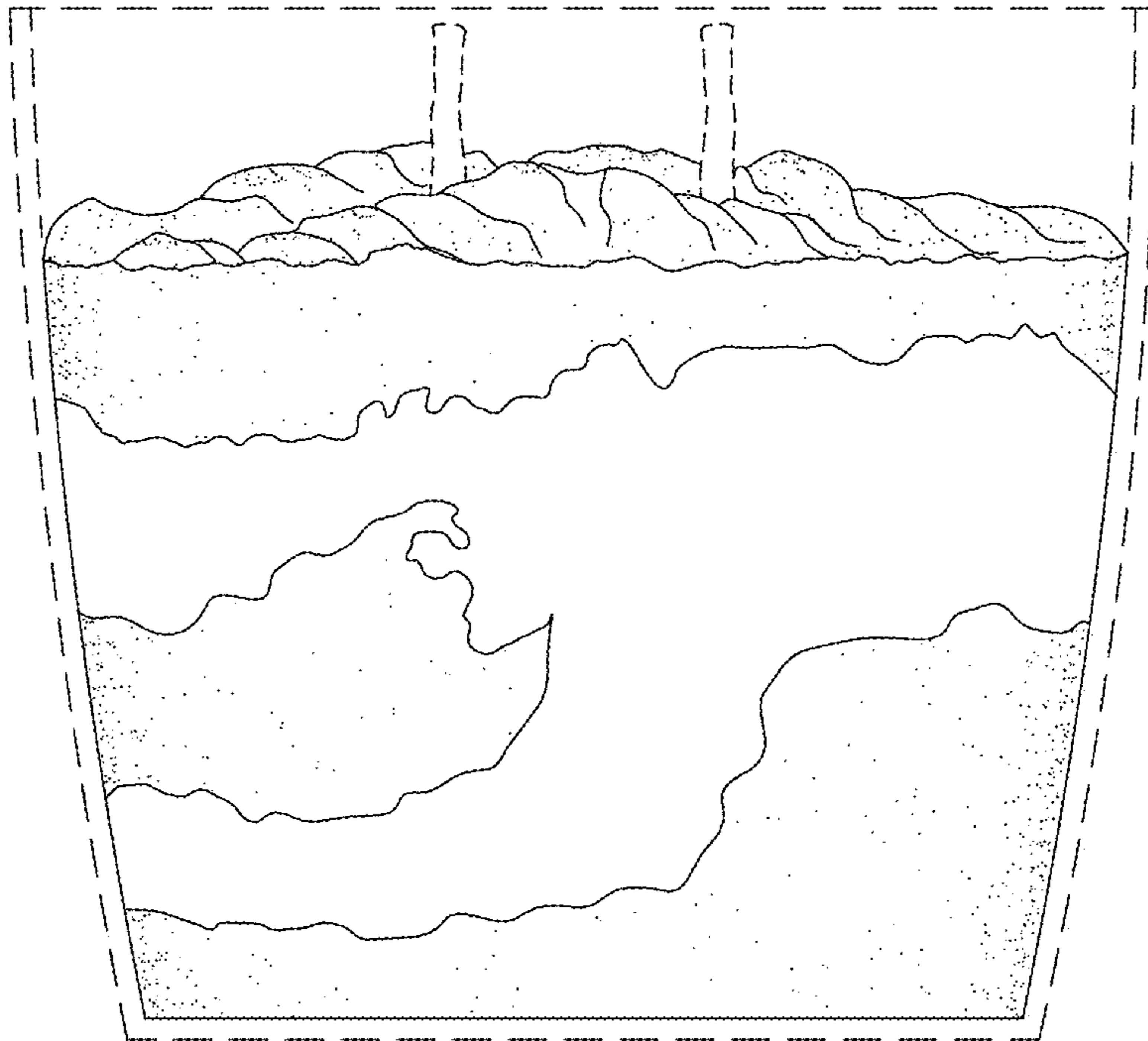

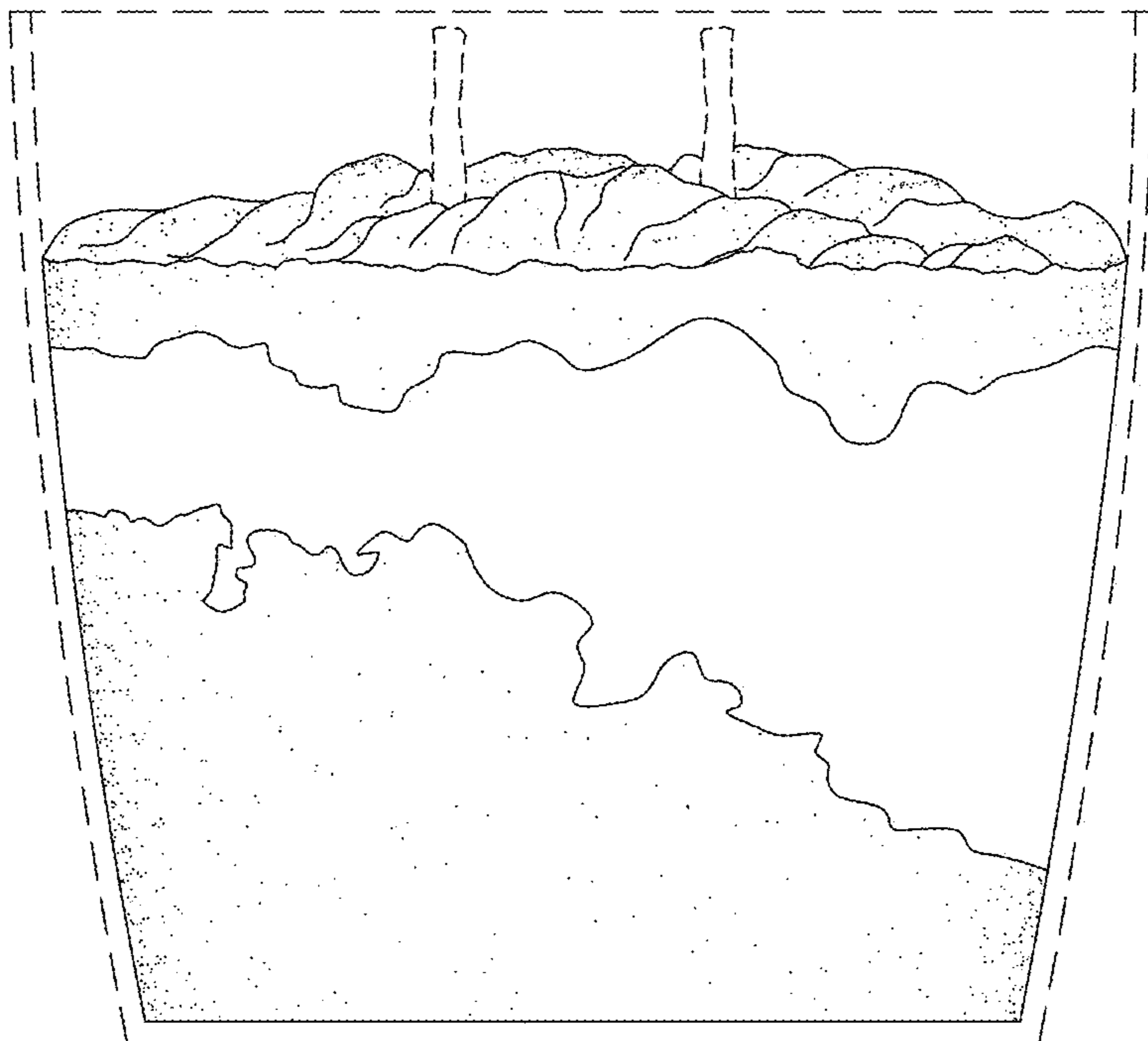

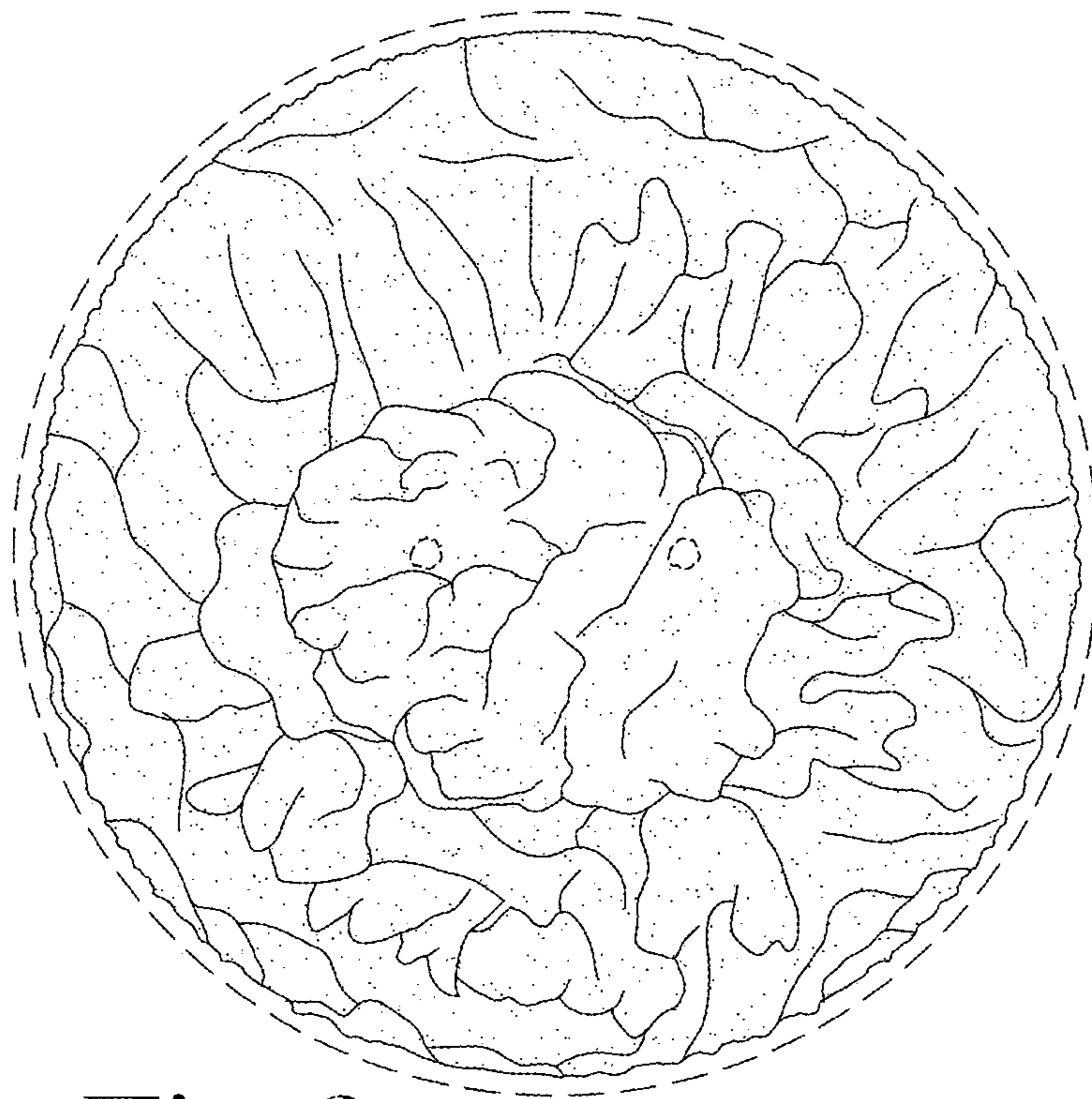
