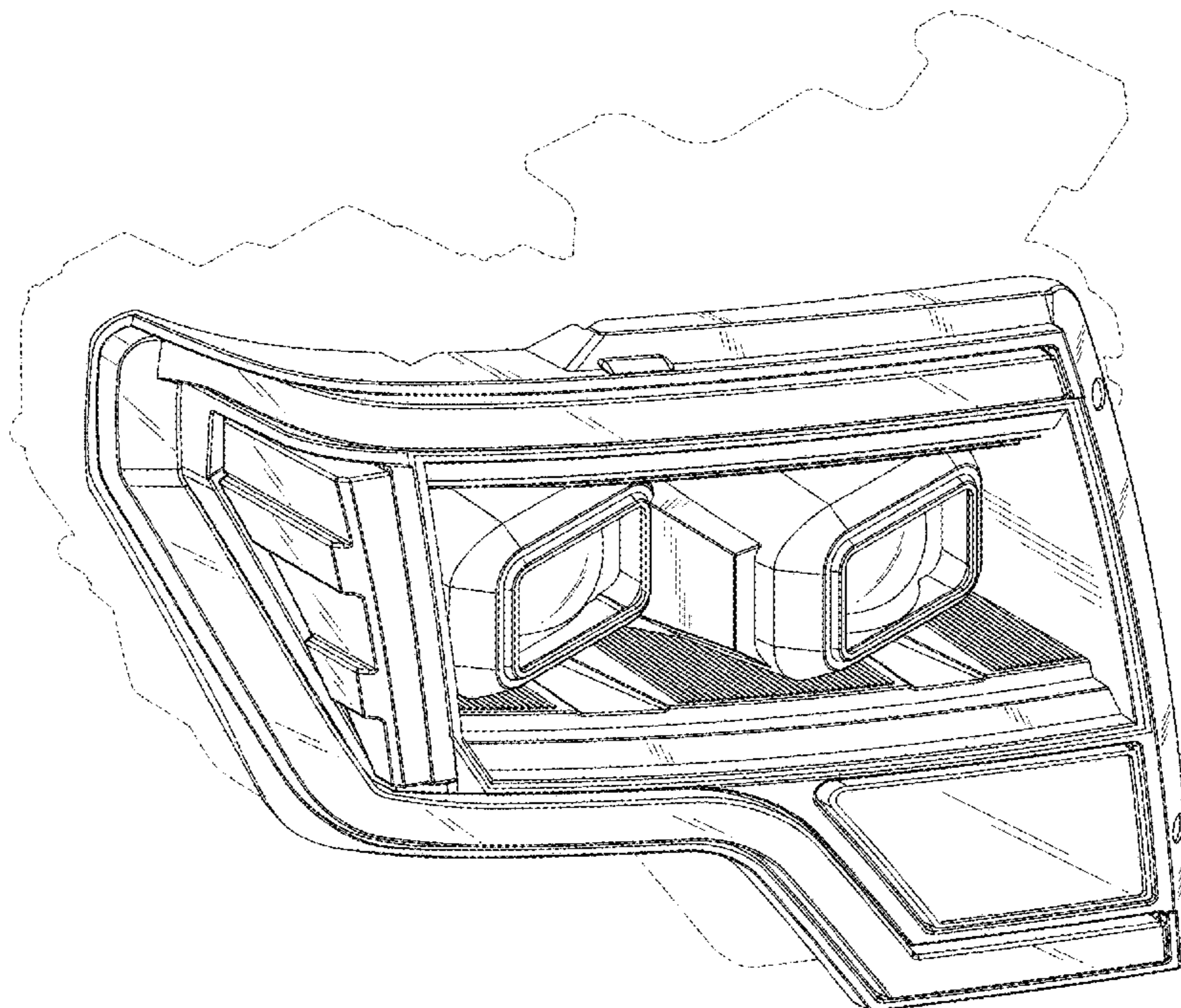
The ornamental design for vehicle light, as shown and described.

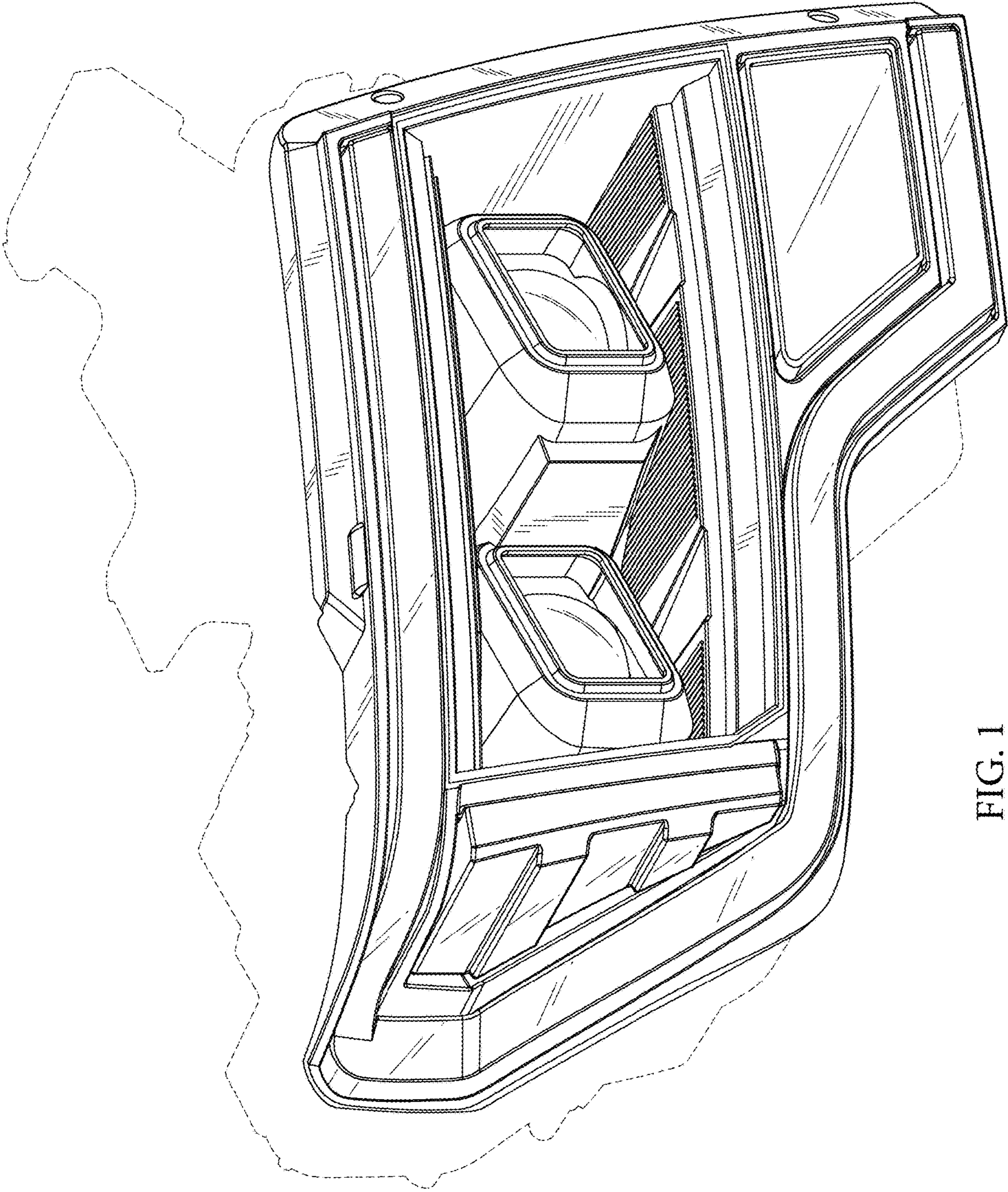

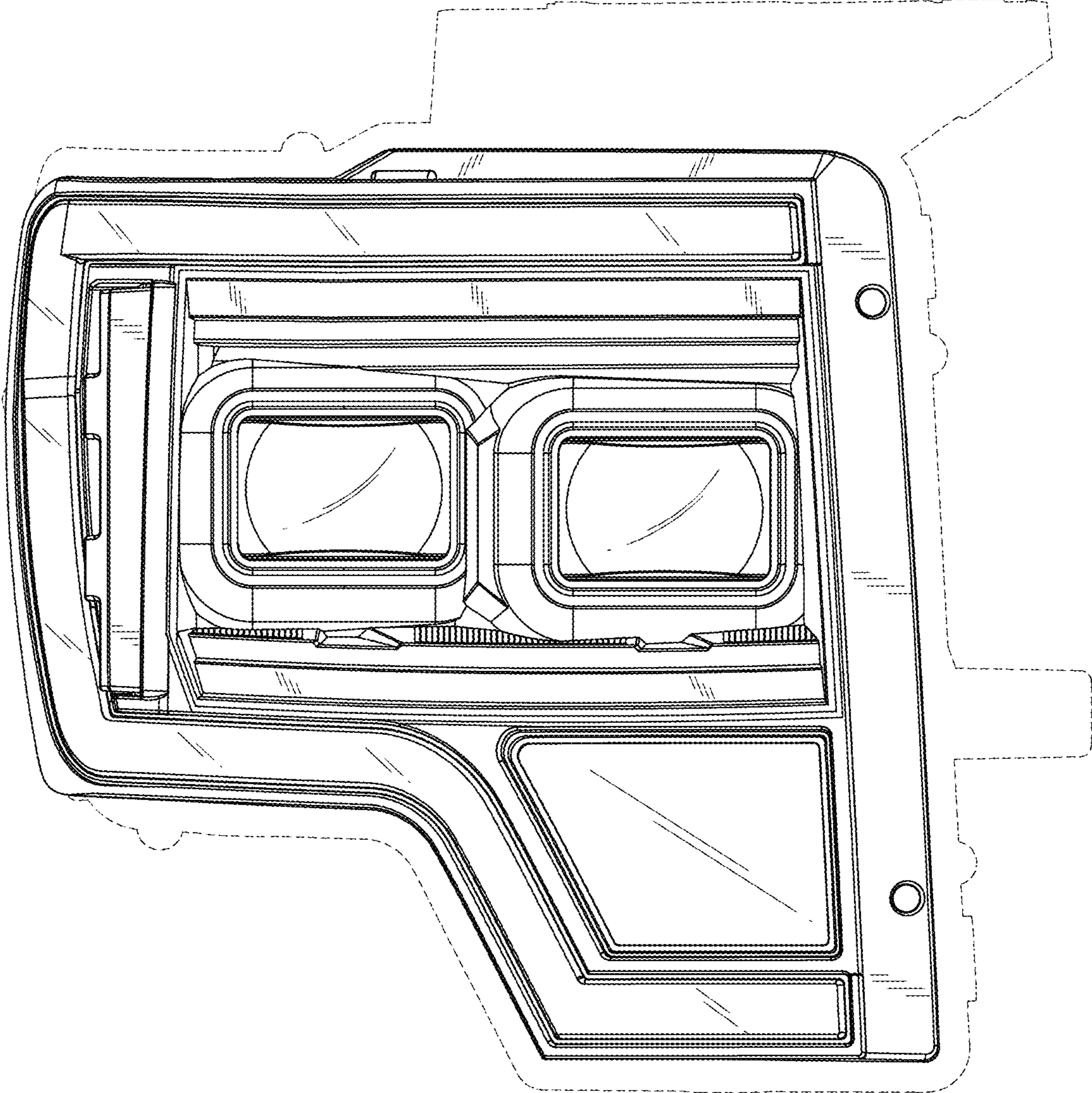

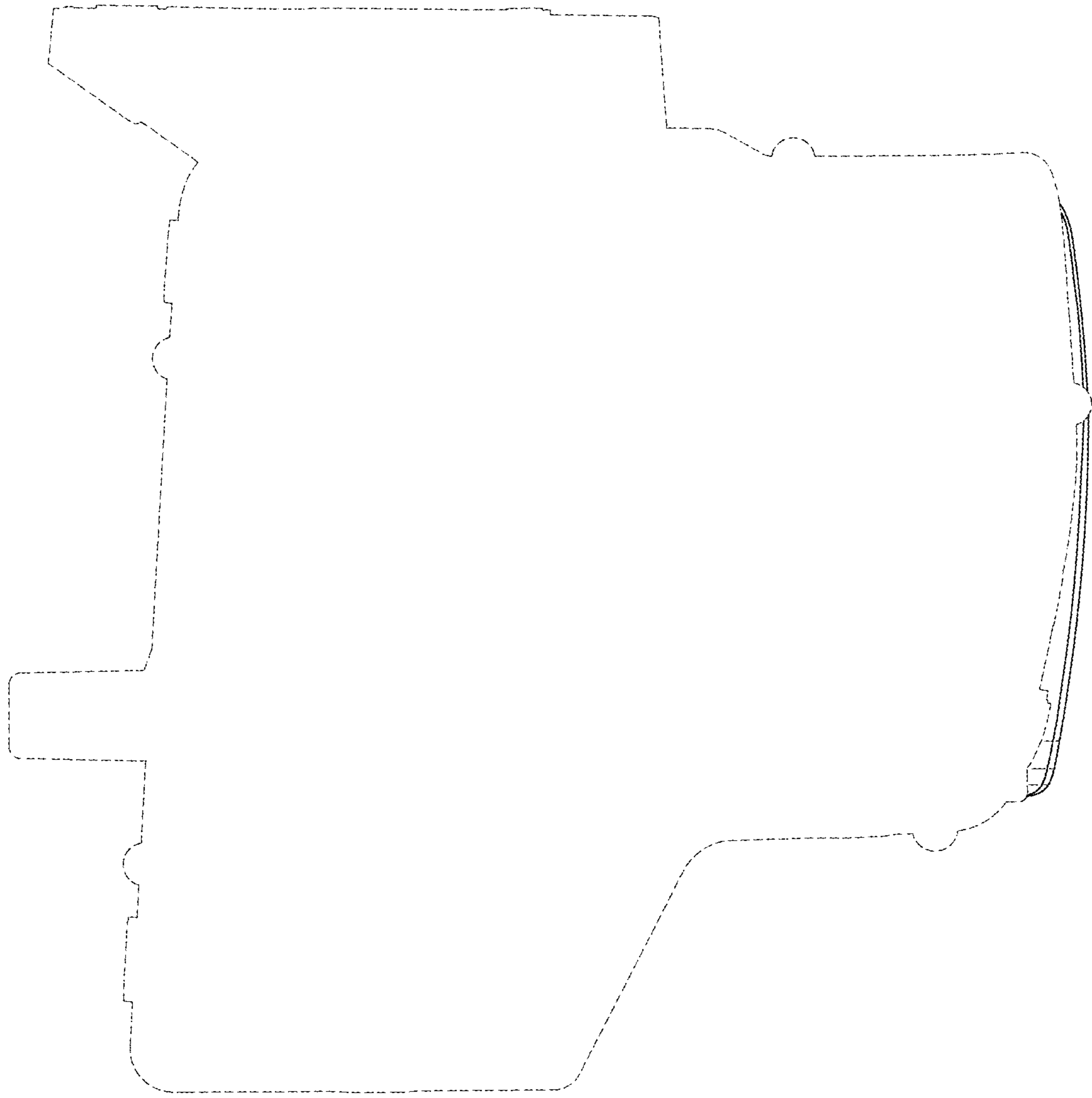

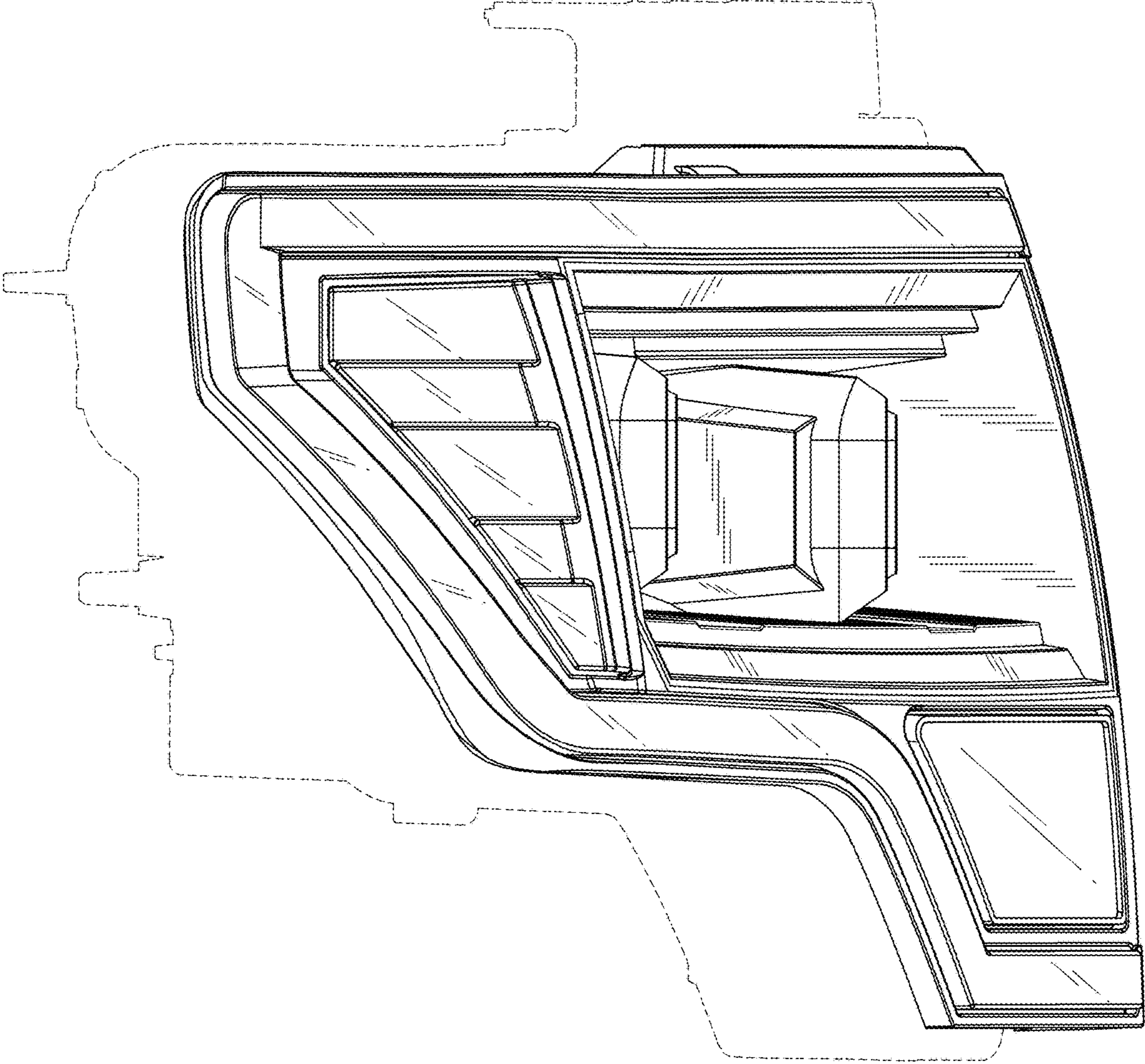

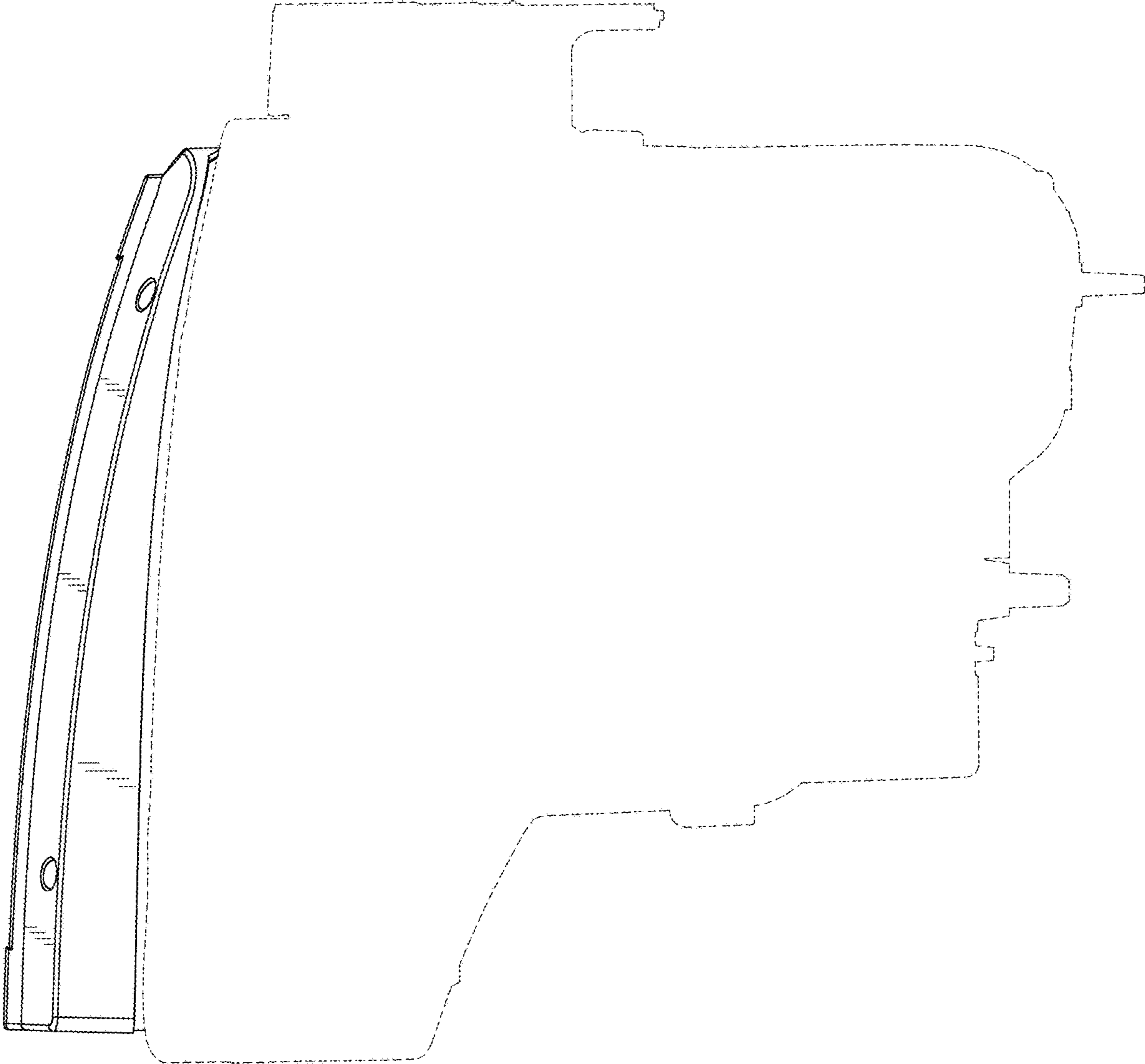

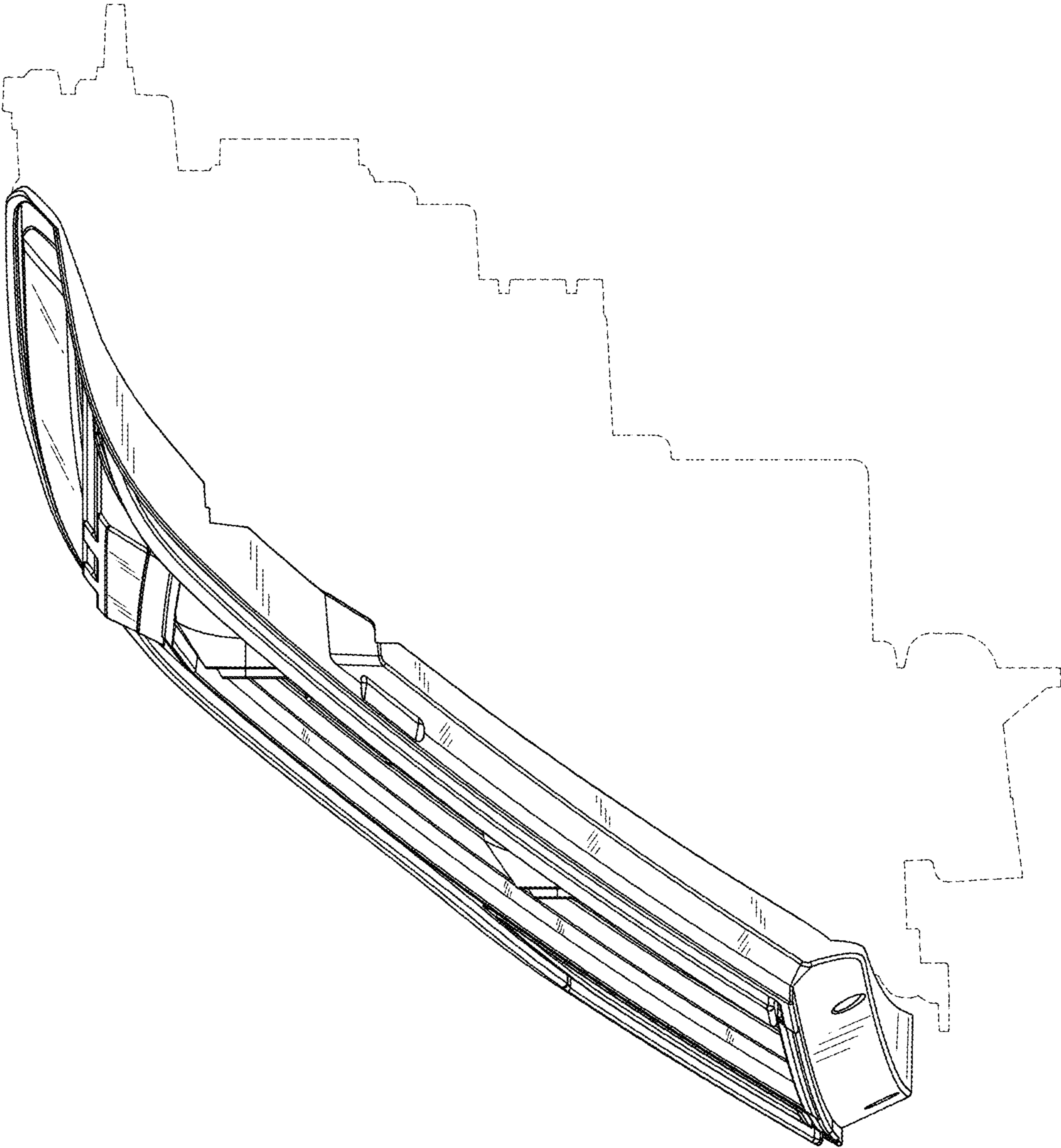

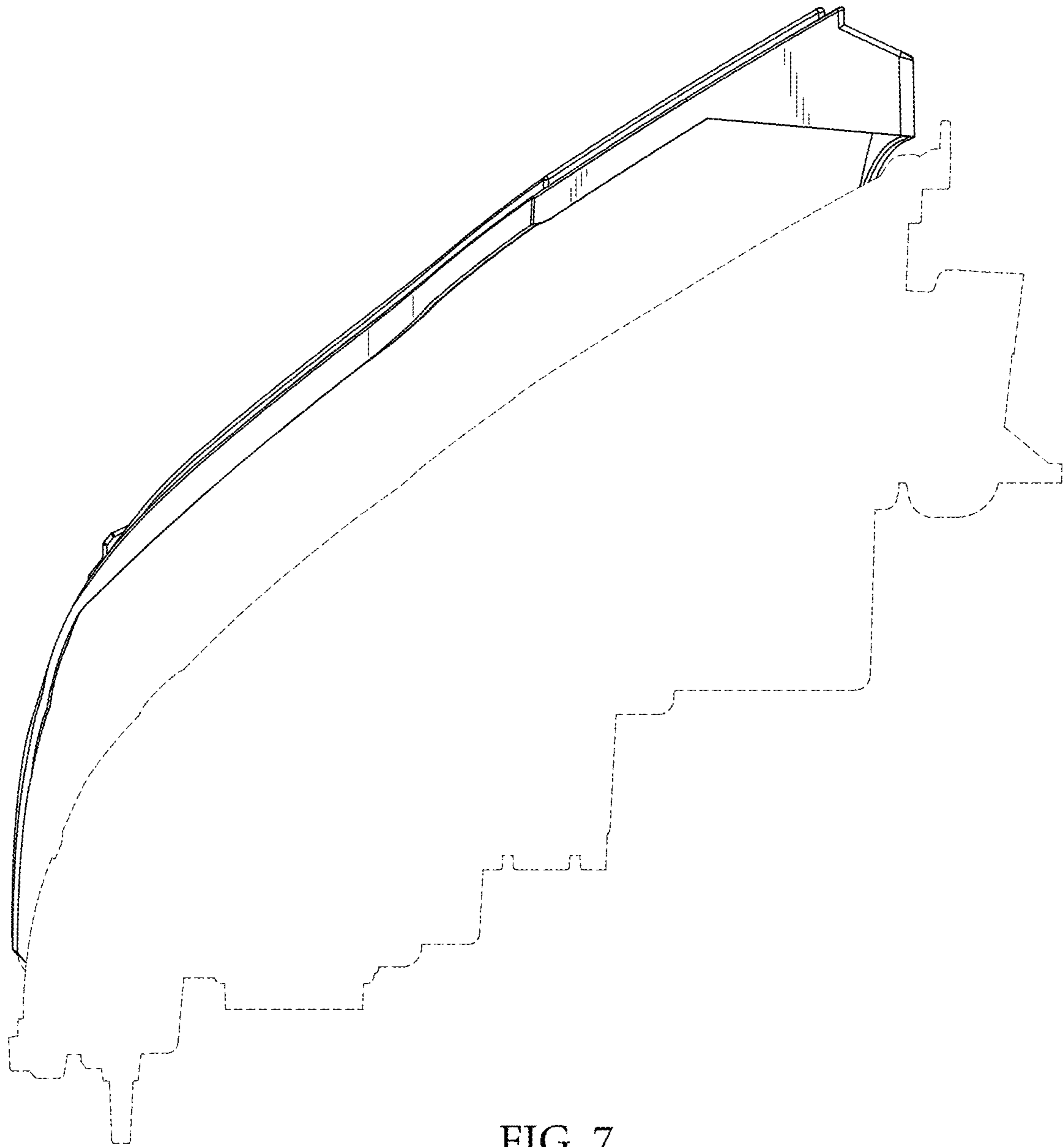
