The ornamental design for a table lamp base, as shown and described in the foregoing application.

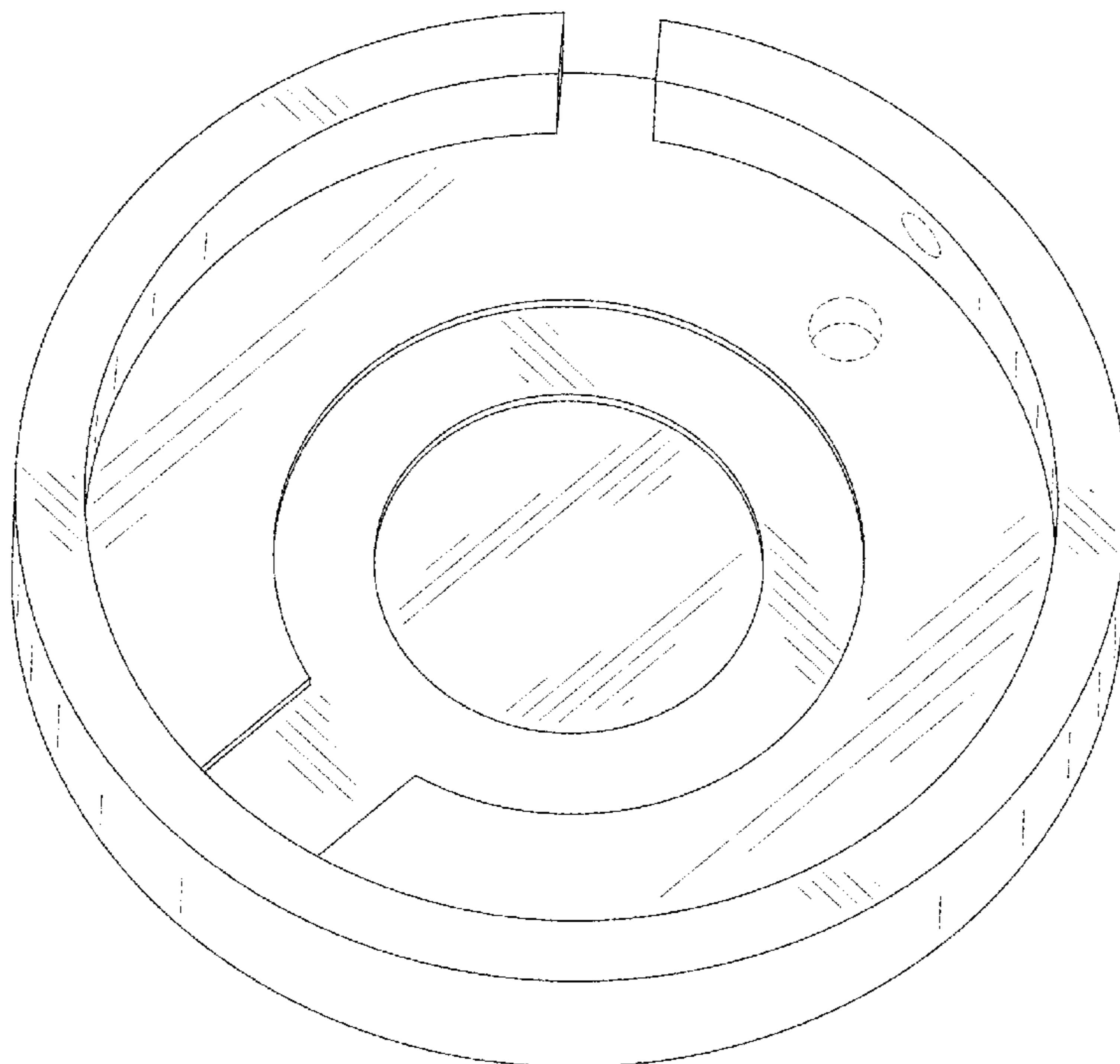
DESCRIPTION

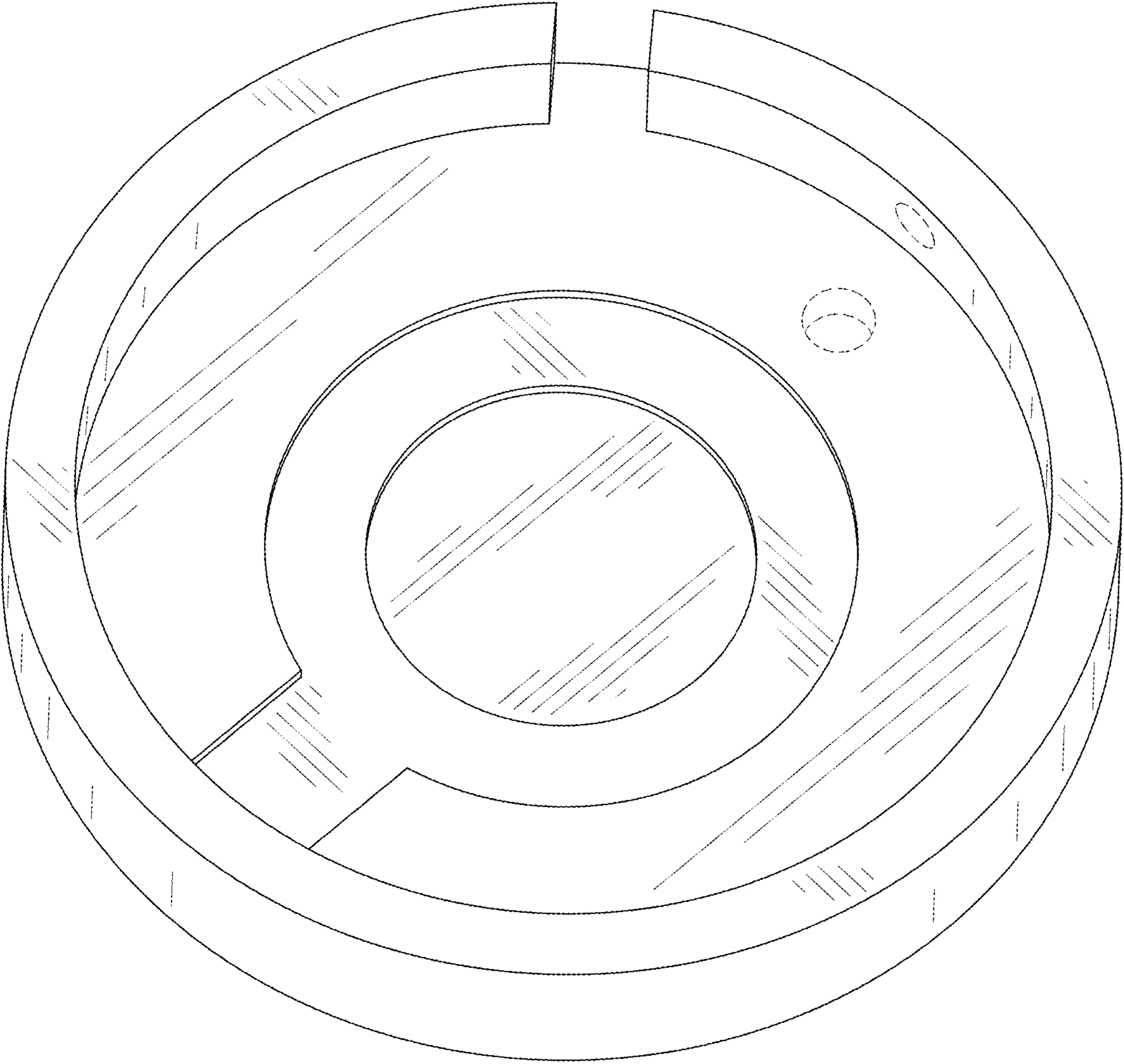

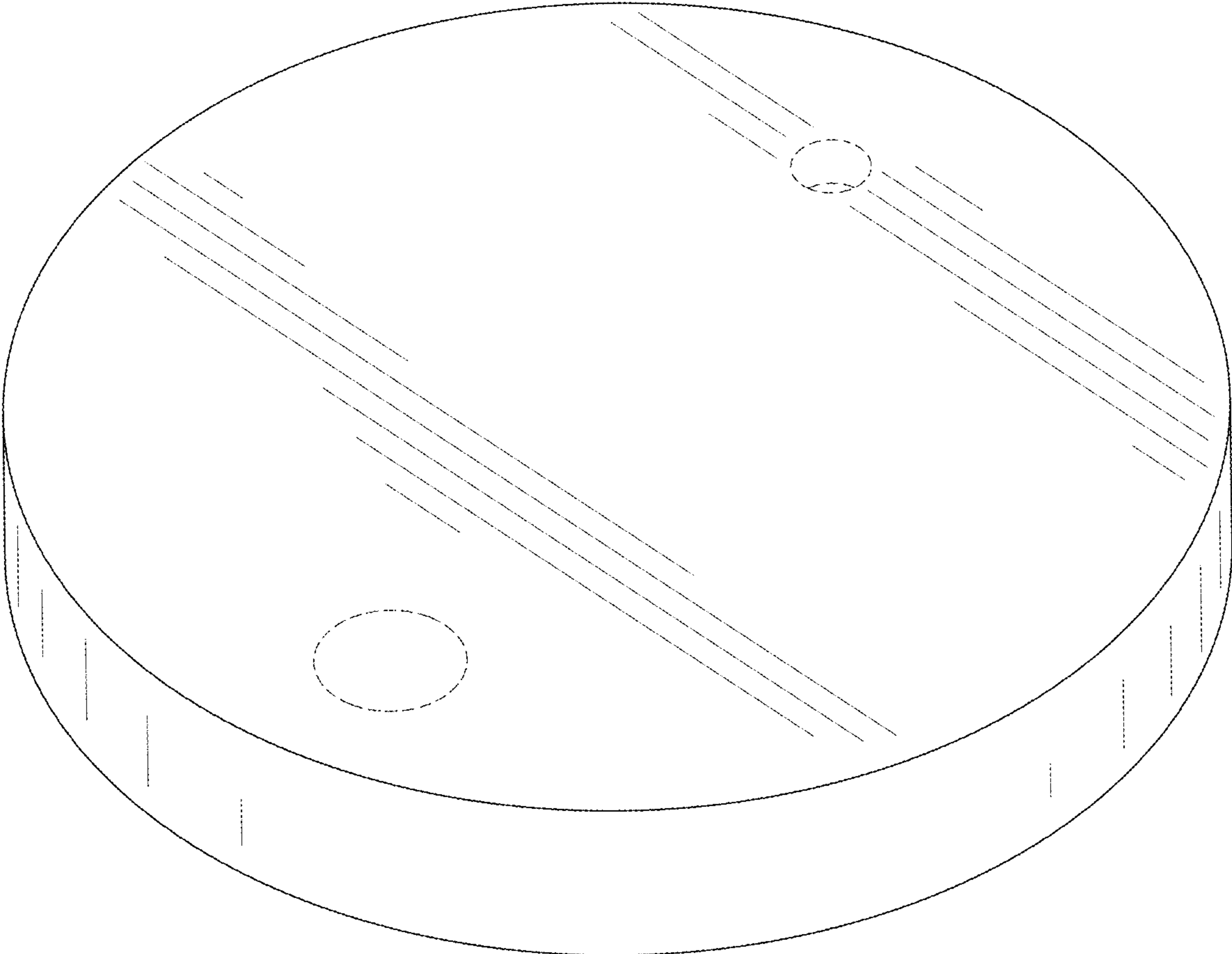

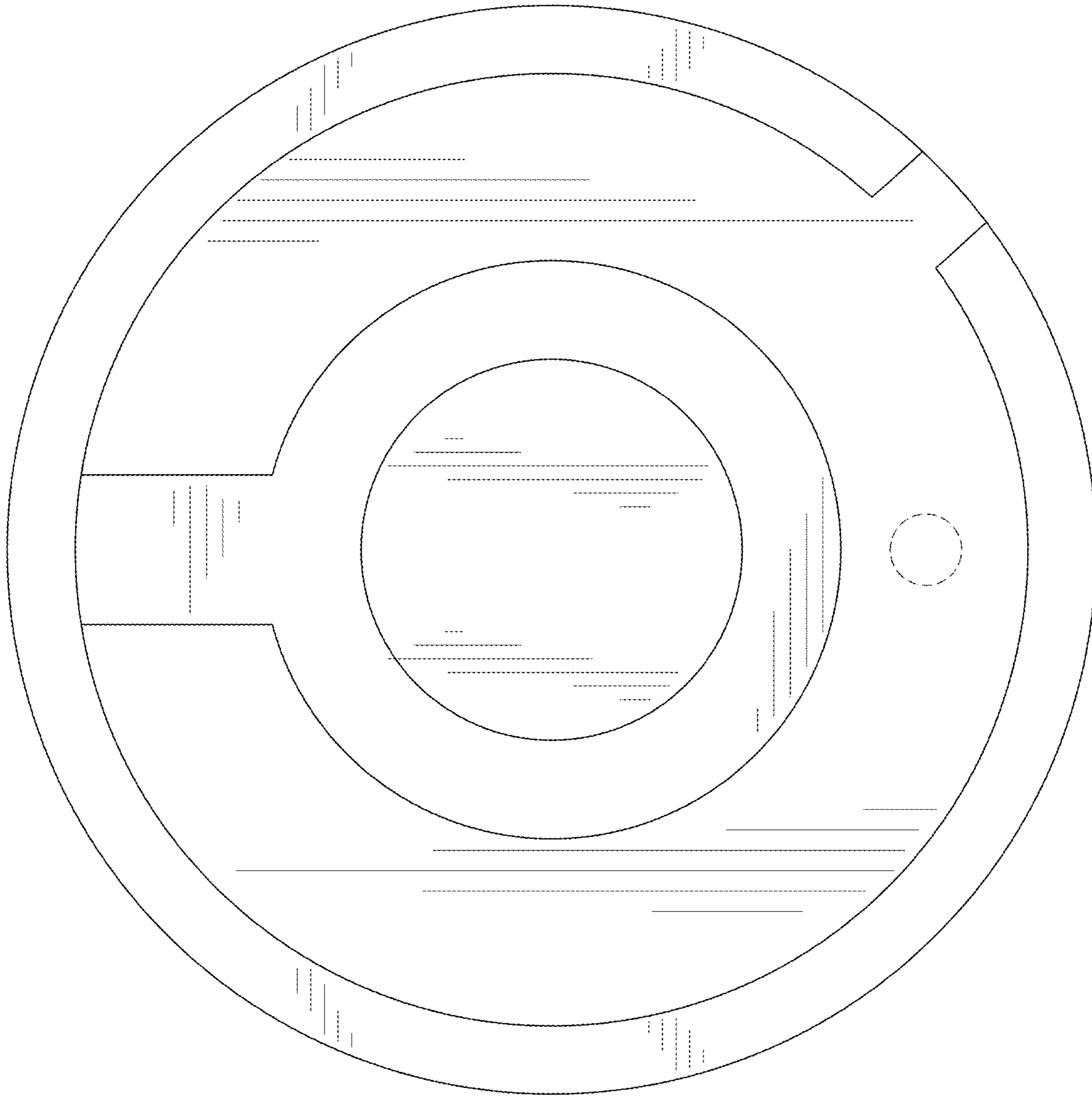

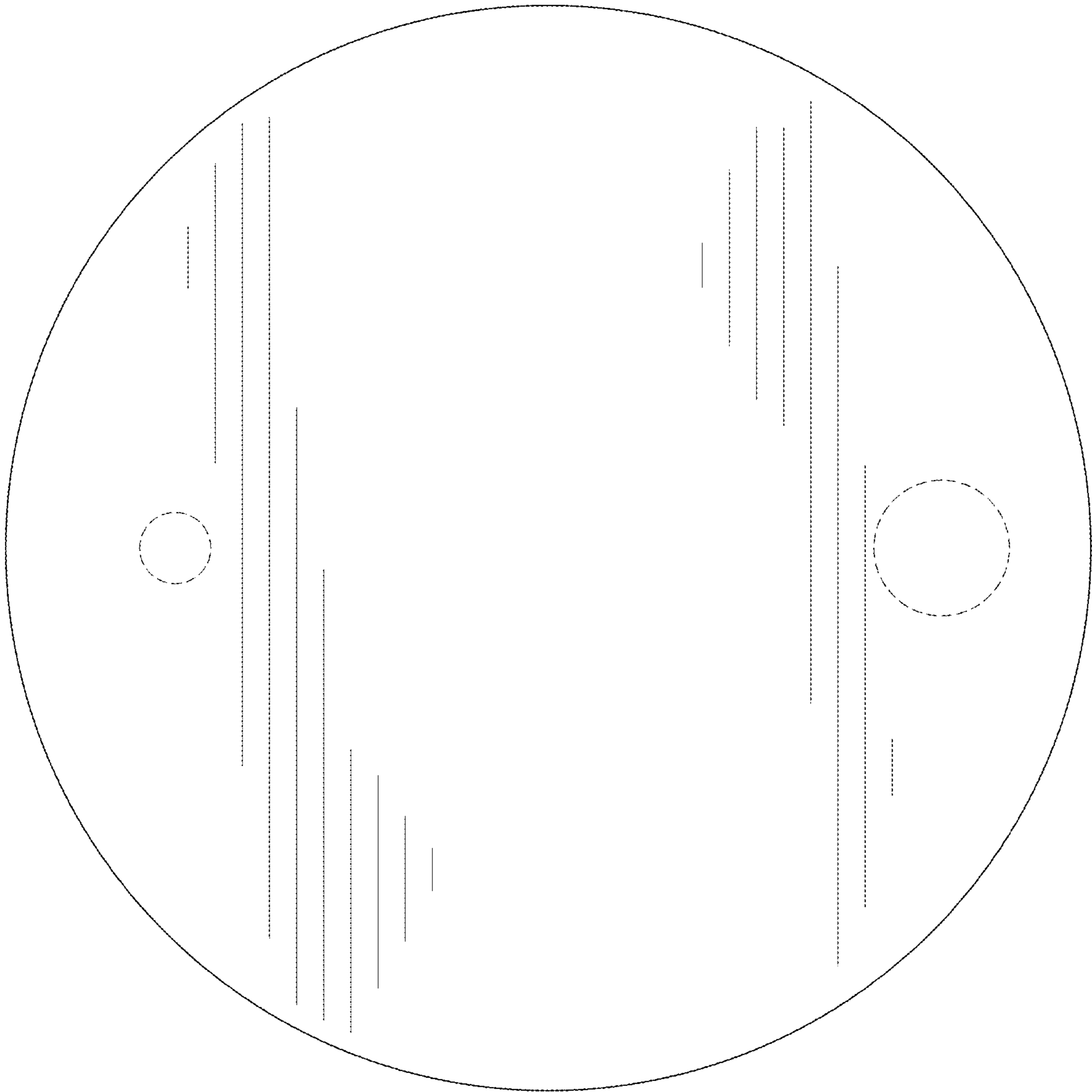

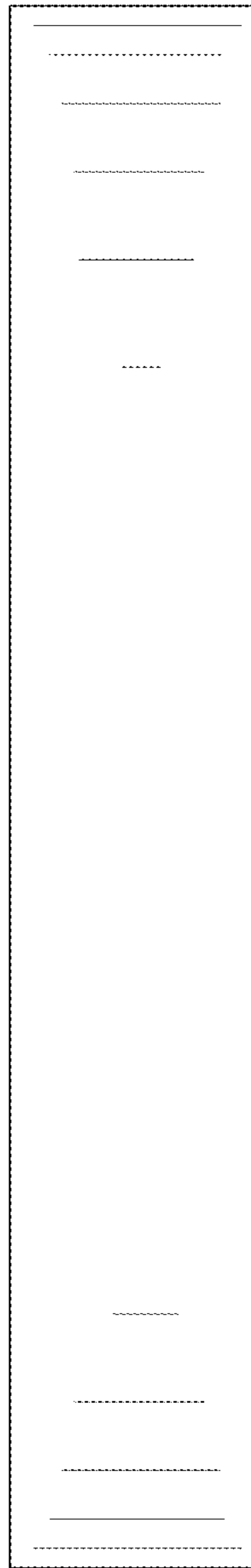

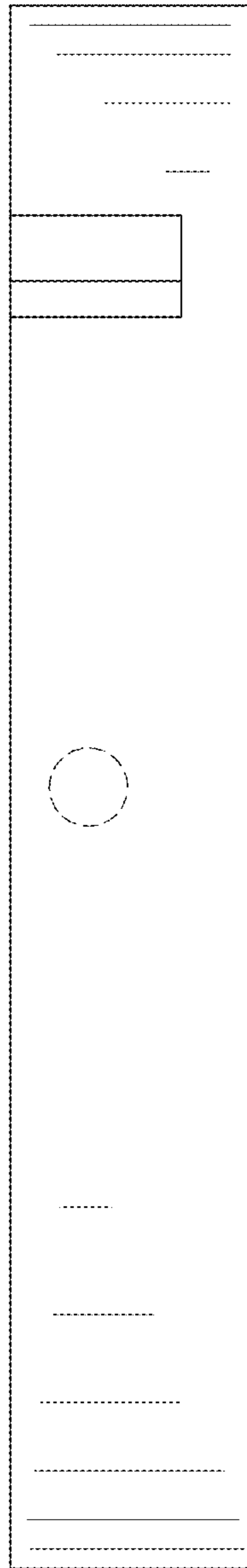

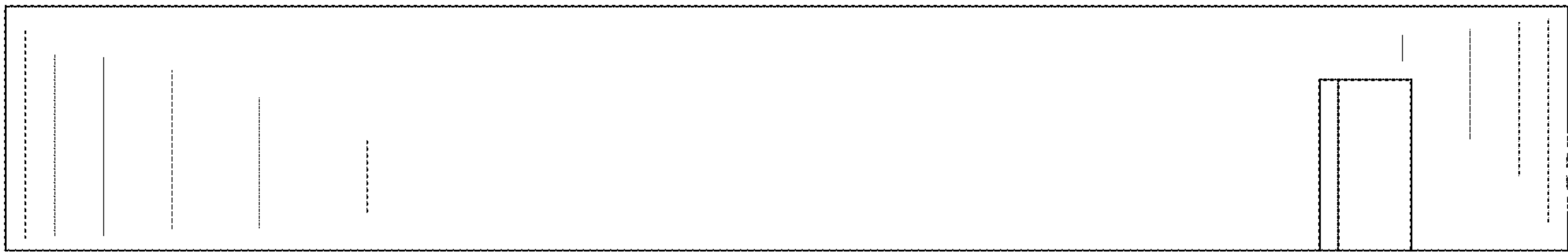

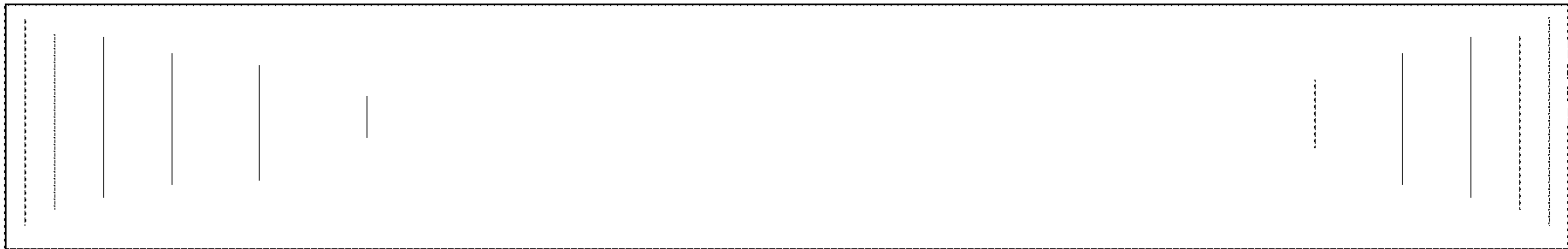
