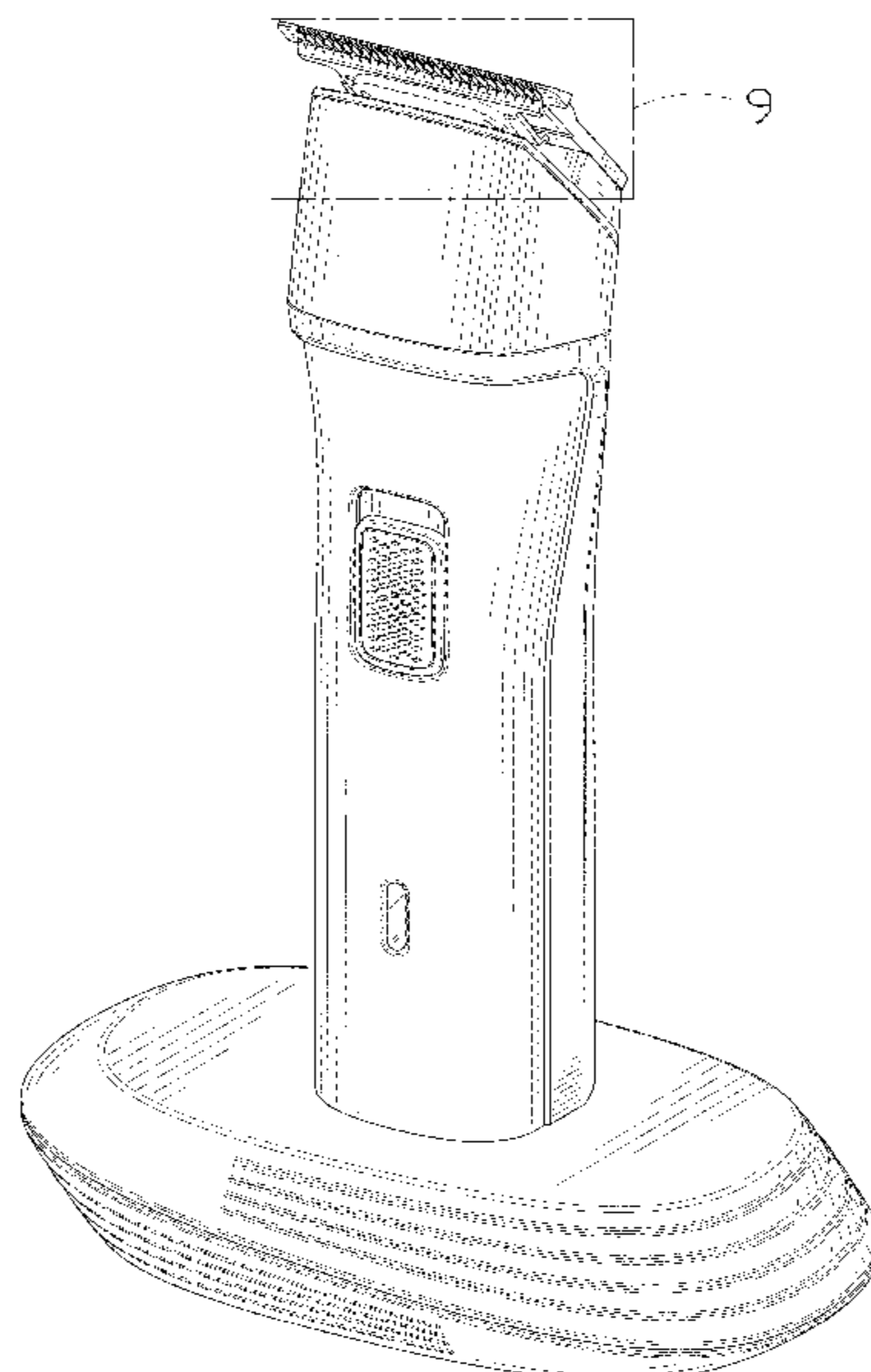
(57) **CLAIM**

The ornamental design for a combined hair clipper and stand, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combined hair clipper and stand, showing my design.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a rear elevation view thereof.
FIG. 4 is a left side elevation thereof.
FIG. 5 is a right side elevation thereof.
FIG. 6 is a top plan view thereof.
FIG. 7 is a bottom plan view thereof.
FIG. 8 is an exploded view thereof; and,
FIG. 9 is an enlarged view of an area labeled 9 in FIG. 1.
The broken lines illustrate portions of the combined hair clipper and stand that form no part of the claimed design.

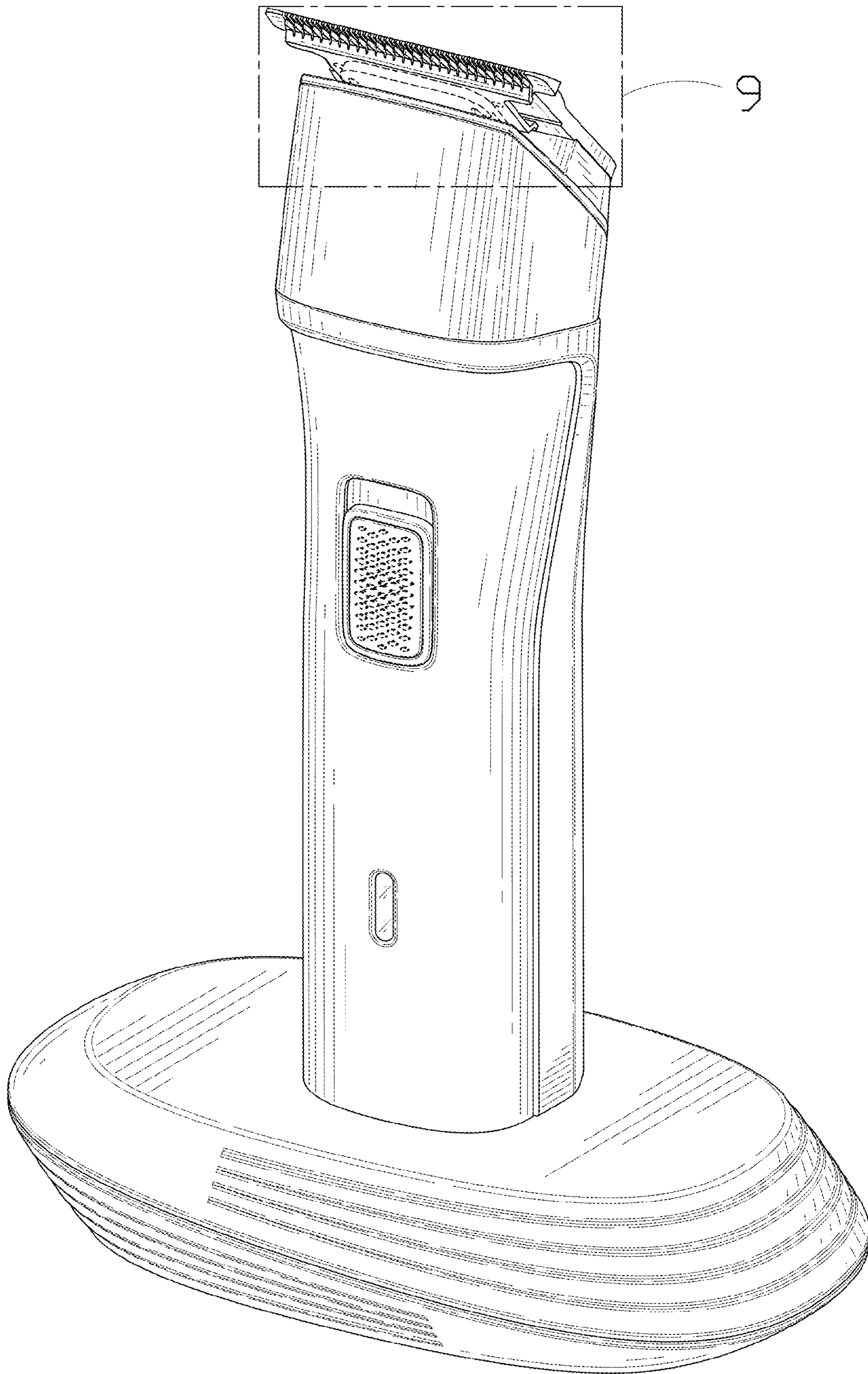

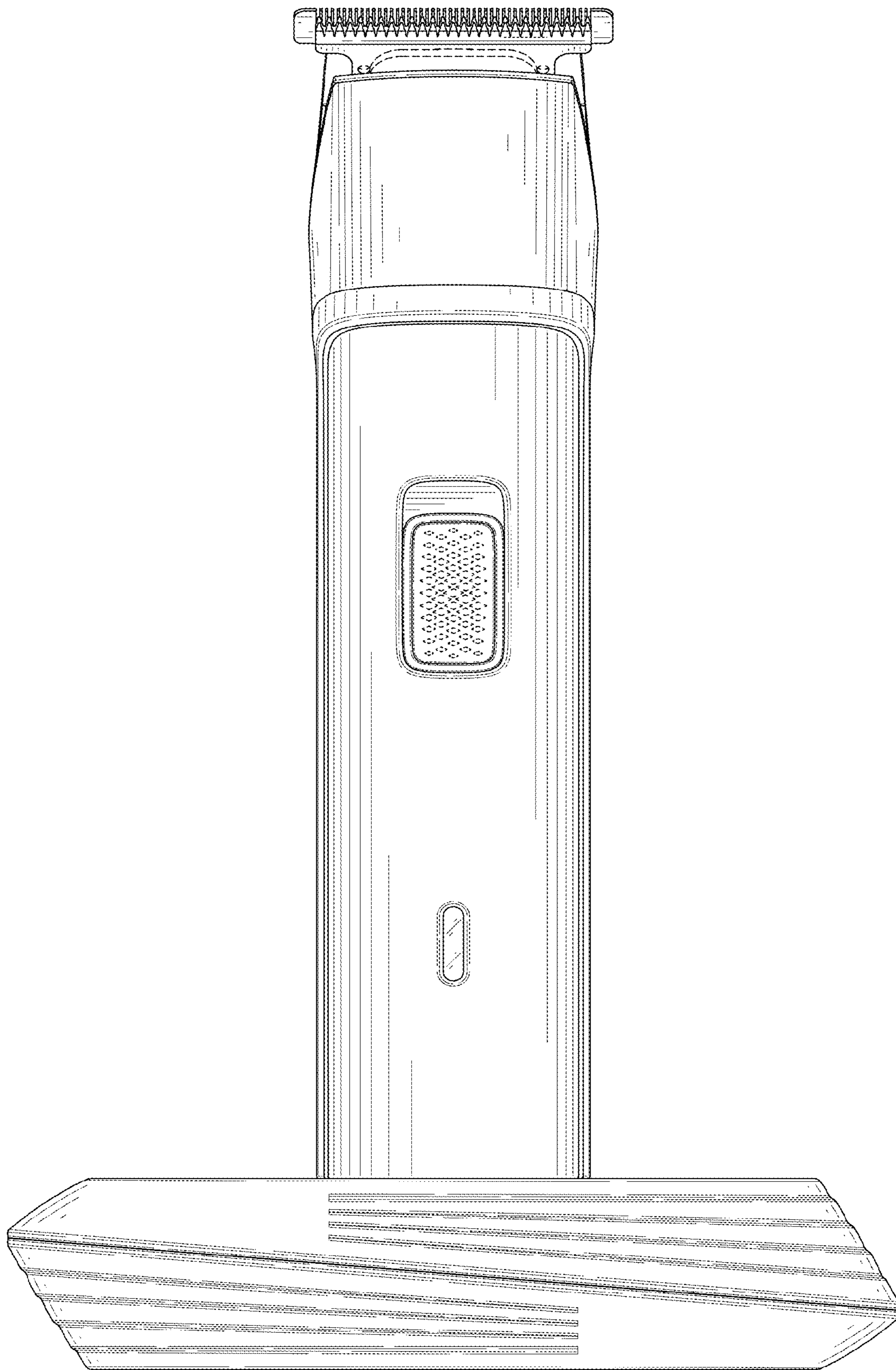

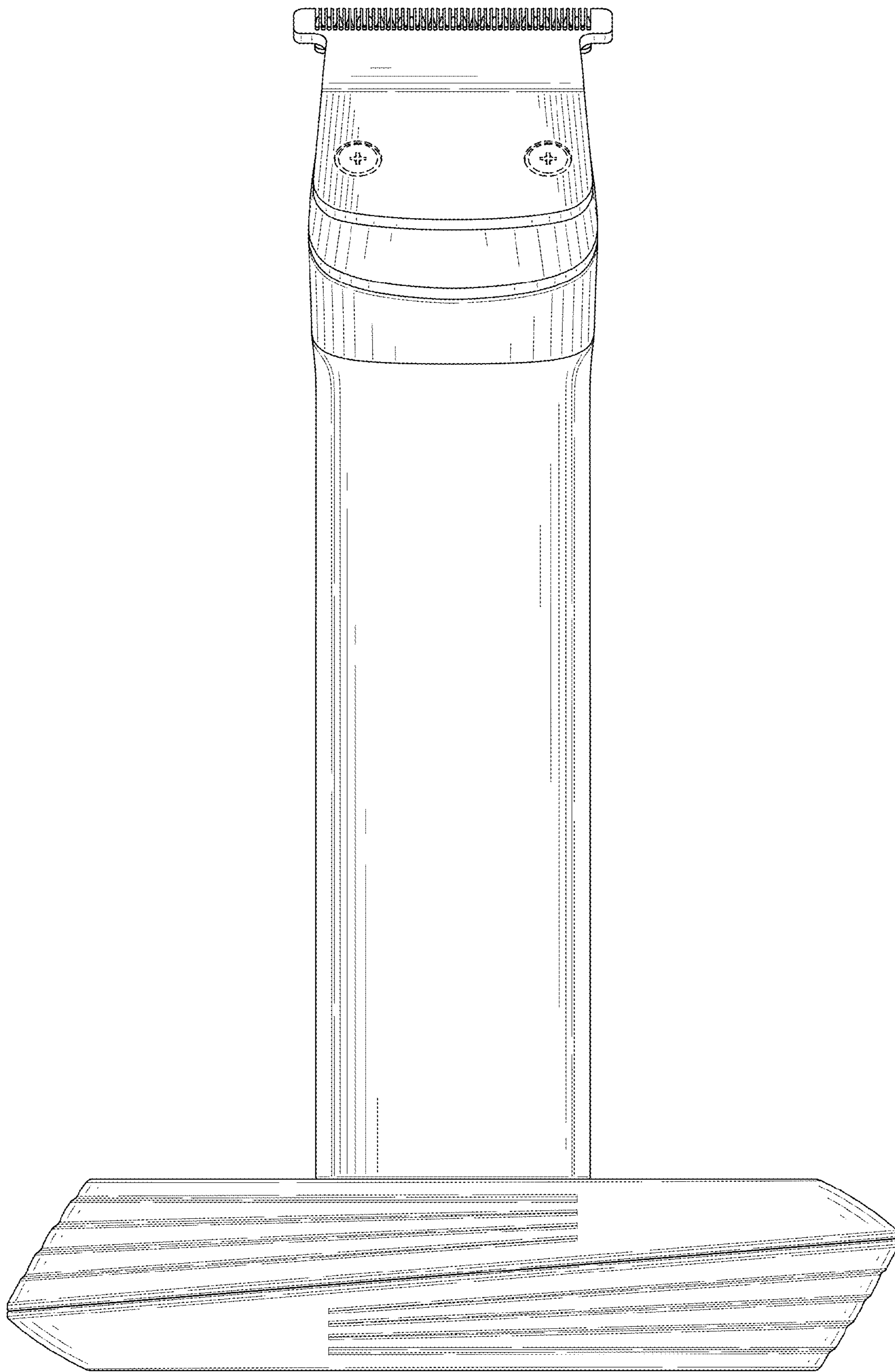

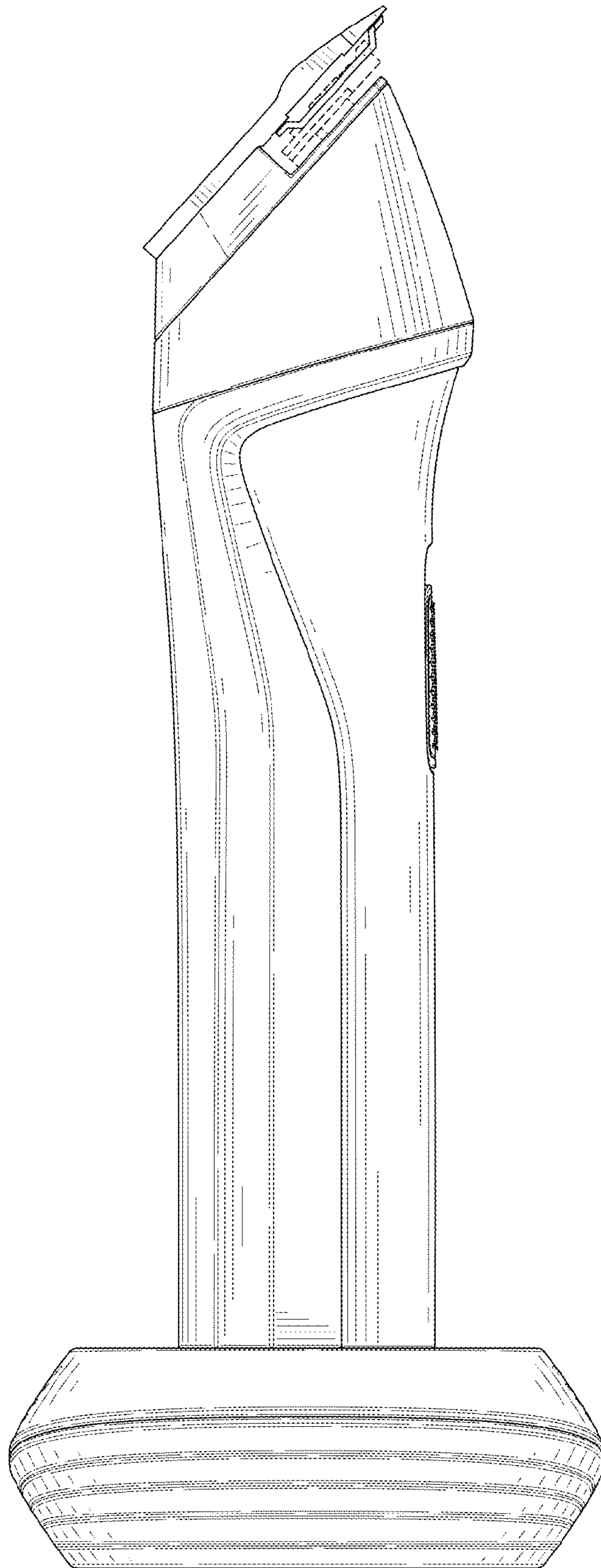

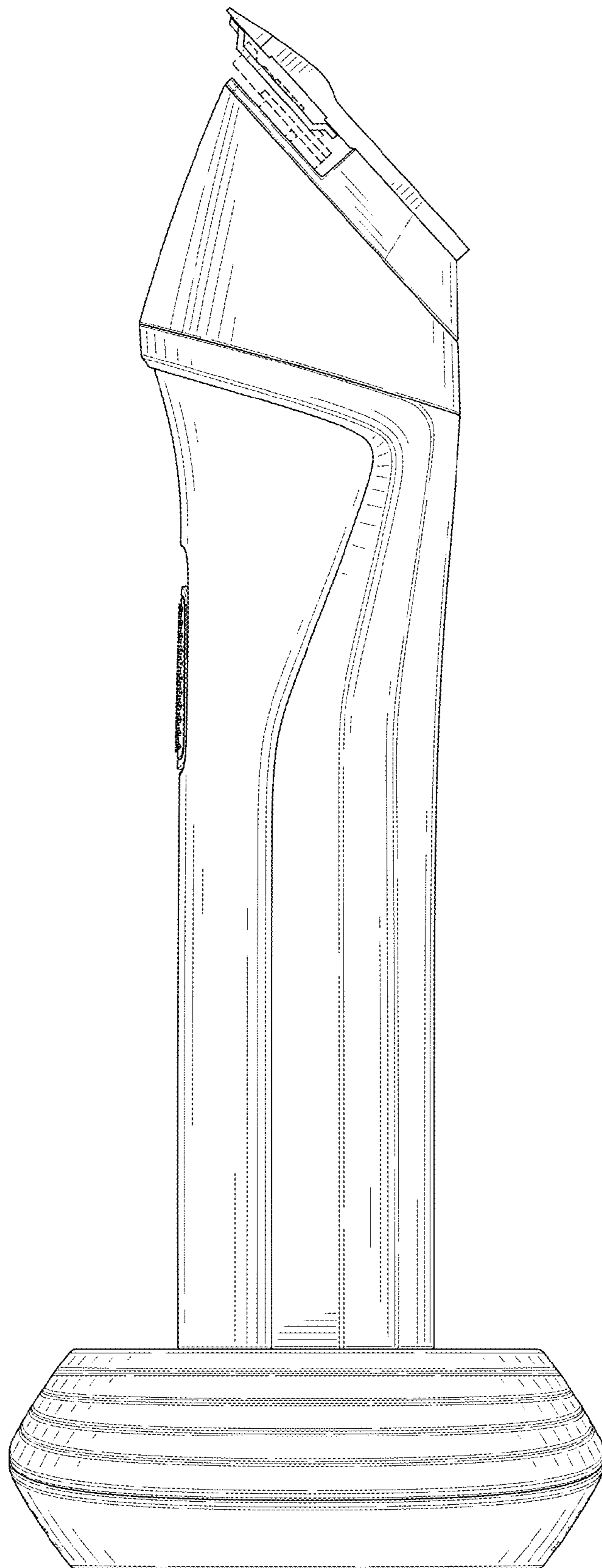

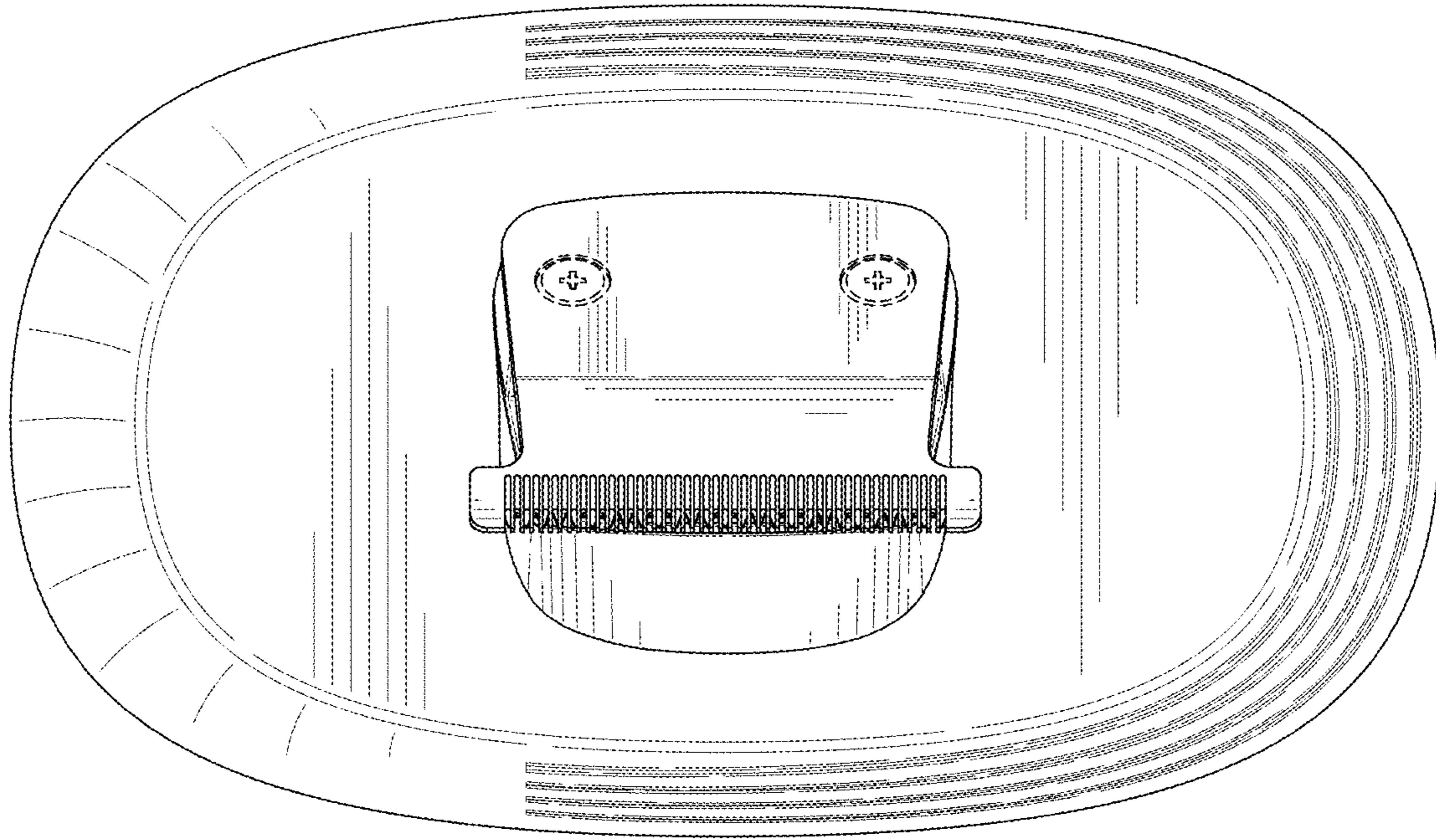

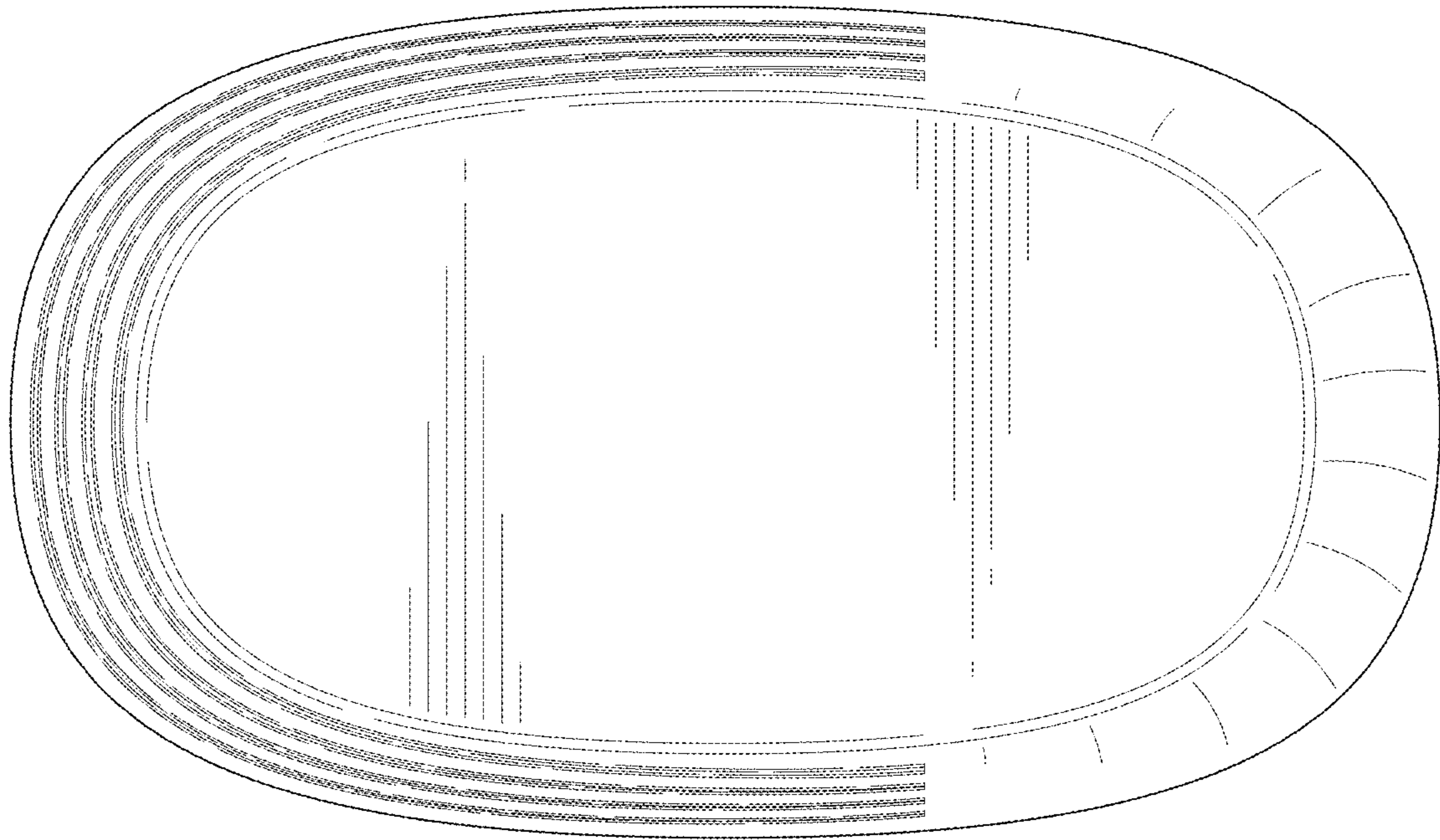

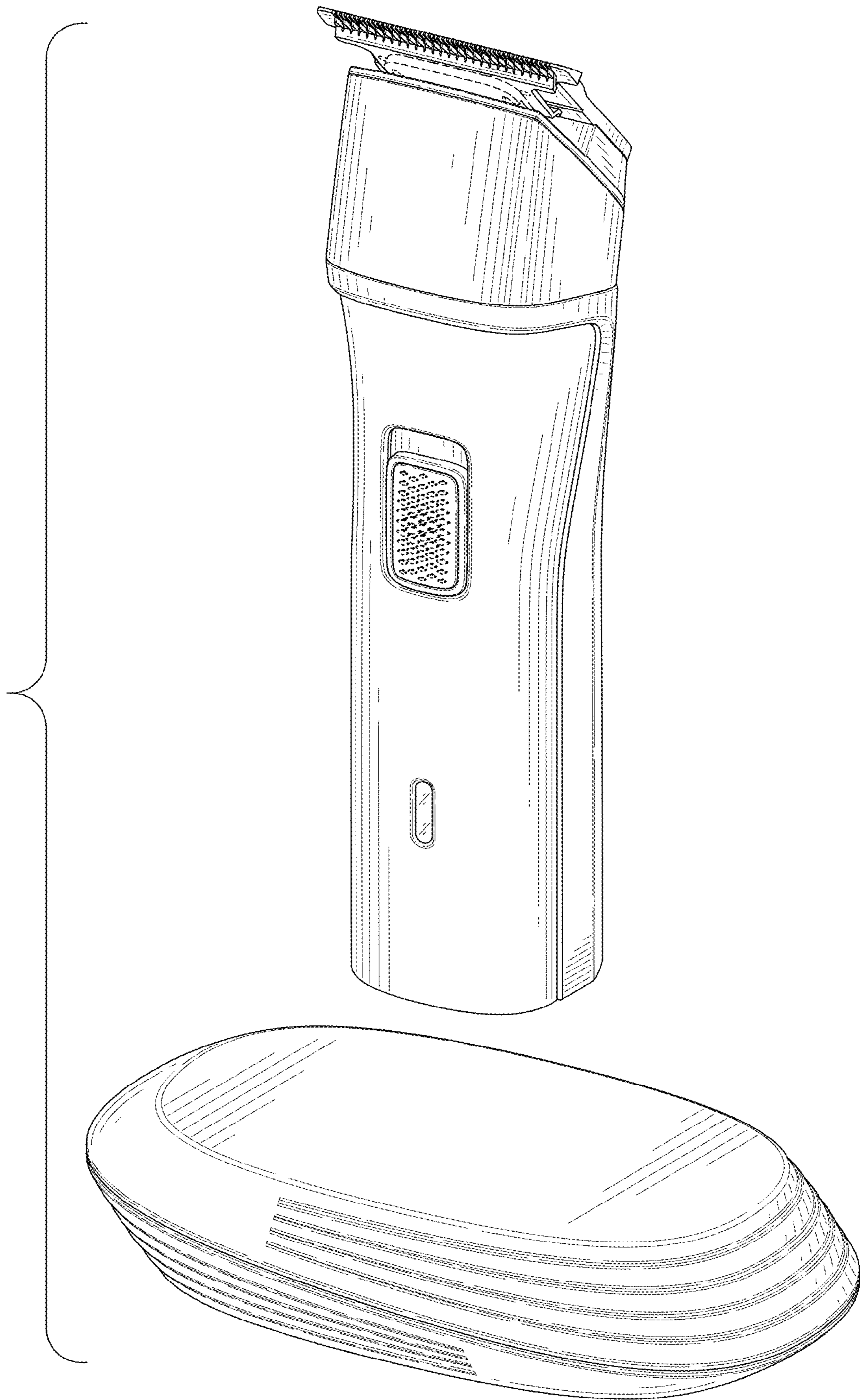

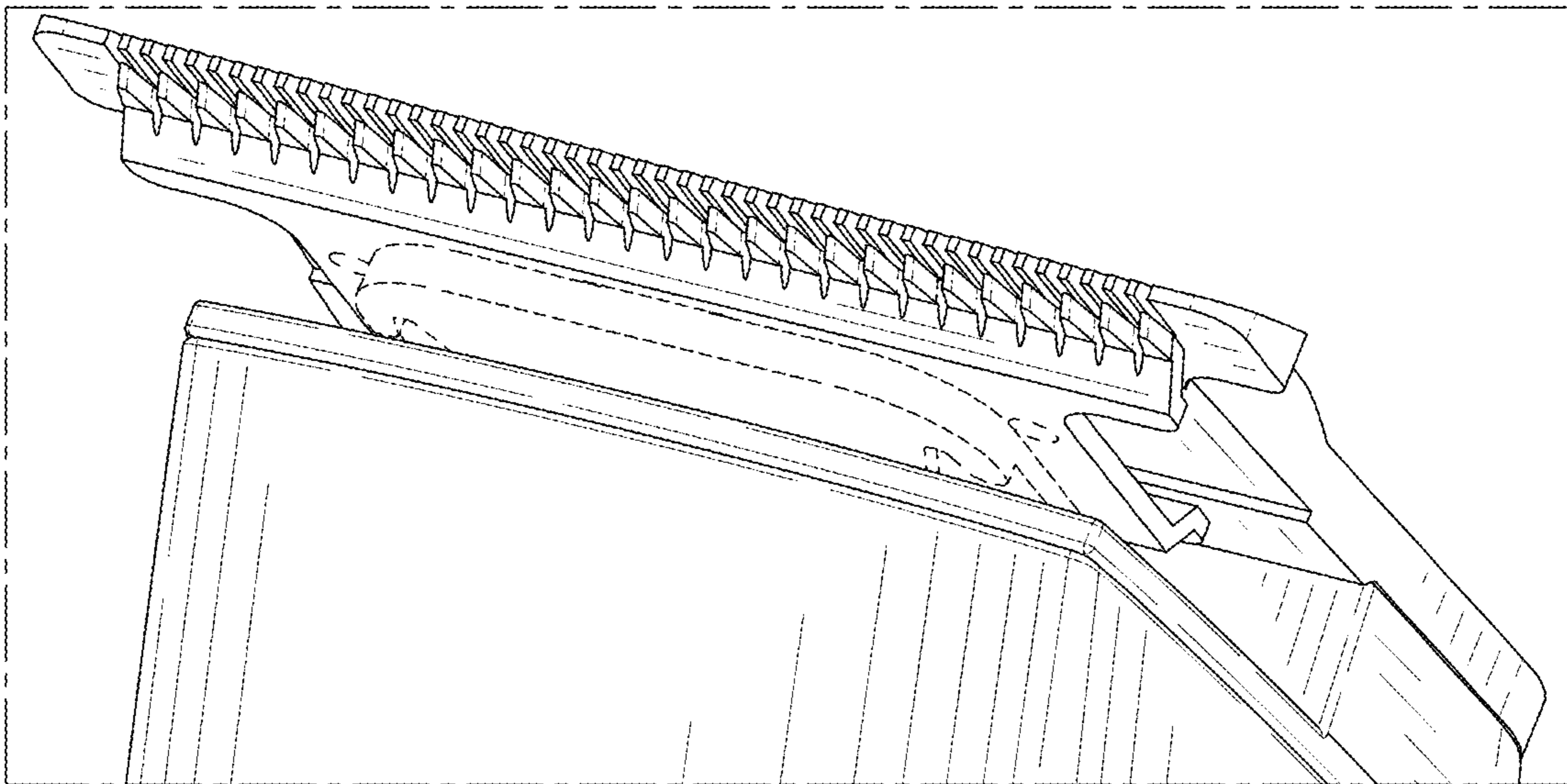
