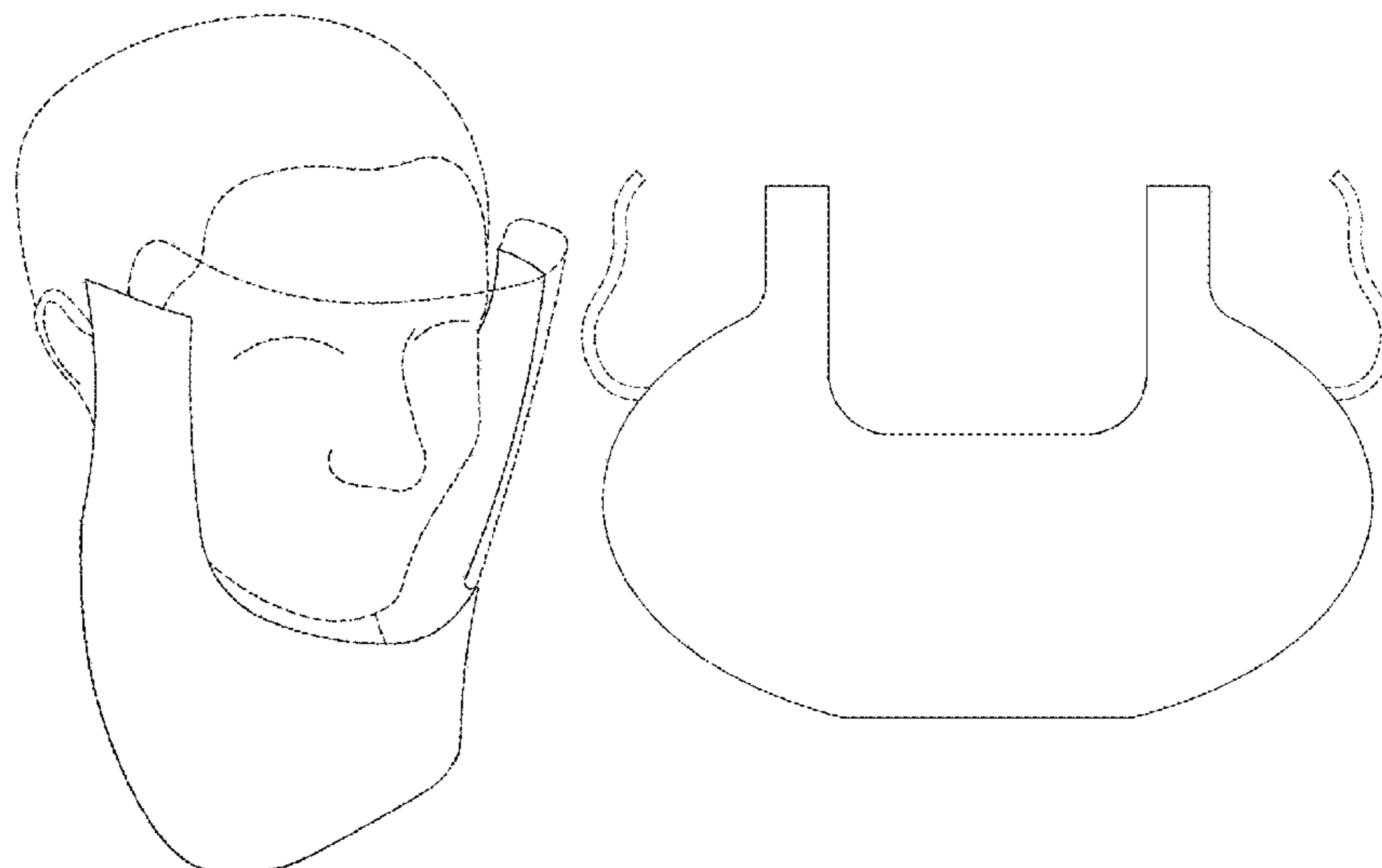
(57) **CLAIM**

The ornamental design for a face shield attachment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a face shield attachment of a first embodiment, showing my new design in an as-used configuration;  
FIG. 2 is a front elevation view of the face shield attachment of the first embodiment;  
FIG. 3 is a rear elevation view of the face shield attachment of the first embodiment;  
FIG. 4 is a top plan view of the face shield attachment of the first embodiment;  
FIG. 5 is a bottom plan view of the face shield attachment of the first embodiment;  
FIG. 6 is a left side elevation view of the face shield attachment of the first embodiment;  
FIG. 7 is a right side elevation view of the face shield attachment of the first embodiment;  
FIG. 8 is a perspective view of a face shield attachment of a second embodiment in an as-used configuration;  
FIG. 9 is a front elevation view of the face shield attachment of the second embodiment;  
FIG. 10 is a rear elevation view of the face shield attachment of the second embodiment;  
FIG. 11 is a top plan view of the face shield attachment of the second embodiment;  
FIG. 12 is a bottom plan view of the face shield attachment of the second embodiment;  
FIG. 13 is a left side elevation view of the face shield attachment of the second embodiment; and,  
FIG. 14 is a right side elevation view of the face shield attachment of the second embodiment.

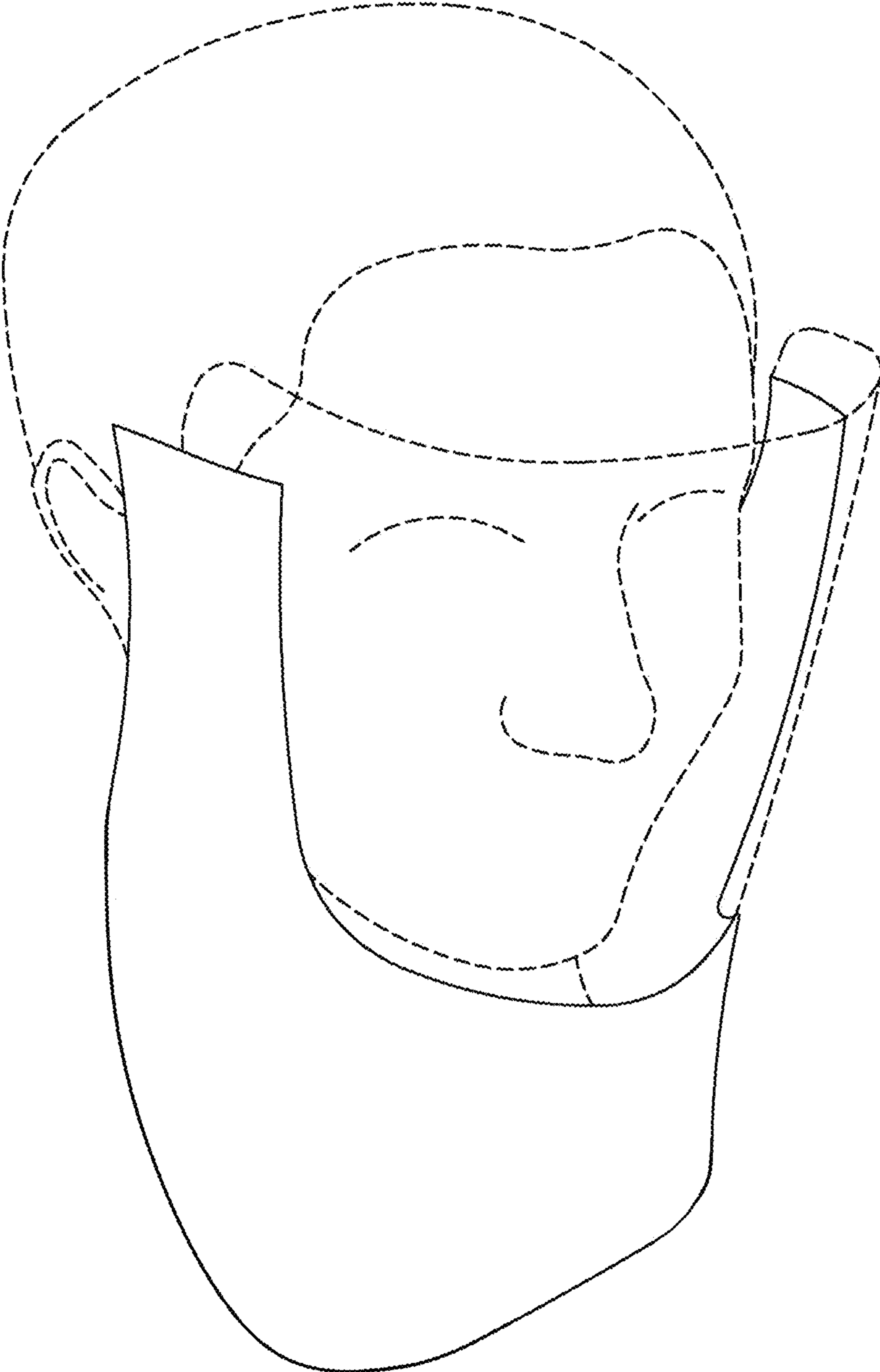

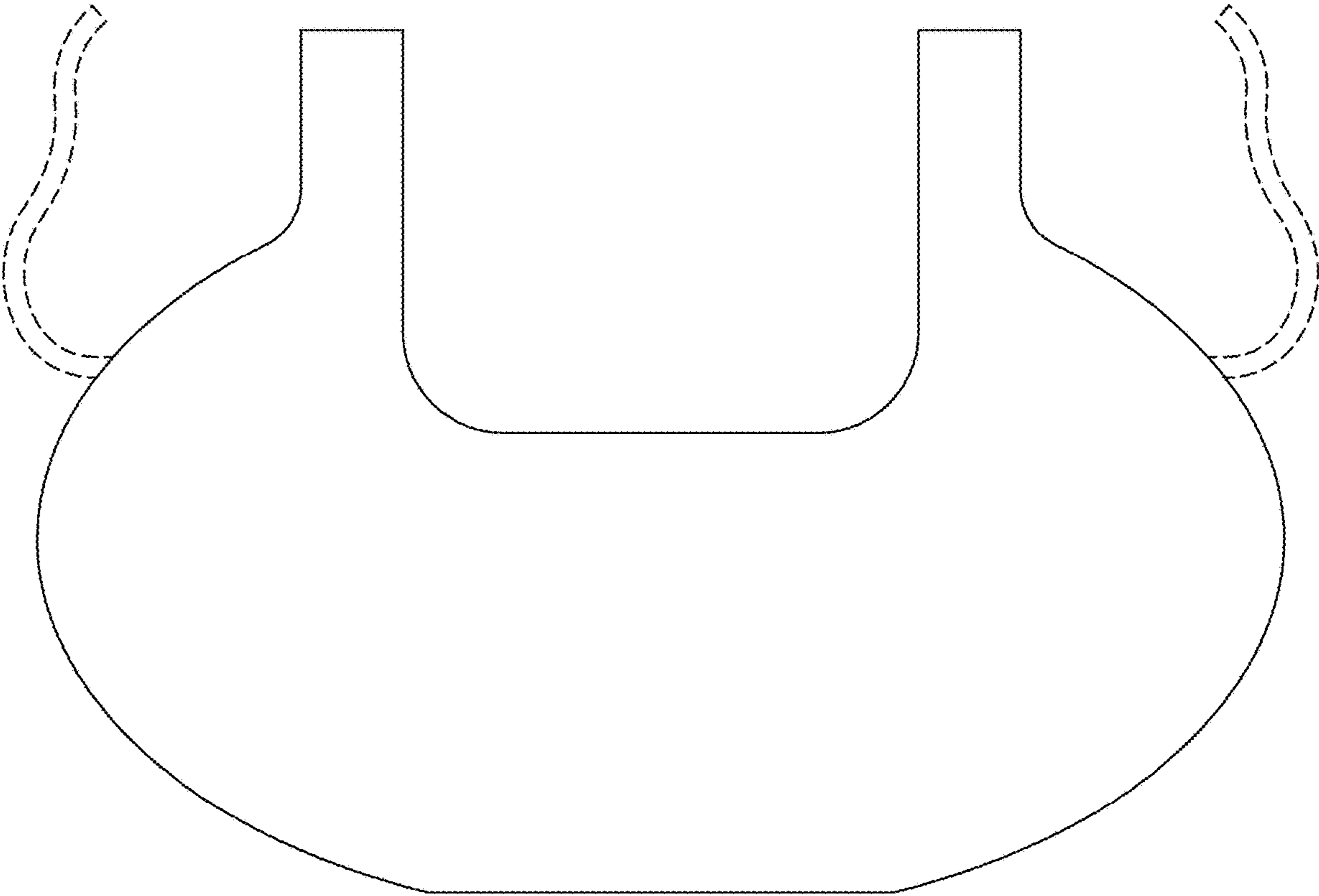

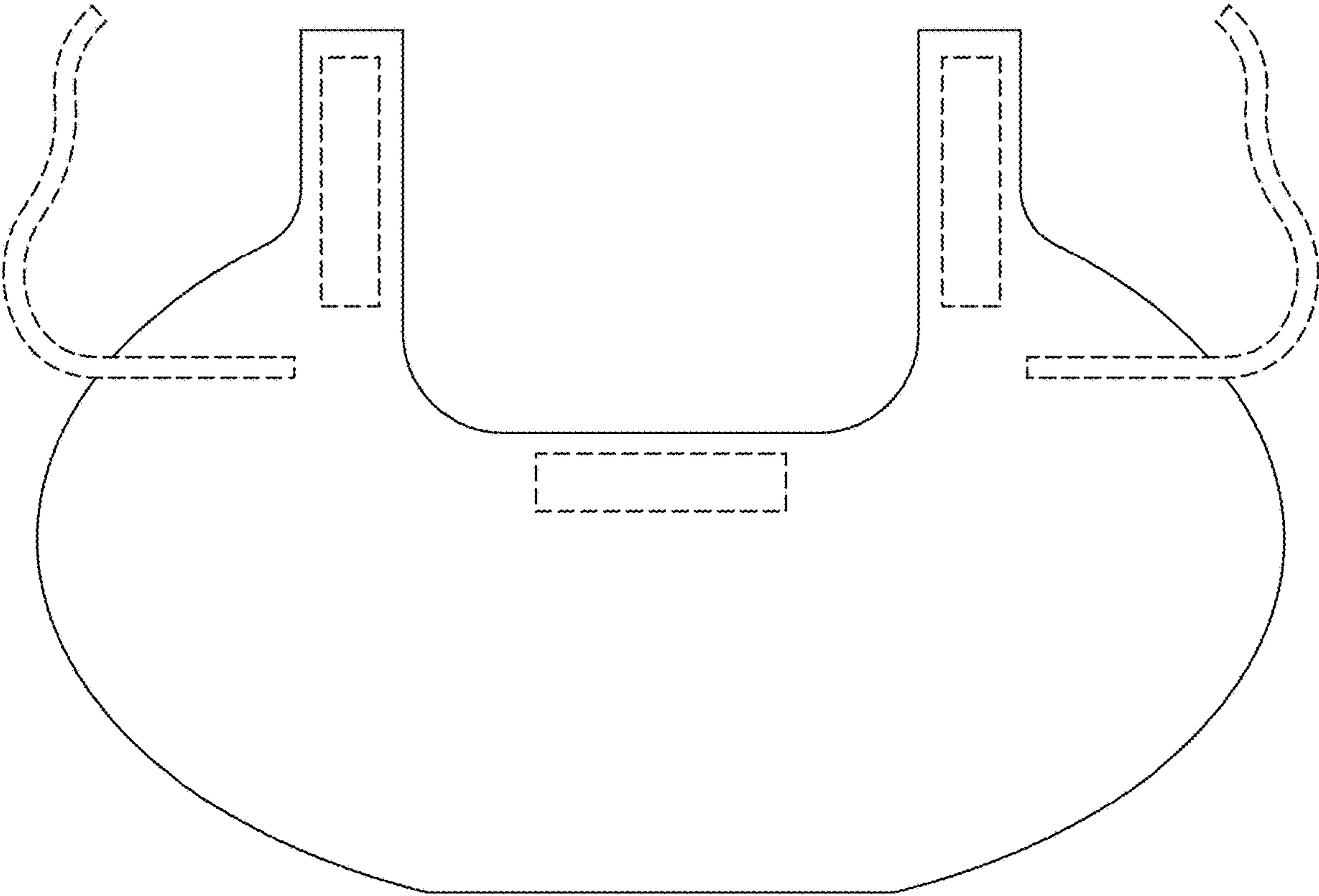

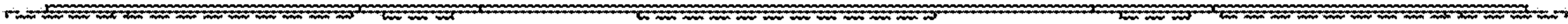

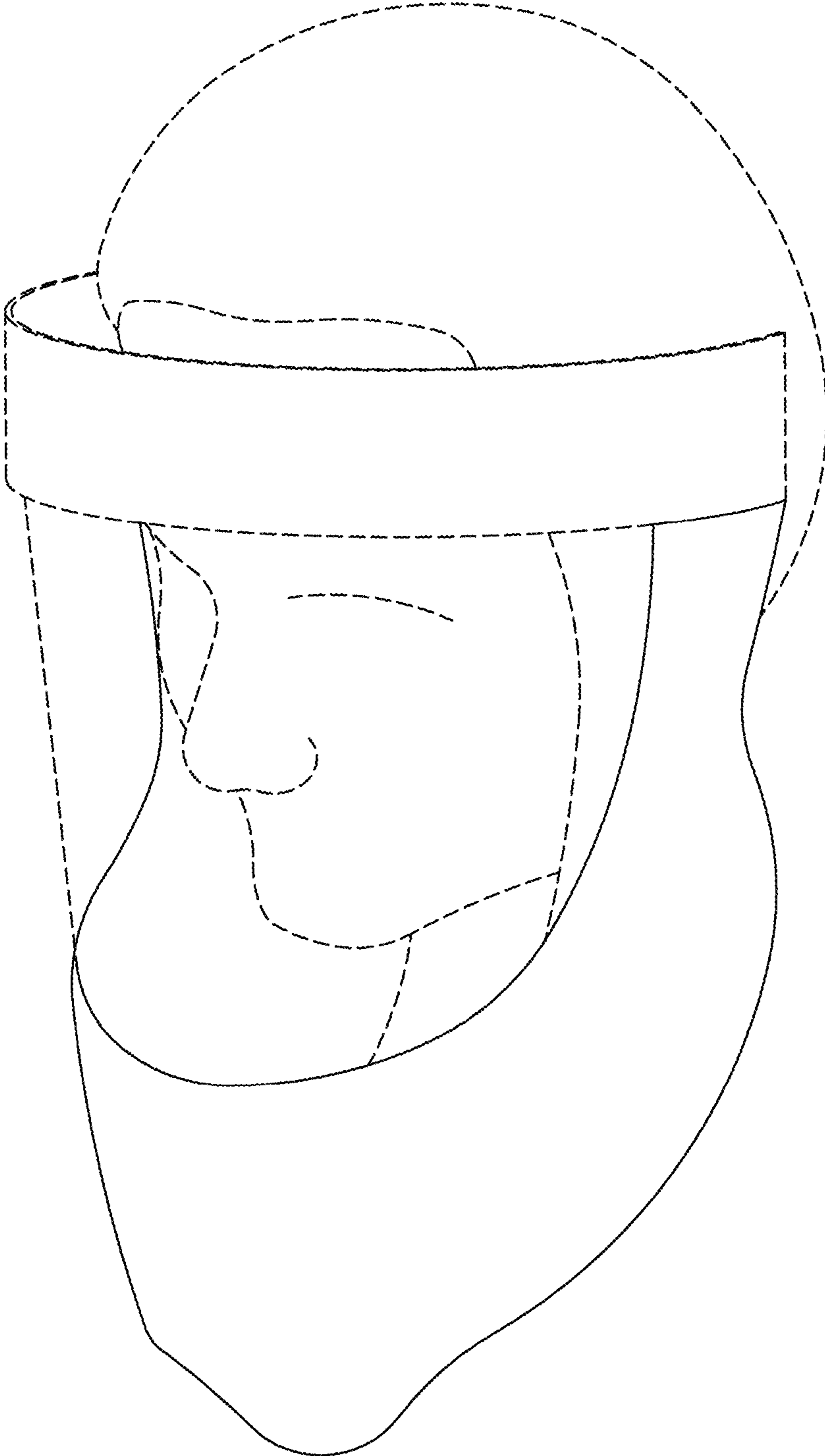

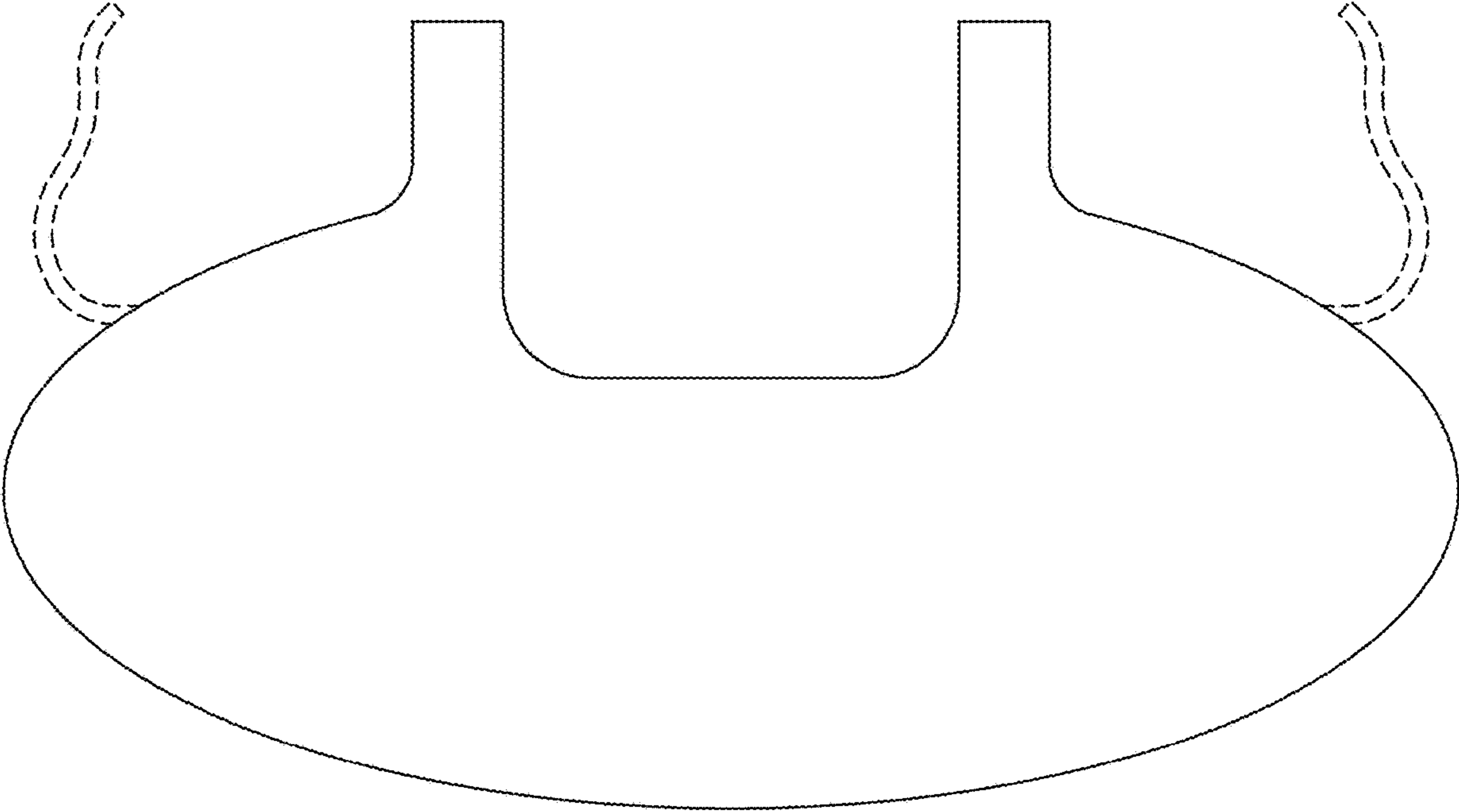

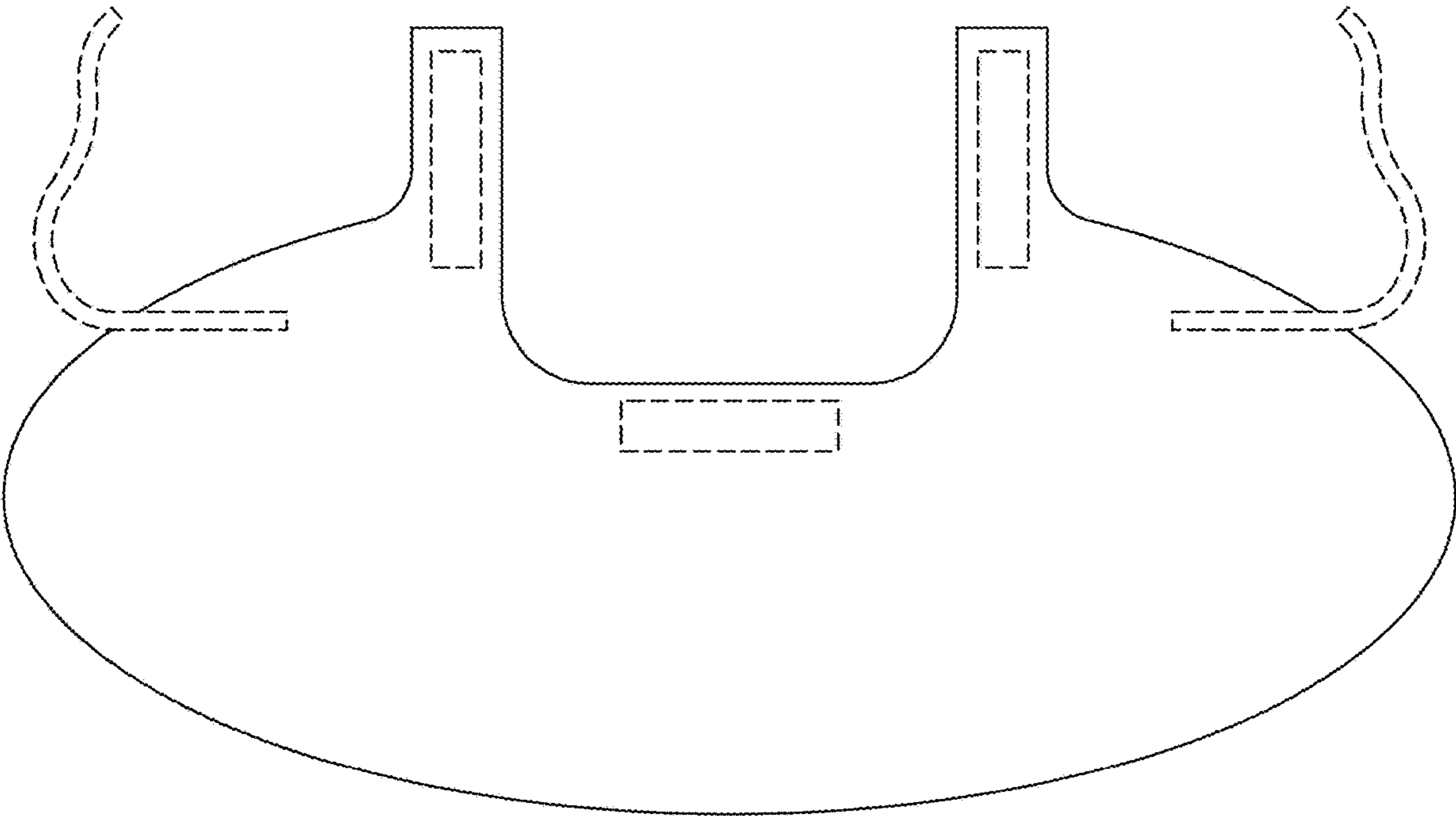

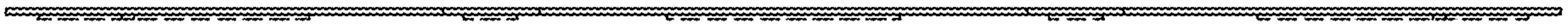

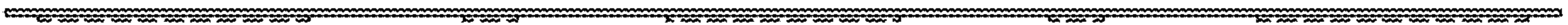

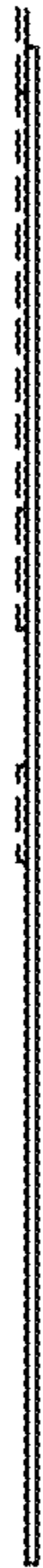
