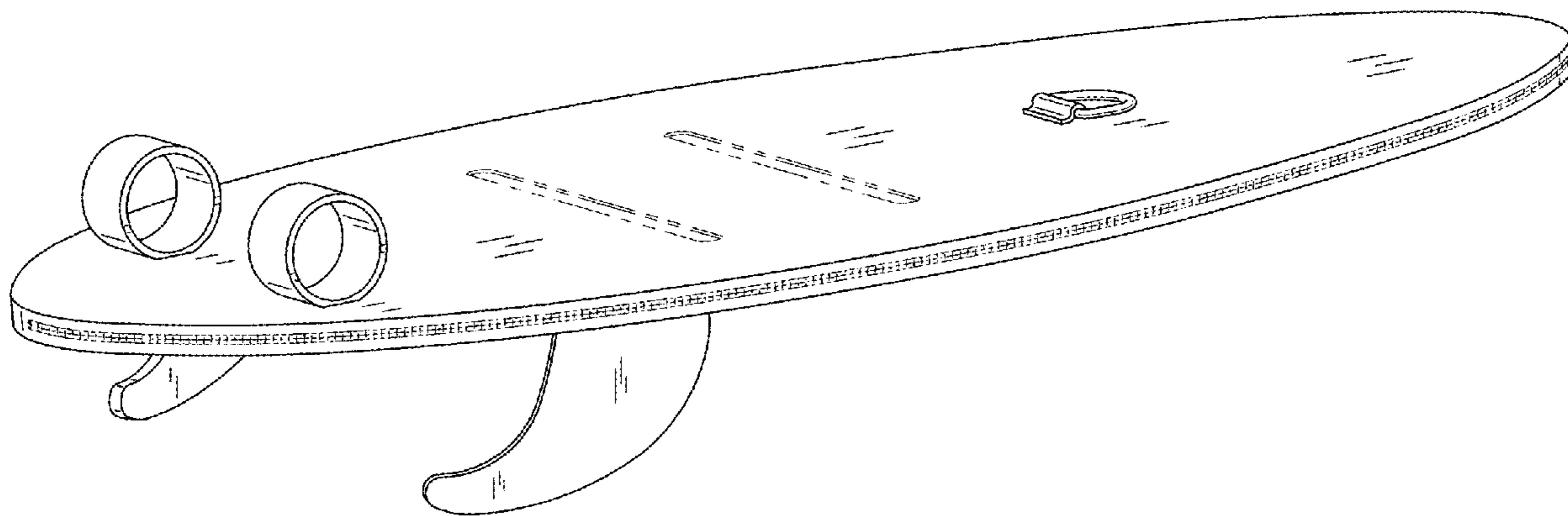
FIG. 1 is a top right perspective view of the dog backpack;

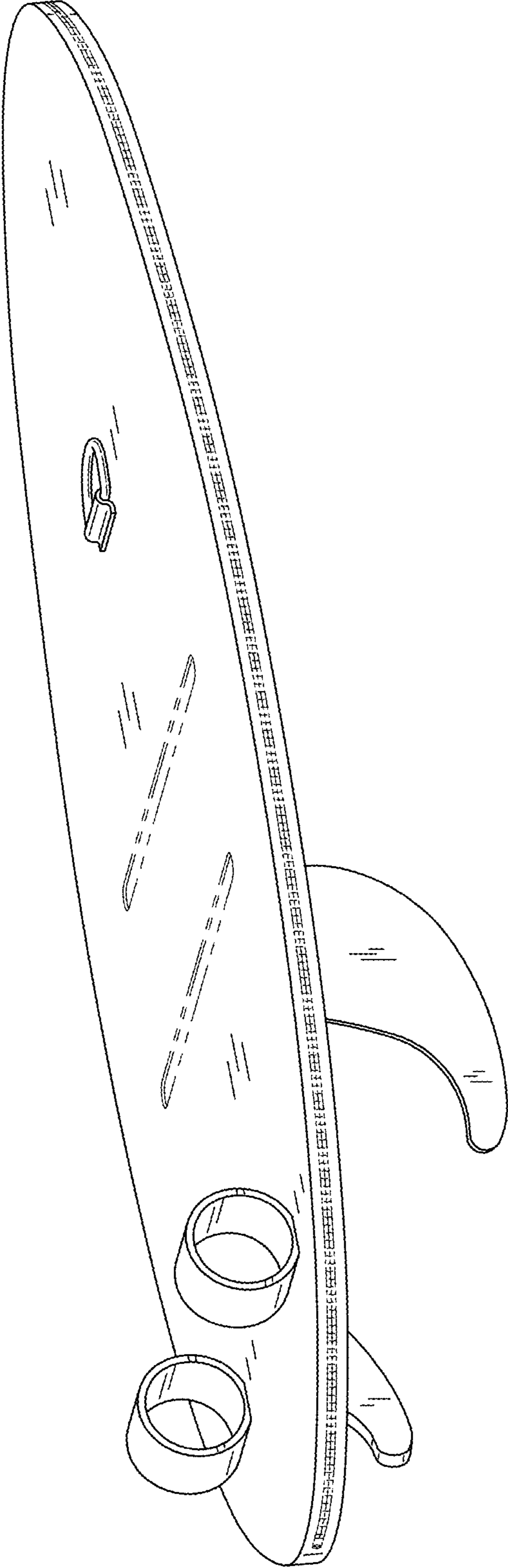

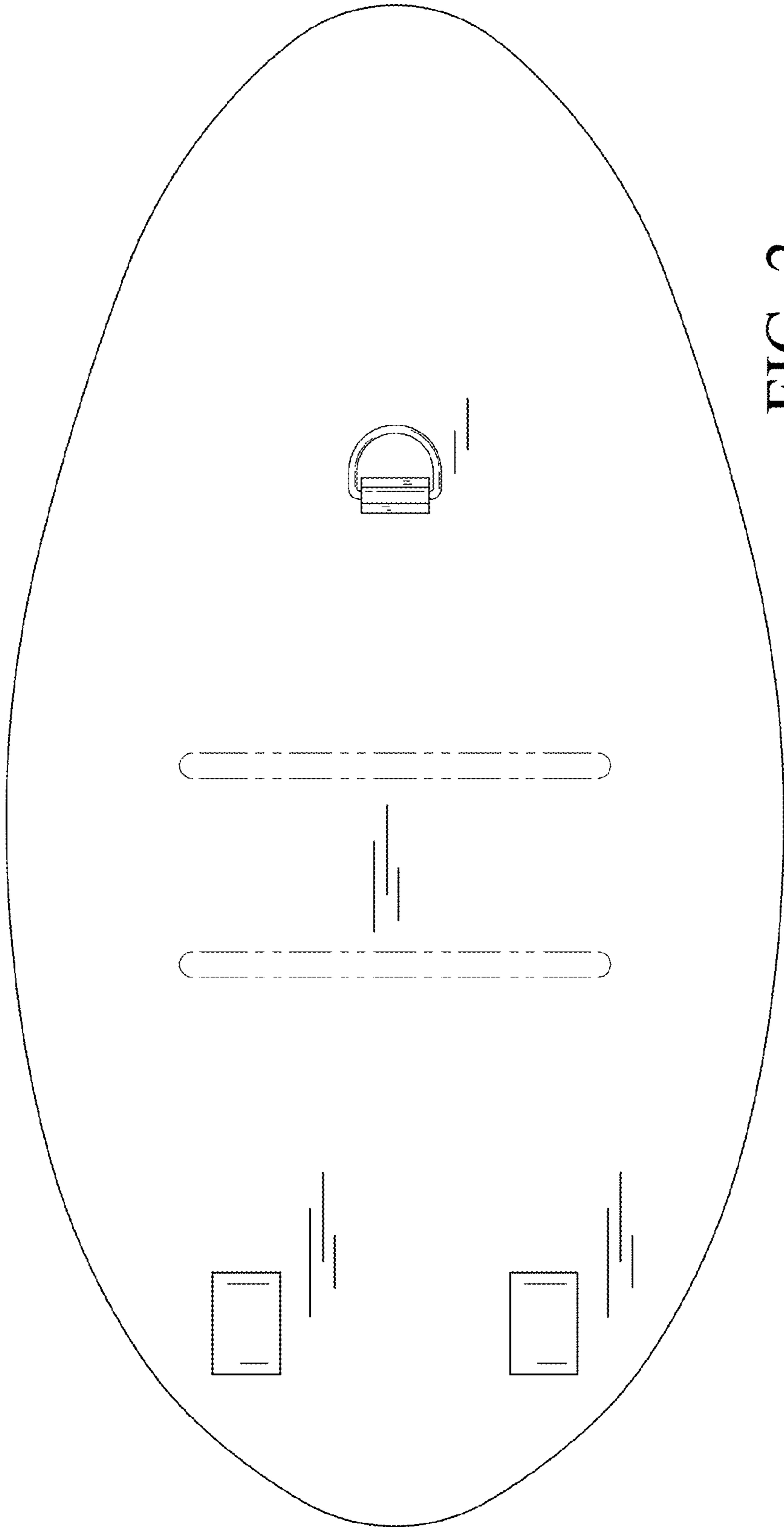

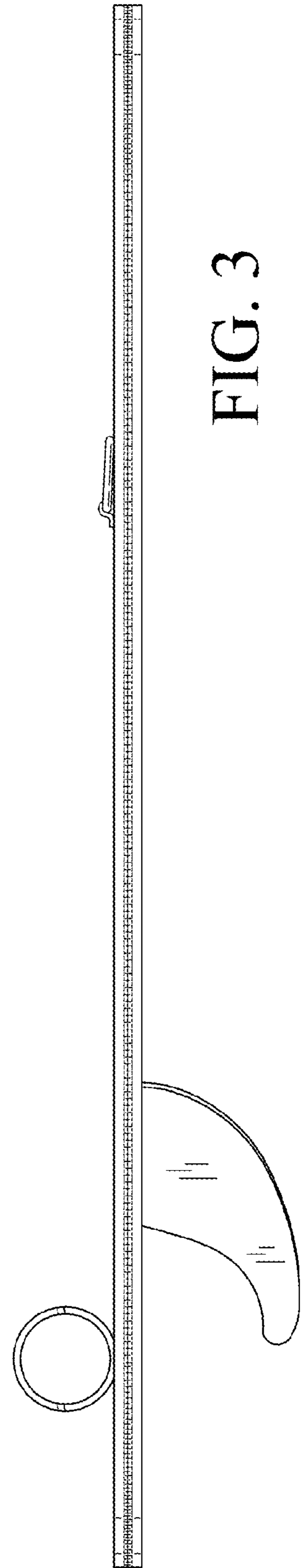

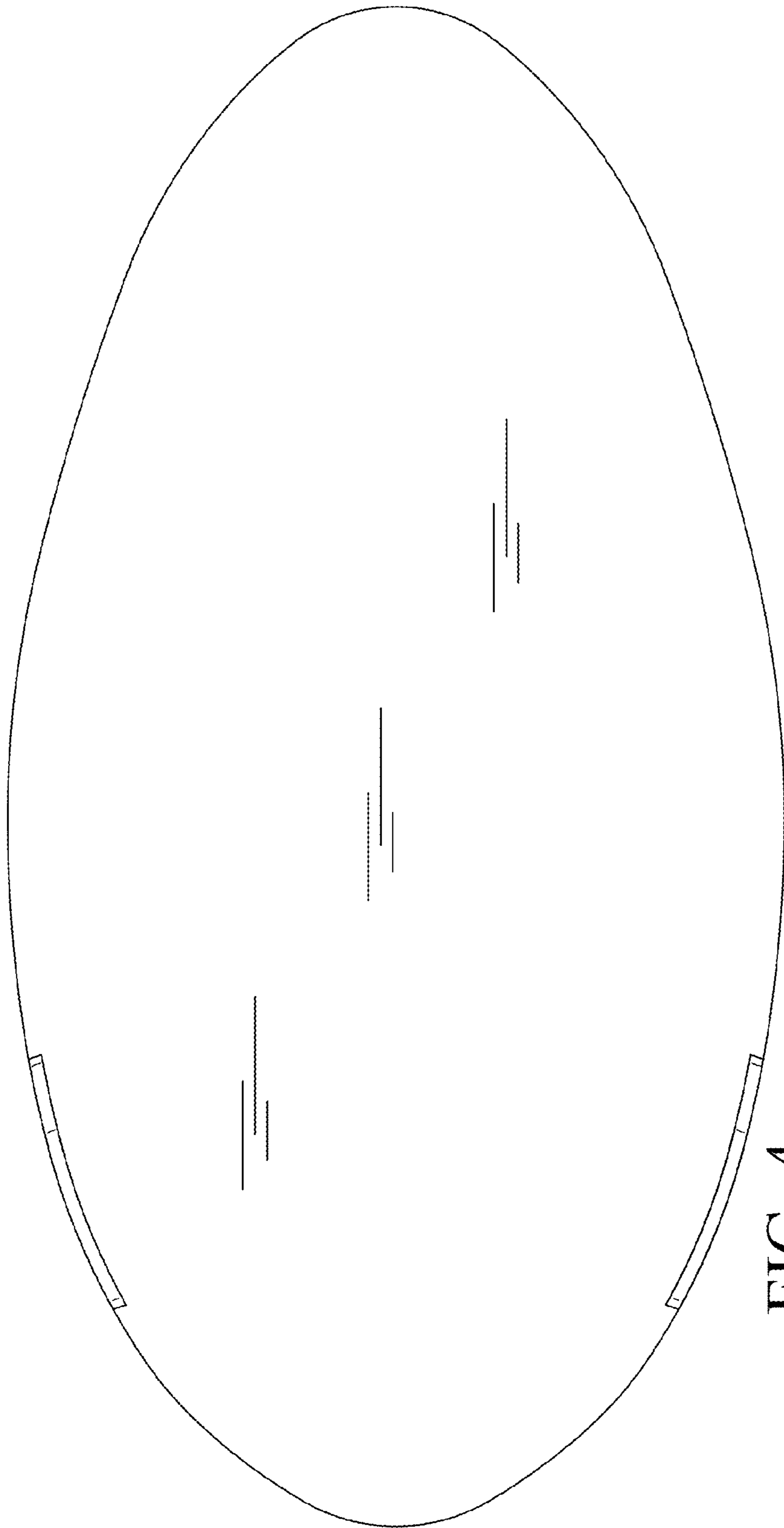

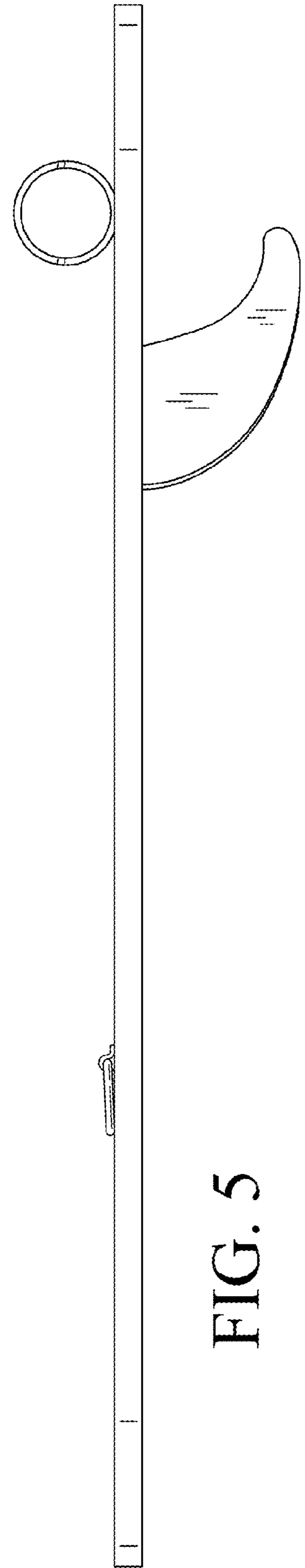

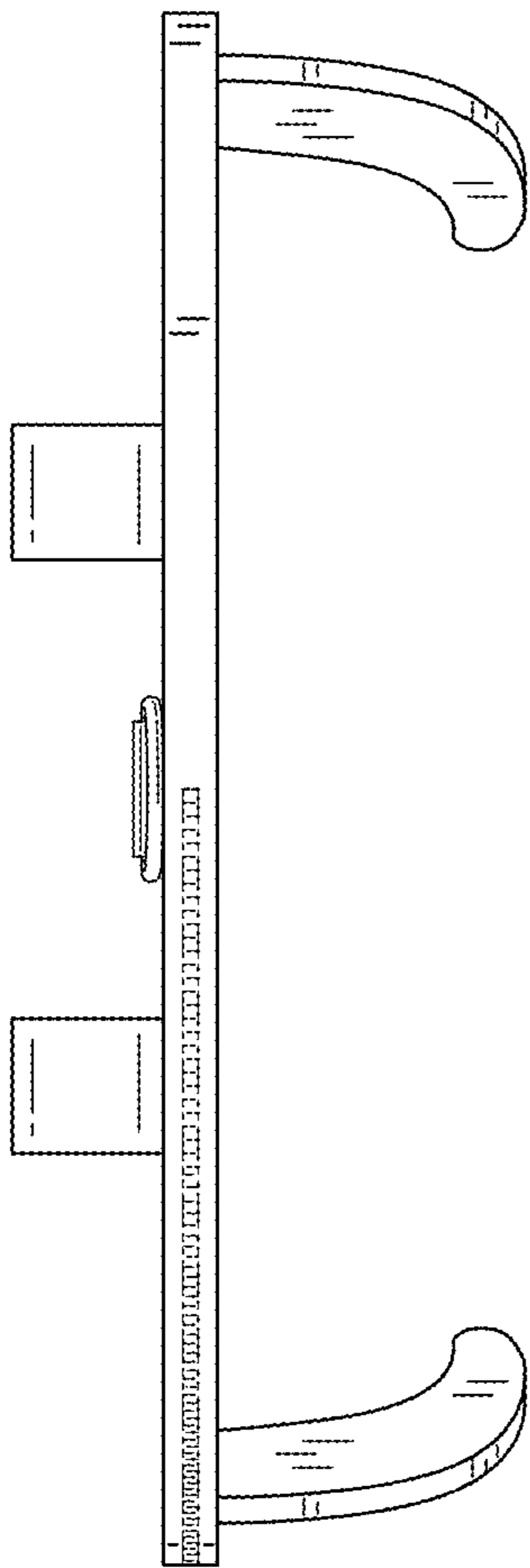

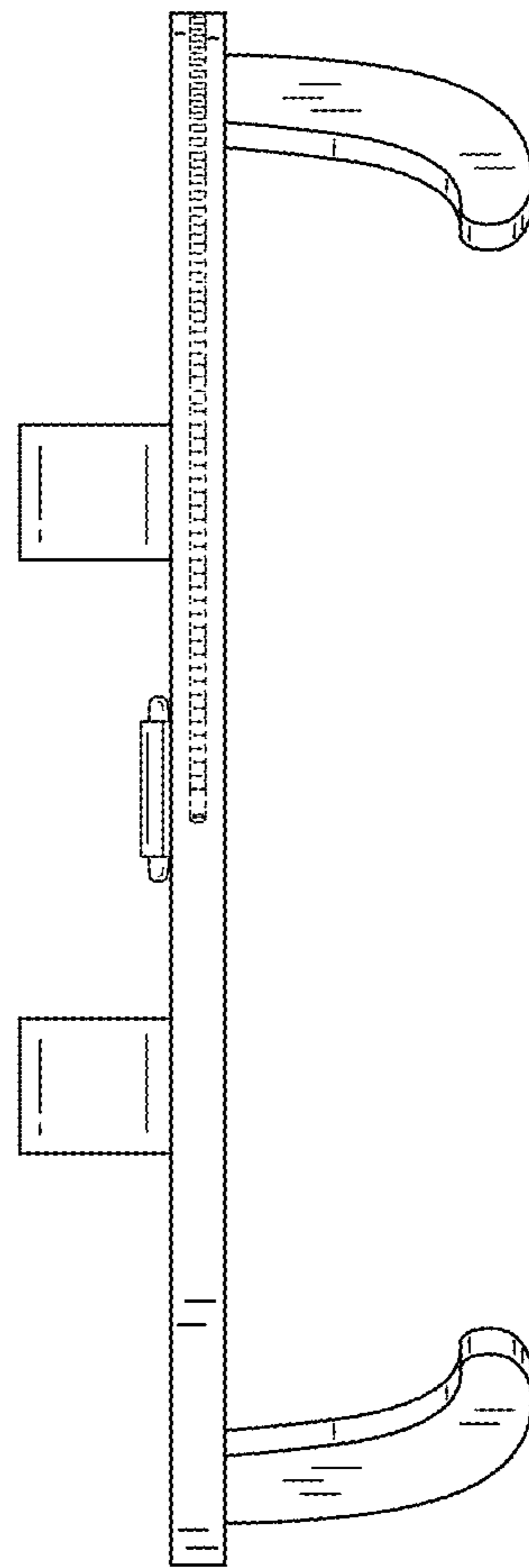
