DESCRIPTION

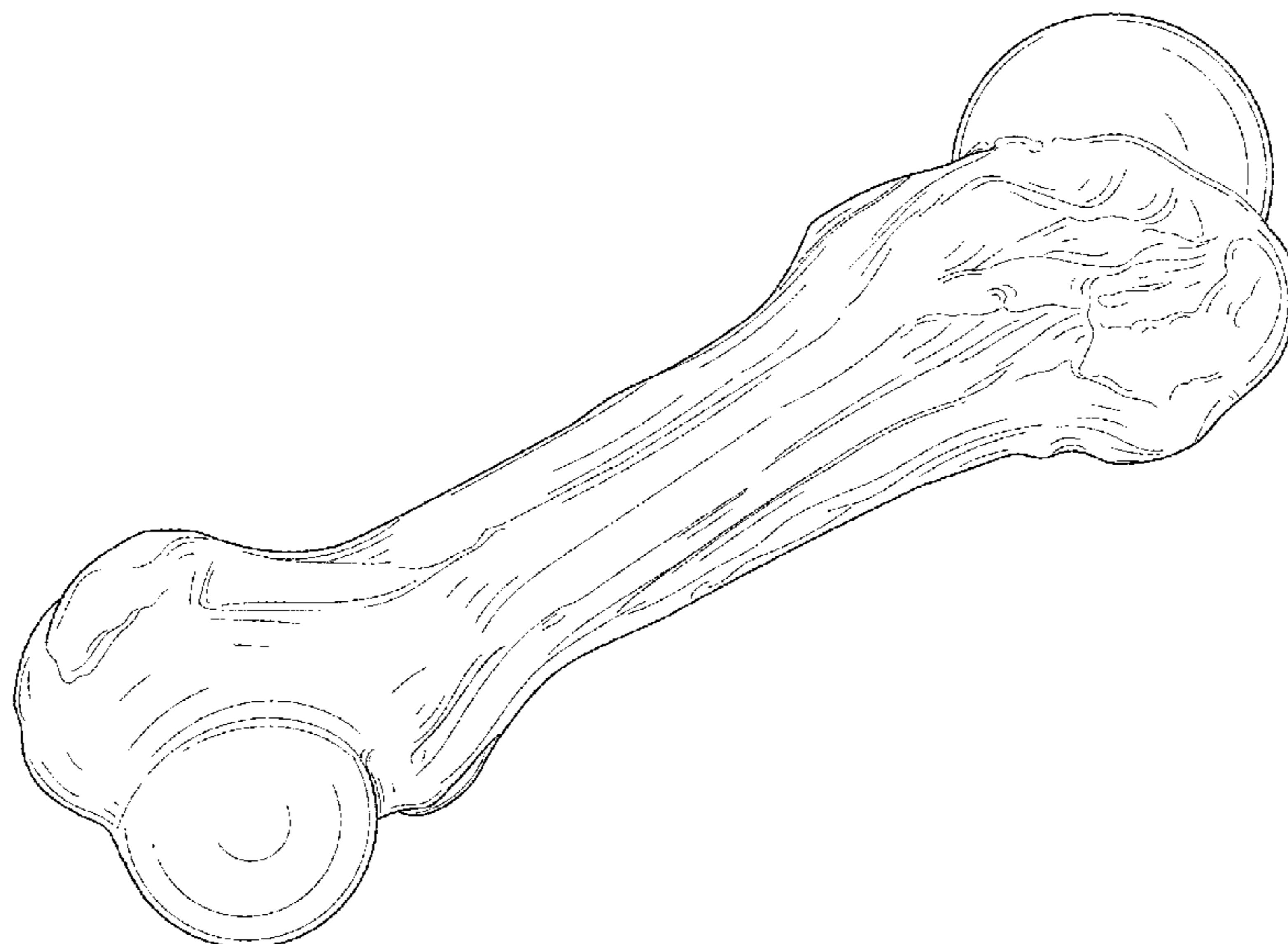
FIG. 1 is a perspective view of a dog chew toy according to the present disclosure.

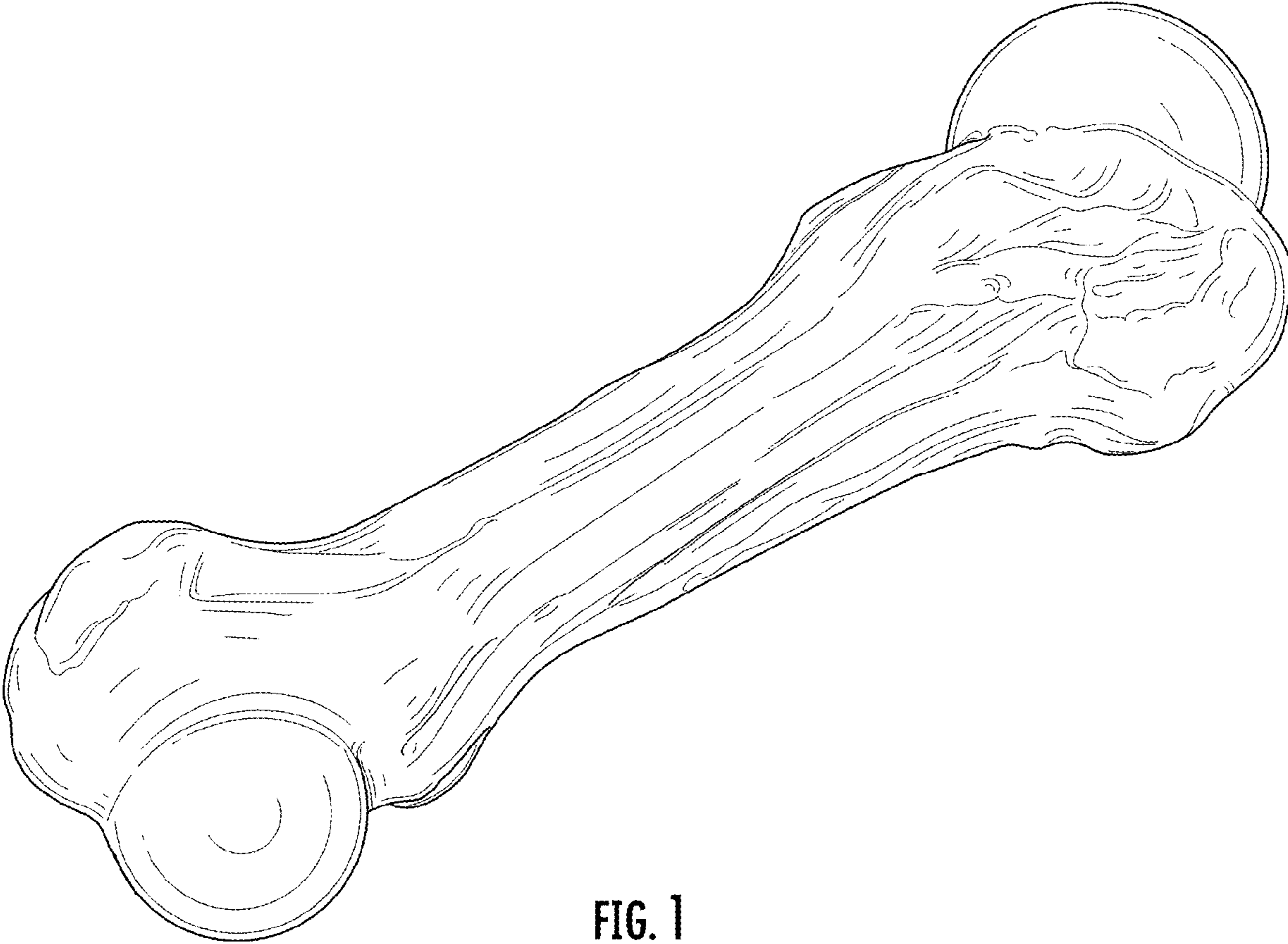

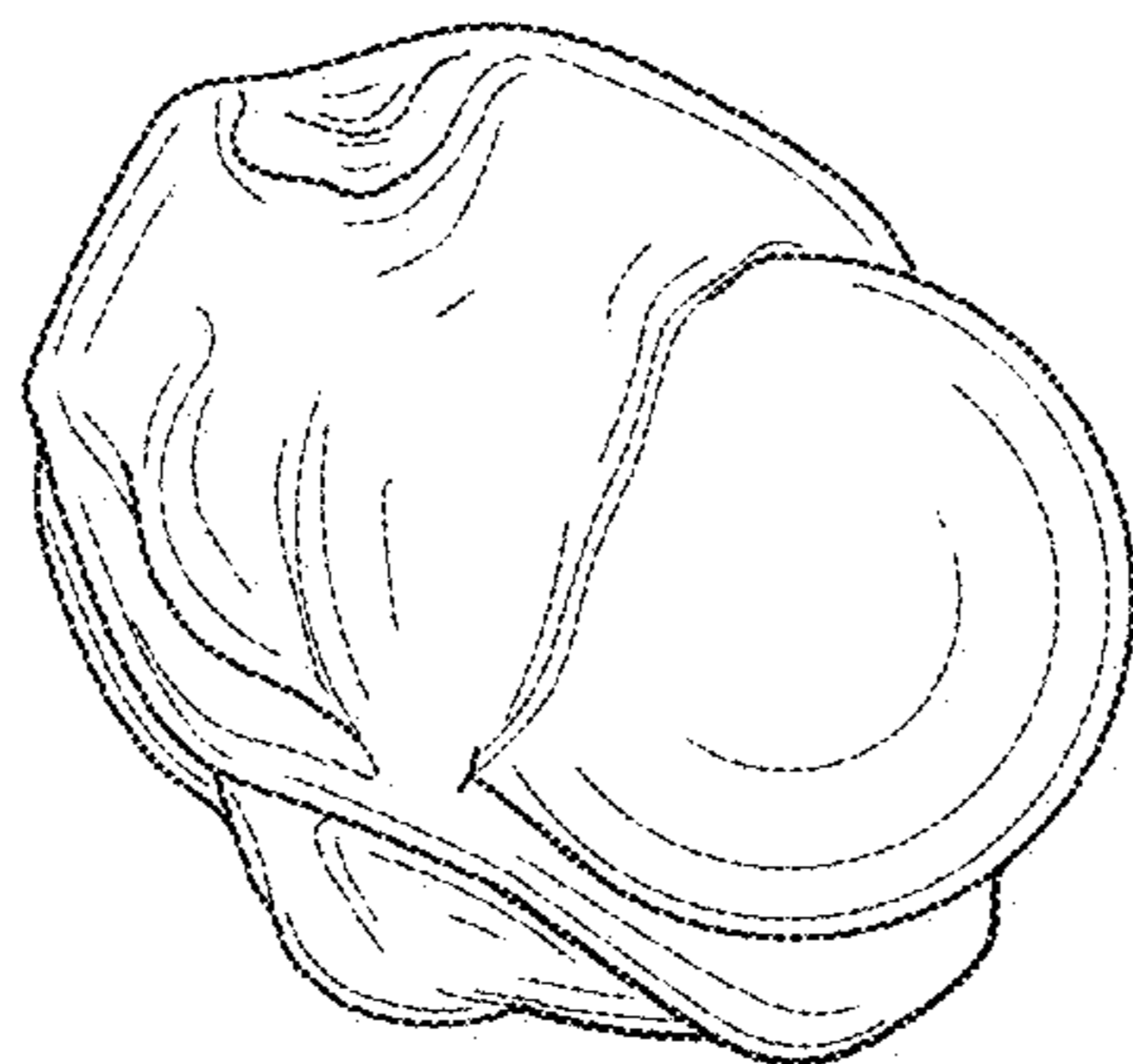

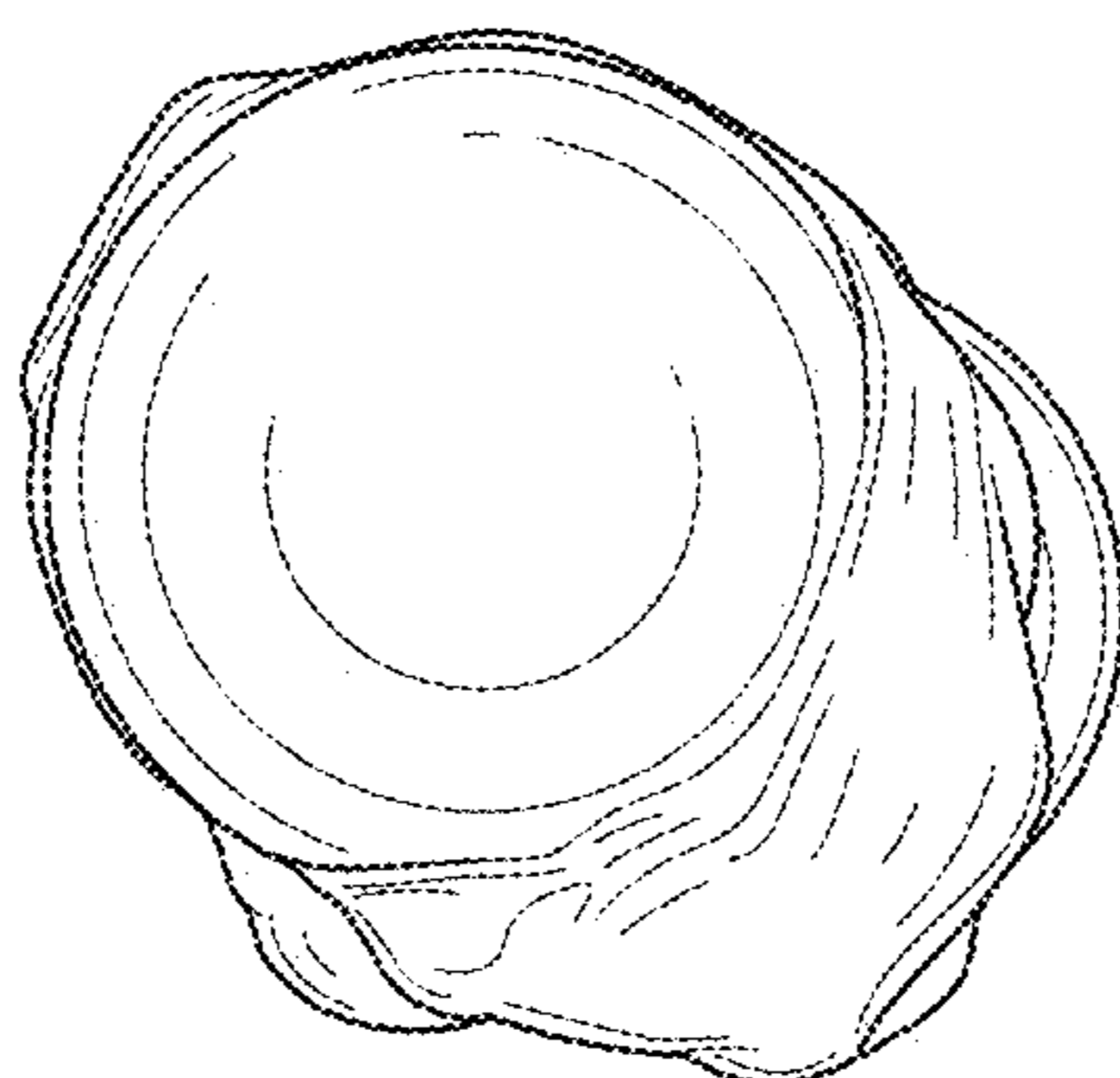

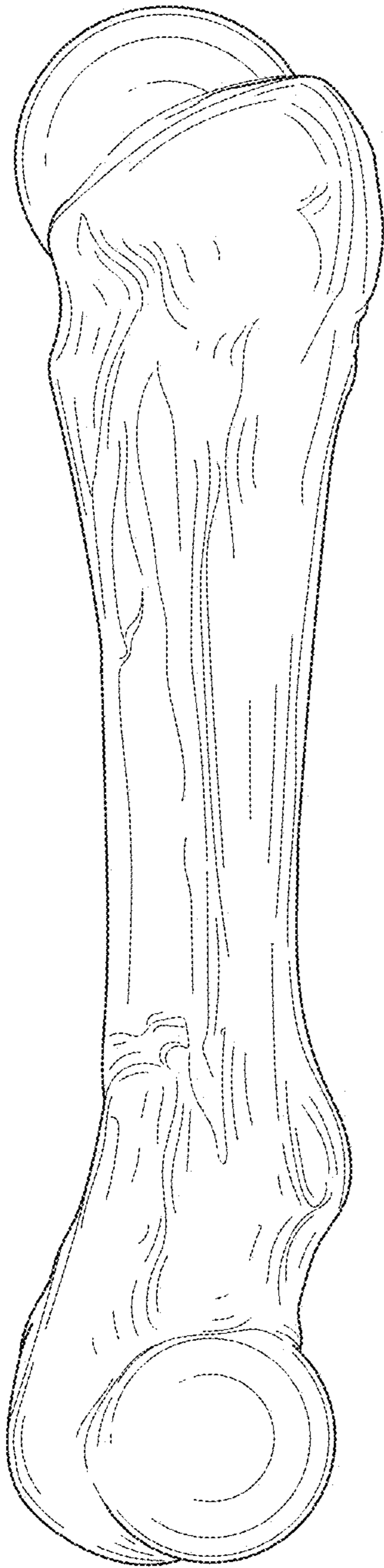

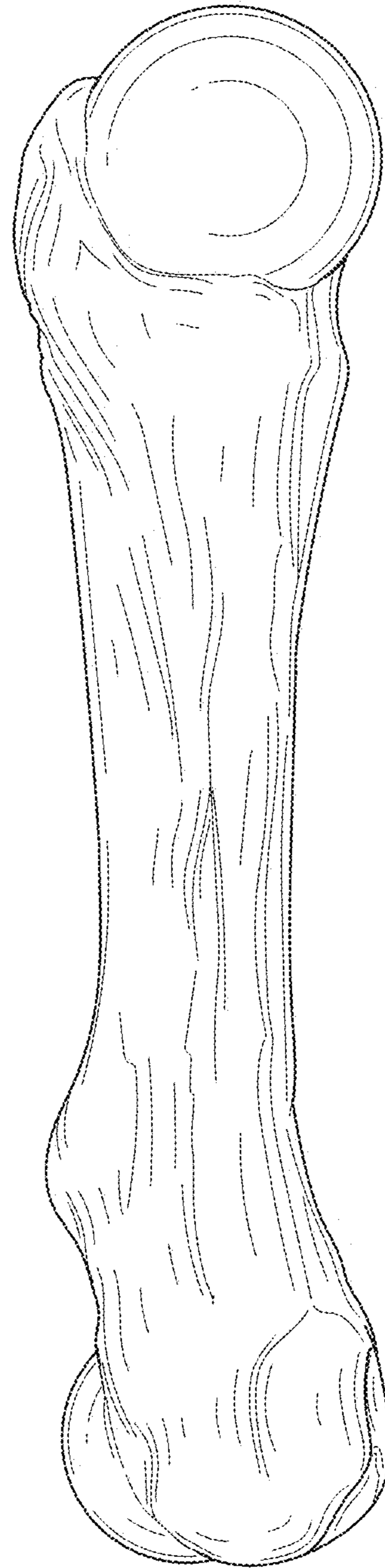

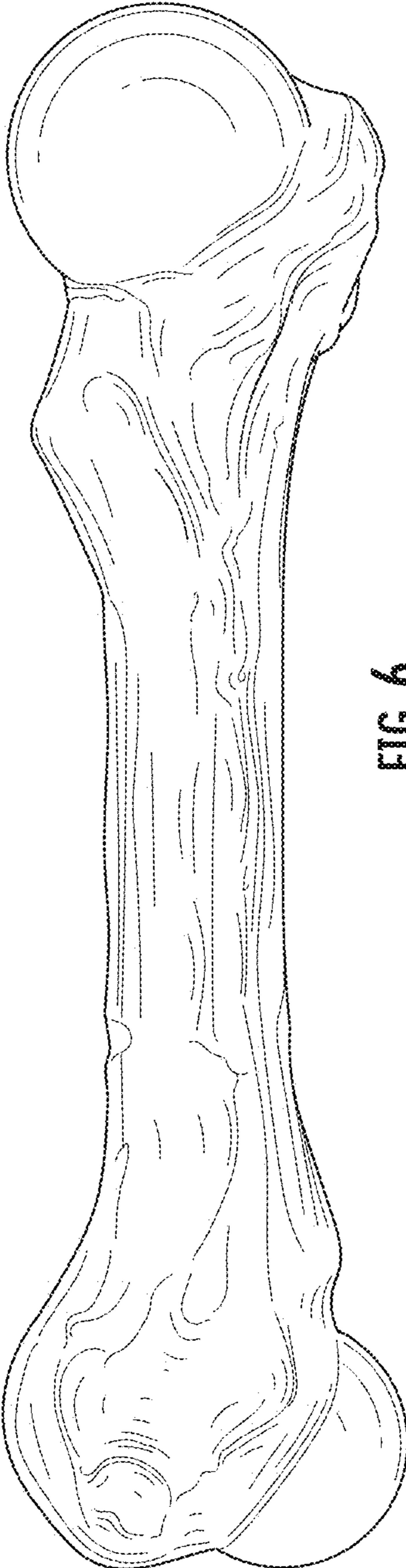

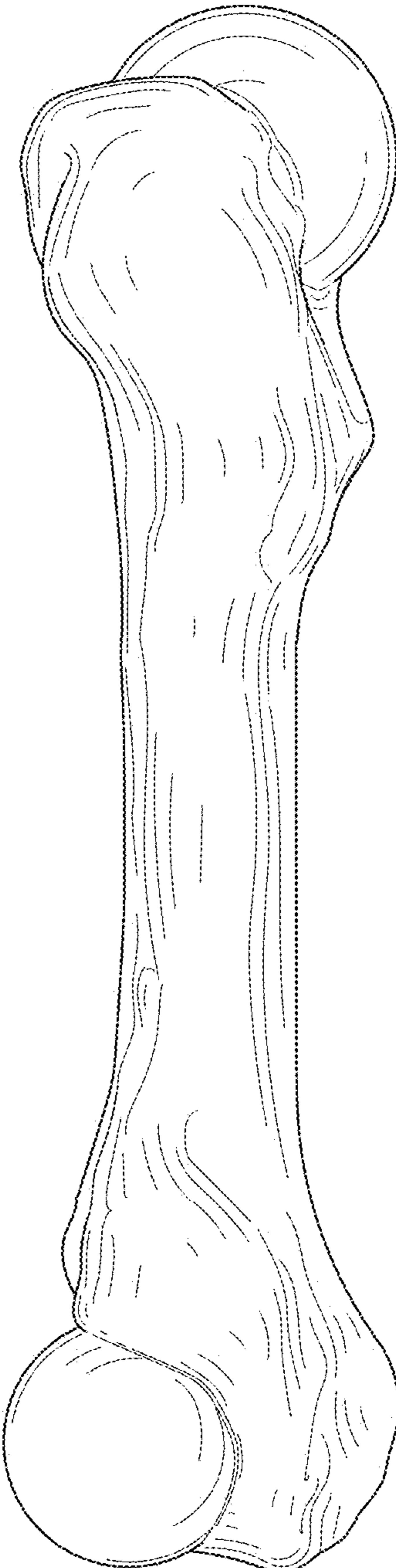
