
CLAIM

The ornamental design for a linking glove, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of a linking glove; FIG. 2 shows a right side elevation view thereof; FIG. 3 shows a left side elevation view thereof; FIG. 4 shows a top plan view thereof; FIG. 5 shows a bottom plan view thereof; FIG. 6 shows a front end elevation view thereof; FIG. 7 shows a rear end elevation view thereof; and, FIG. 8 shows a perspective view of a pair of the linking gloves bound together.

The broken lines shown in FIGS. 1-7 depict portions of the linking glove which form no part of the claimed design. The broken lines shown in FIG. 8 of the linking glove depict environment only and form no part of the claimed design.
















