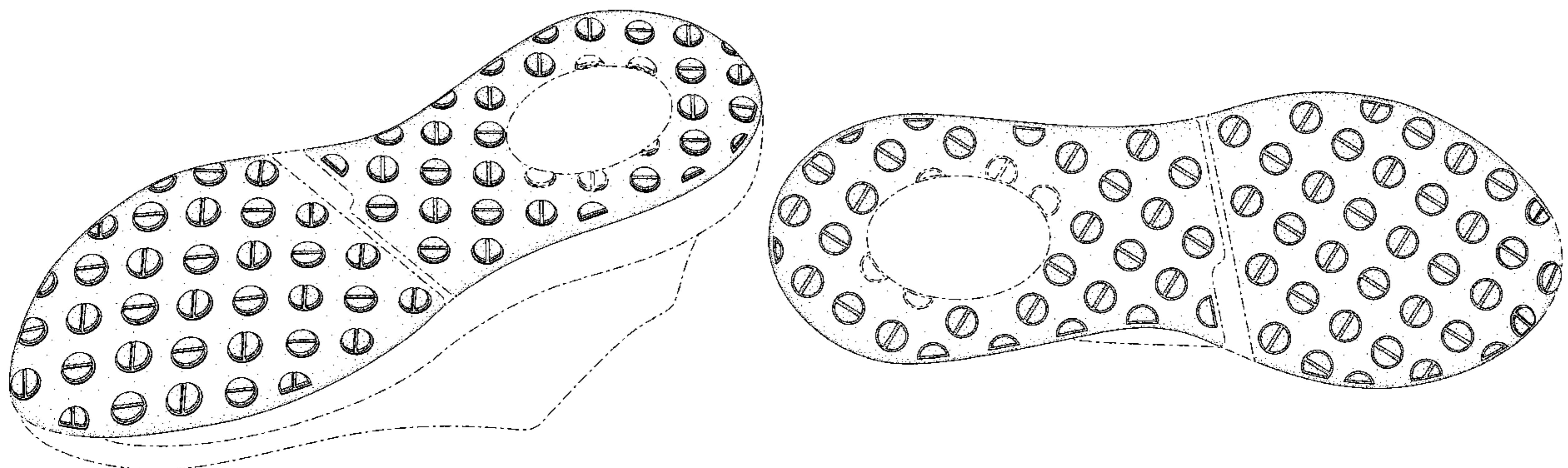

DESCRIPTION

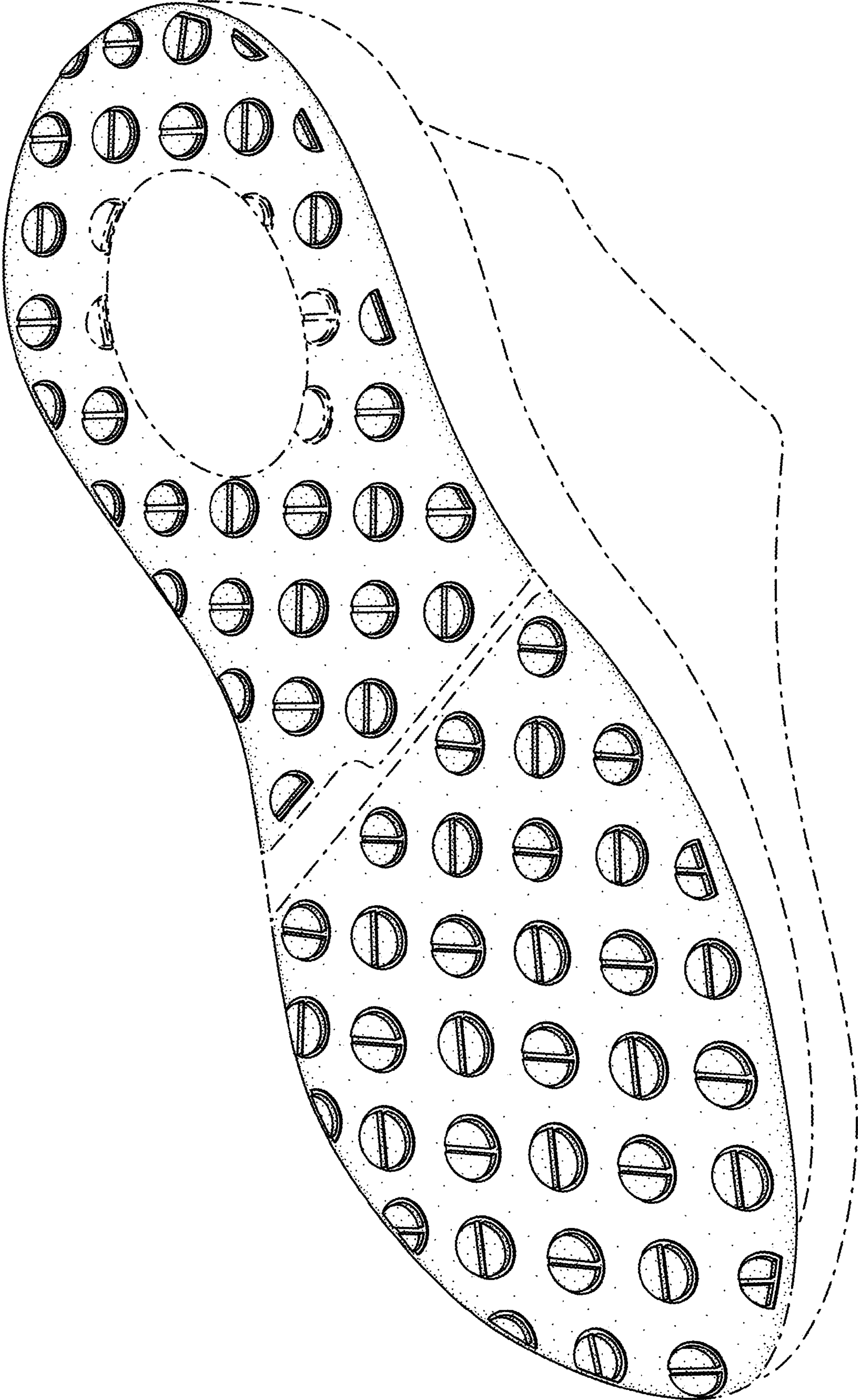

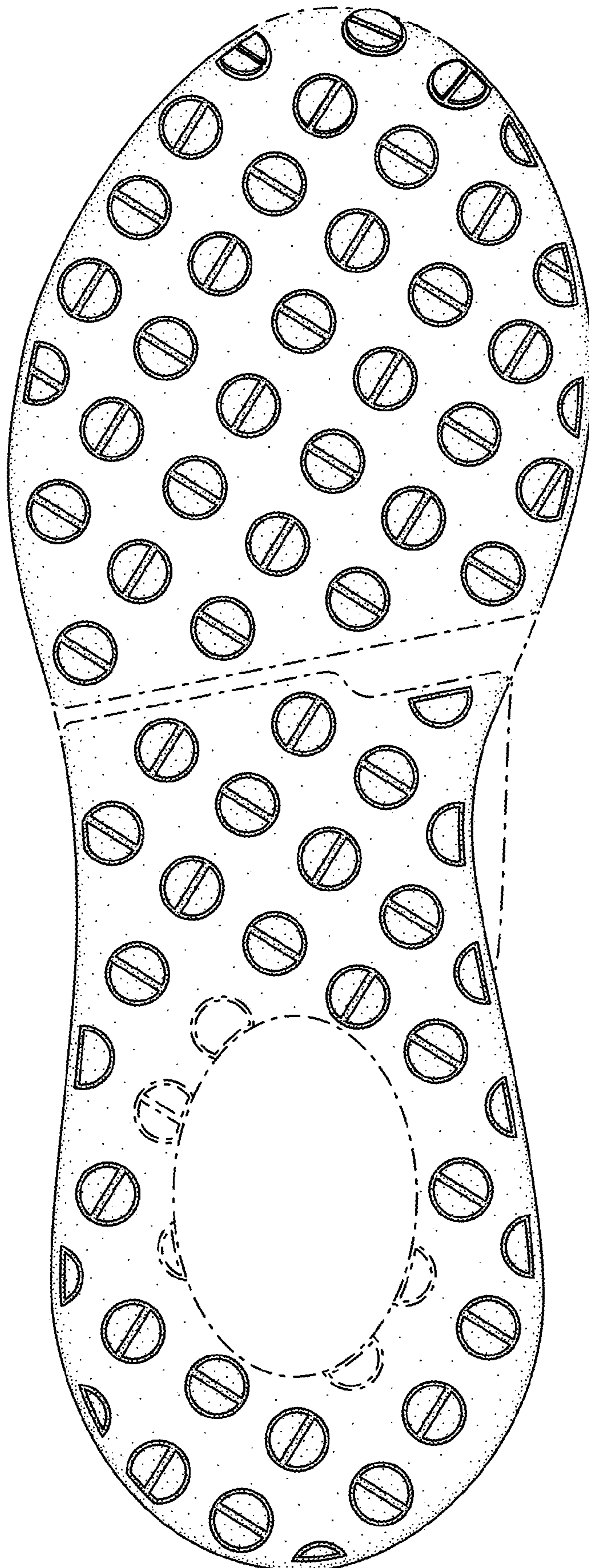

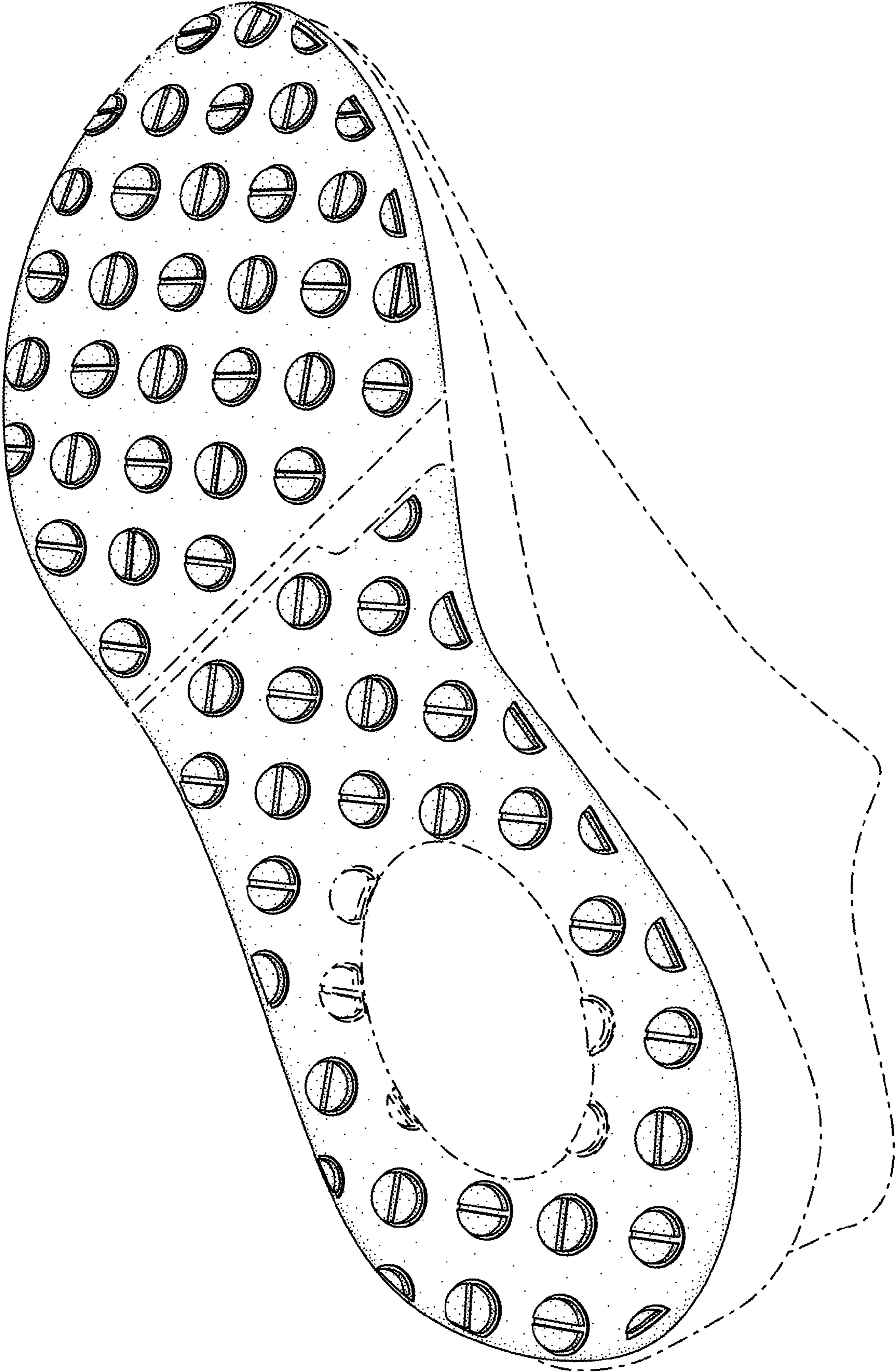
