The ornamental design for a footwear sole component, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the footwear sole component embodying the new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a right side view thereof;

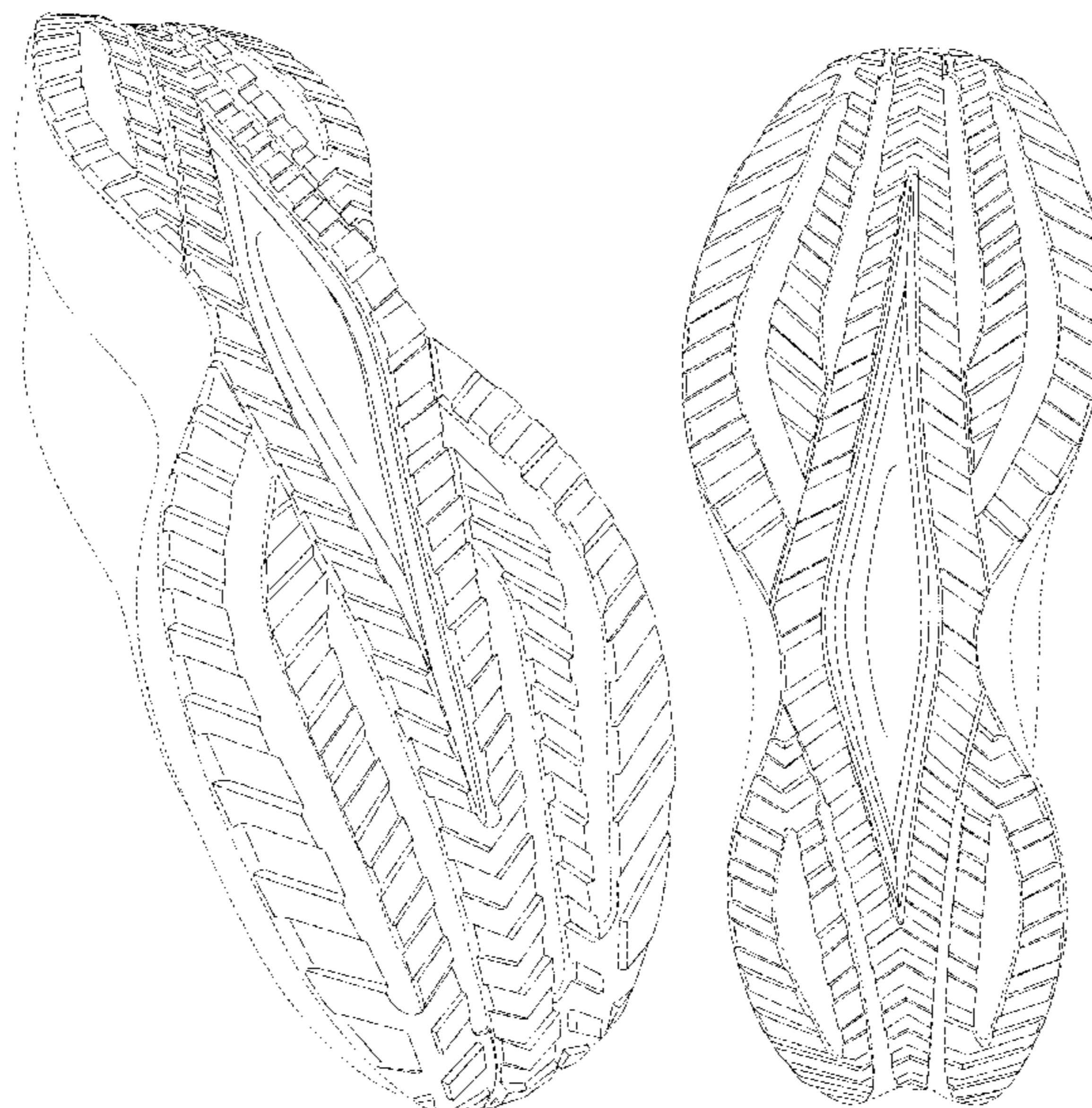
FIG. 4 is a left side view thereof;

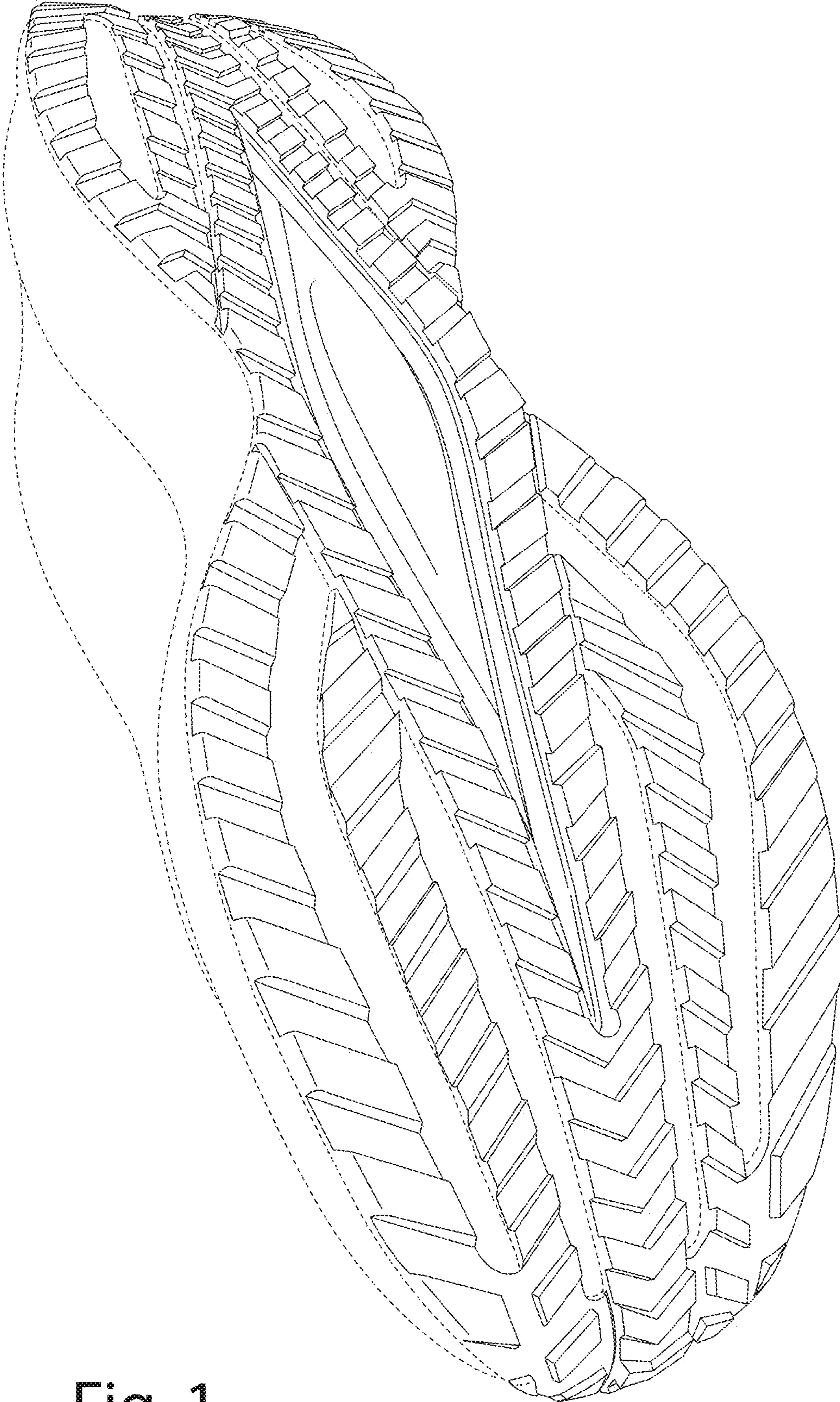

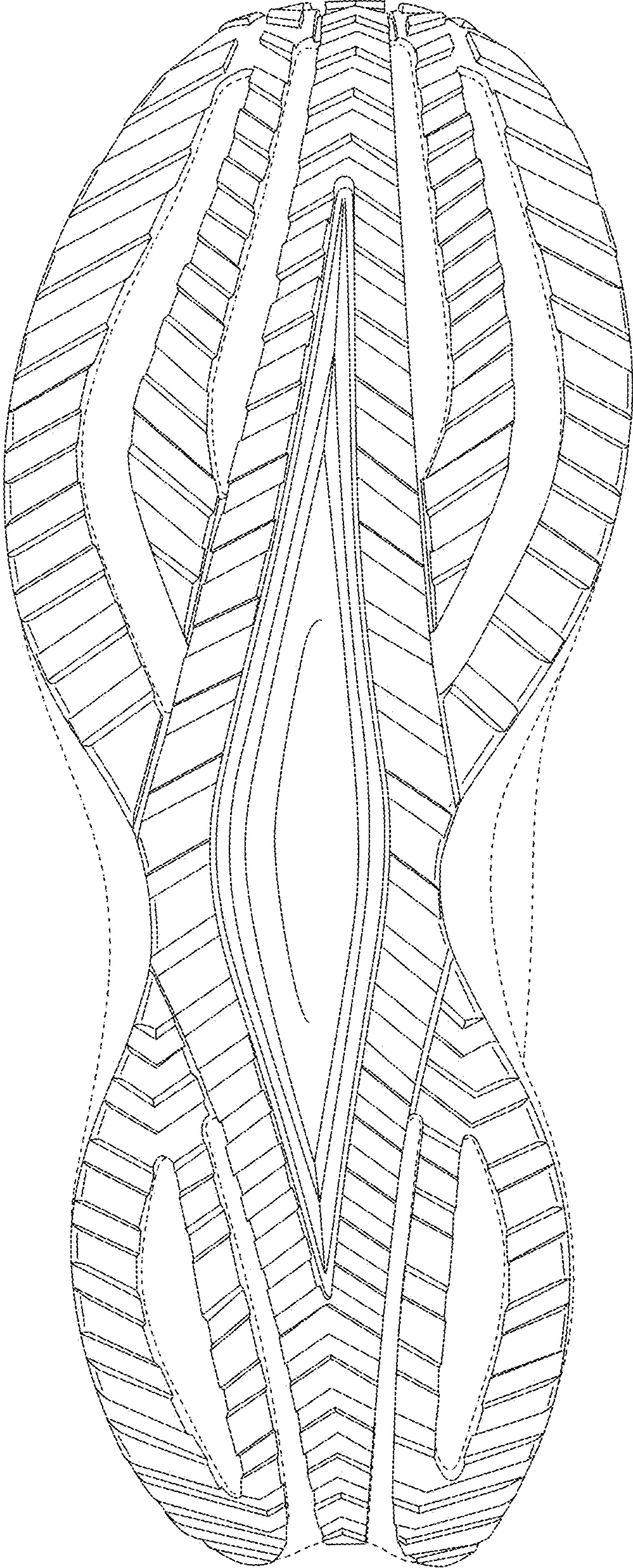

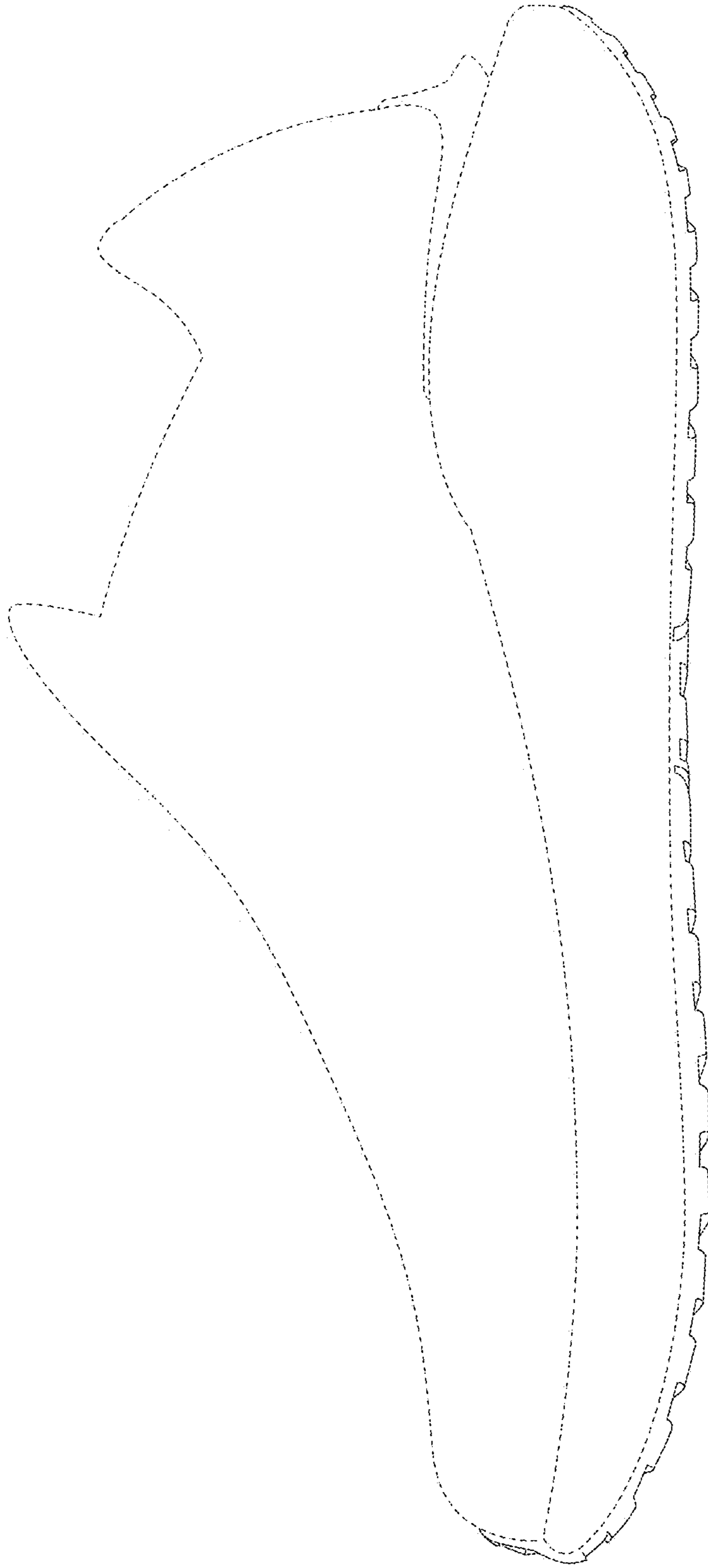

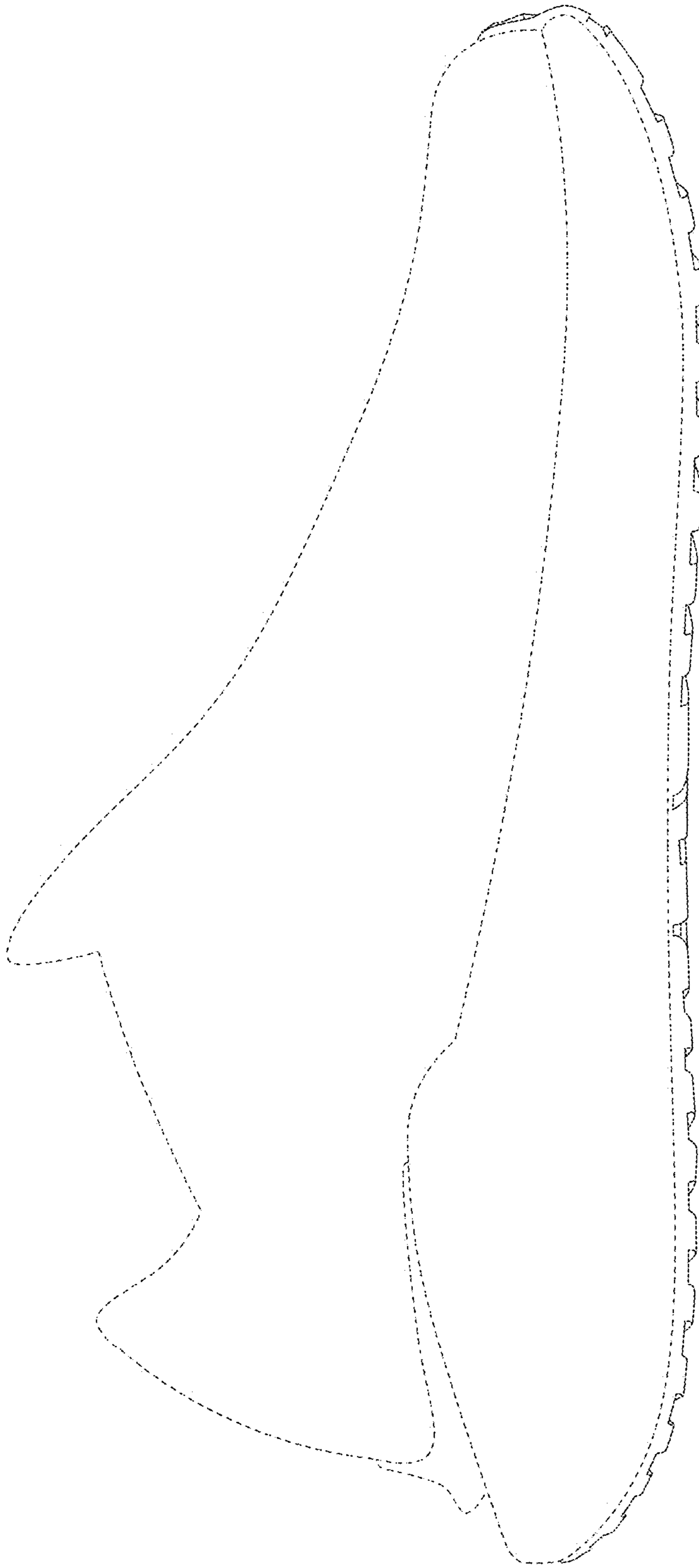

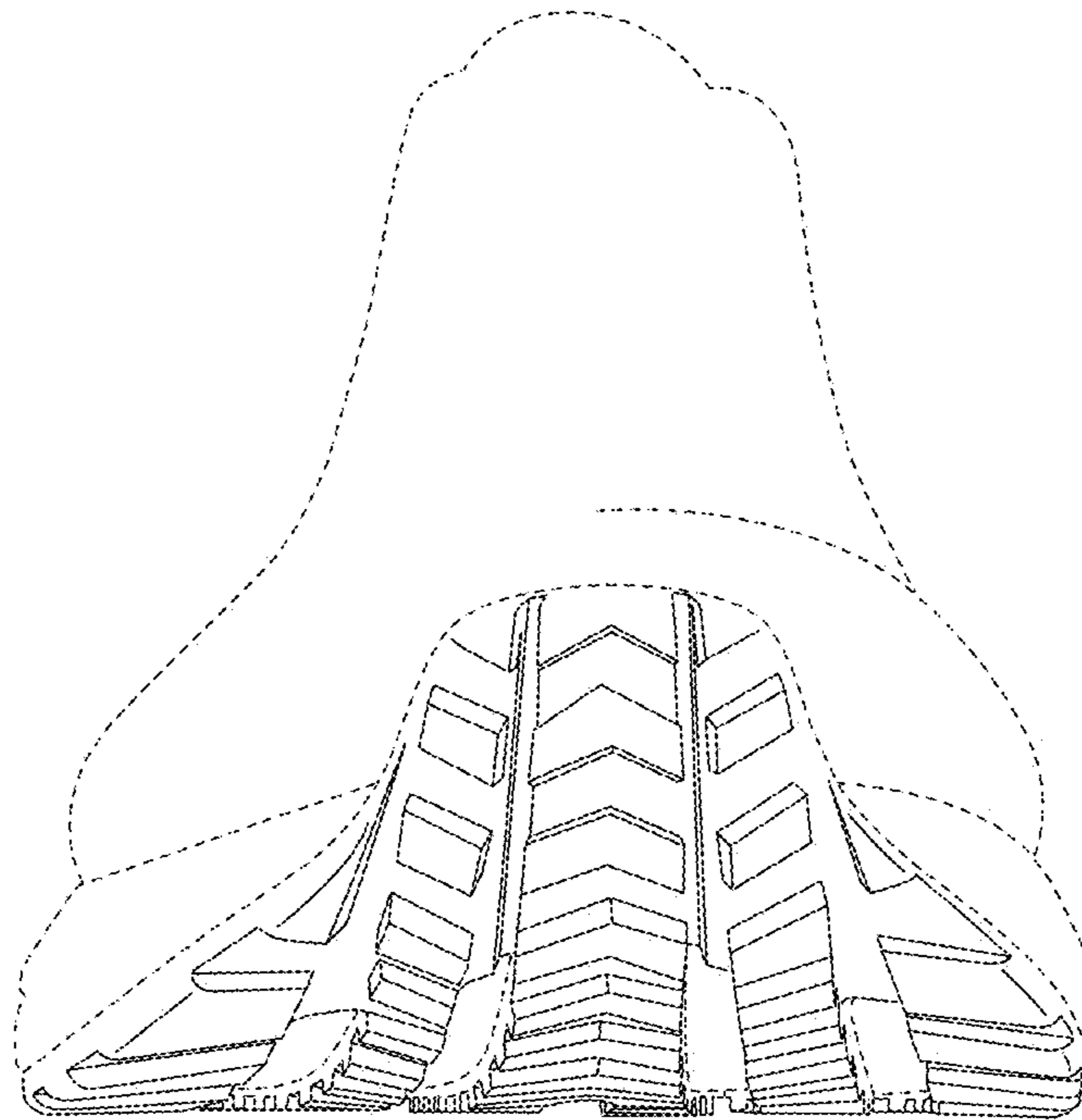

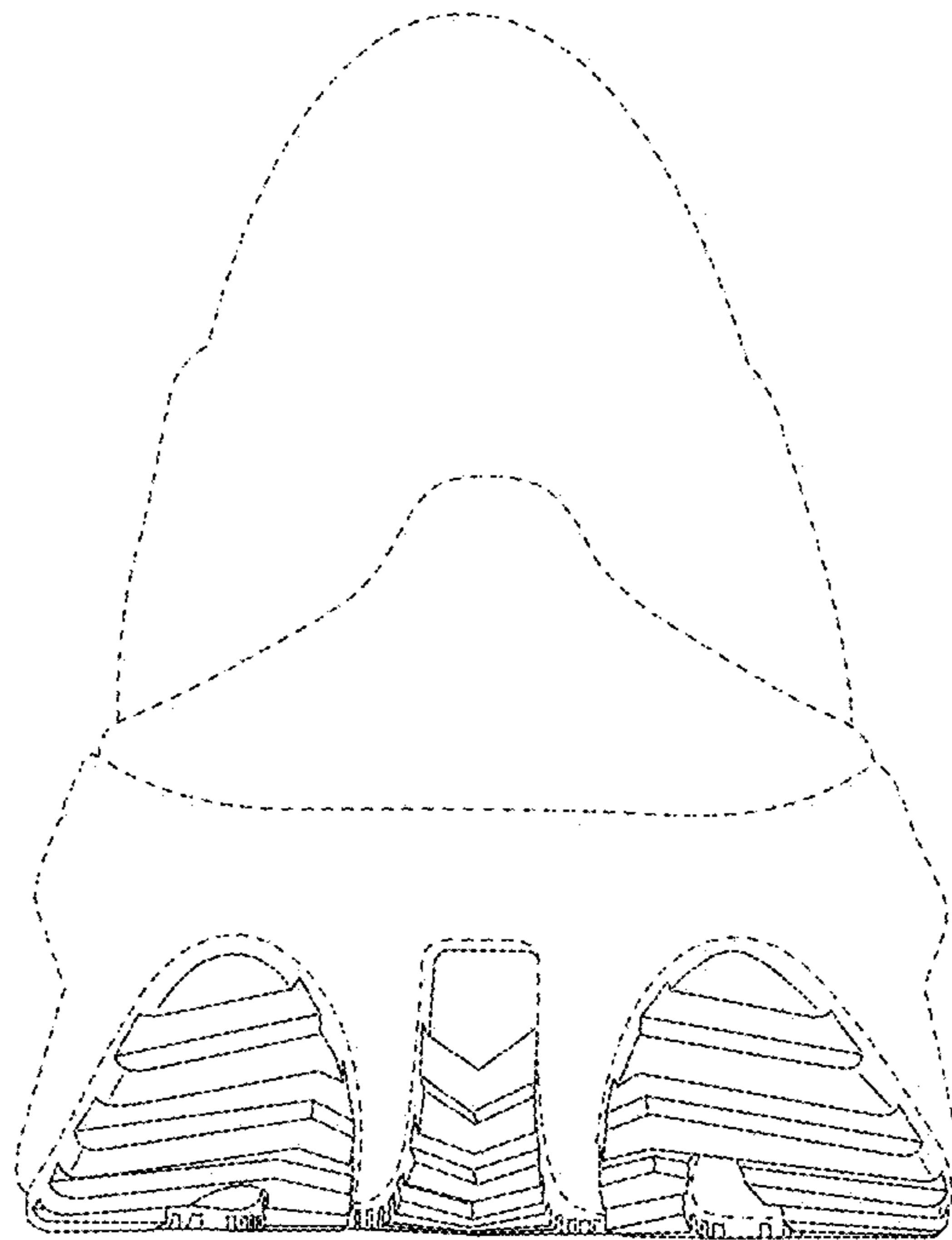
