(57) **CLAIM**

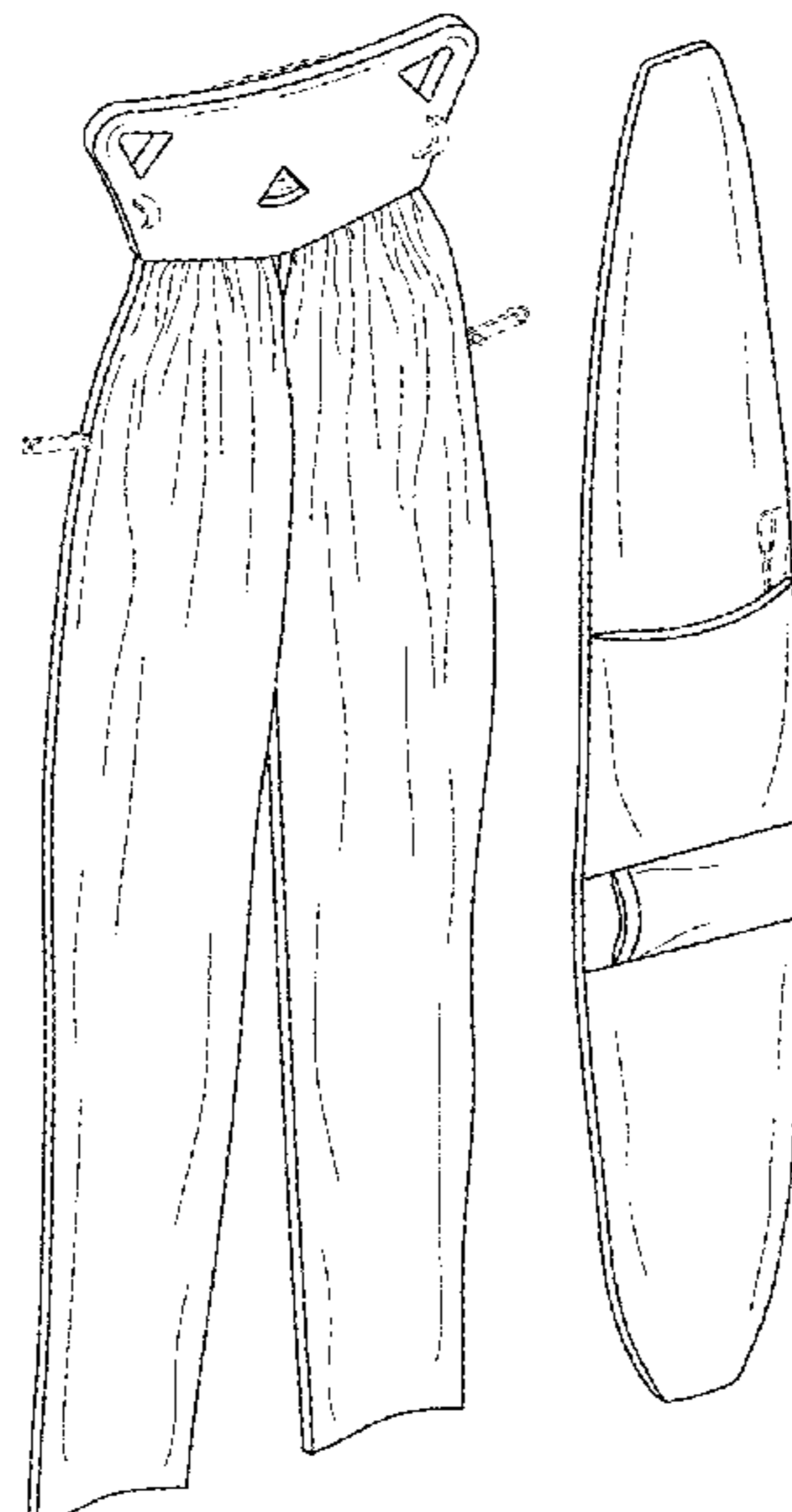
I claim the ornamental design for a baby carrier, as shown and described.

DESCRIPTION

FIG. 1 is a top, perspective view of the baby carrier; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a perspective view of the baby carrier shown in use with environment.

The dash-dash-dash lines depict portions of the baby carrier which form no part of the claimed design; the dash-dot-dot-dash lines depict environment that forms no part of the claimed design.

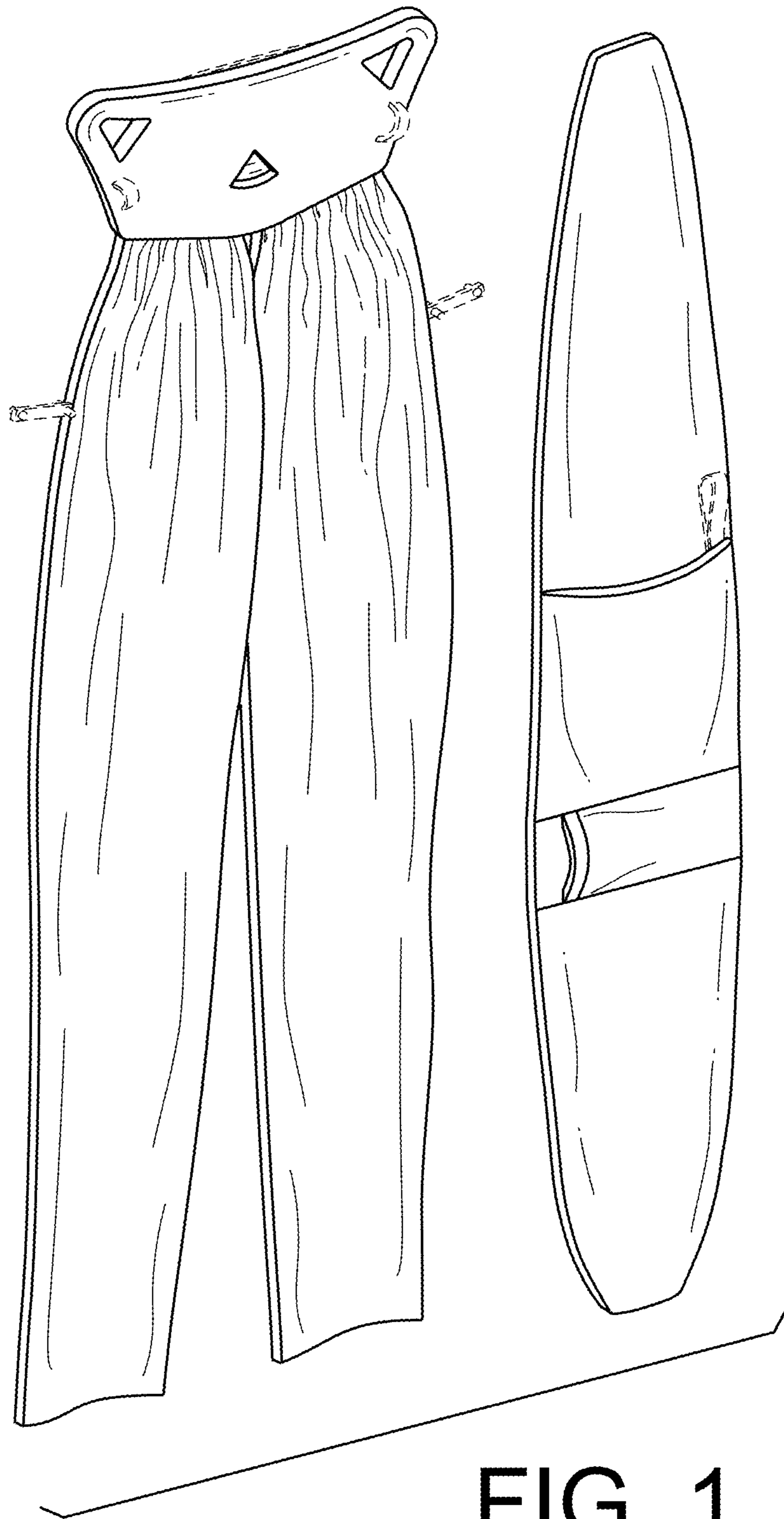

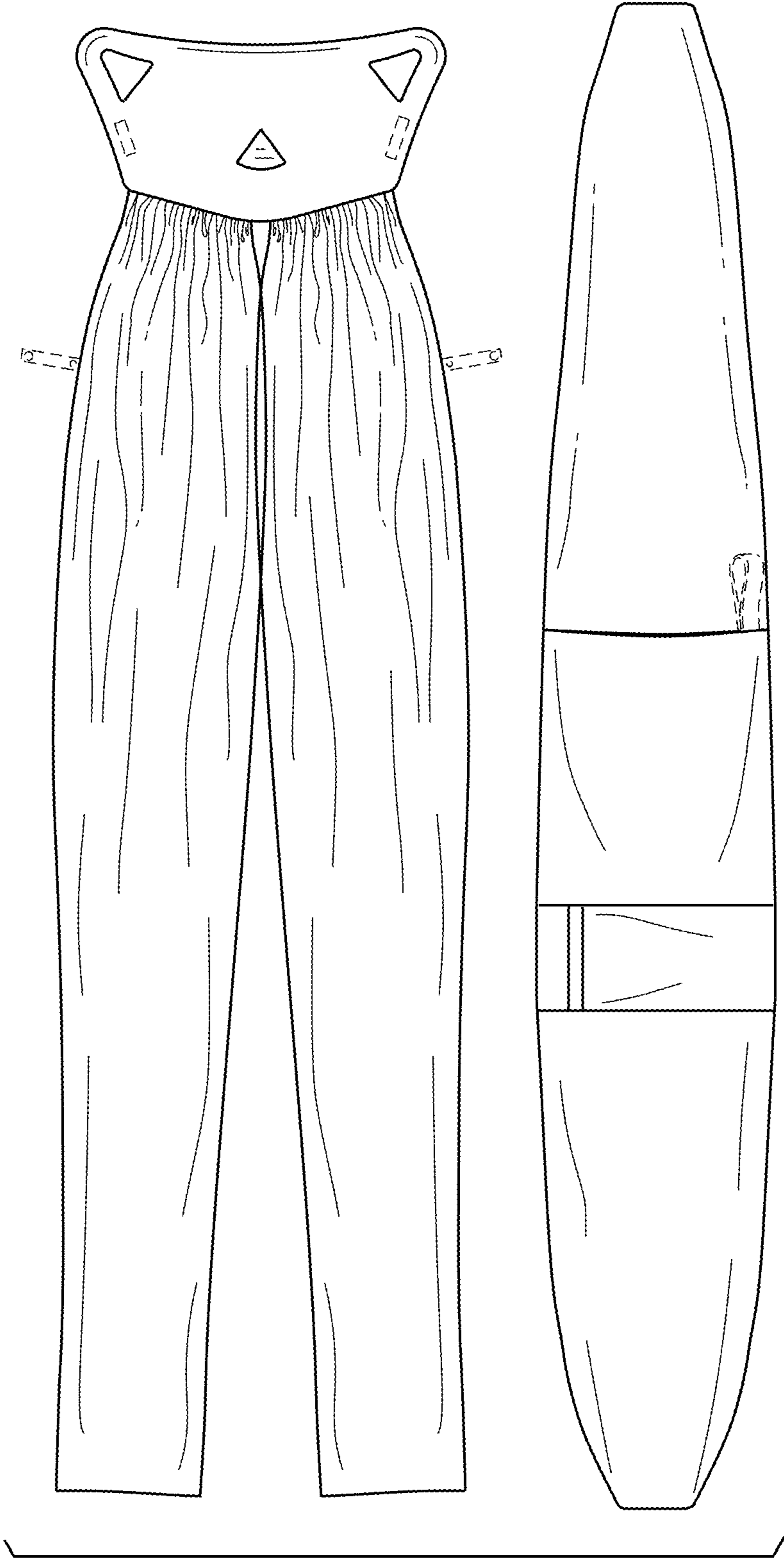

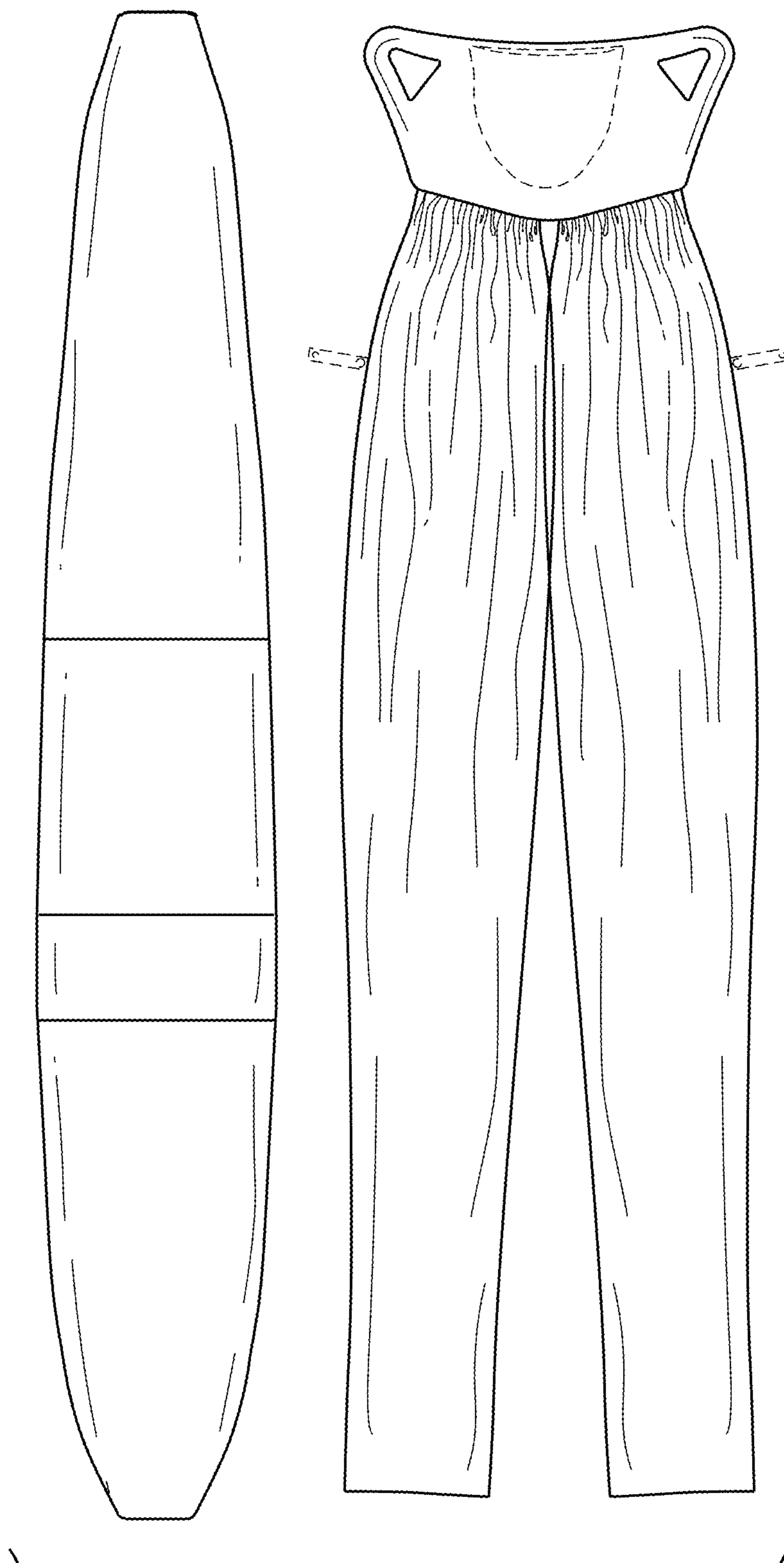

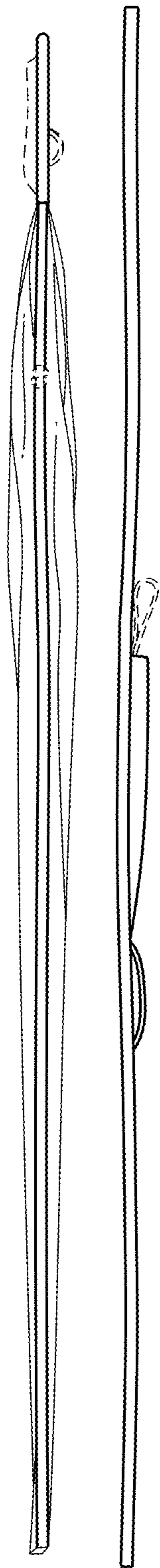

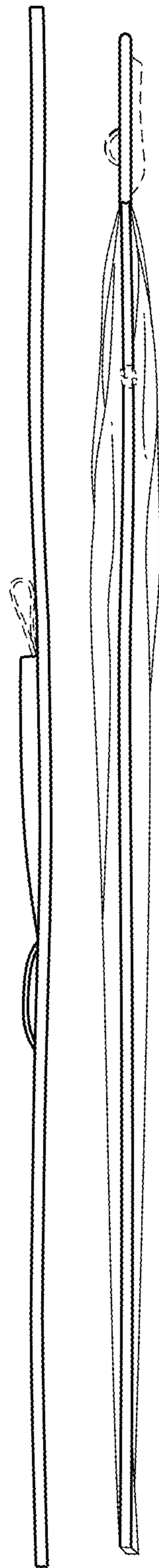

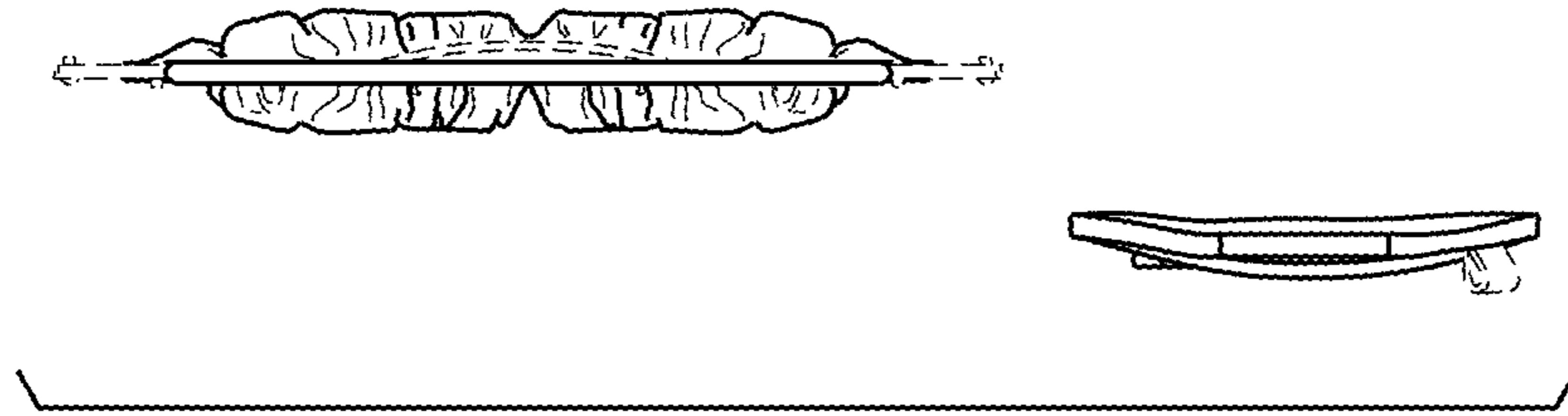

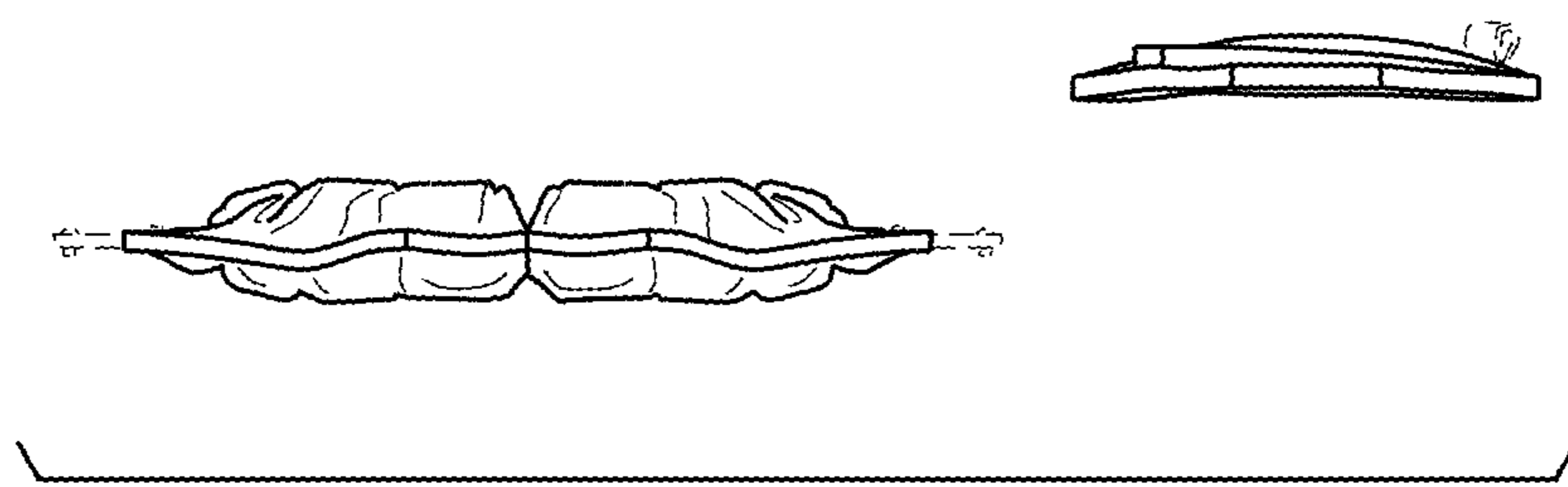

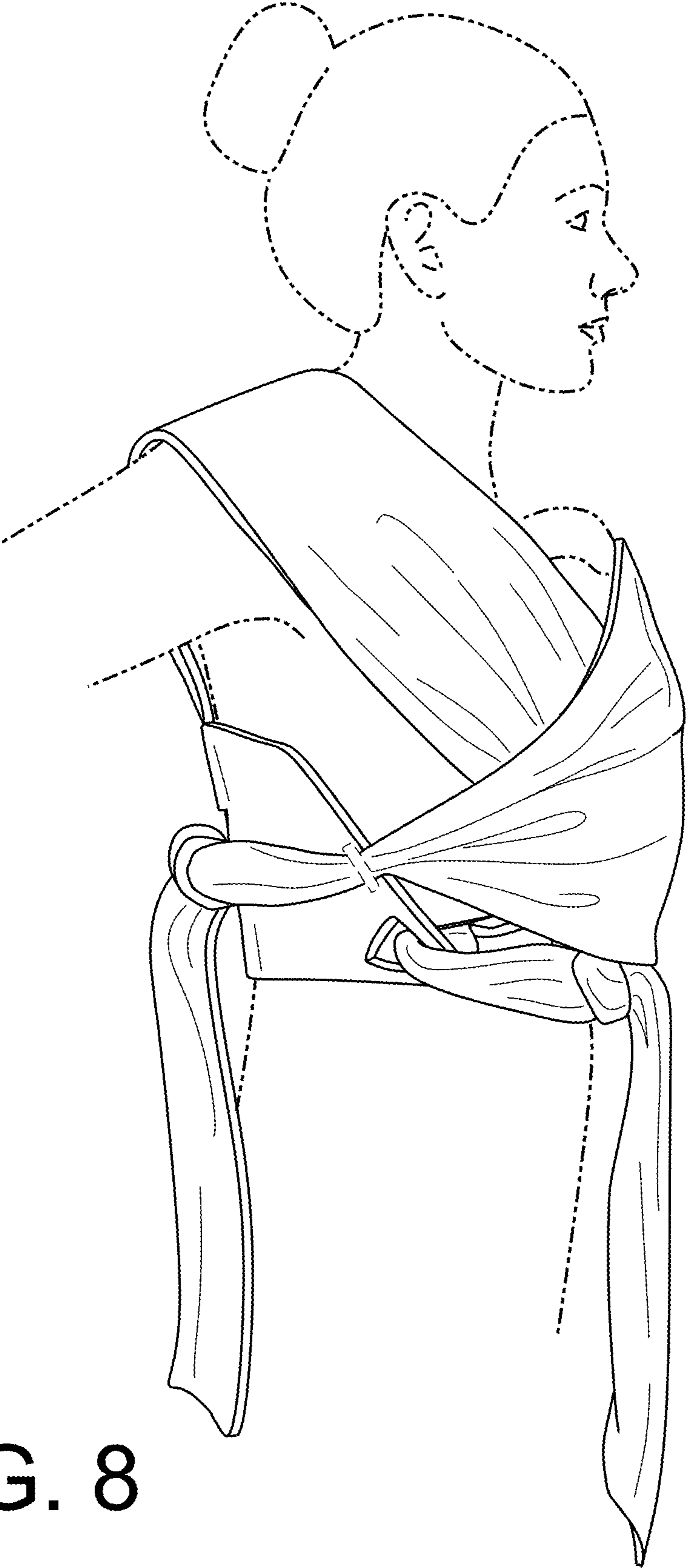
