(57) **CLAIM**

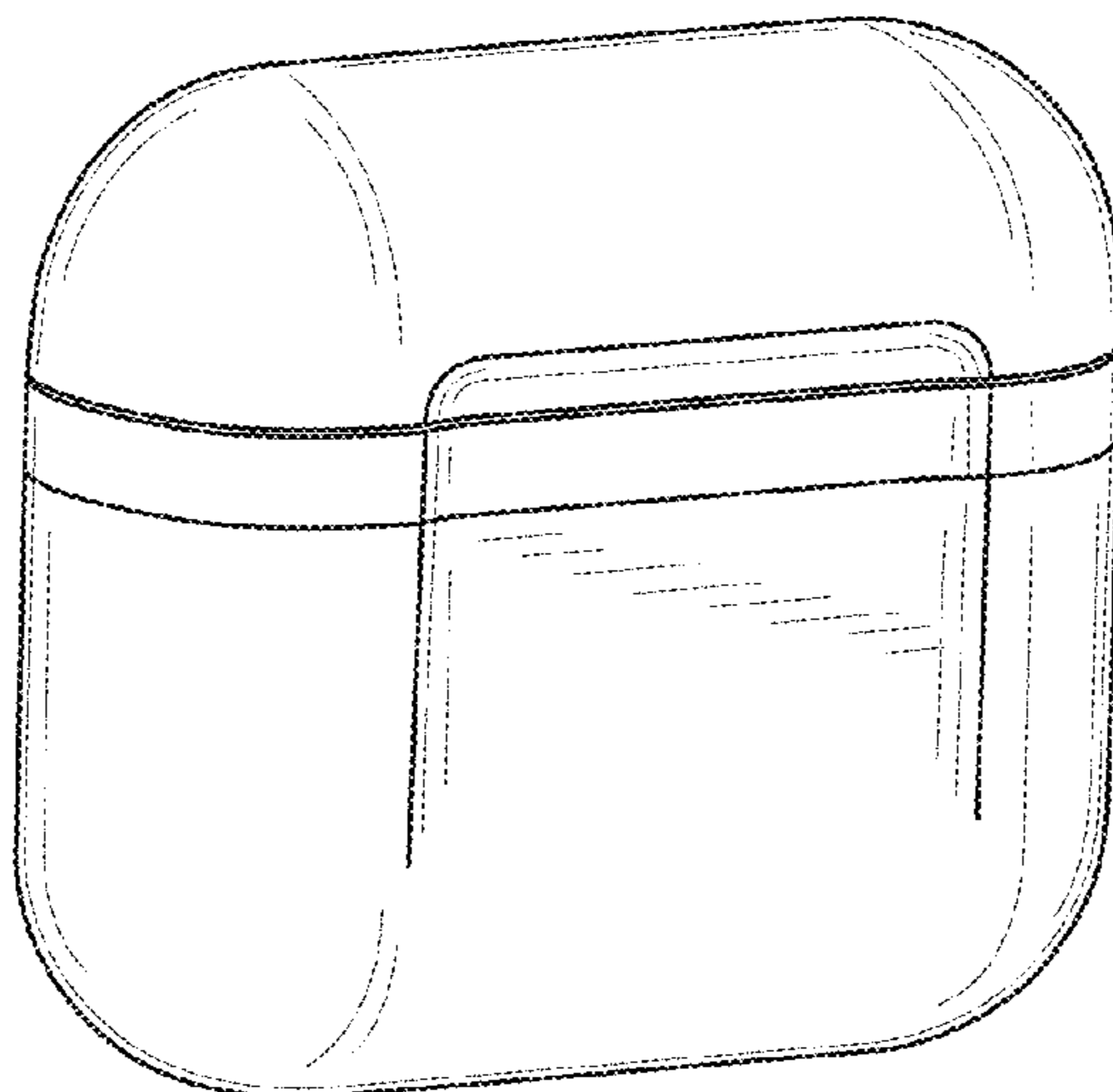
The ornamental design for an earbud headset case, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of an earbud headset case according to our new design;  
FIG. 2 is a front right perspective view of the earbud headset case shown in FIG. 1;

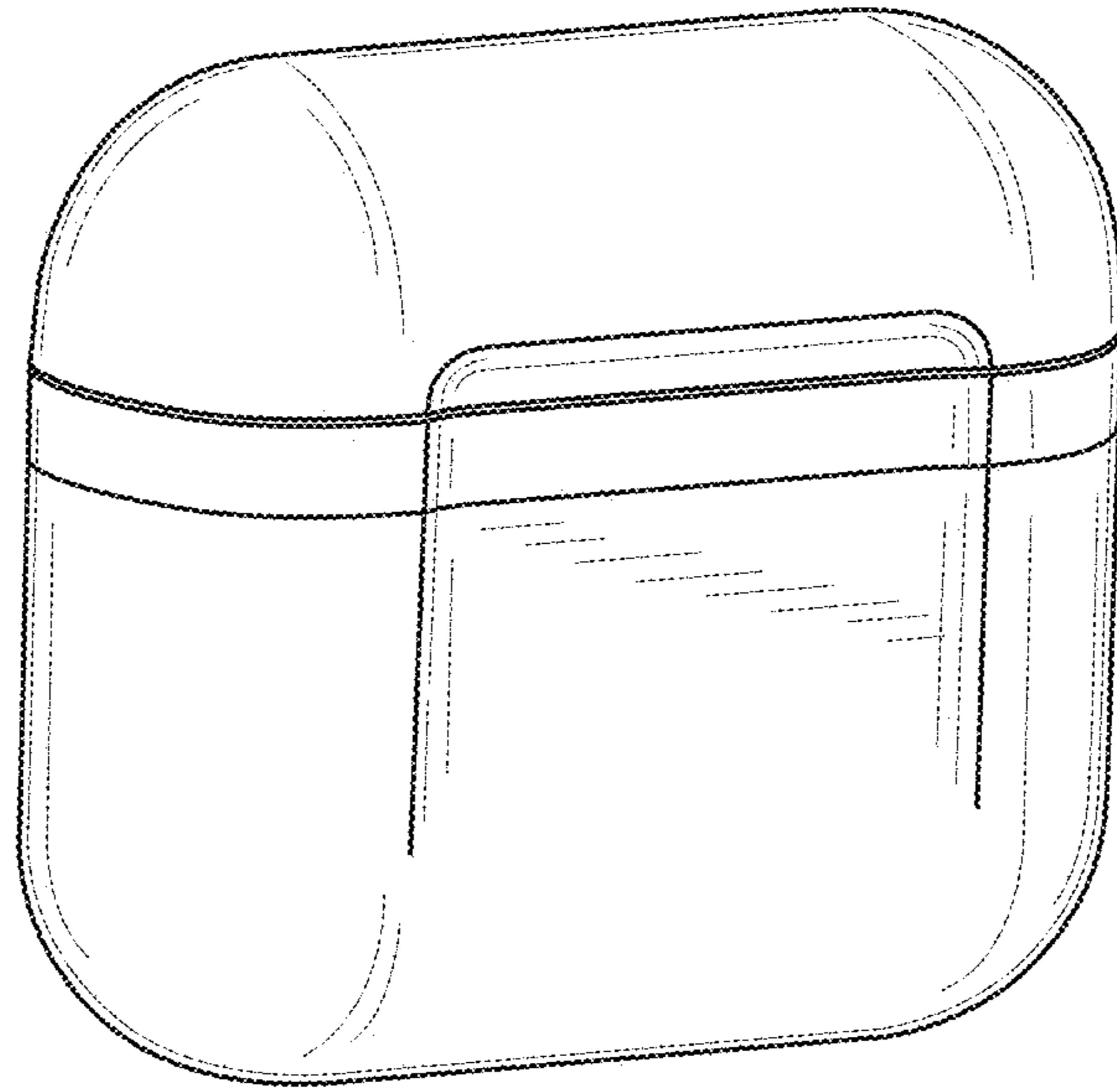

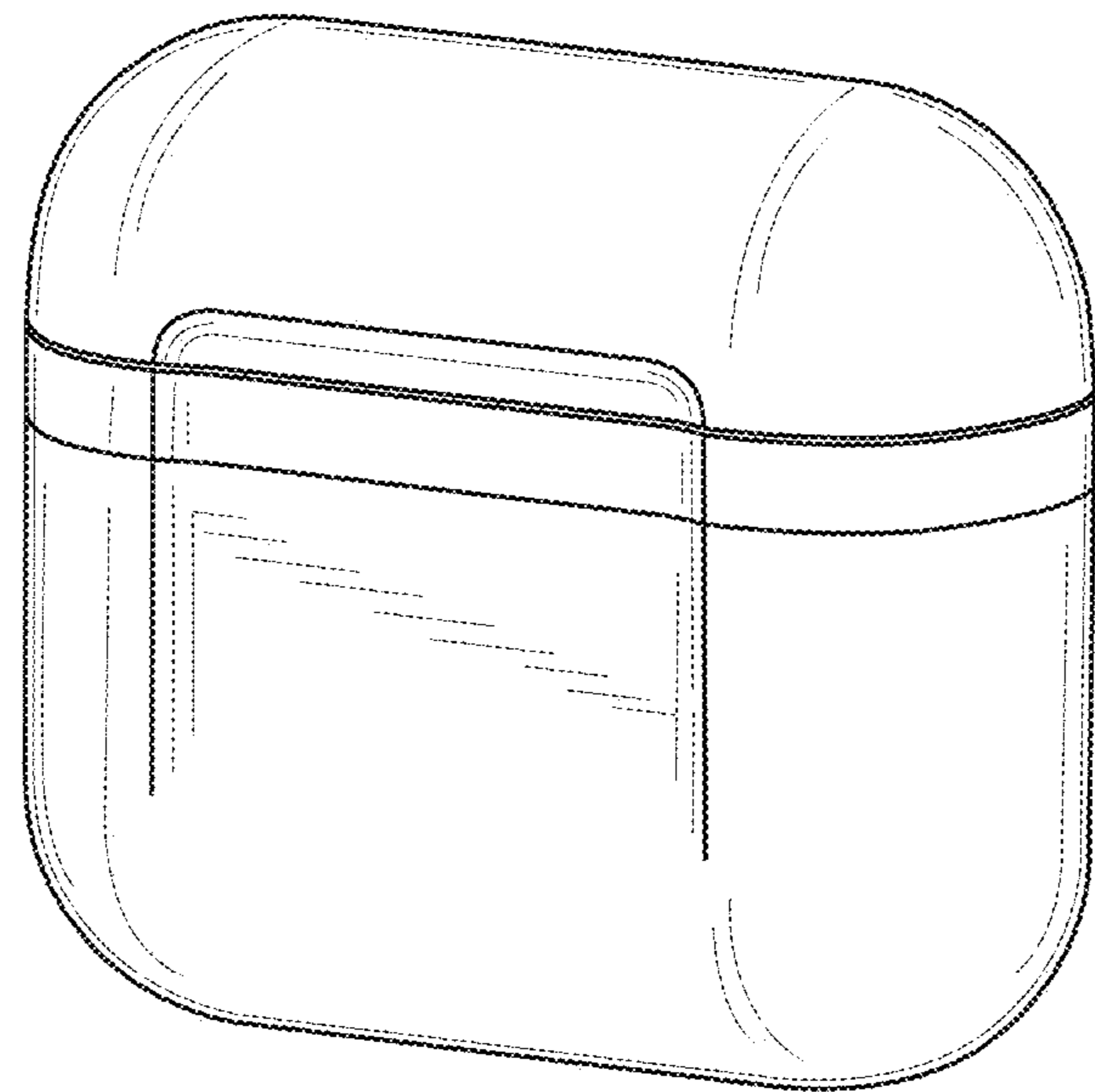

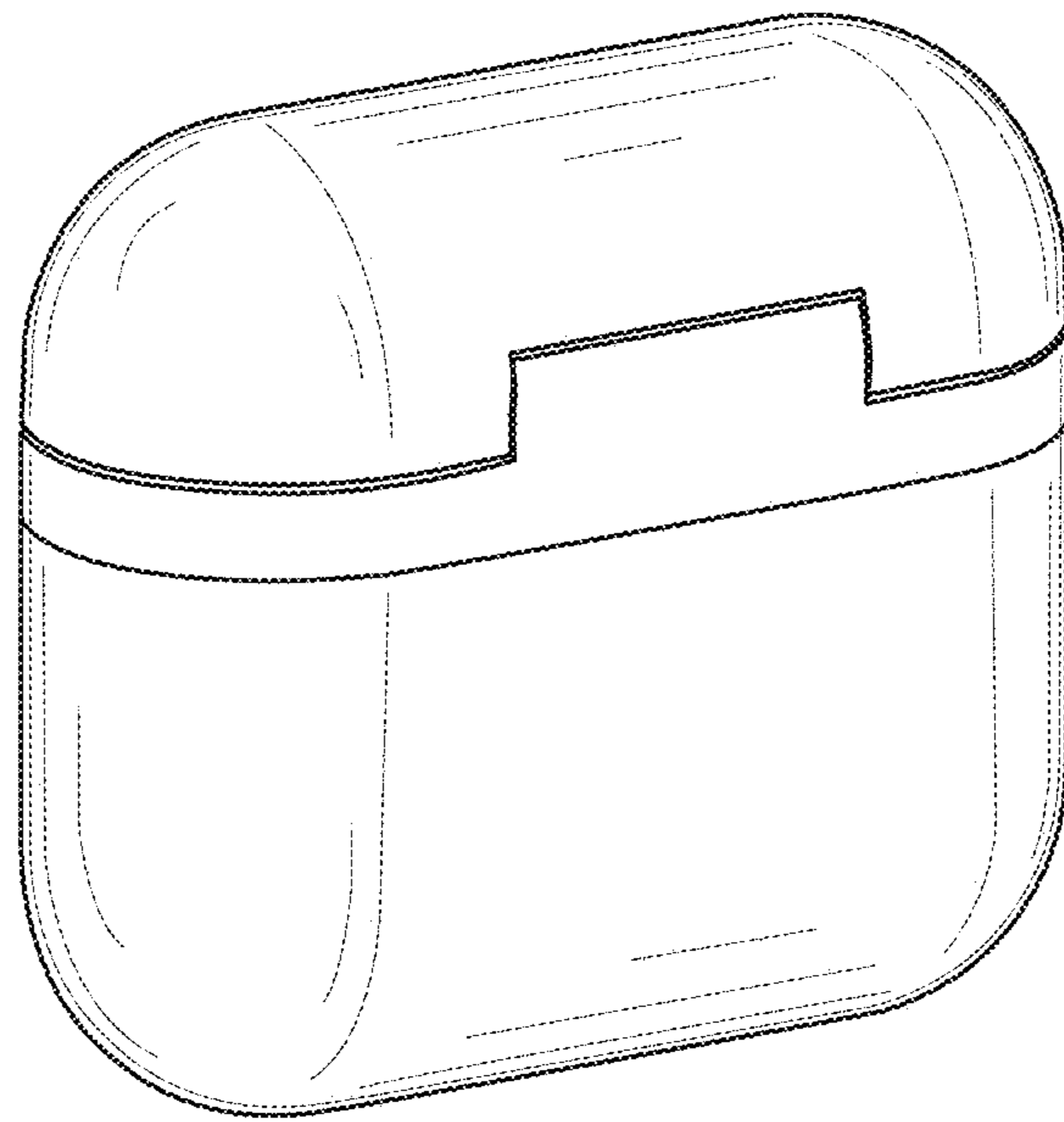

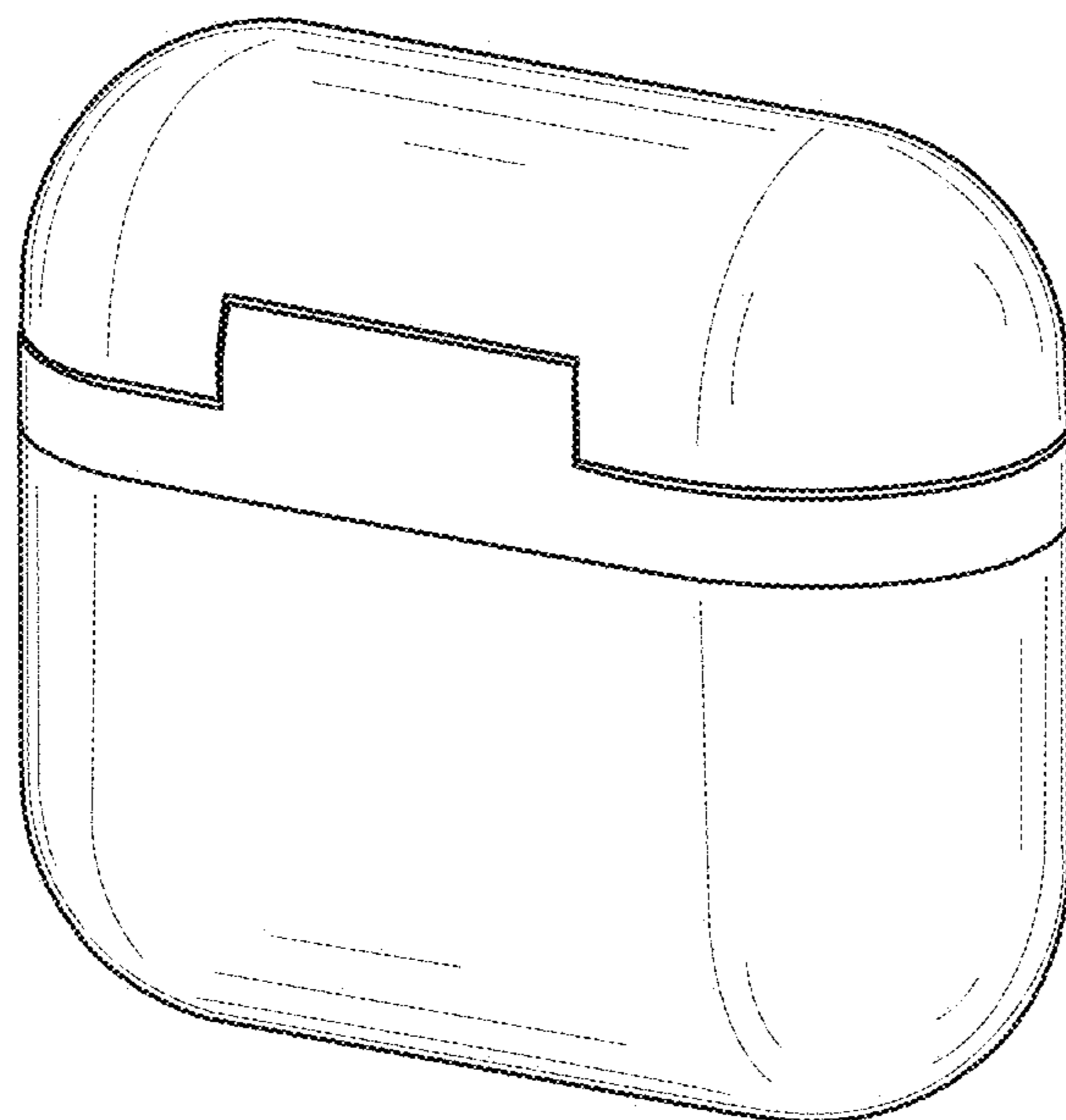

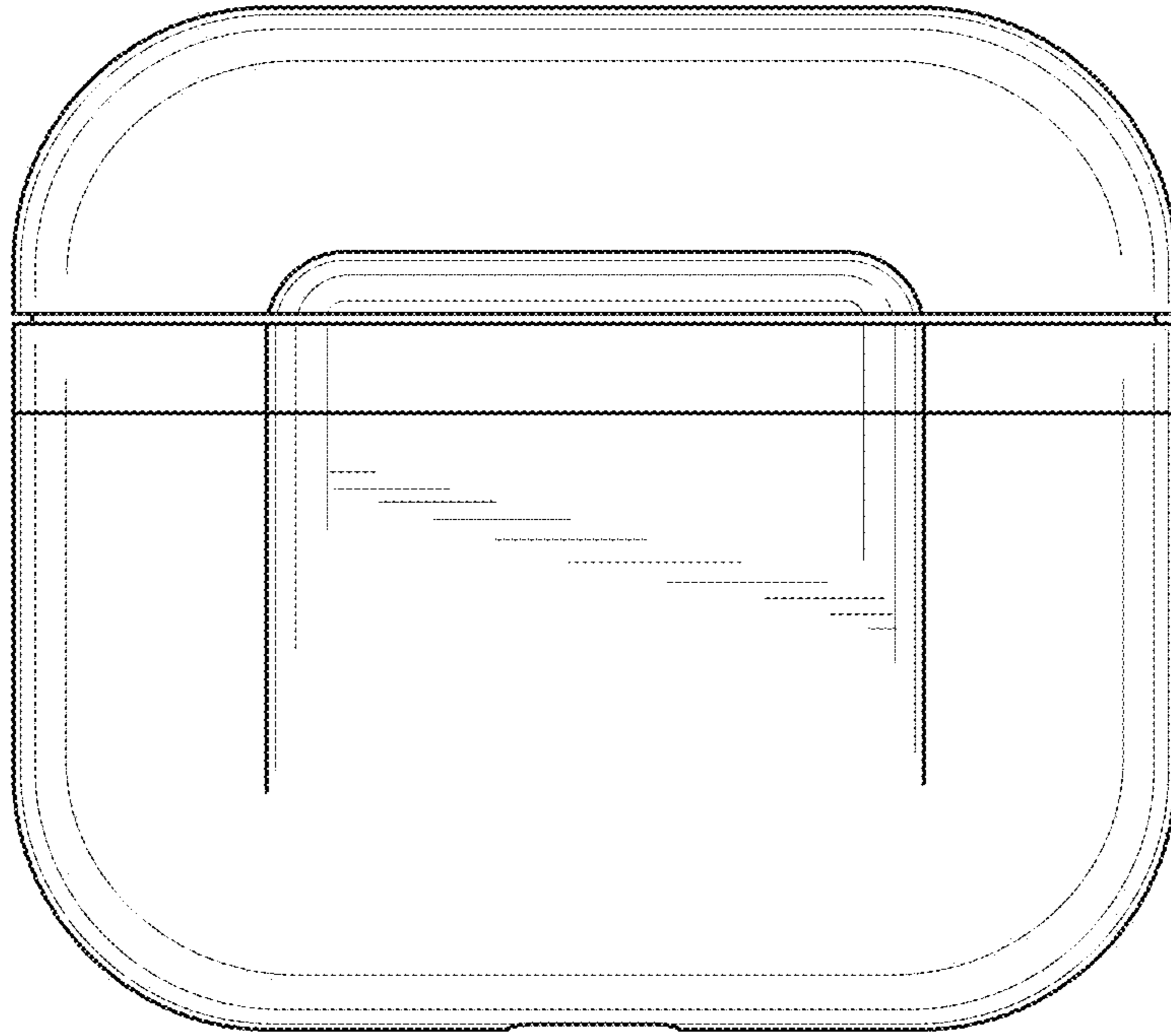

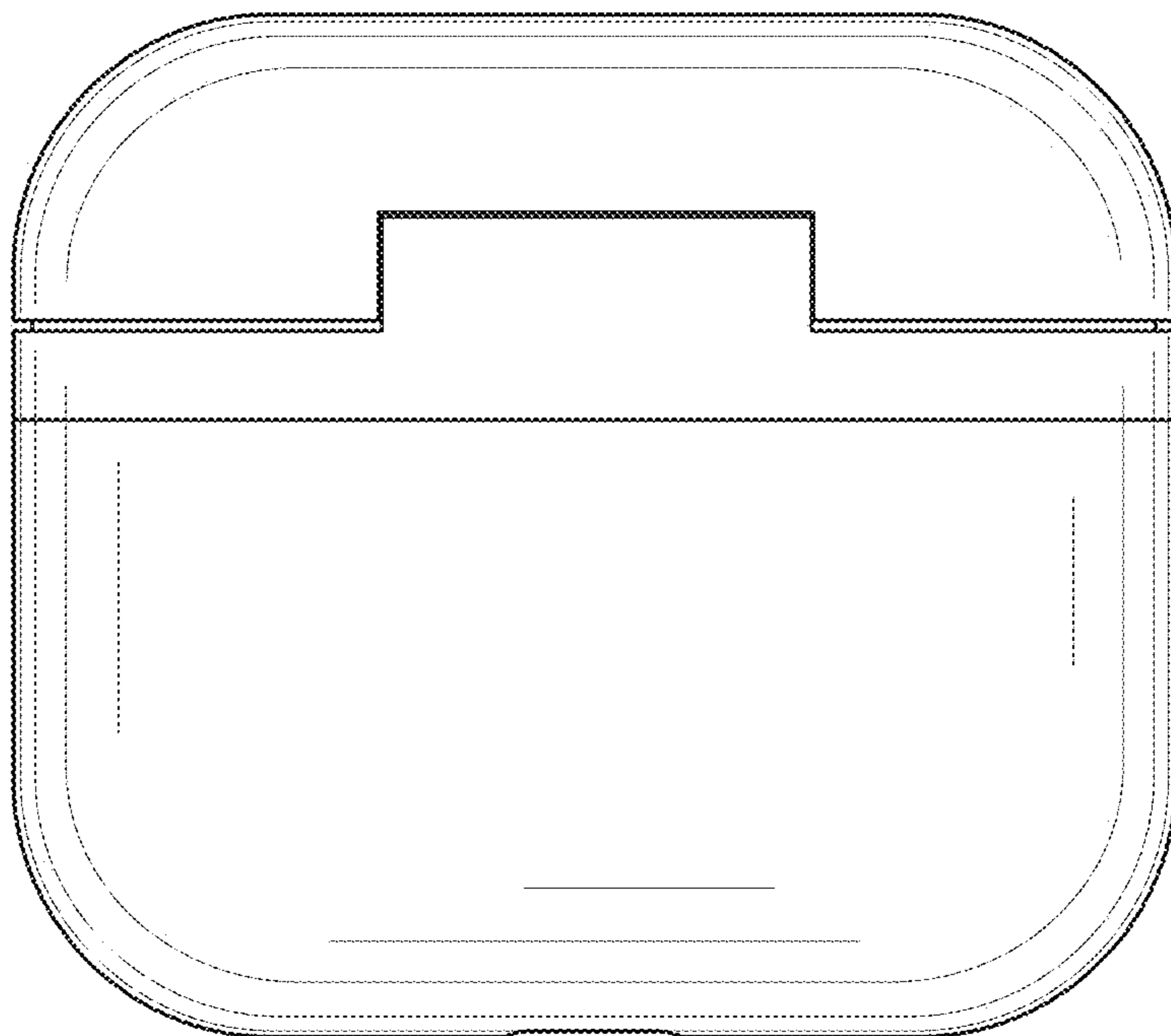

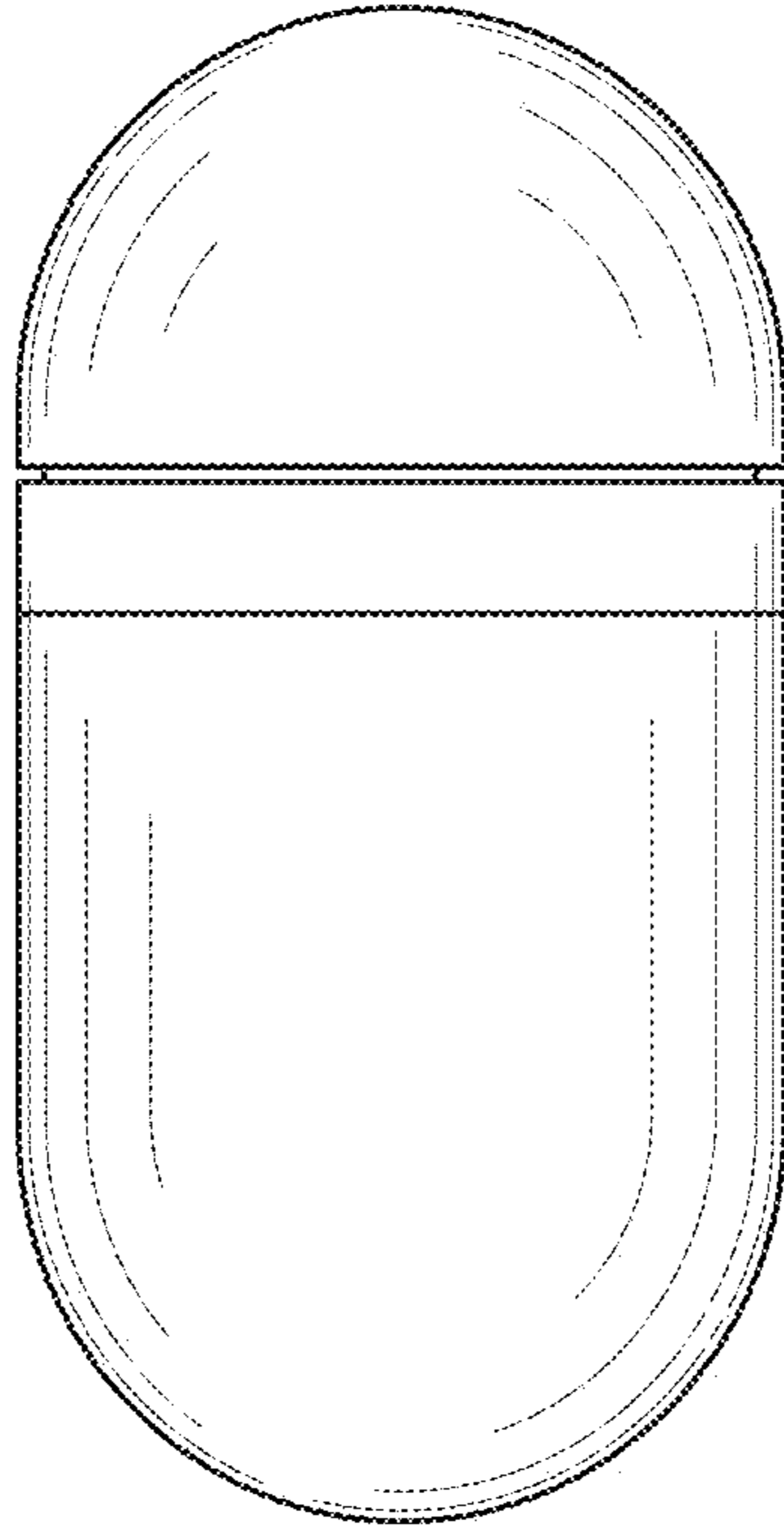




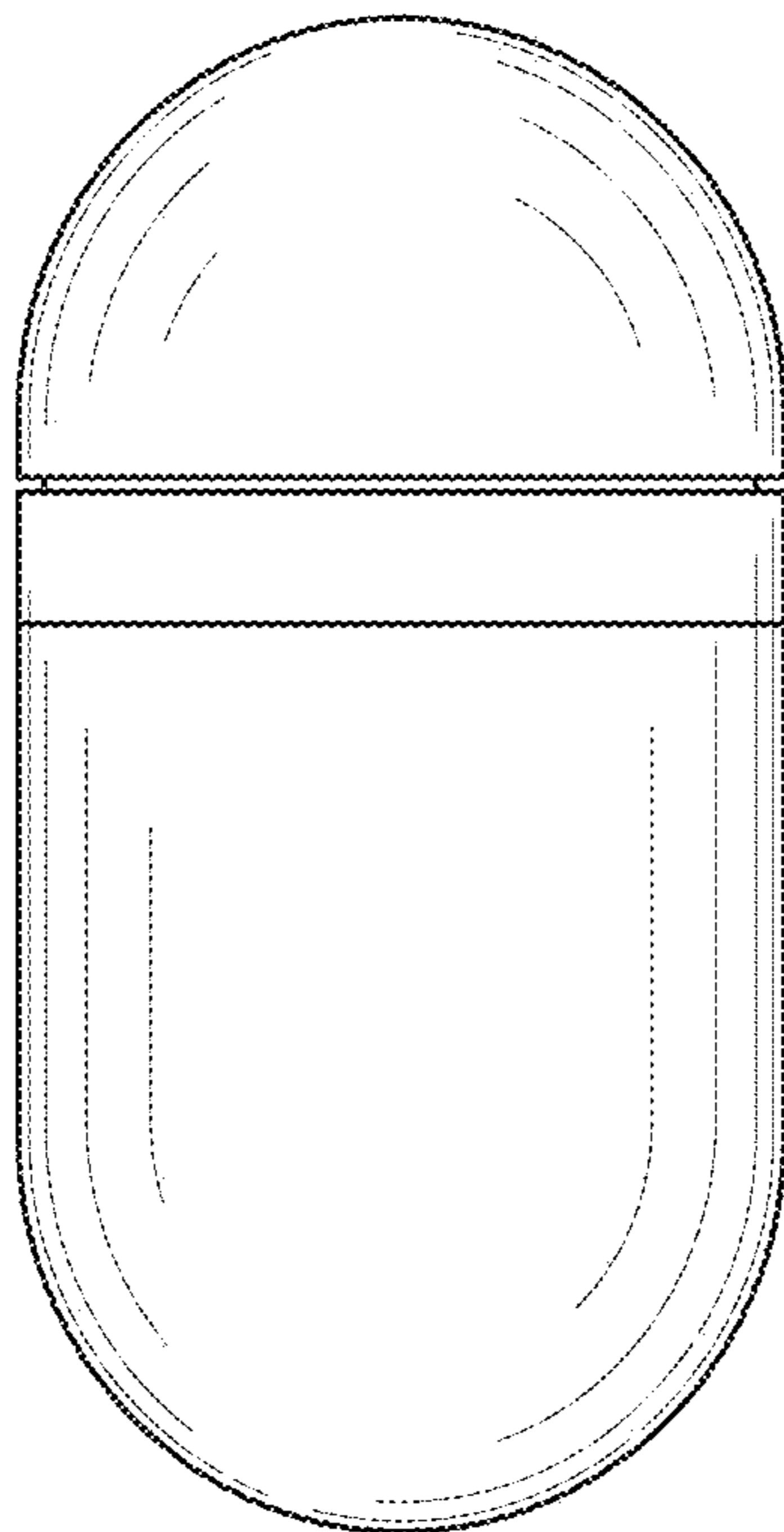

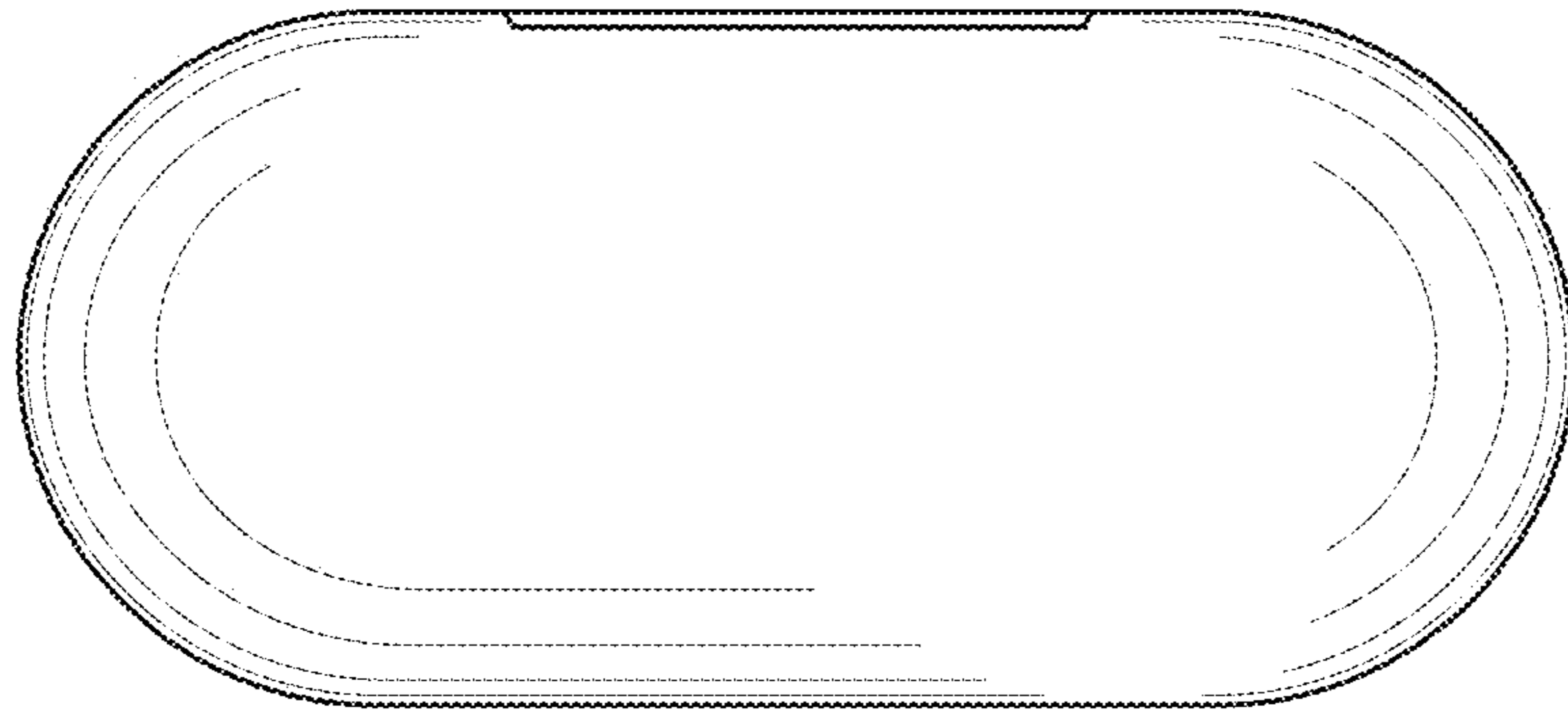

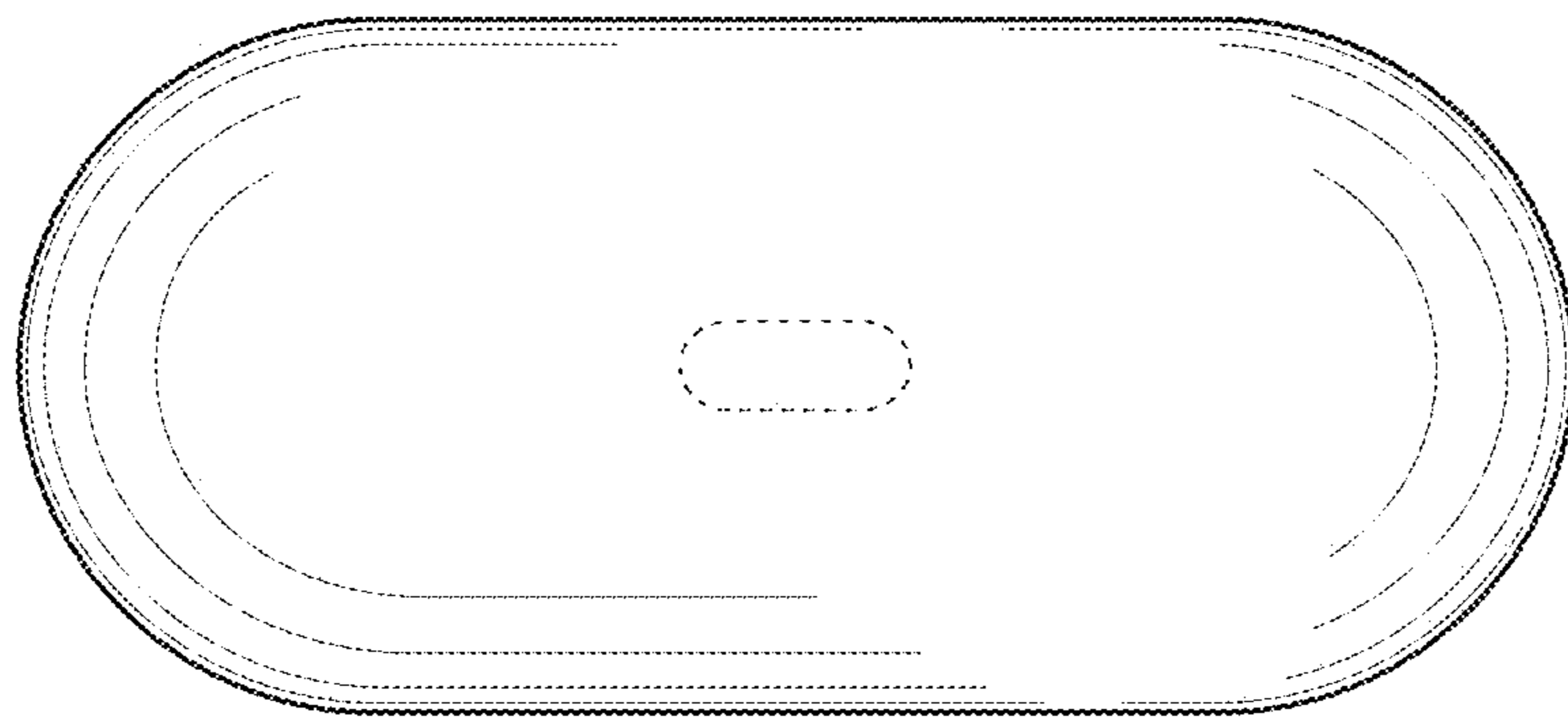
