FIG. 1.4 is a top view thereof;

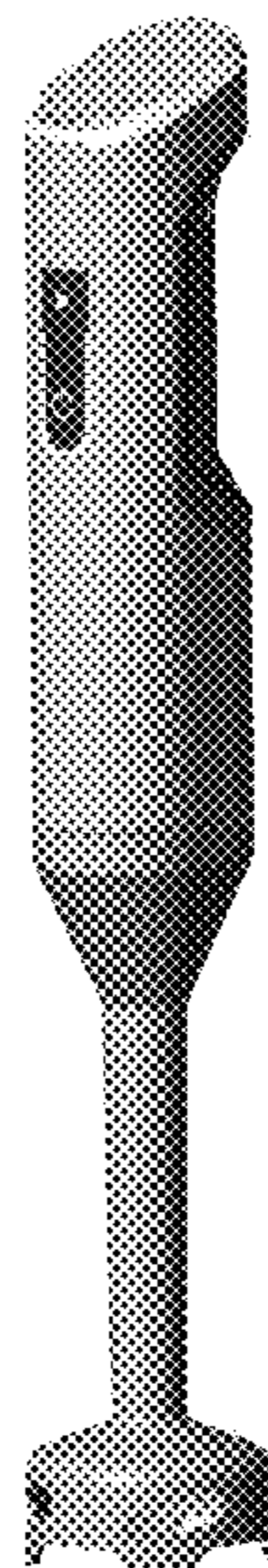
FIG. 1.5 is a bottom view thereof;

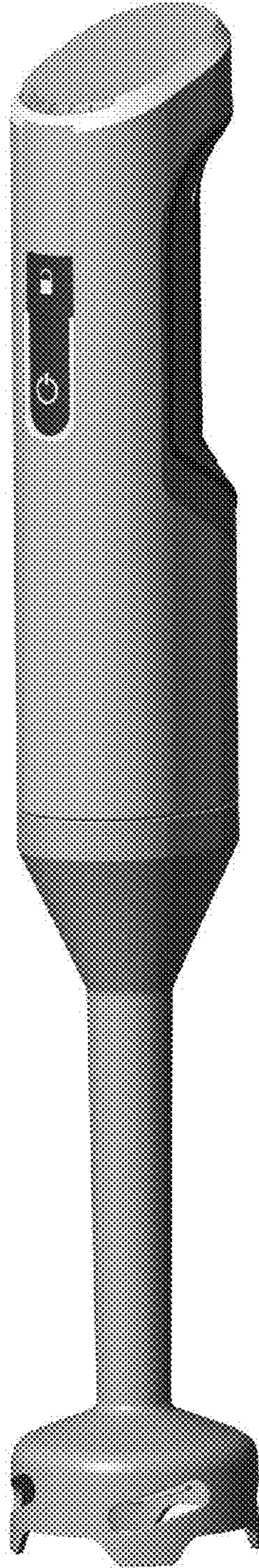

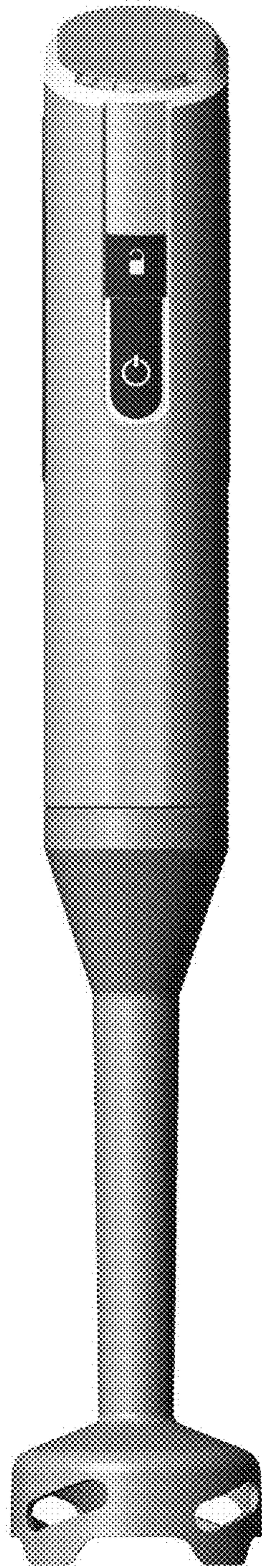

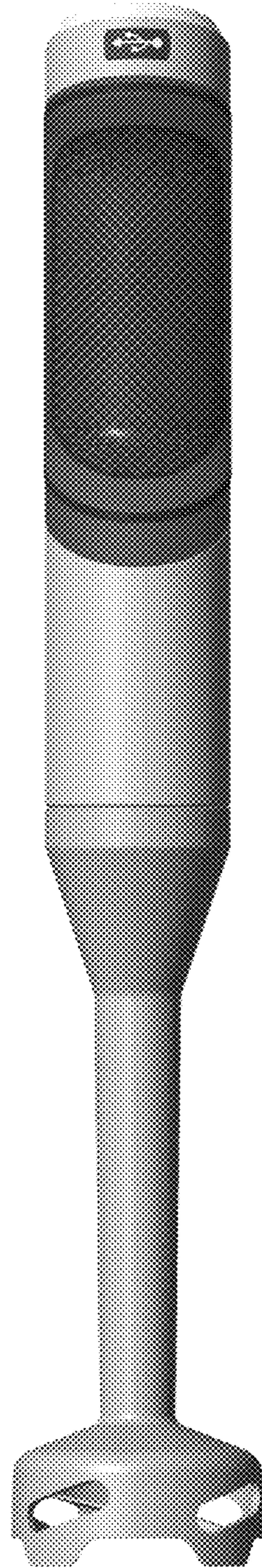

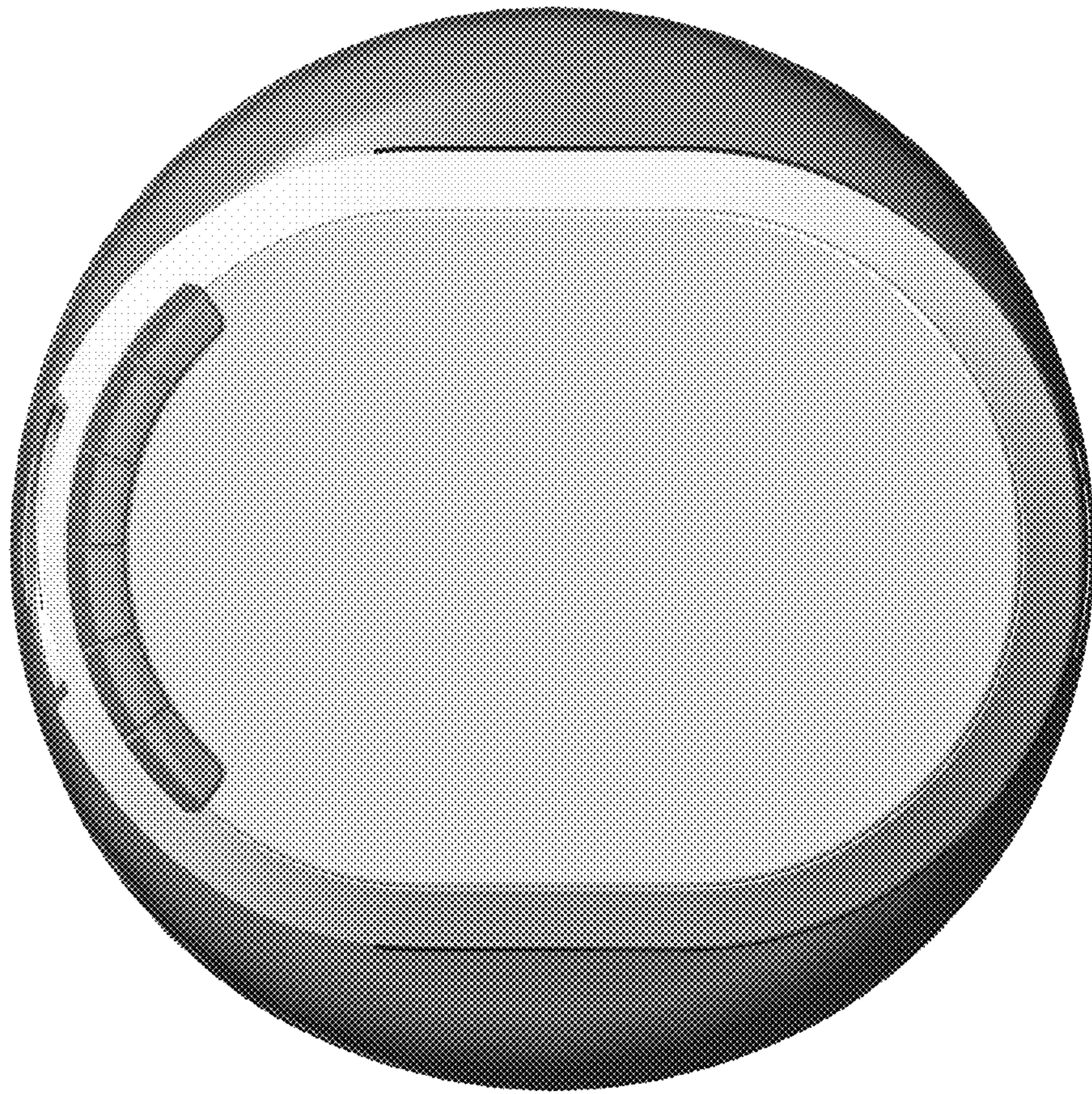

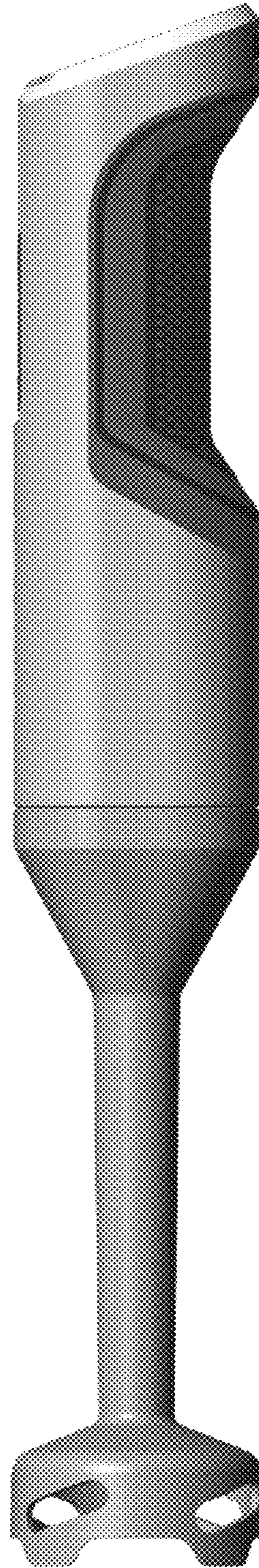

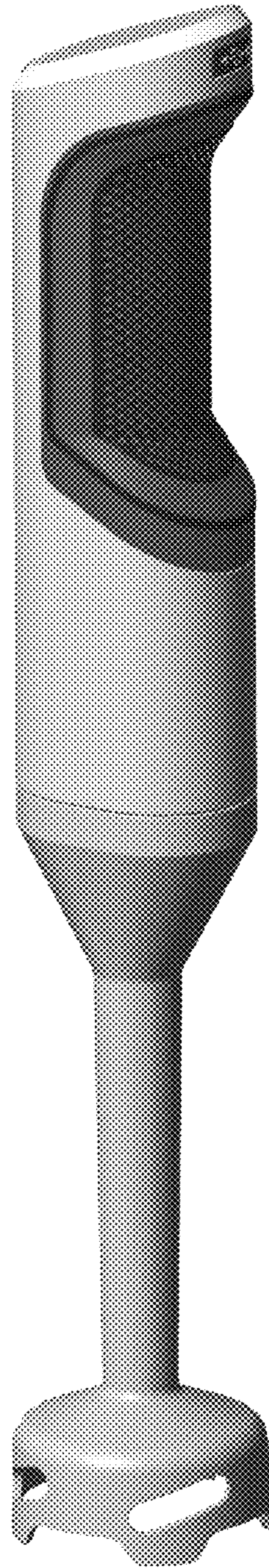
