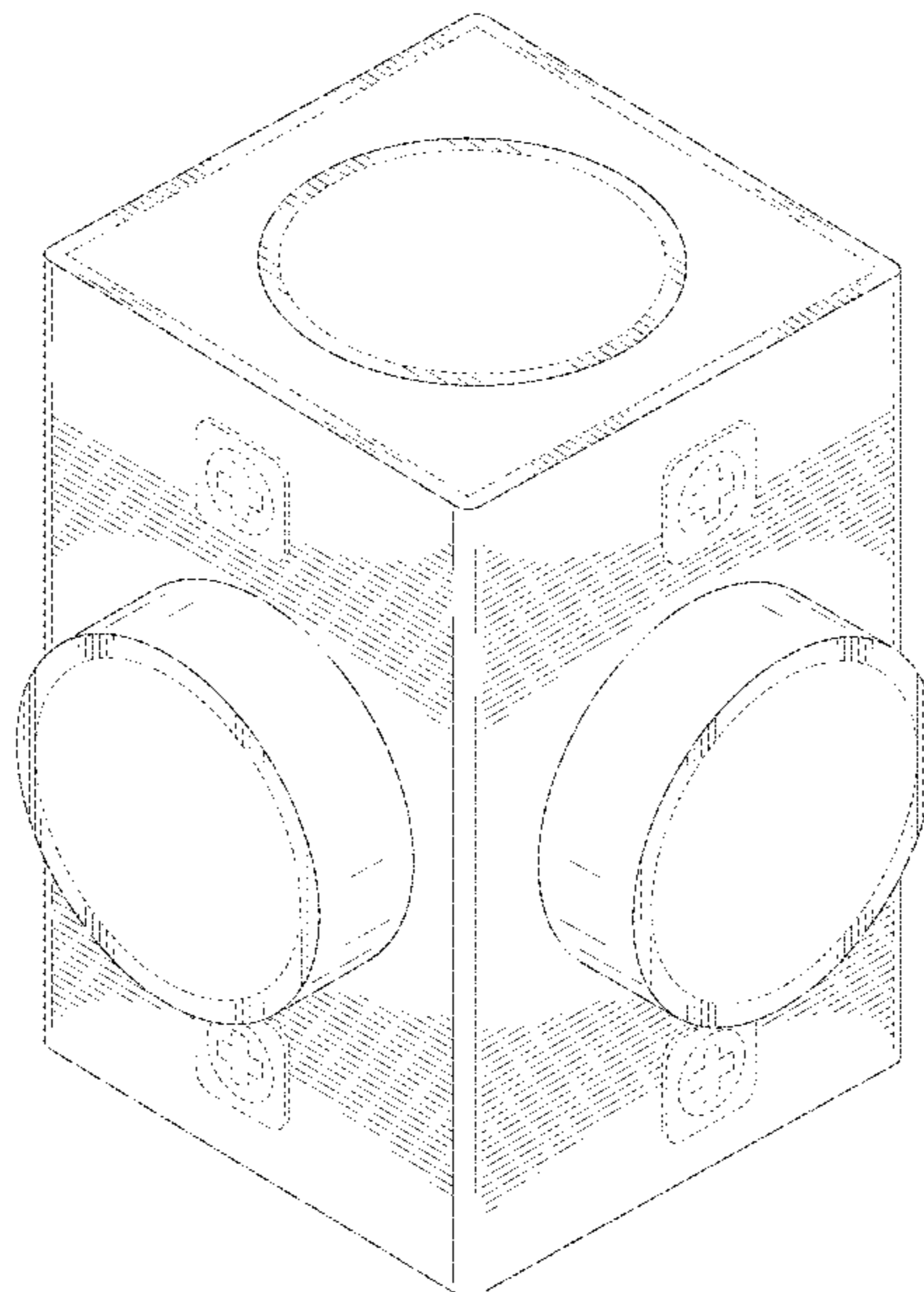

FIG. 1 is a front, right, top perspective view of the claimed design, the rear, left, bottom perspective view being identical thereto;
FIG. 2 is a front view of the claimed design of FIG. 1, the rear, left and right side views being identical thereto; and,

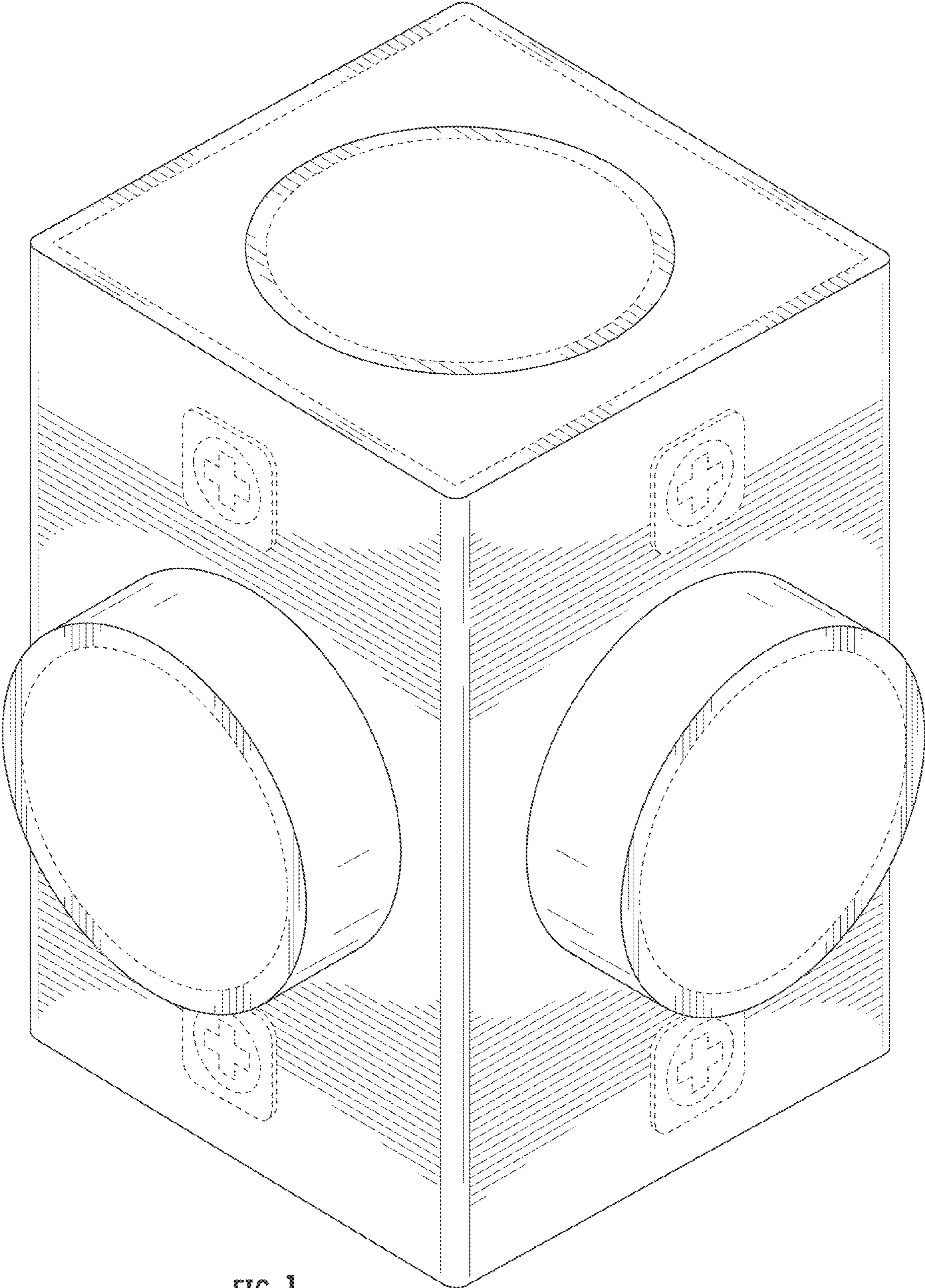

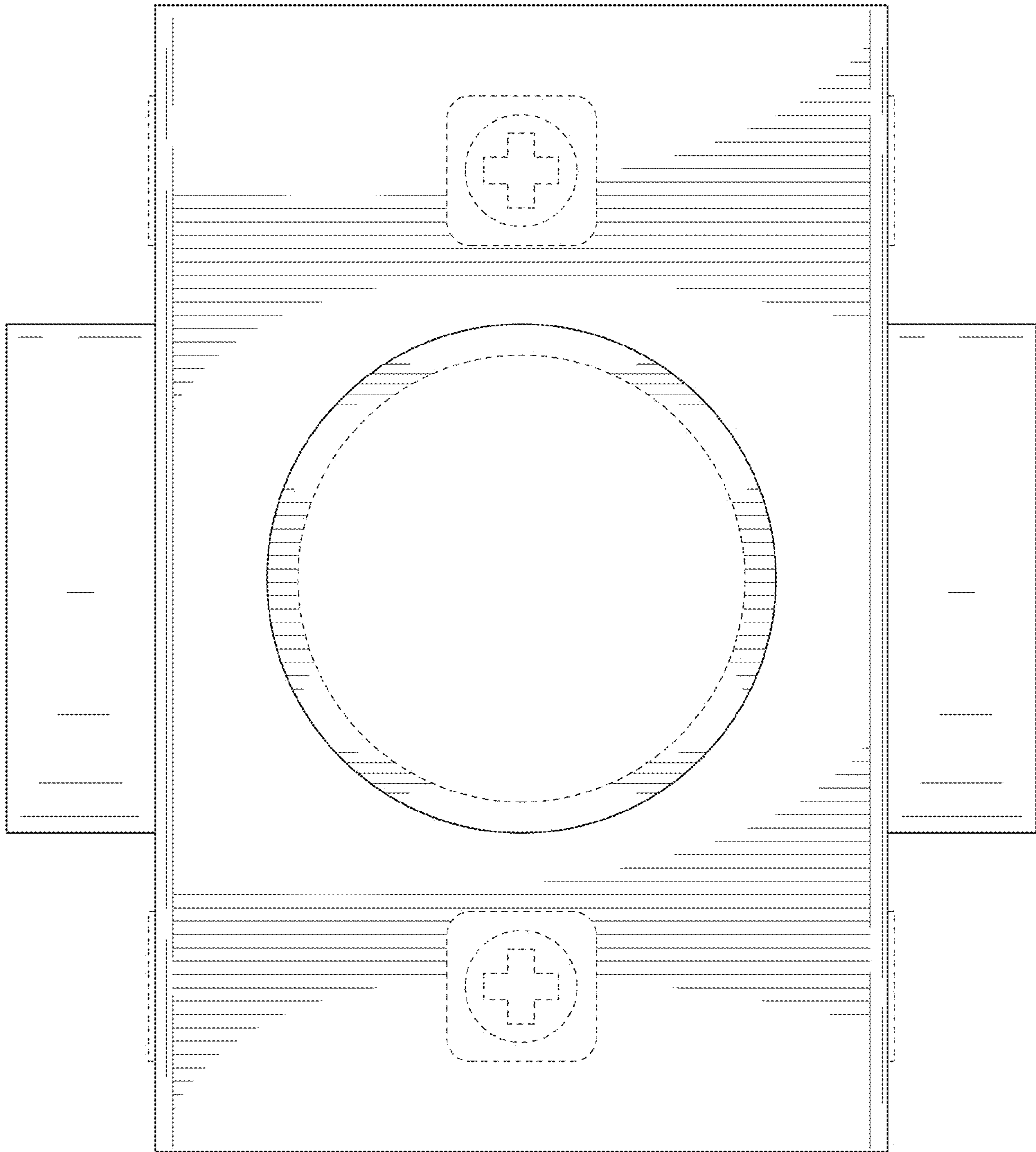

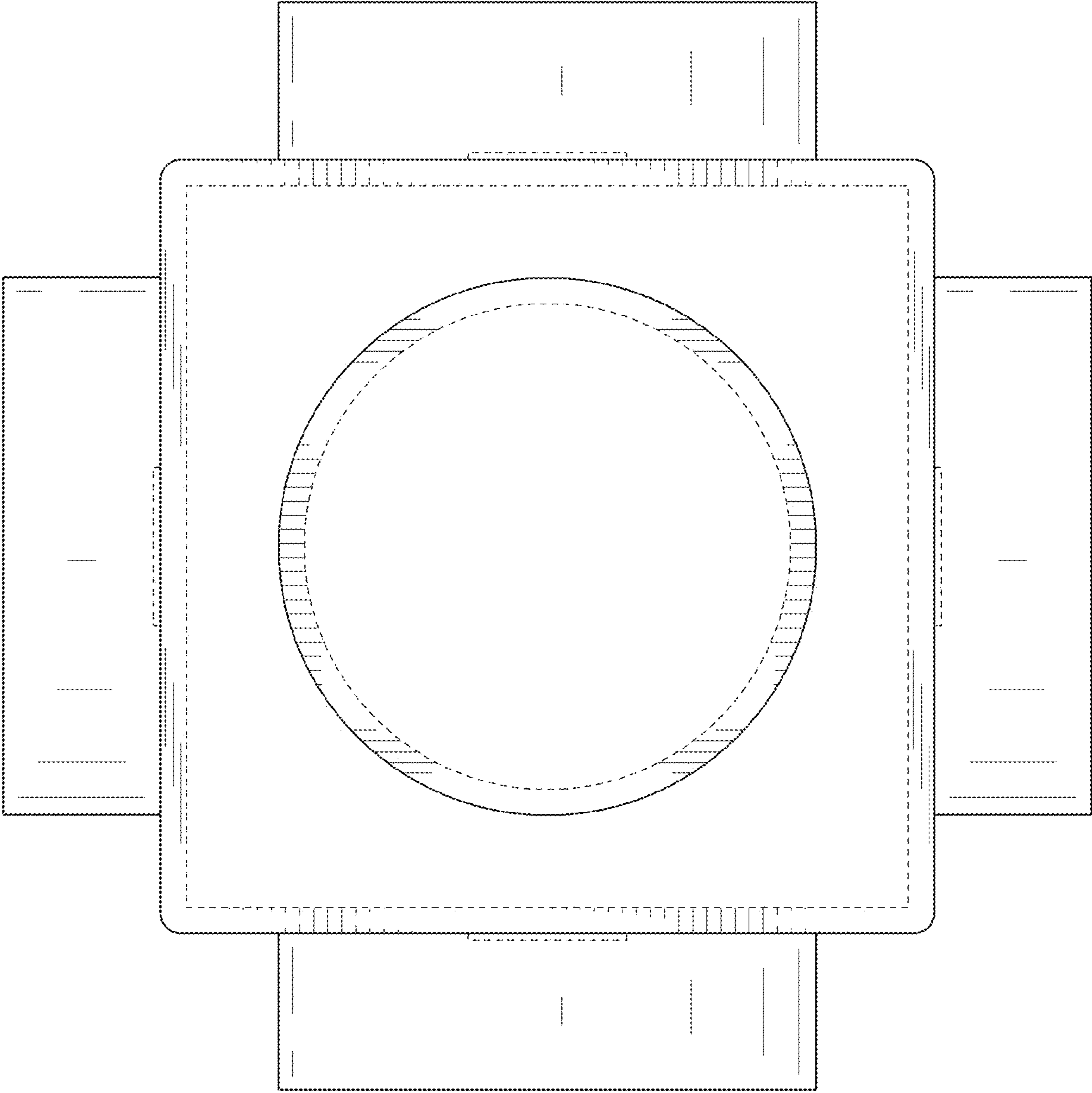
