(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a container, showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken lines illustrate portions of the container that form no part of the claimed design.

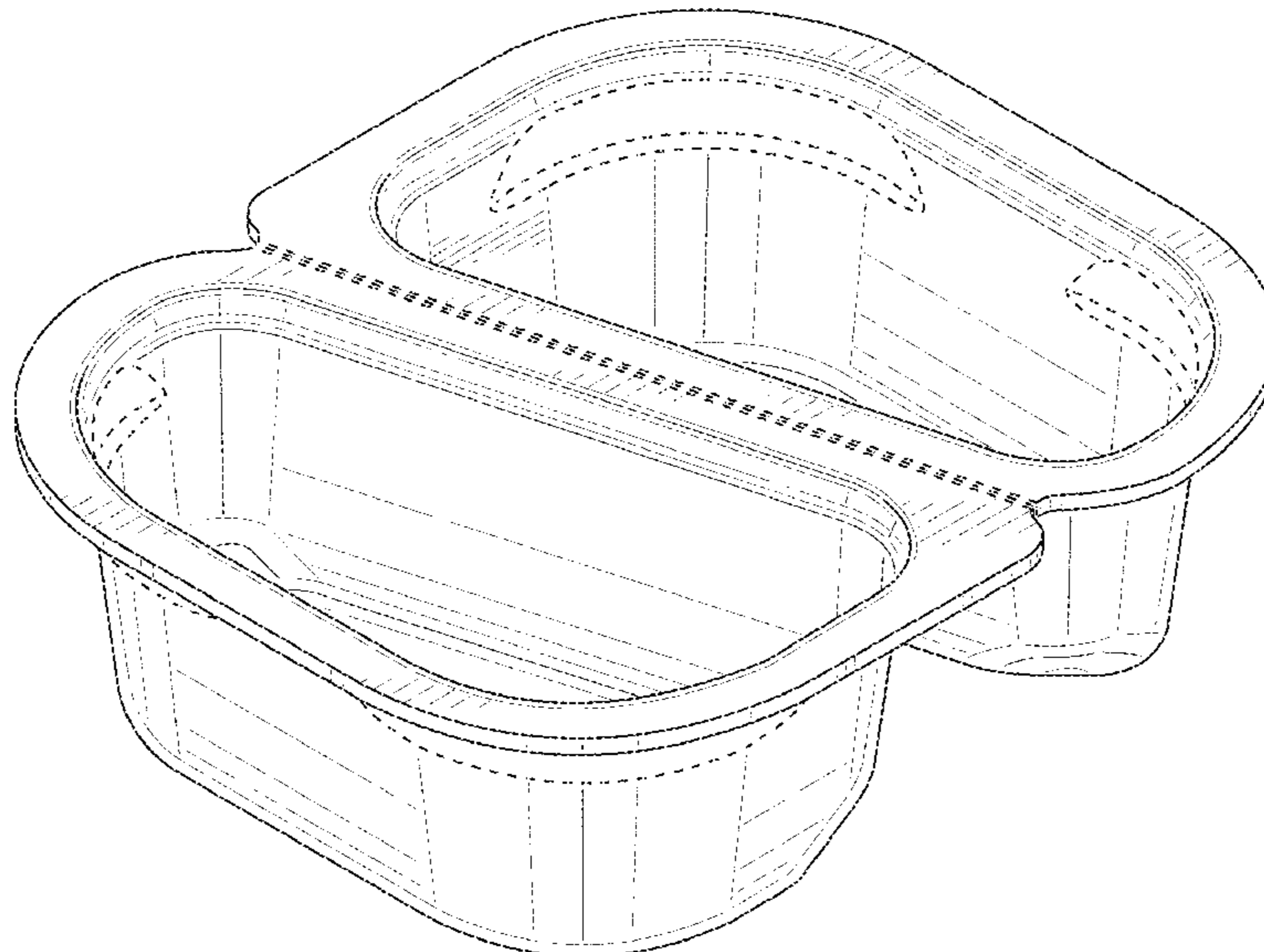
The diagonal broken lines in the middle of the flange on the container in FIGS. 1 and 4-7 are included to show unclaimed seam on the article.

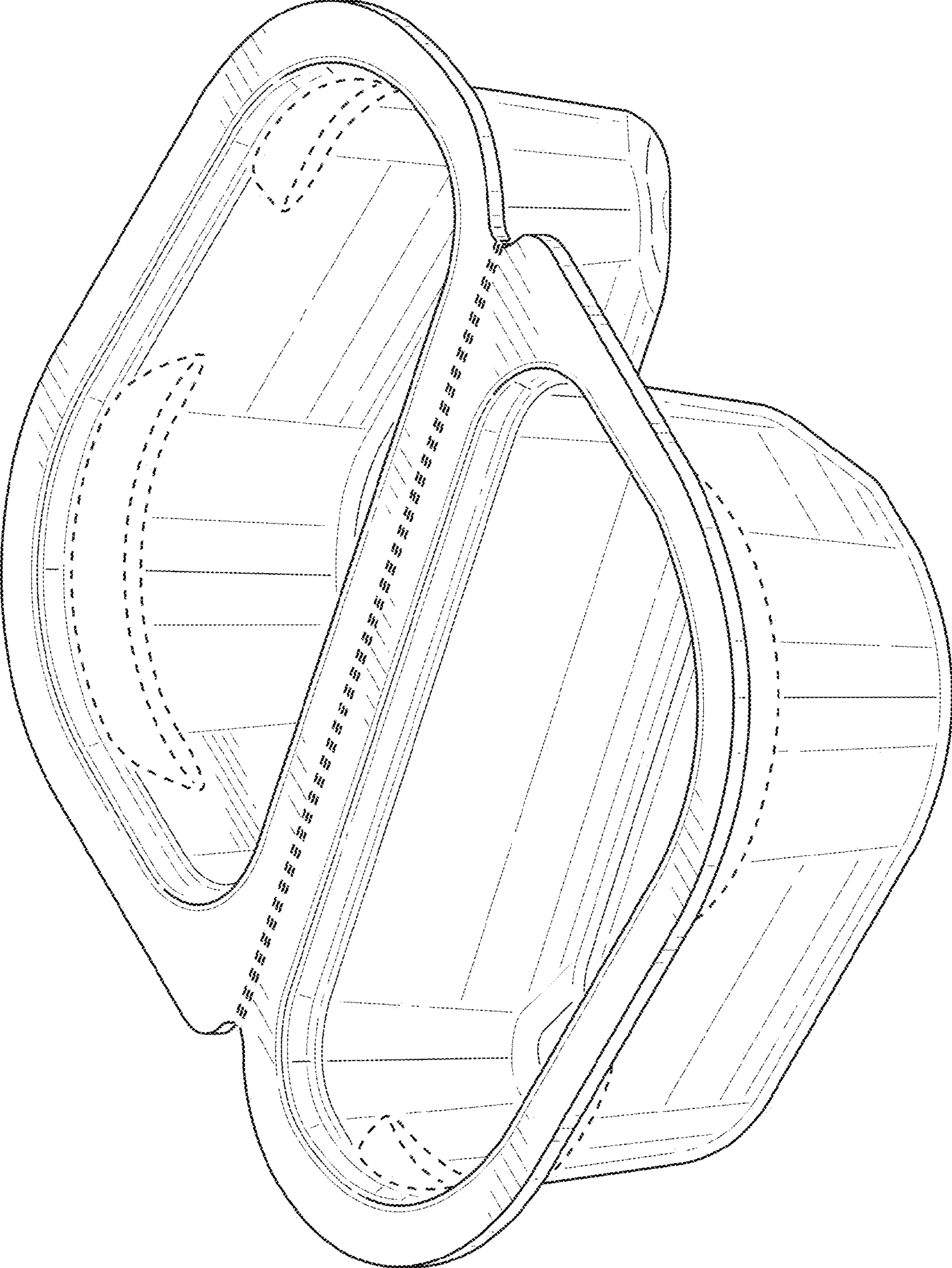

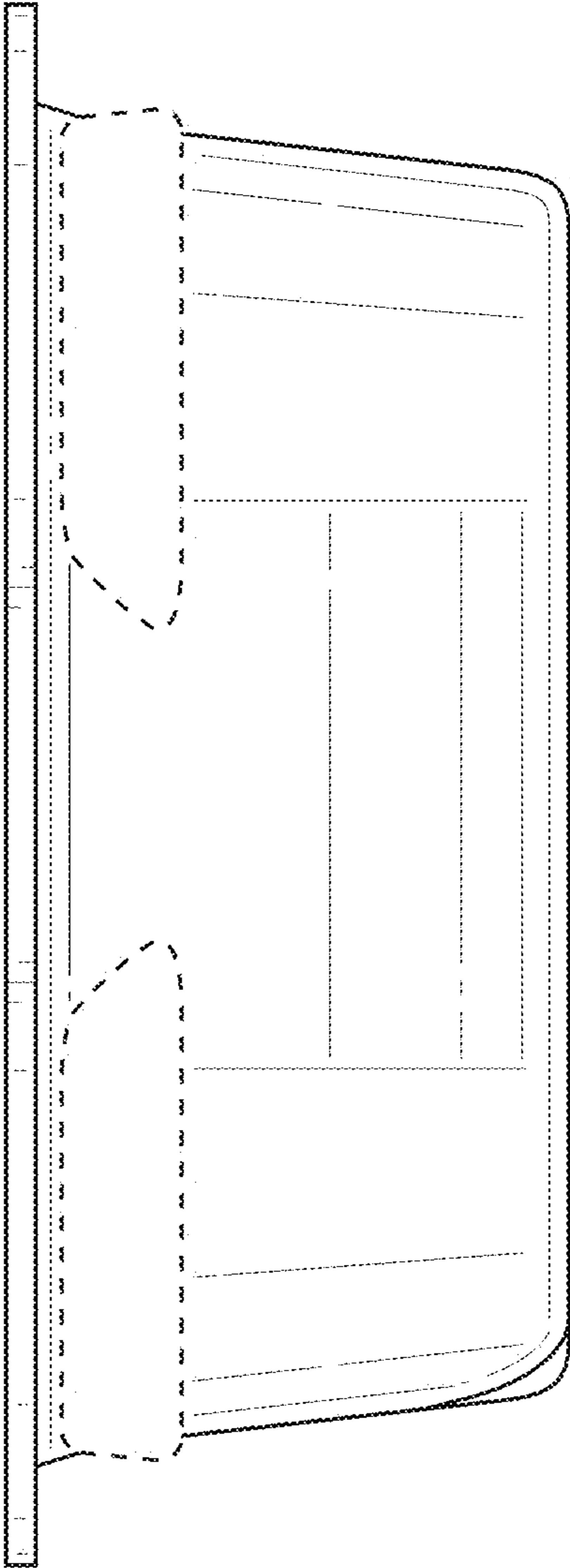

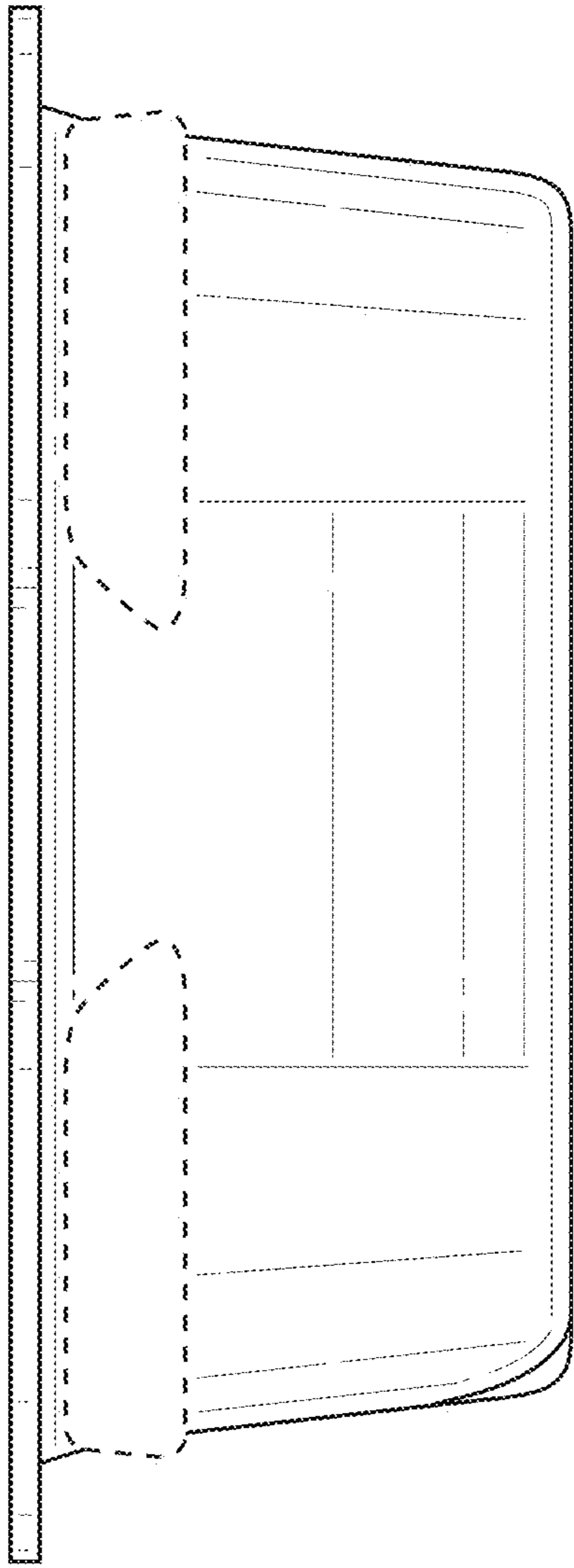

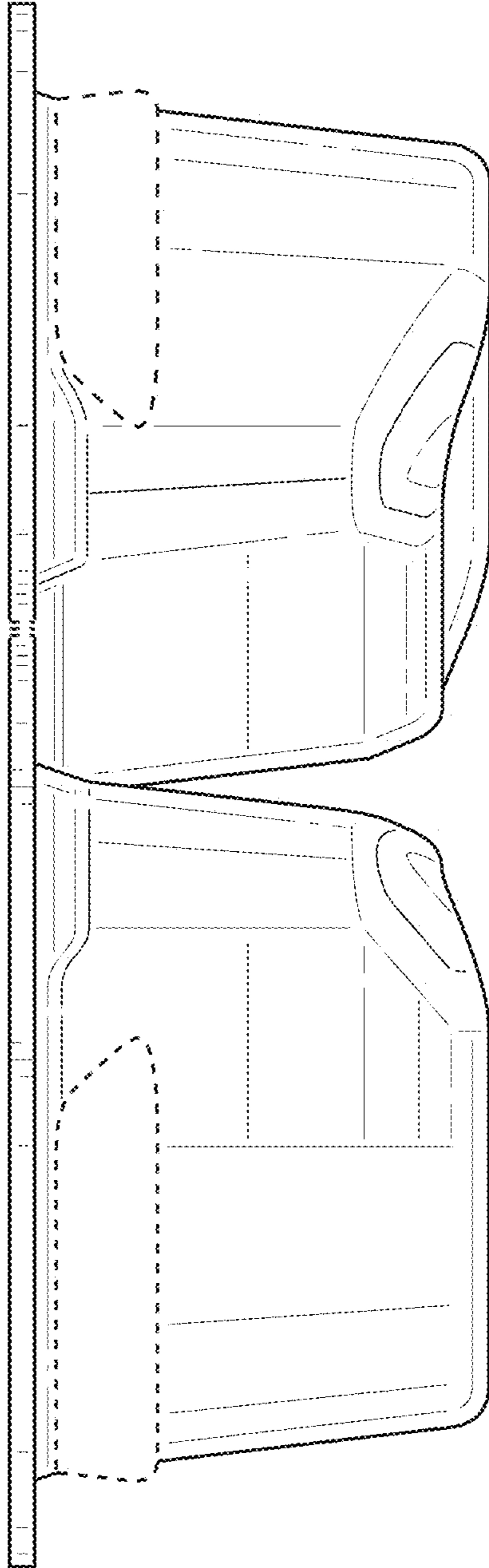

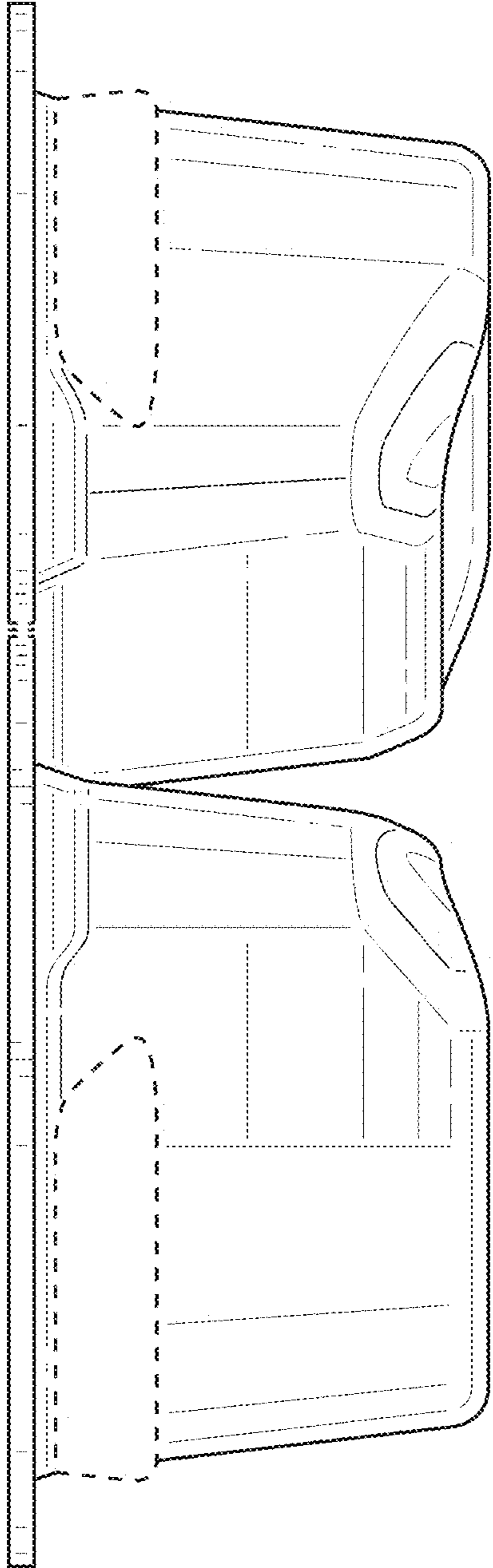

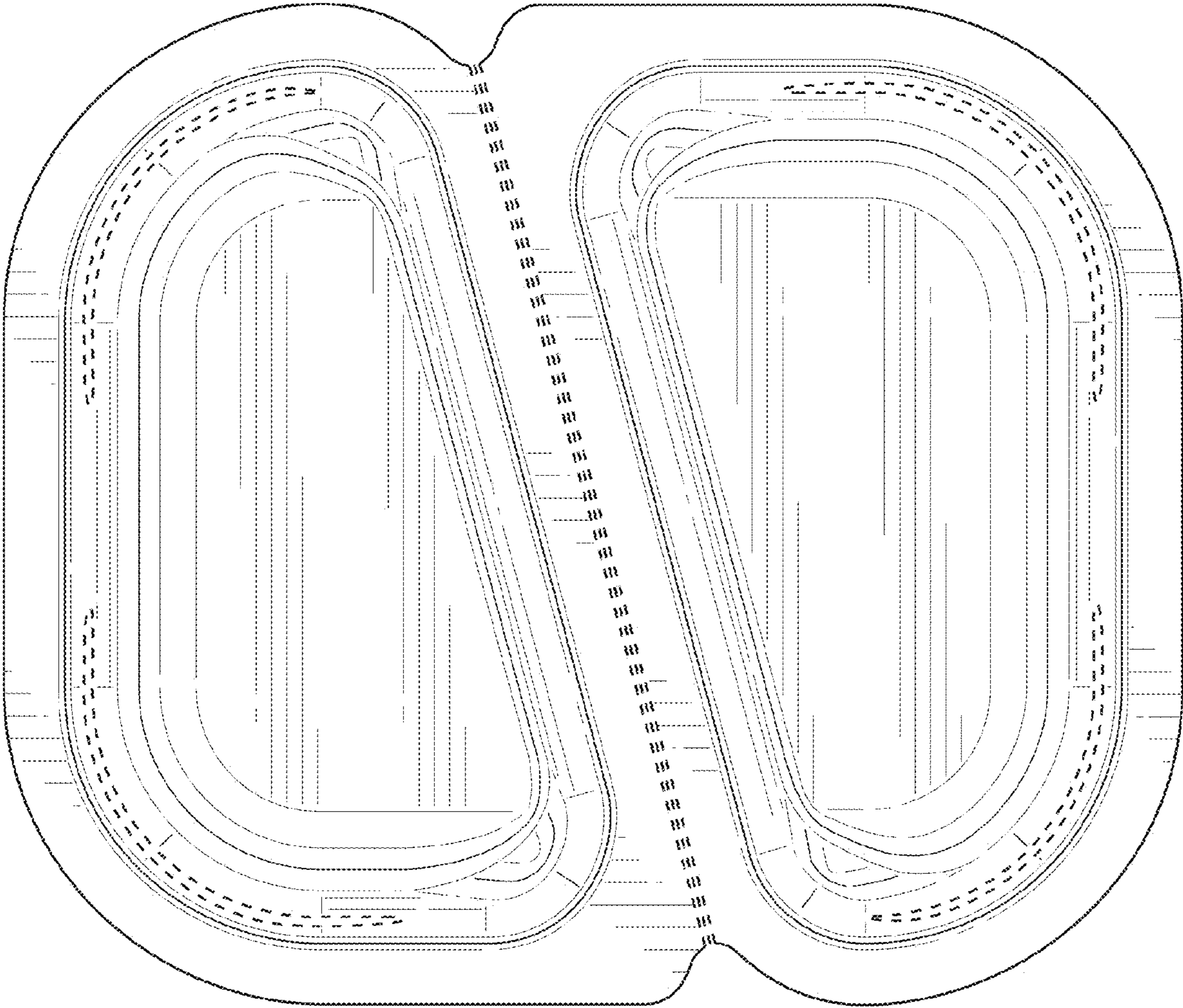

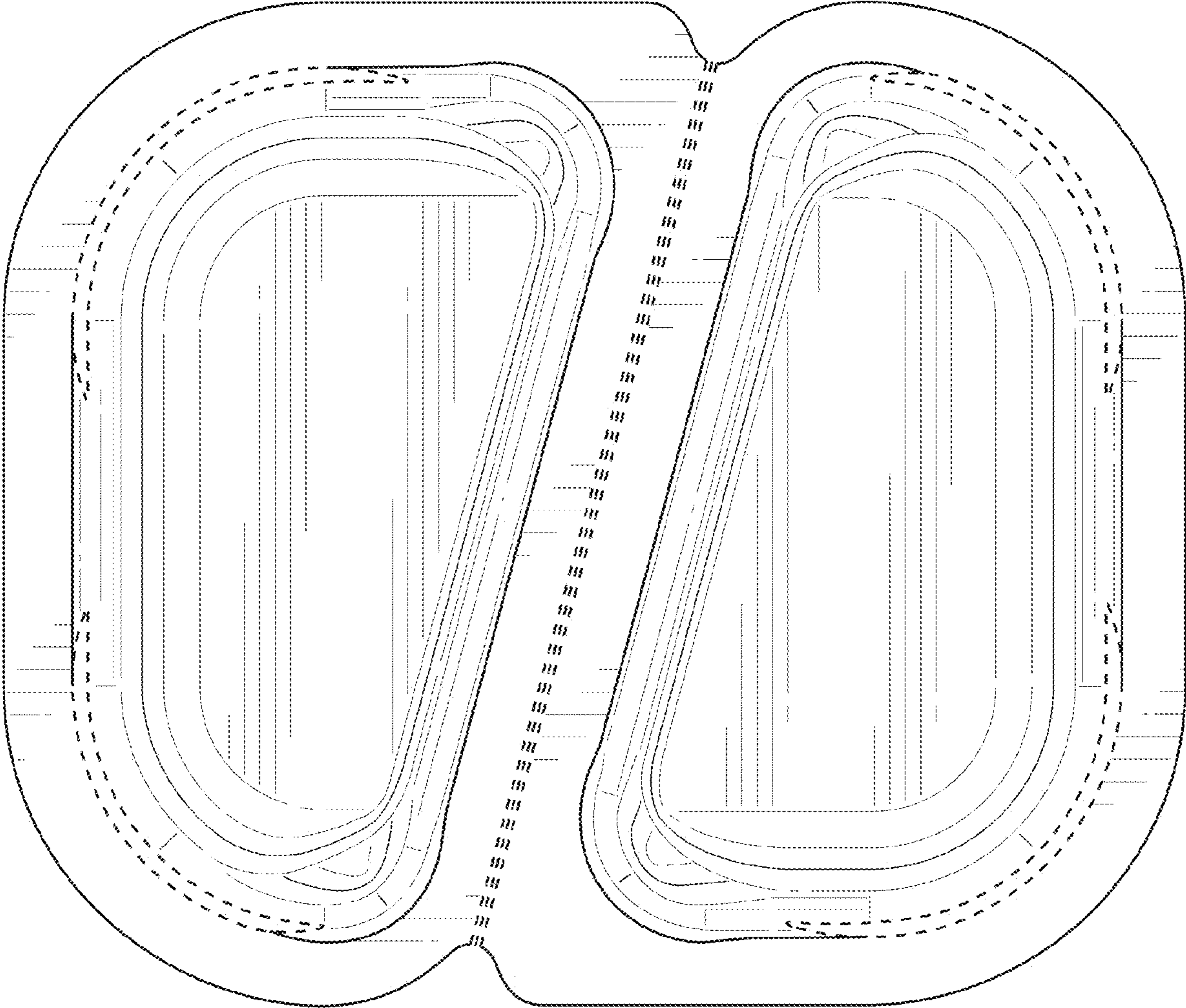
