DESCRIPTION

1. Front door panel for automobiles

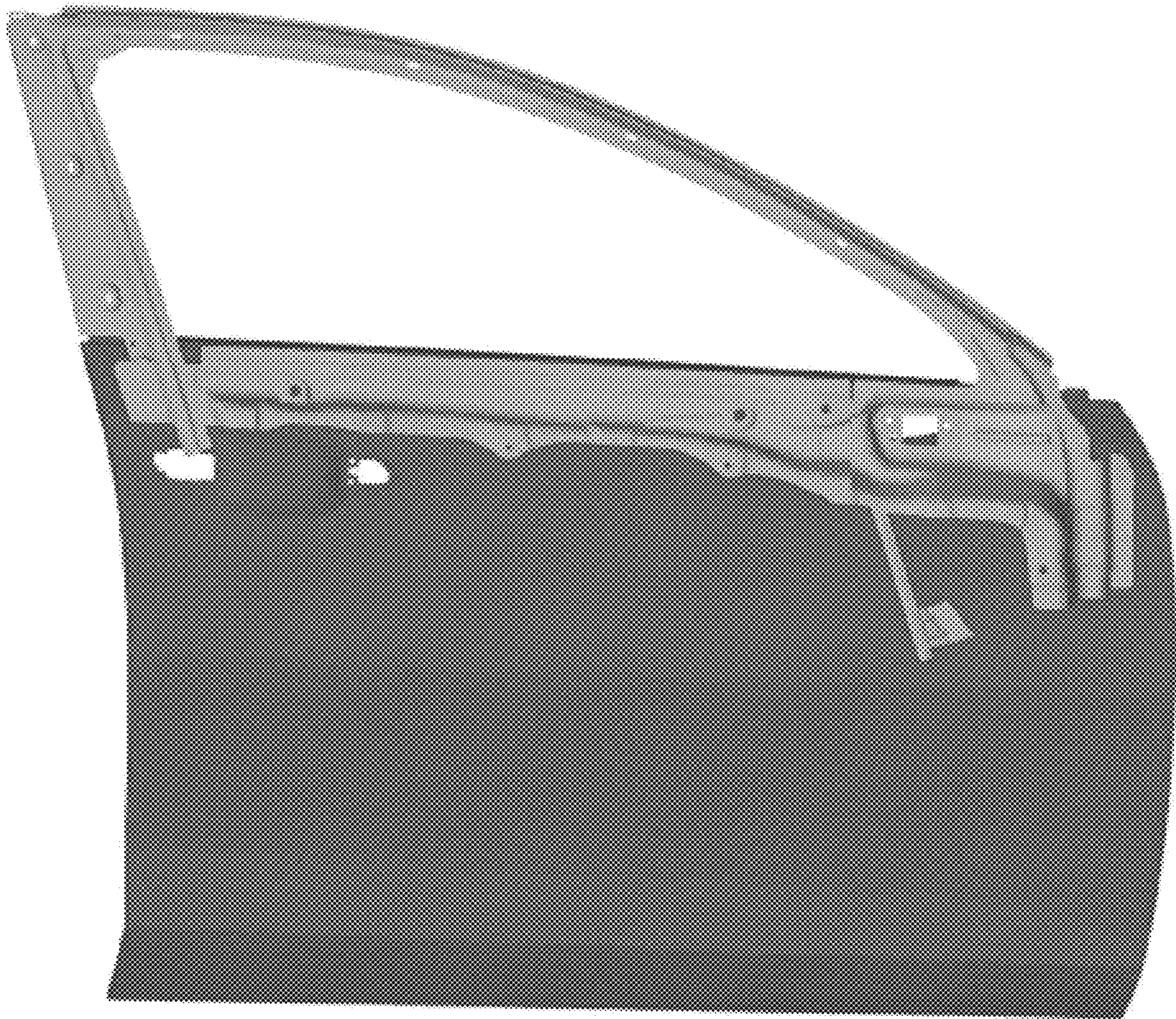

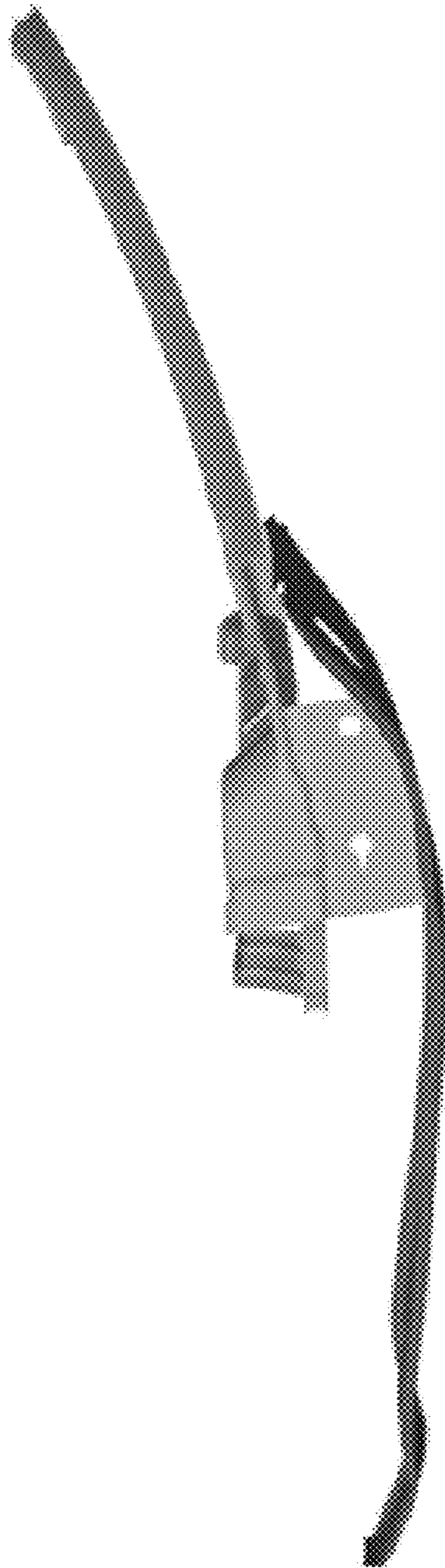

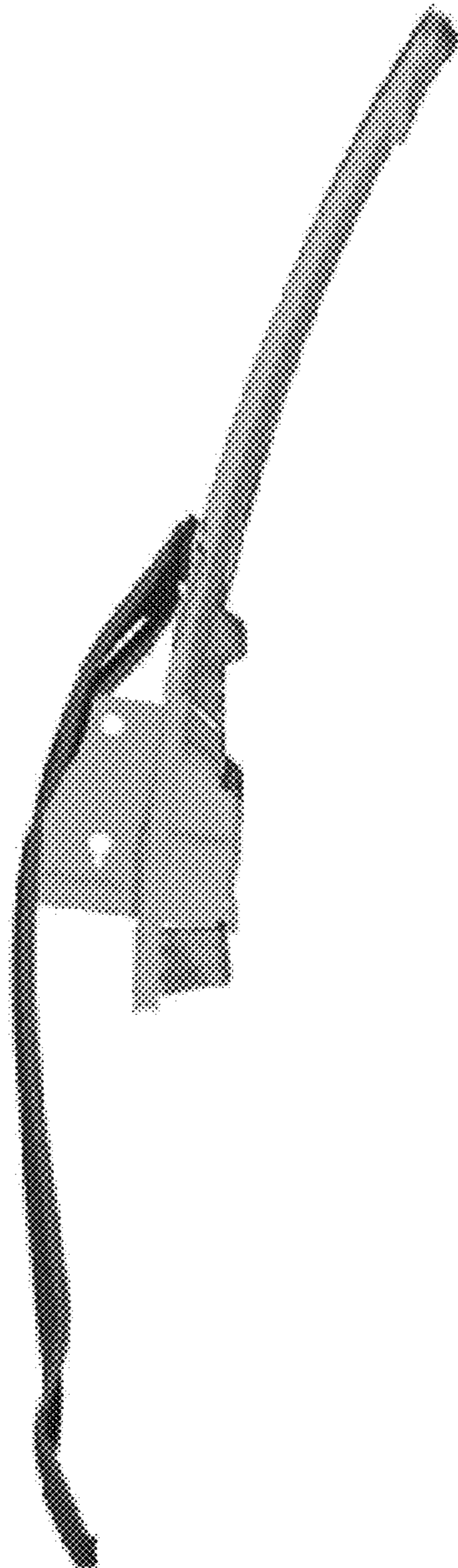

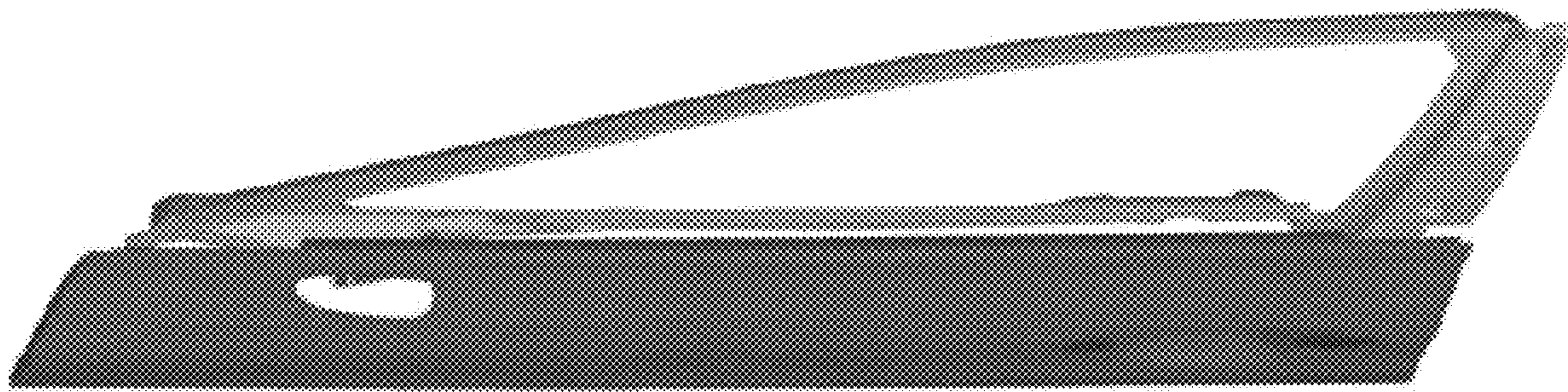
