(57) **CLAIM**

The ornamental design for a power cord cover, substantially as shown and described.

DESCRIPTION

FIG. 1 is a side view of a first embodiment of a power cord cover, shown in an environment of use.

FIG. 2 is an enlarged view of portion “2” shown in FIG. 1. FIG. 3 is a perspective view thereof, shown separately from the environment of use.

FIG. 4 is a top plan view thereof.

FIG. 5 is a side view of a second embodiment of a power cord cover, shown in an environment of use.

FIG. 6 is an enlarged view of portion “6” shown in FIG. 5. FIG. 7 is a perspective view thereof, shown separately from the environment of use; and,

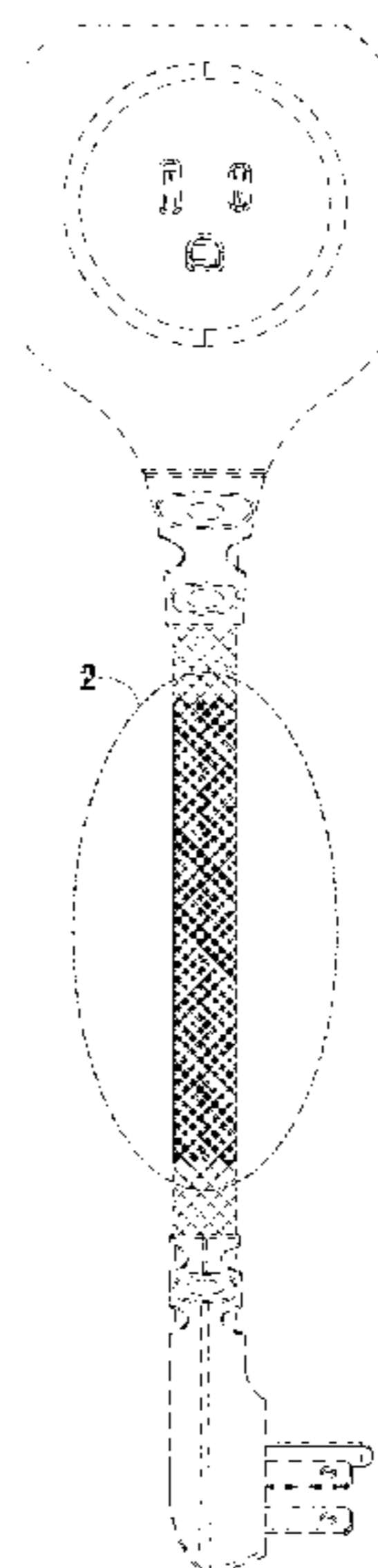
FIG. 8 is a top plan view thereof.

The evenly spaced broken lines illustrate environmental subject matter forming no part of the claimed design. The dot-dash lines illustrate enlarged view indicators and form no part the claimed design.

The power cord cover comprises squarish regions forming contrasting surface areas and thus defining a pattern of contrast in appearance. A single pattern of contrast in appearance is depicted in the drawings.

The claimed pattern of contrast in appearance of the power cord cover repeats uniformly along the length of the power cord cover.

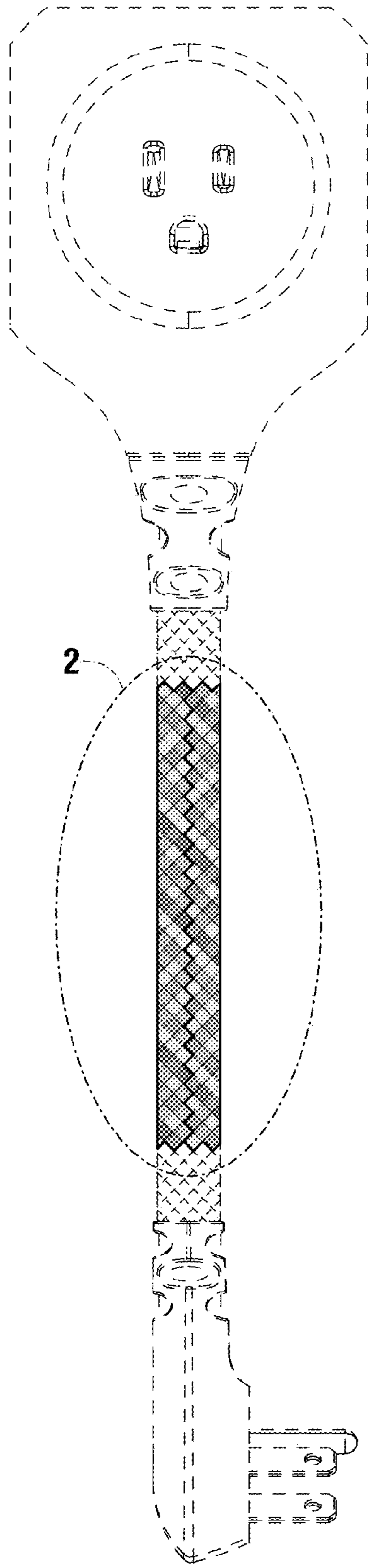

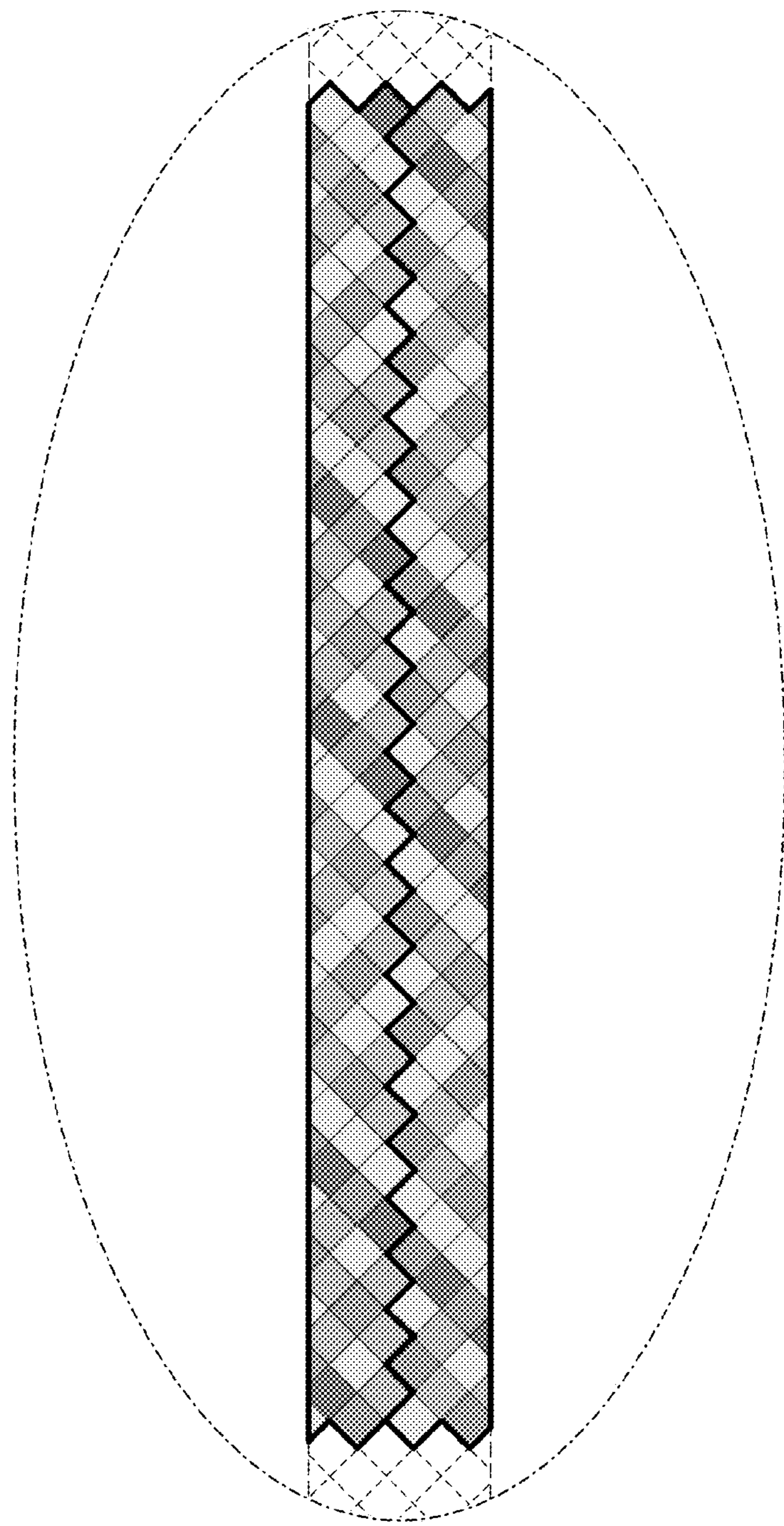

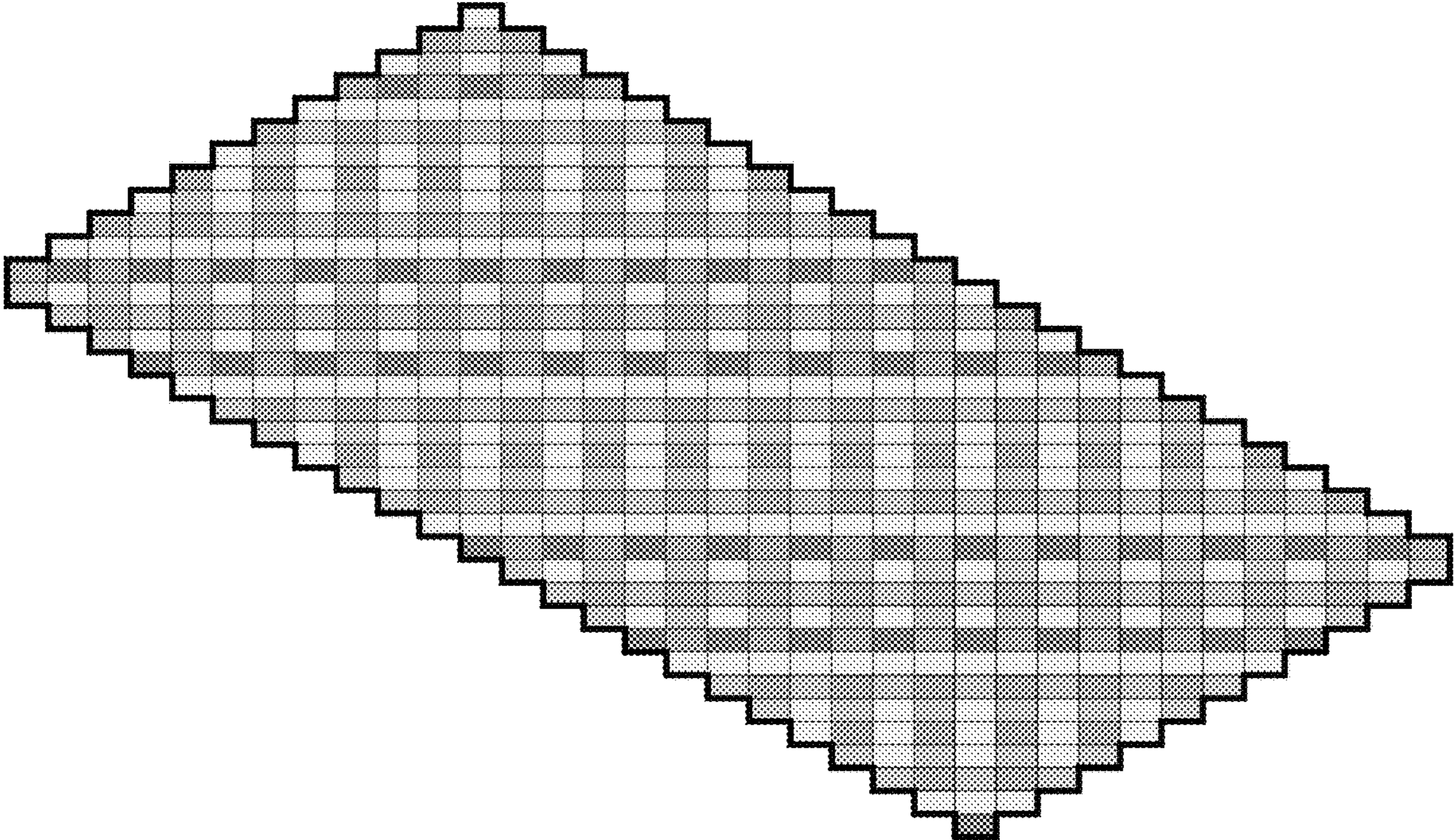

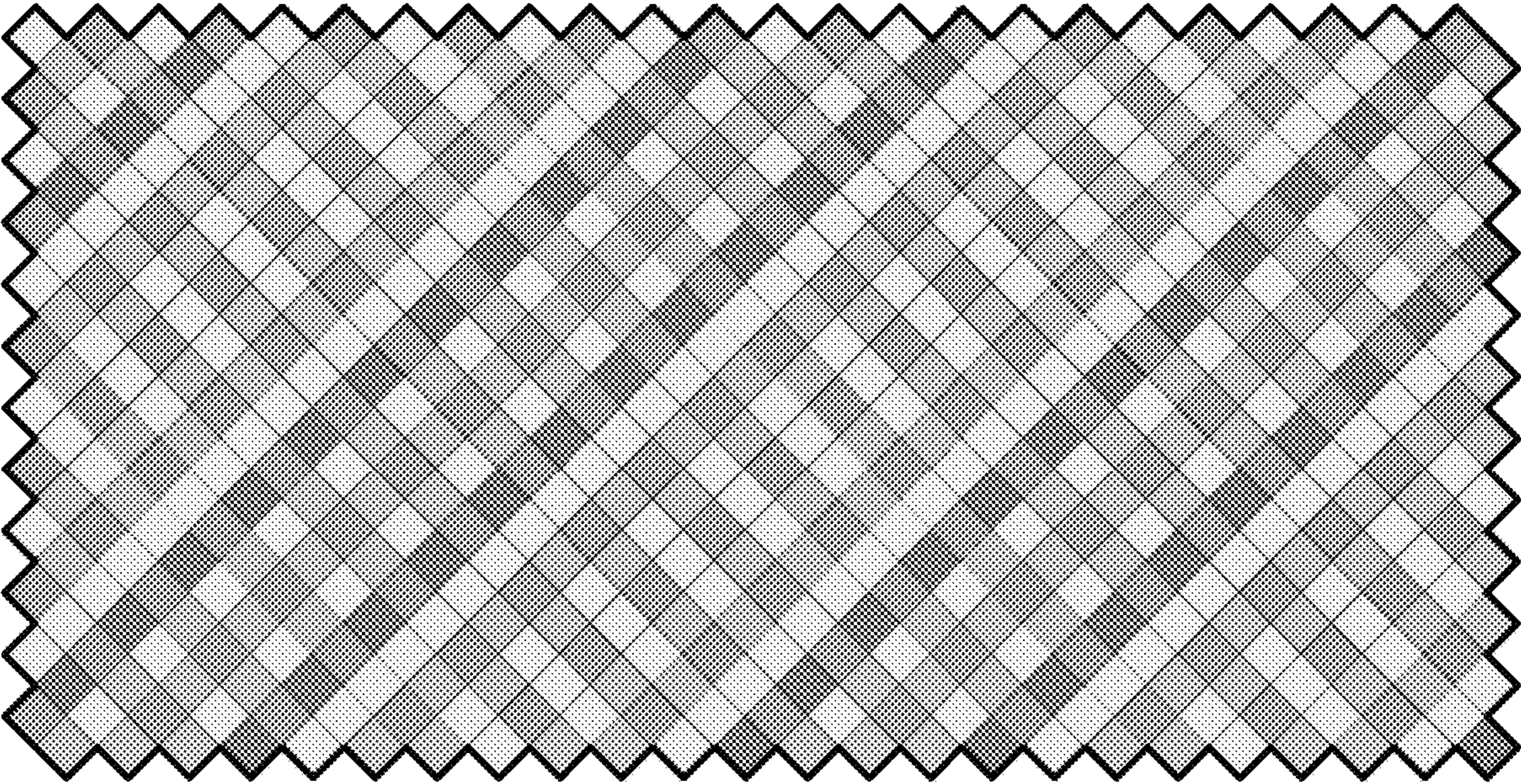

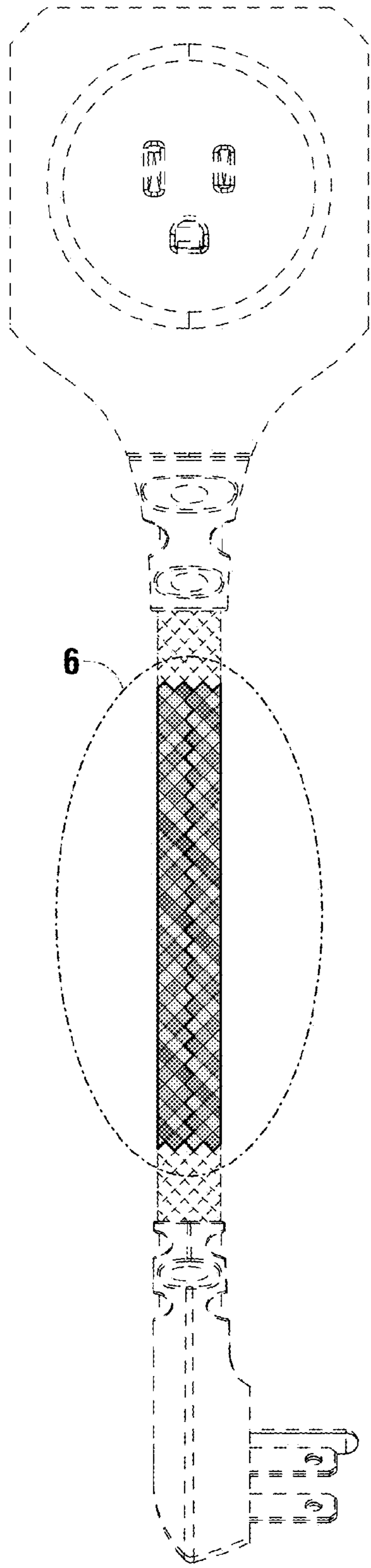

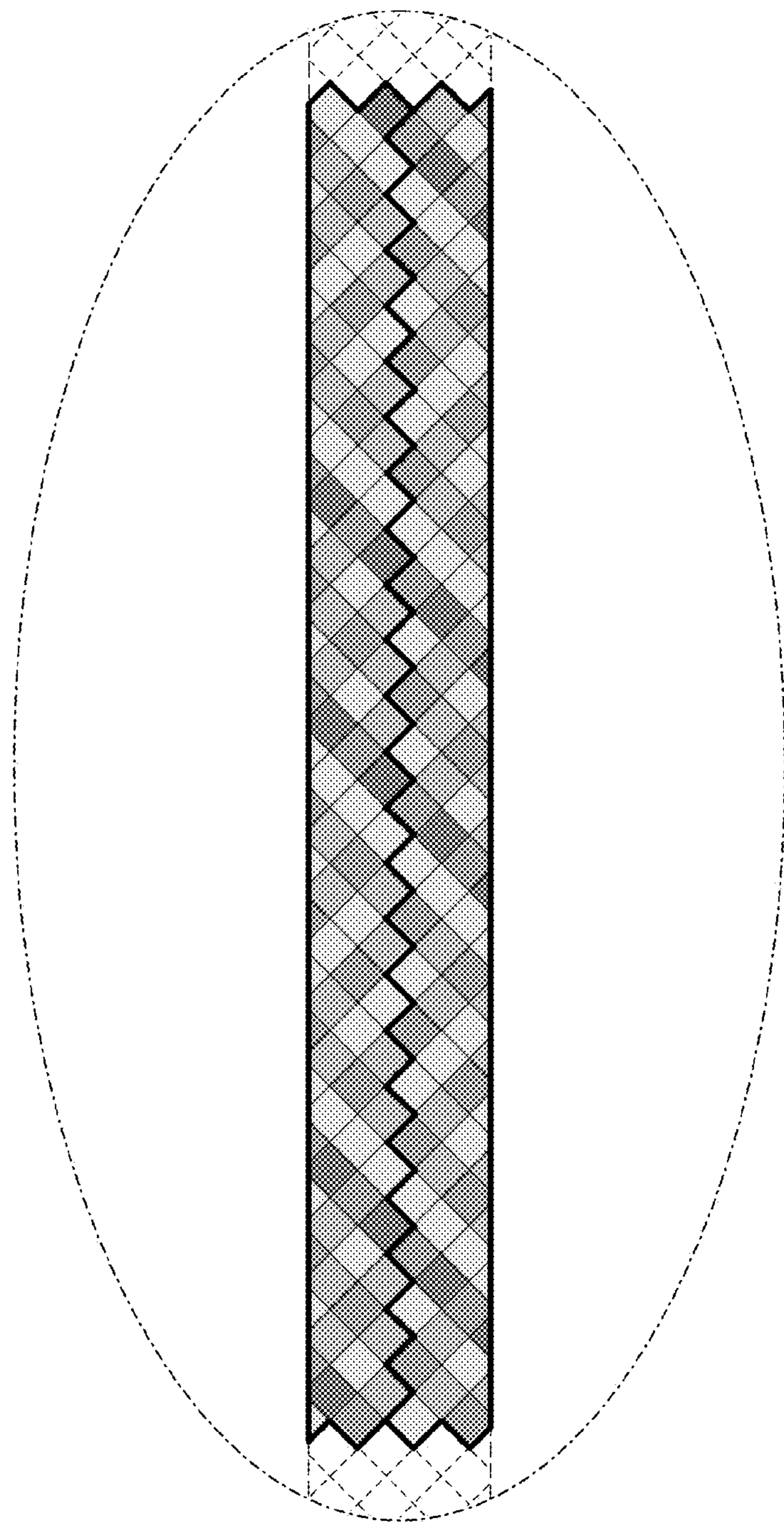

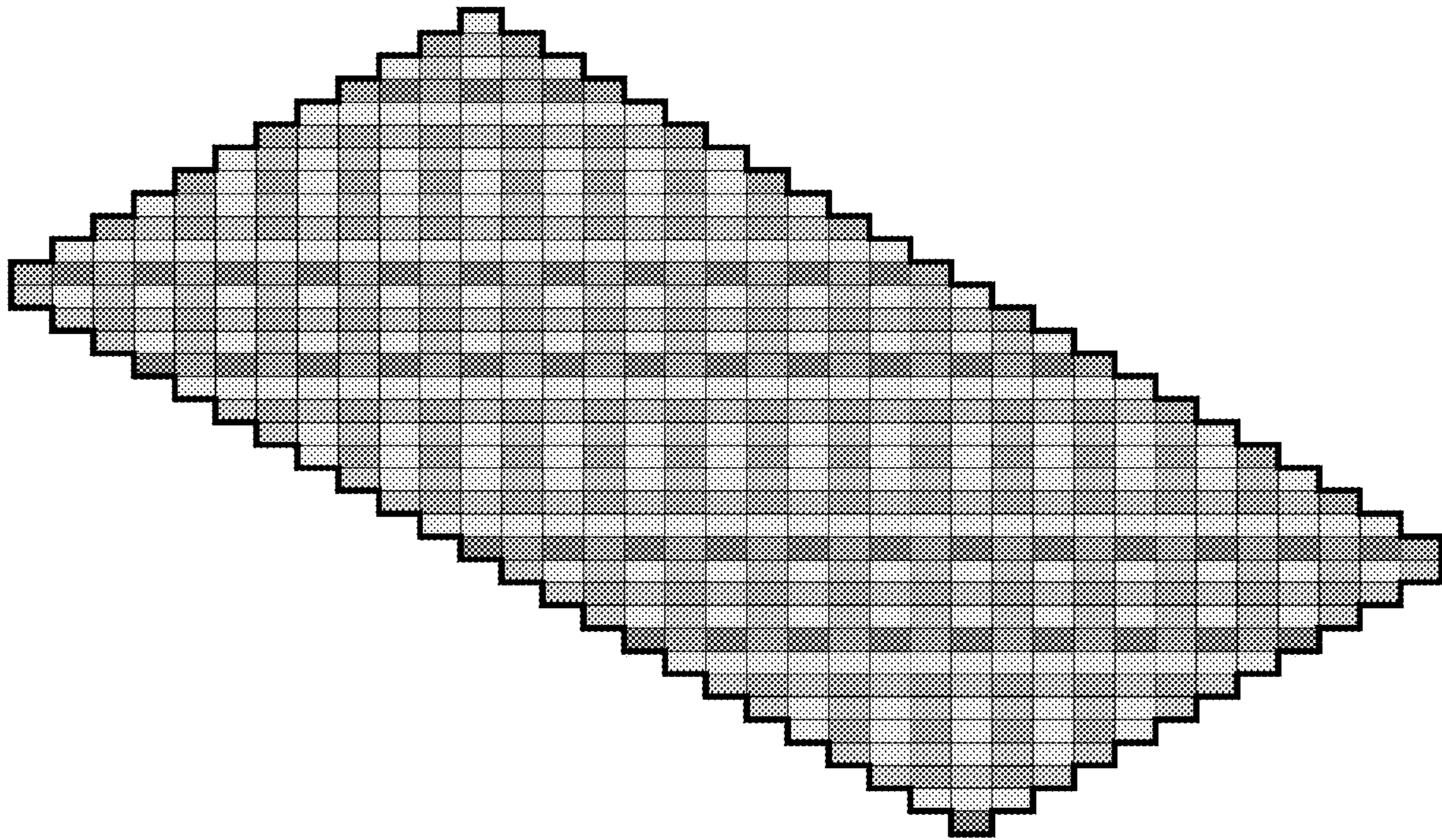

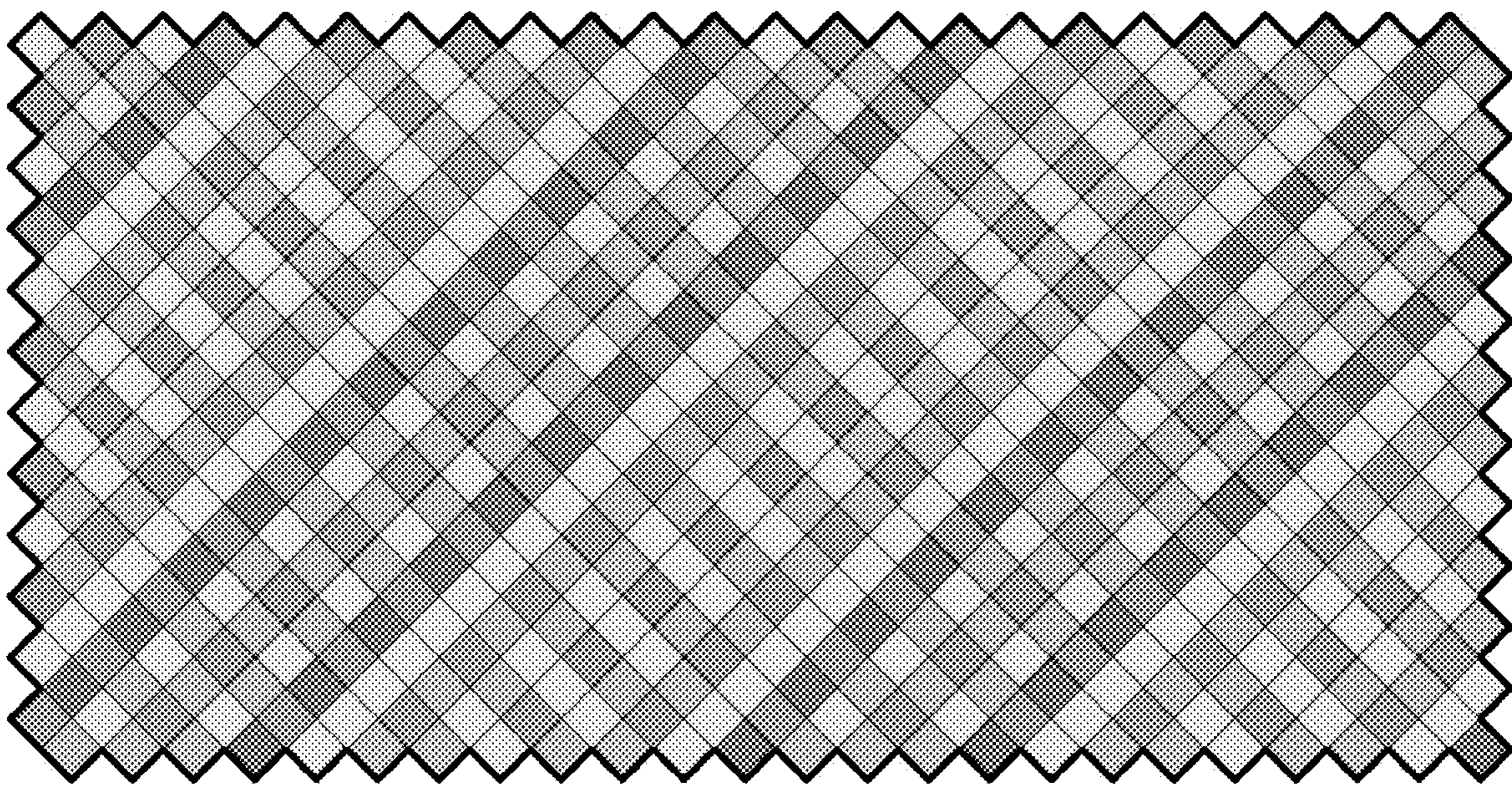
