DESCRIPTION

FIG. 1 is a front and right side perspective view of a stand for mobile telephone showing my new design;

FIG. 9 is a front and right side perspective view in a first unfolded state;

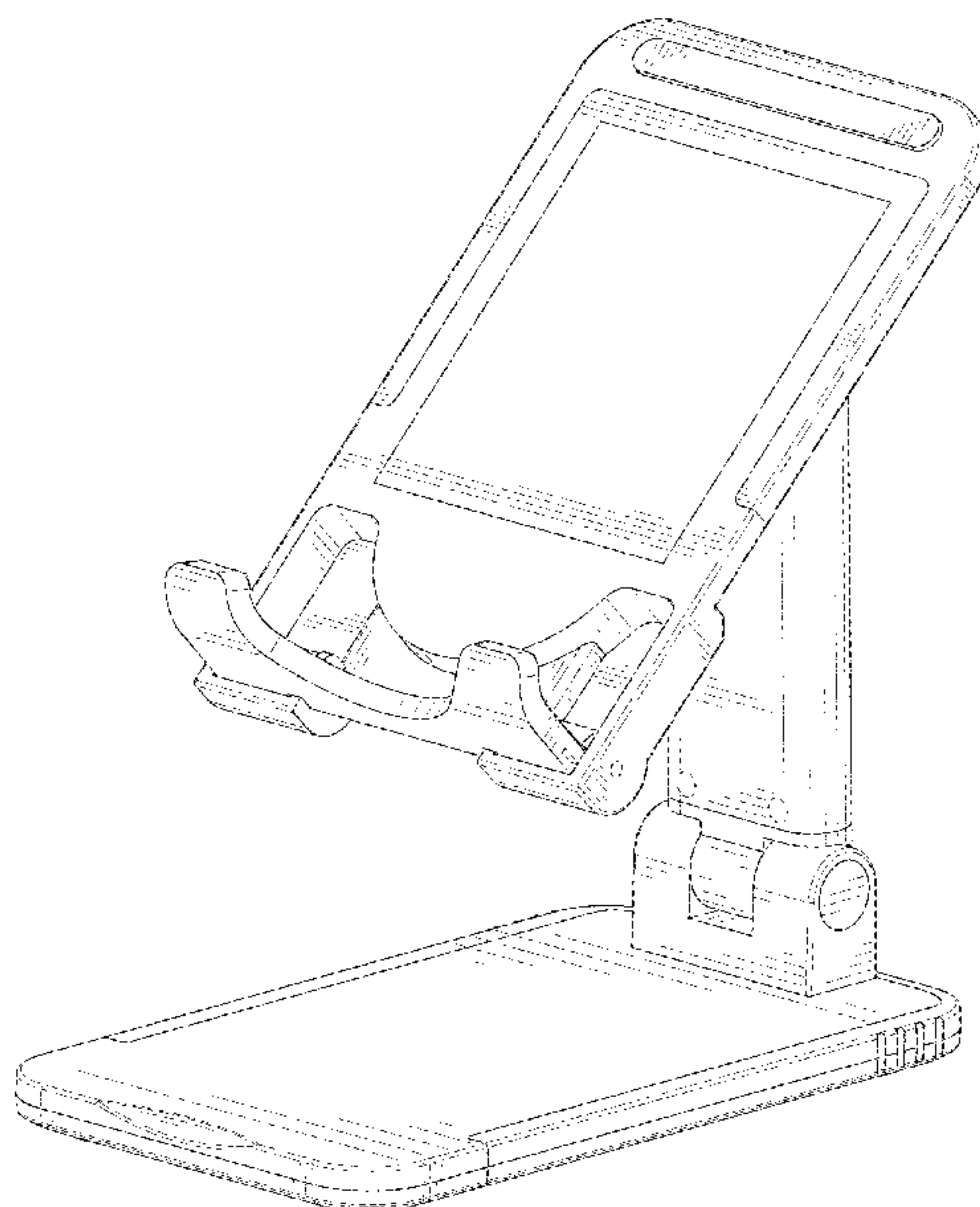
FIG. 10 is a front and right side perspective view in a second unfolded state;

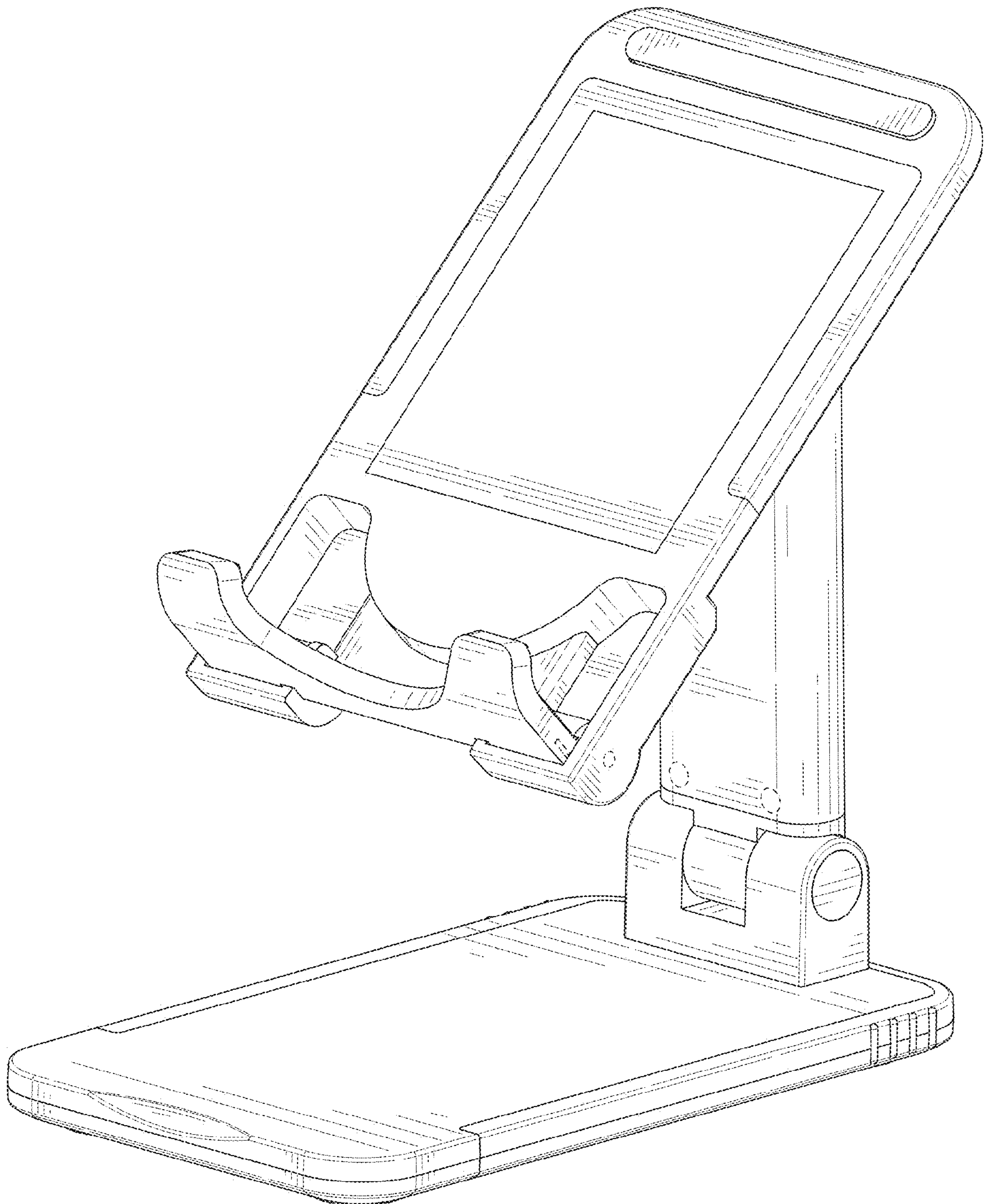

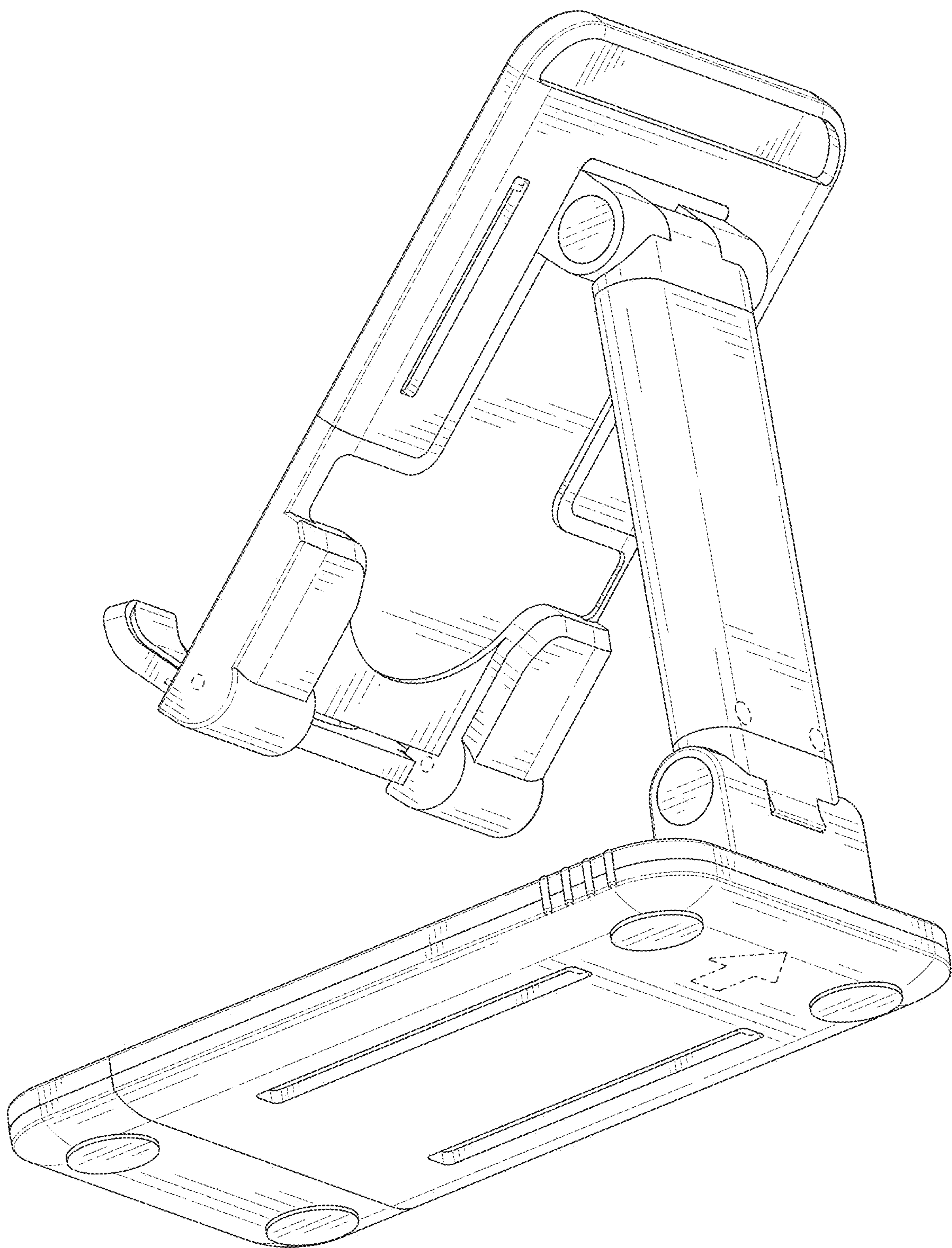

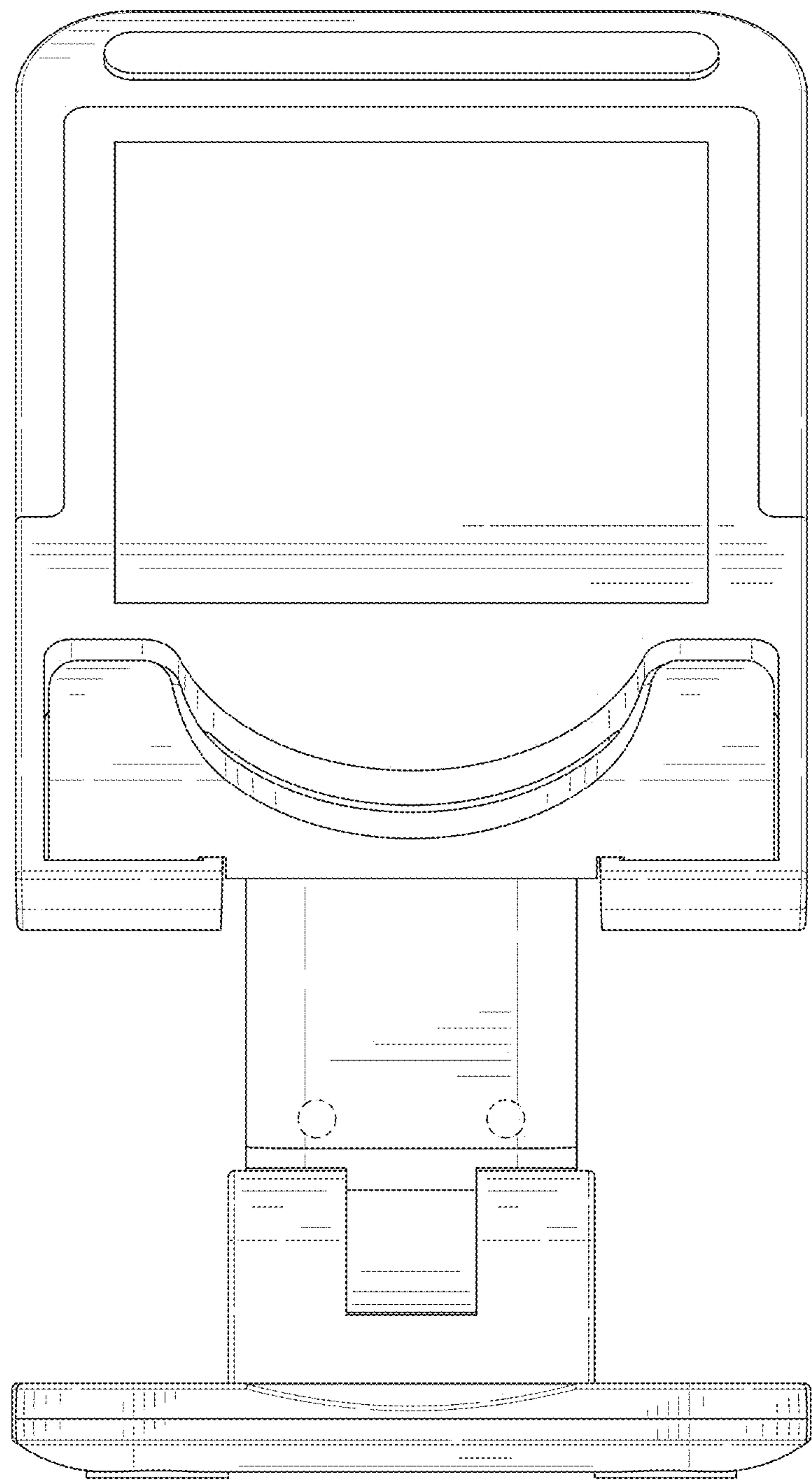

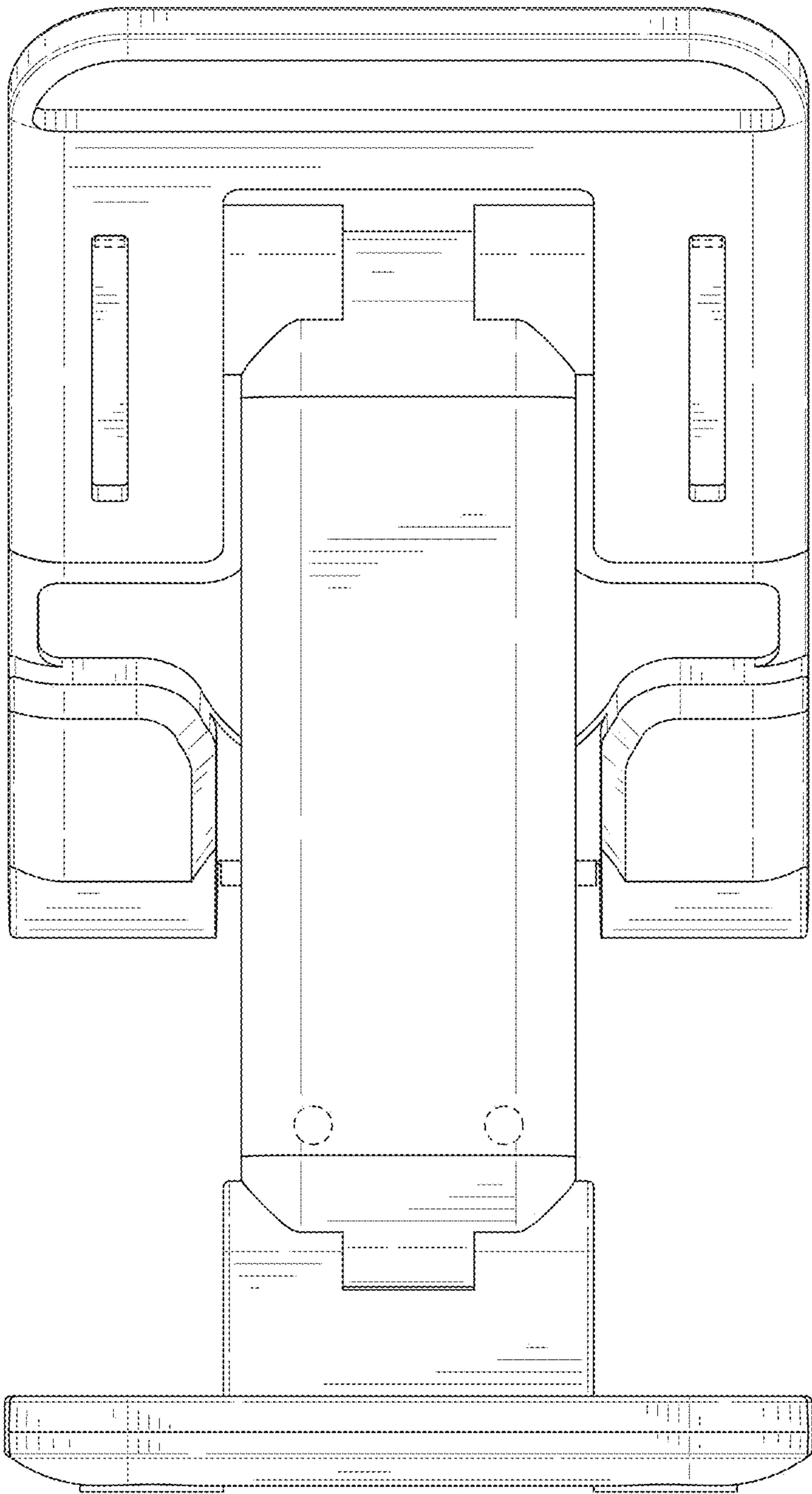

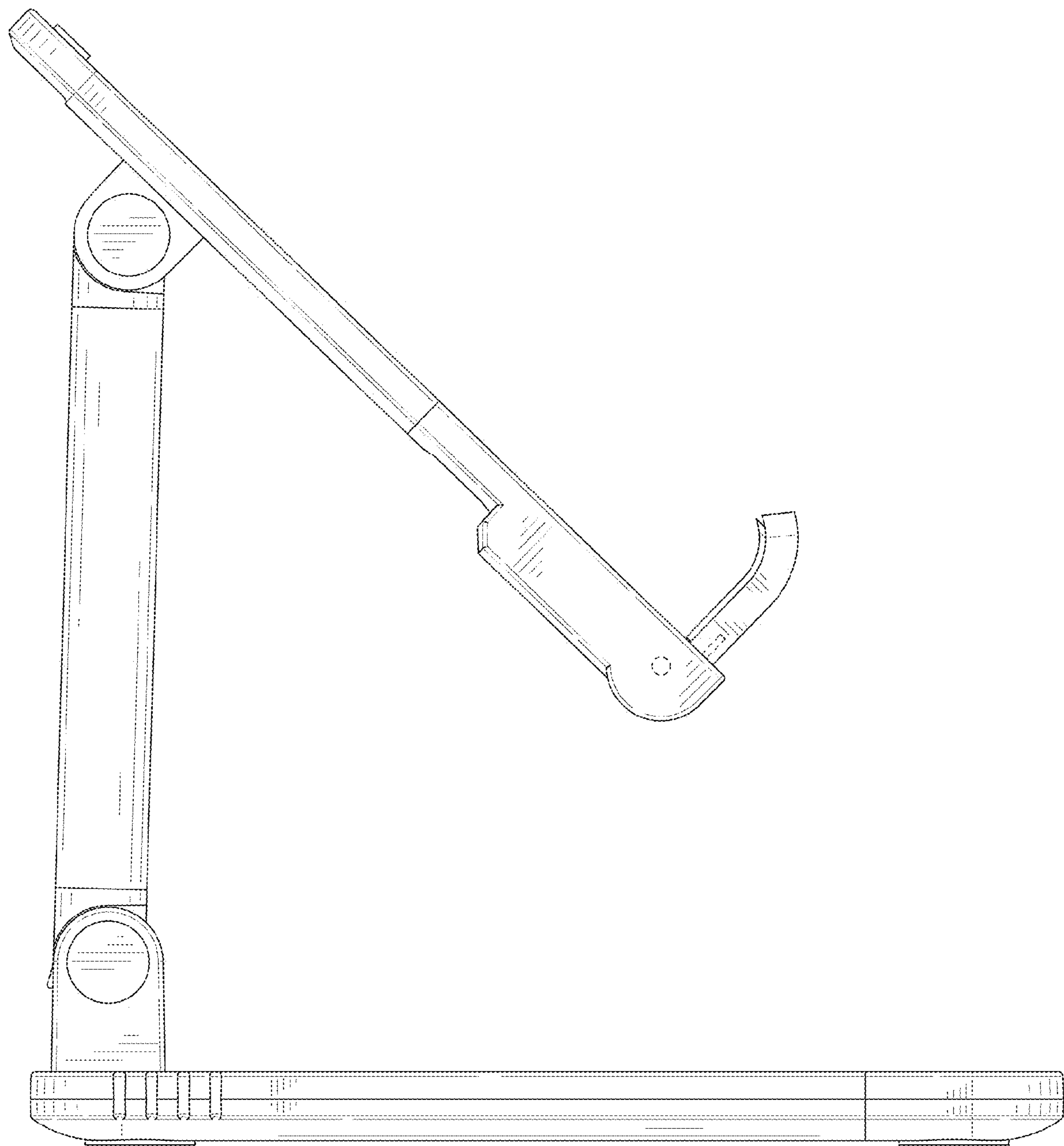

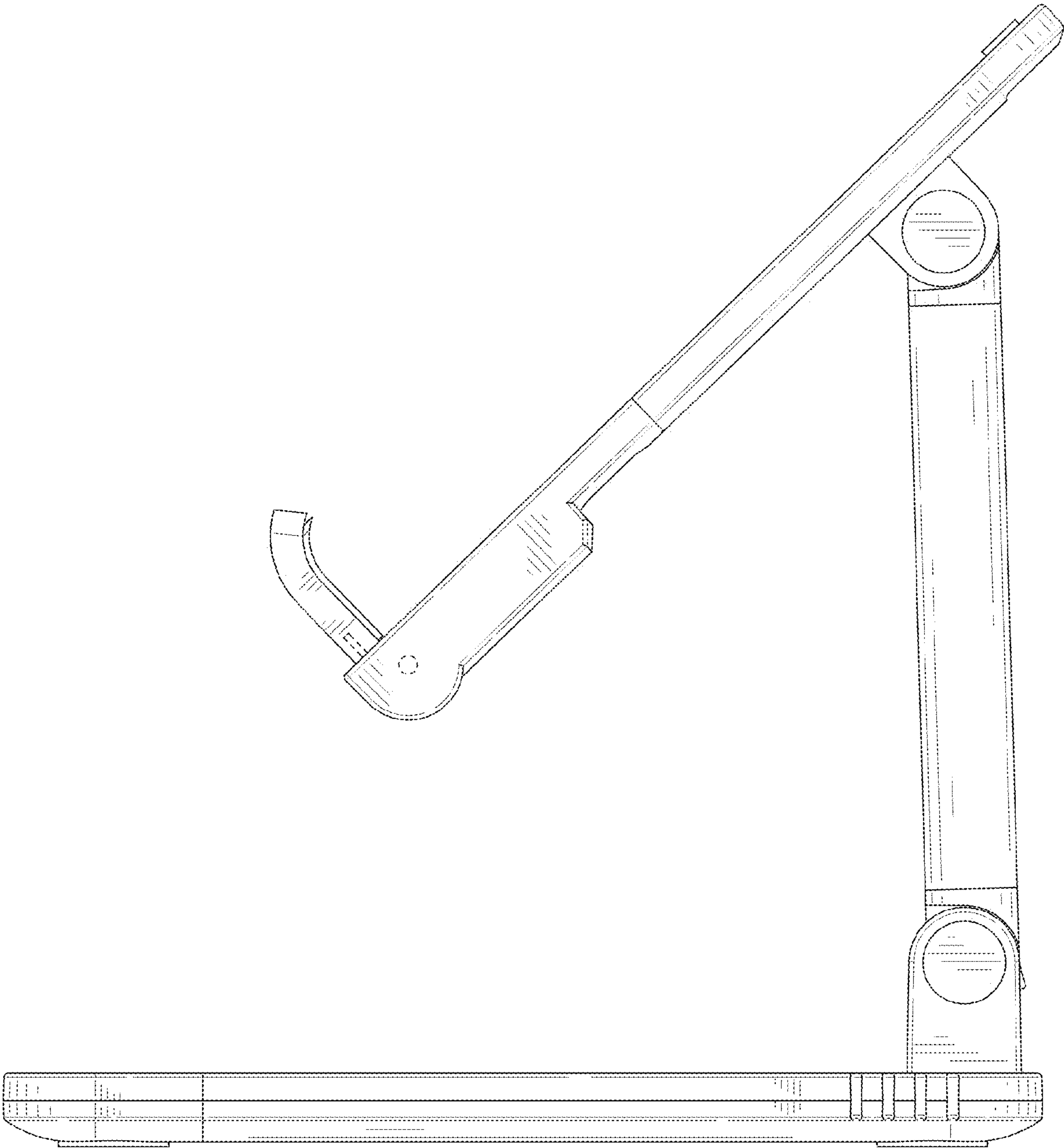

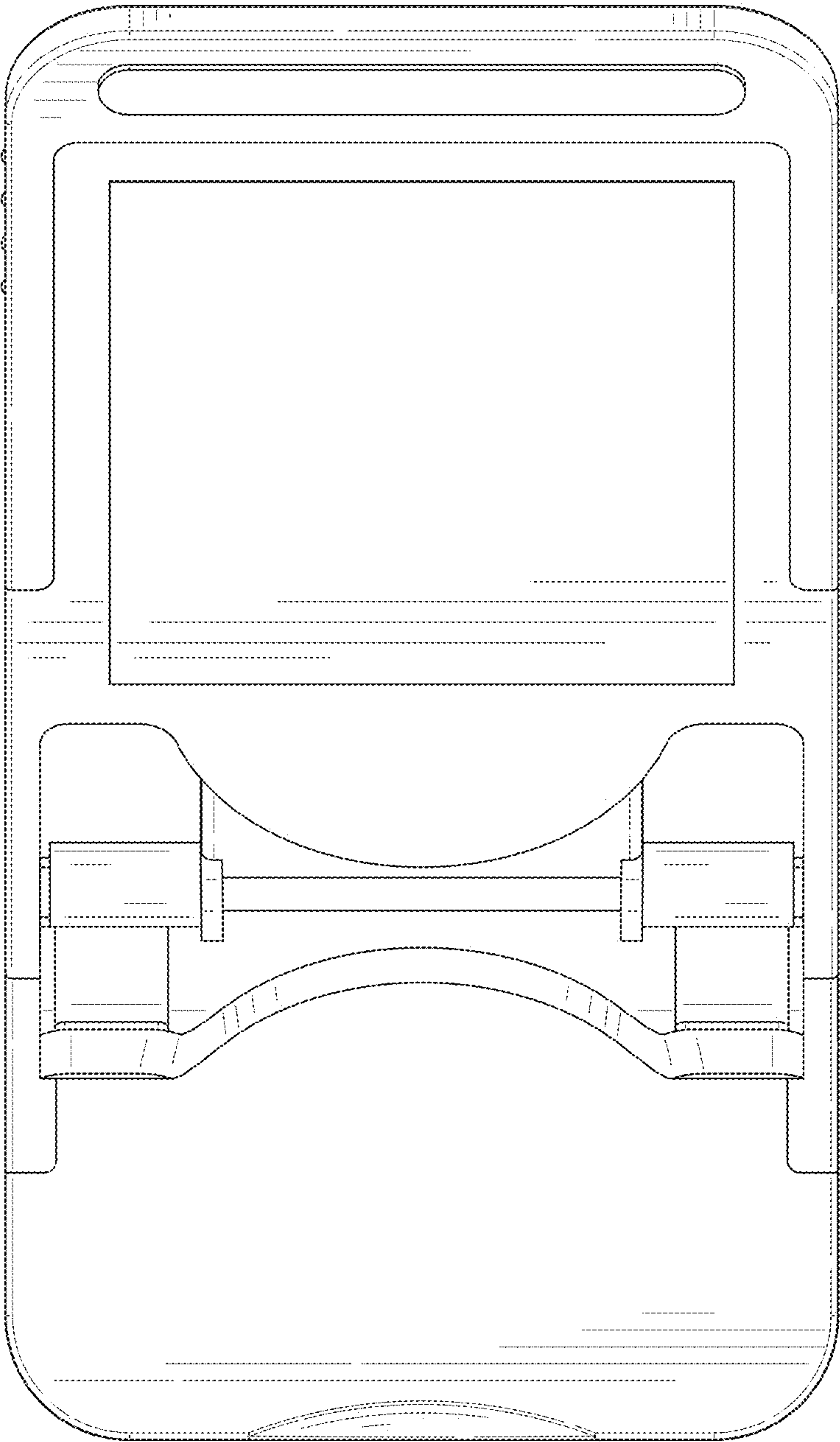

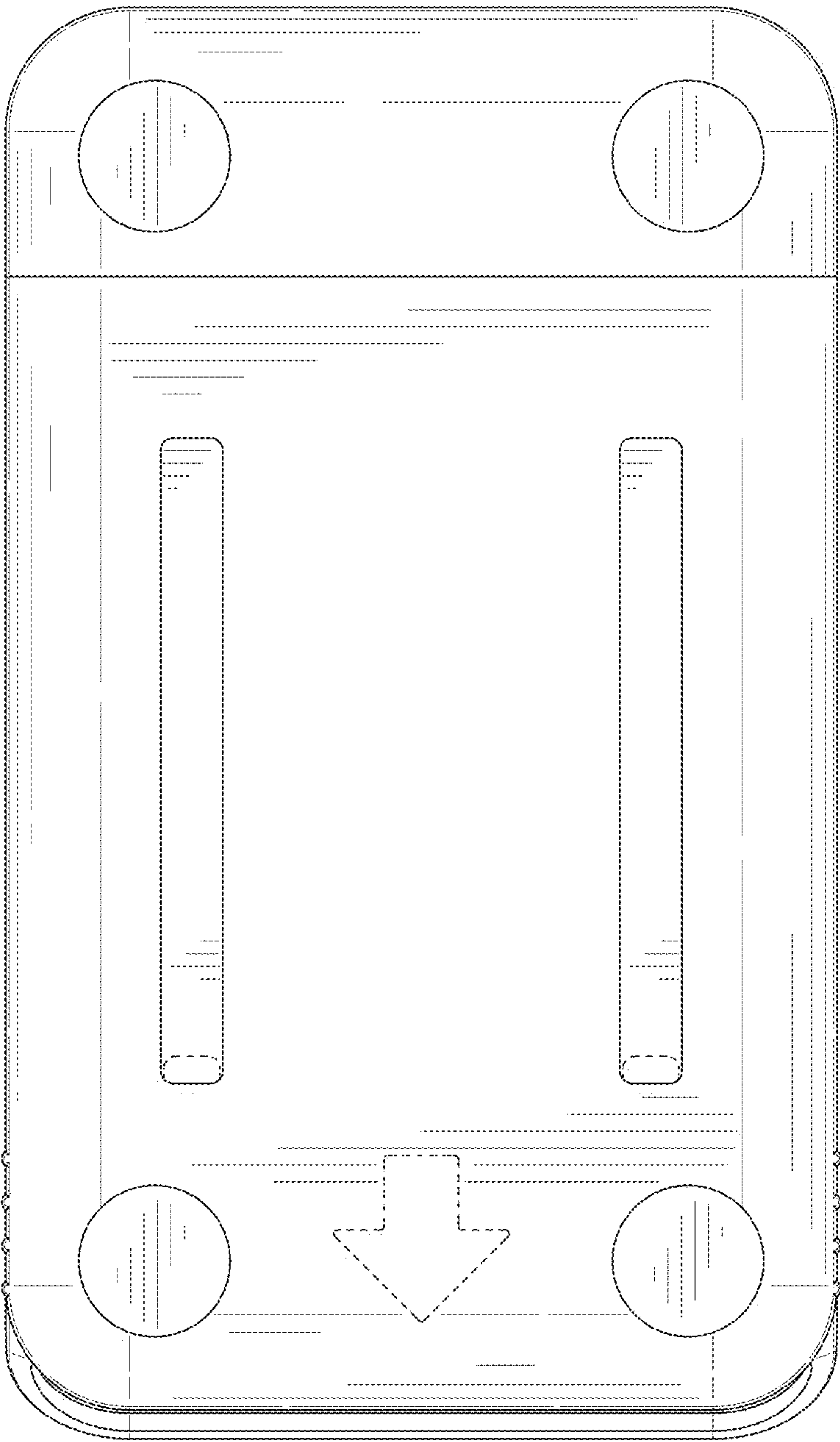

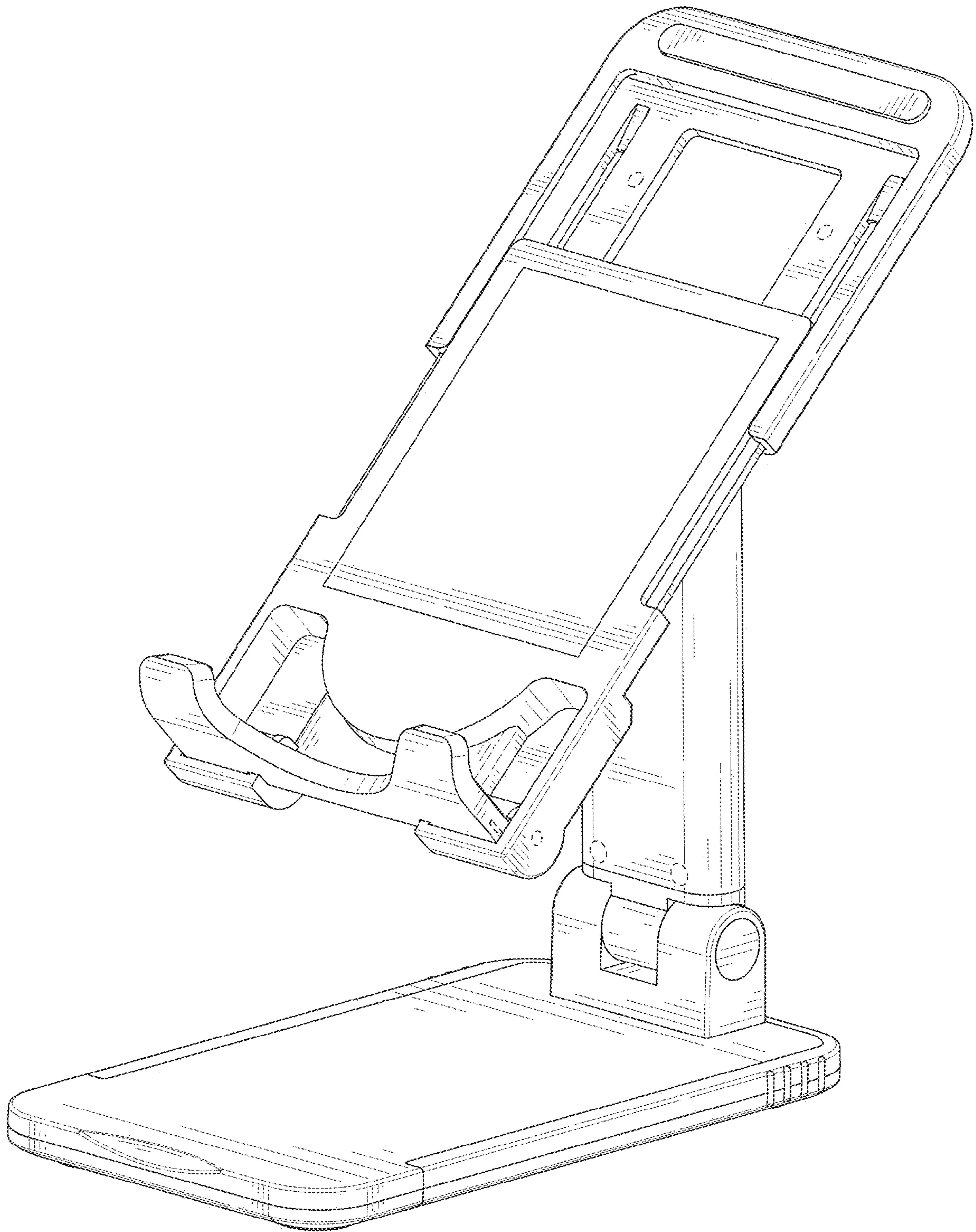

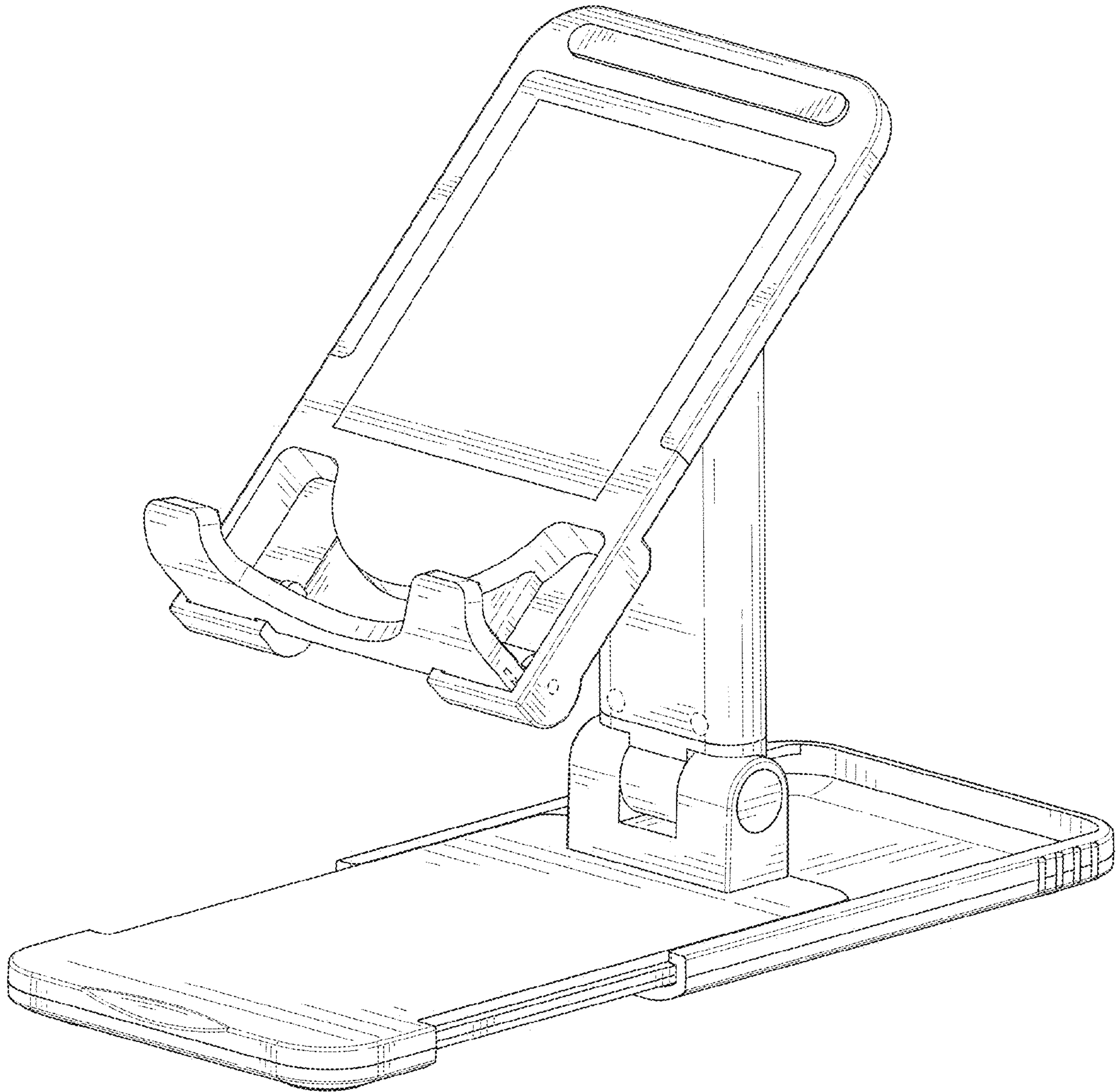

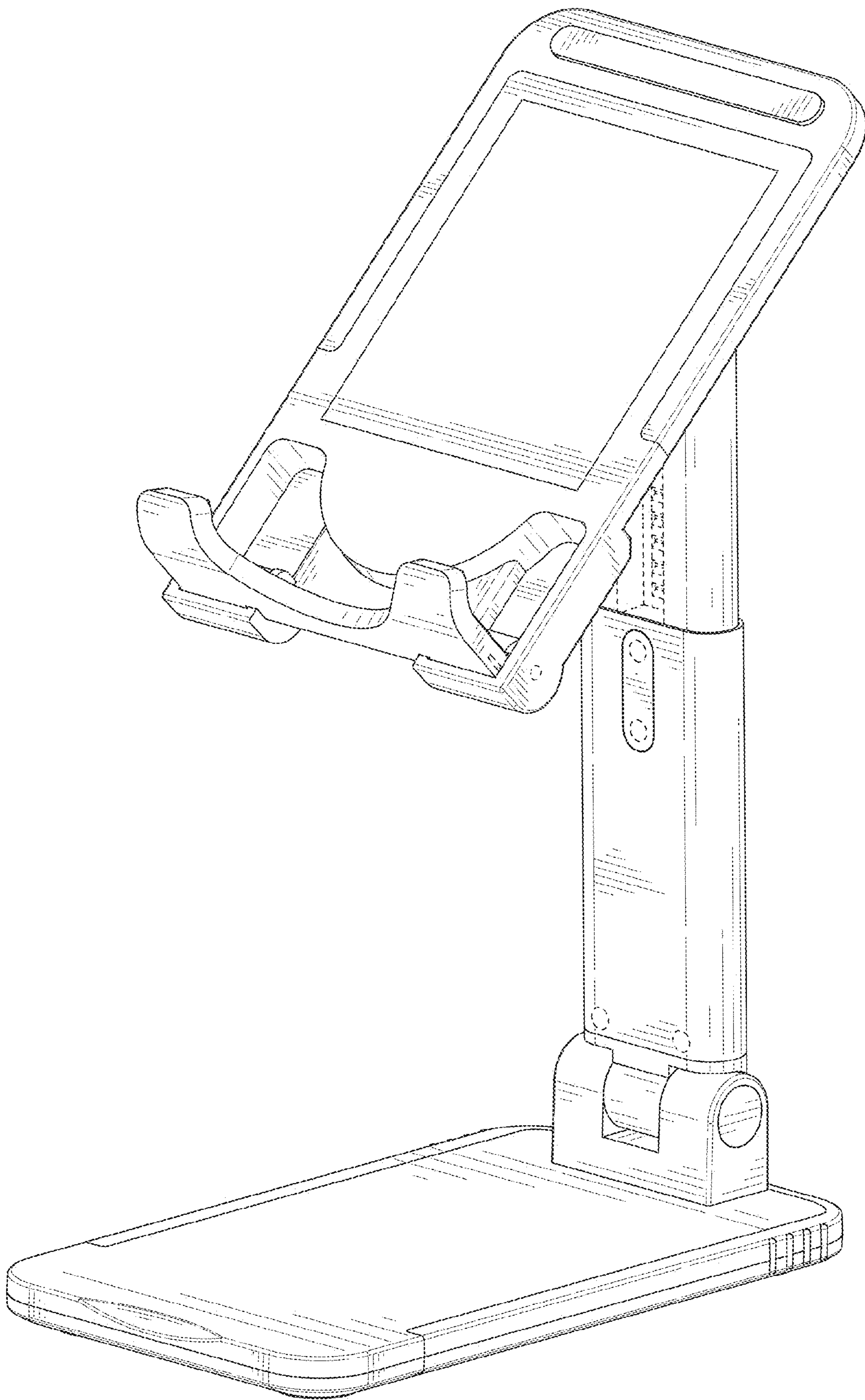

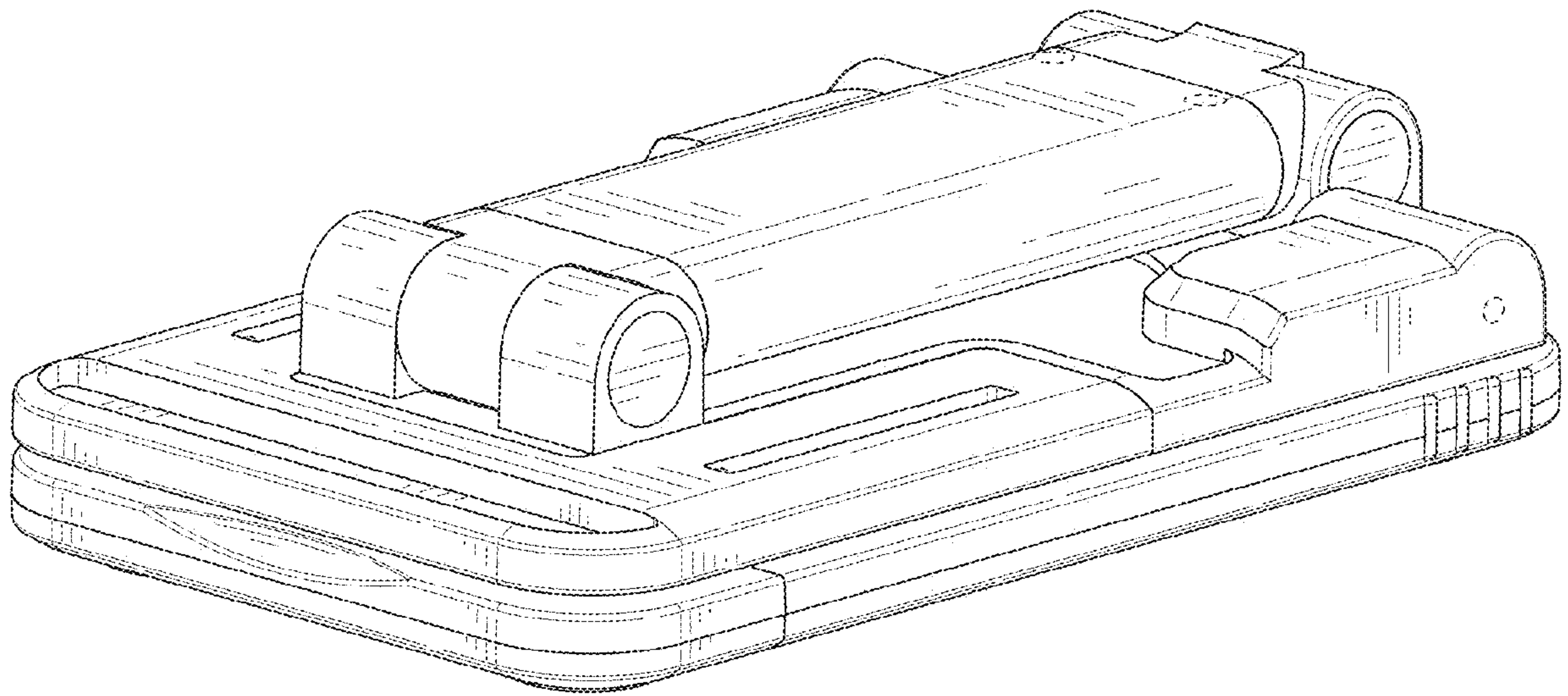
