DESCRIPTION

FIG. 1 is an isometric view of a plush sloth showing my new design;

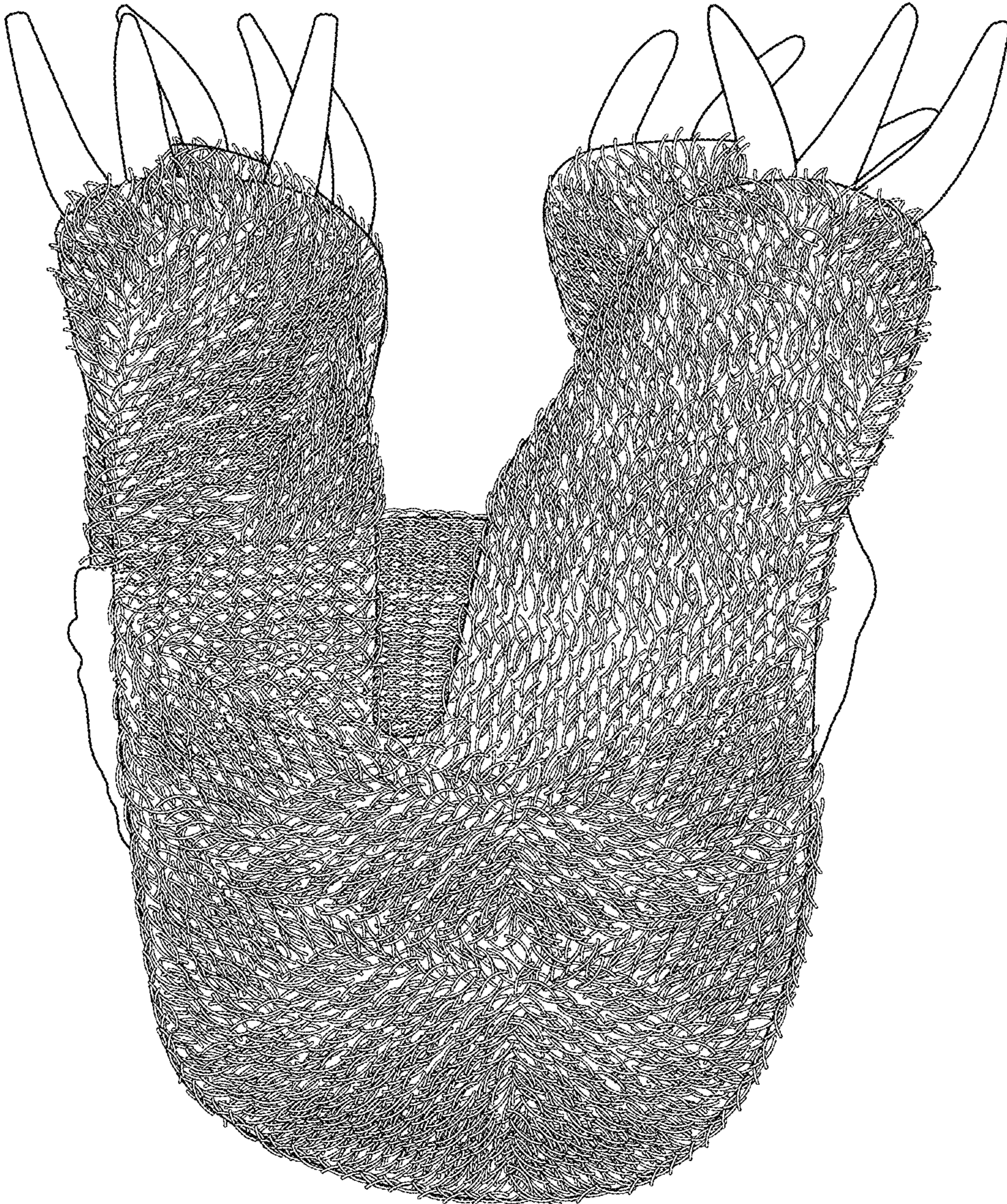
