The ornamental design for an inflatable motorcycle float, as shown and described.

DESCRIPTION

FIG. 4 is a left side elevational view thereof;

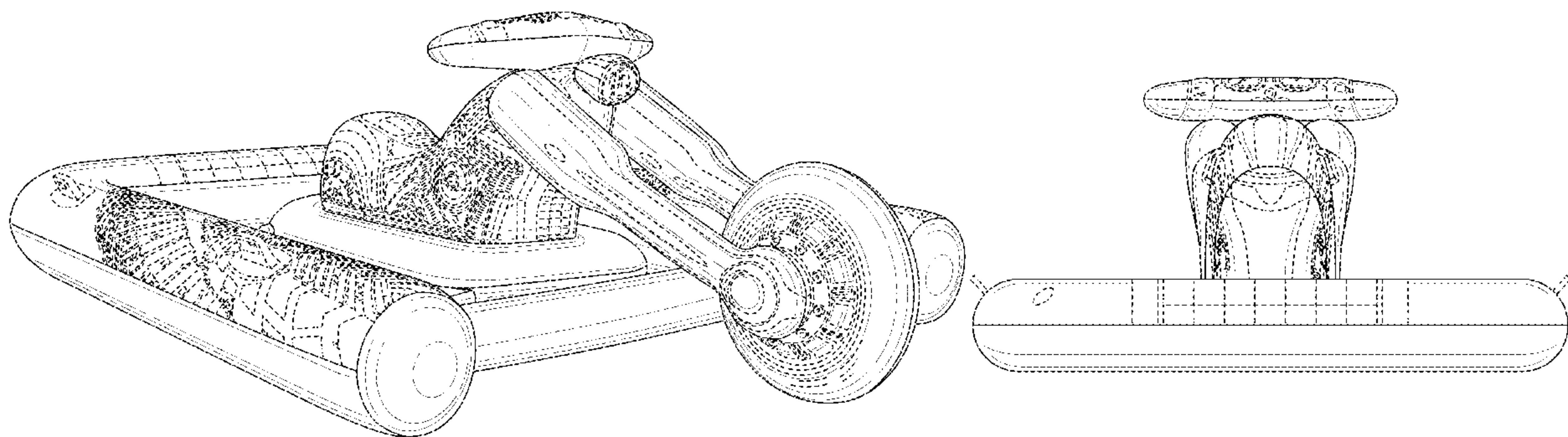
FIG. 5 is a right side elevational view thereof;

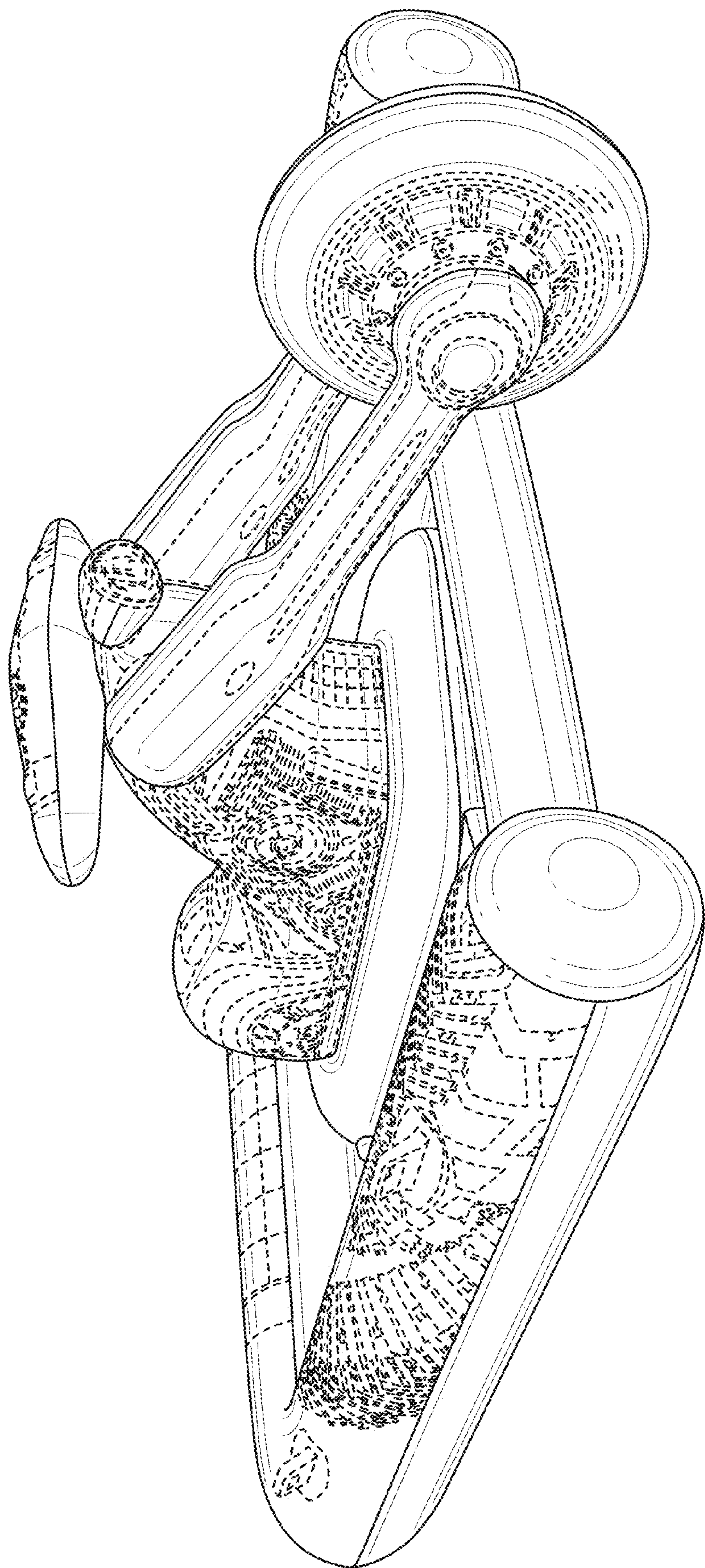

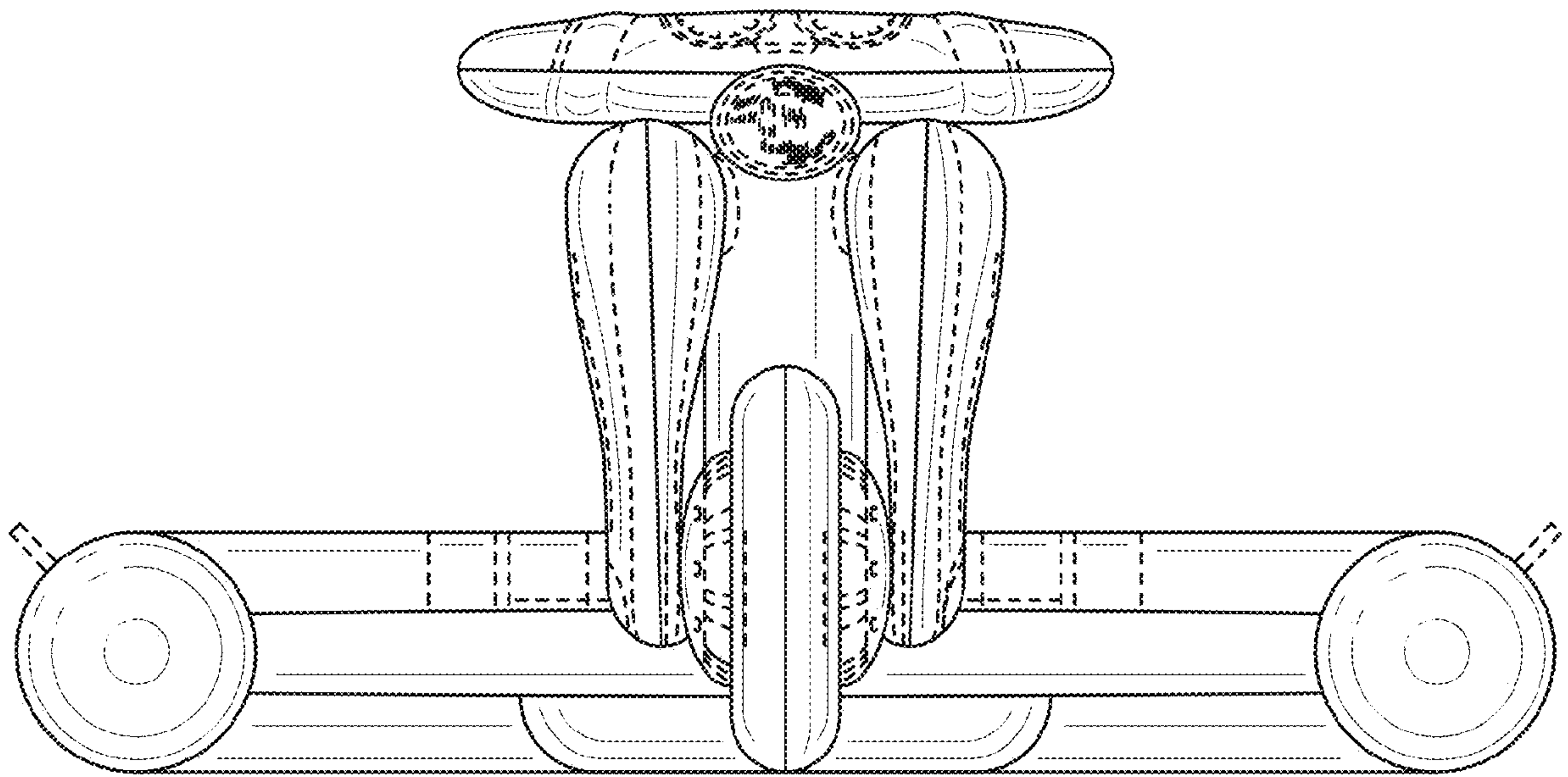

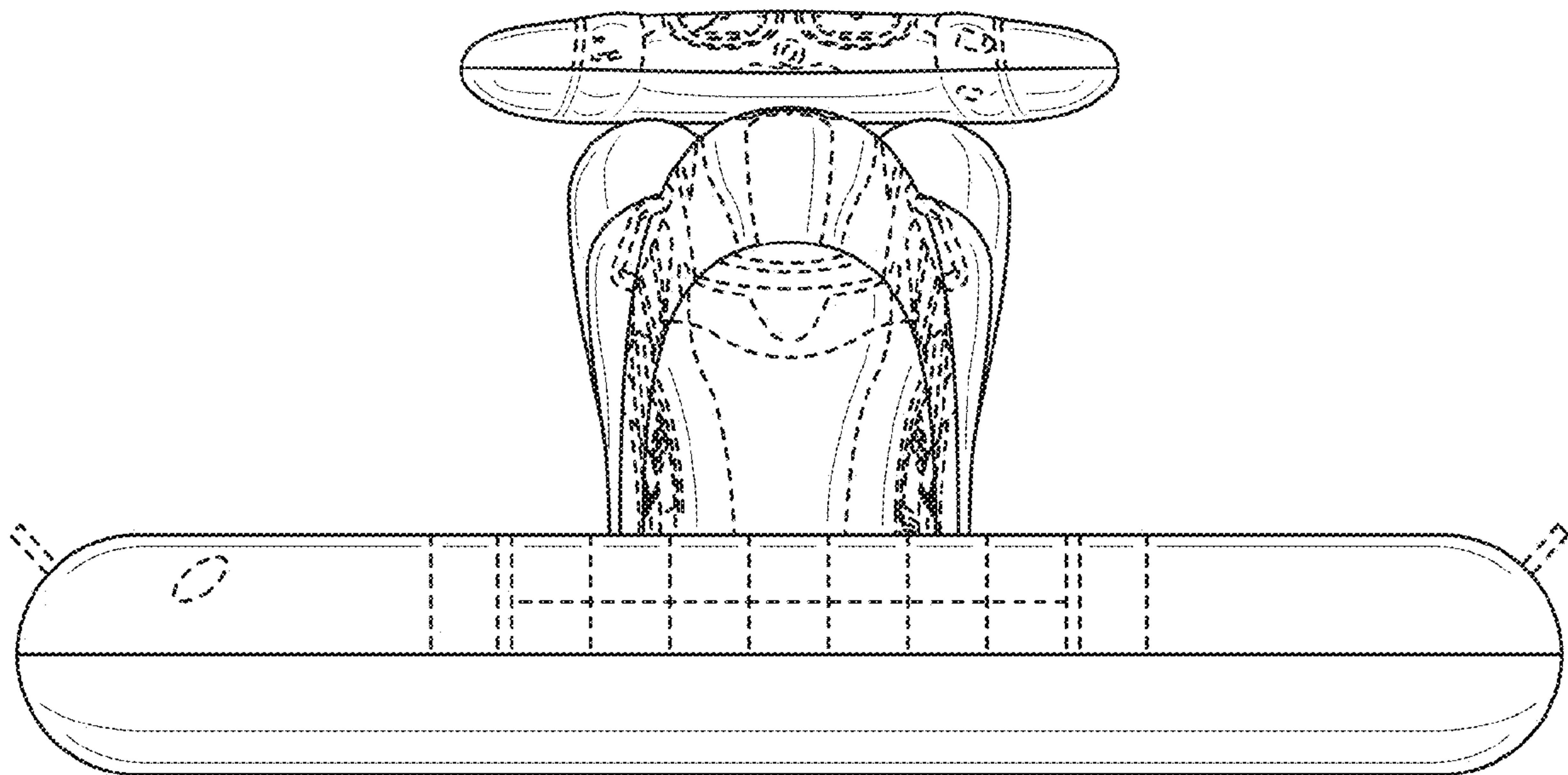

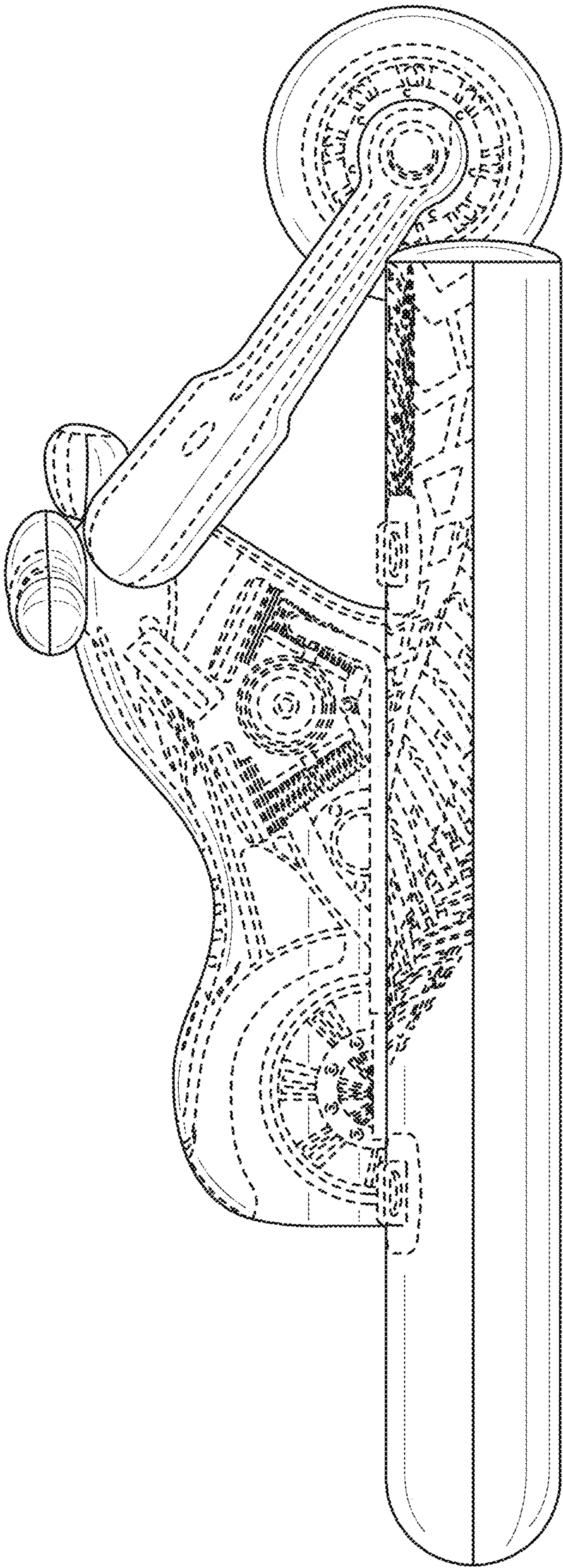

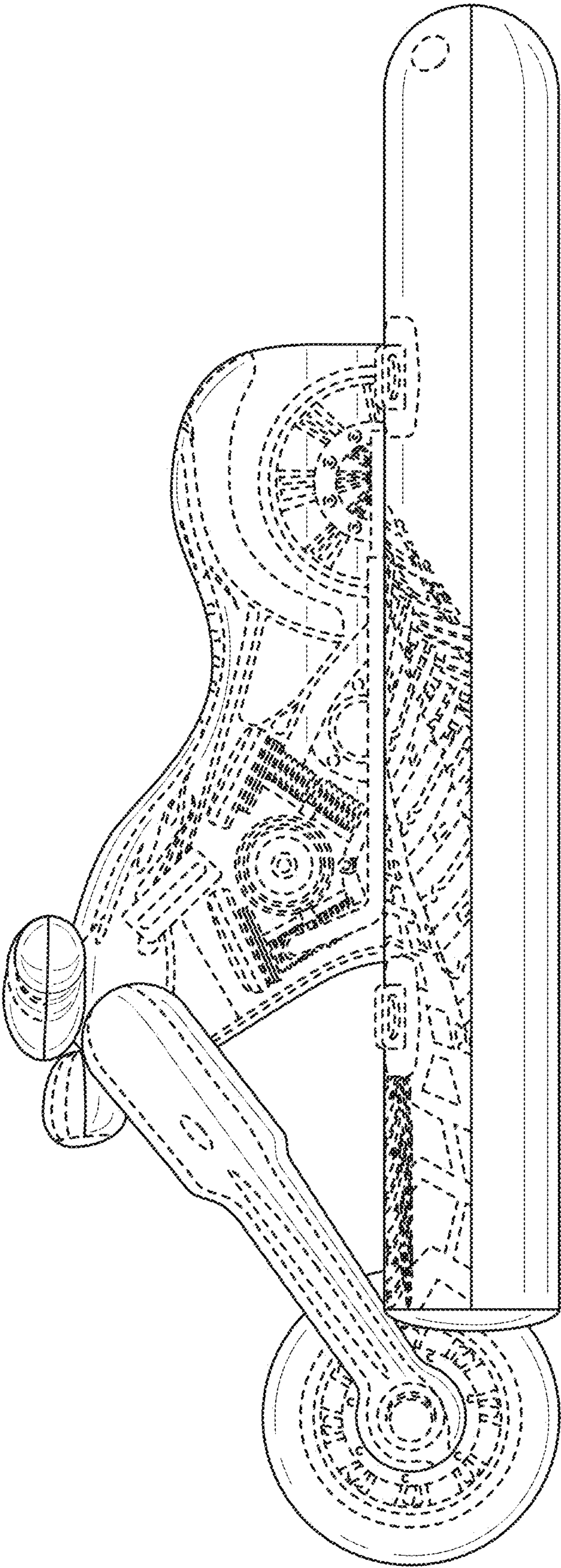

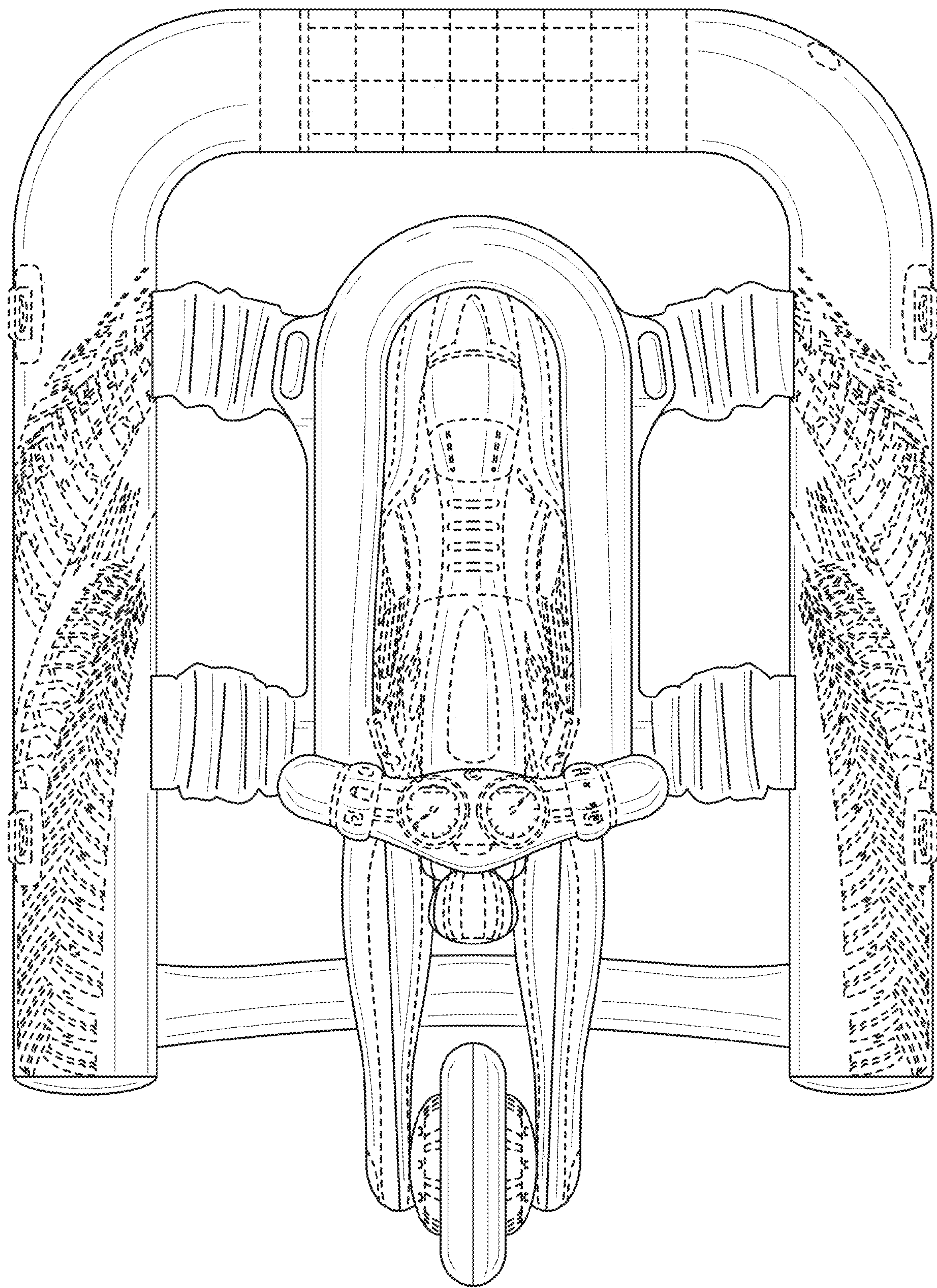

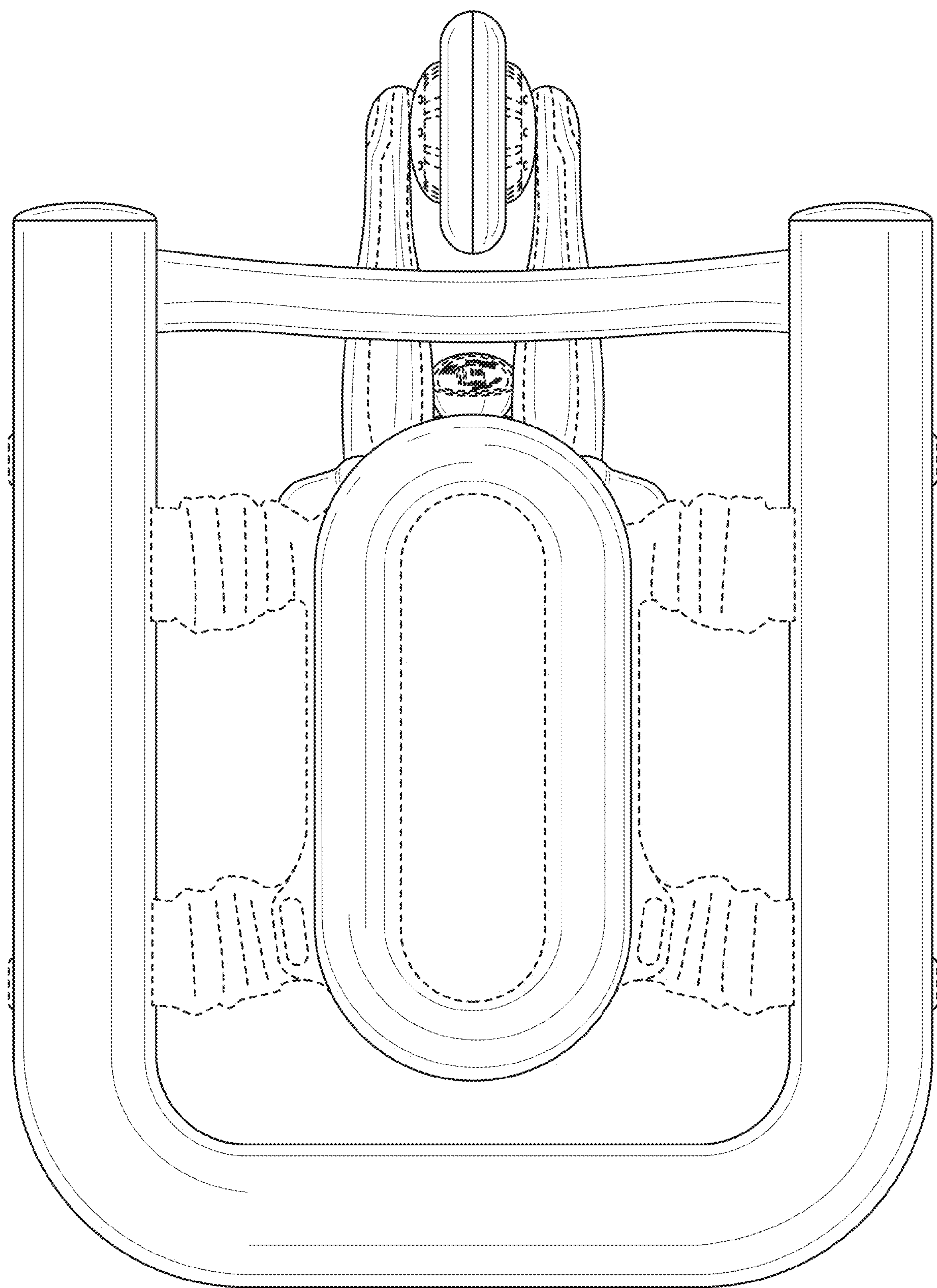
