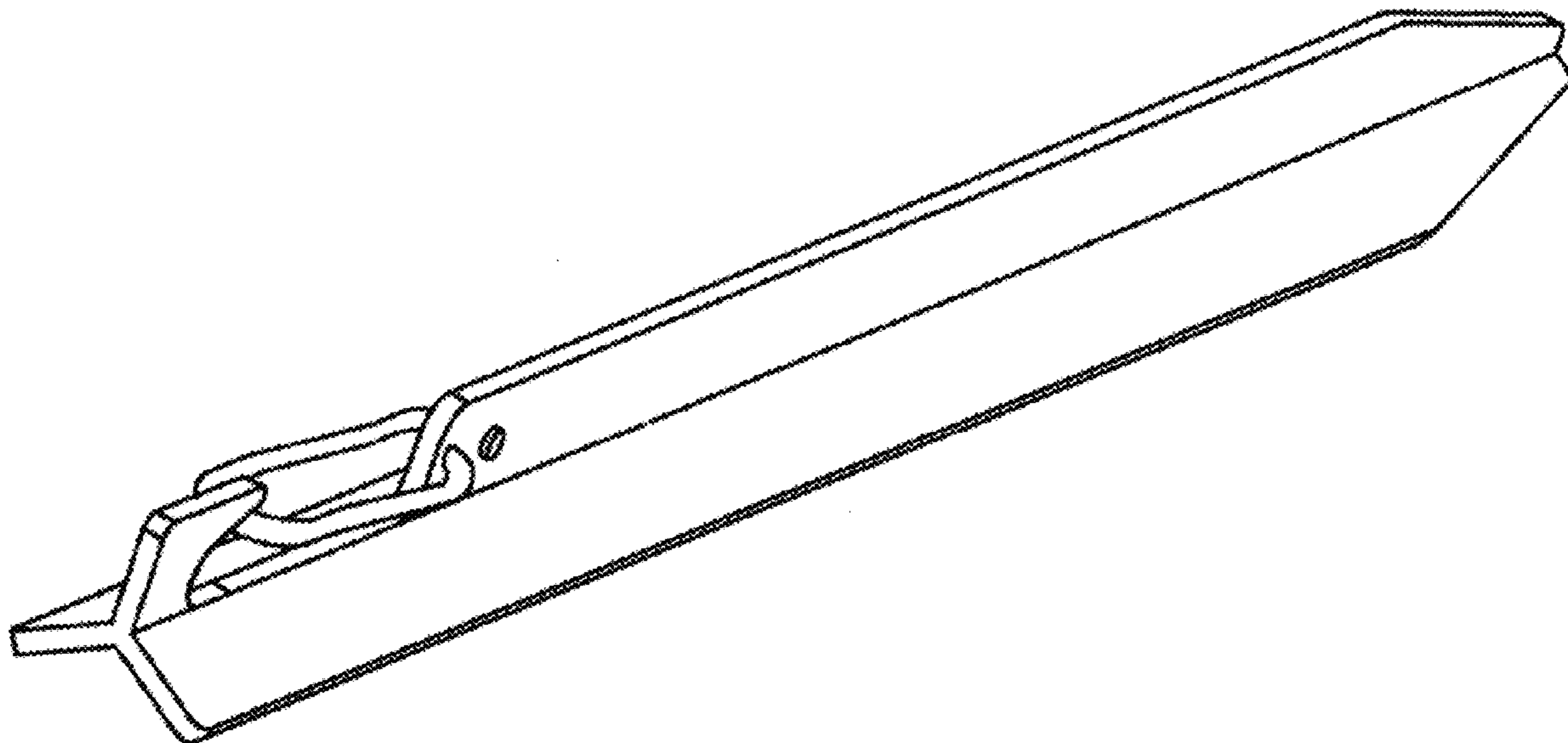
(57) **CLAIM**

The ornamental design for a gated three flange tent stake, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a gated three flange tent stake showing my new design;
FIG. 2 is a back view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a right side view thereof; and,
FIG. 5 is a top view thereof;
FIG. 6 is a front view thereof;
FIG. 7 is a left side view thereof; and,
FIG. 8 is a right side view showing the gate in an open position.

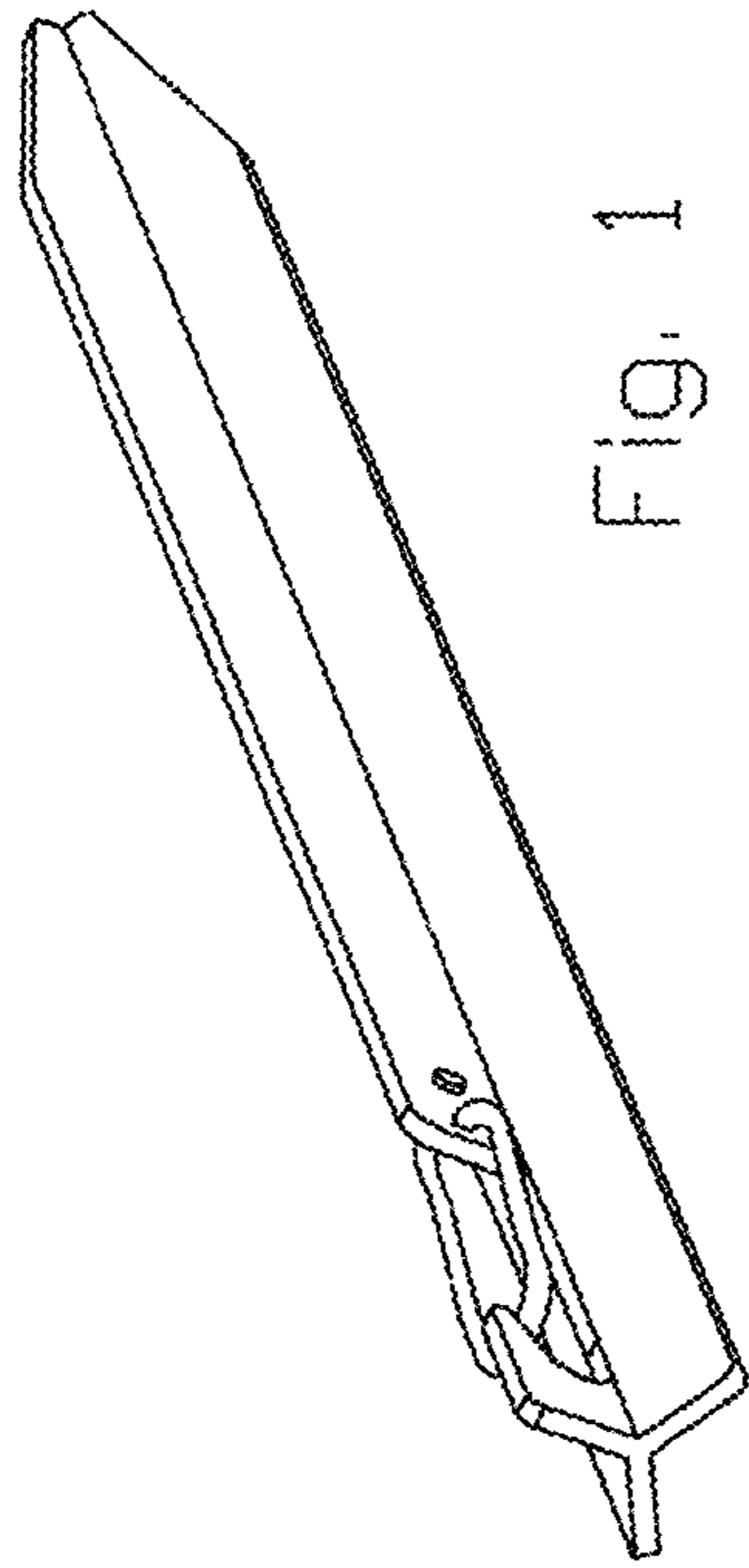

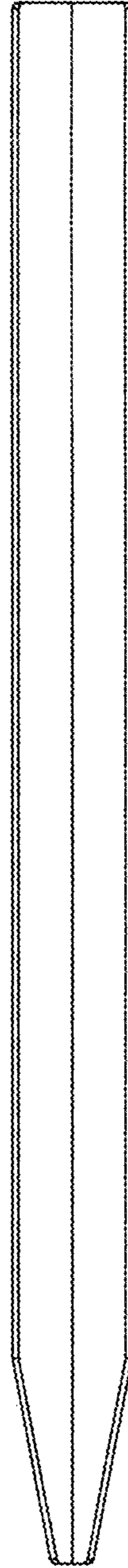

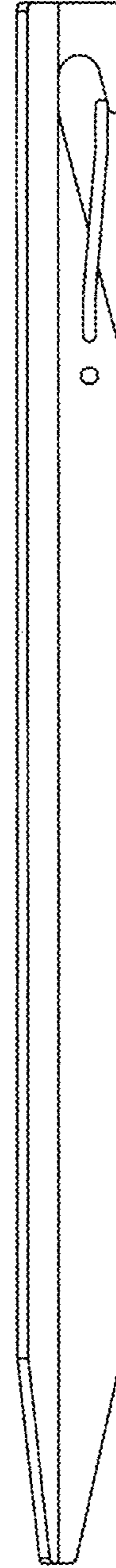

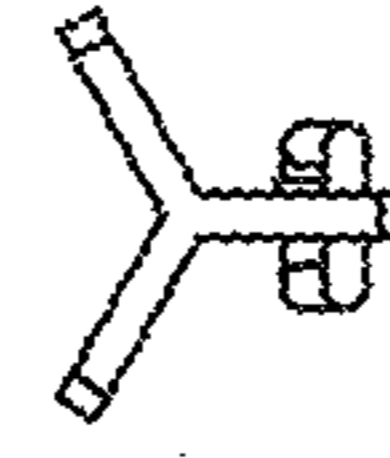

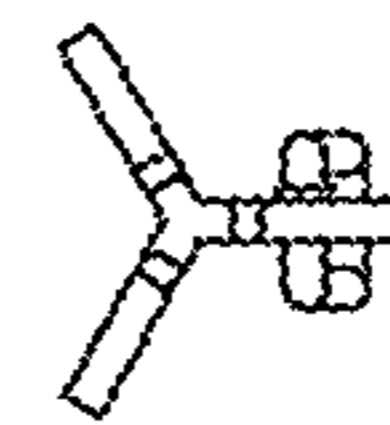
