(57) **CLAIM**

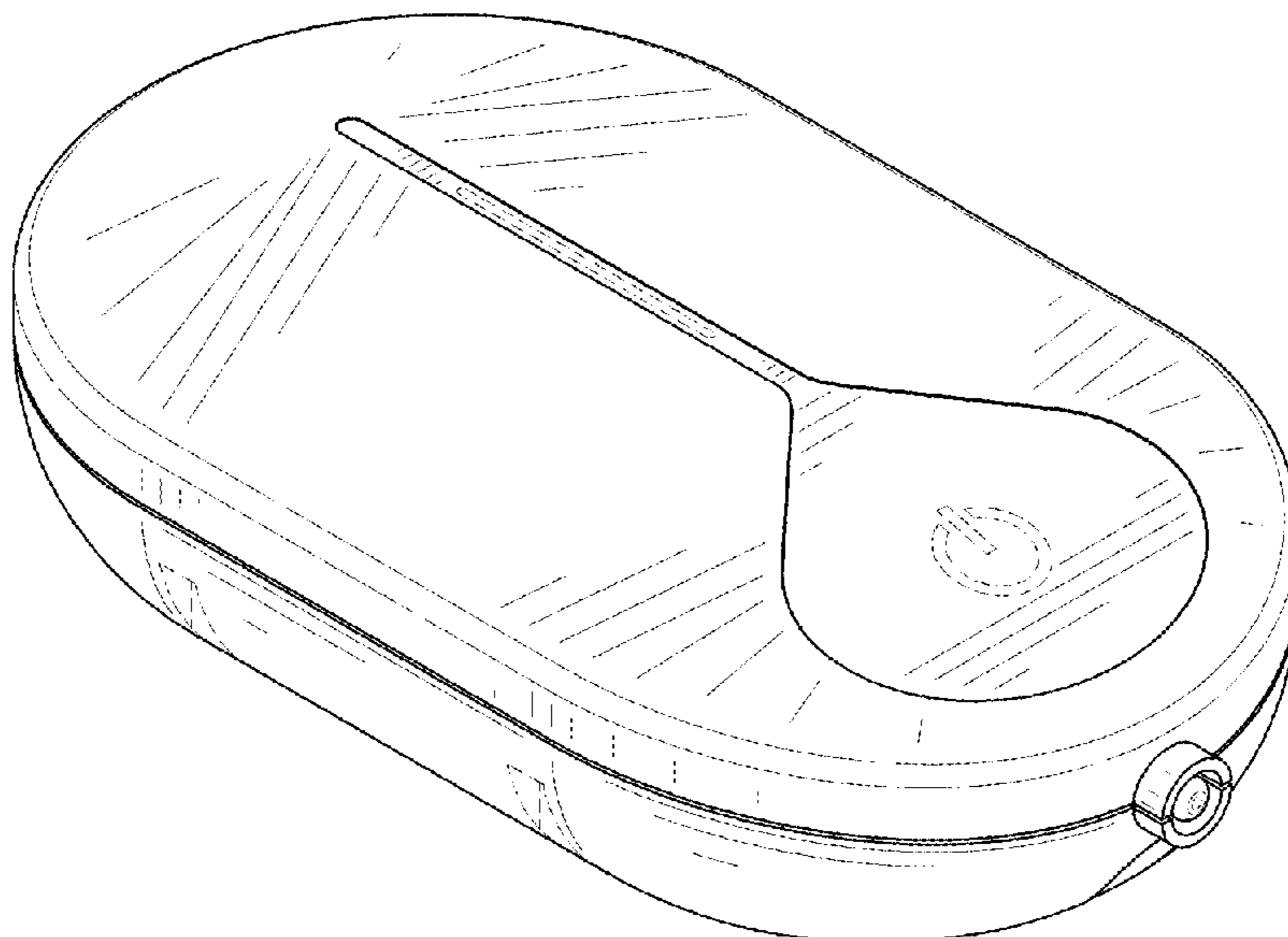
The ornamental design for a oxygen pump, as shown and described.

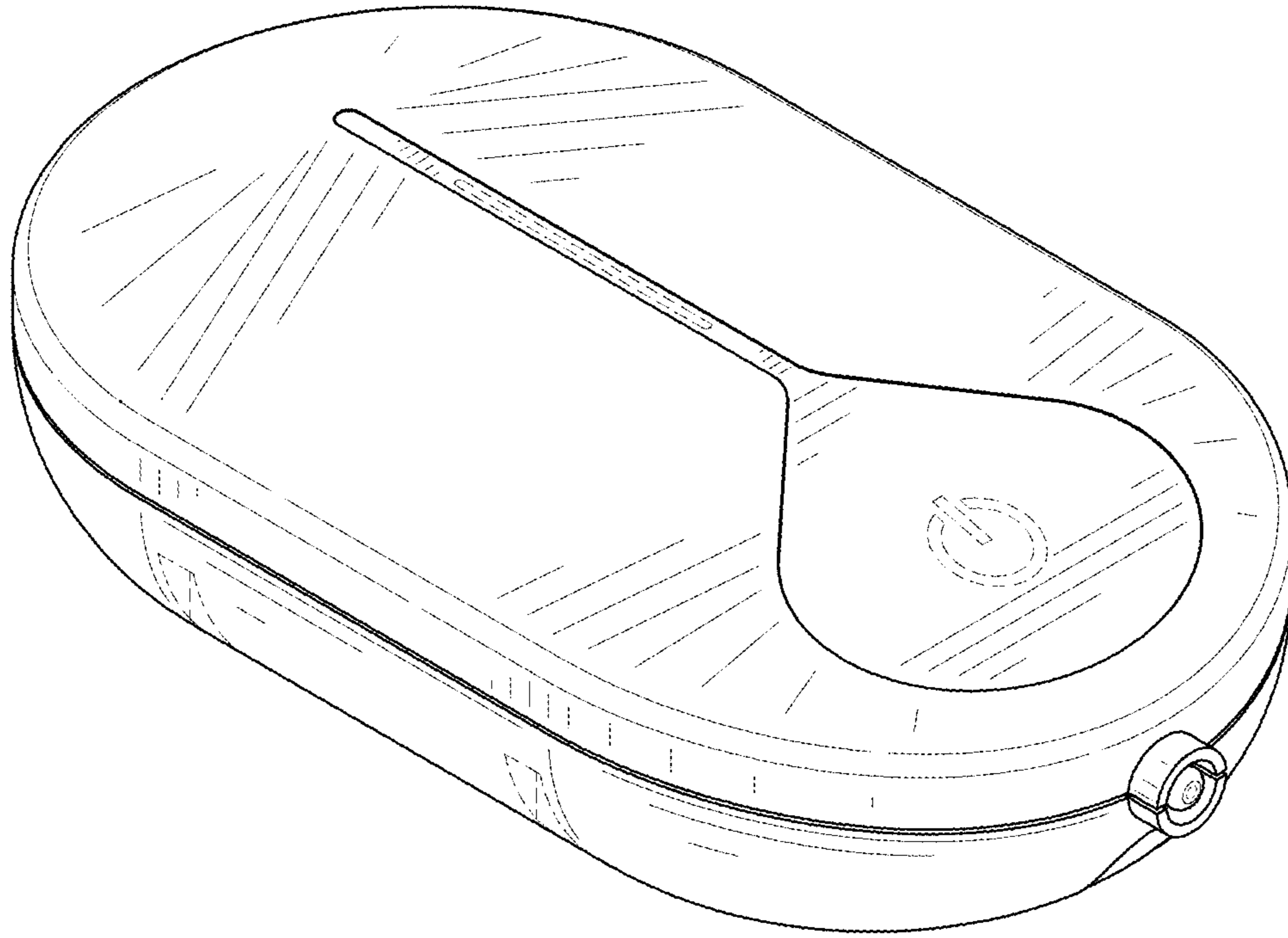

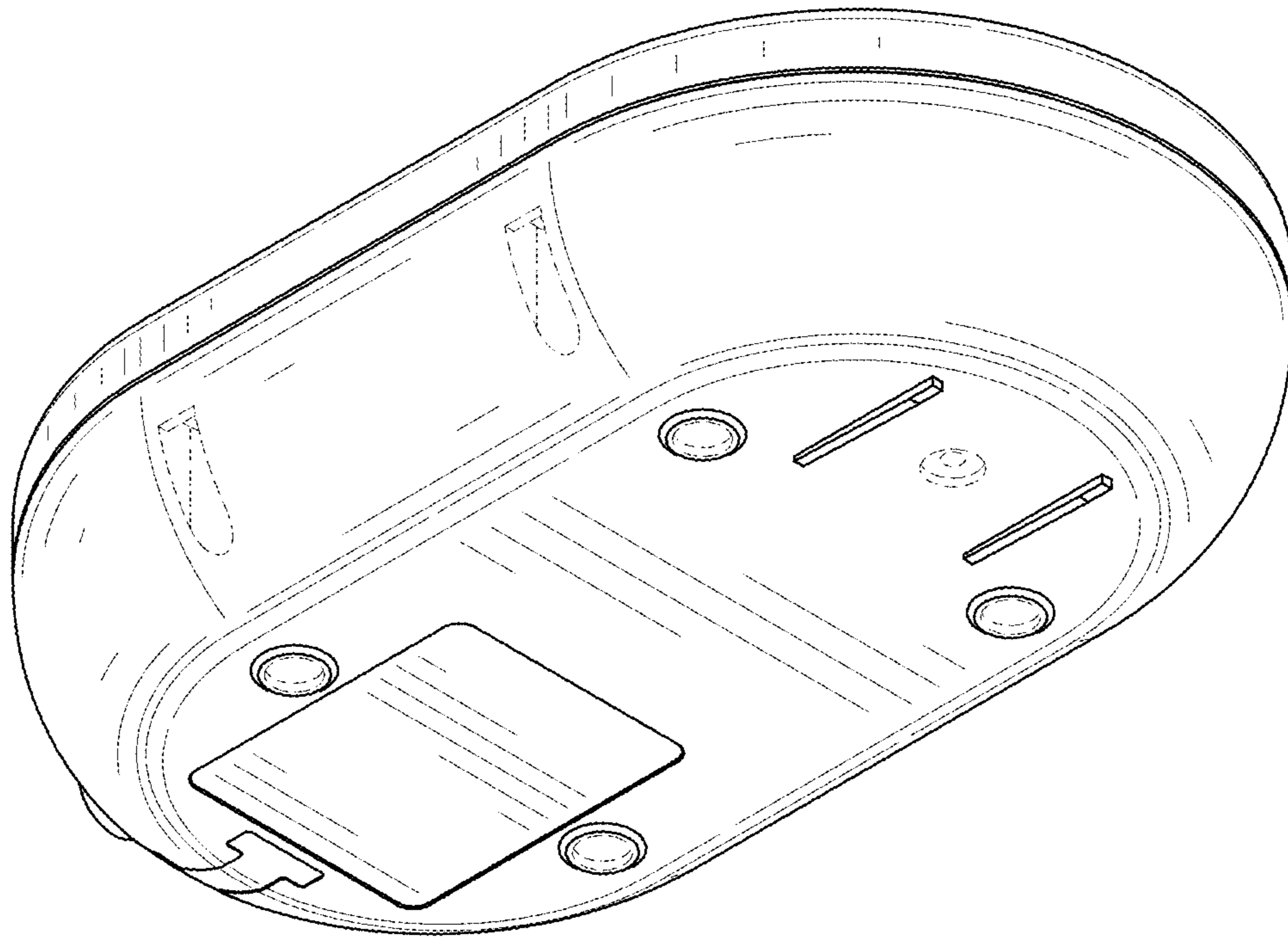

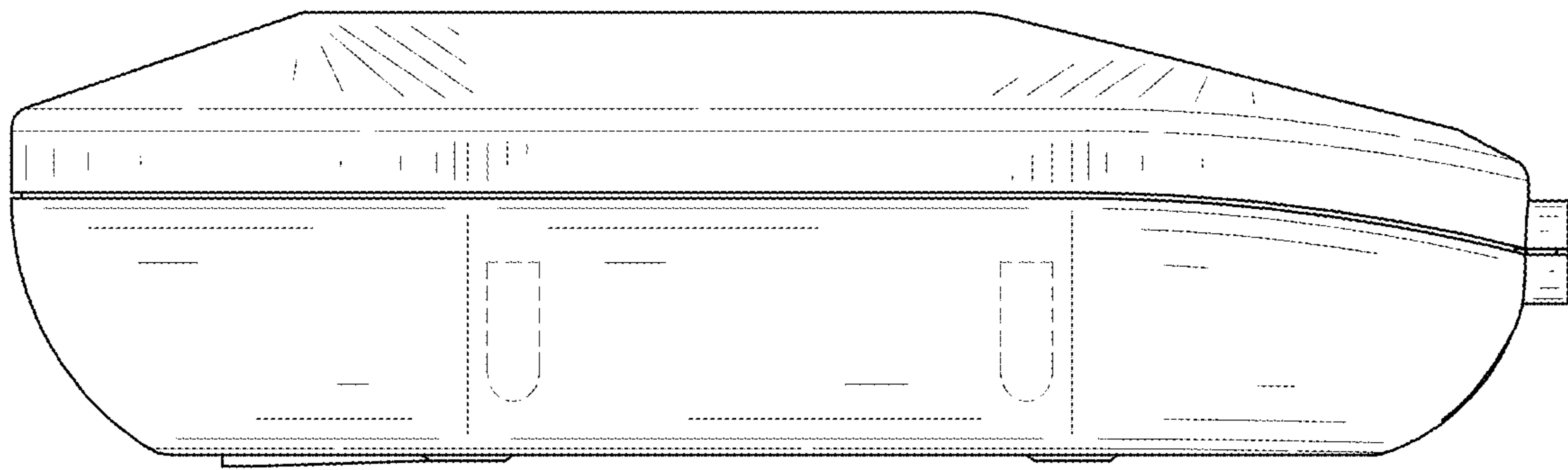

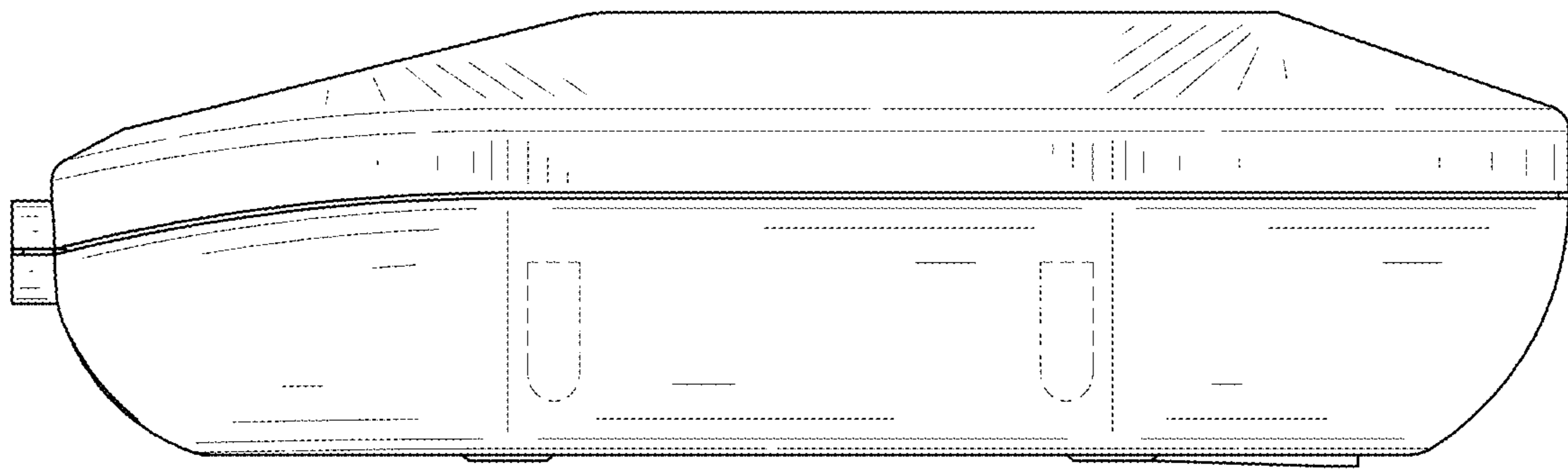

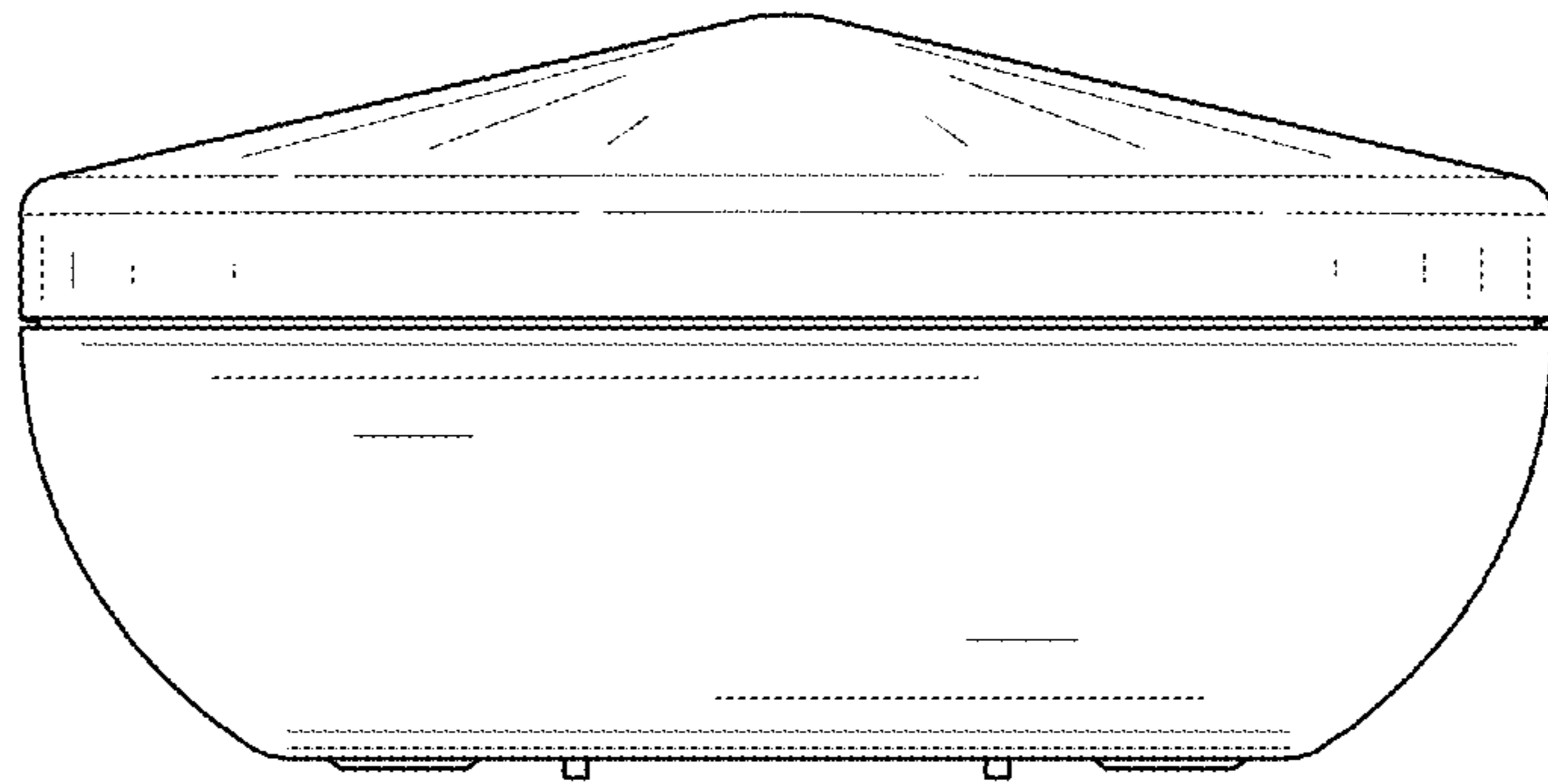

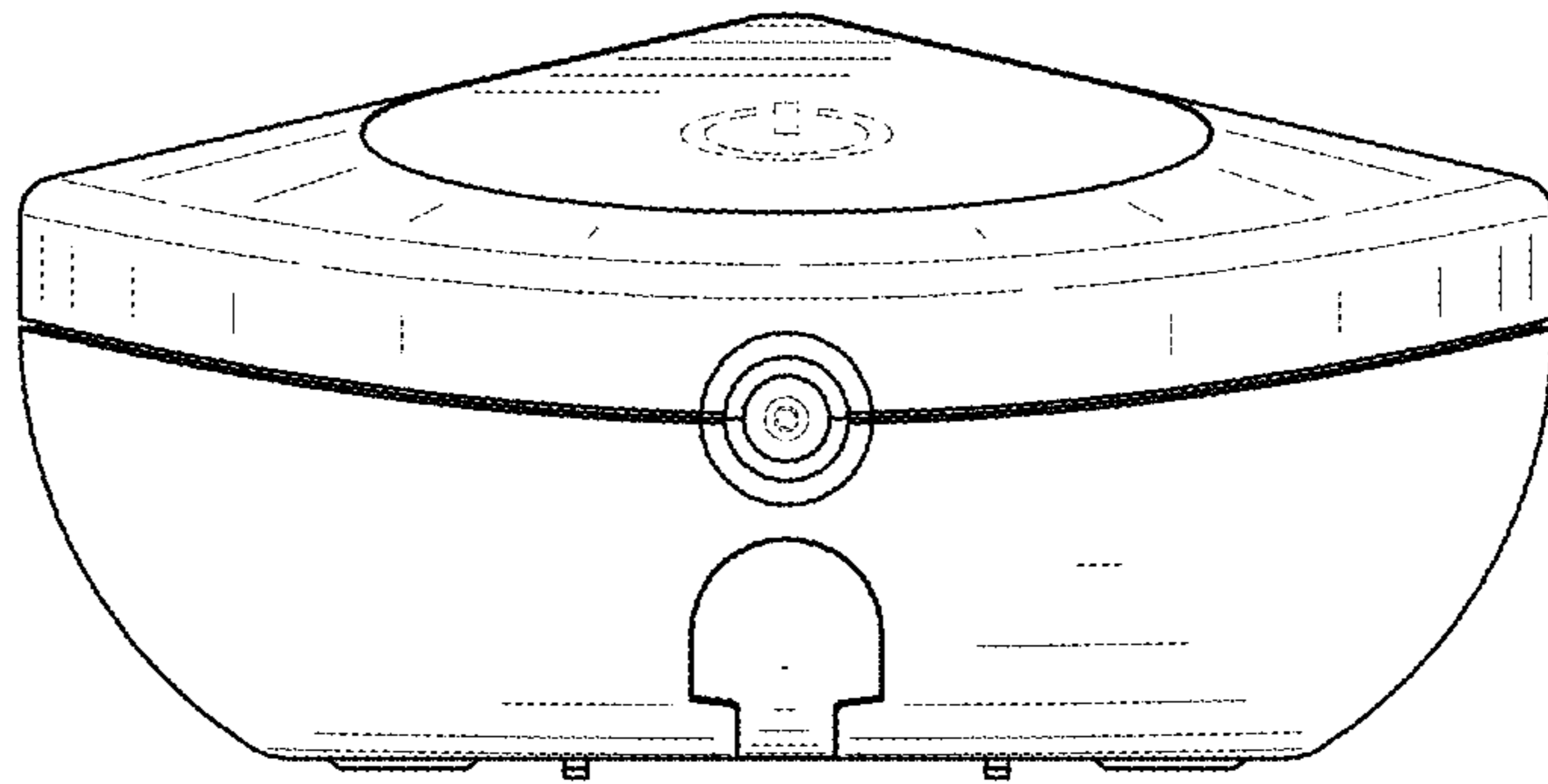

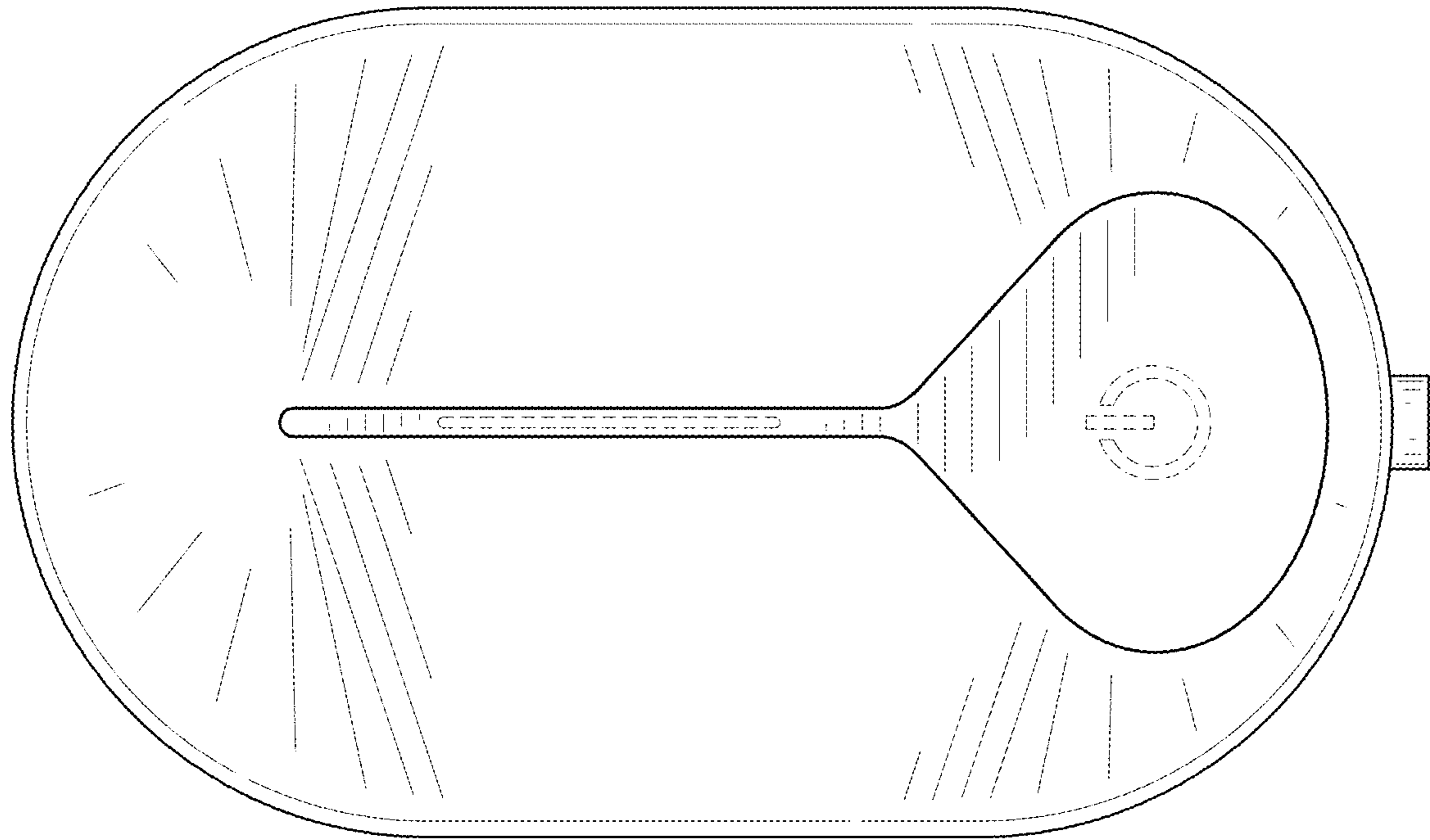

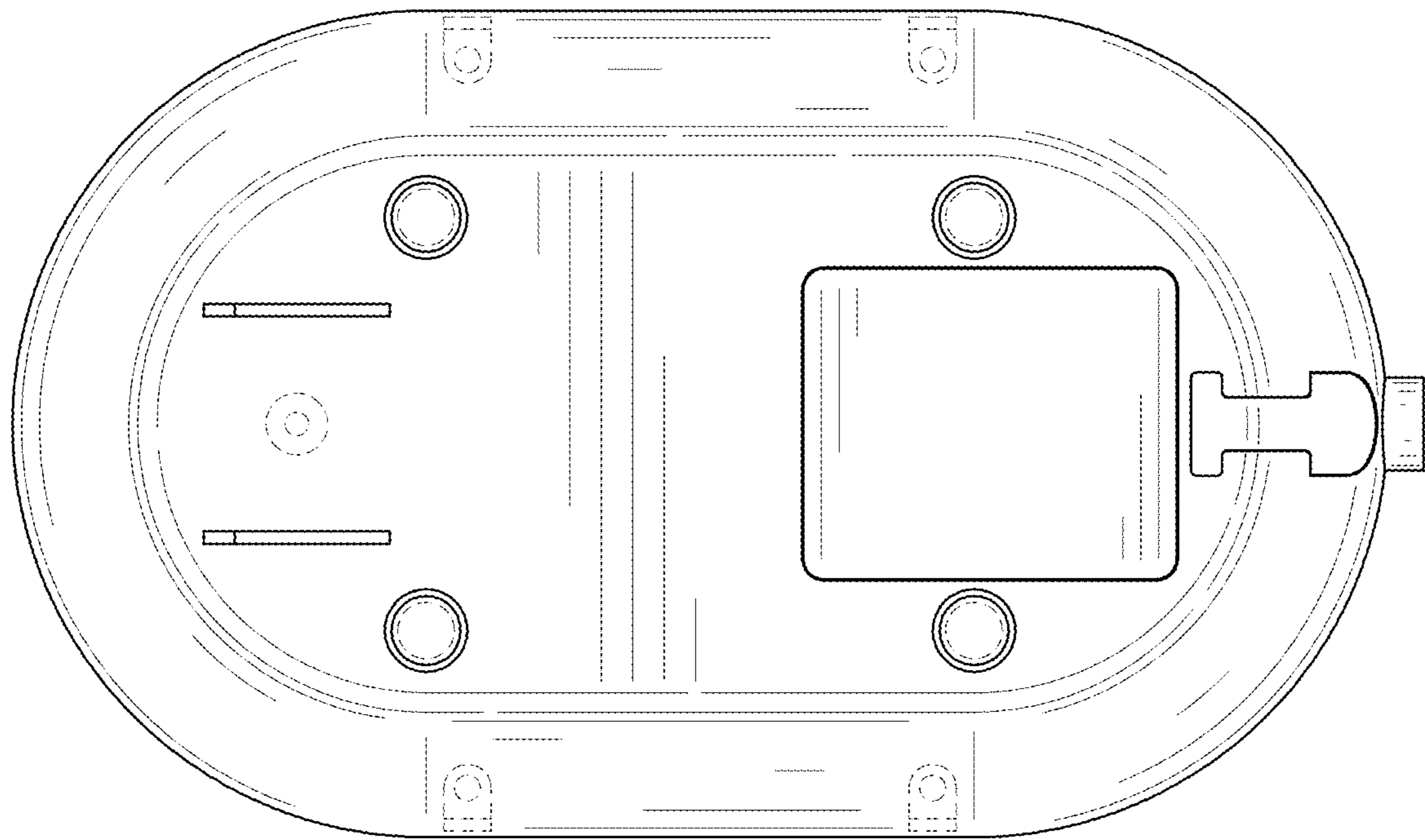
