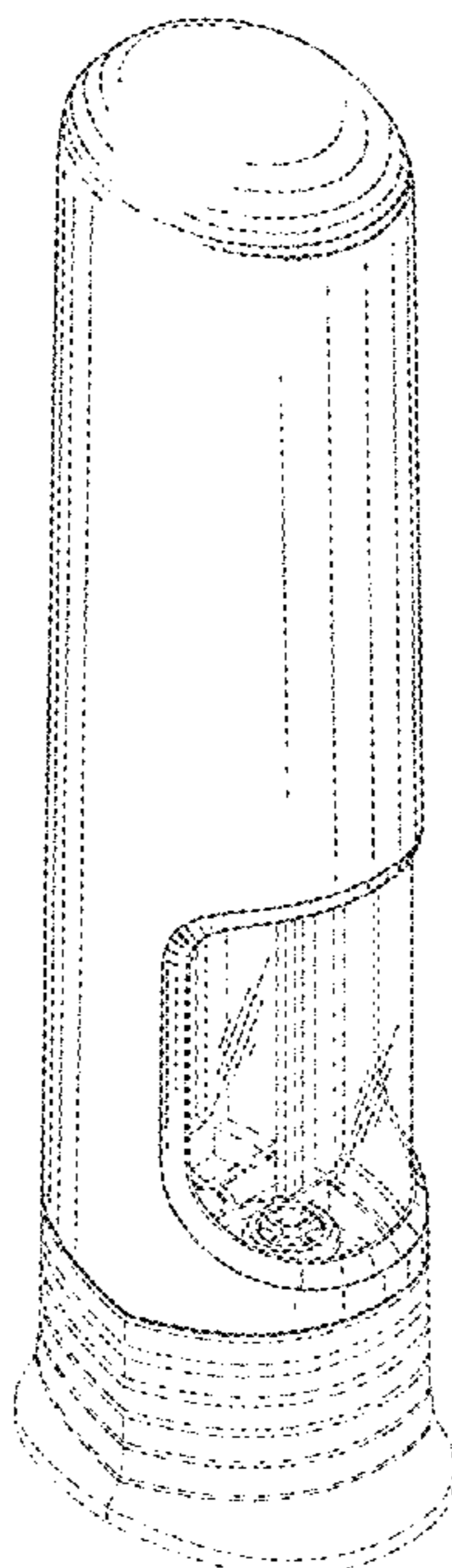
FIG. 1 is a perspective view of an injector housing, showing our new design;

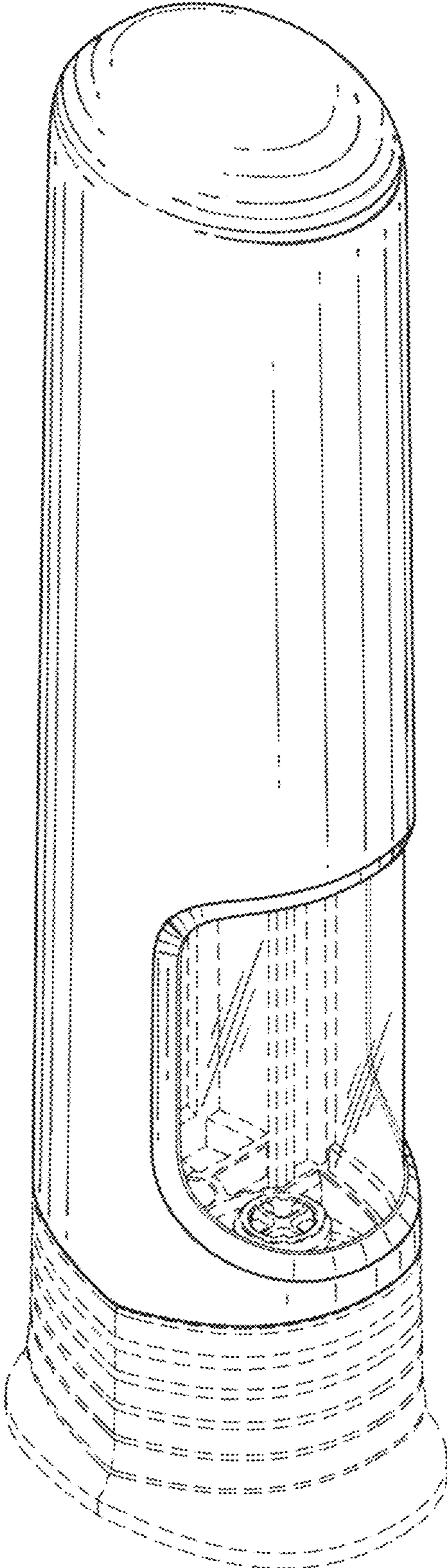

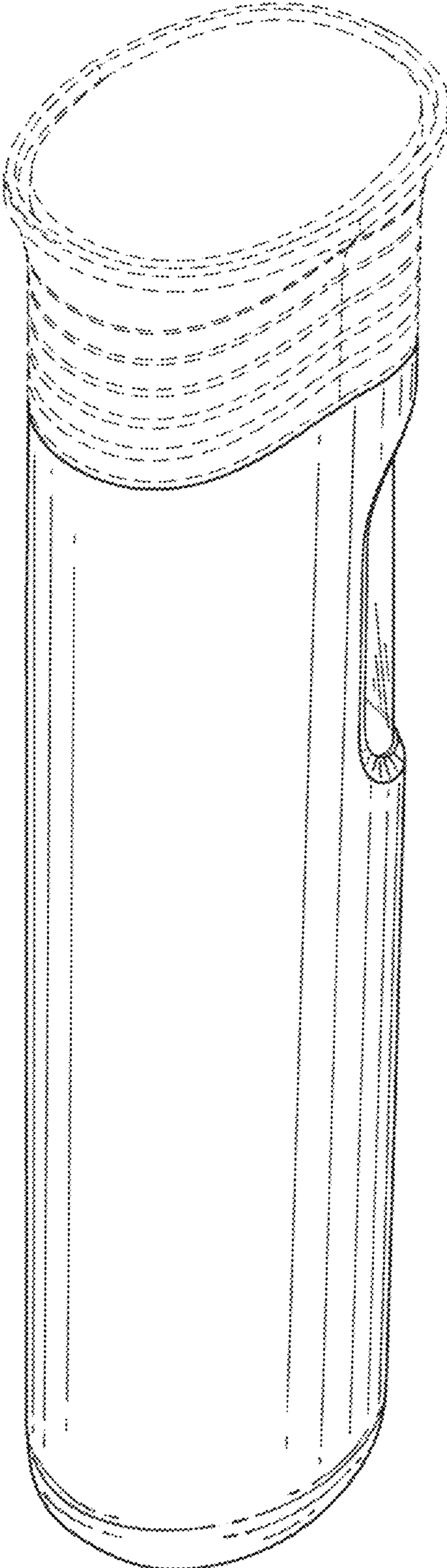

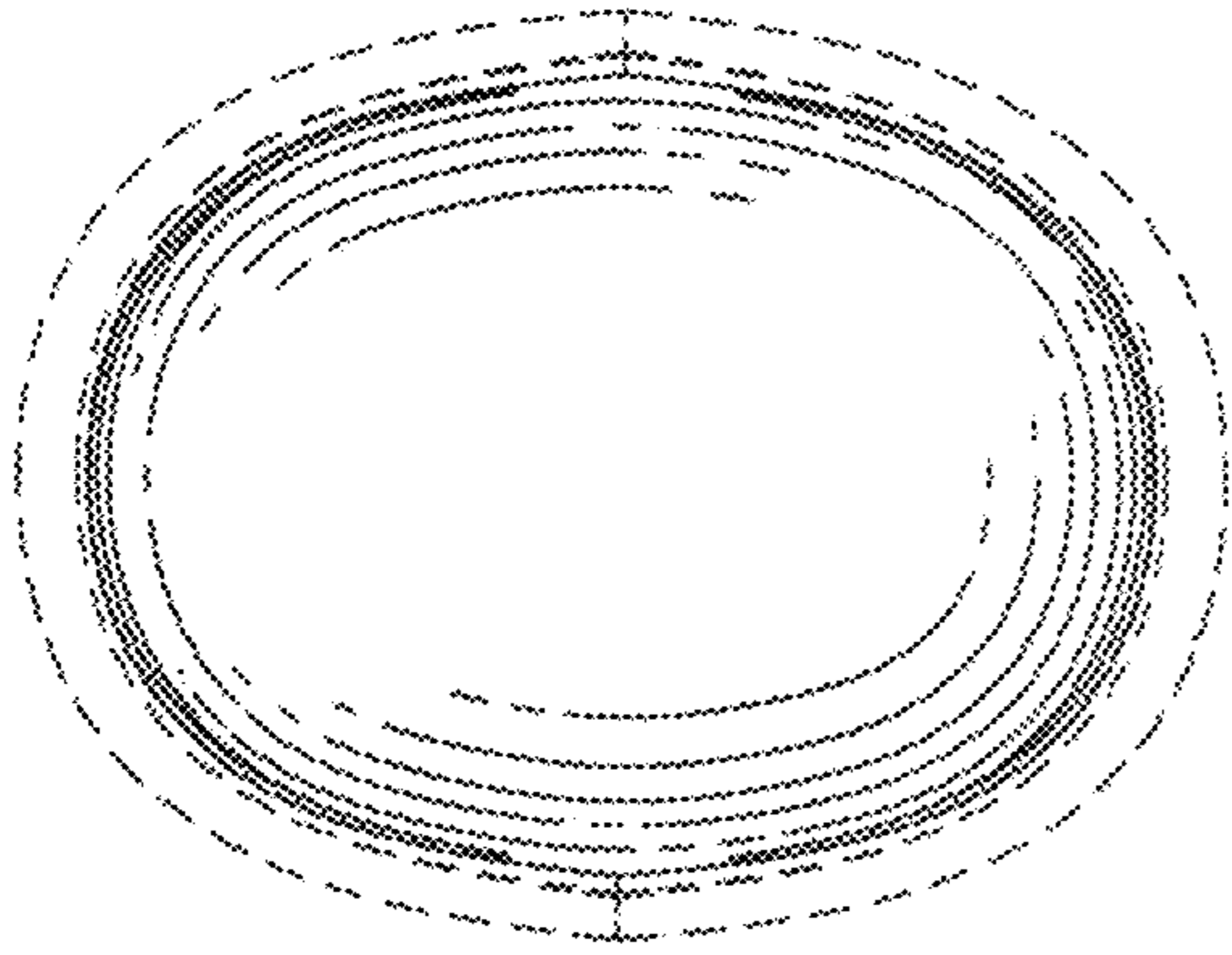

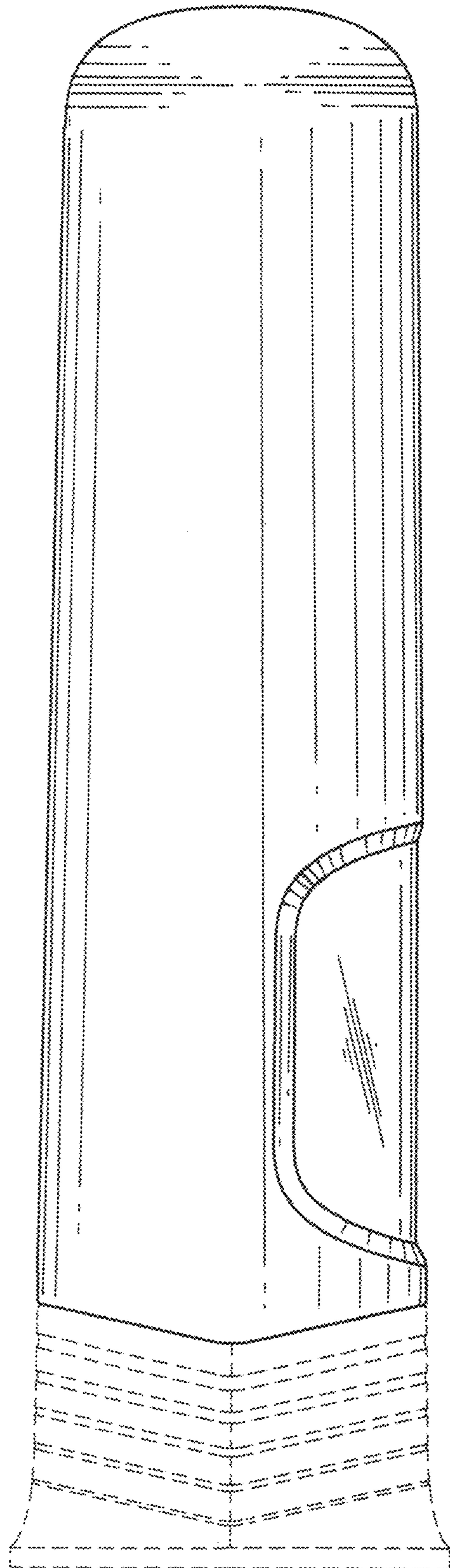

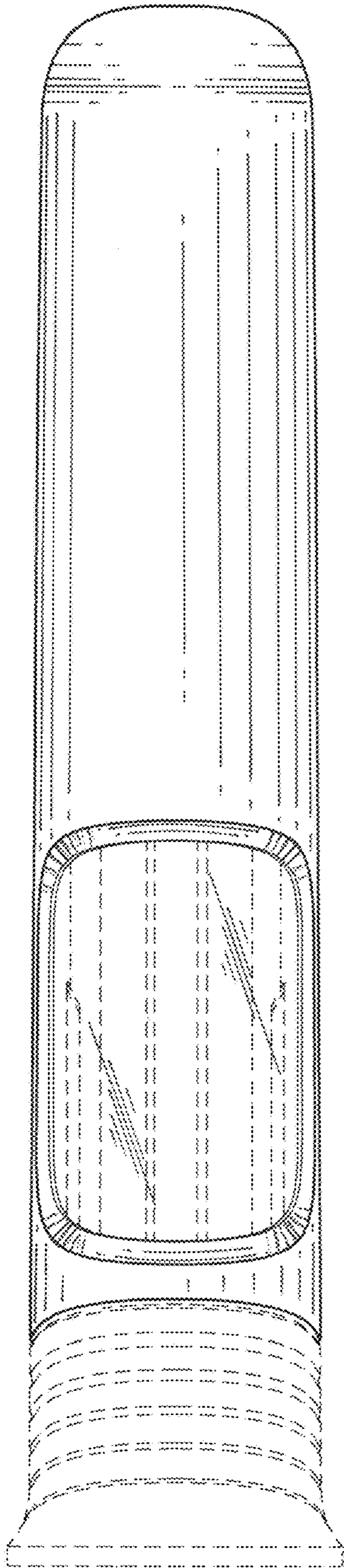

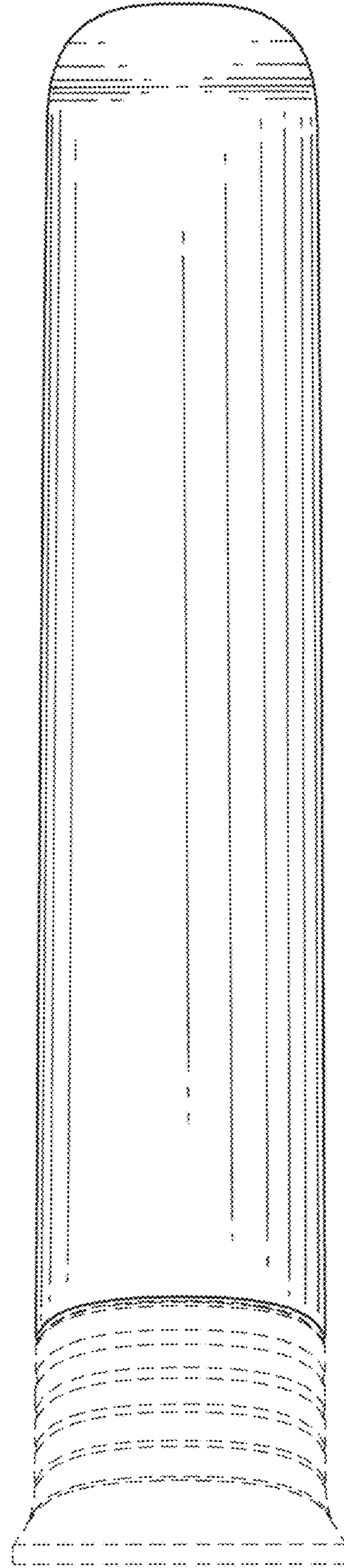

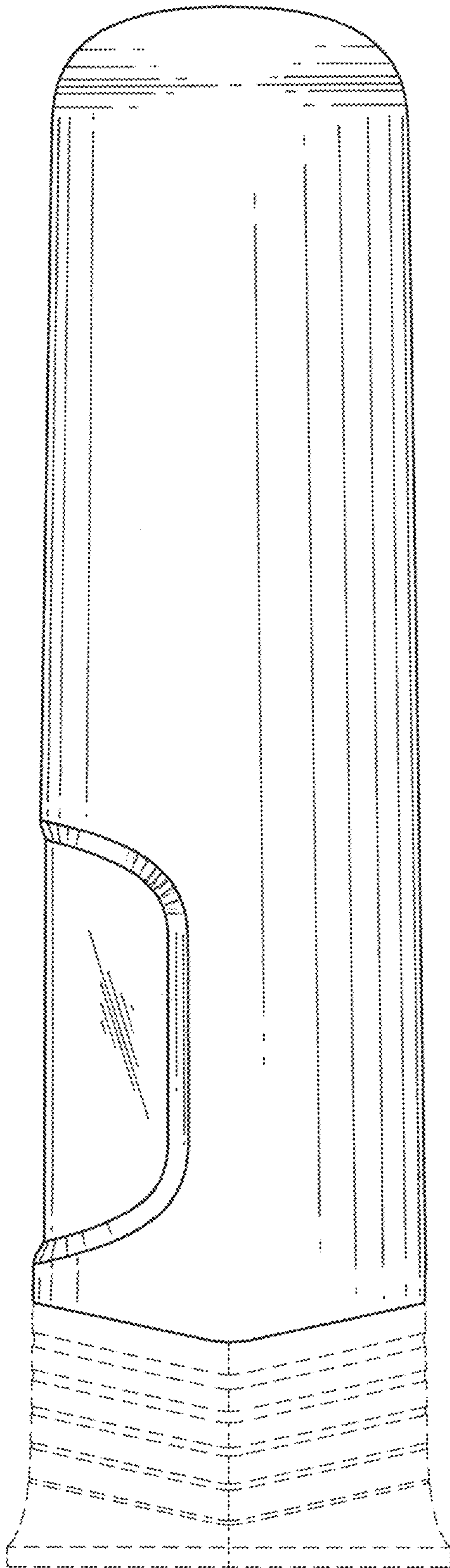

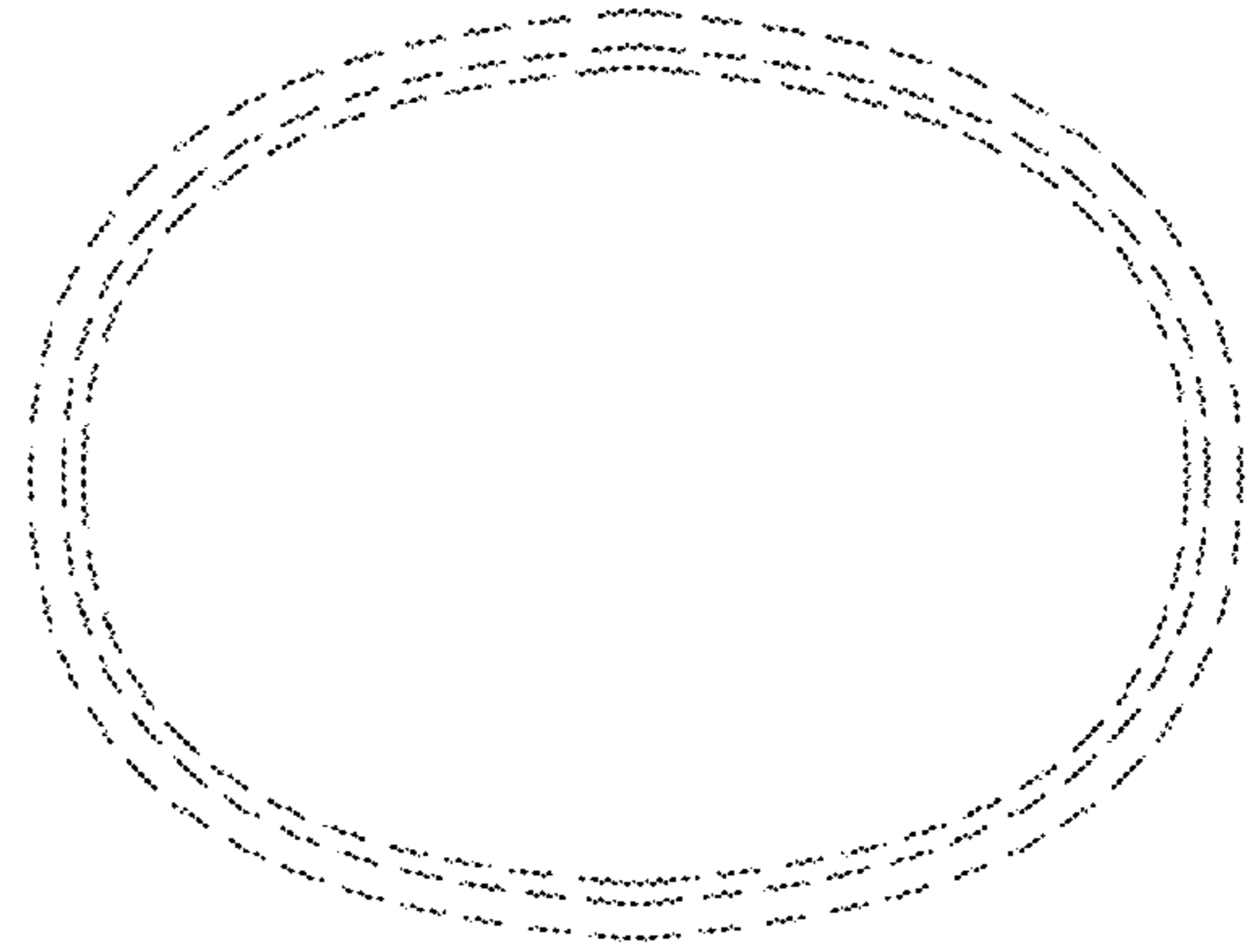
