DESCRIPTION

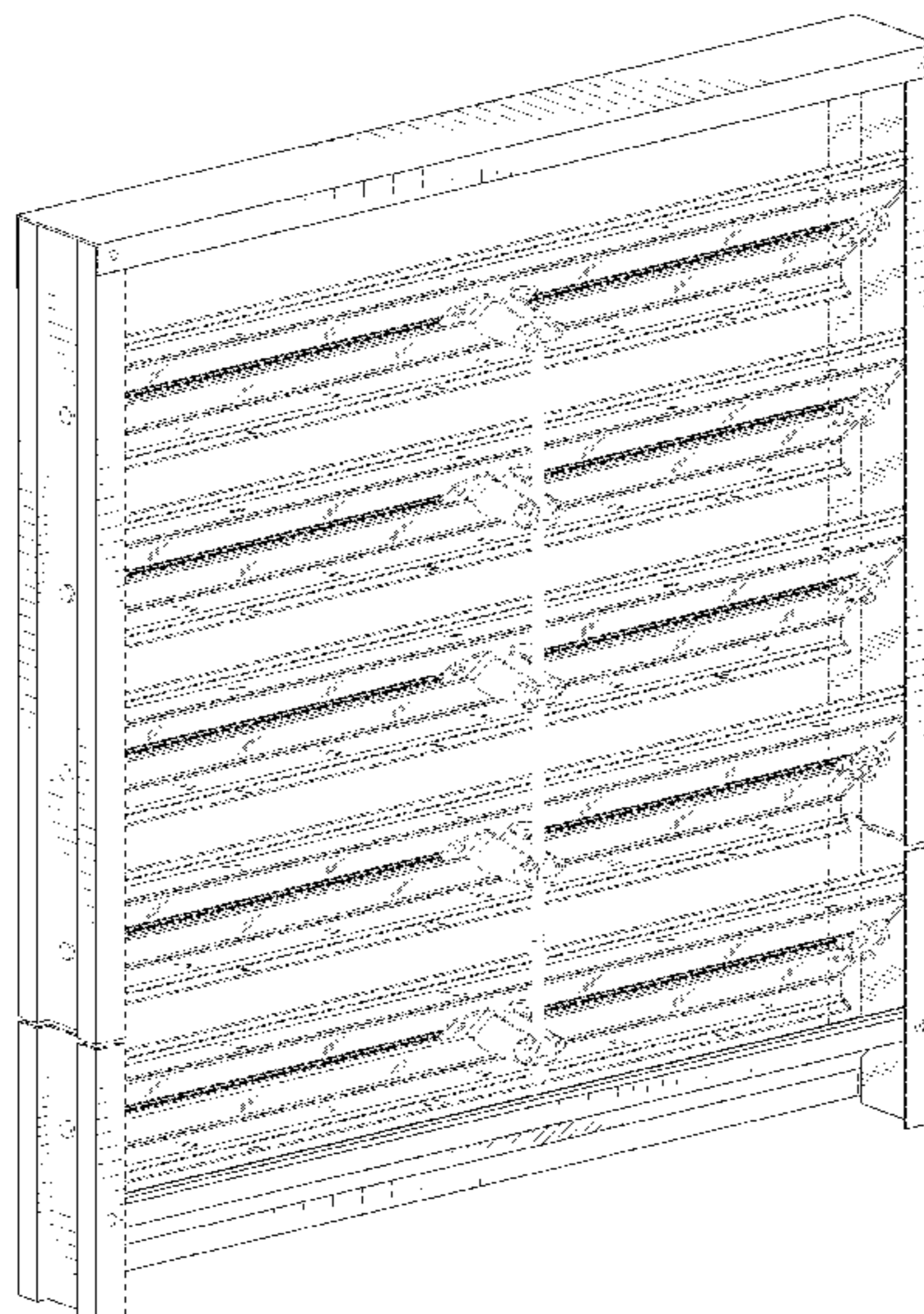
FIG. 1 is a front perspective view of a louver showing our new design;

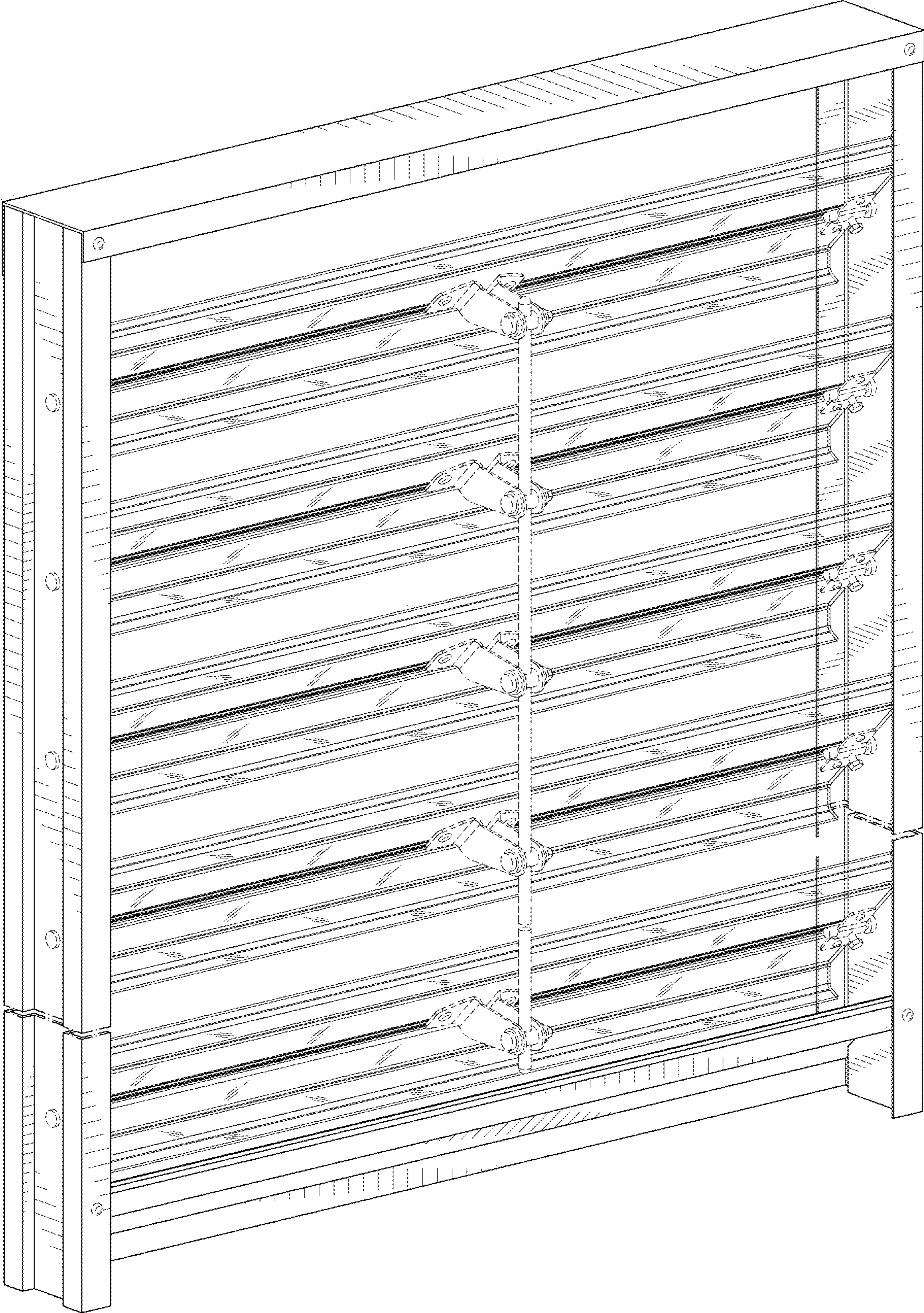

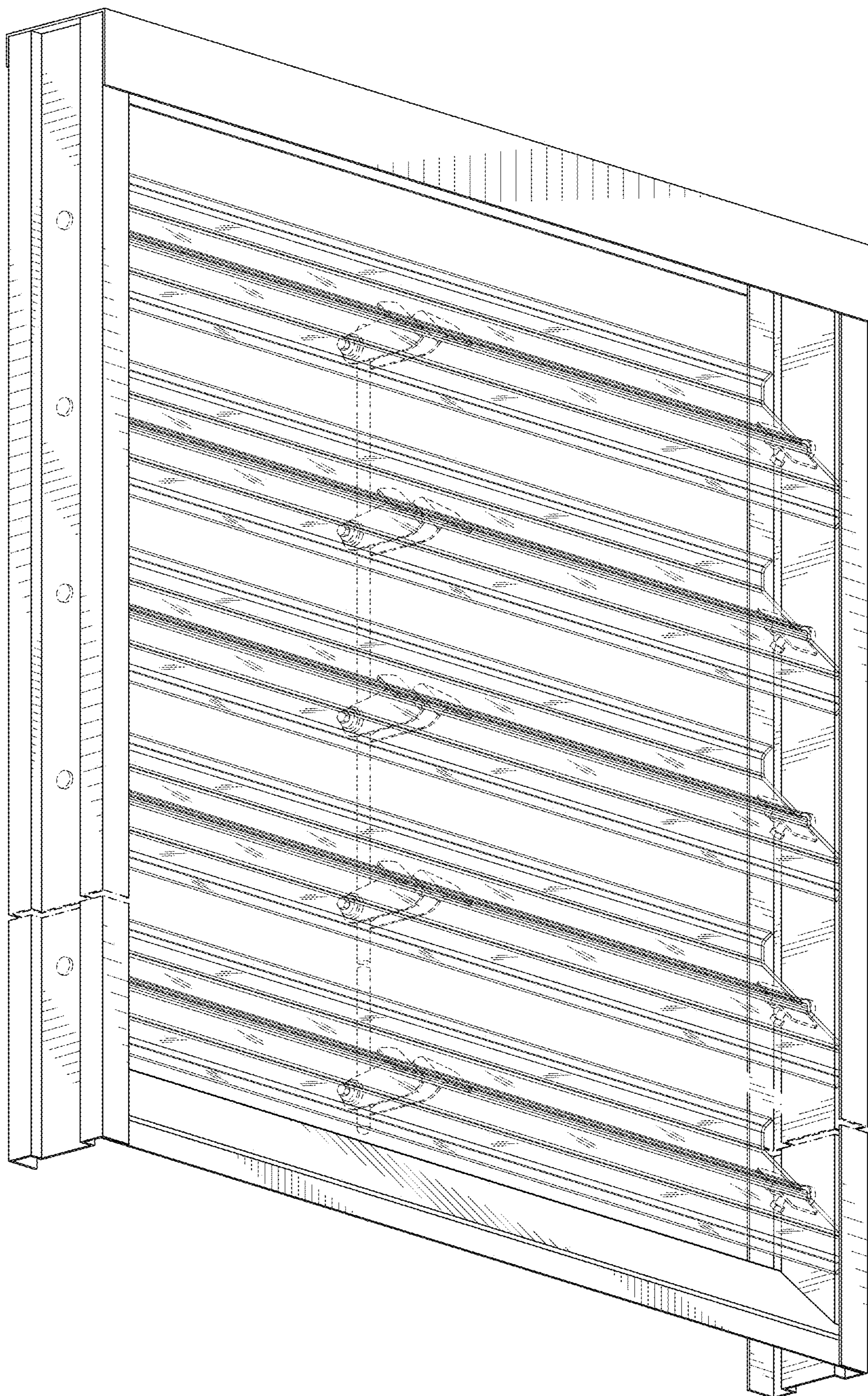

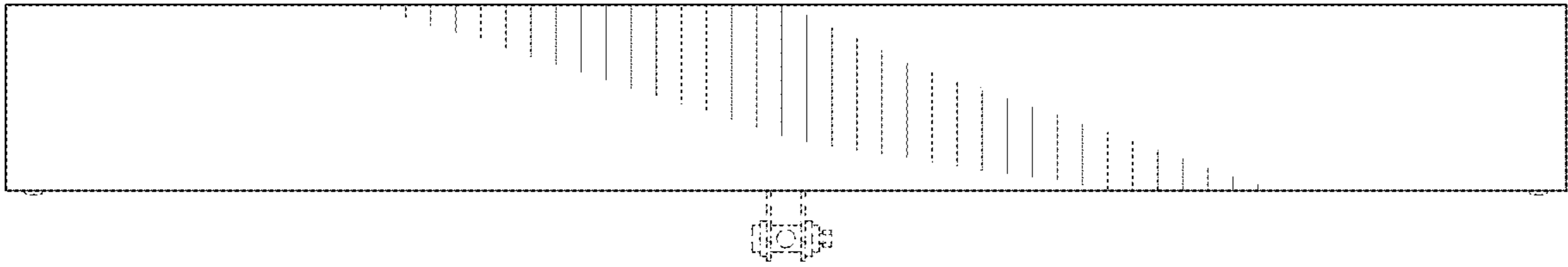

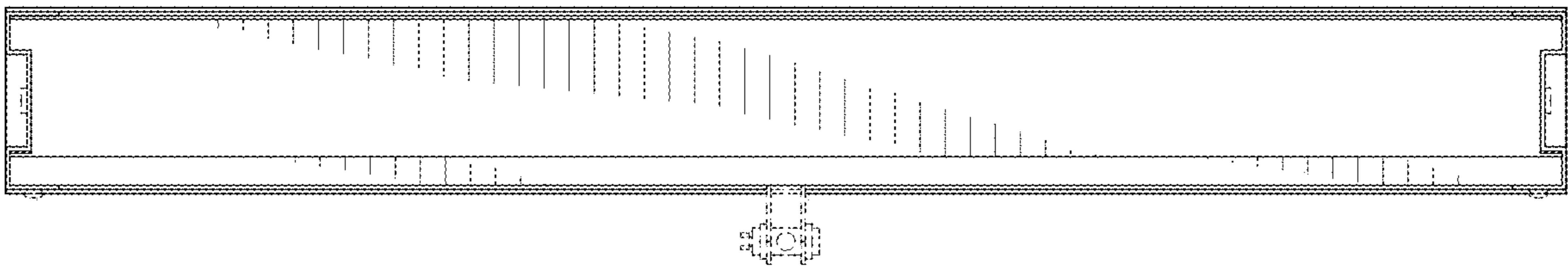

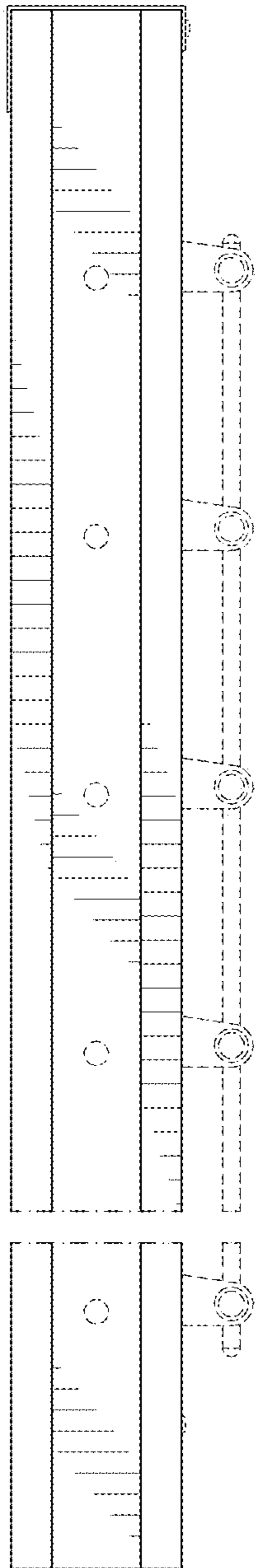

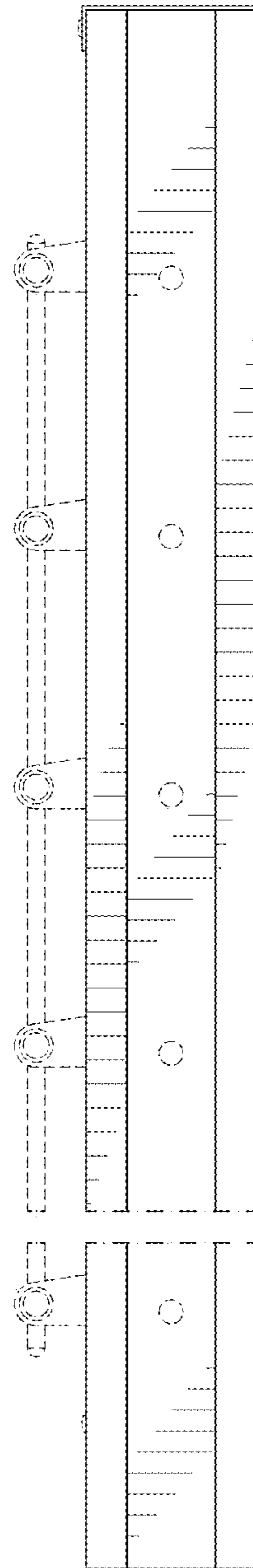

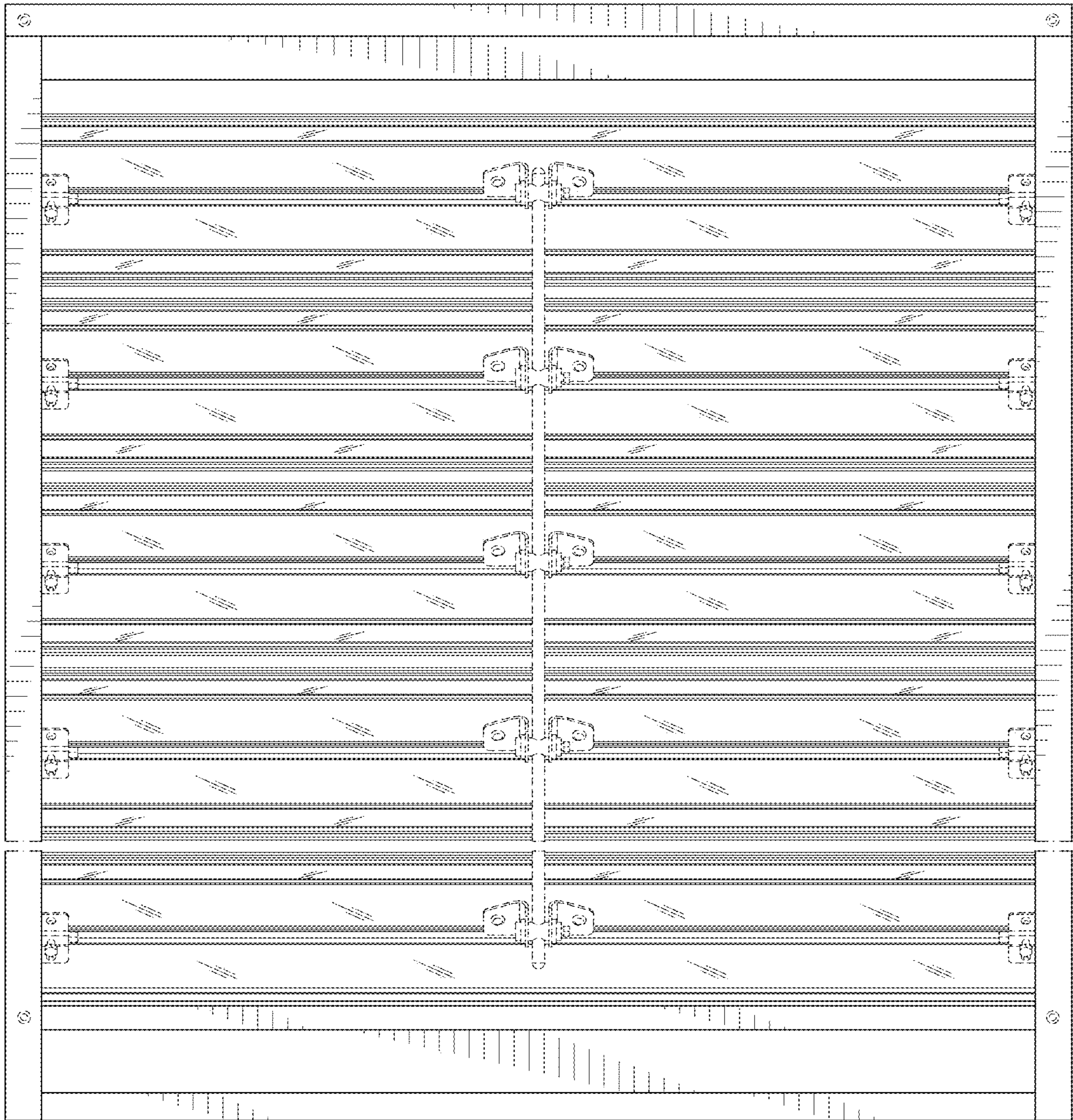

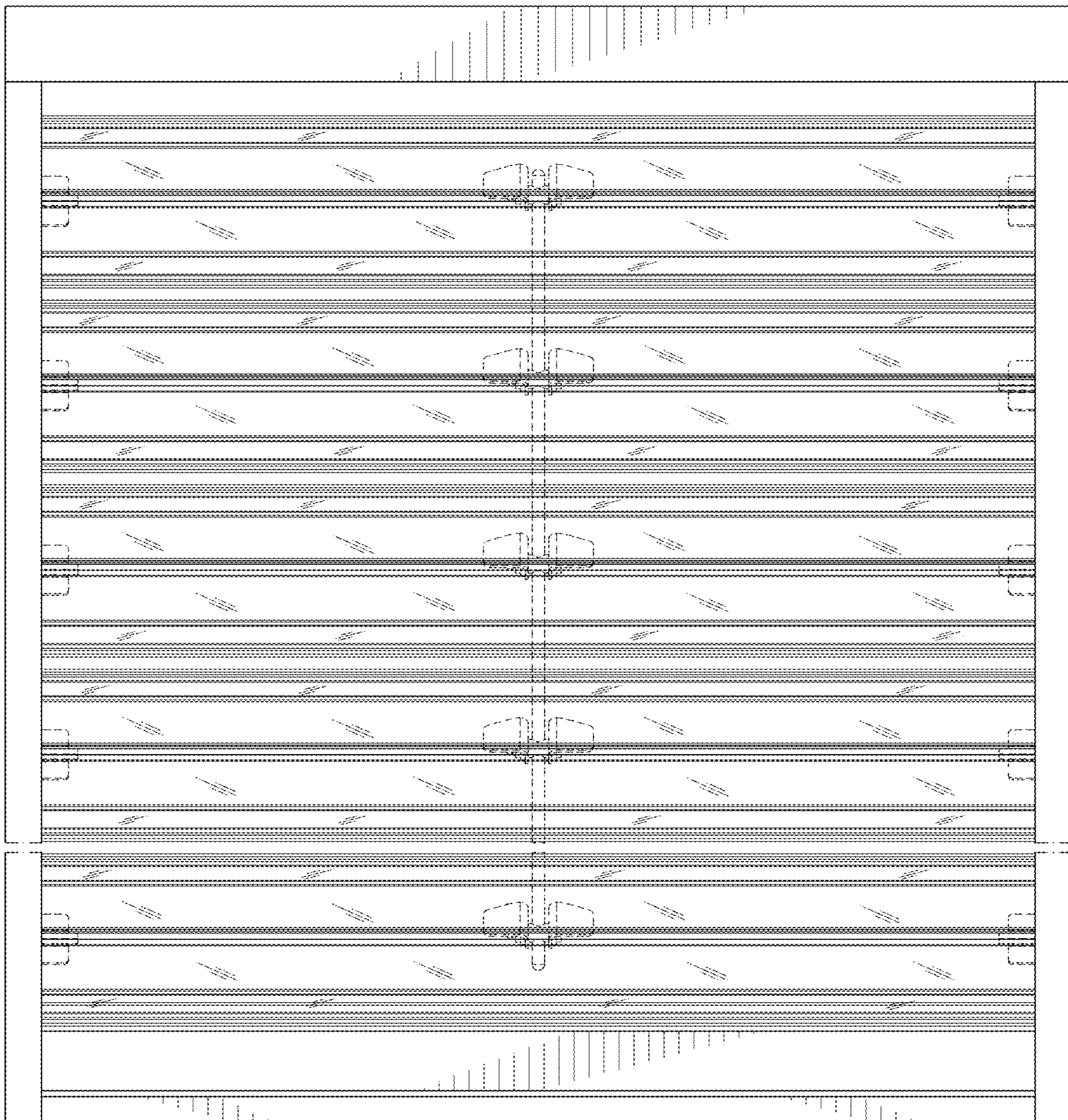
