FIG. 4 illustrates a right side view of the light device.

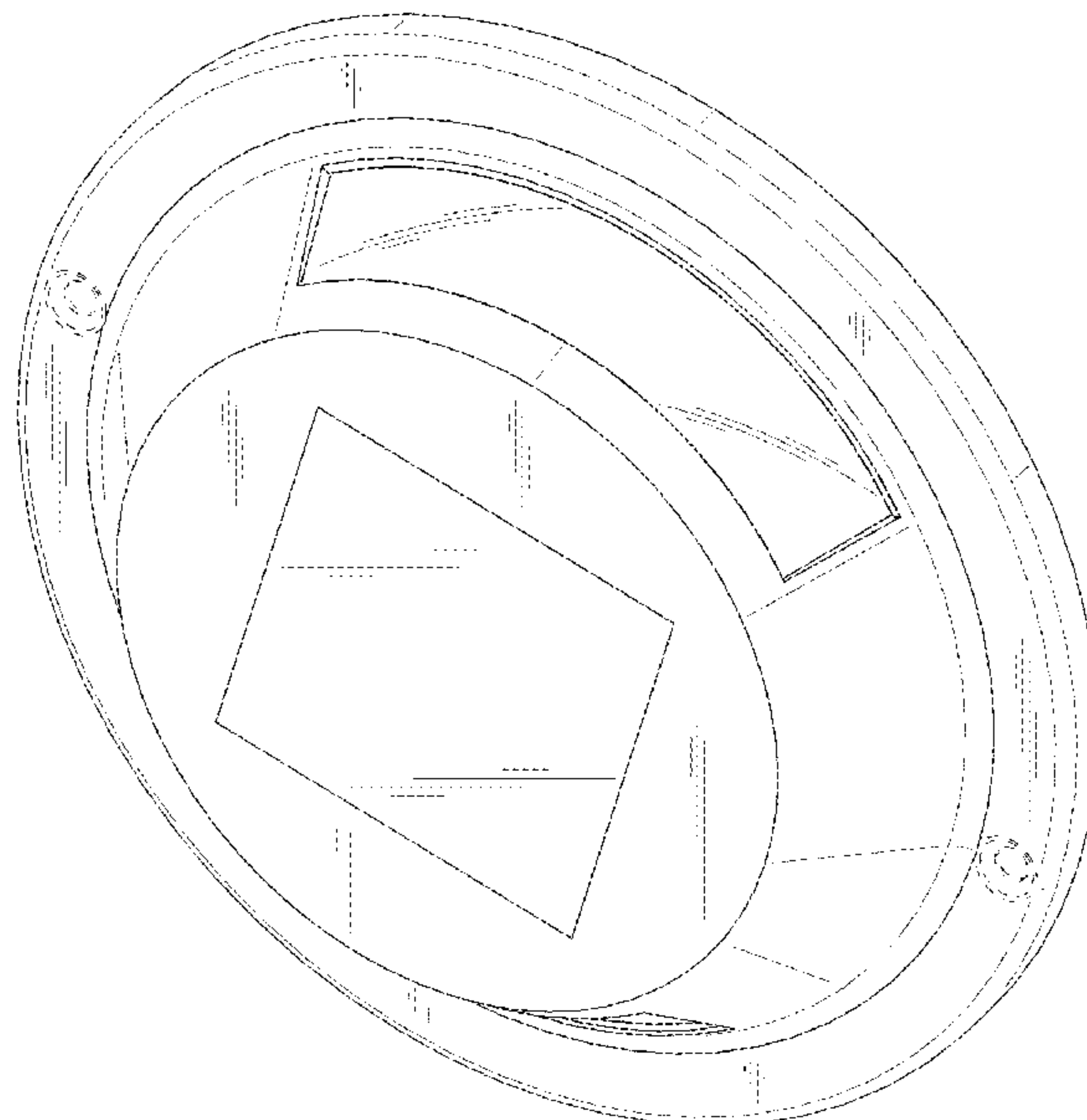
FIG. 5 illustrates a left side elevational view of the light device.

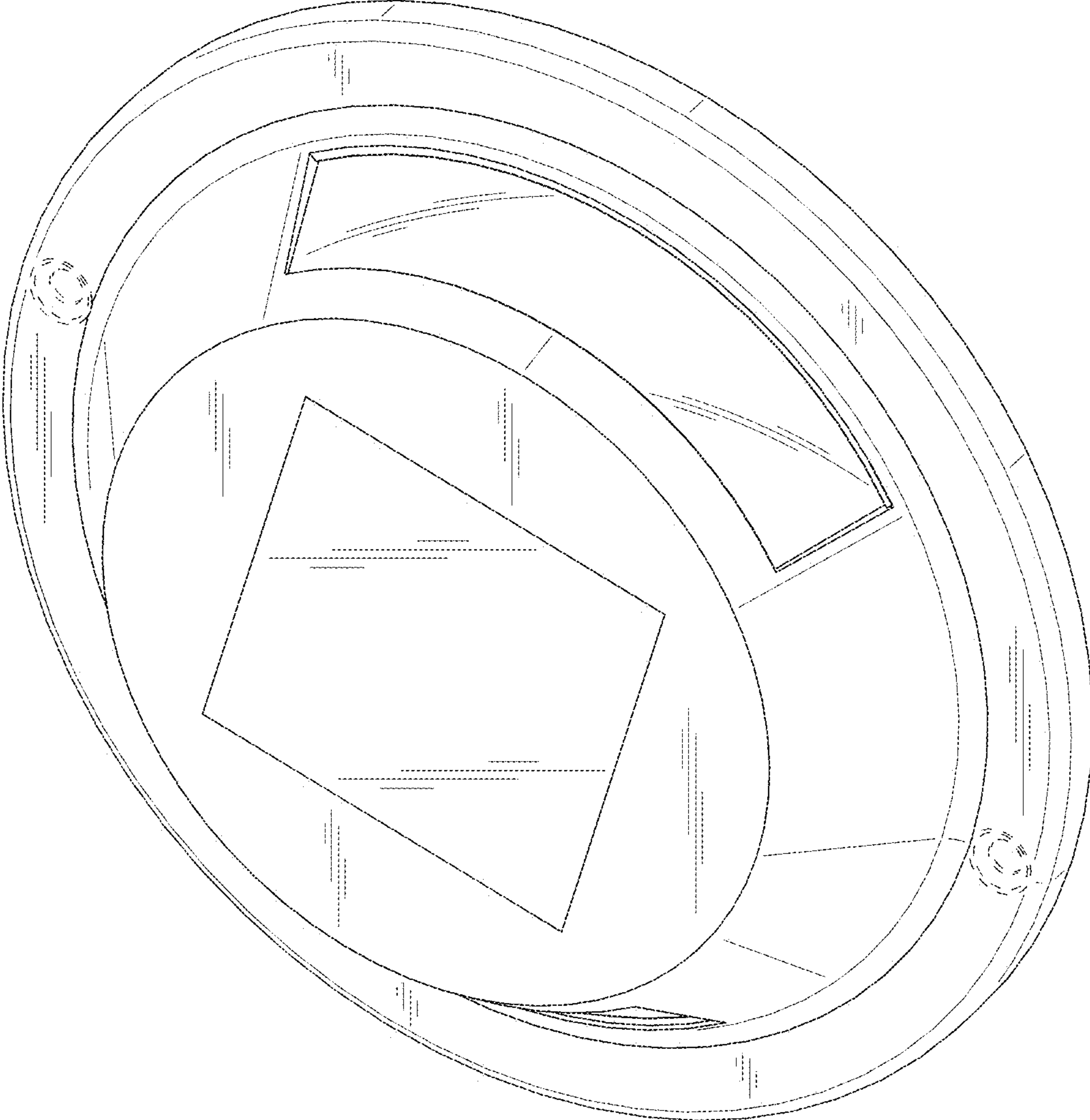

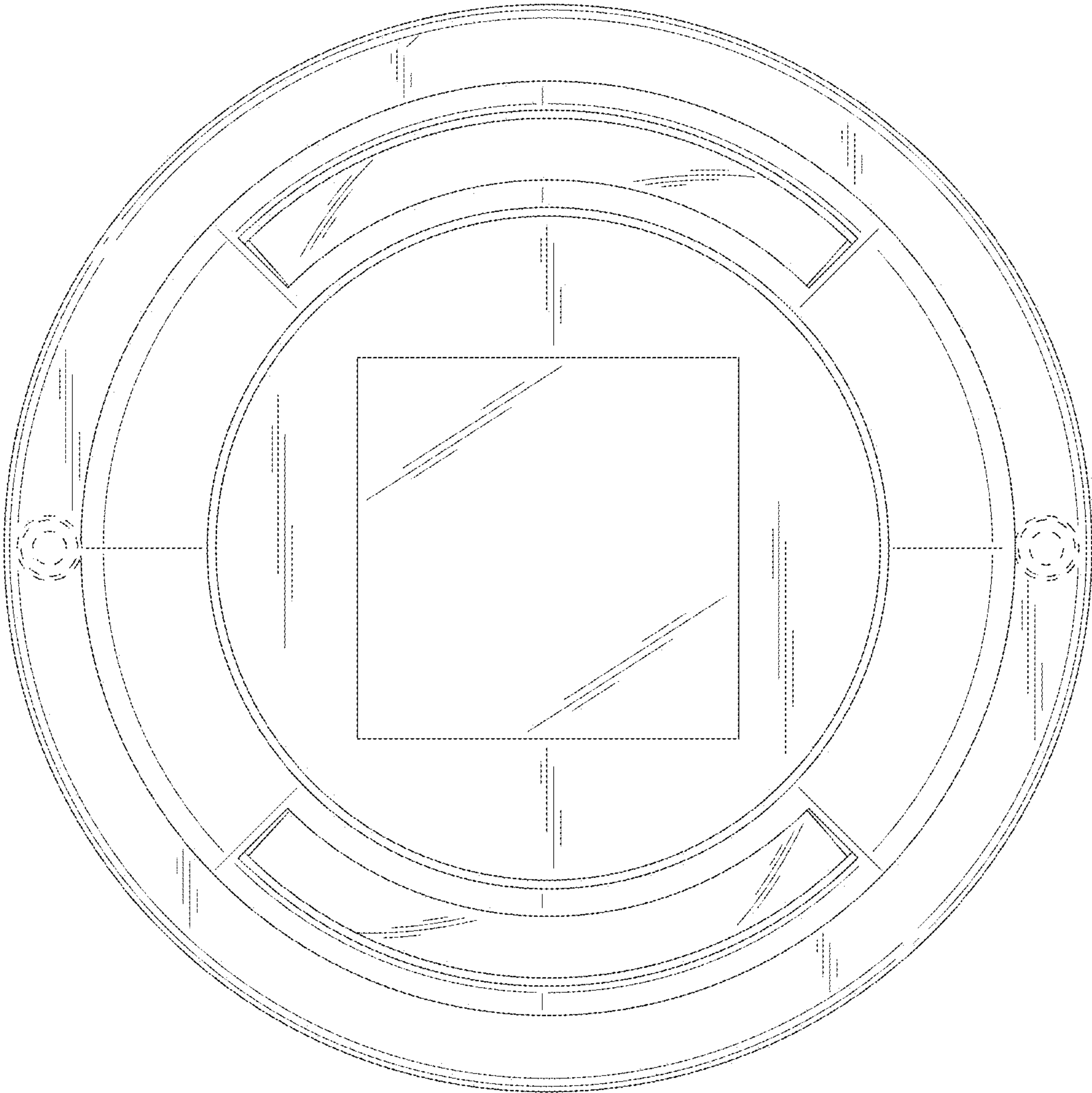

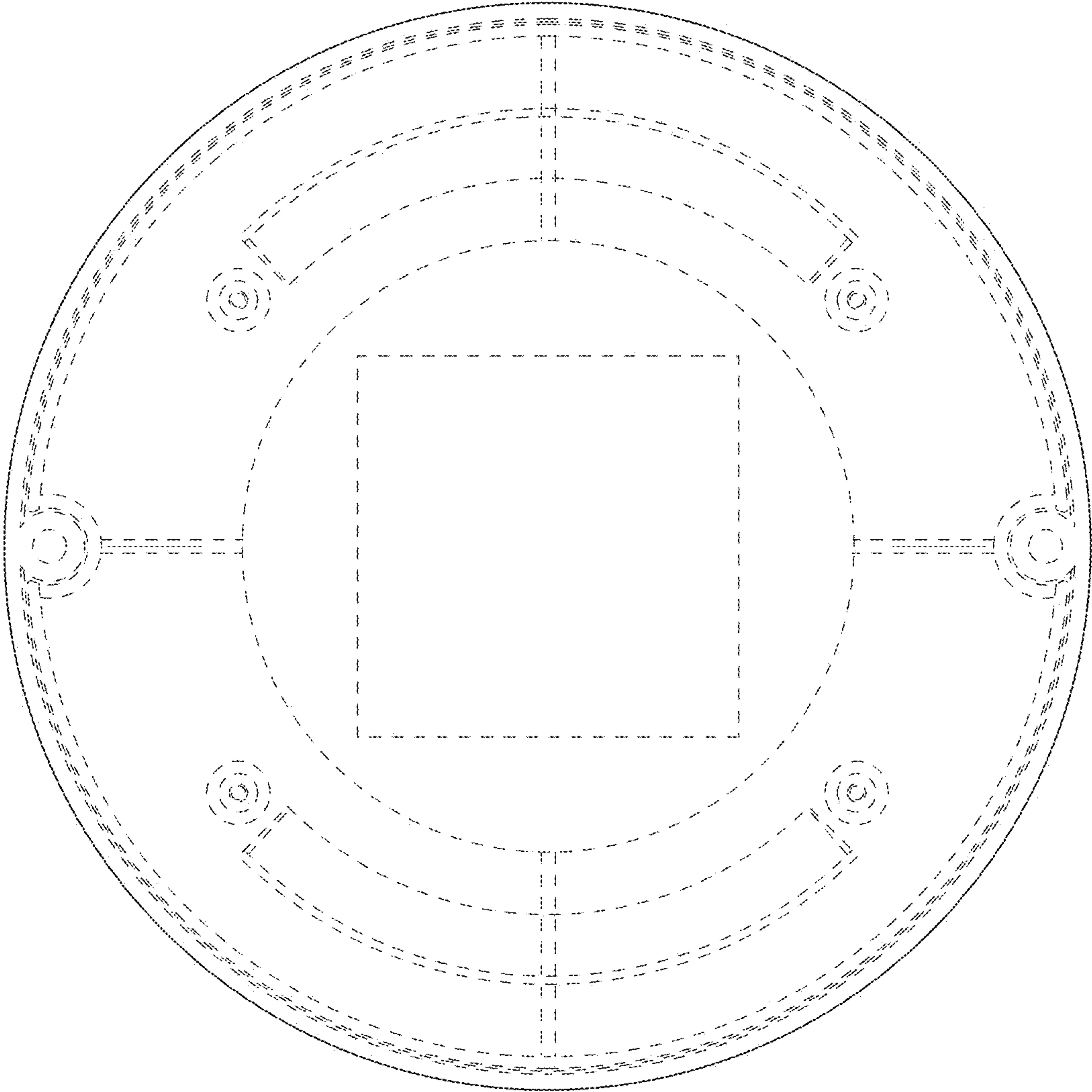

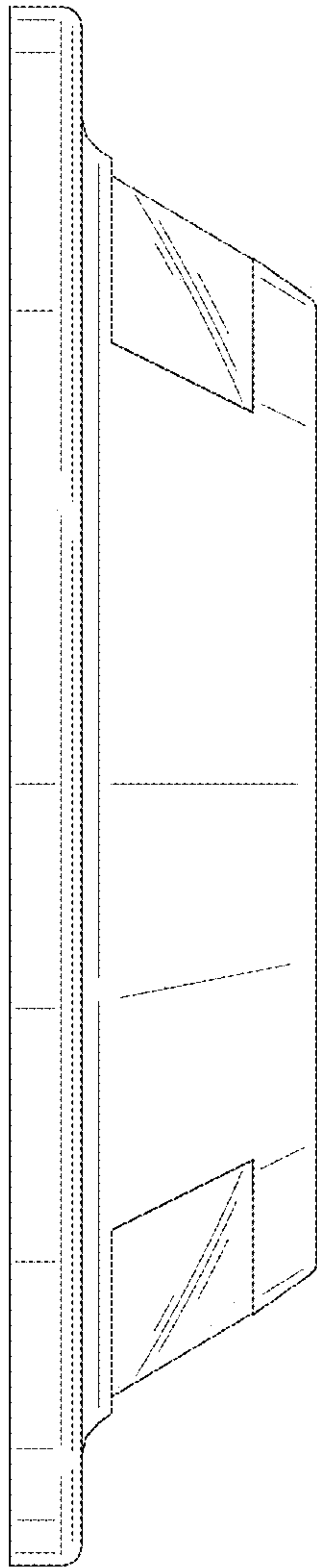

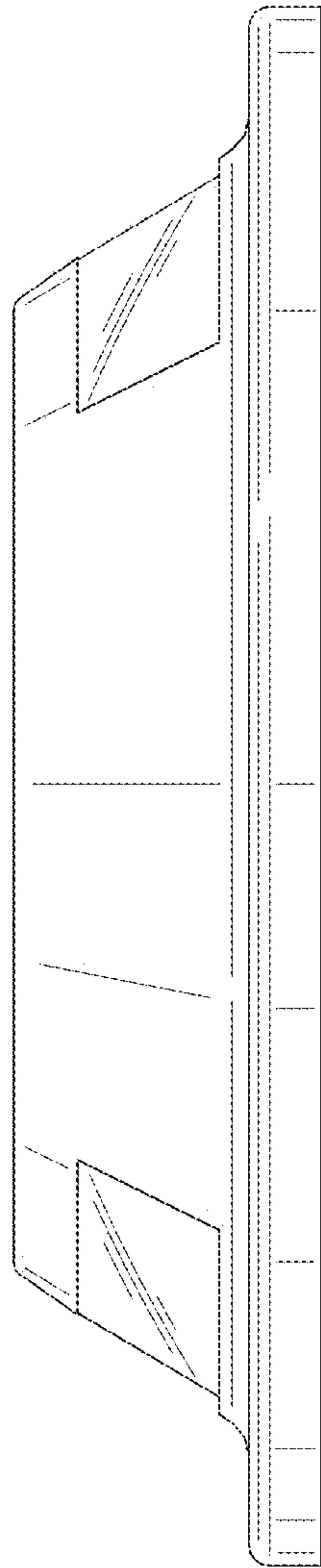

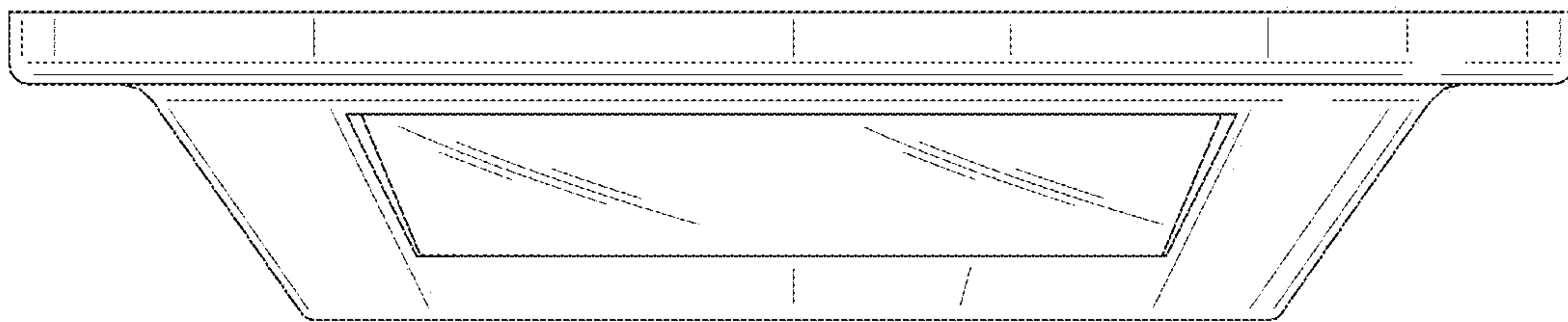

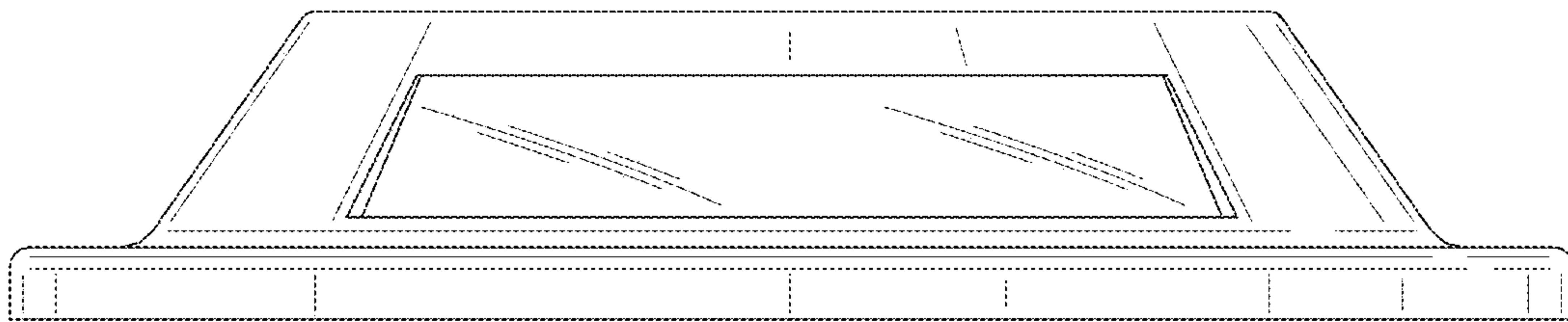
