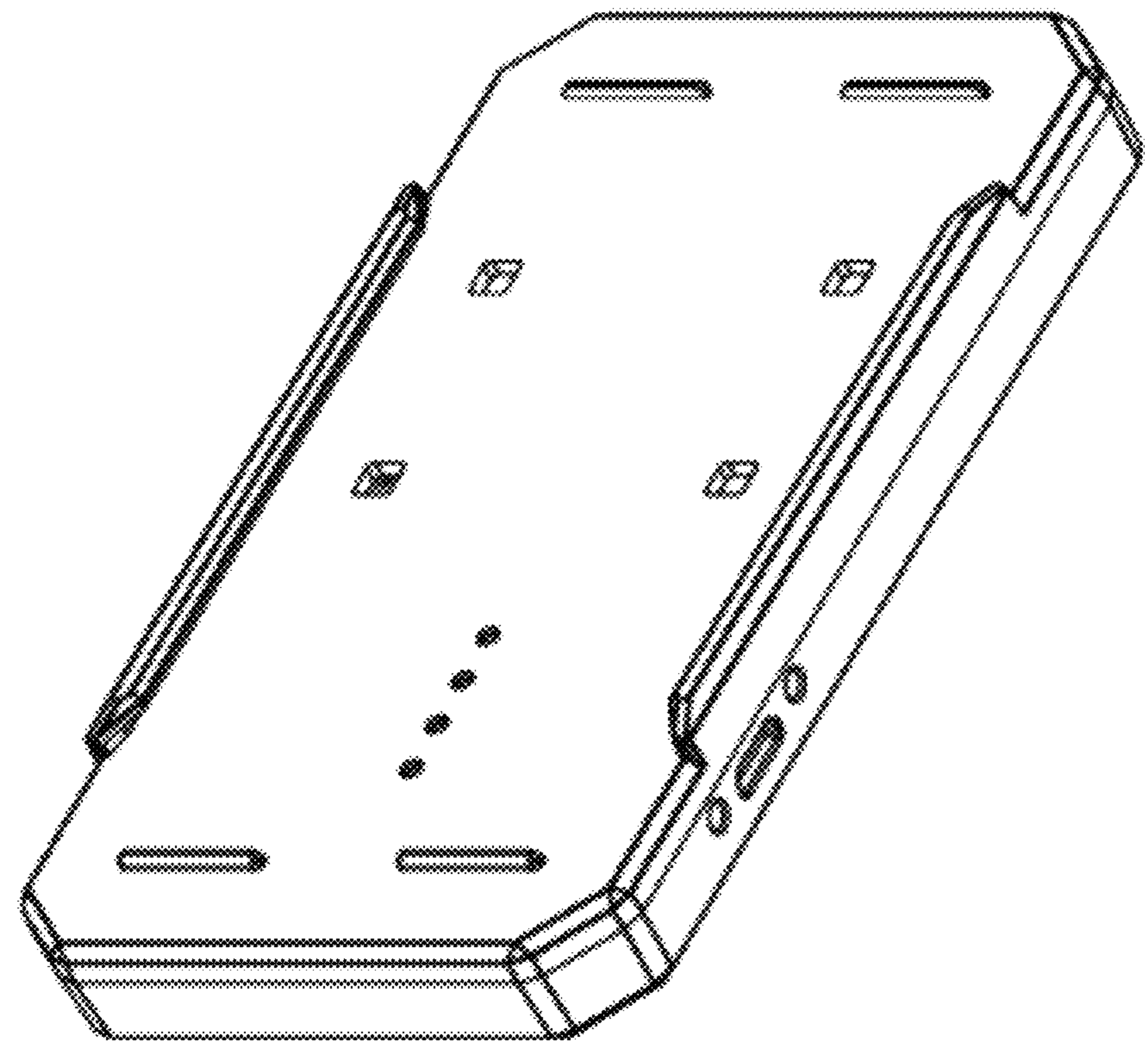

(57) **CLAIM**
Applicant claims the ornamental design of the active card holder, as shown and described.

DESCRIPTION

FIG. 1 provides a top view diagrammatic representation of the active card holder.
 FIG. 2 provides a top perspective diagrammatic representation of the active card holder of FIG. 1 rotated 180 degrees.
 FIG. 3 provides an end-on diagrammatic representation of the active card holder of FIG. 1, viewed with the top of the base flipped downward as compared to the orientation provided in FIG. 1.
 FIG. 4 provides a side diagrammatic representation of the active card holder of FIG. 1 viewed in the same orientation as in FIG. 3 but rotated 90 degrees to show the side view rather than an end-on view of the active card holder; and,
 FIG. 5 provides a top diagrammatic representation of the active card holder of FIG. 1, viewed from above with an unclaimed identification card in place.
 The bottom of the active card holder forms no part of the claimed design.
 The broken lines disclosed in FIG. 5 depict the outline of an unclaimed identification card and form no part of the claimed design.

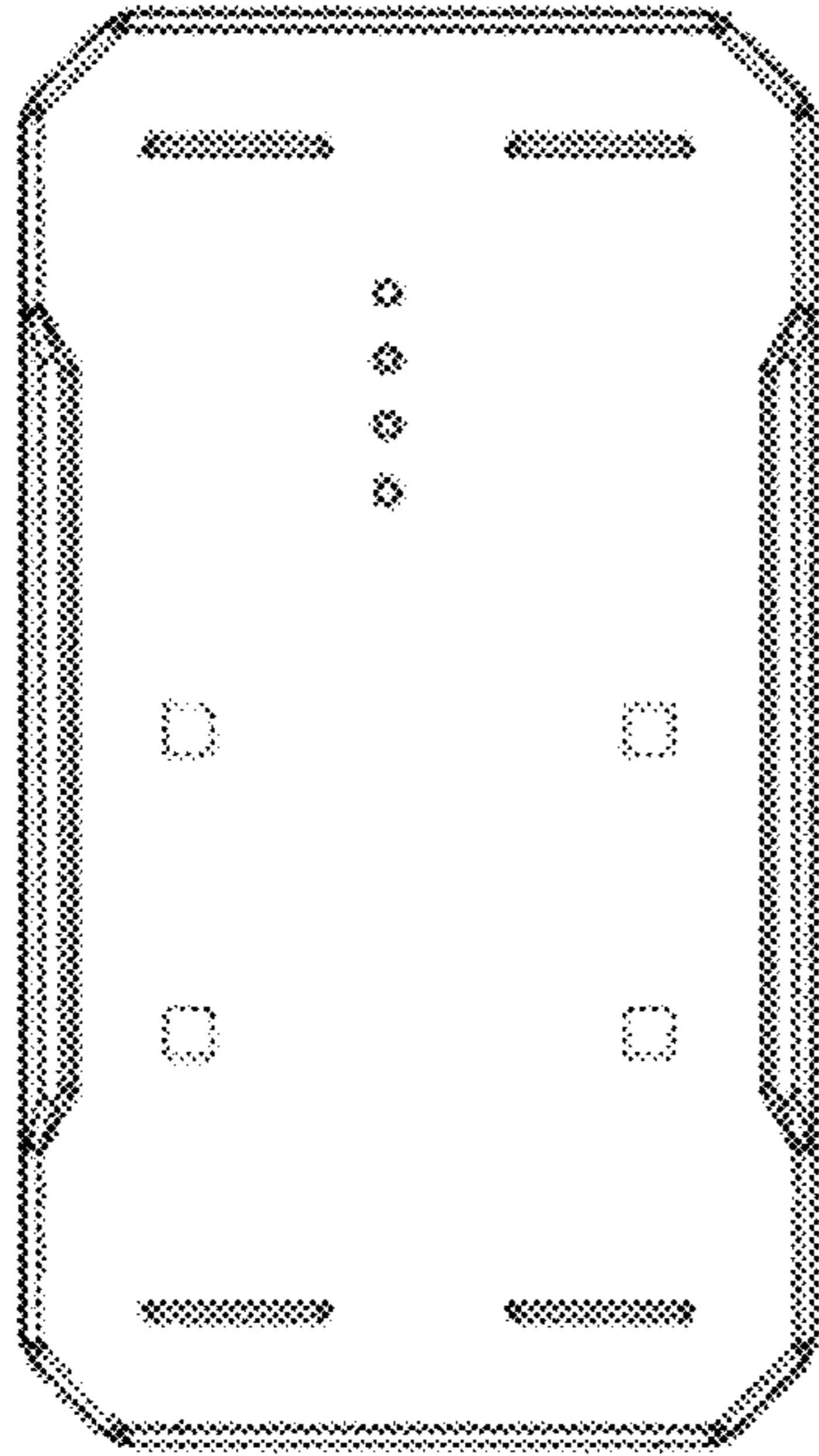

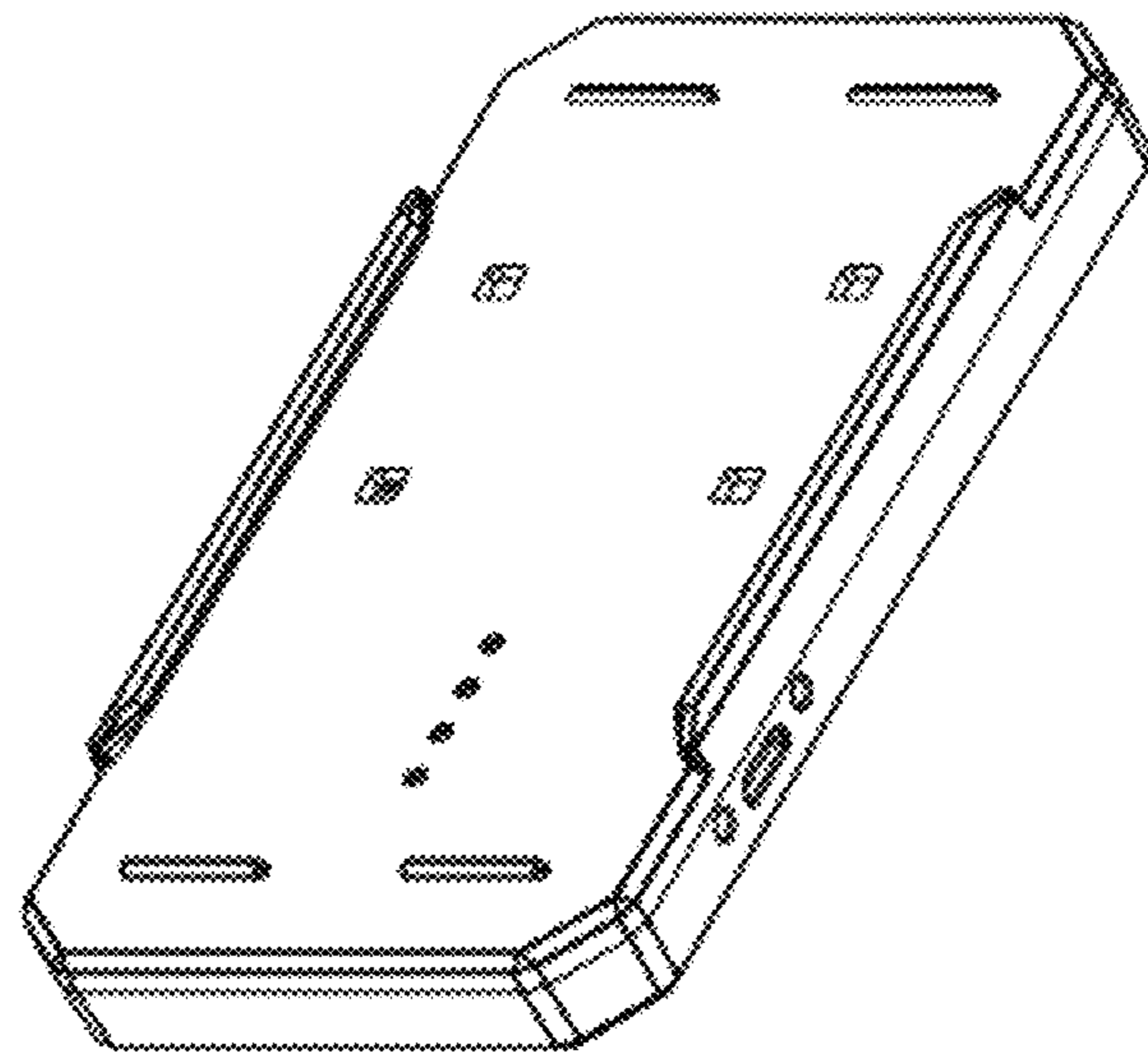

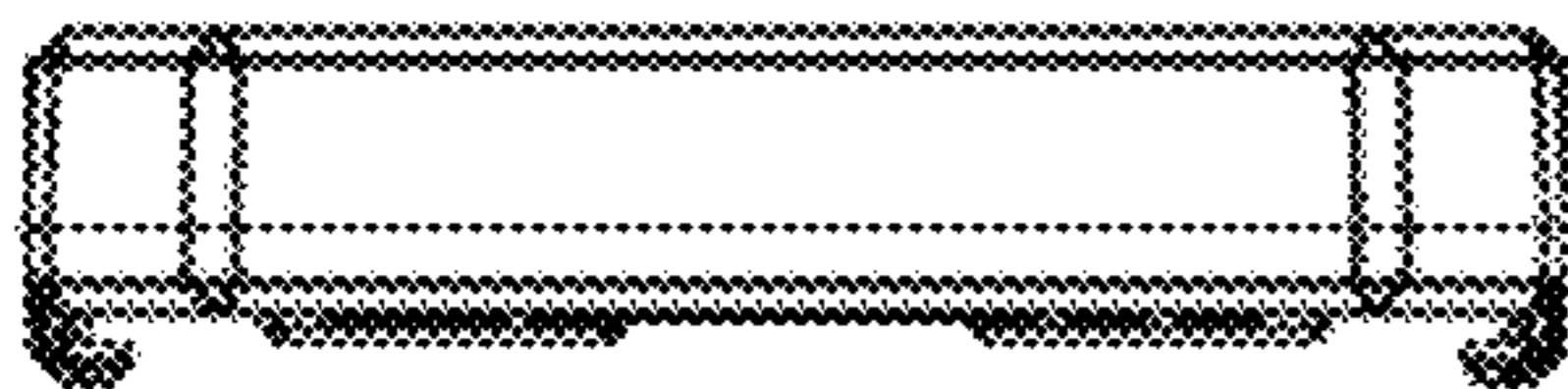

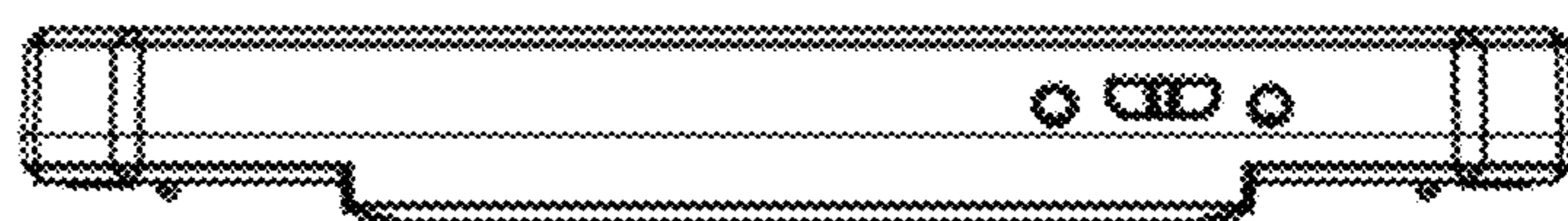

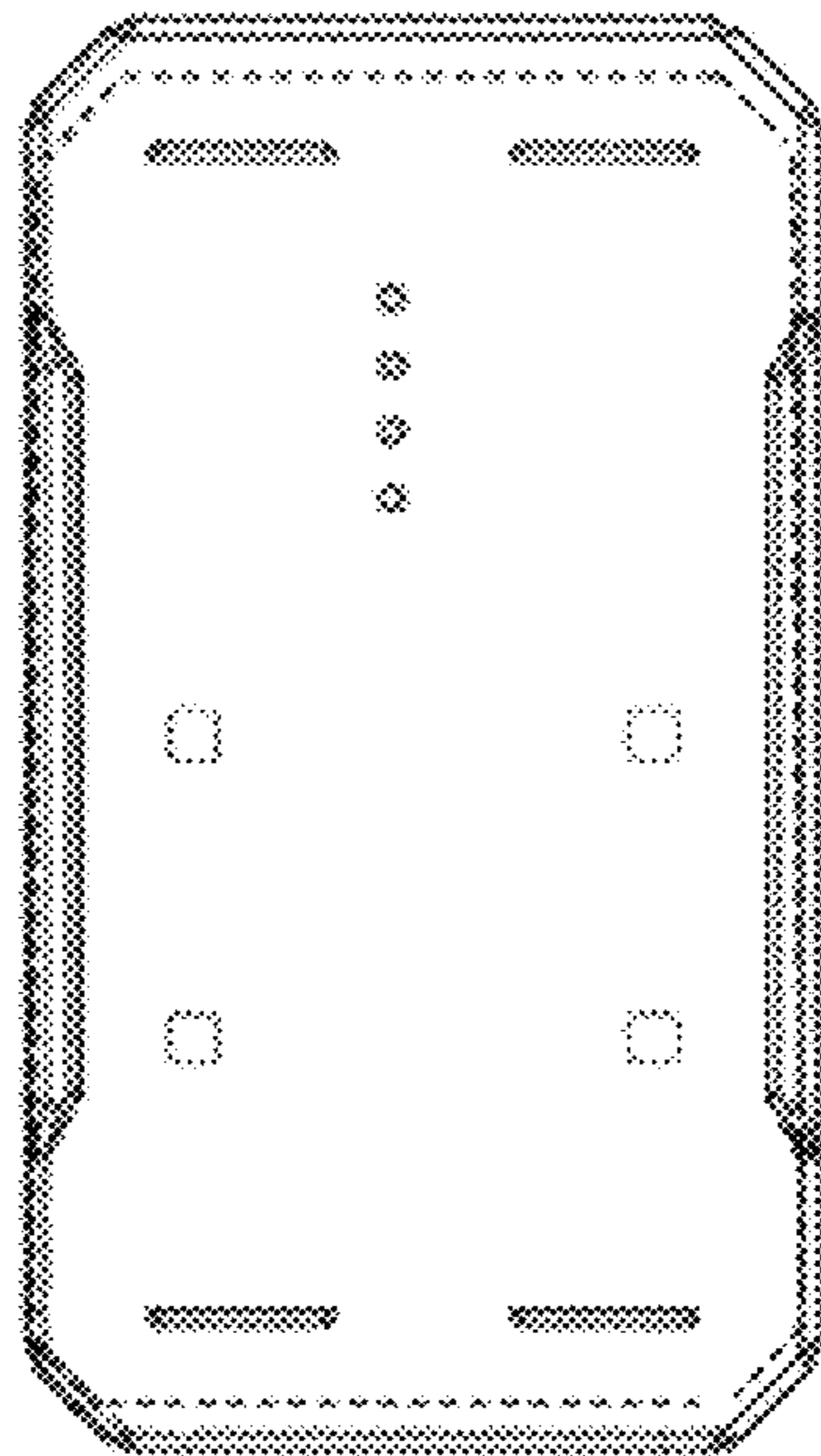
