The ornamental design for an inflatable lounger, as shown and described.

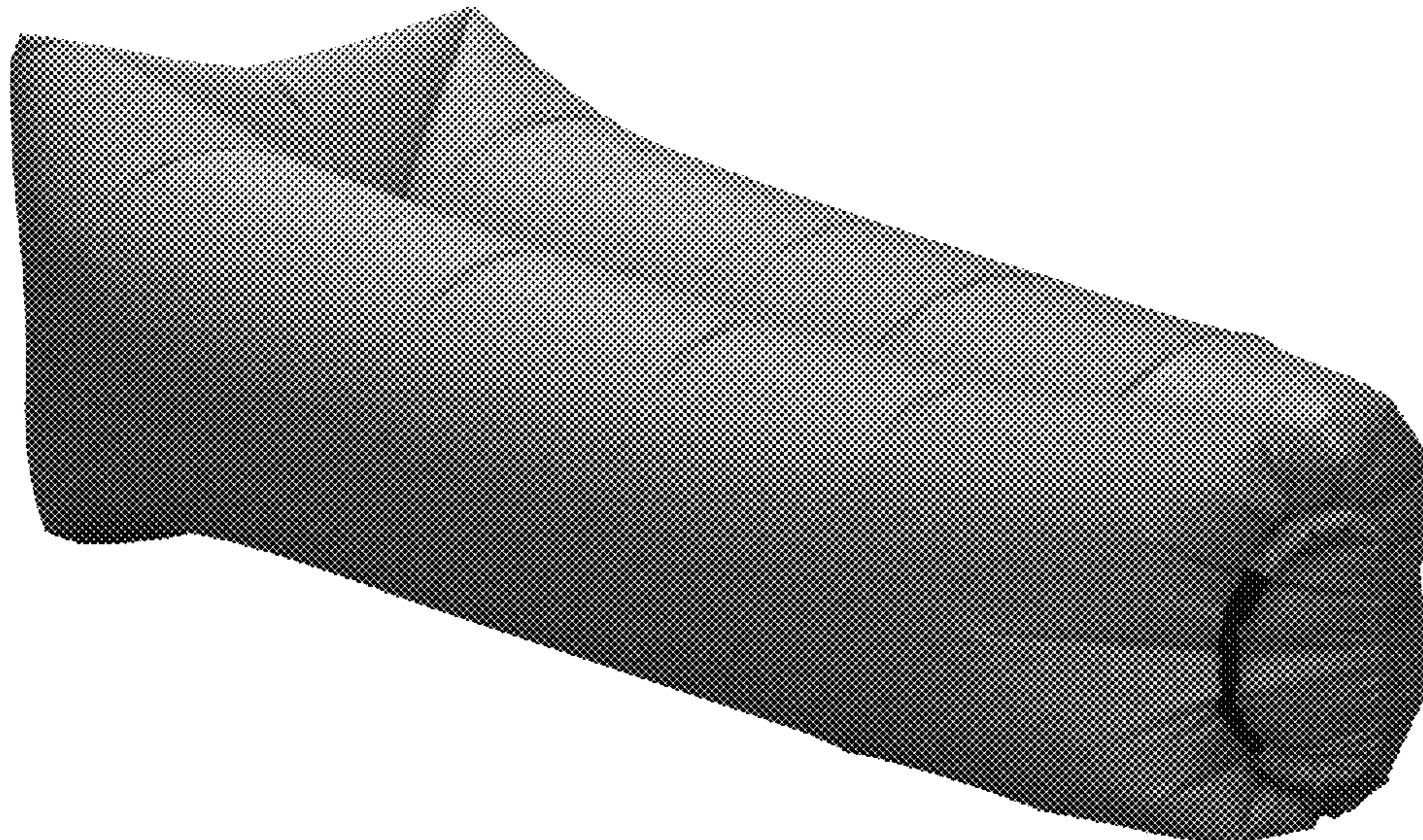
**DESCRIPTION**

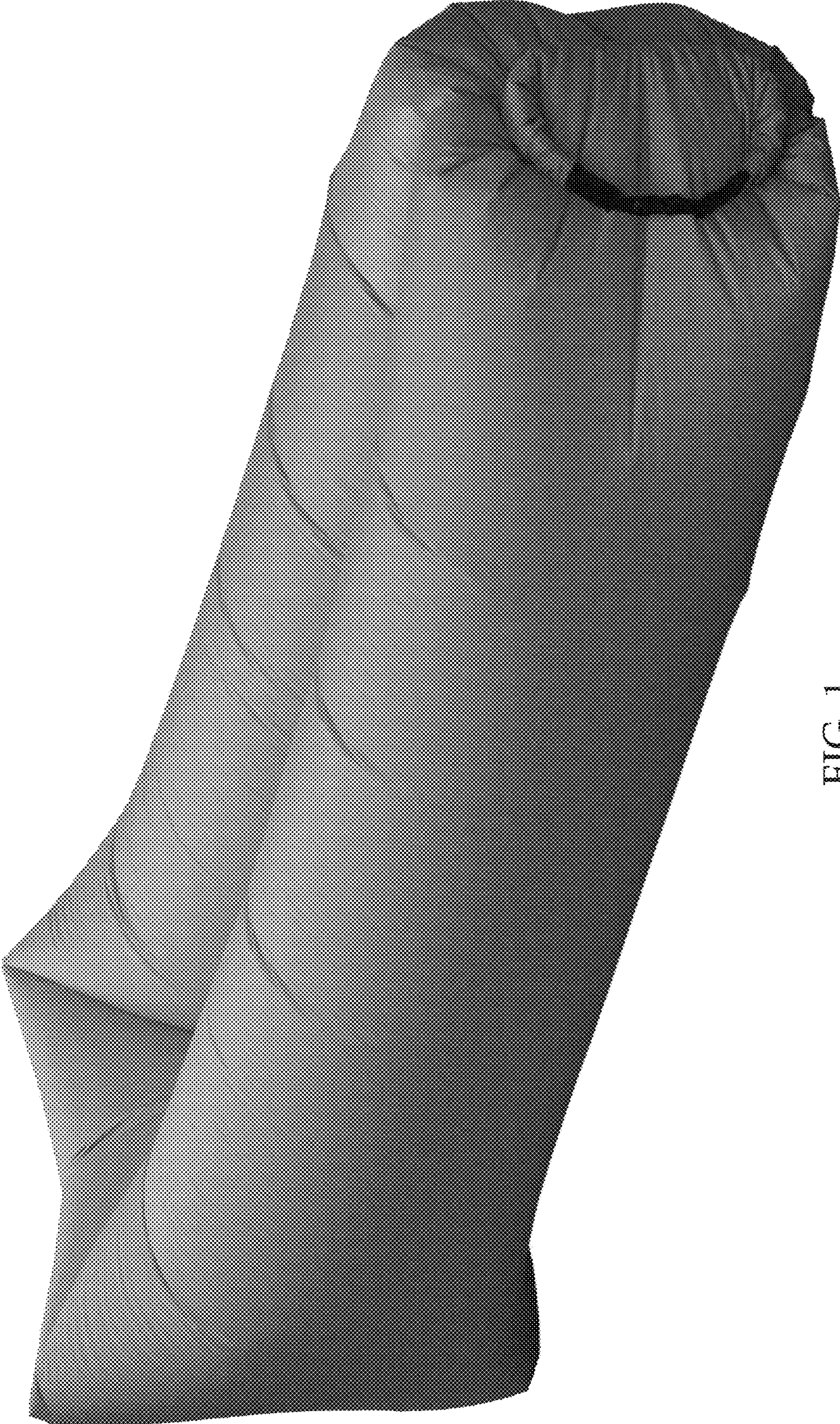

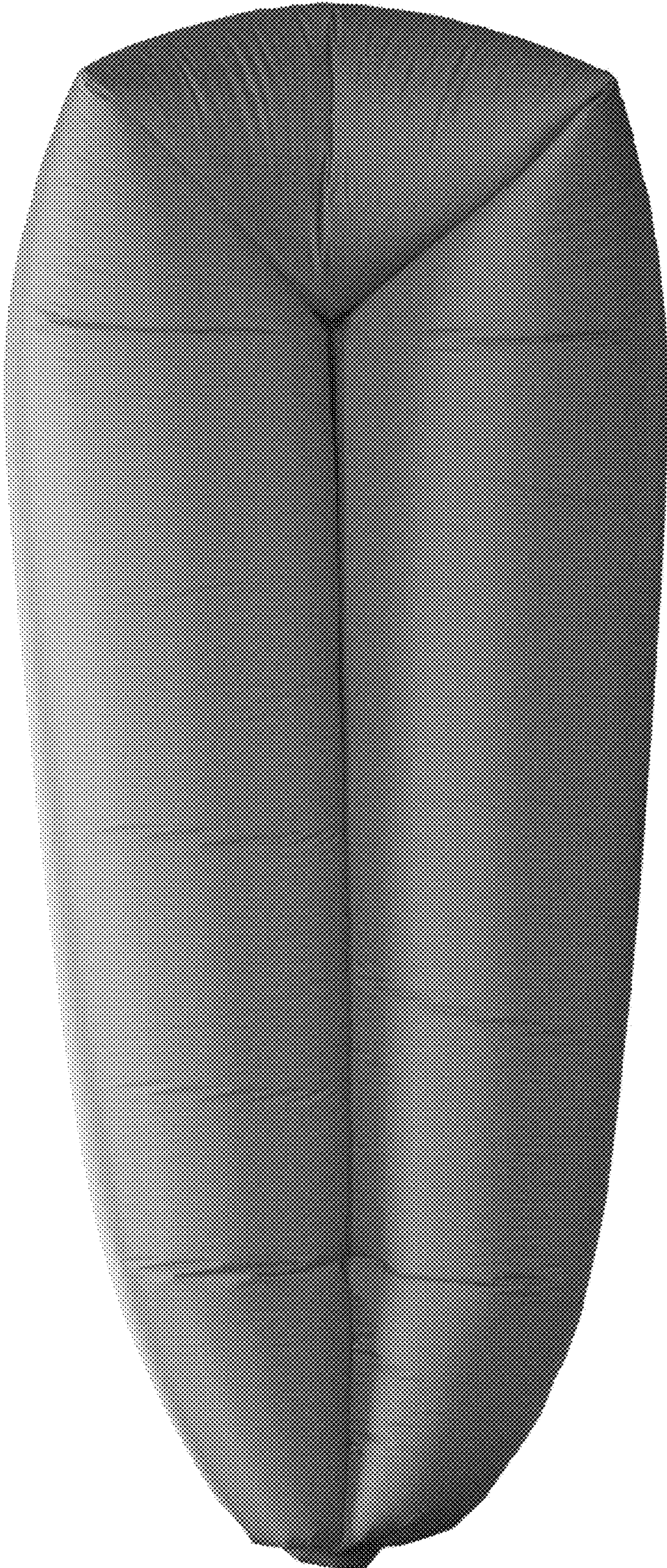

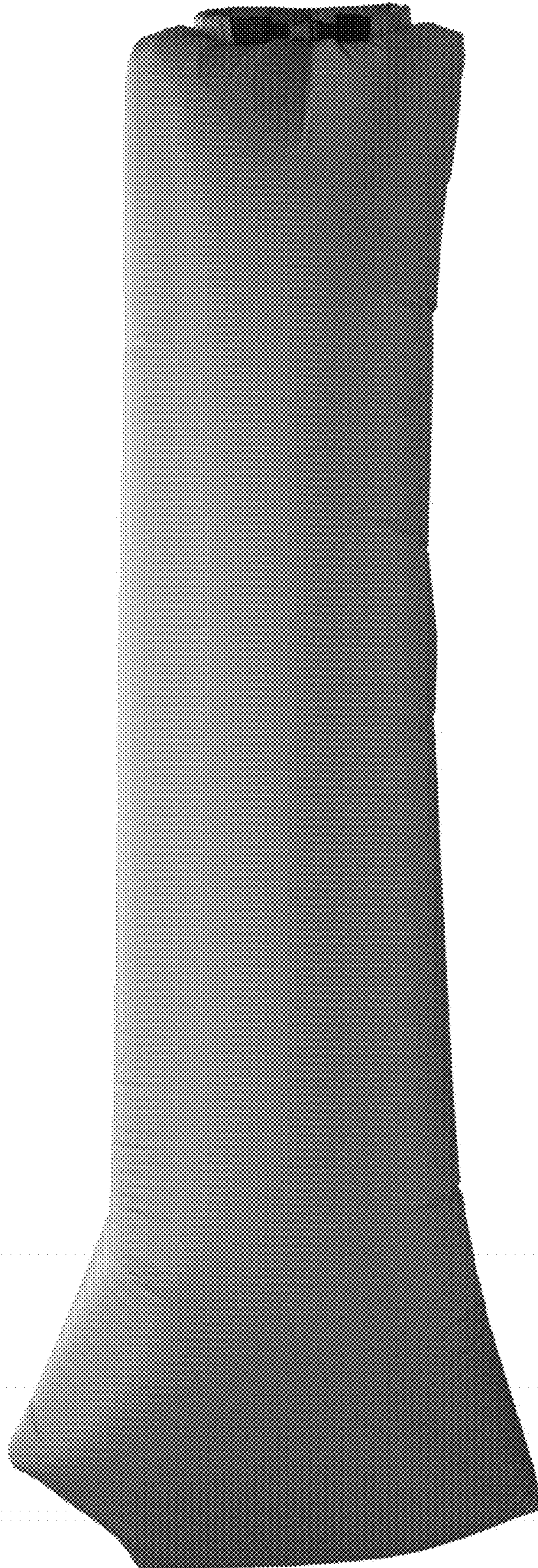

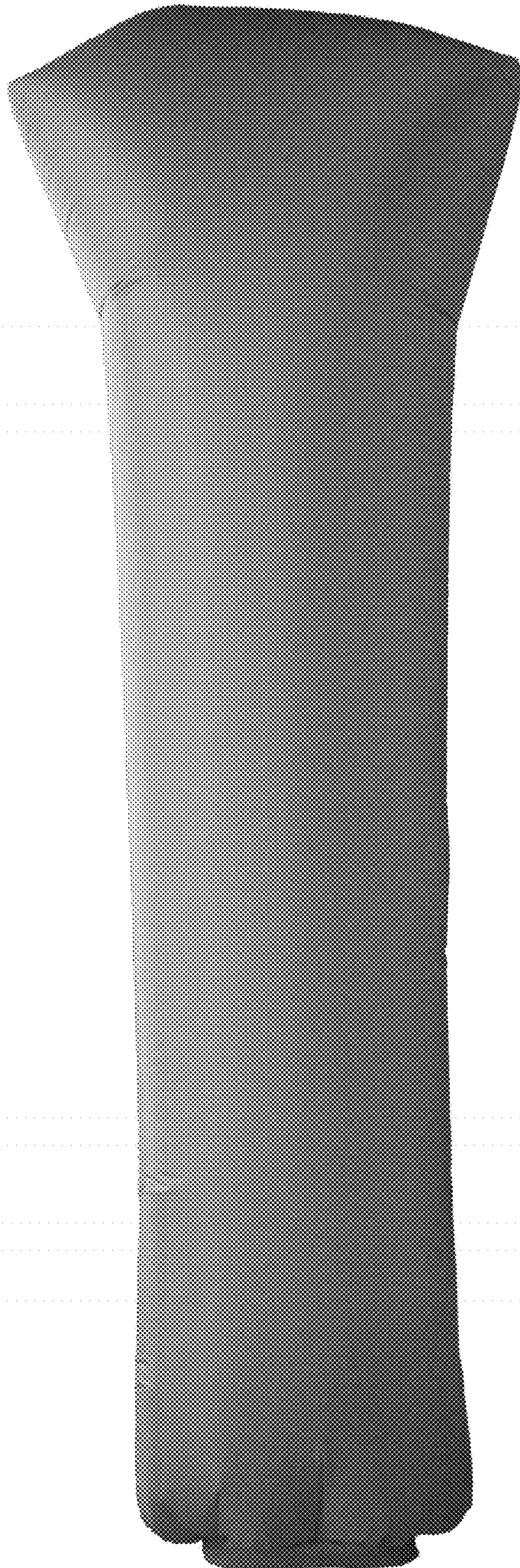
