FIG. 5 is a right side view of the blade guard of FIG. 1;

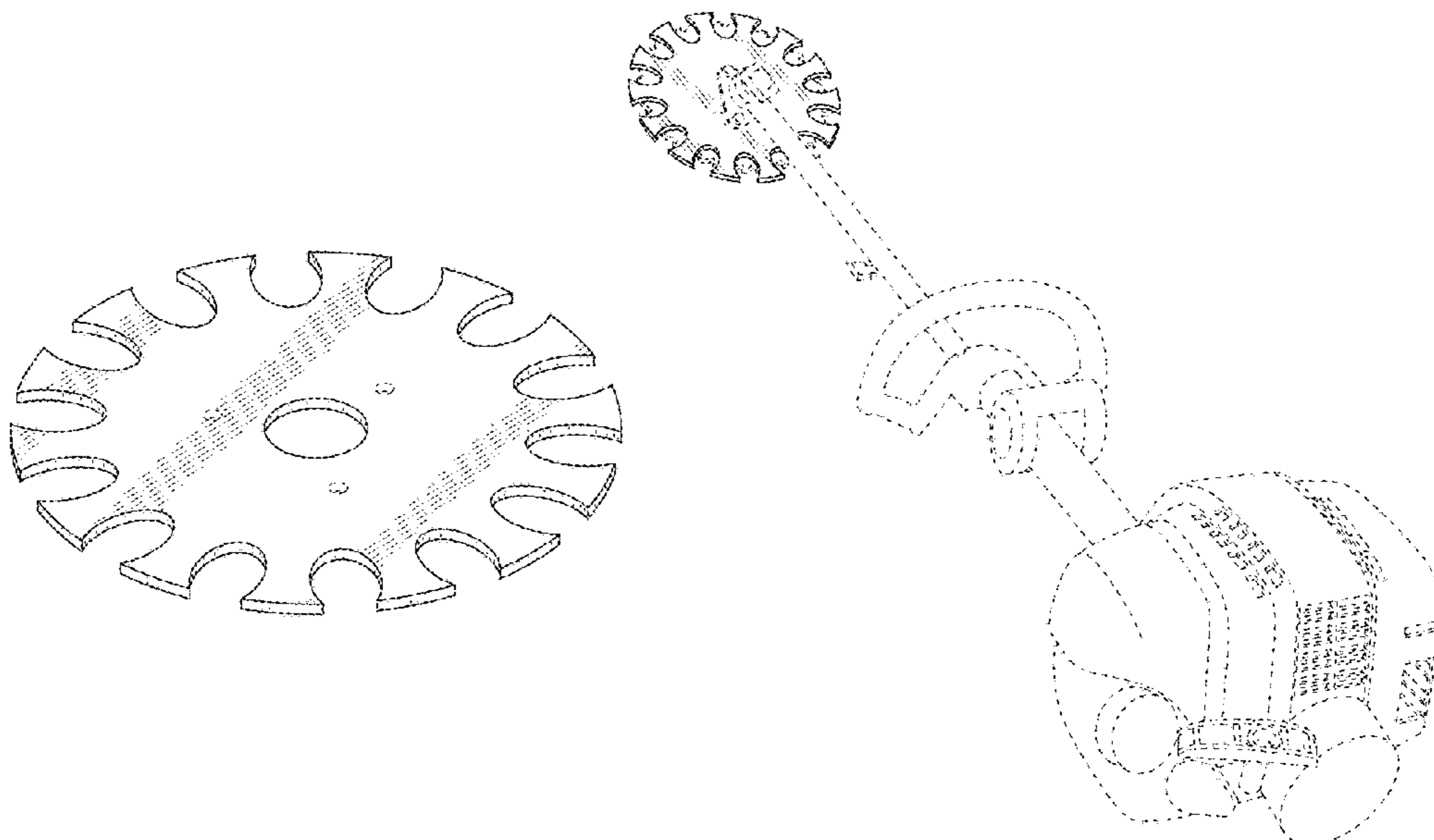
FIG. 6 is a top view of the blade guard of FIG. 1;

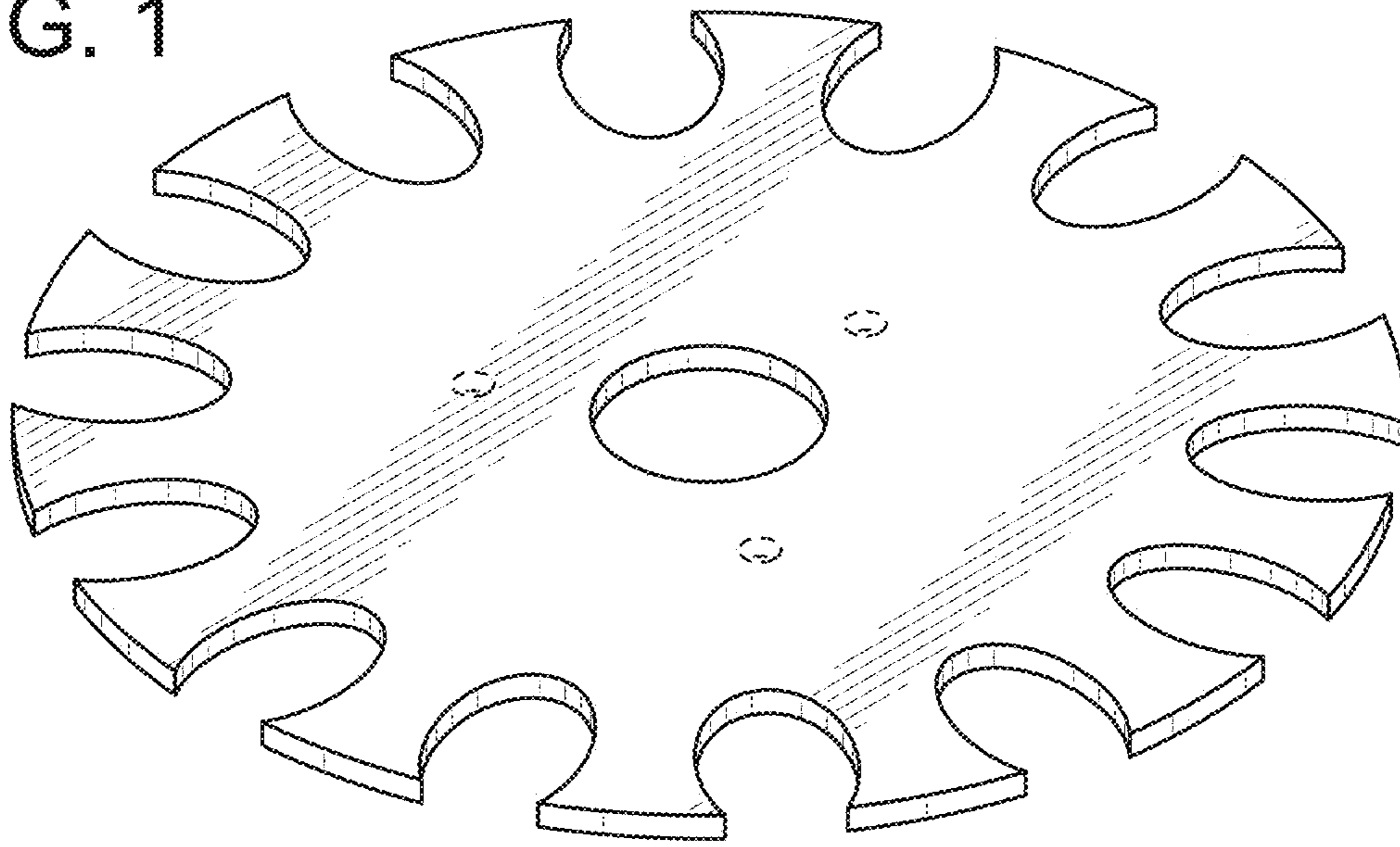

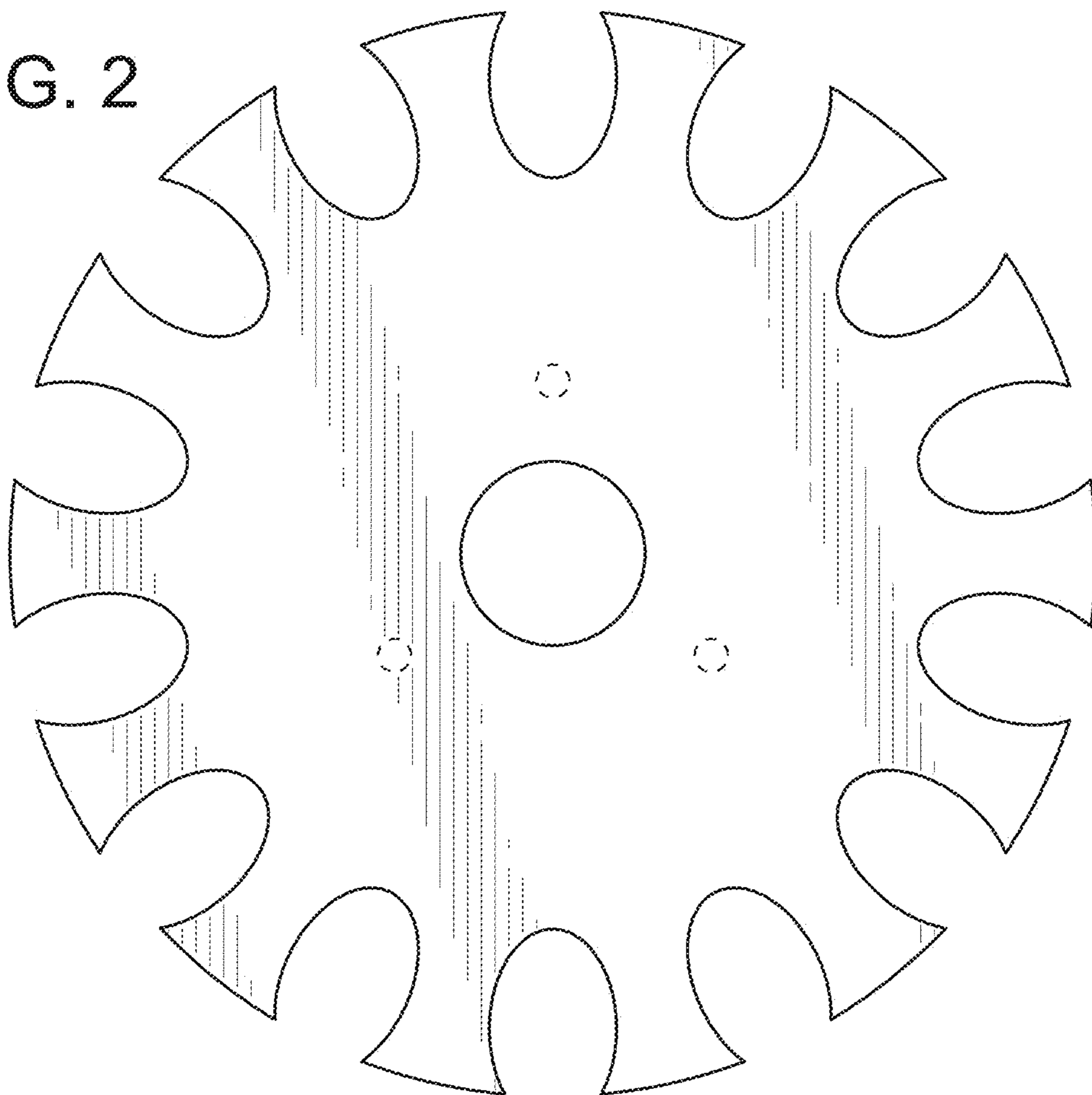

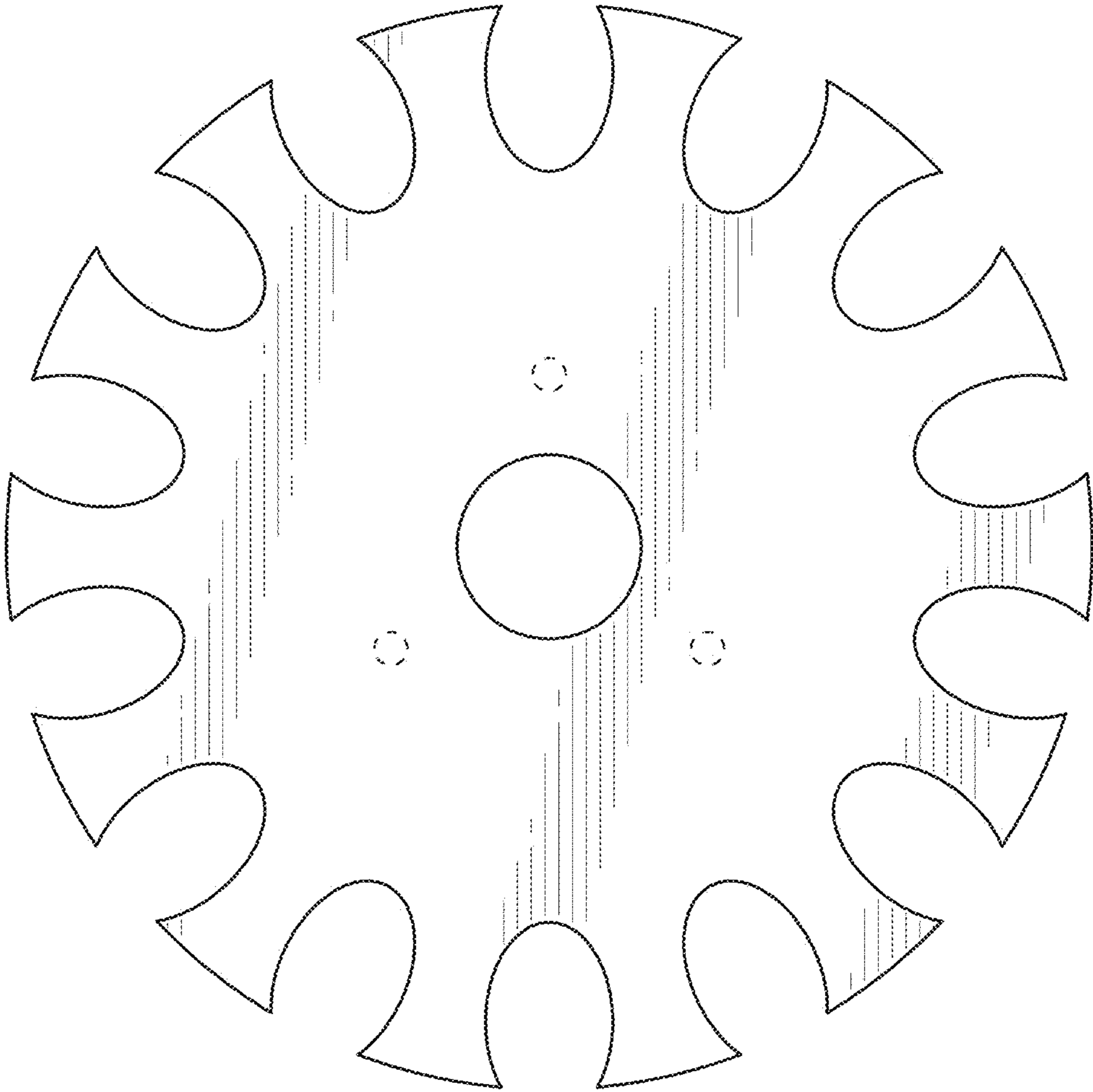

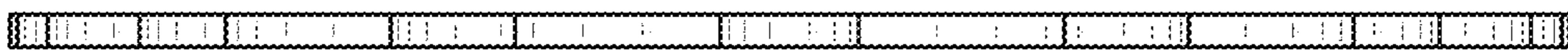

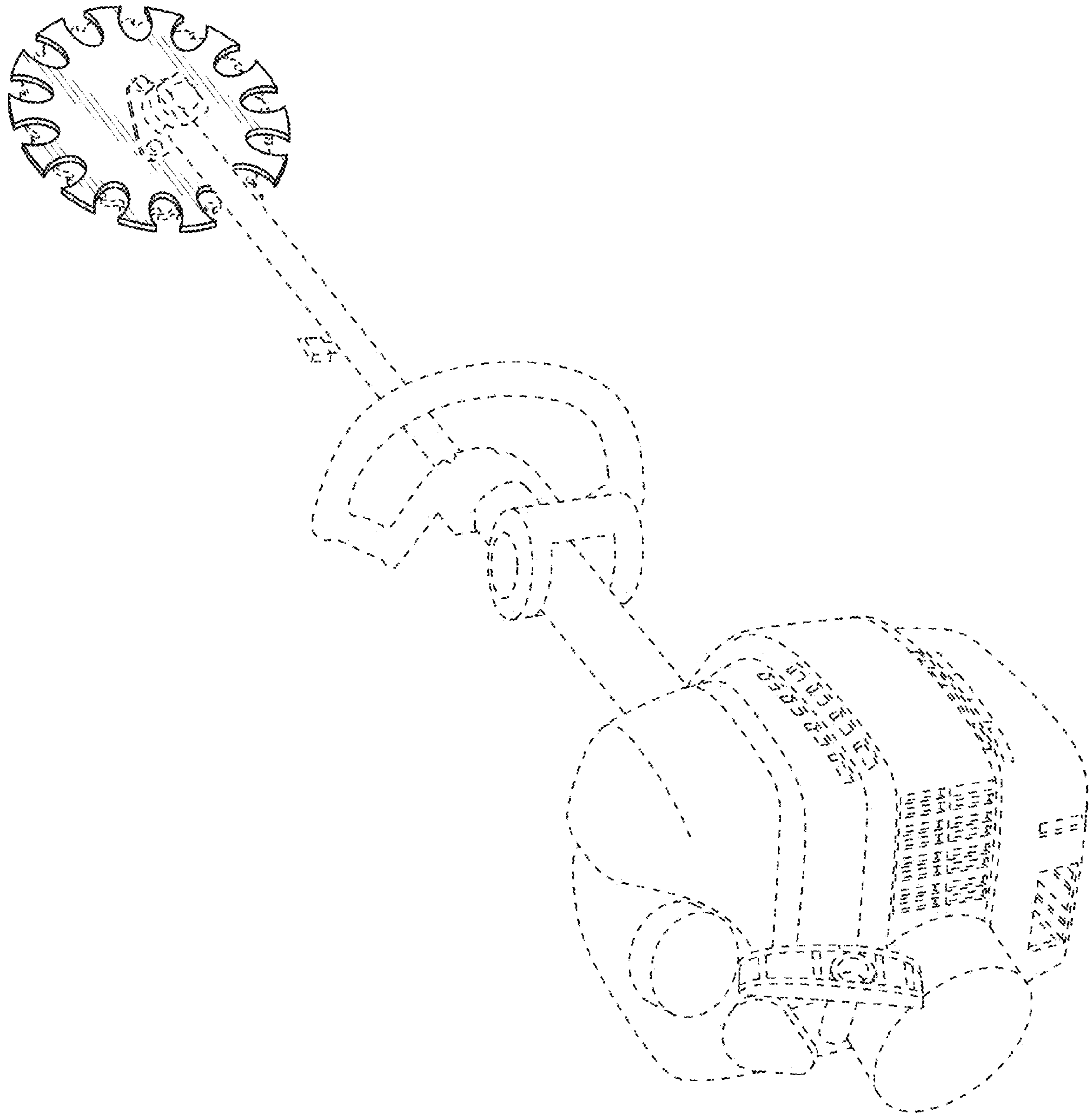
