FIG. 3 is a Back view Thereof;

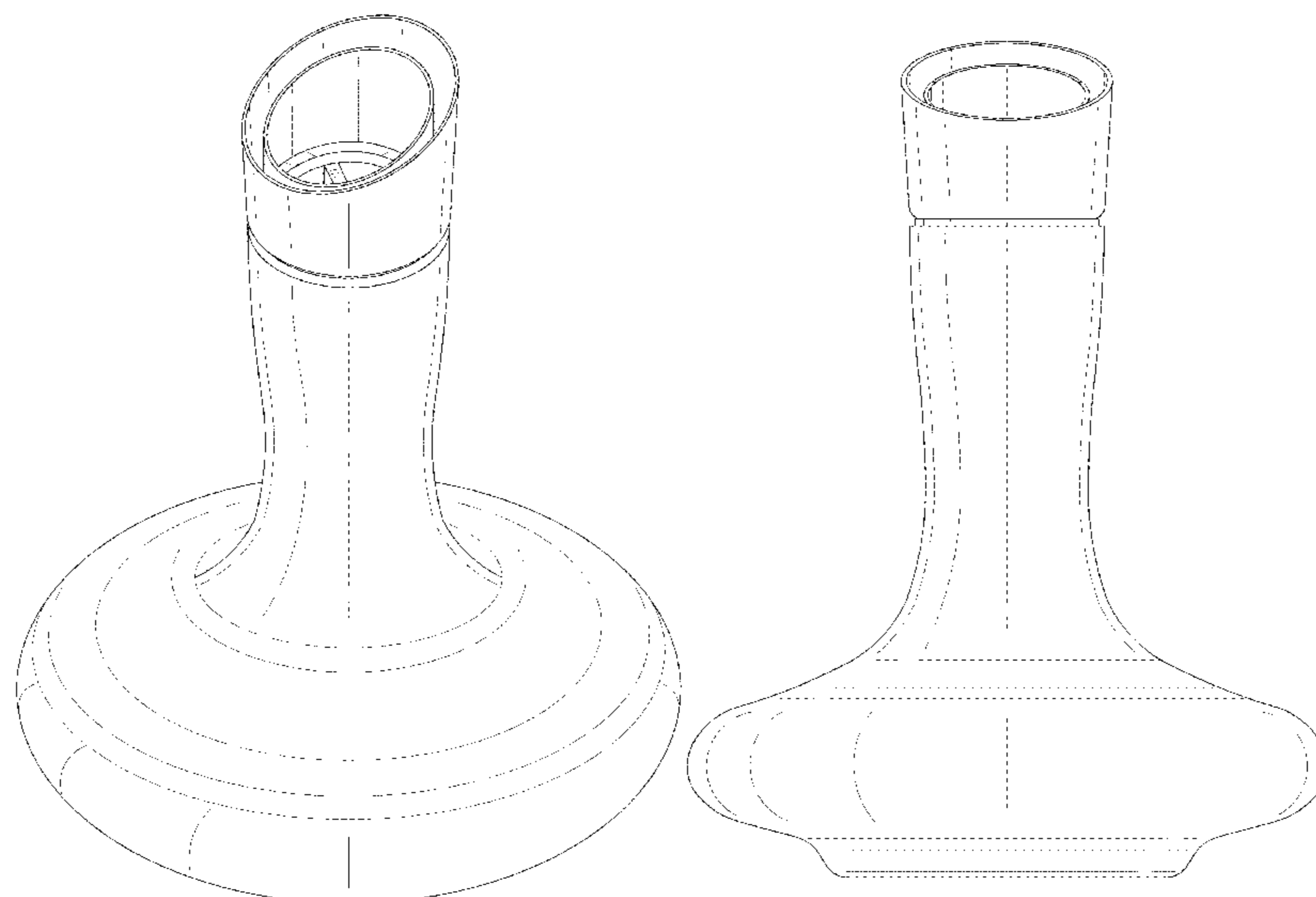
FIG. 4 is a Right-side view Thereof;

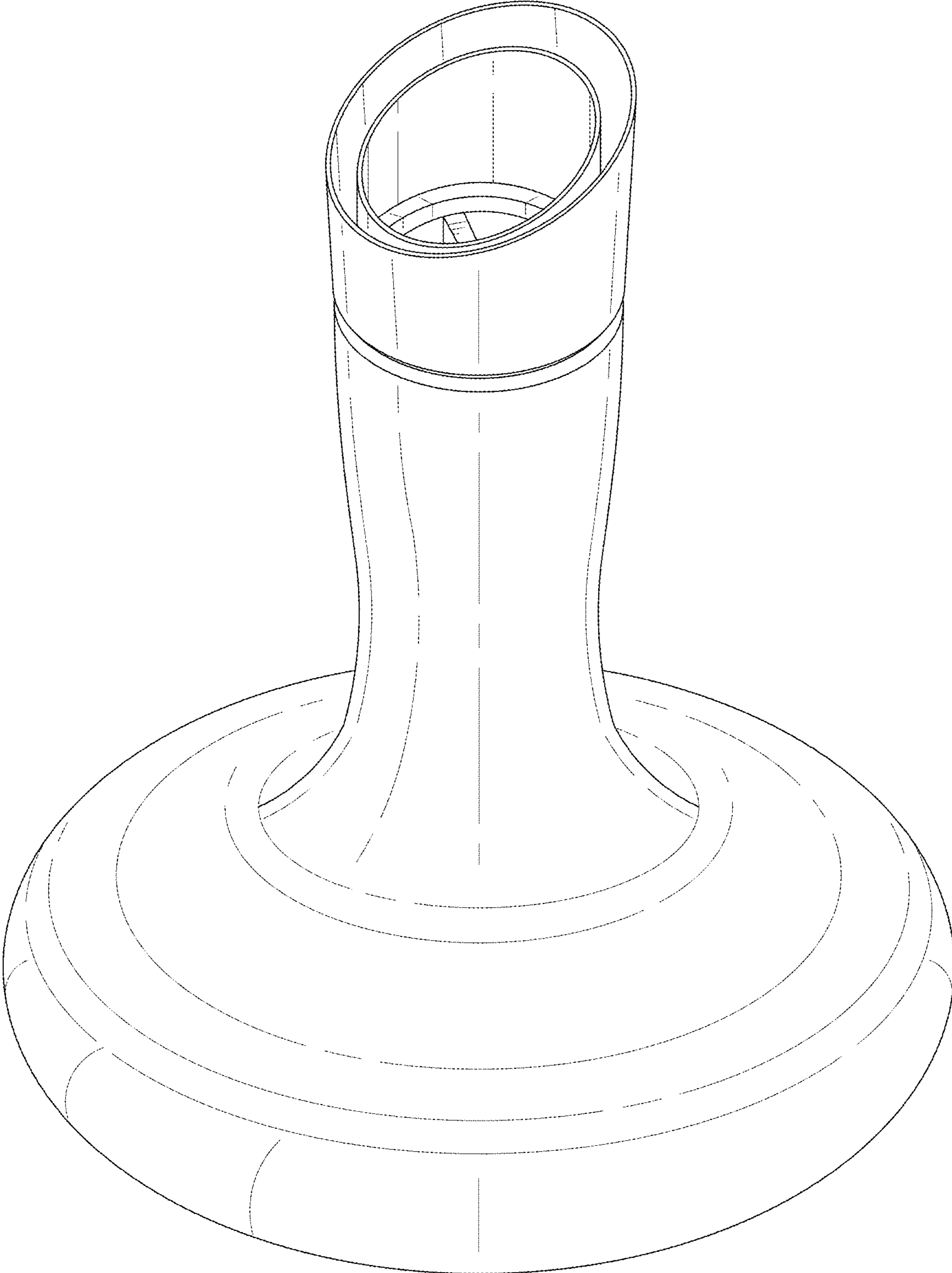

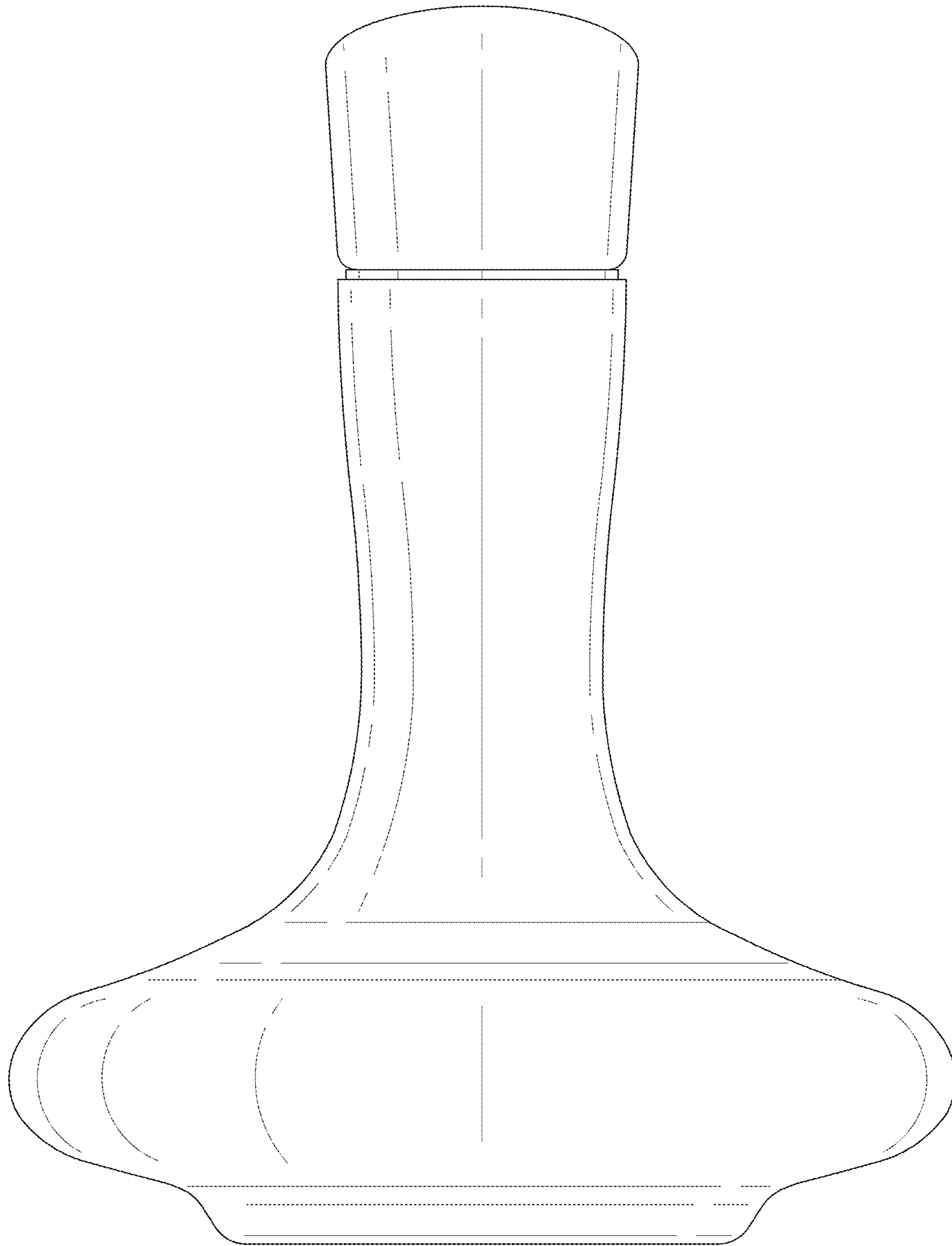

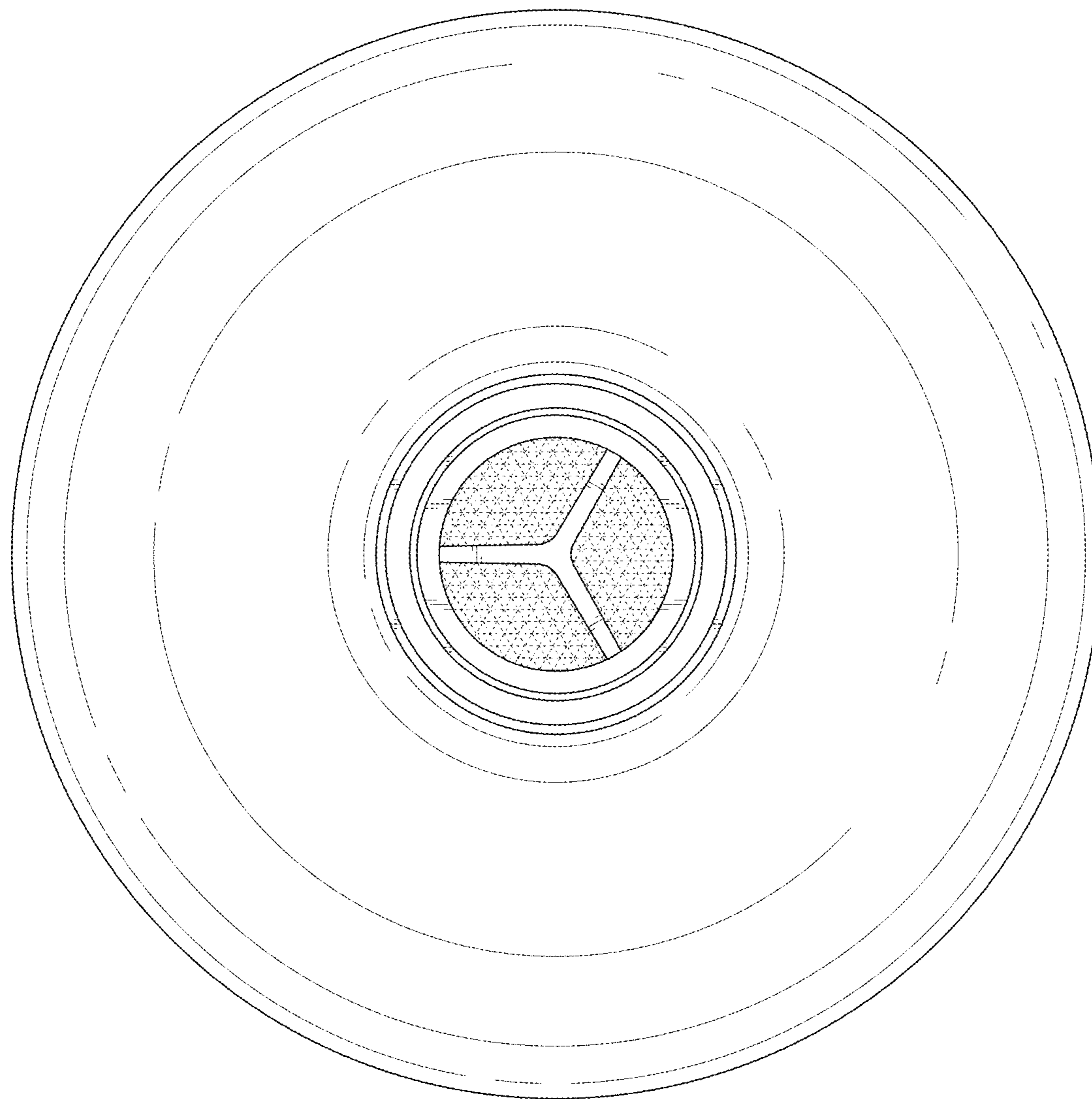

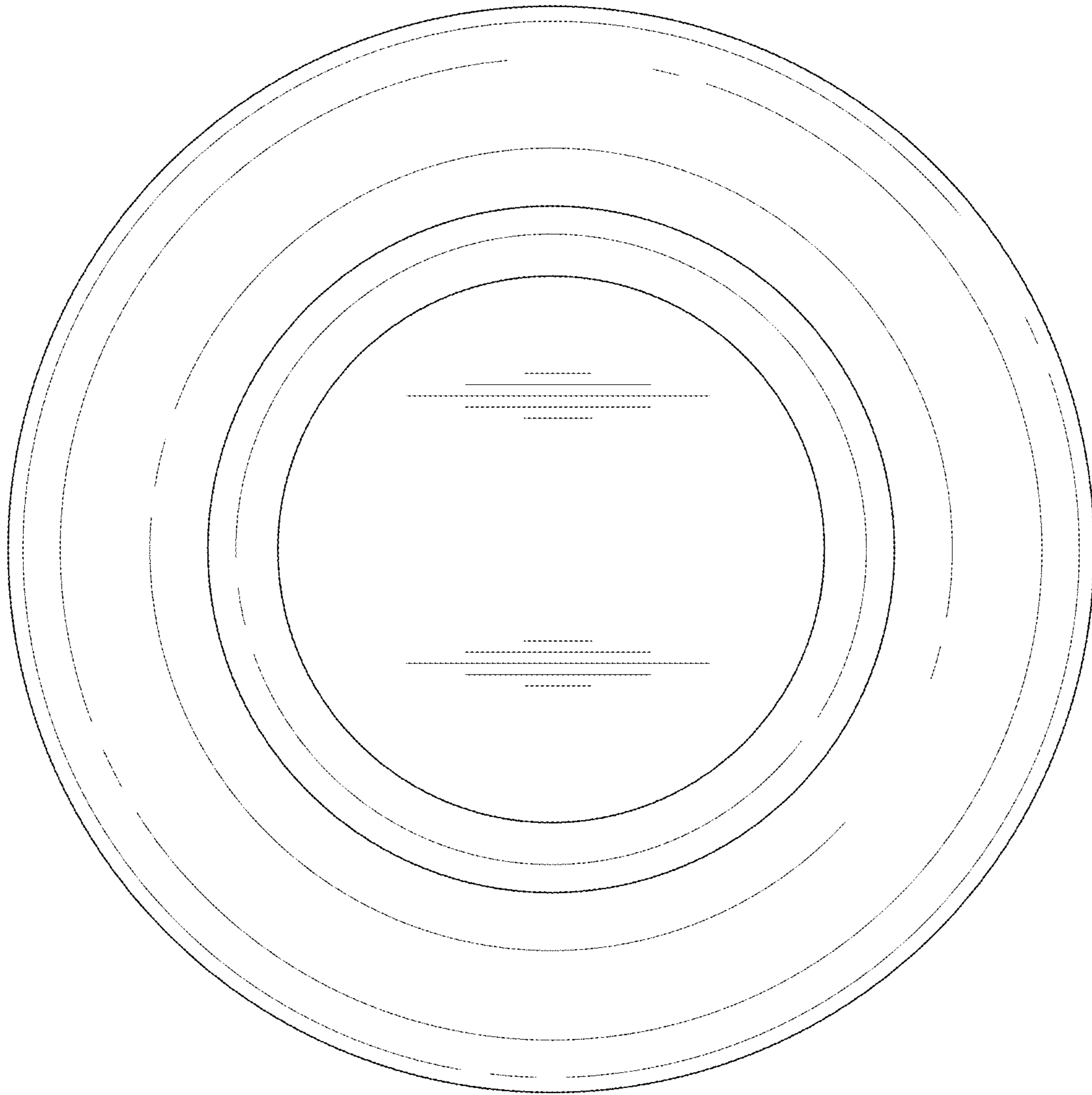
