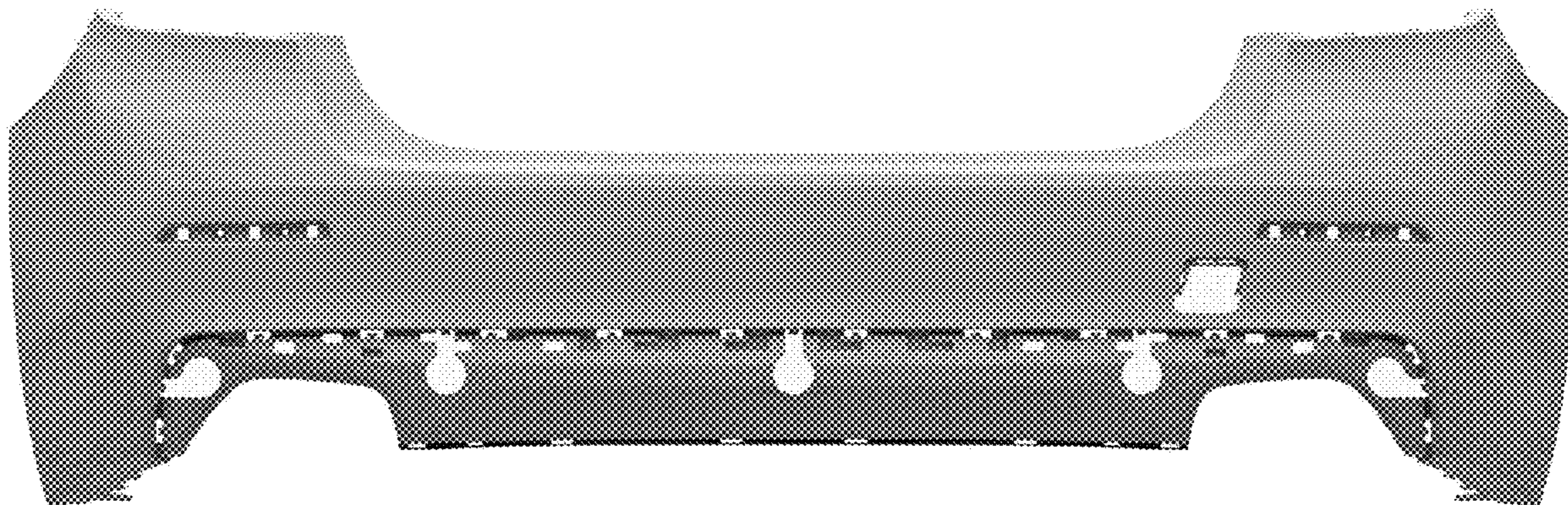

DESCRIPTION

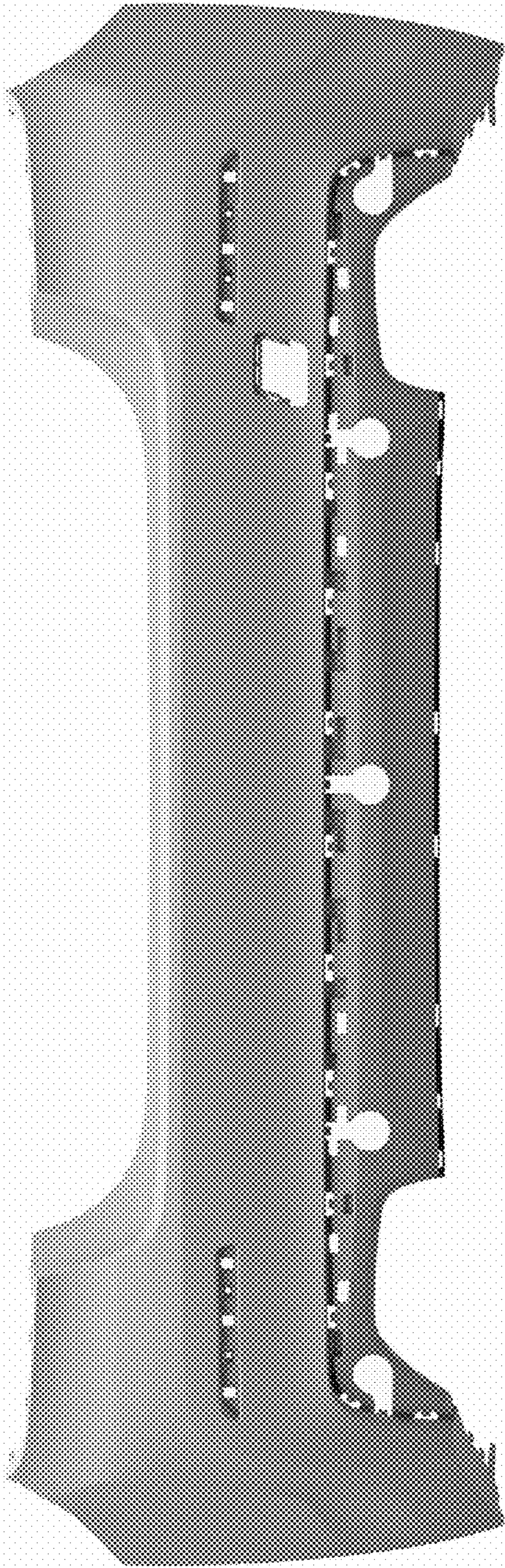

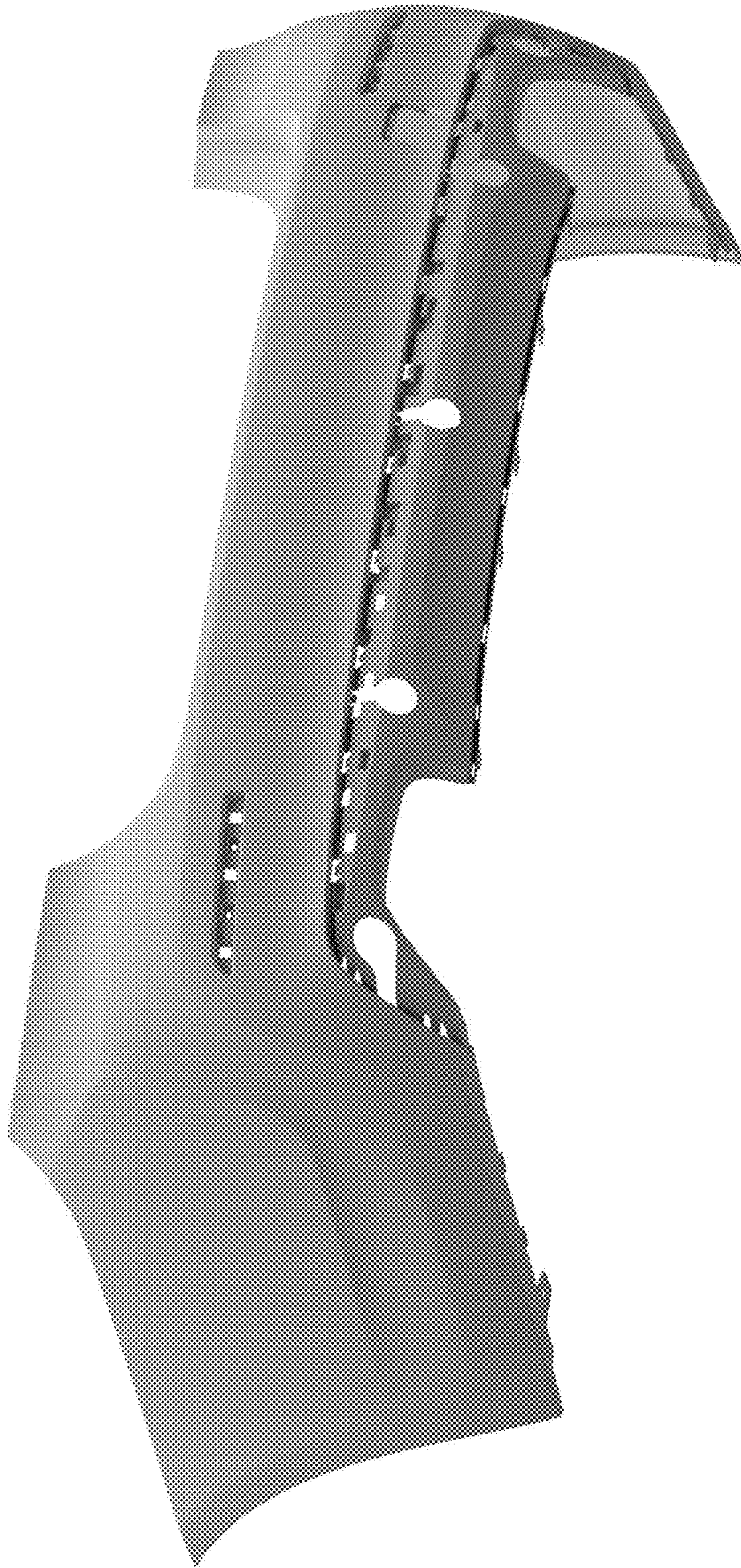

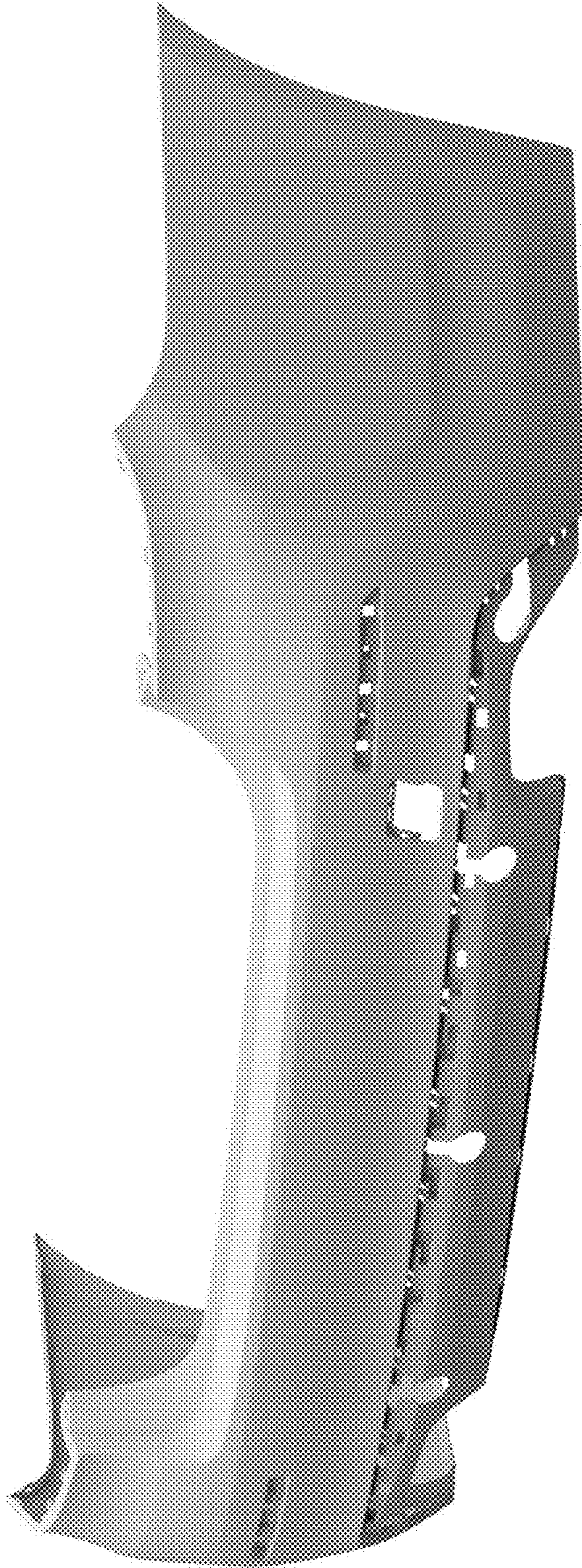

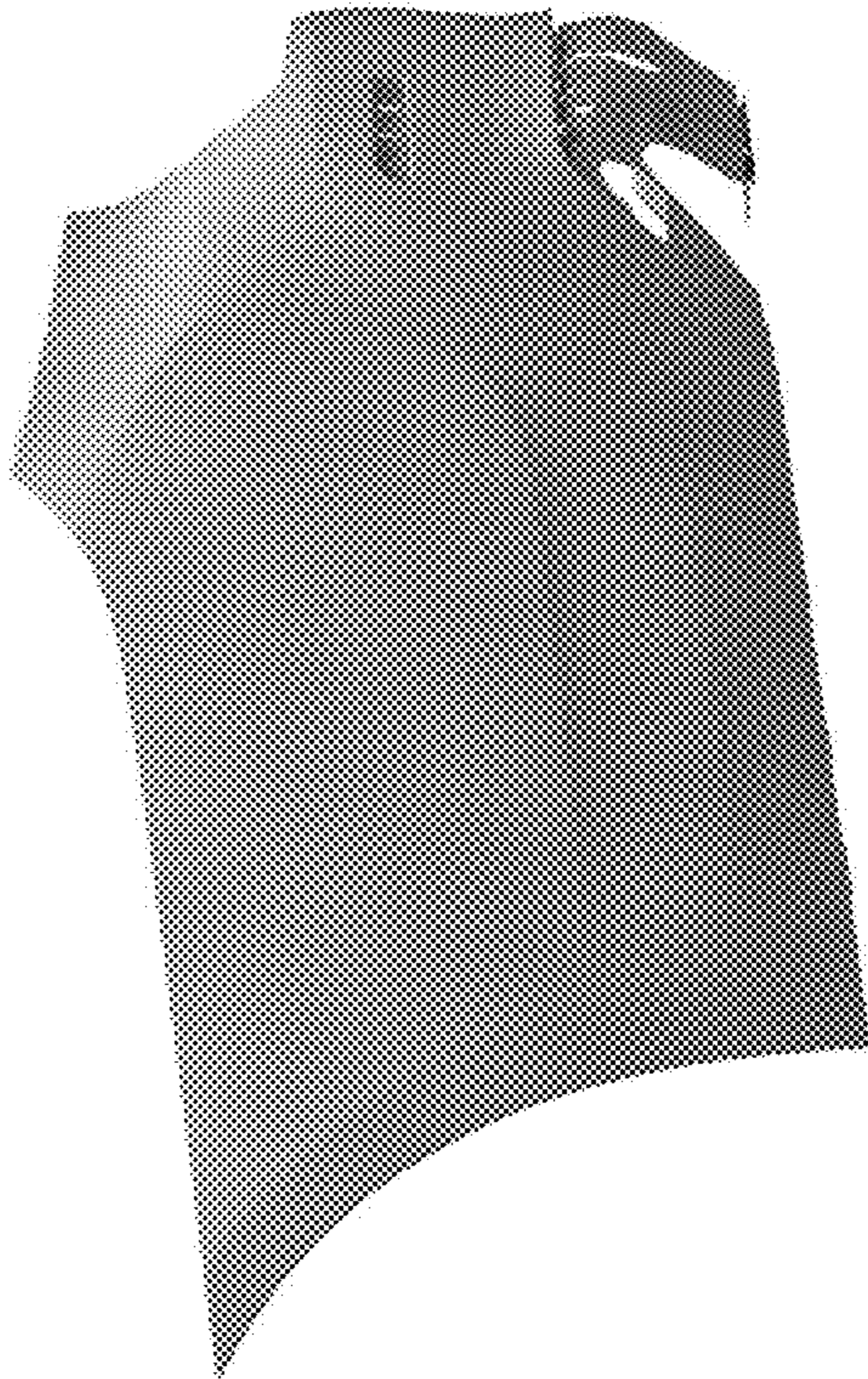

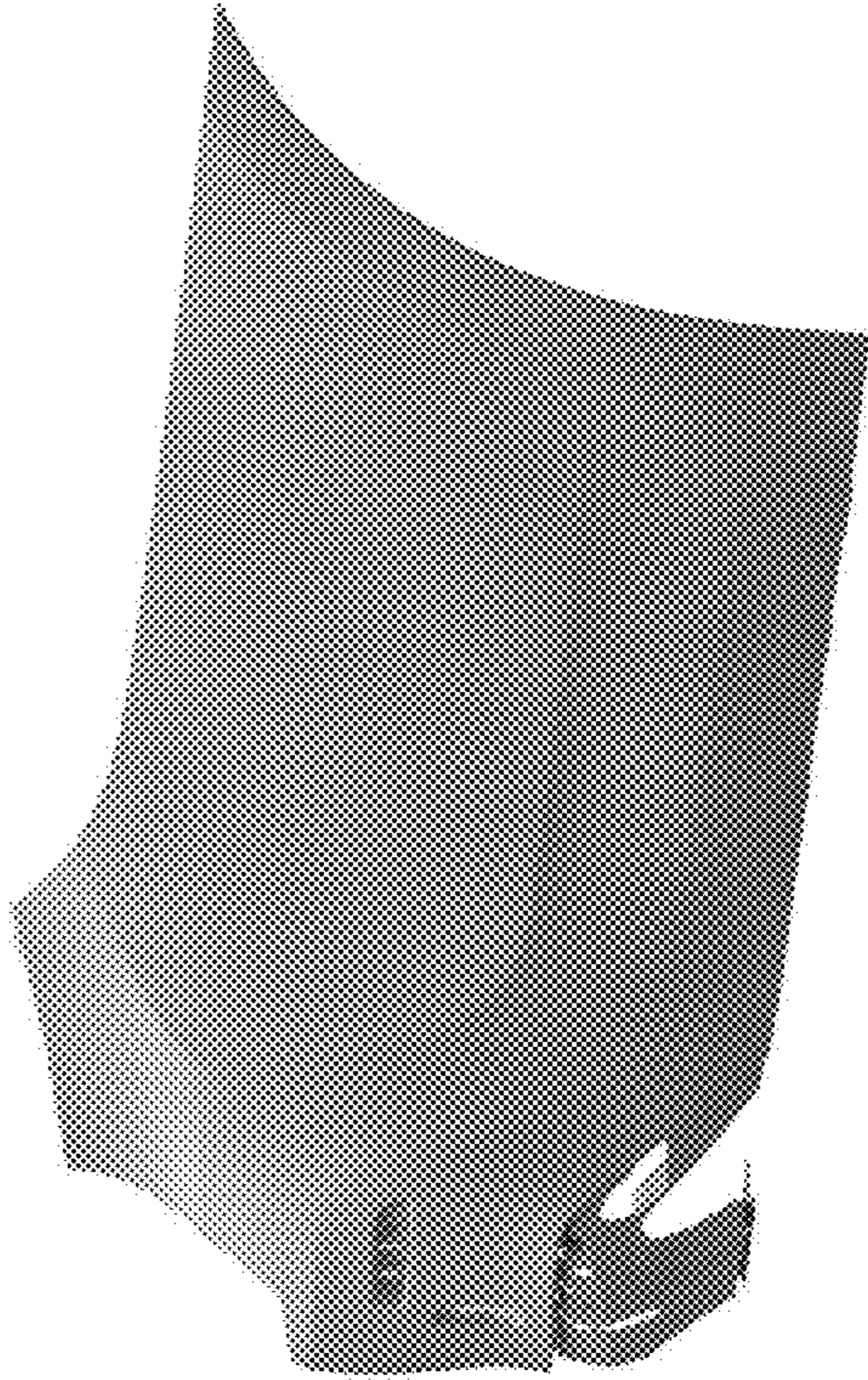

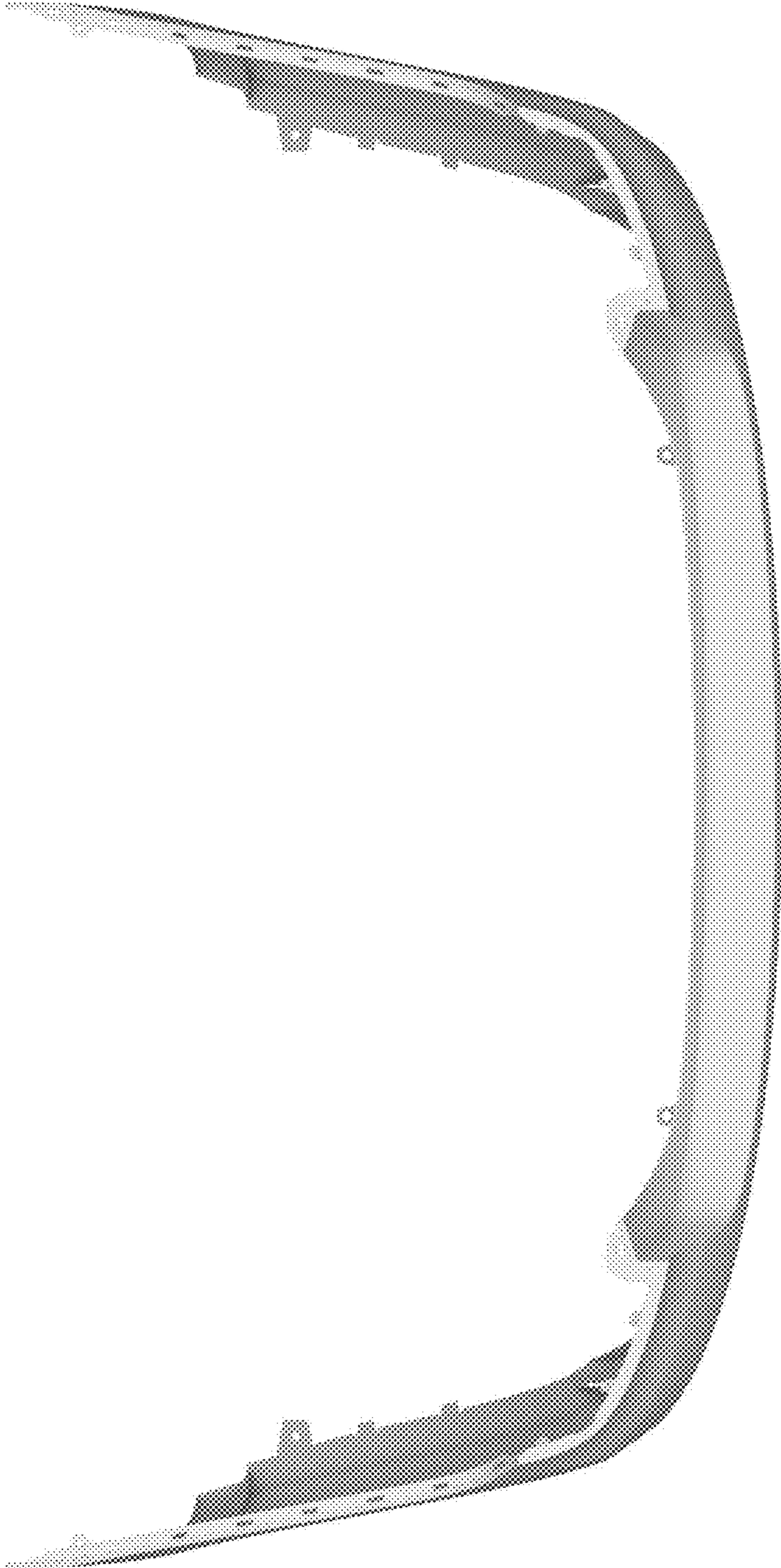

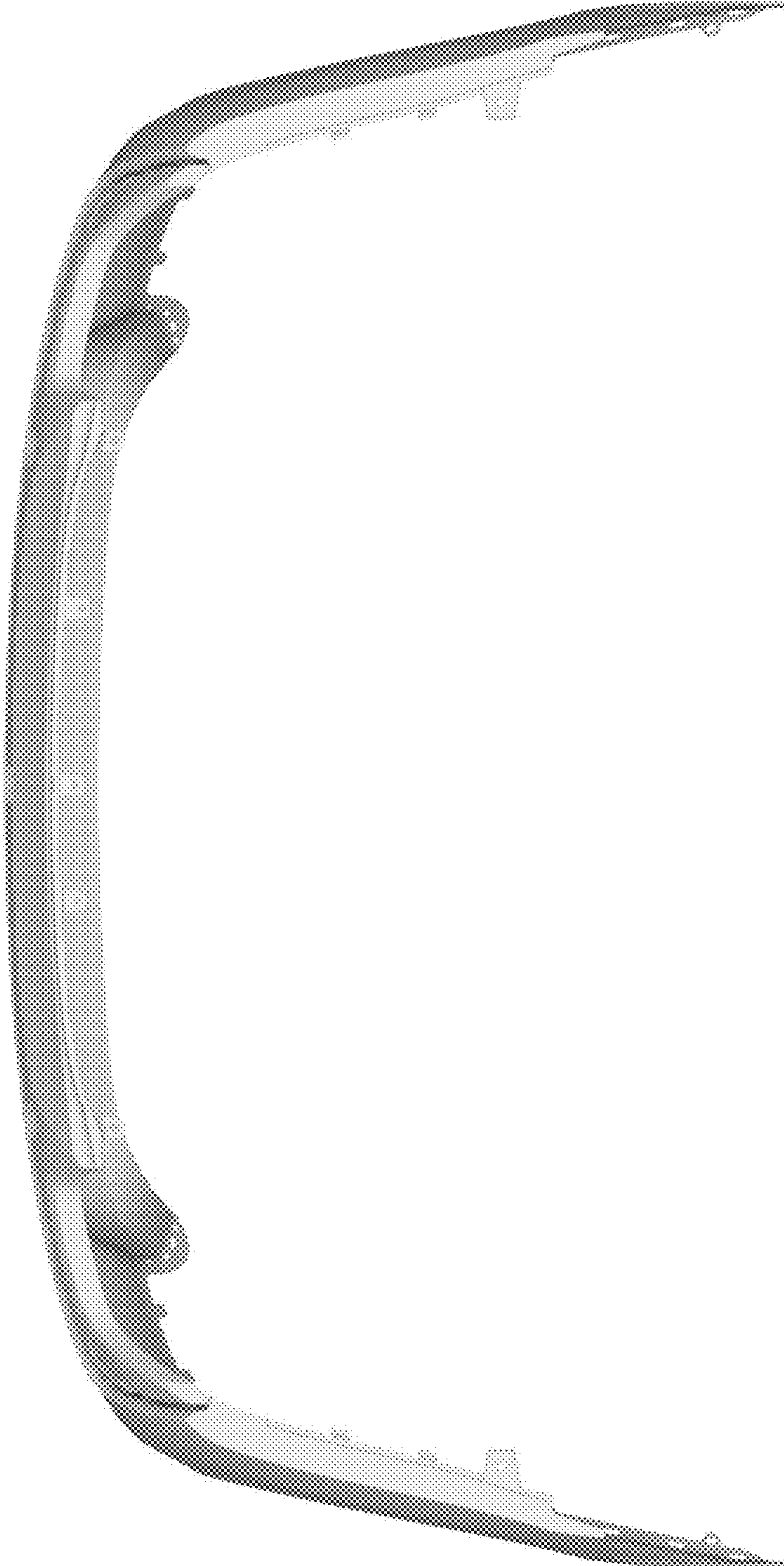

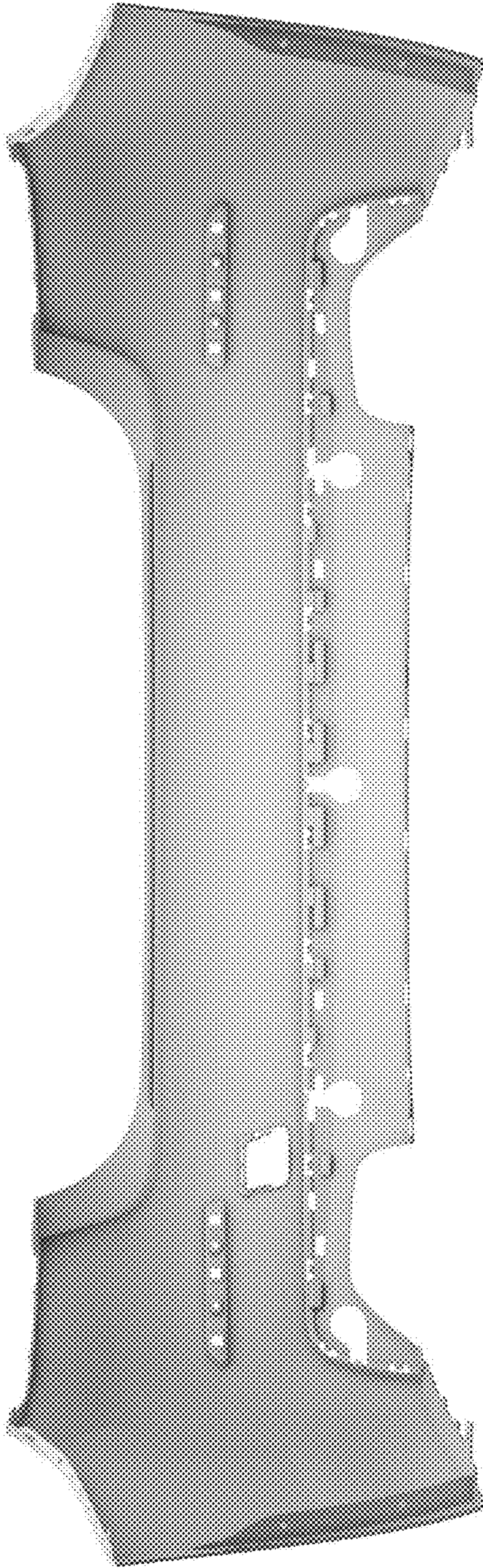
