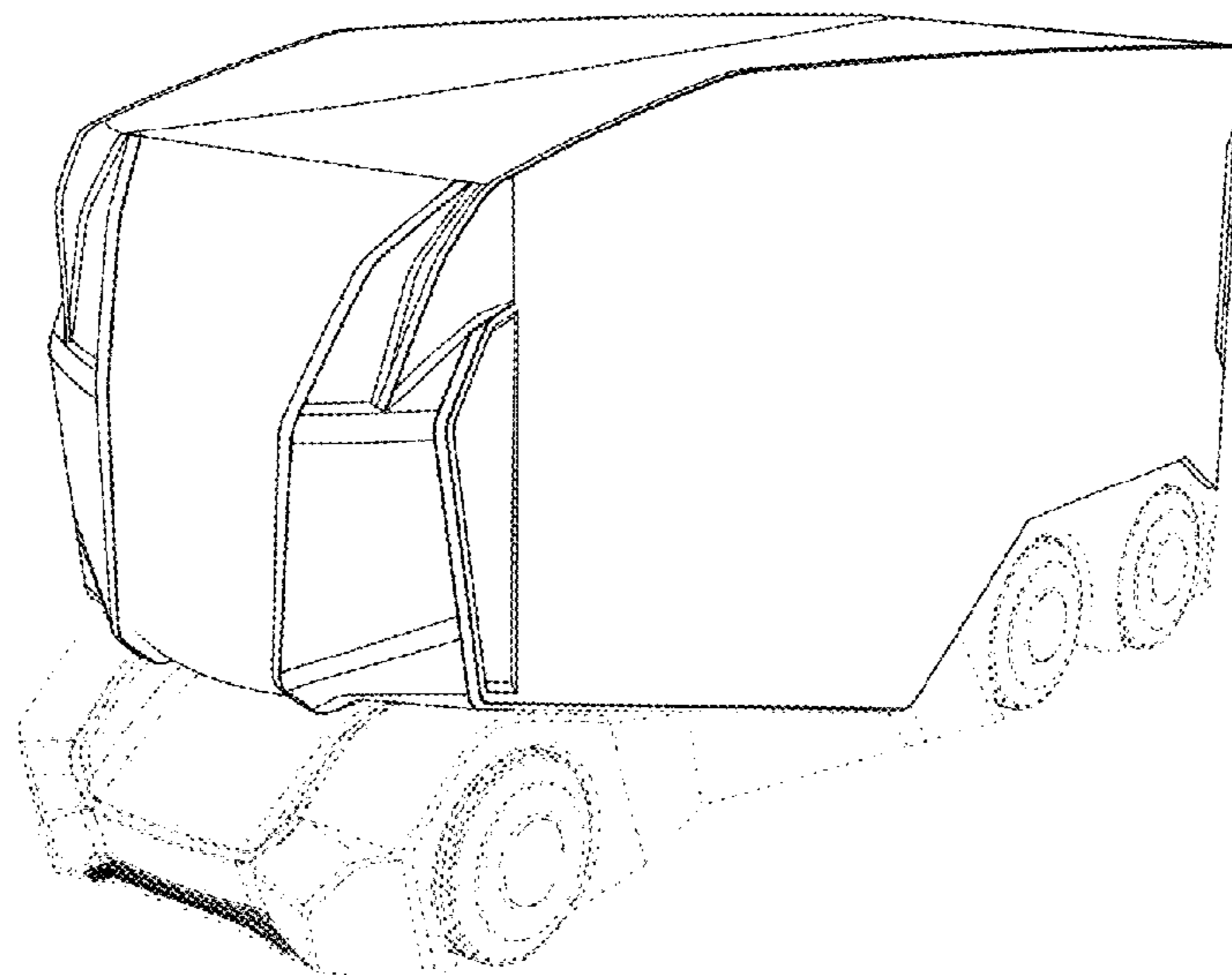
(57) **CLAIM**

I claim the ornamental design for a part of a vehicle, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a perspective view of a part of a vehicle;  
 FIG. 2 is a front plan view thereof;  
 FIG. 3 is a right side elevational view thereof;  
 FIG. 4 is a left side elevational view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a rear elevational view thereof; and,

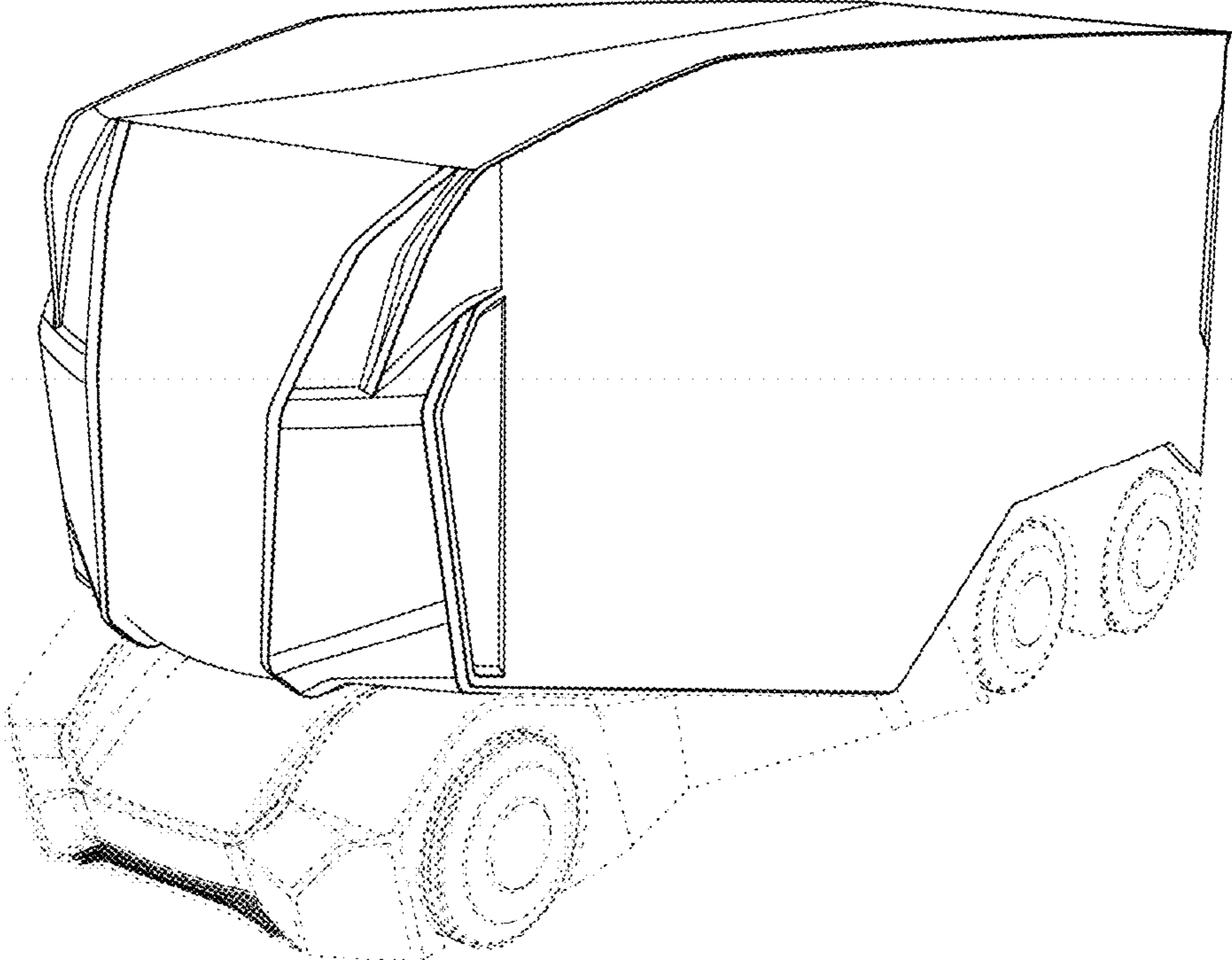

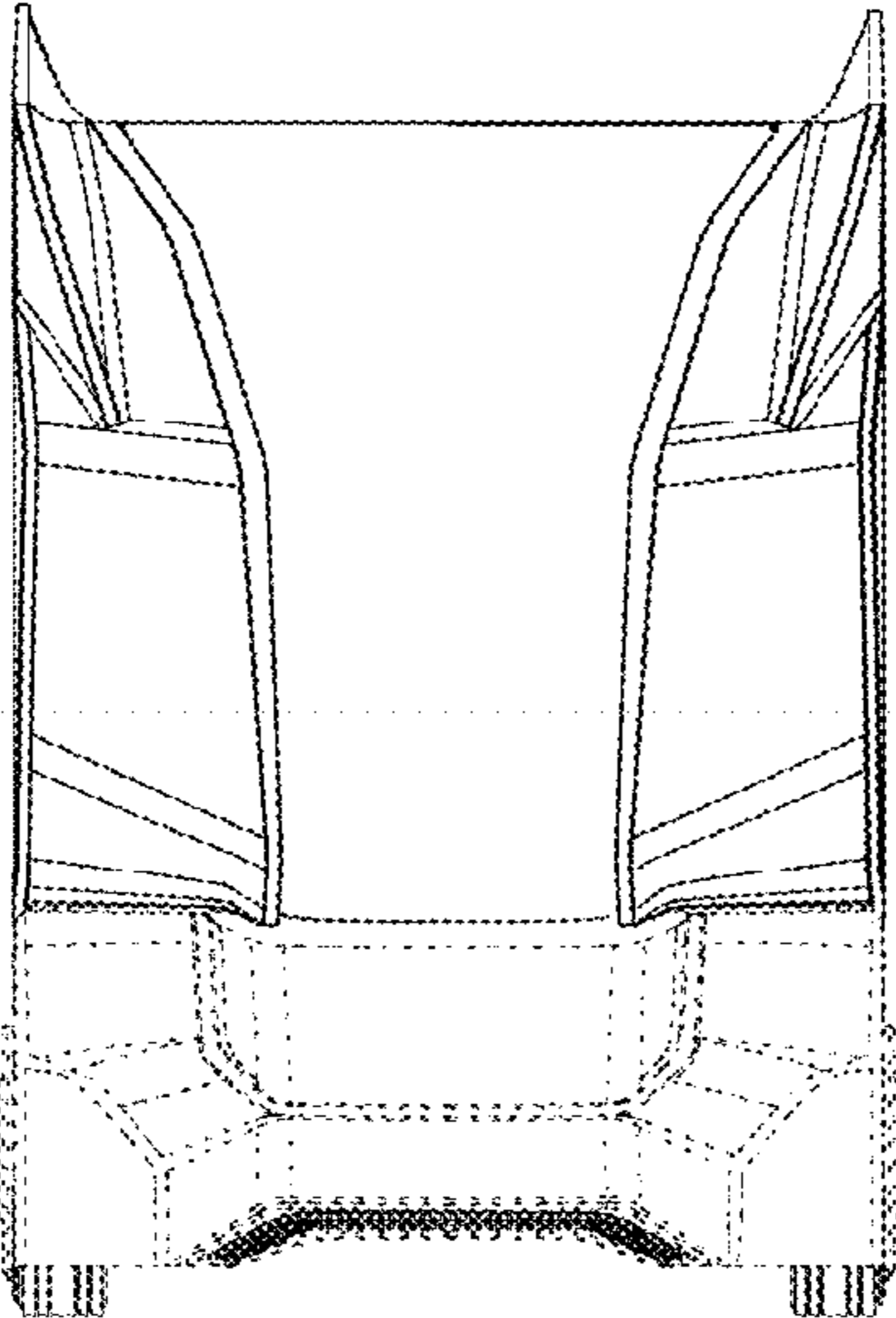

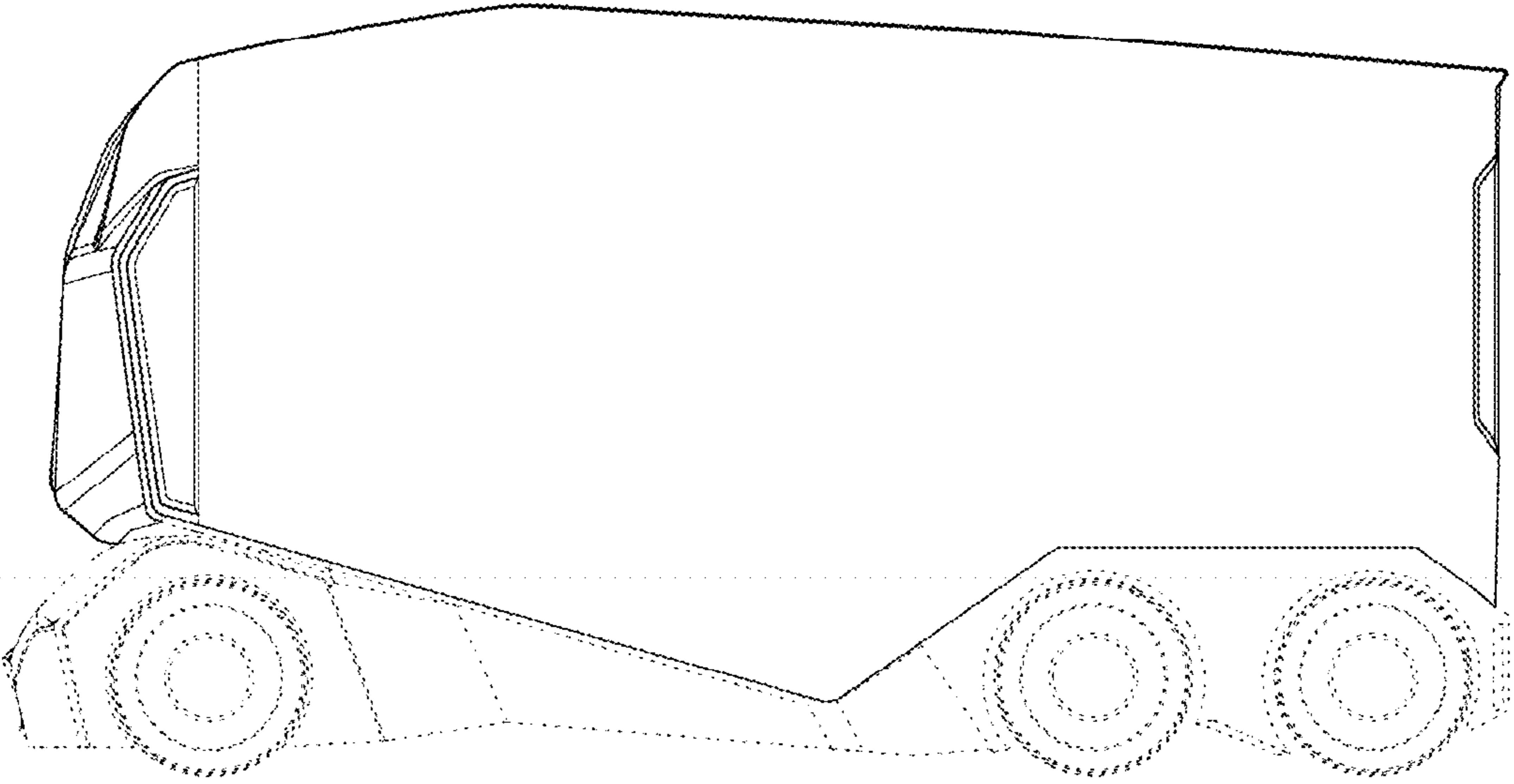

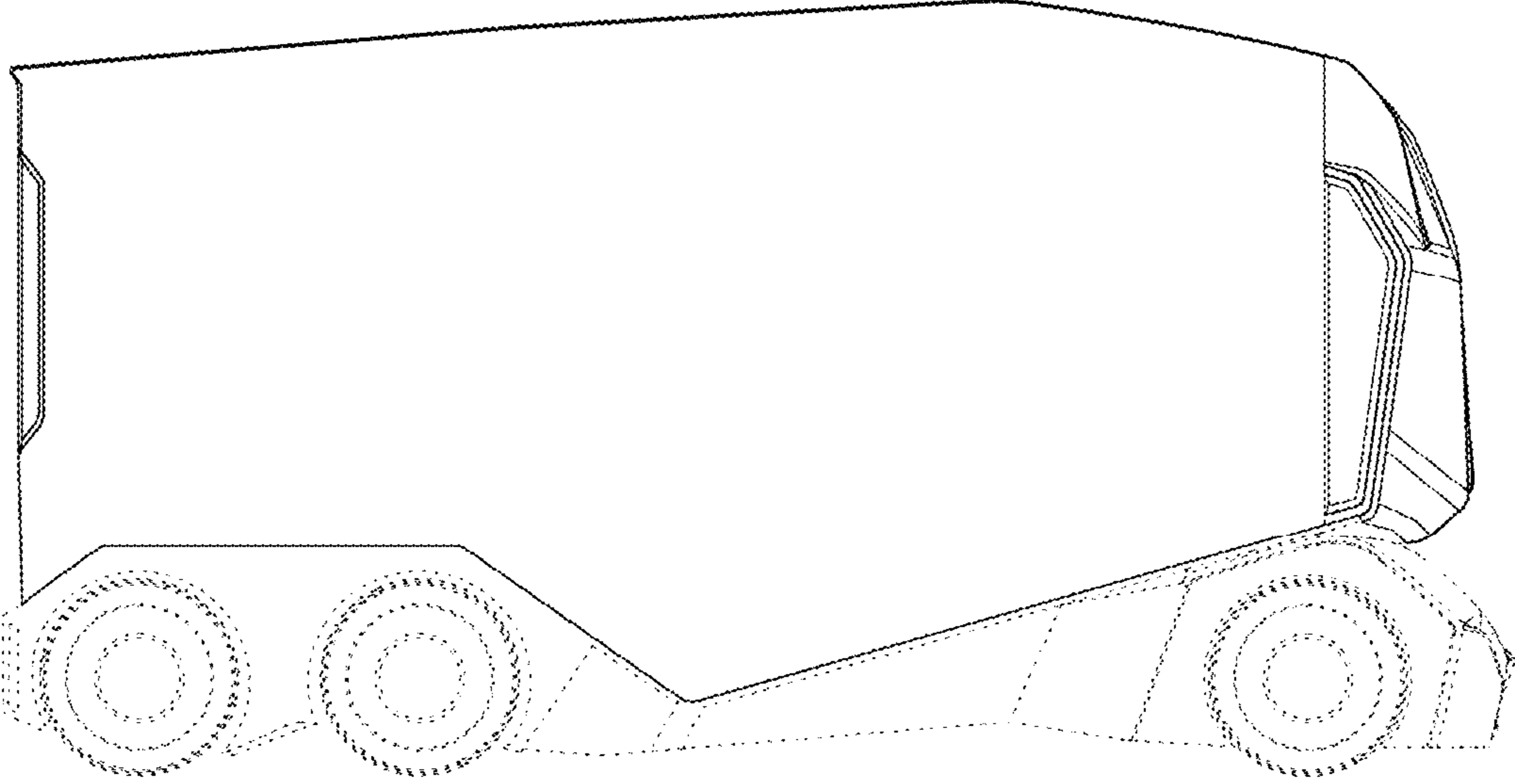

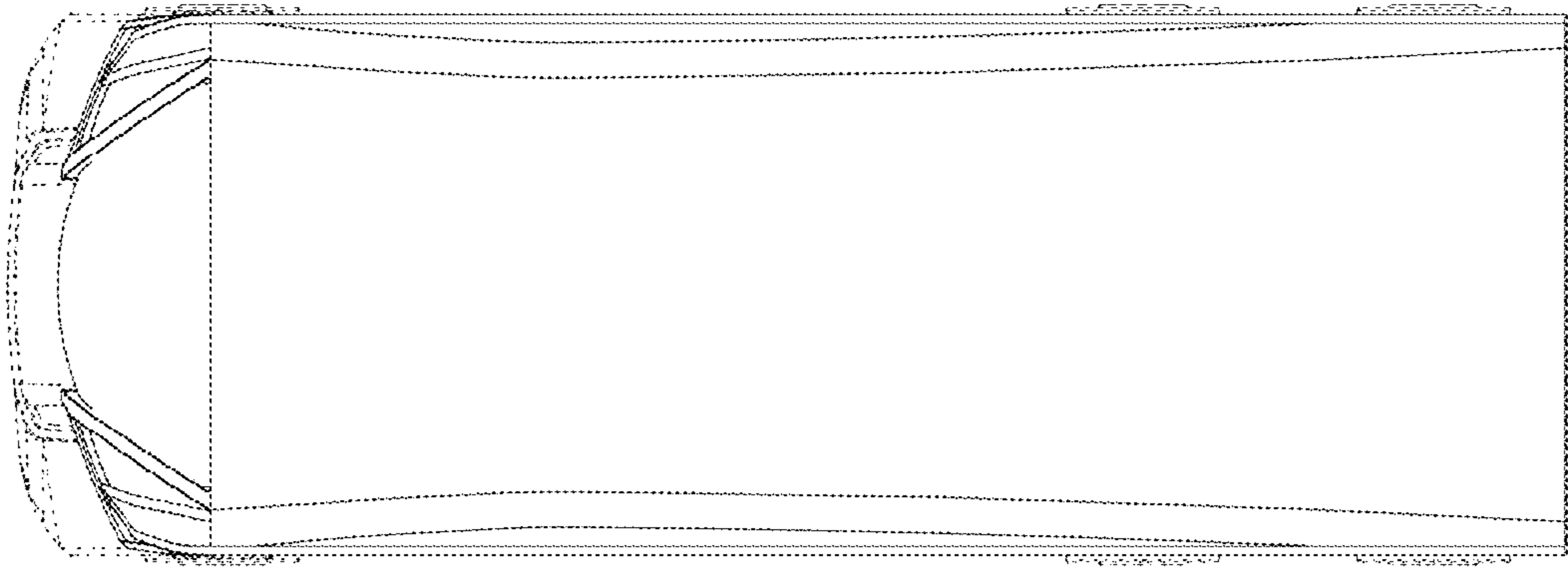

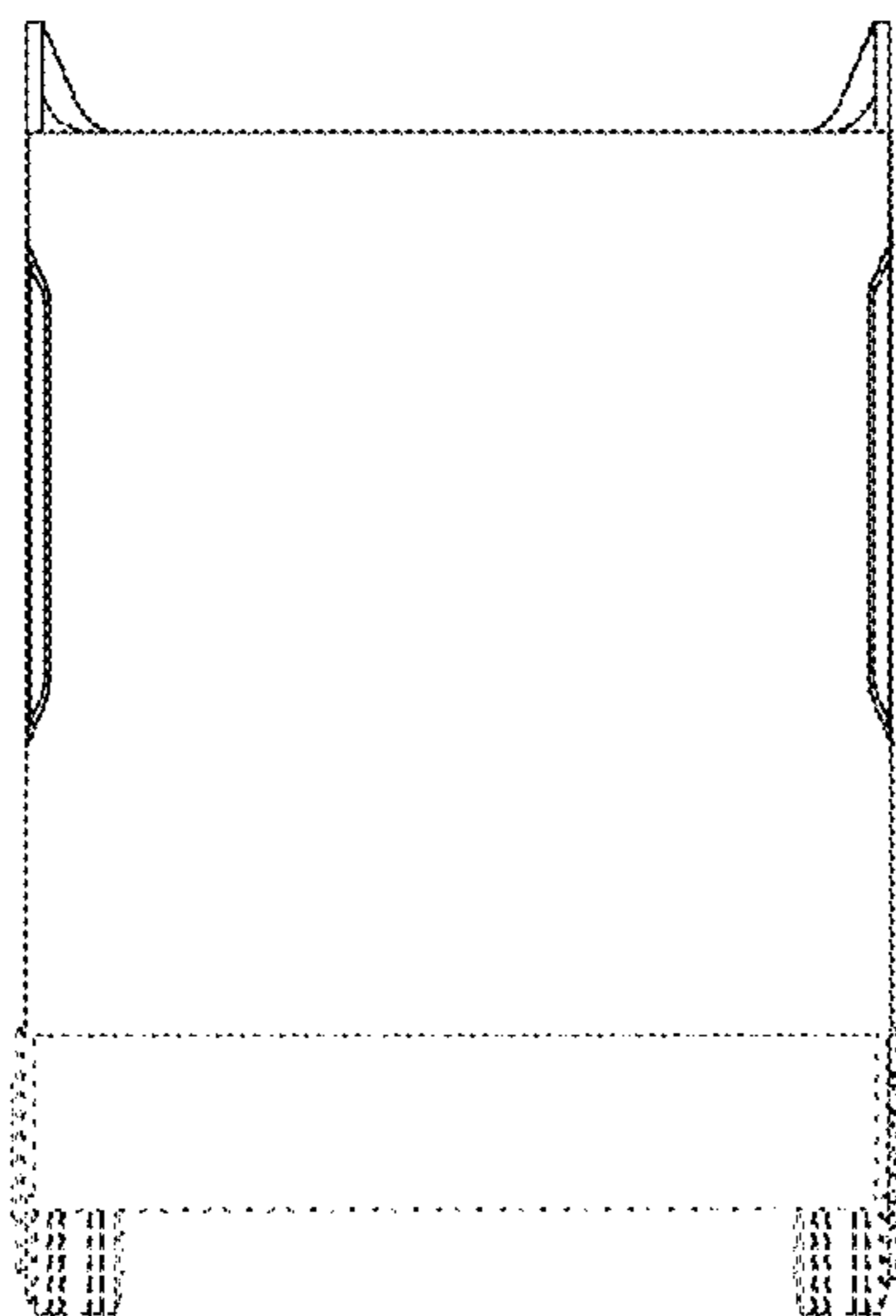

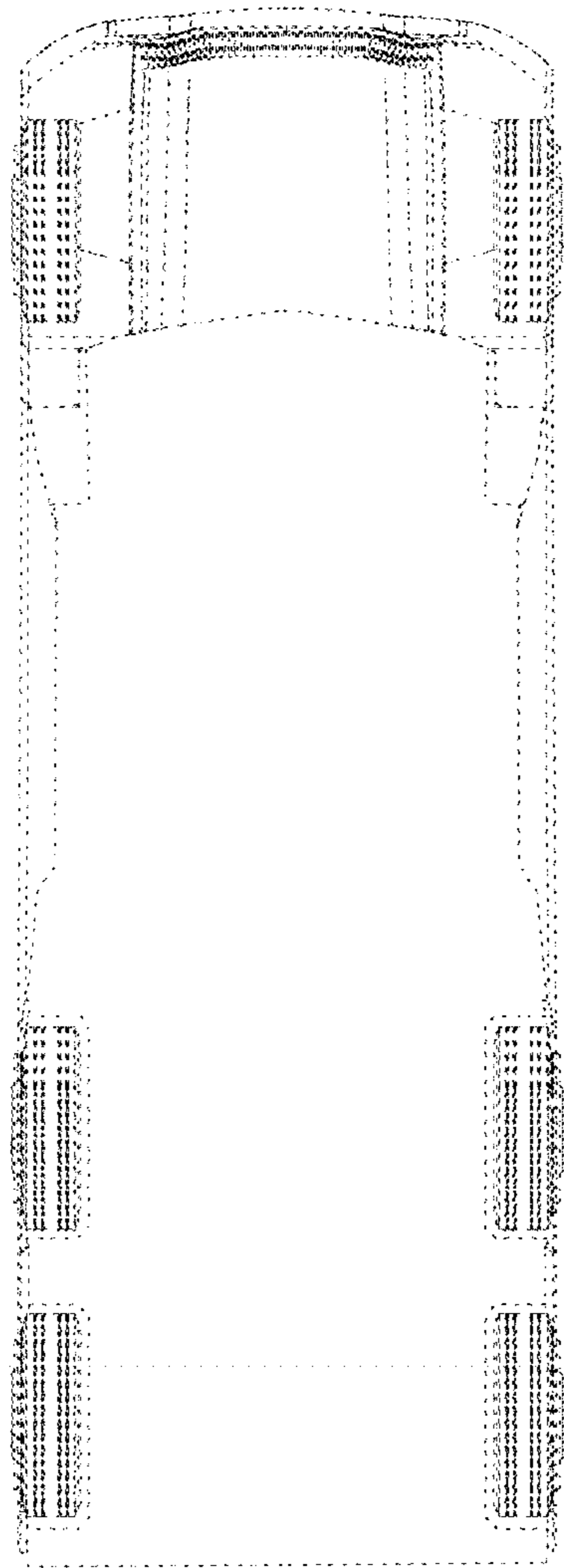
