The ornamental design for a charger, as shown.

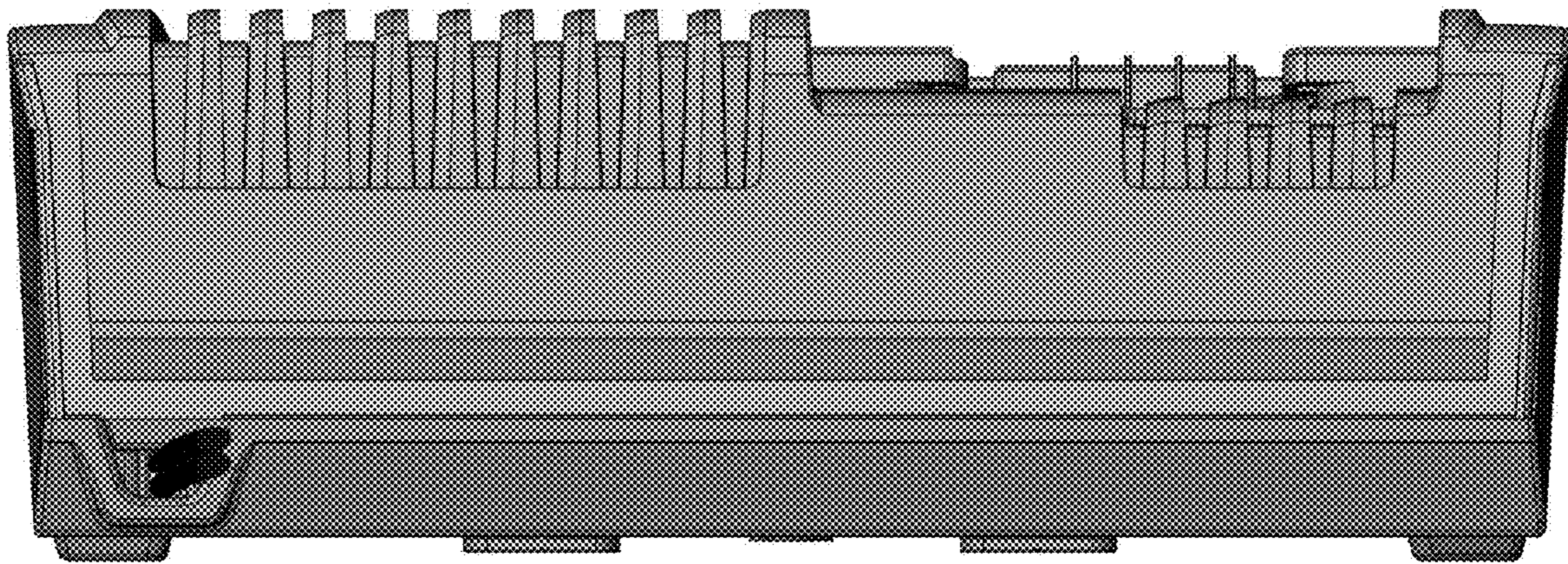
DESCRIPTION

 - 1.7 is a top, rear, right side perspective view.

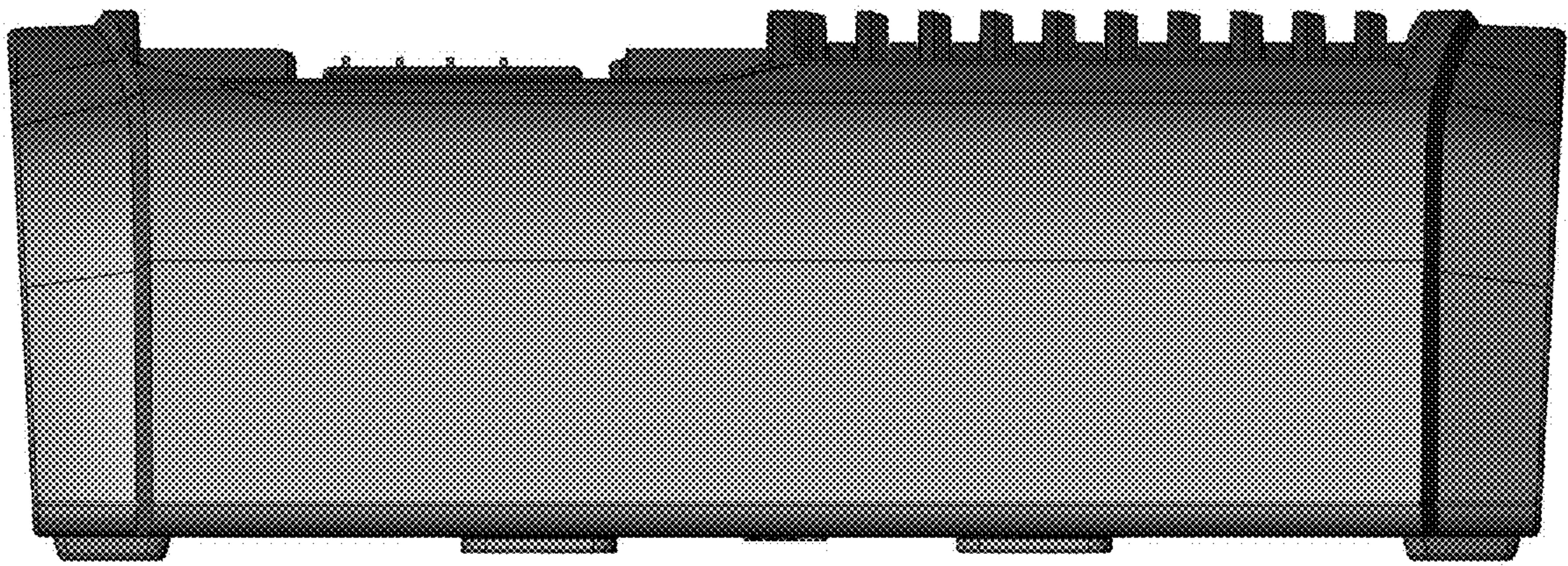

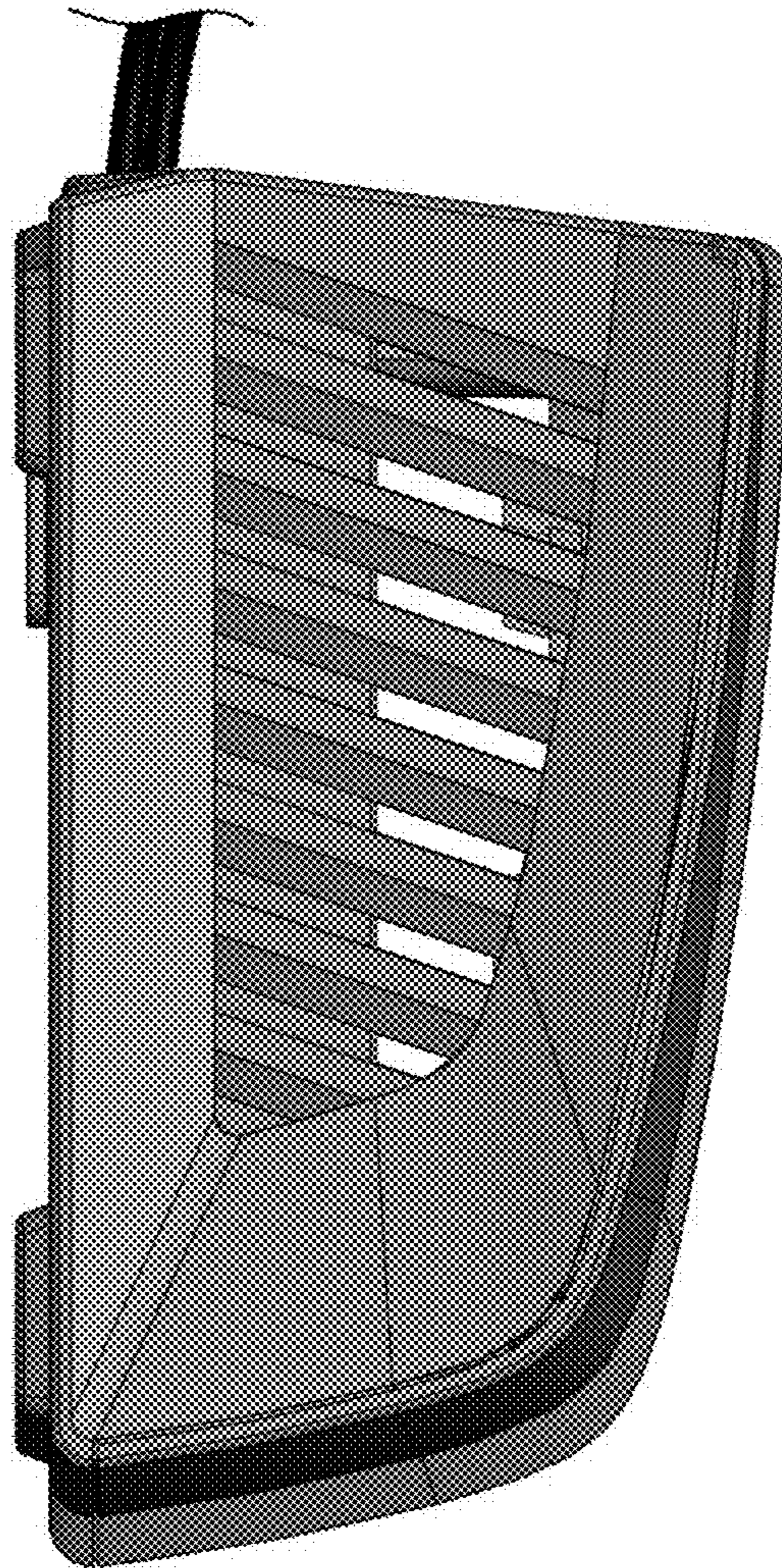

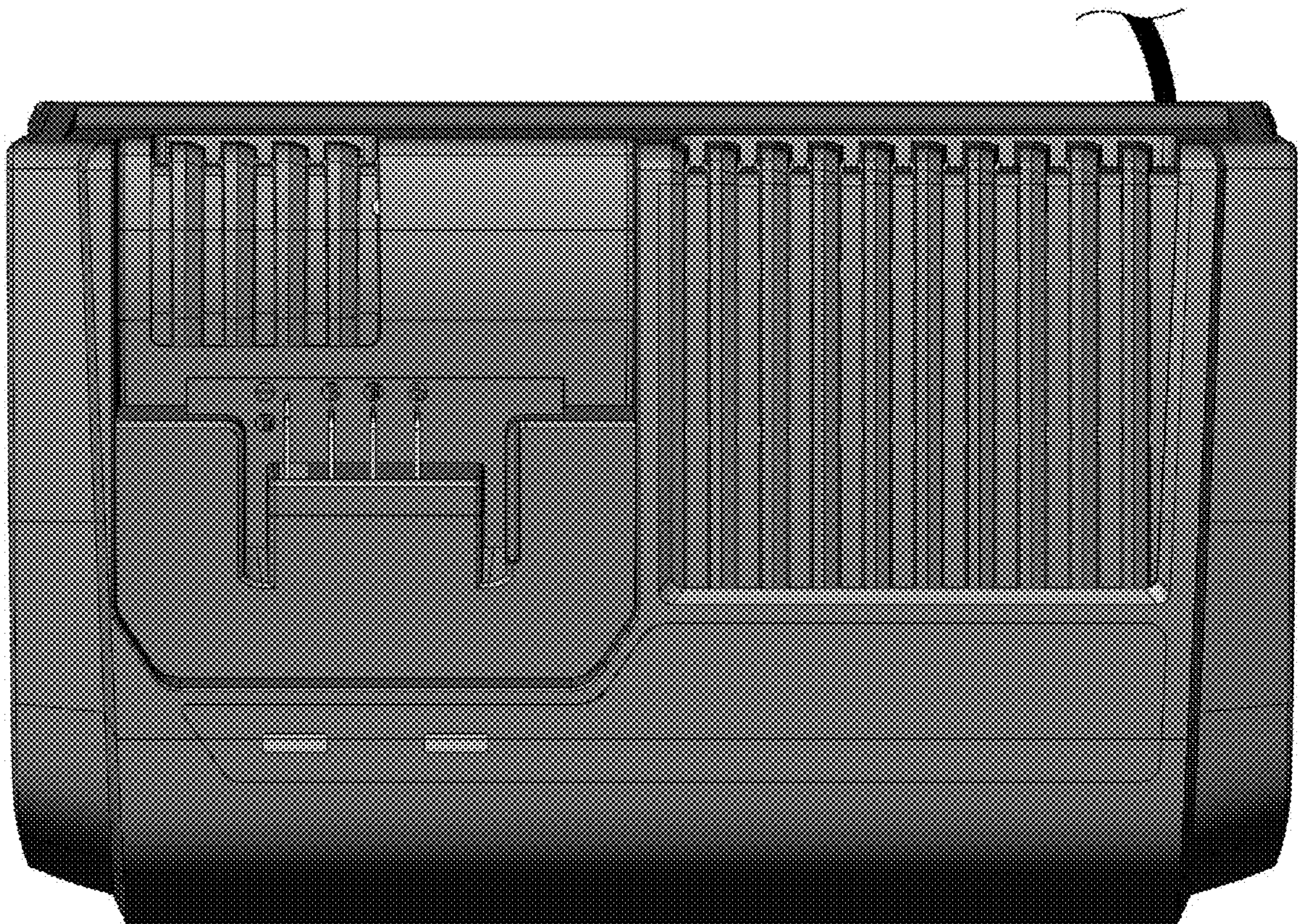

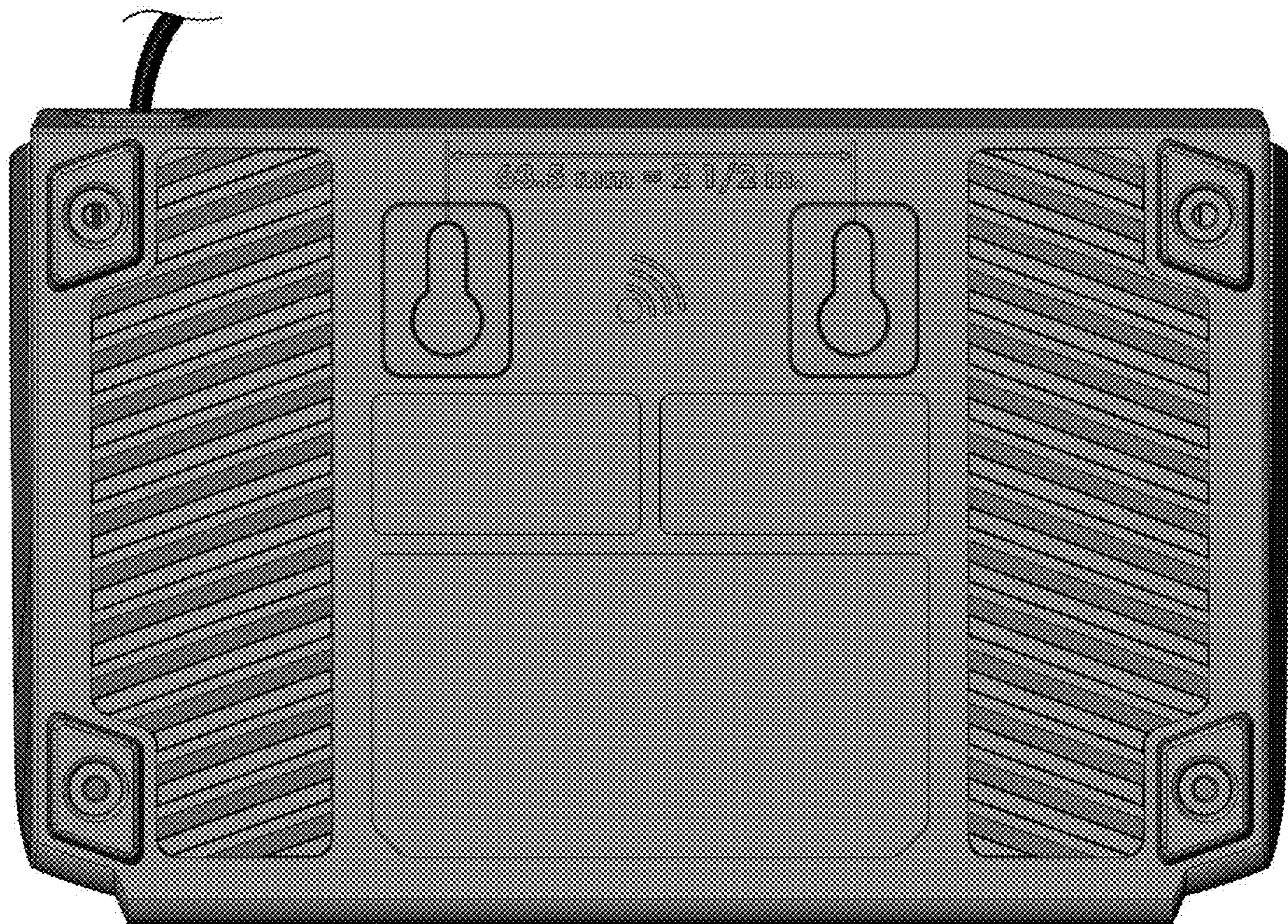

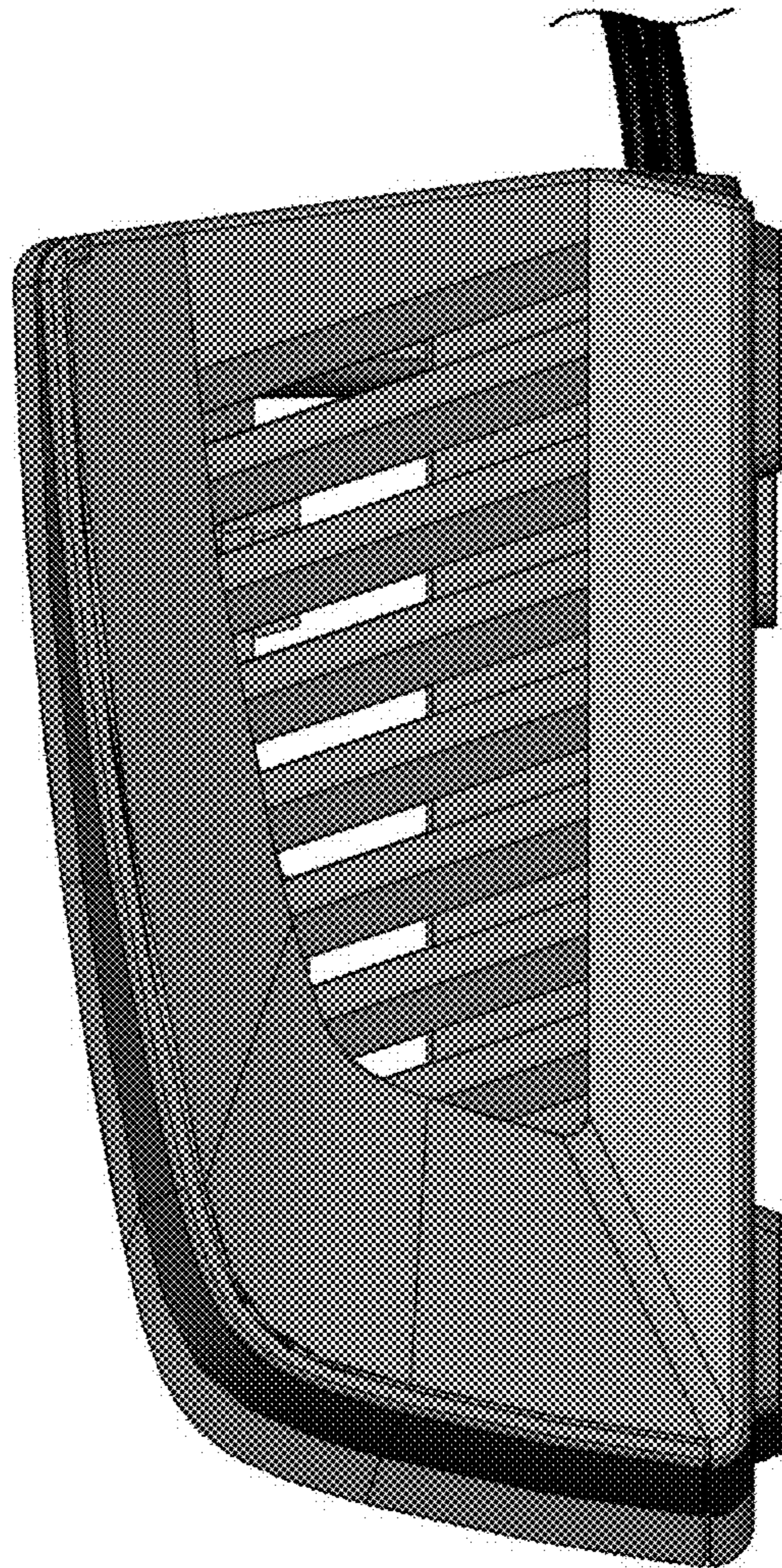
