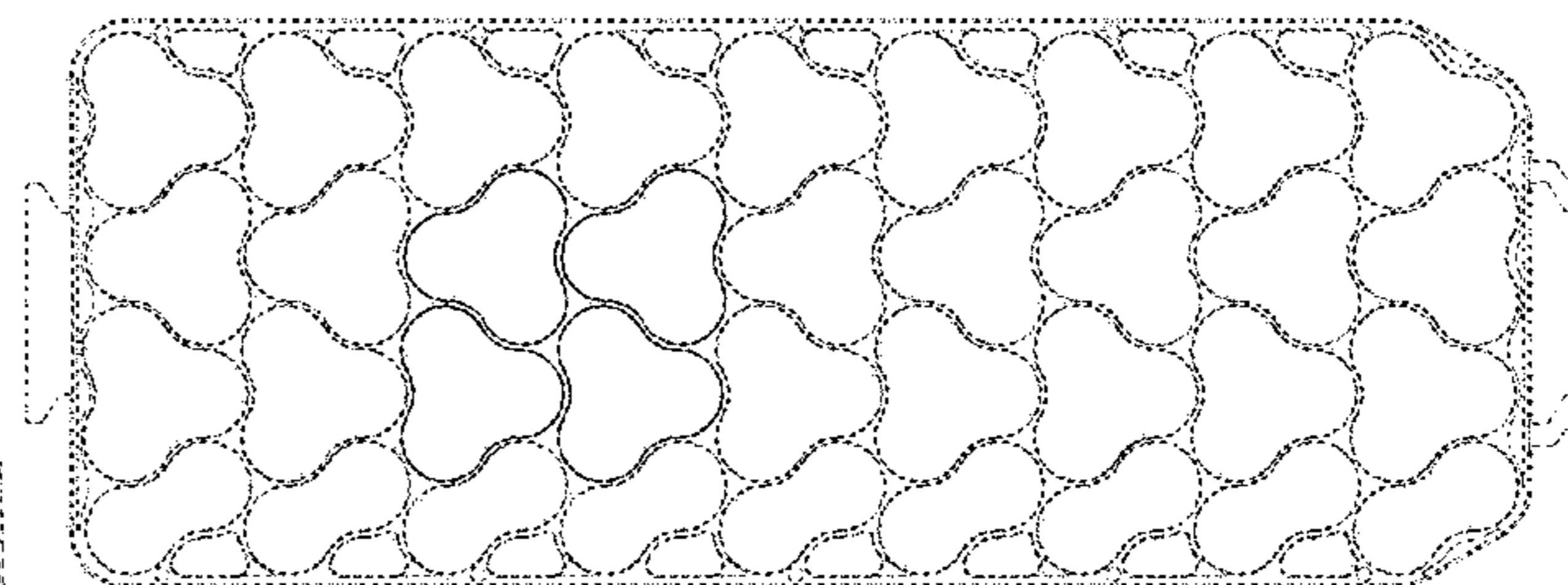
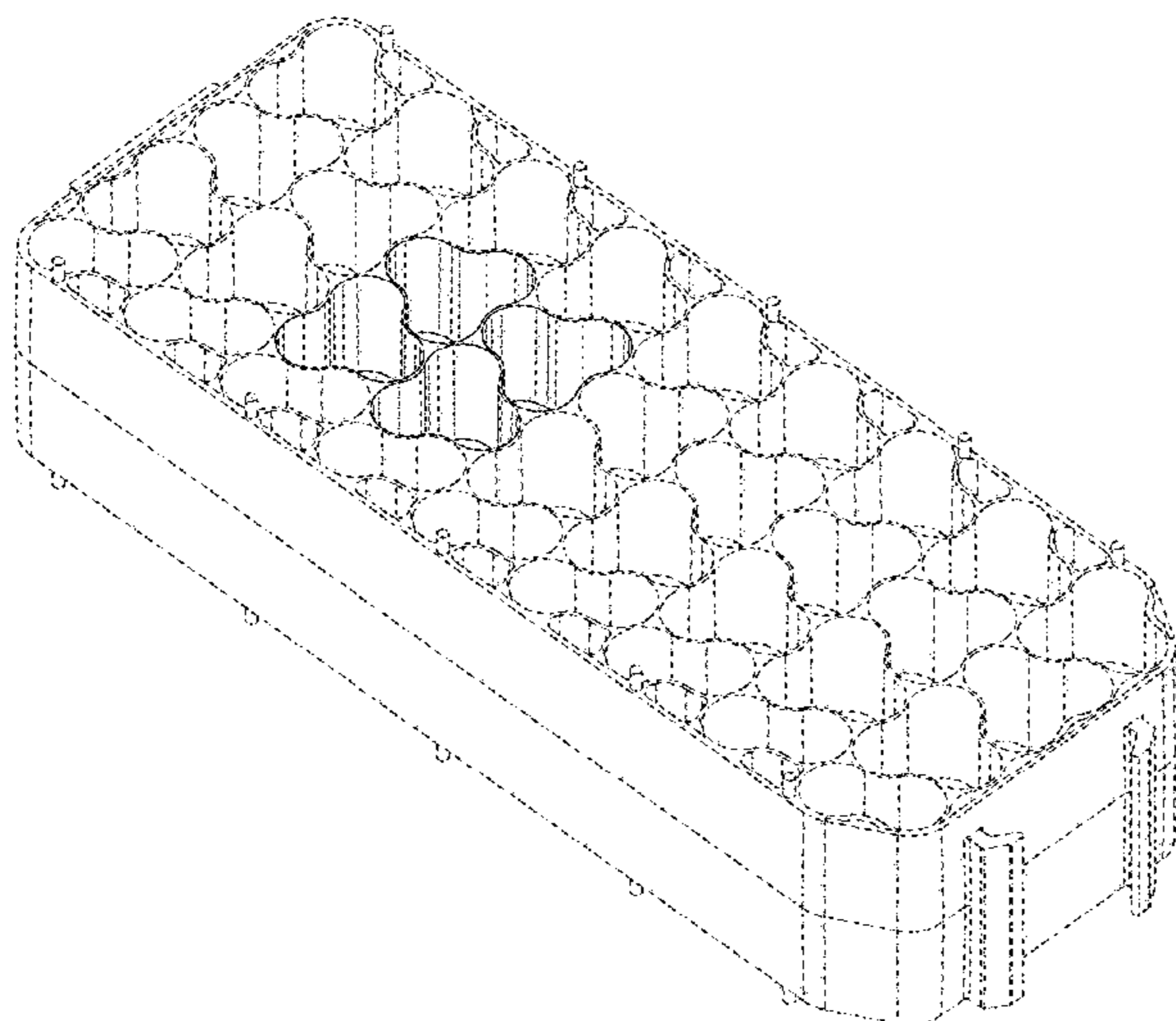
The ornamental design for a battery cell housing honeycomb, as shown and described.

DESCRIPTION

FIG. 1 is a front left top perspective view of a battery cell housing honeycomb according to the present invention.
 FIG. 2 is a rear left bottom perspective view of the battery cell housing honeycomb shown in FIG. 1.
 FIG. 3 is a top view thereof.
 FIG. 4 is a bottom view thereof.
 FIG. 5 is a left side view thereof.
 FIG. 6 is a rear view thereof; and,
 FIG. 7 is a front view thereof.

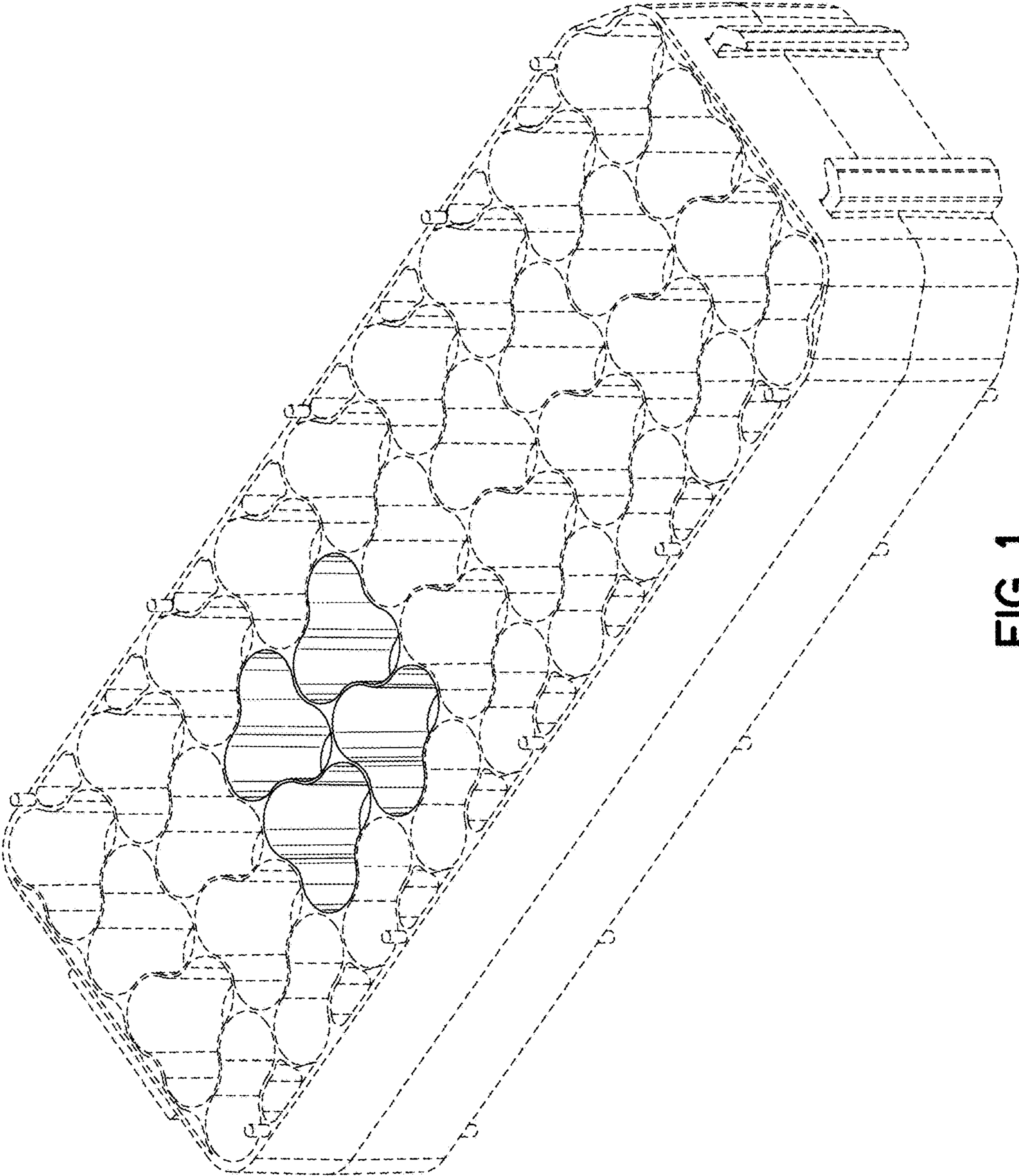

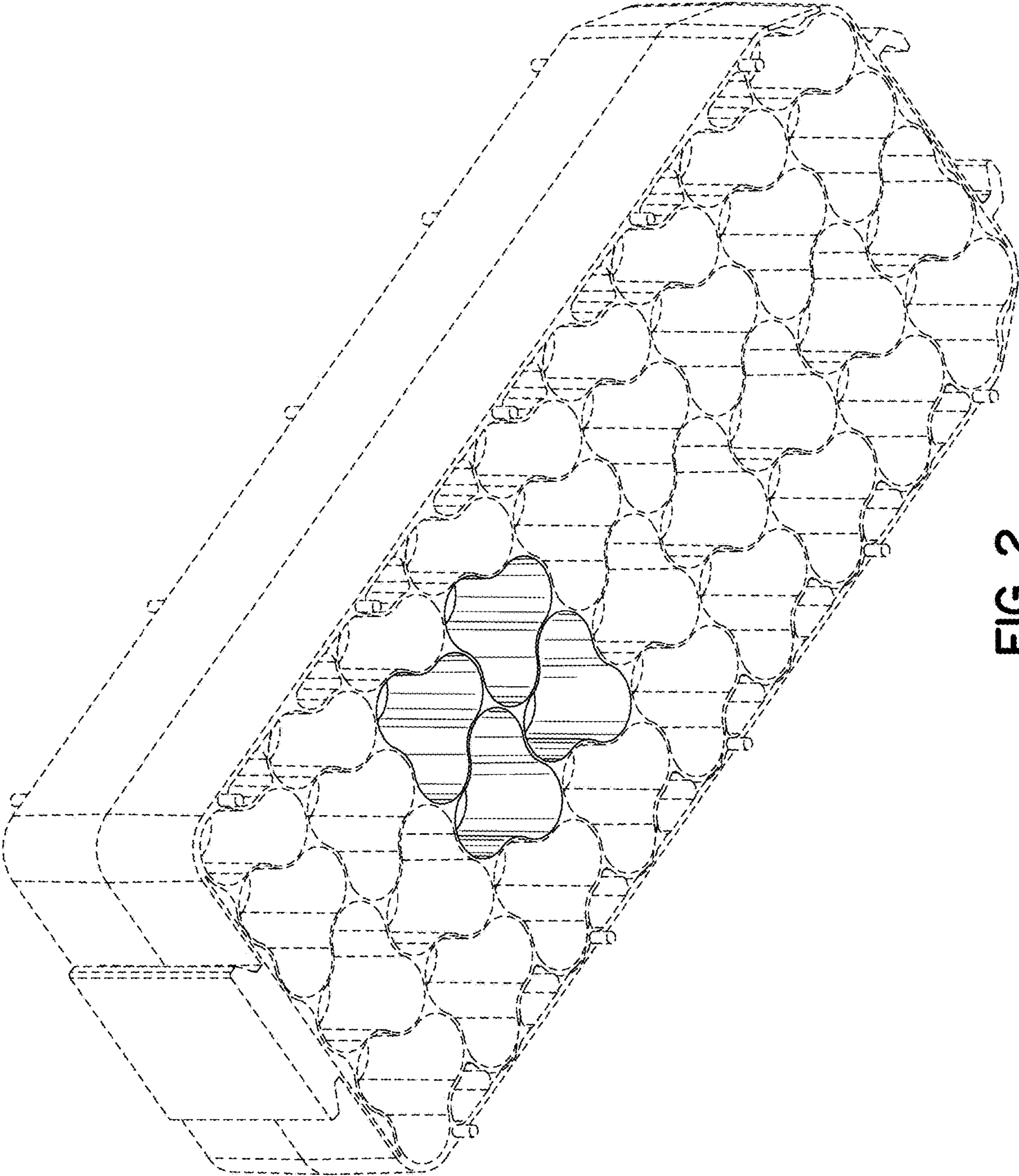

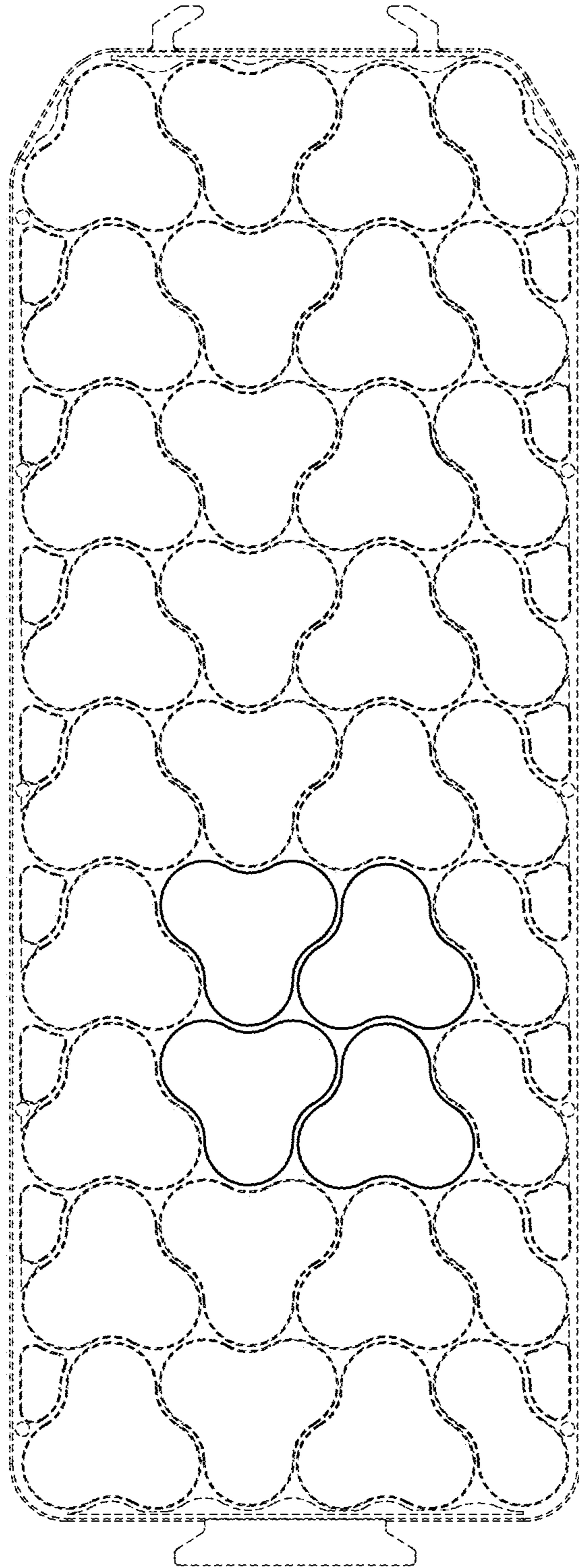

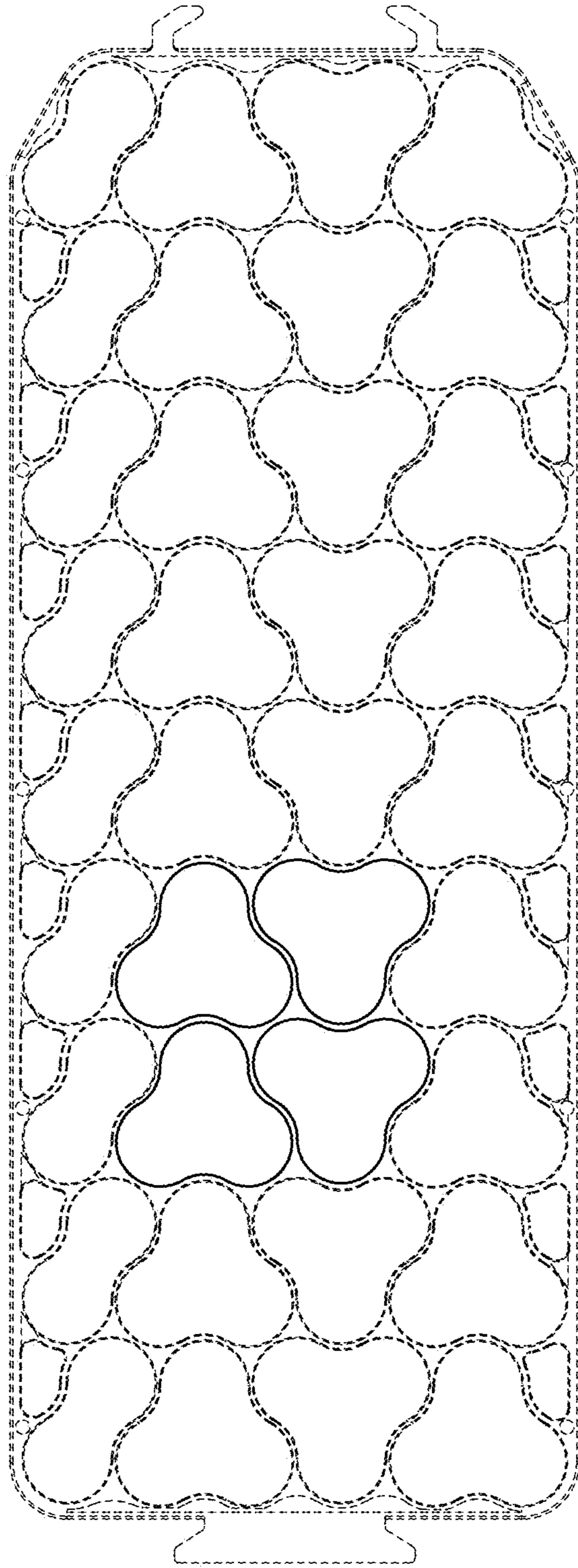

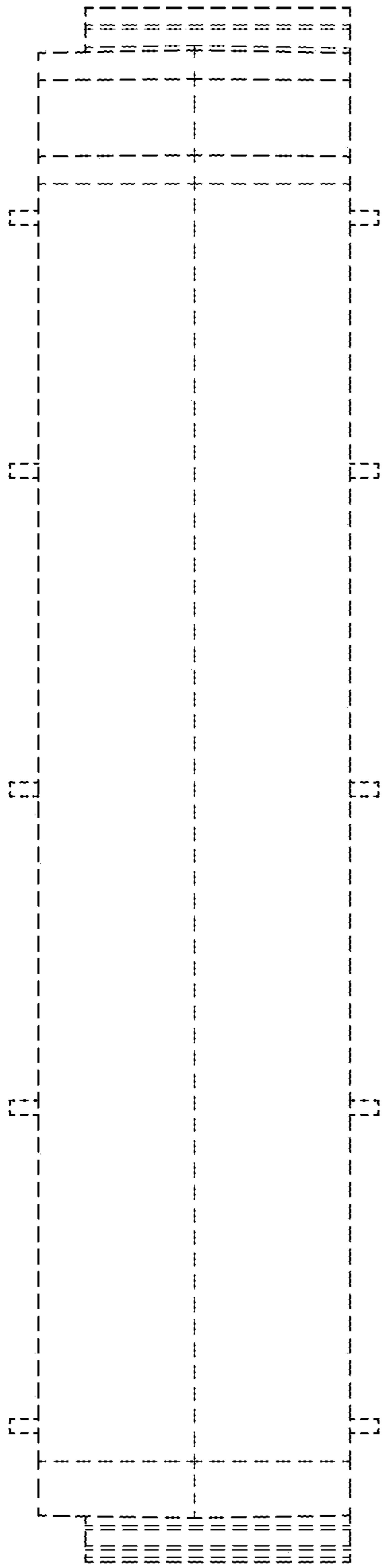

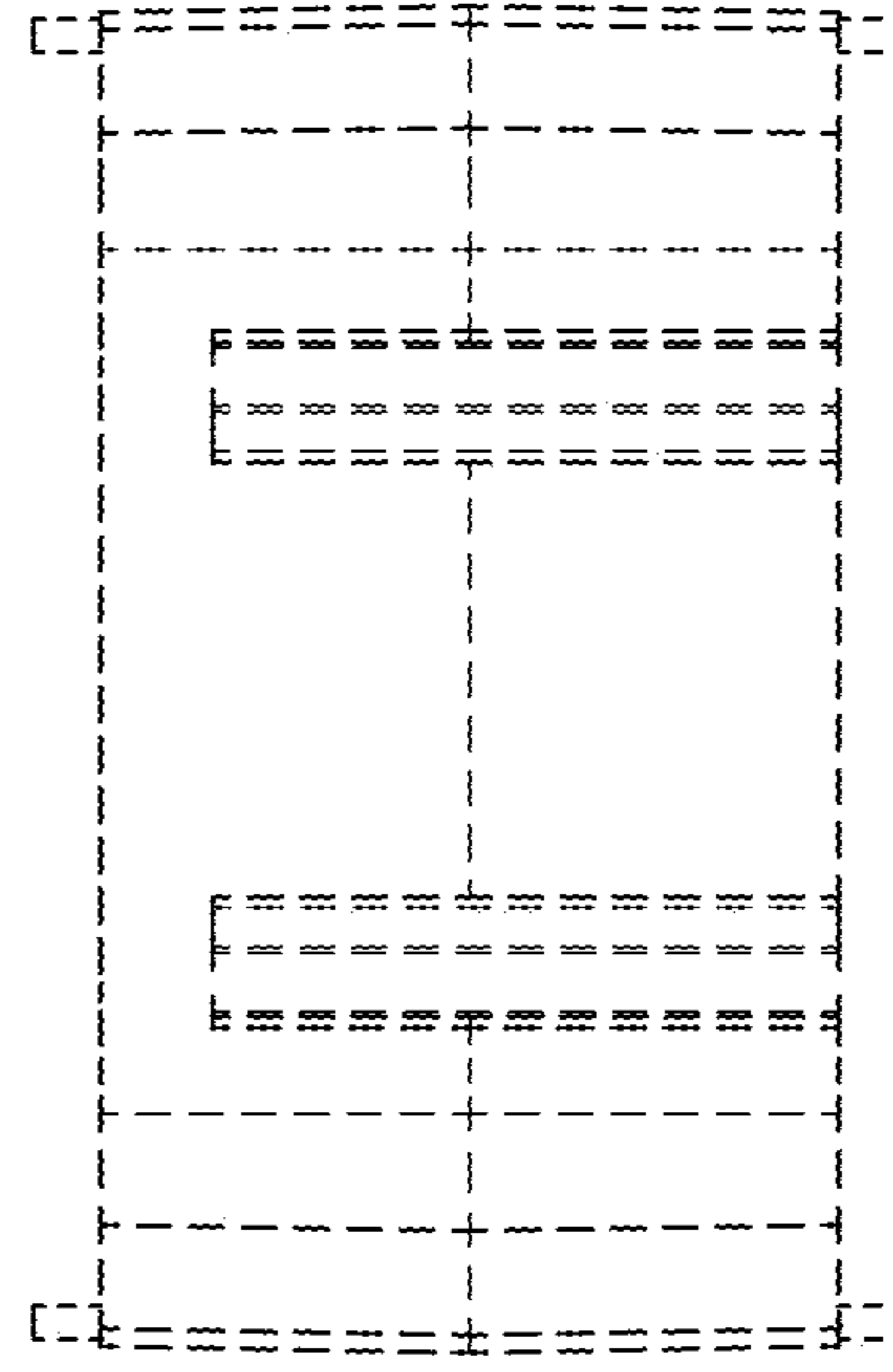

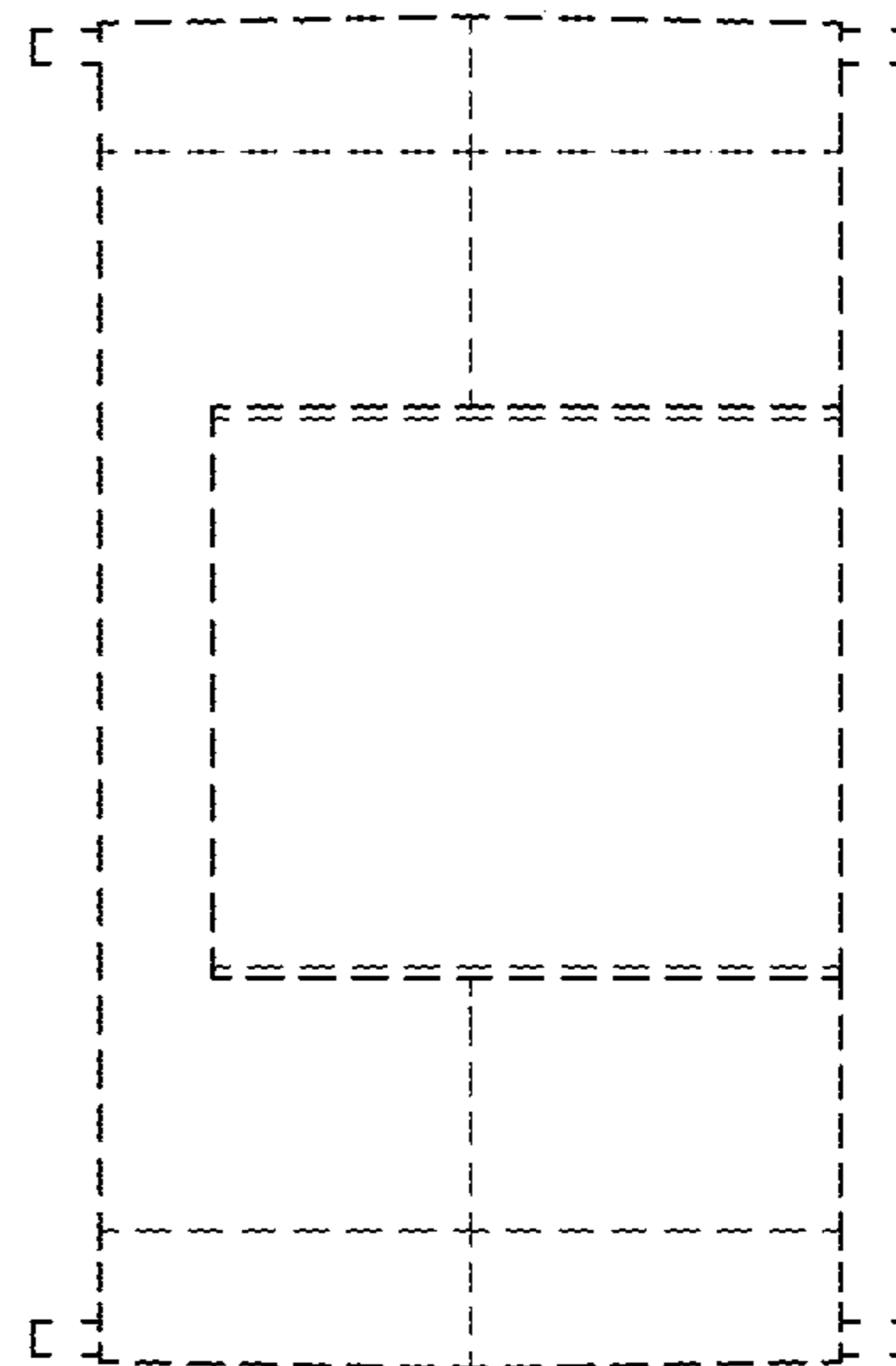
