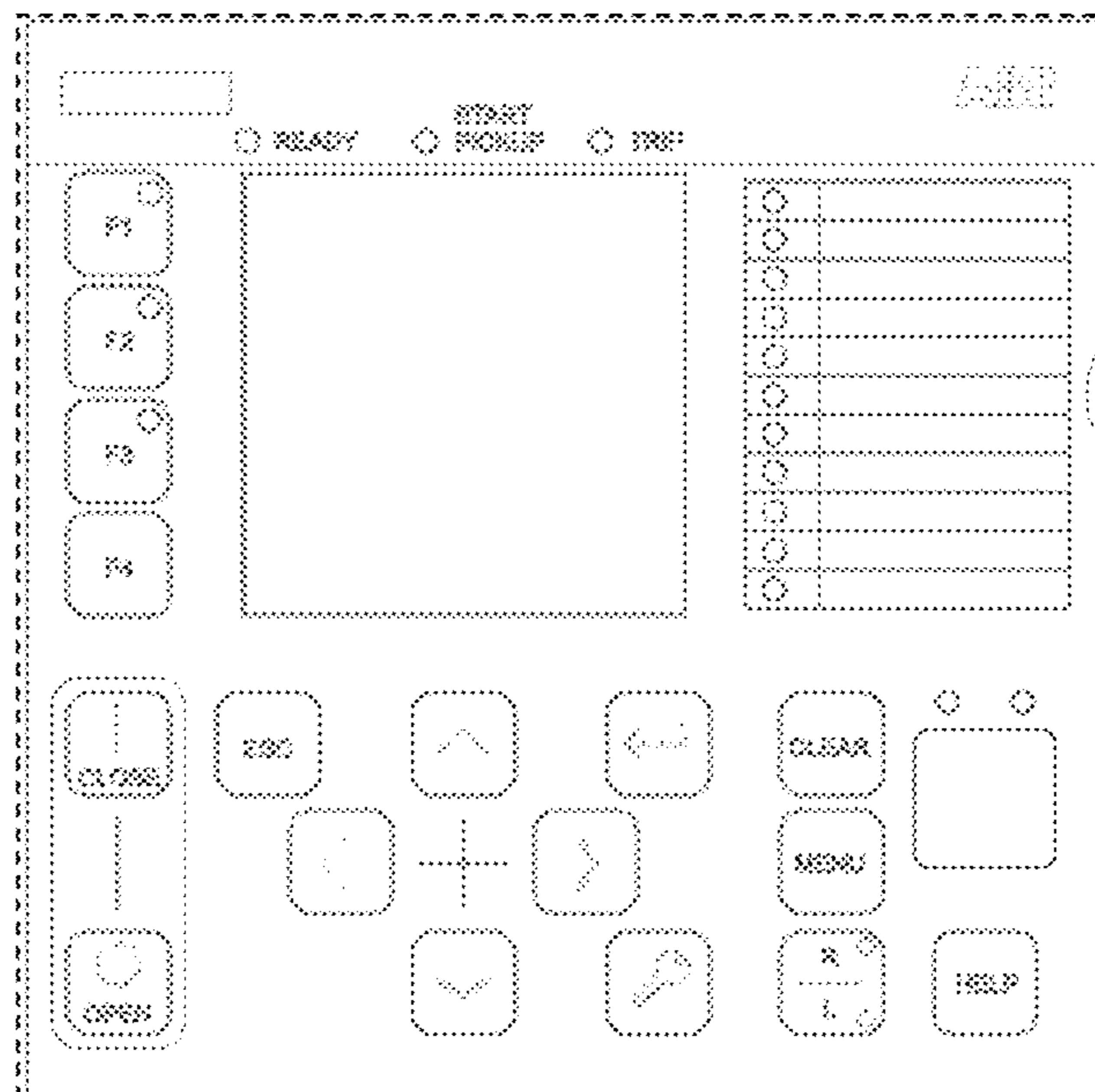
The ornamental design for a display panel with graphical user interface, as shown and described.
