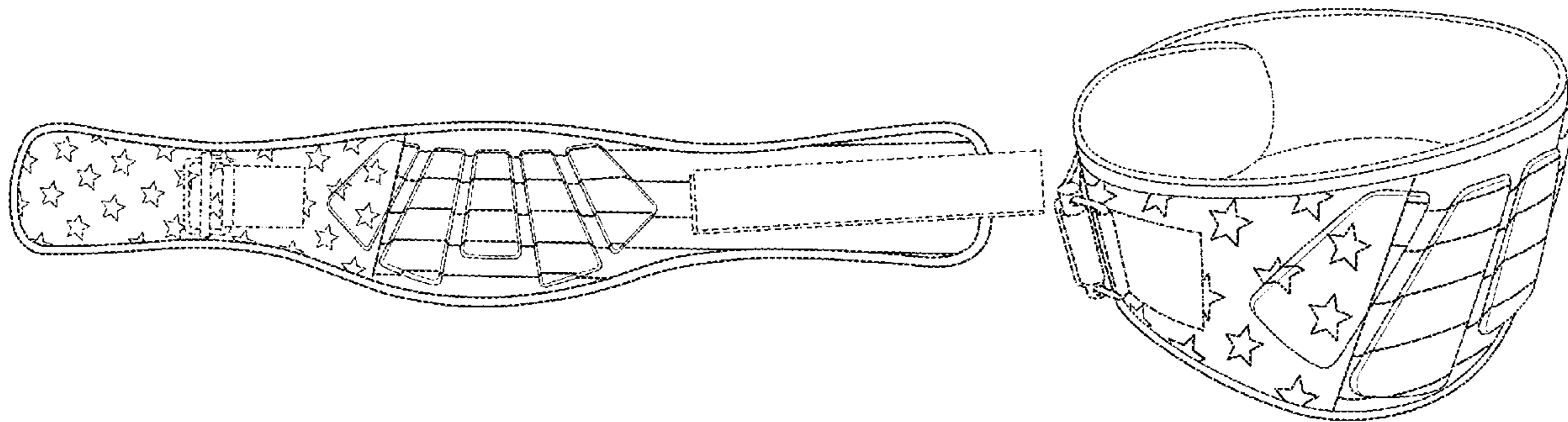
(57) **CLAIM**

The ornamental design for a weightlifting belt, as shown and described.

**DESCRIPTION**

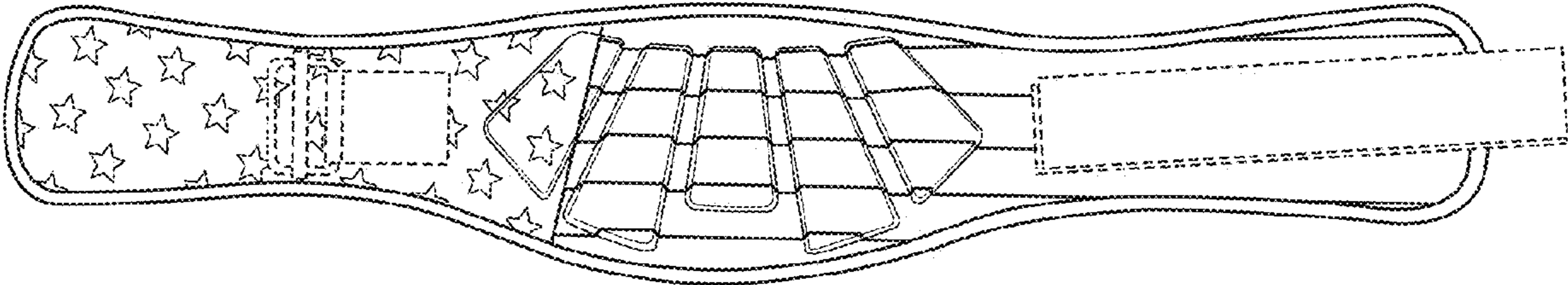

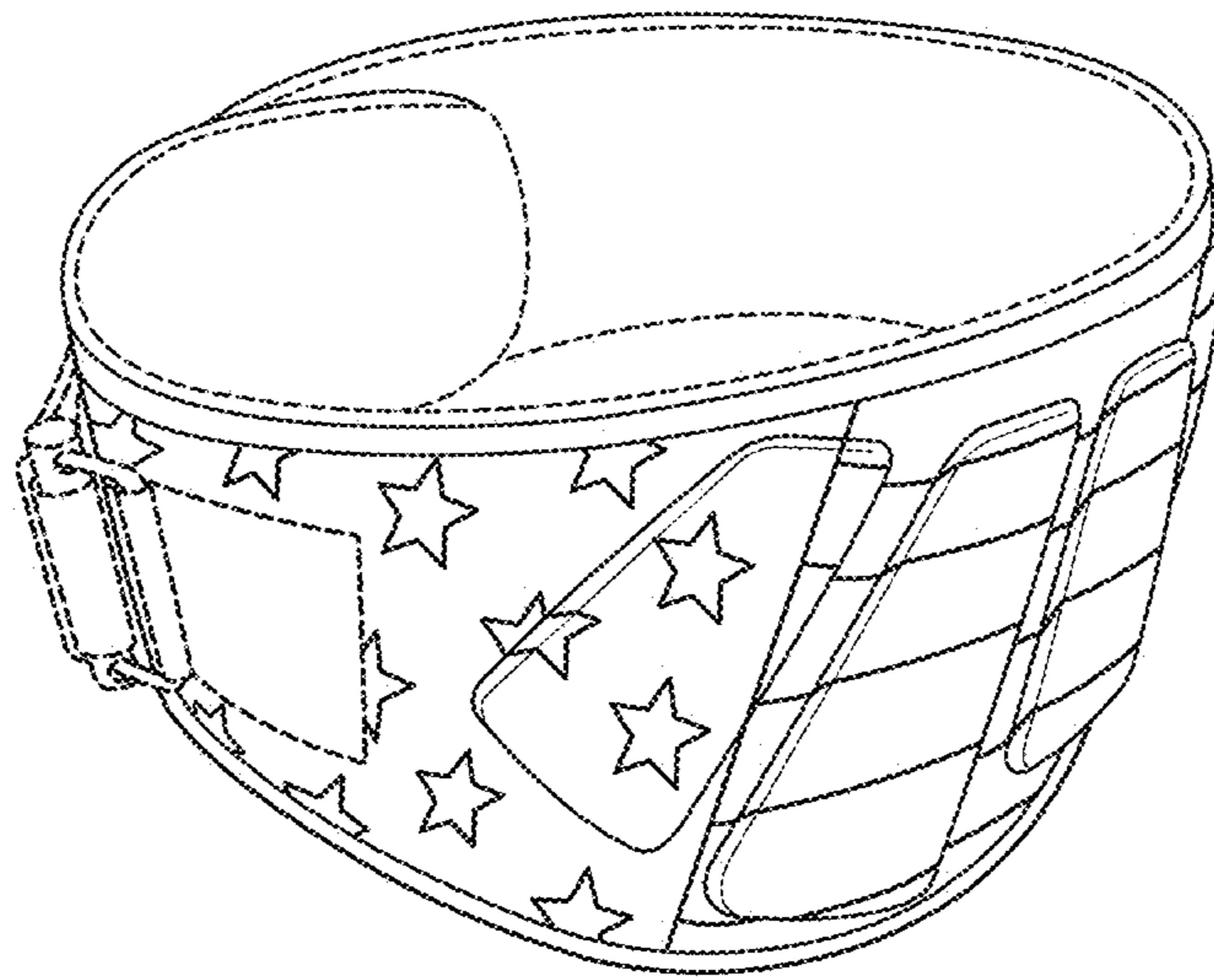
