(57) **CLAIM**

The ornamental design for a heel dressing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the front and top of an embodiment of a heel dressing;

FIG. 2 is a perspective view of the front and bottom of the heel dressing illustrated in FIG. 1;

FIG. 3 is a plan view of the top of the heel dressing illustrated in FIG. 1;

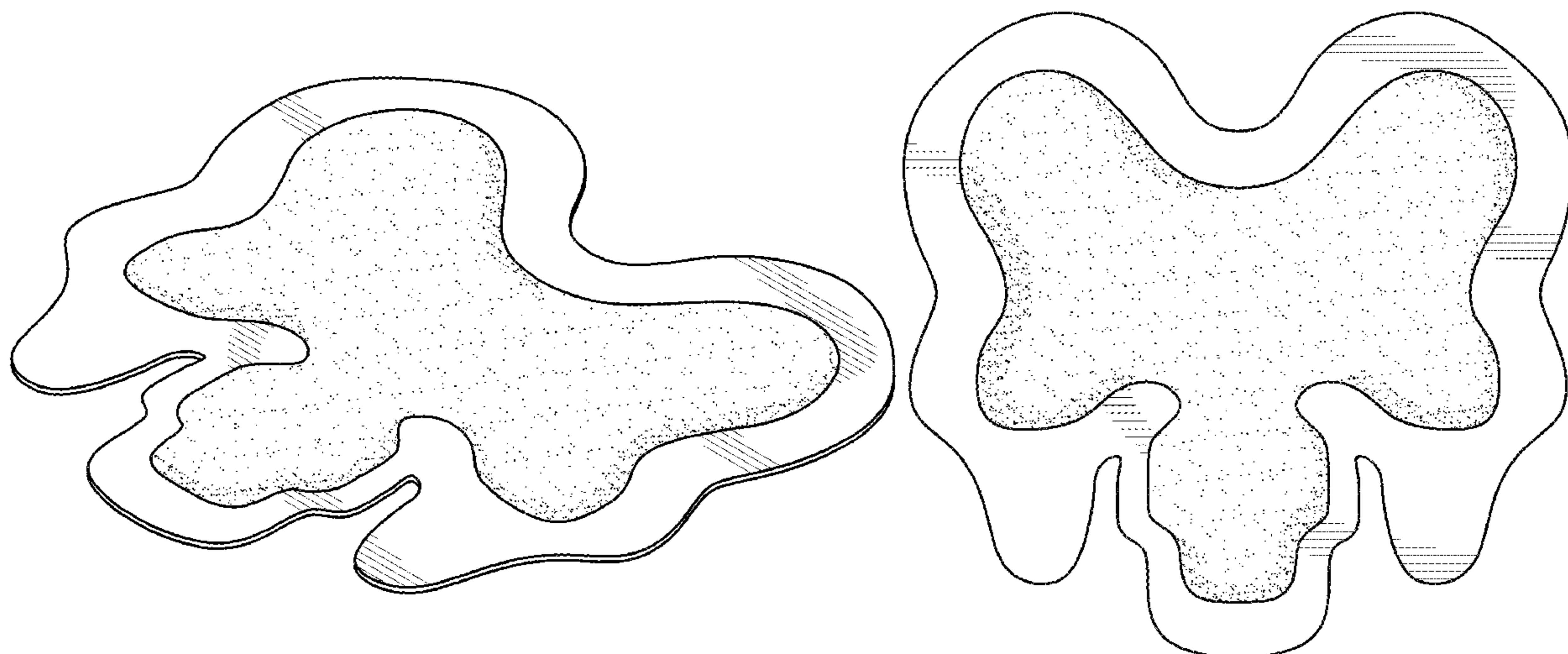
FIG. 4 is a plan view of the bottom of the heel dressing illustrated in FIG. 1;

FIG. 5 is an elevation view of the side of the heel dressing illustrated in FIG. 1, with the elevation view of the opposite side being a mirror image thereof;

FIG. 7 is an elevation view of the front of the heel dressing illustrated in FIG. 1.

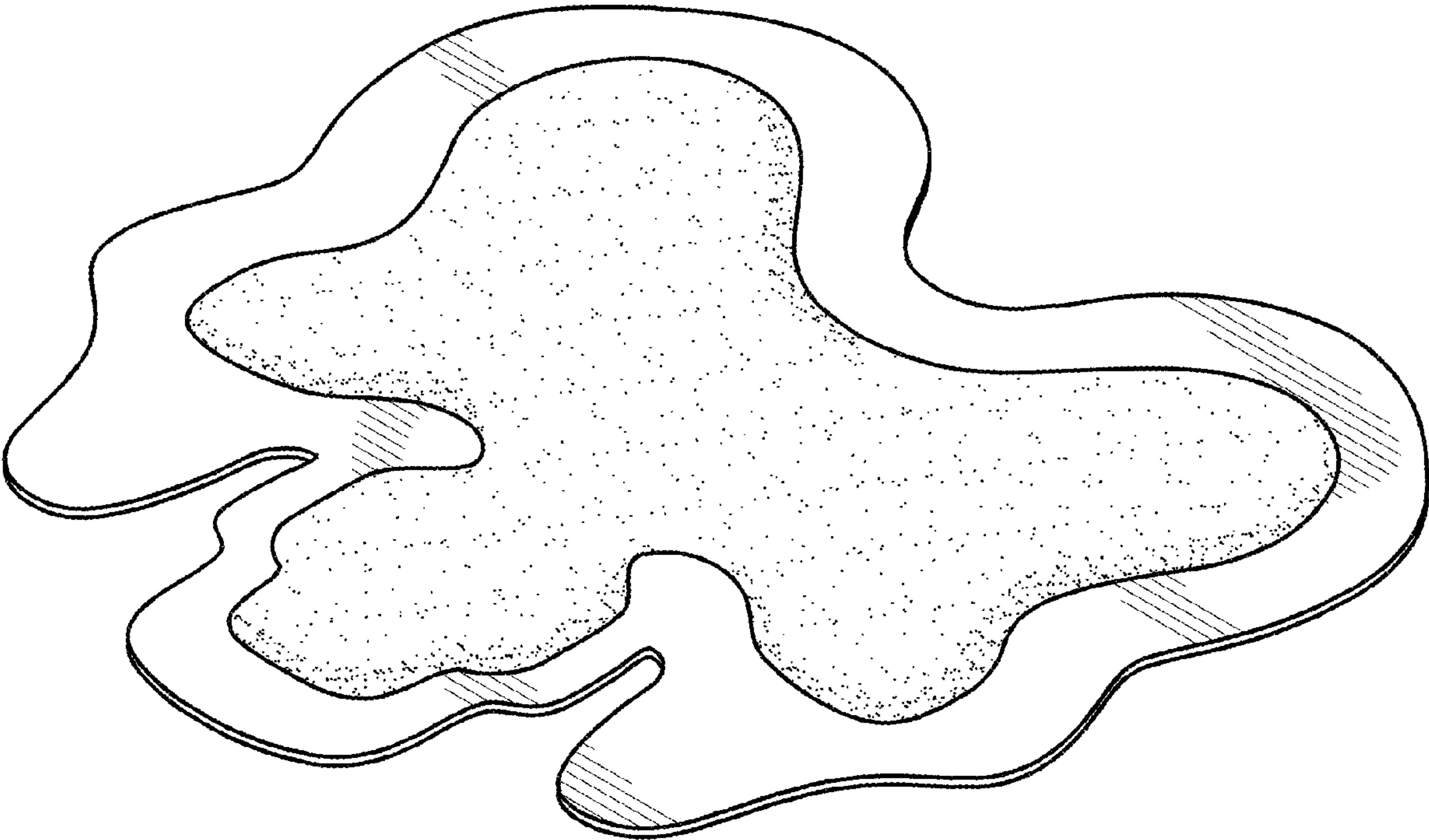

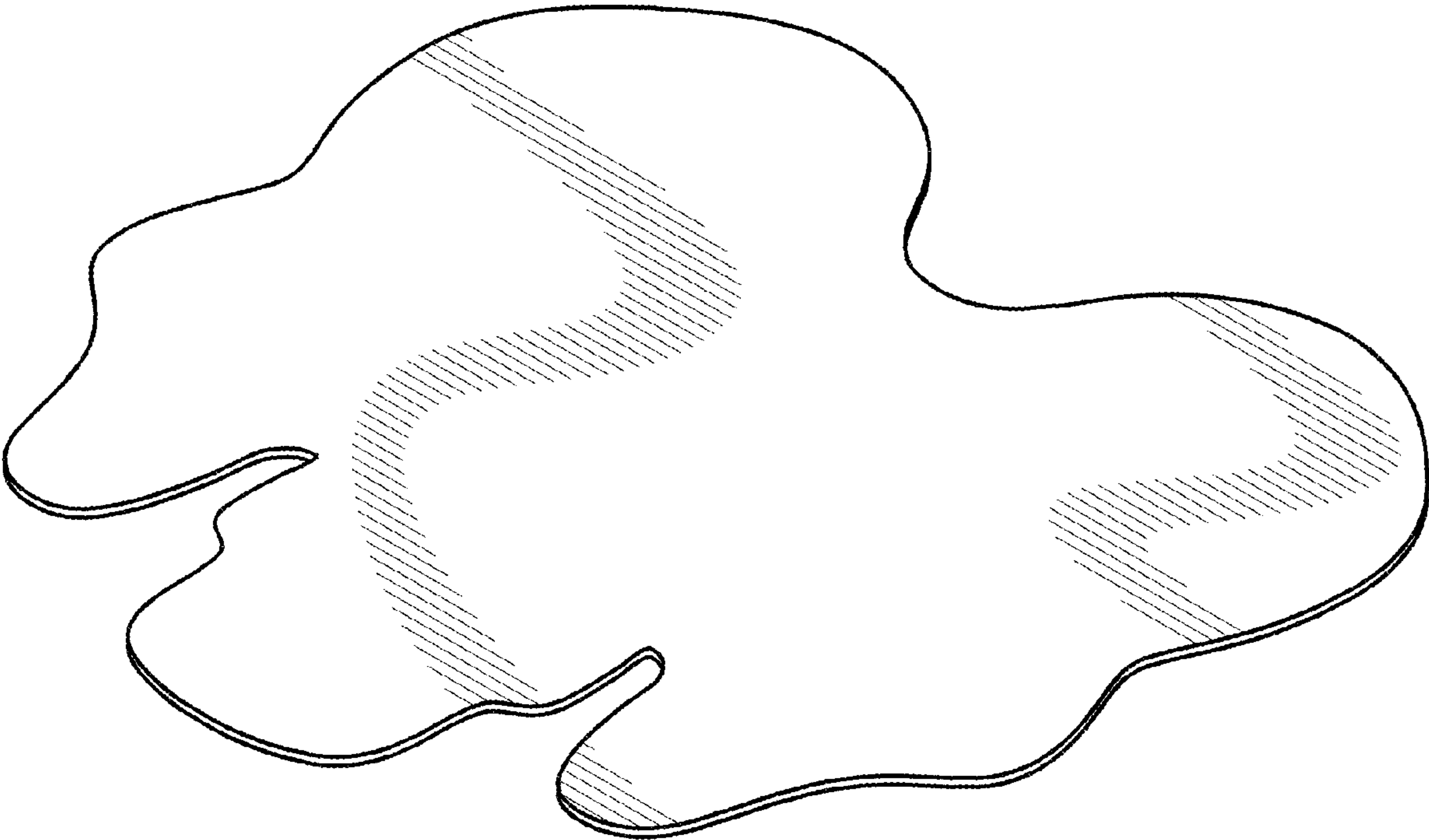

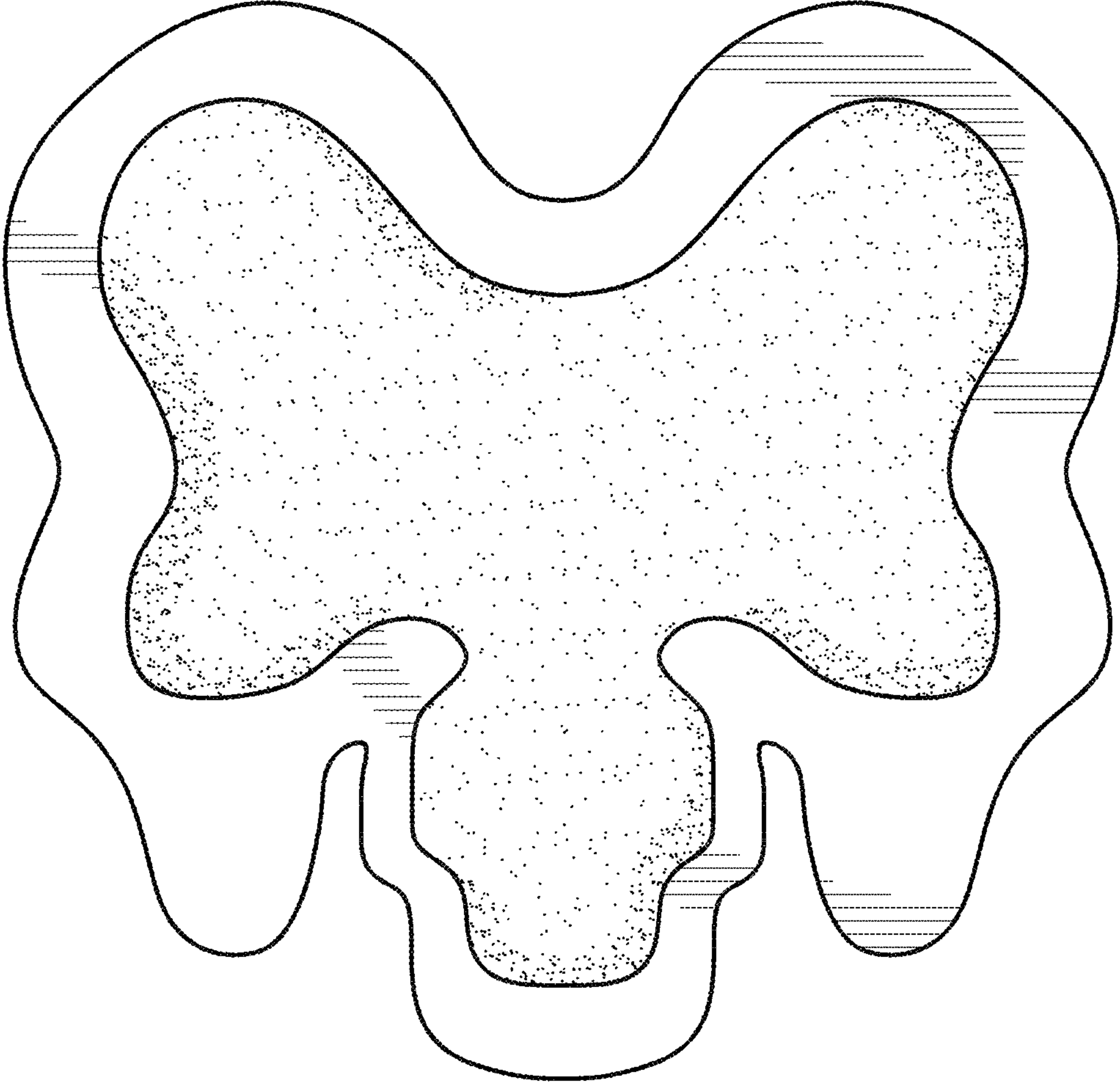

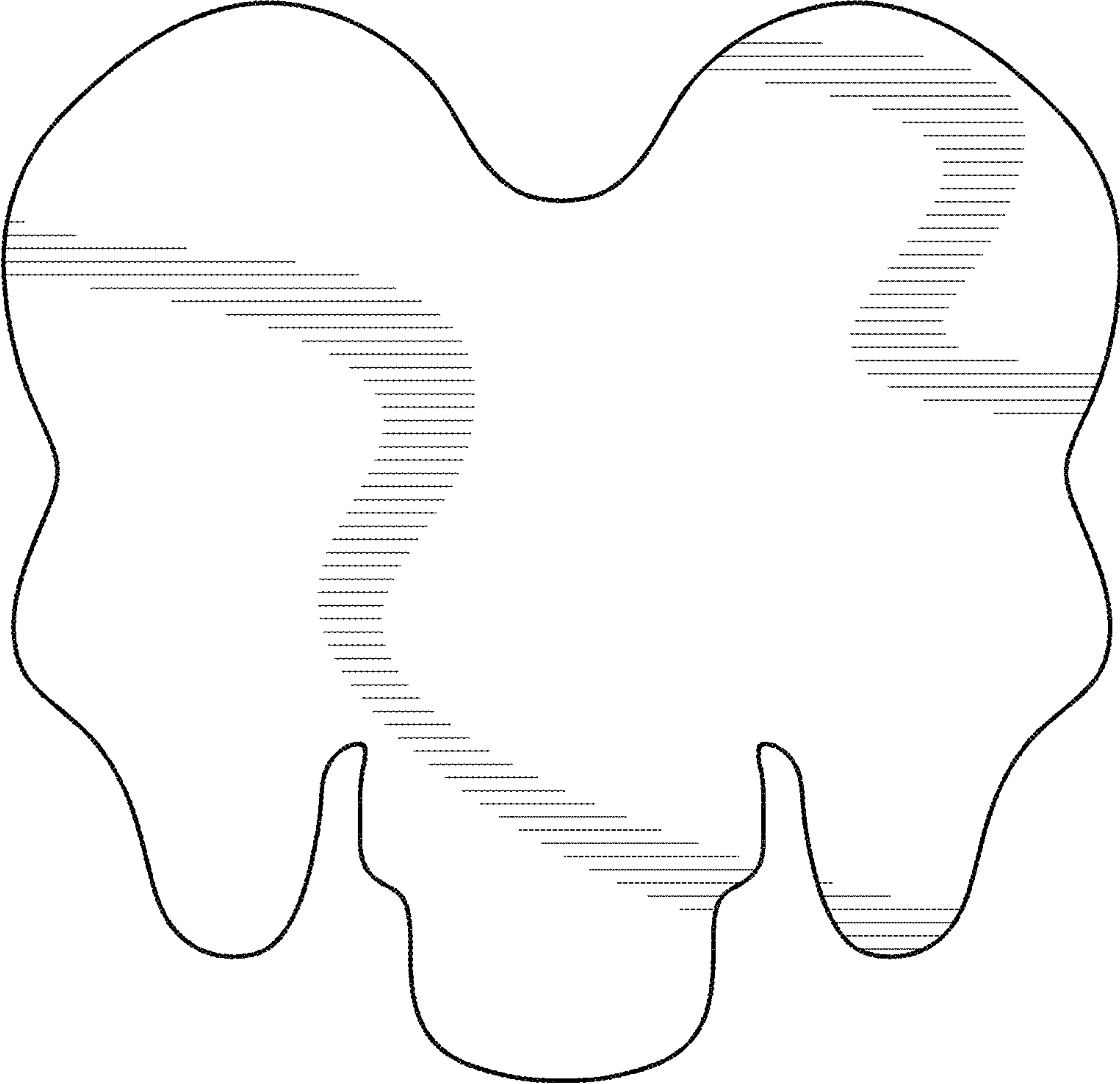

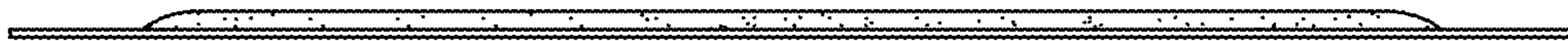

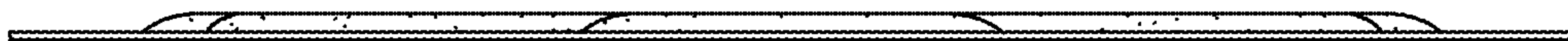
