(57) **CLAIM**

The ornamental design for a toe crest, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom view of a toe crest for a right foot of the present design;

FIG. 2 is a top view of the toe crest for a right foot of the design of FIG. 1;

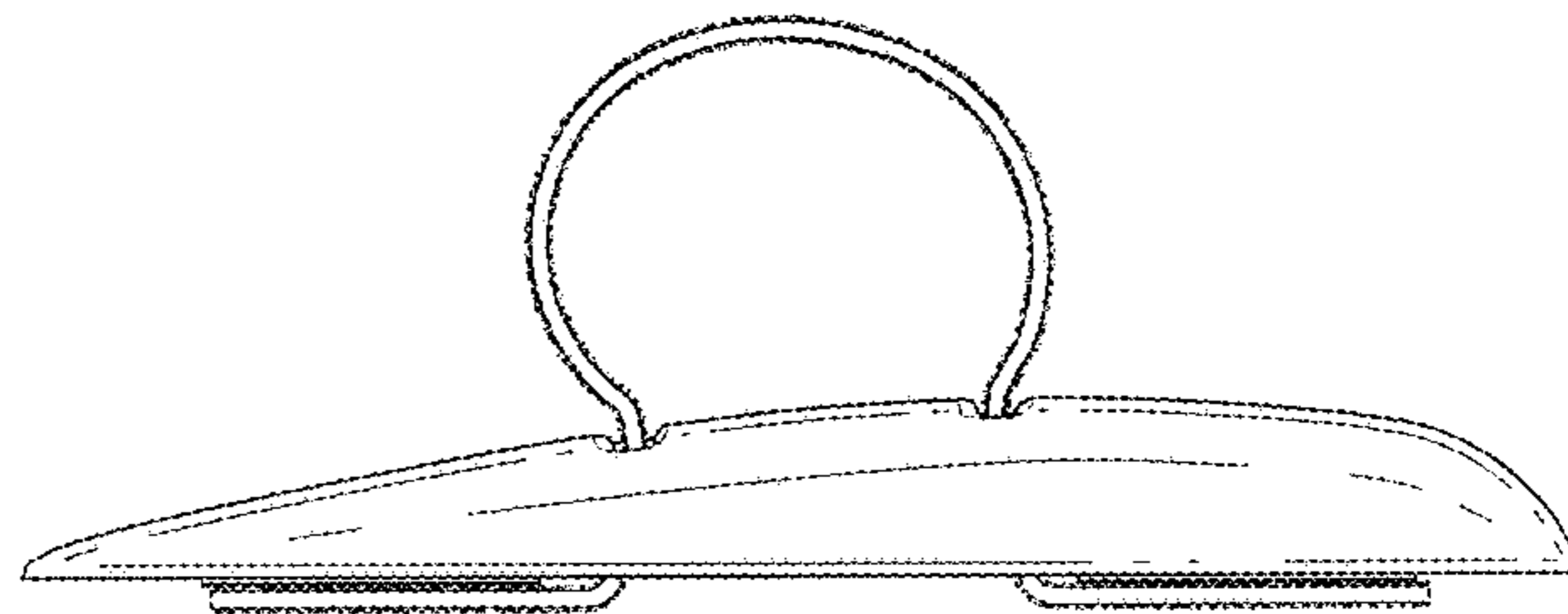
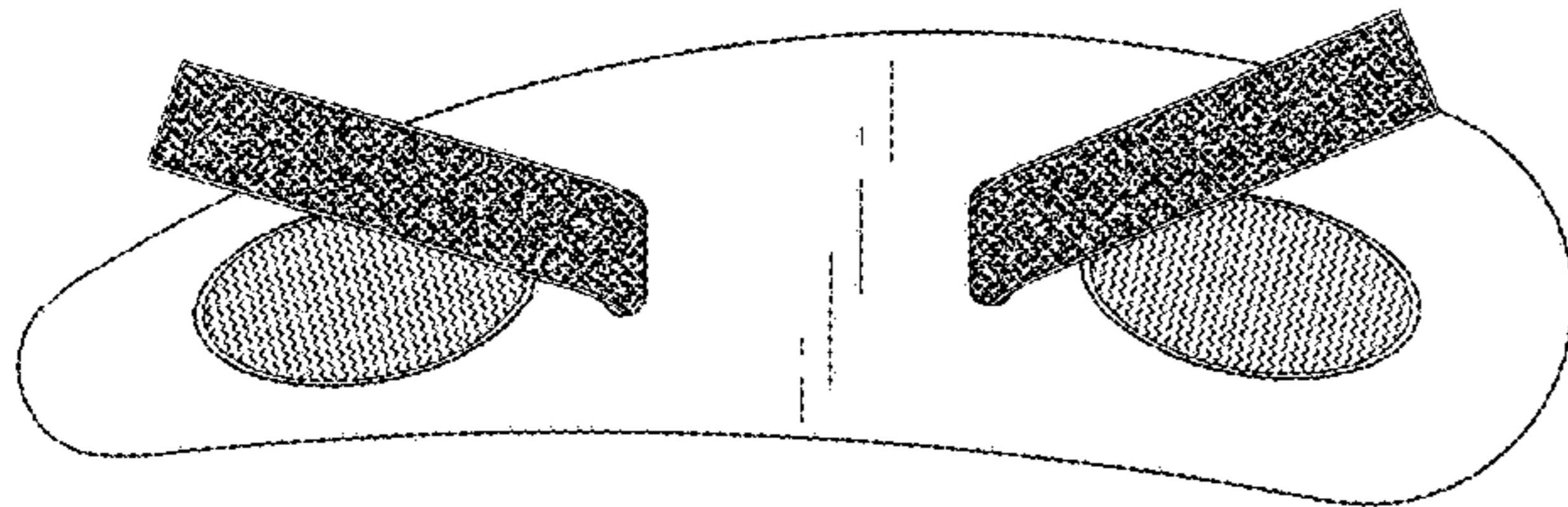
FIG. 3 is a first side view of the toe crest for a right foot of the design of FIG. 1;

FIG. 4 is a second side view of the toe crest for a right foot of the design of FIG. 1, the second side view shown being a side view that is opposite the side of the first side view for a right foot of the design of FIG. 1; and,

FIG. 5 is a front view of the toe crest for a right foot of the design of FIG. 1.

The zig-zag object lines in FIG. 1 indicates a contrast in material specific to the hook-and-loop fastener.

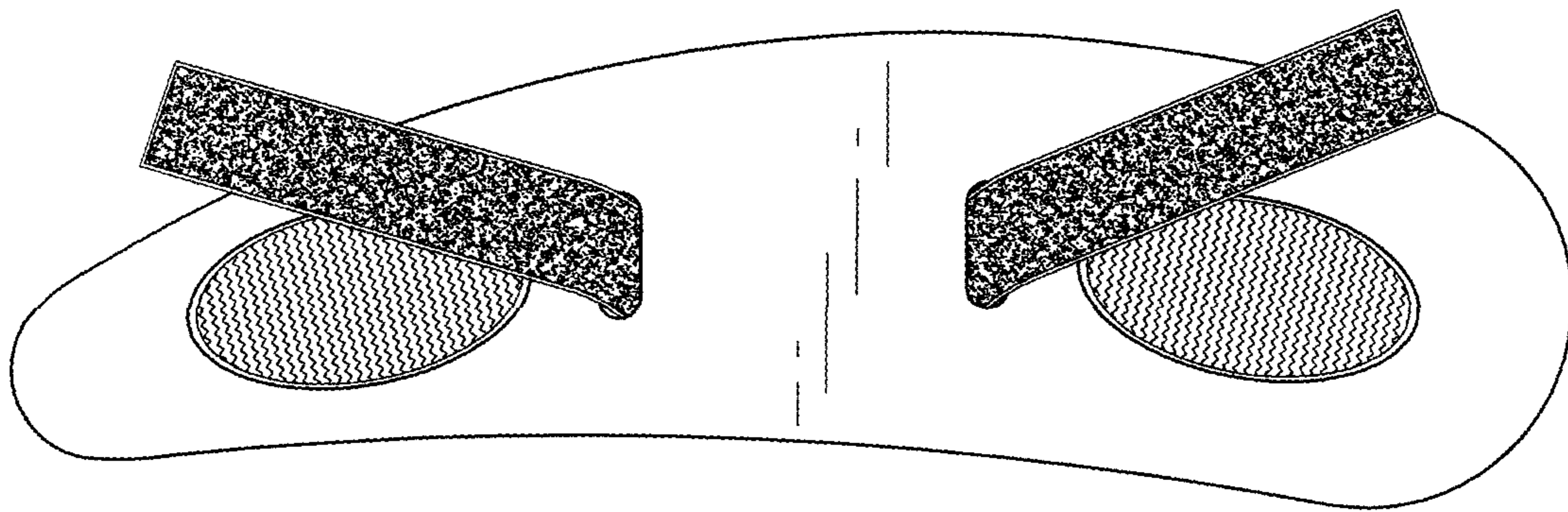

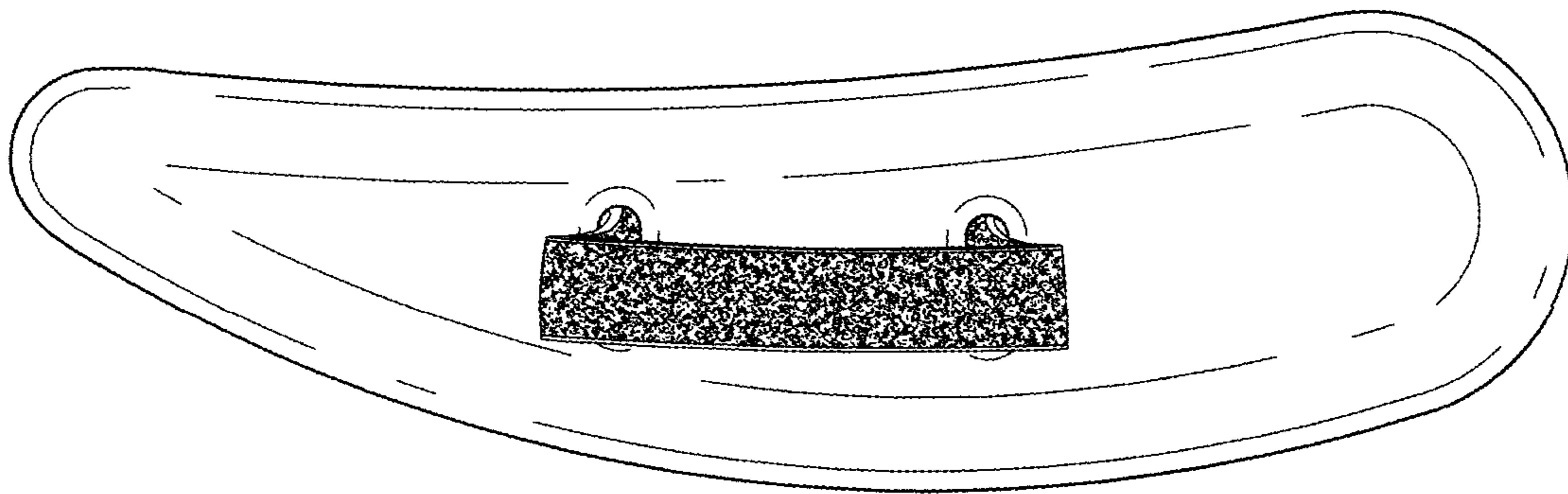

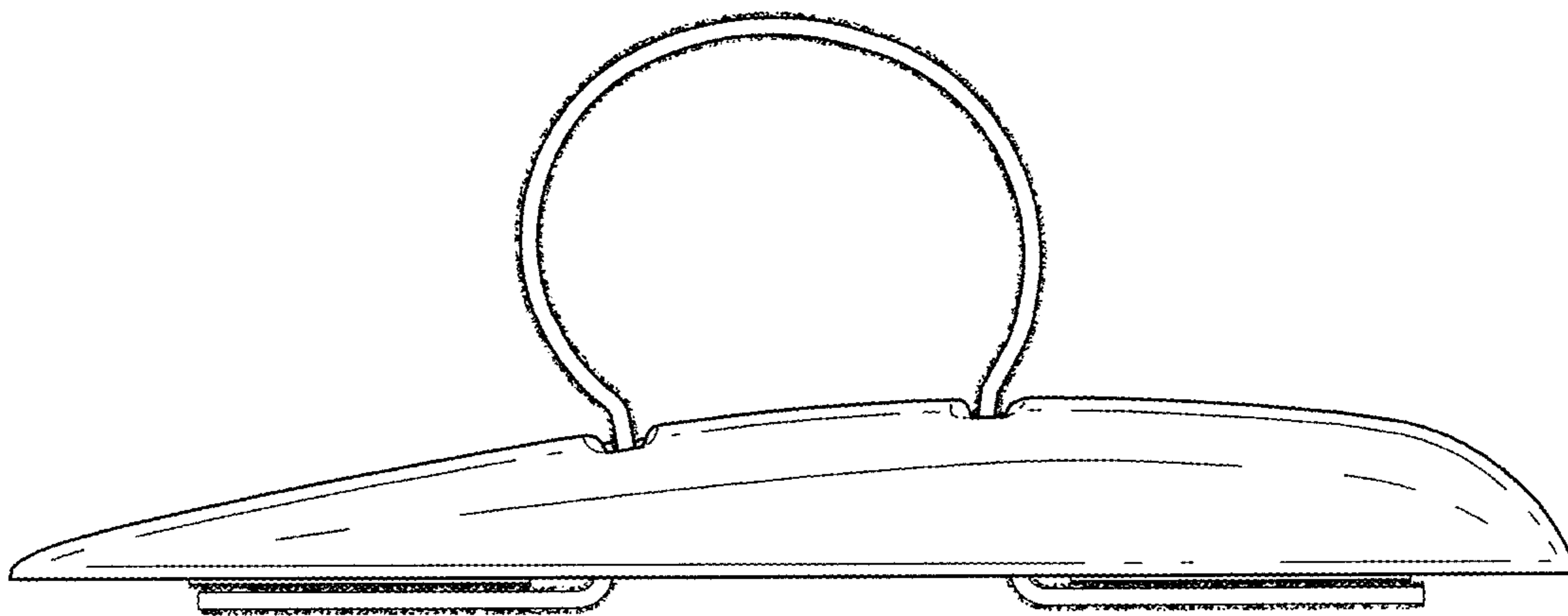

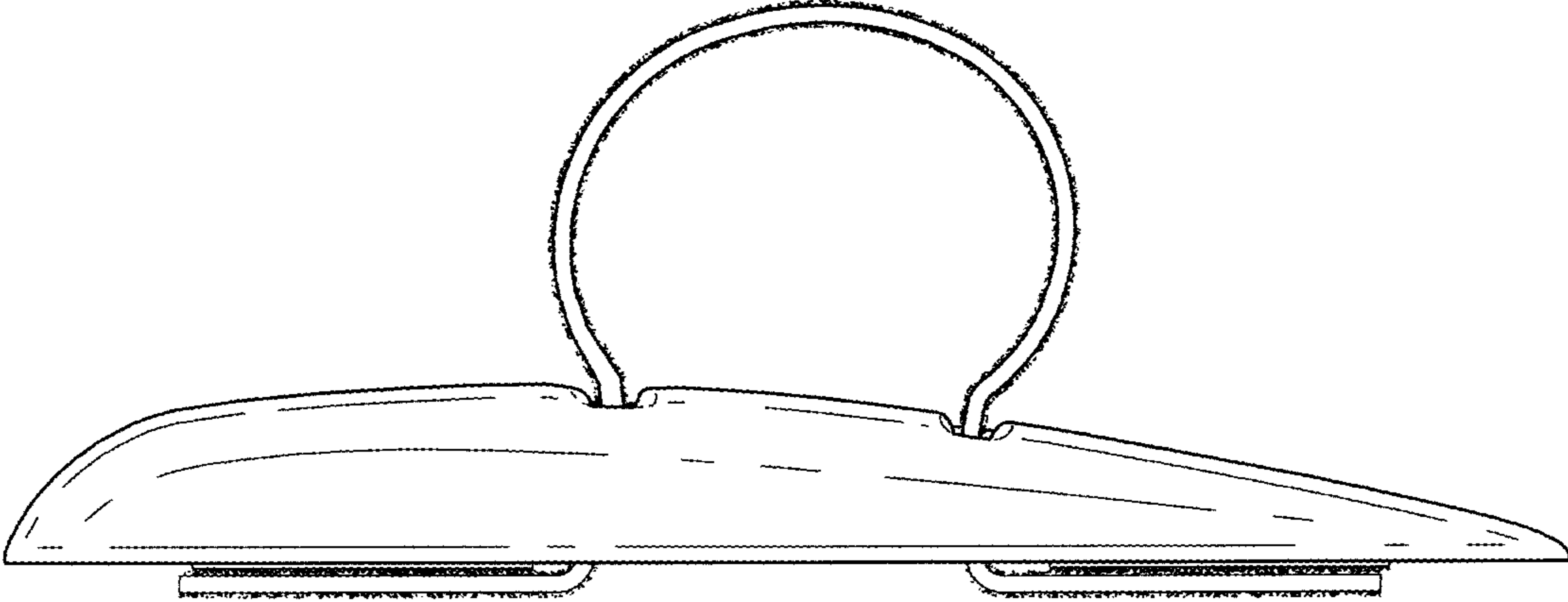

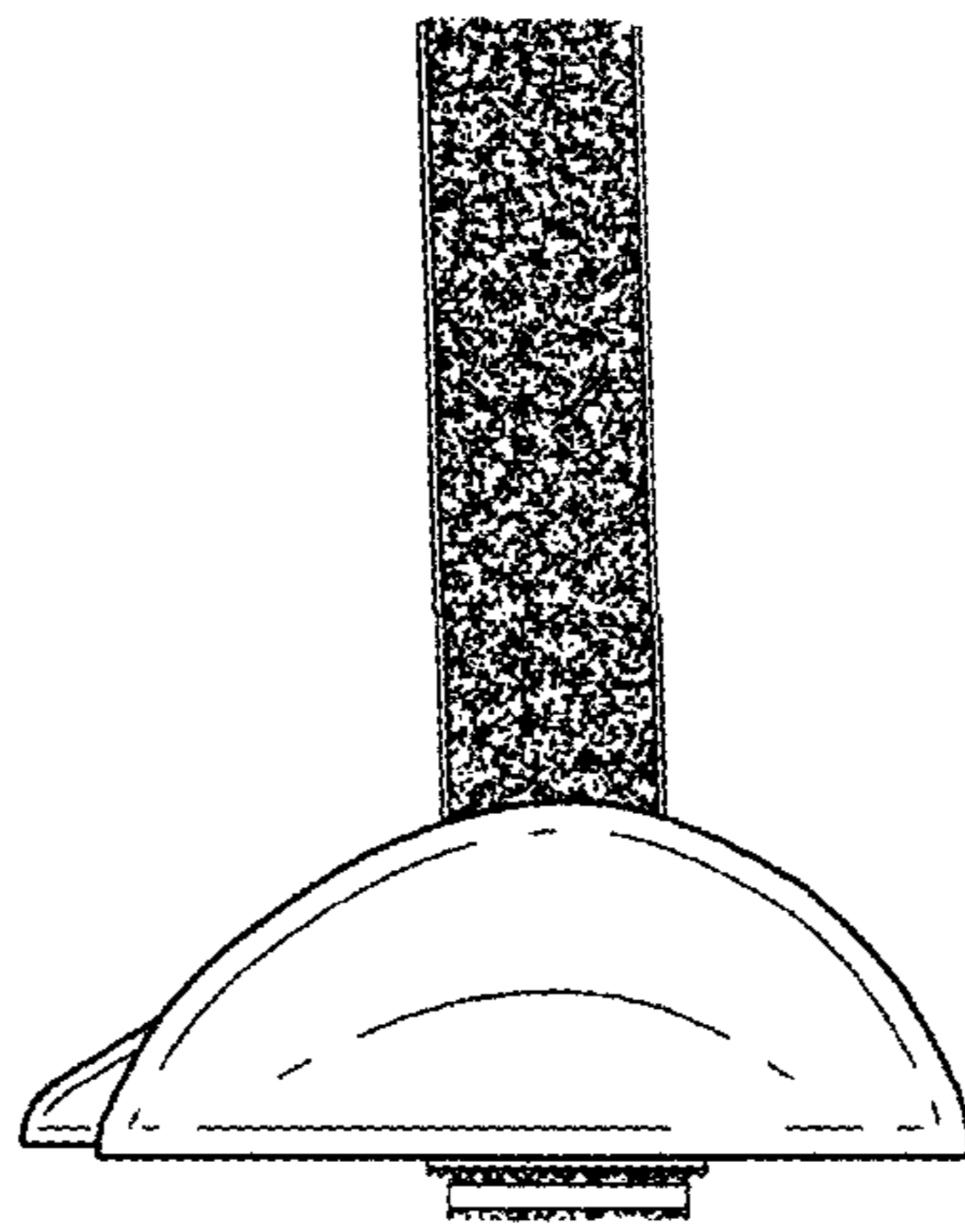
