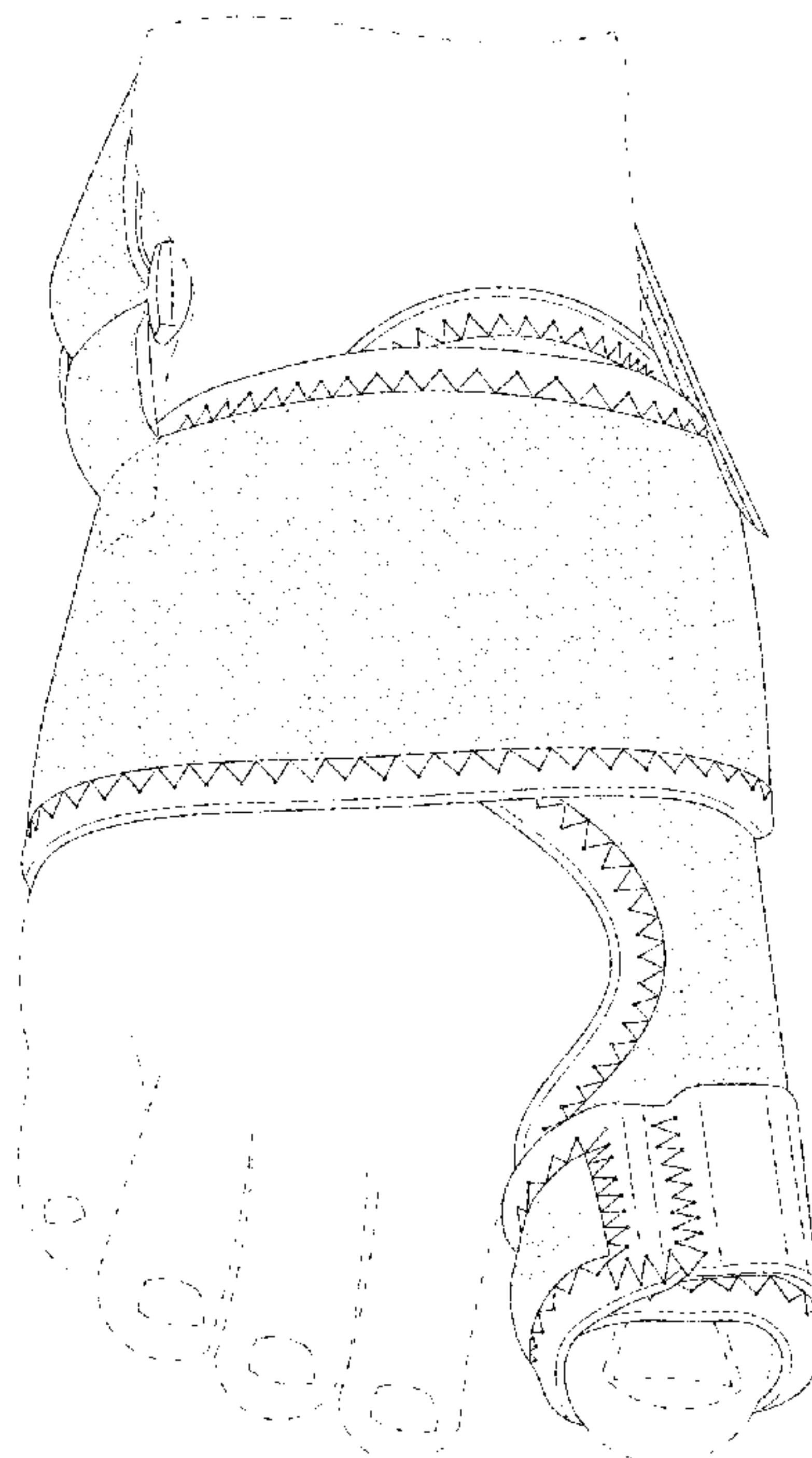
(57) **CLAIM**

I claim the ornamental design for a bunion corrector with buckle, as shown and described.

DESCRIPTION

FIG. 1 is a Perspective view of a bunion corrector with buckle showing my new design;
FIG. 2 is a Front view thereof;
FIG. 3 is a Back view thereof;
FIG. 4 is a Left-side view thereof;
FIG. 5 is a Right-side view thereof;
FIG. 6 is a Top view thereof;
FIG. 7 is a Bottom view thereof;
FIG. 8 is another perspective view of the bunion corrector with buckle as shown in FIG. 1;

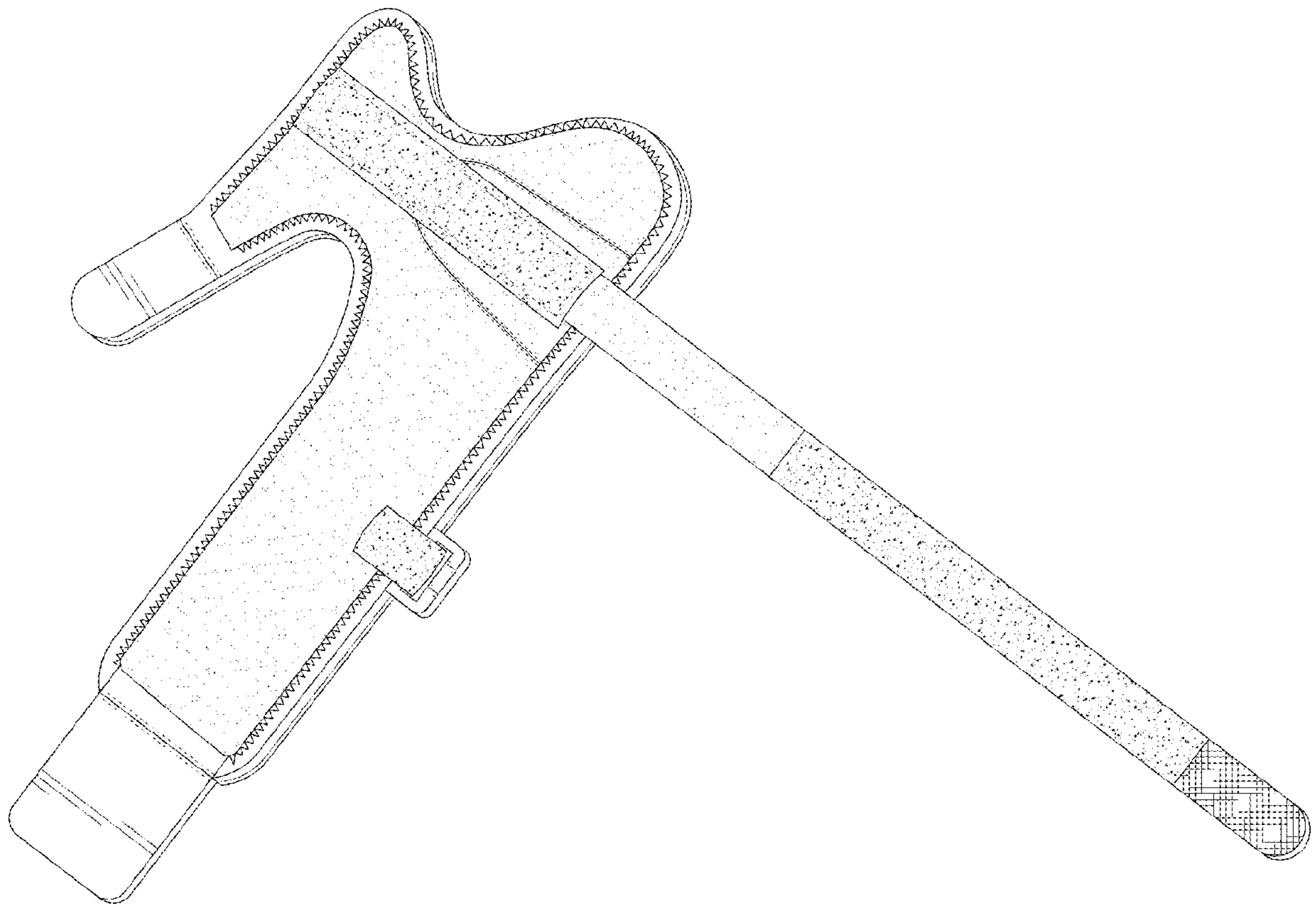

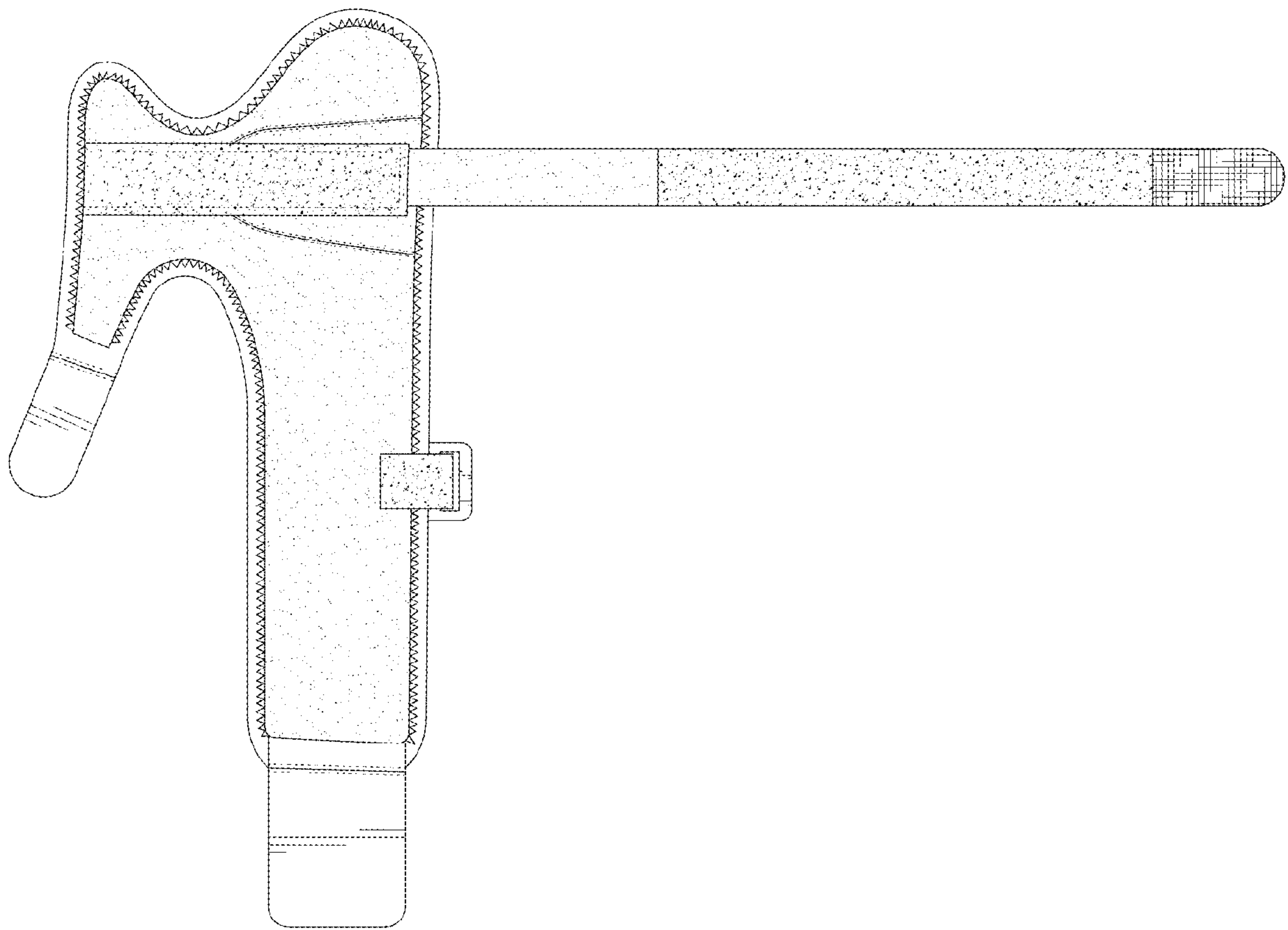

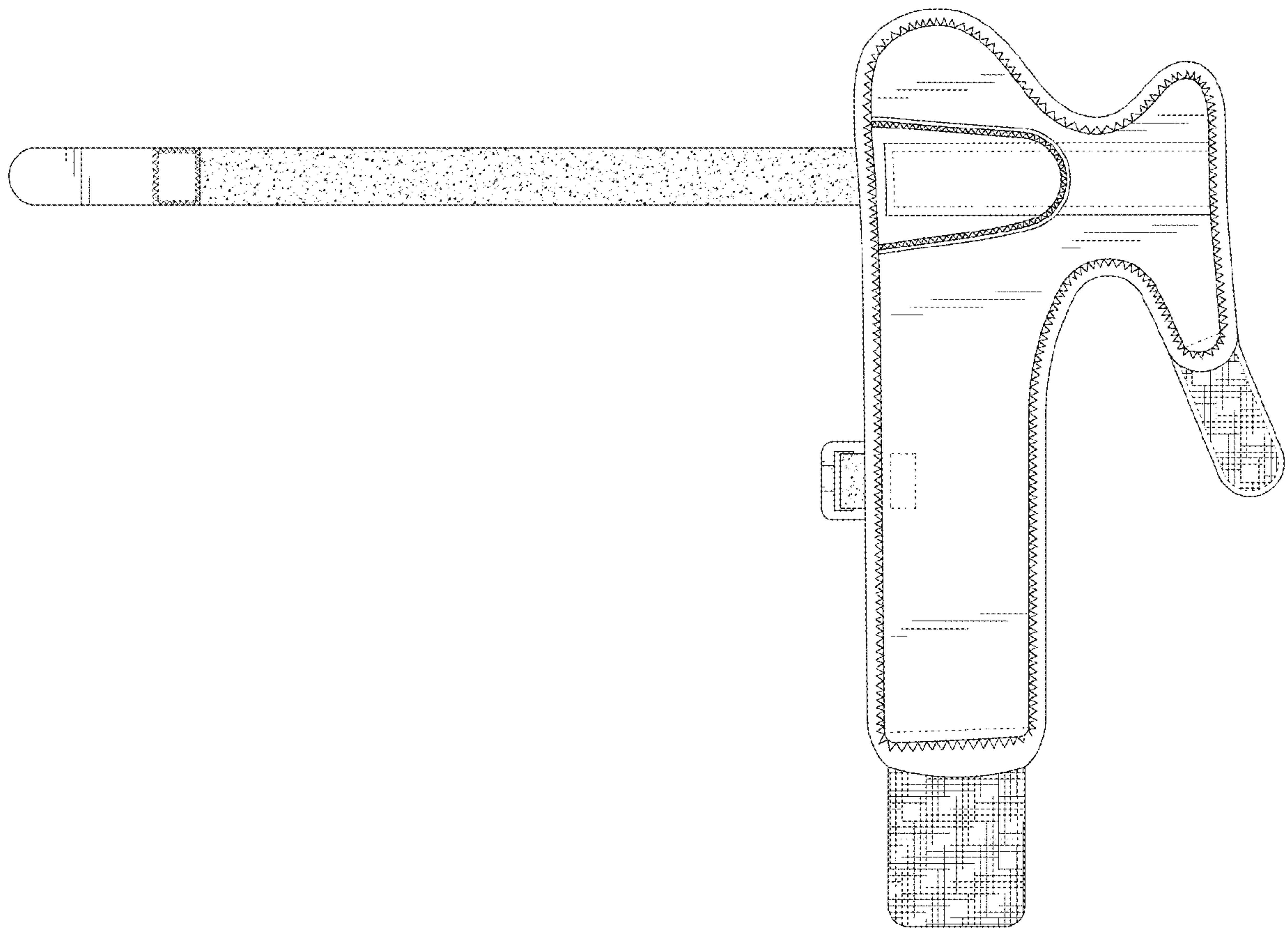

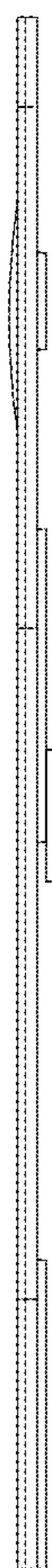

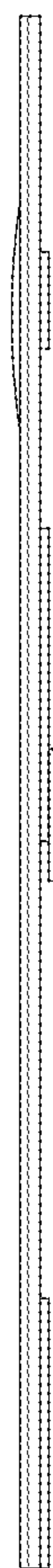

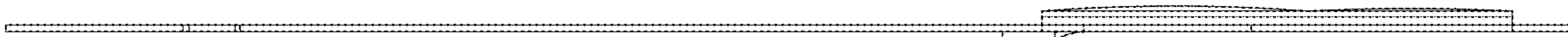

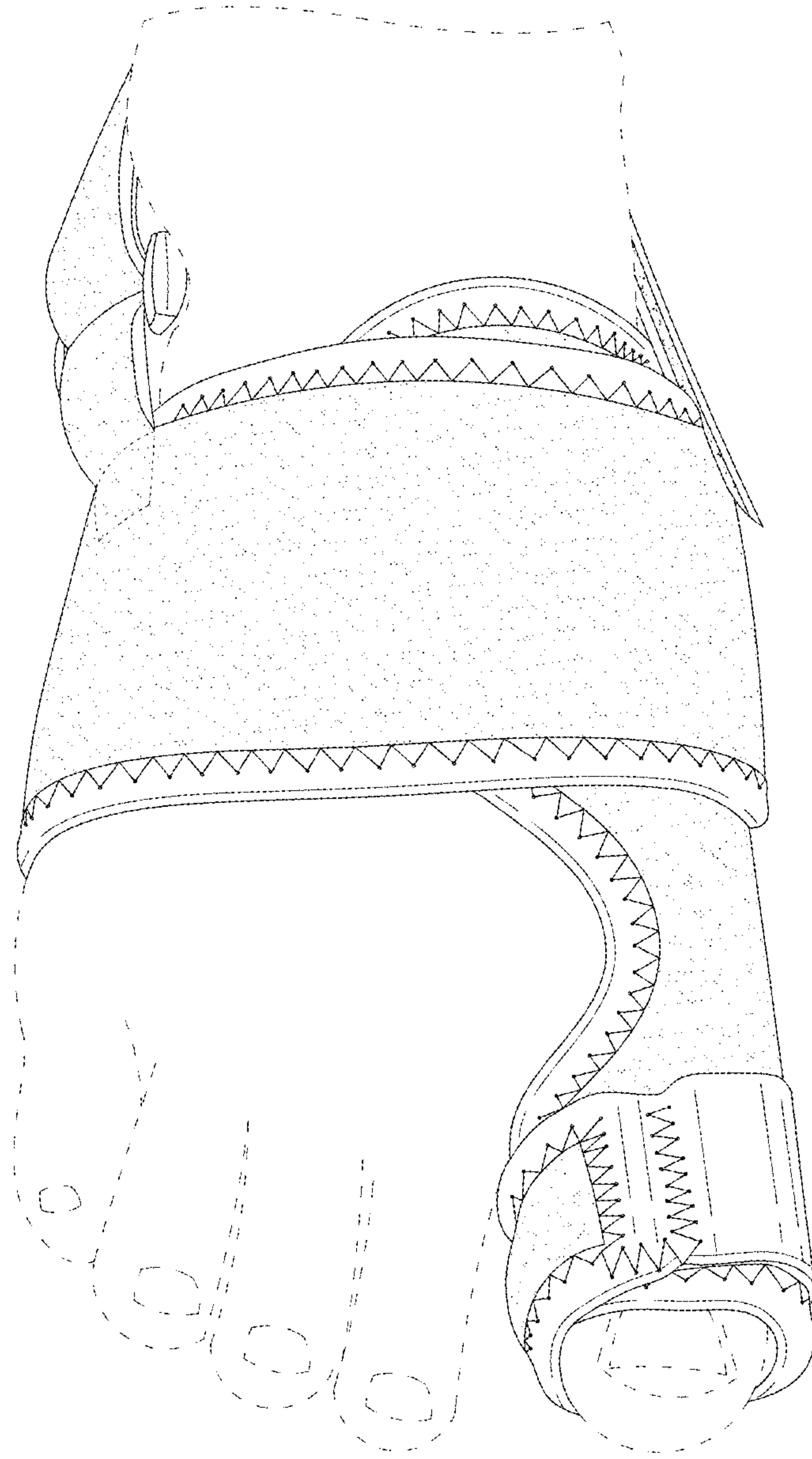

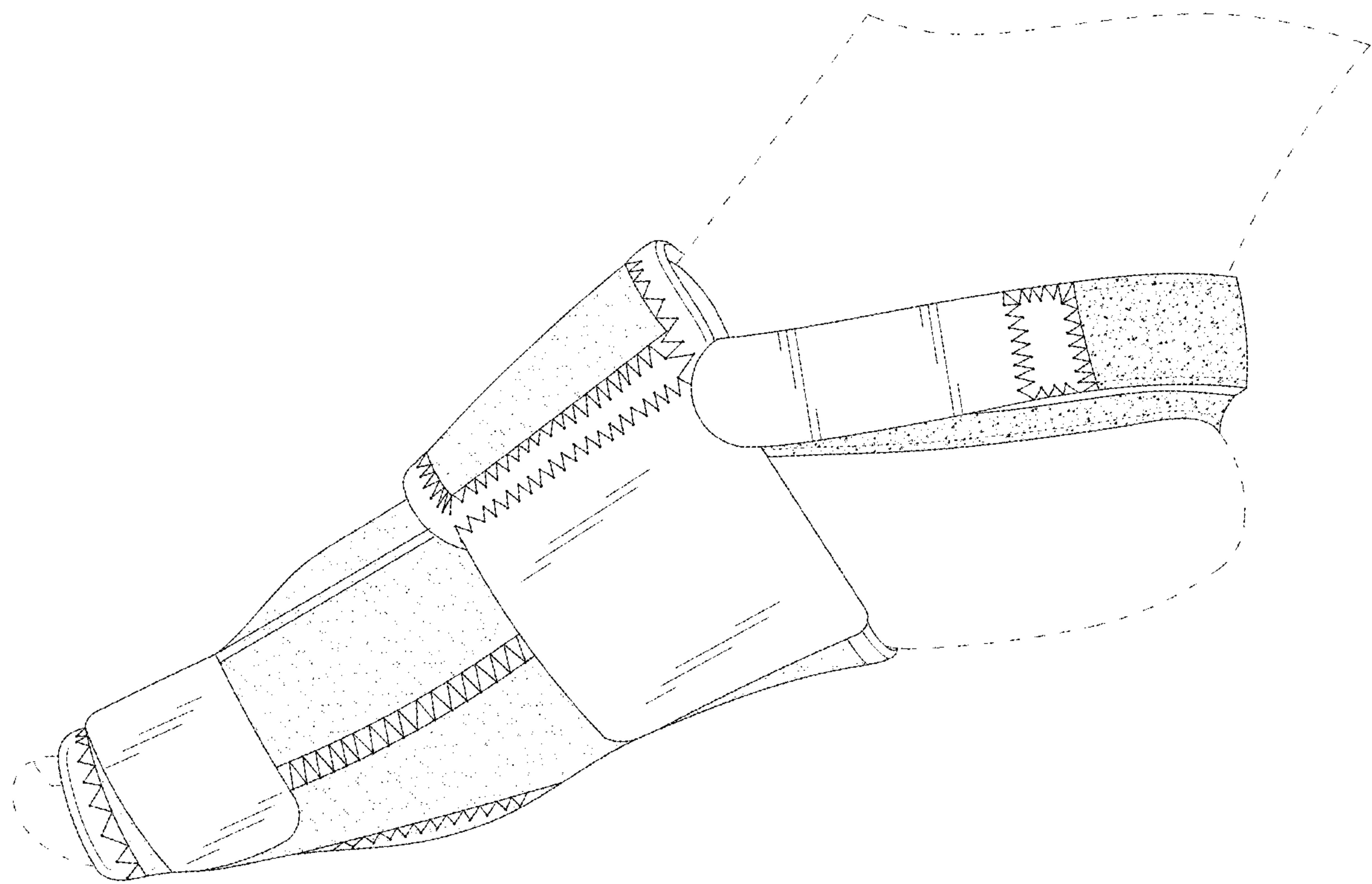

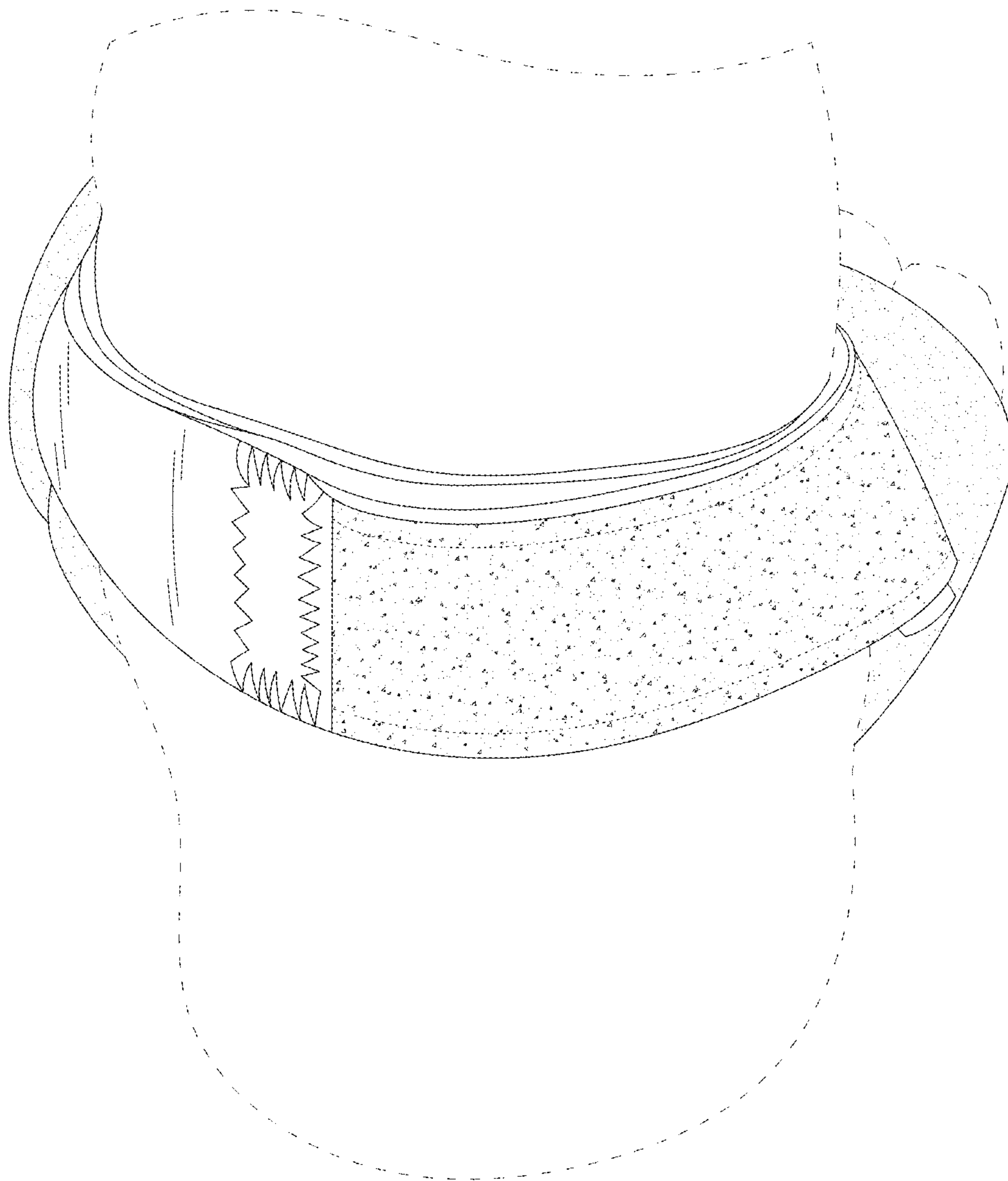
