DESCRIPTION

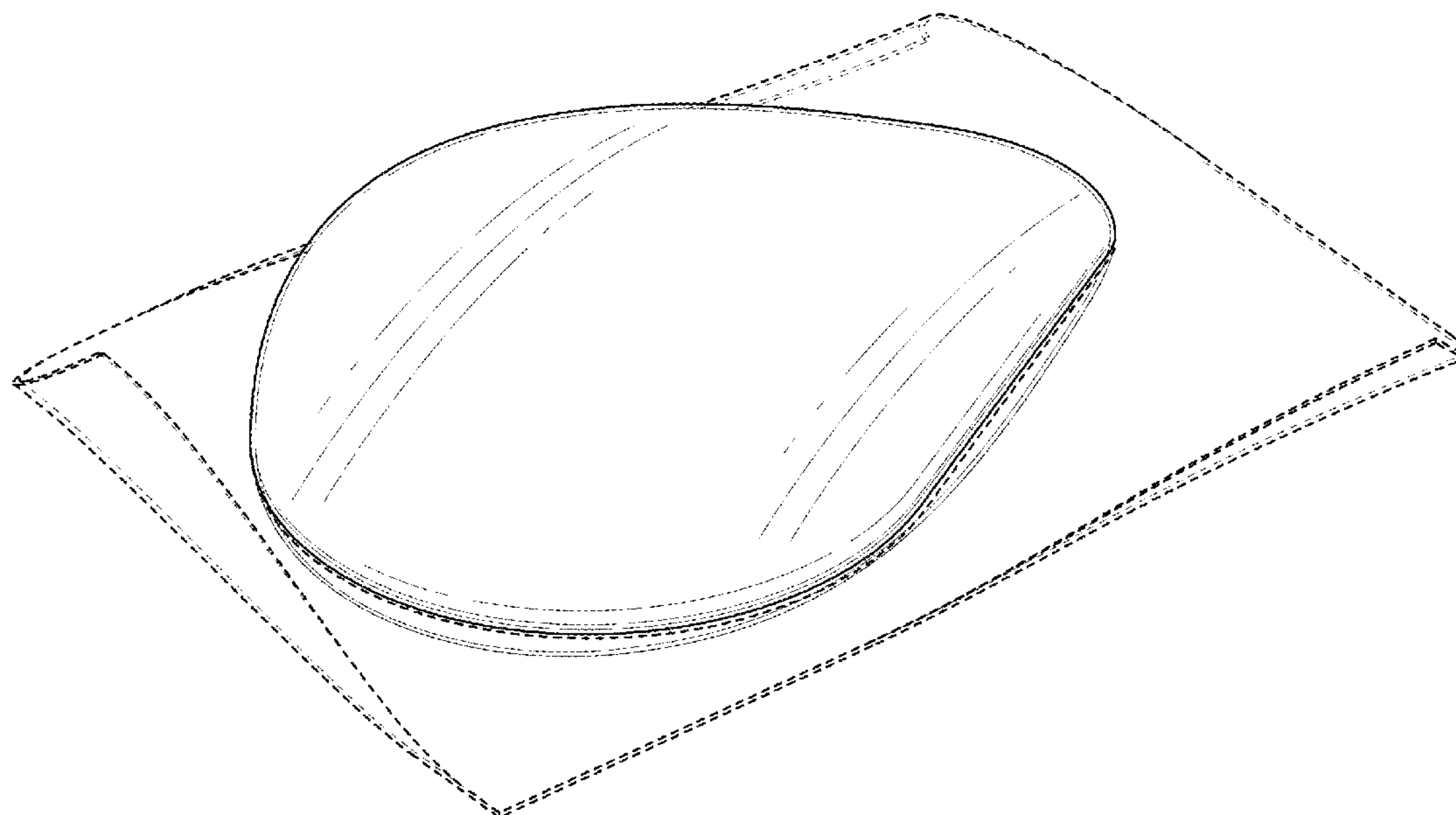
FIG. 1 is a right/back side perspective view of the hygiene product pod design.

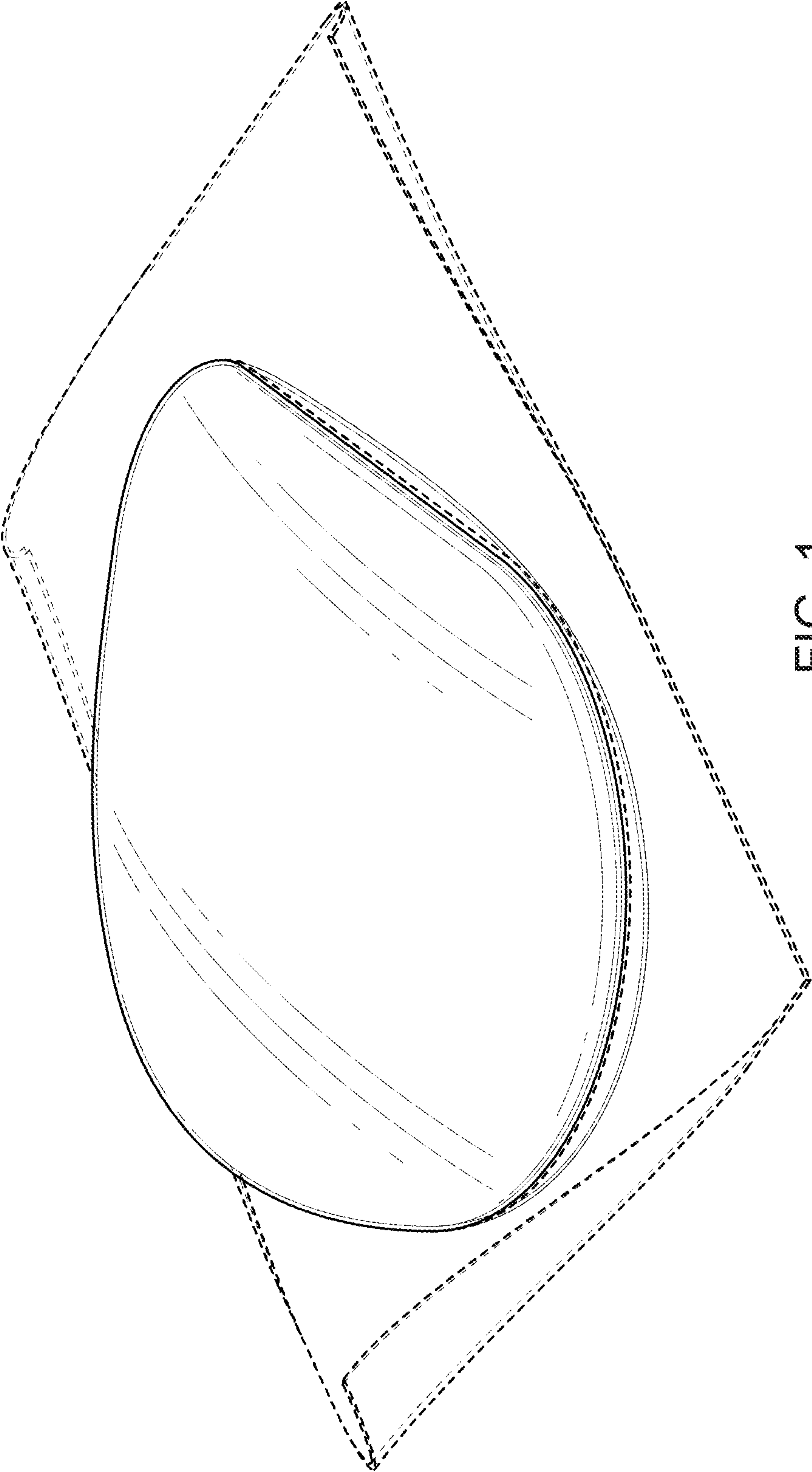

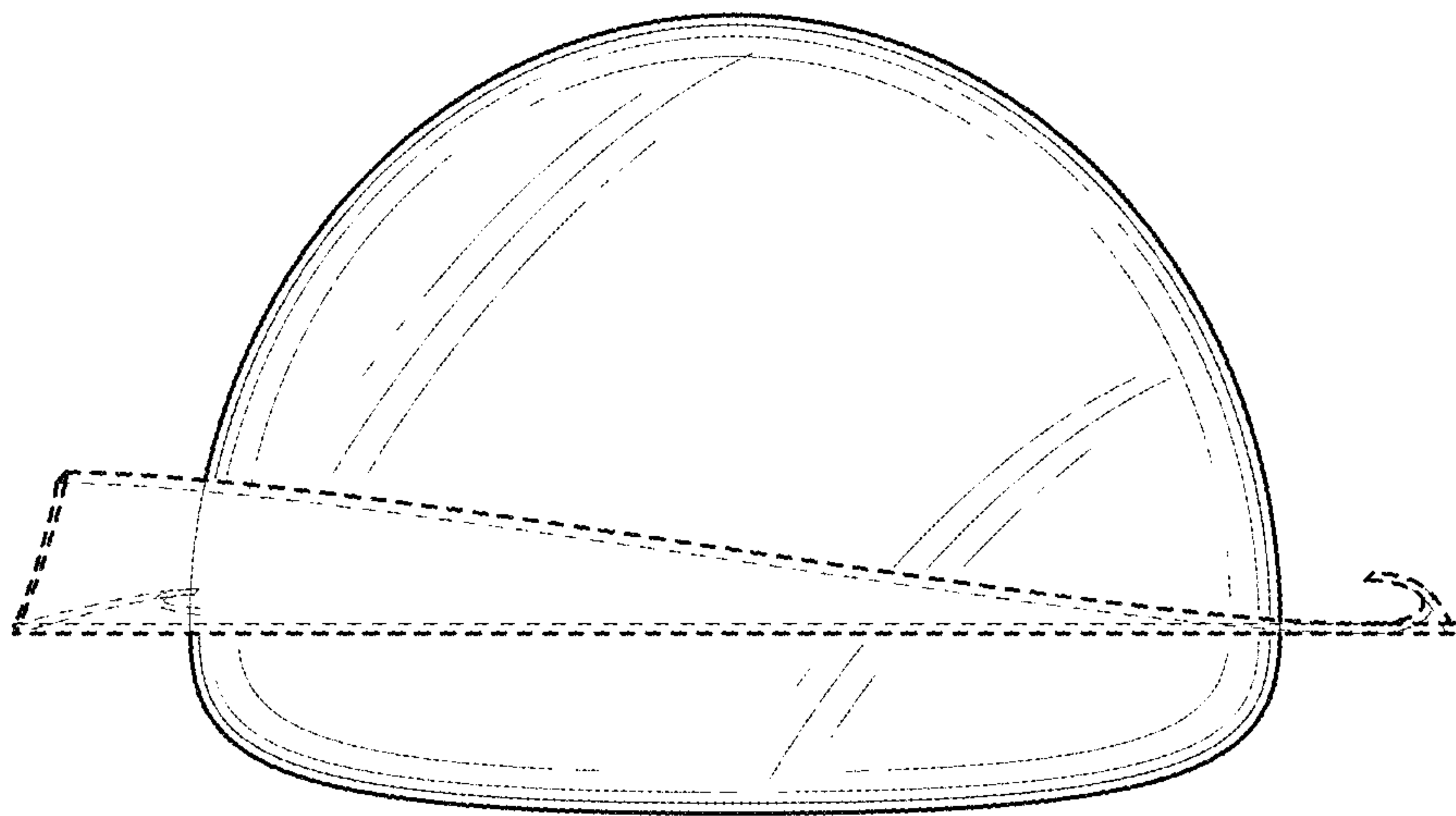

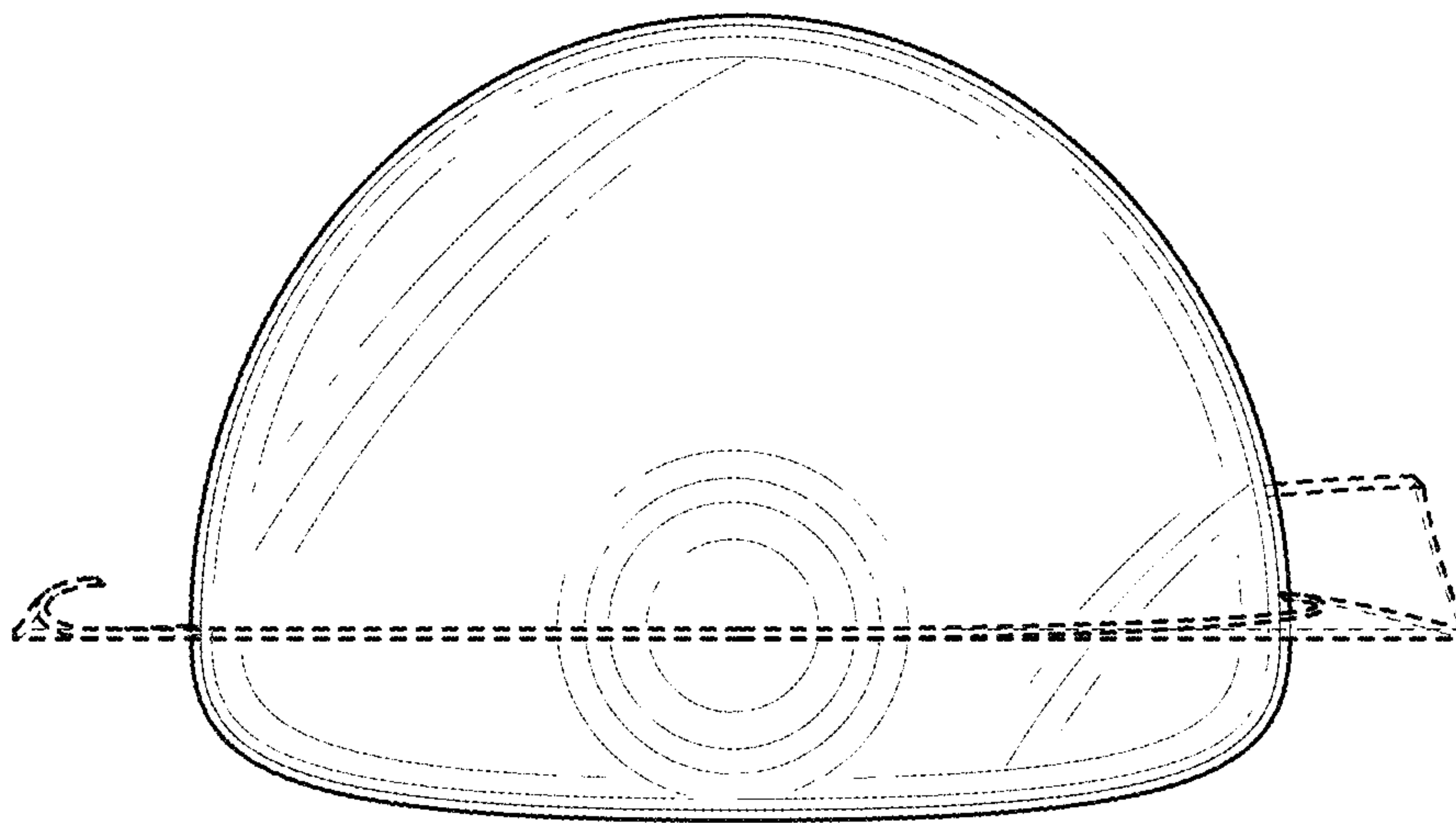

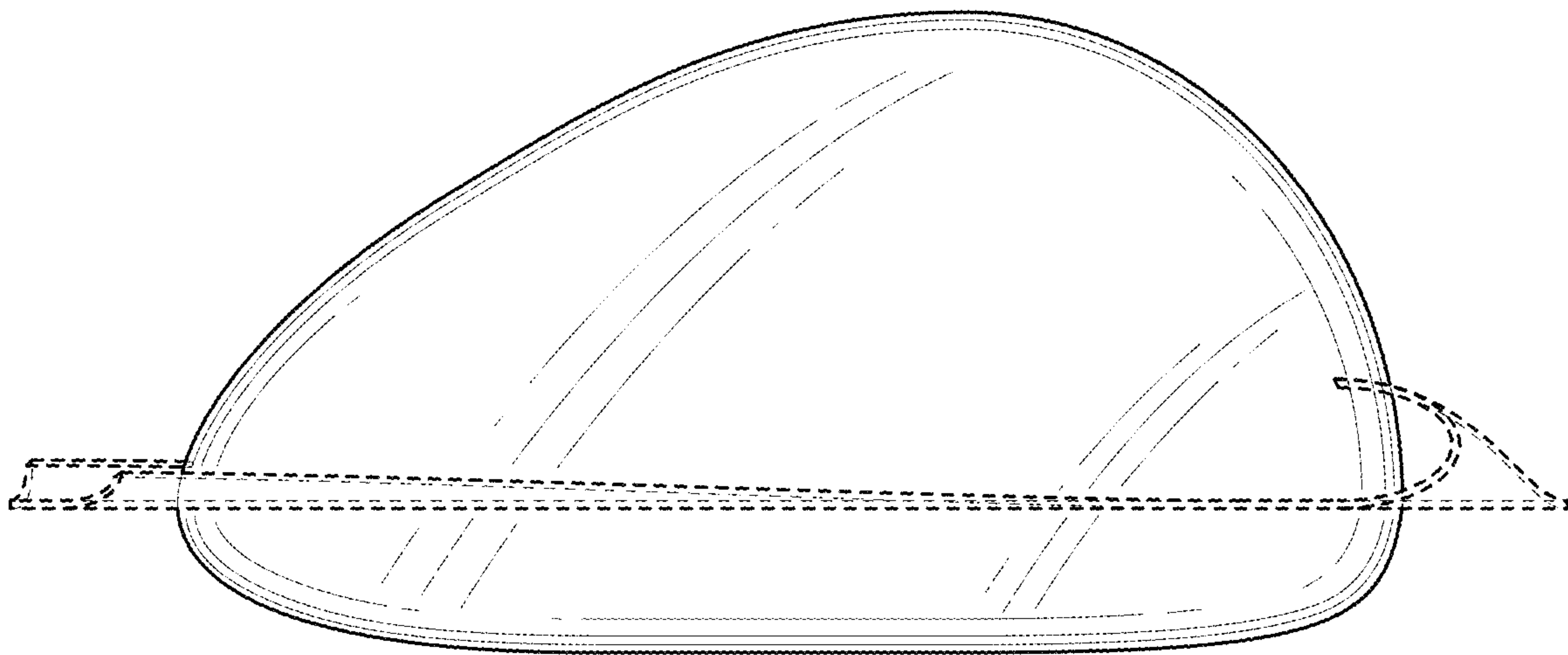

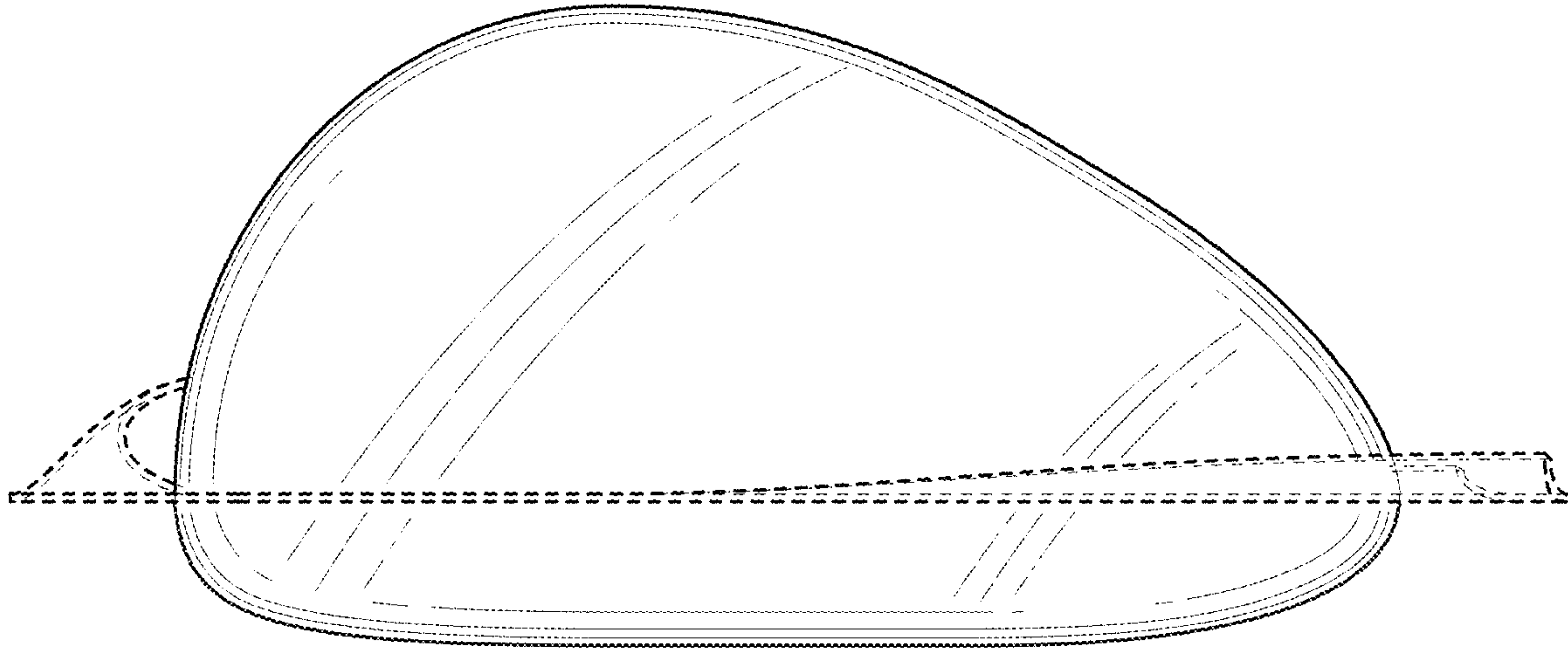

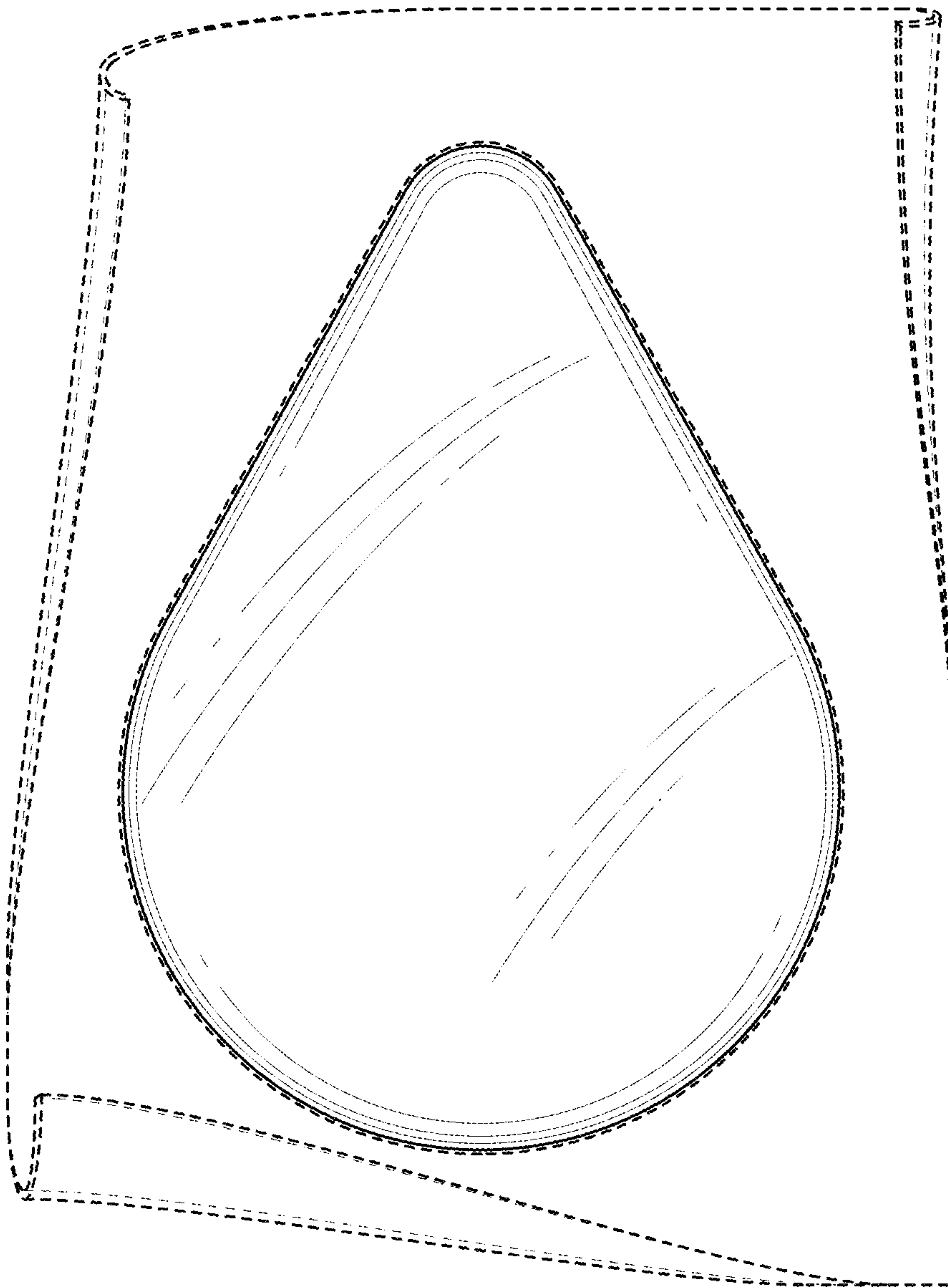

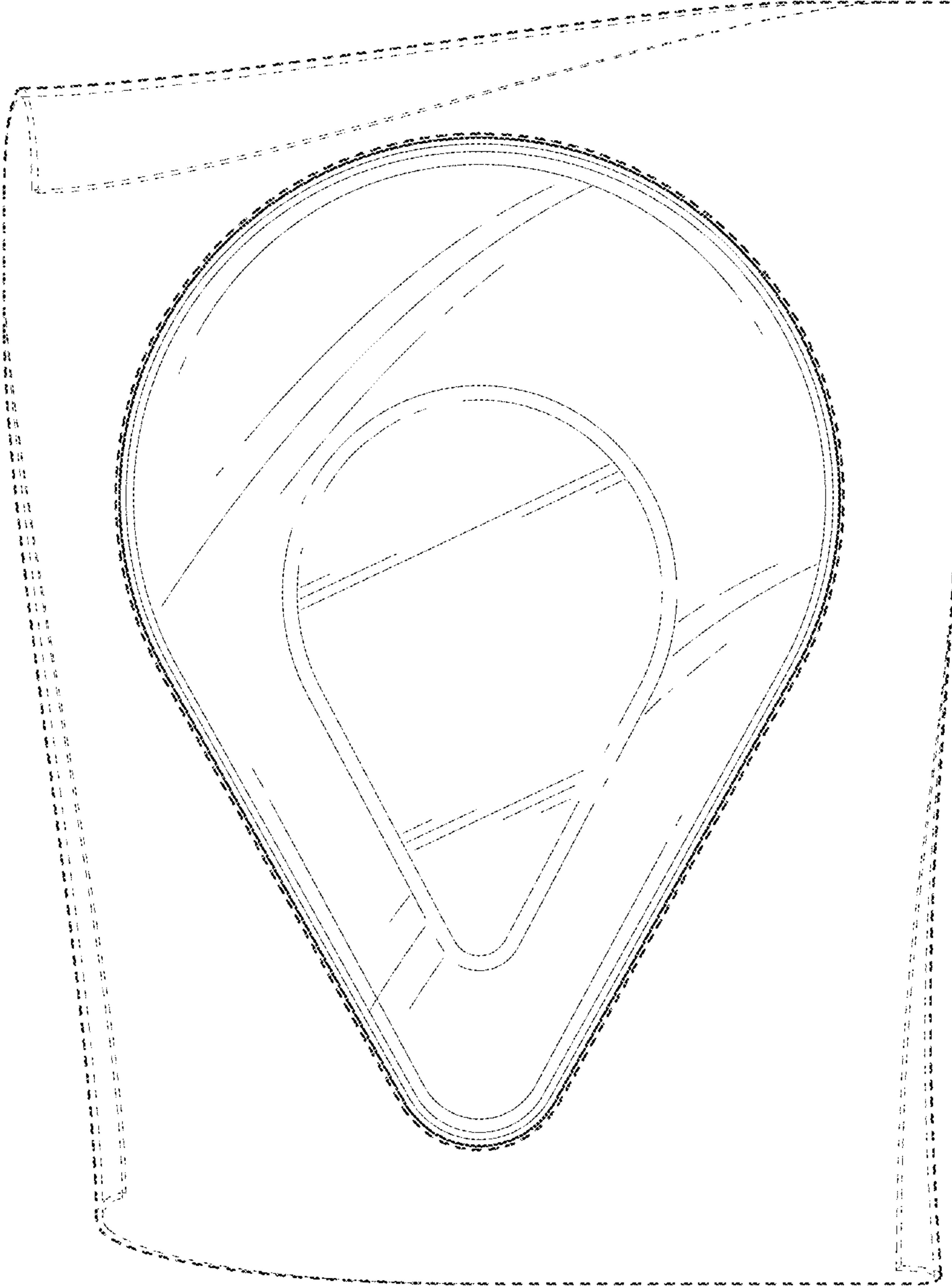
