FIG. 7 is a bottom view thereof.

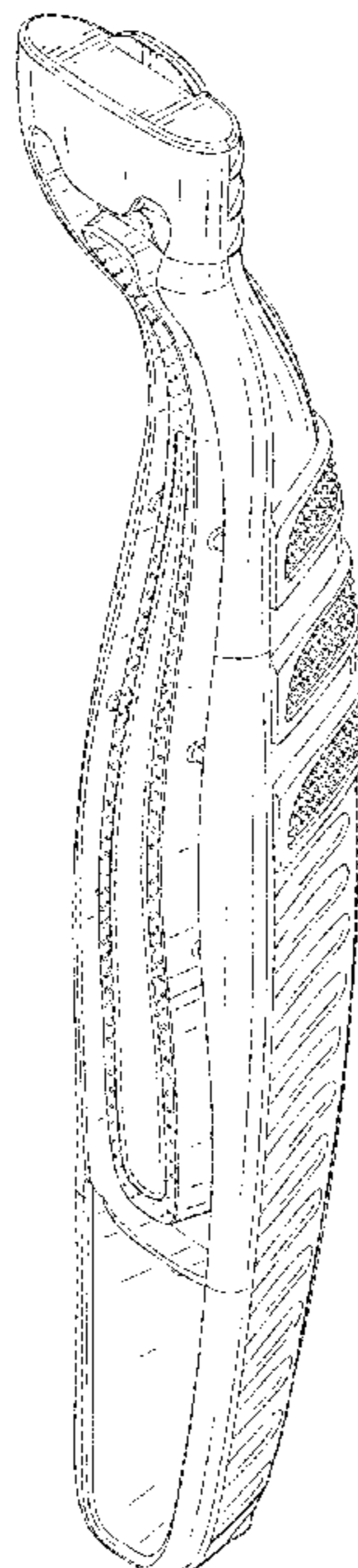
The broken lines illustrate a portion of the razor handle that forms no part of the claimed design.

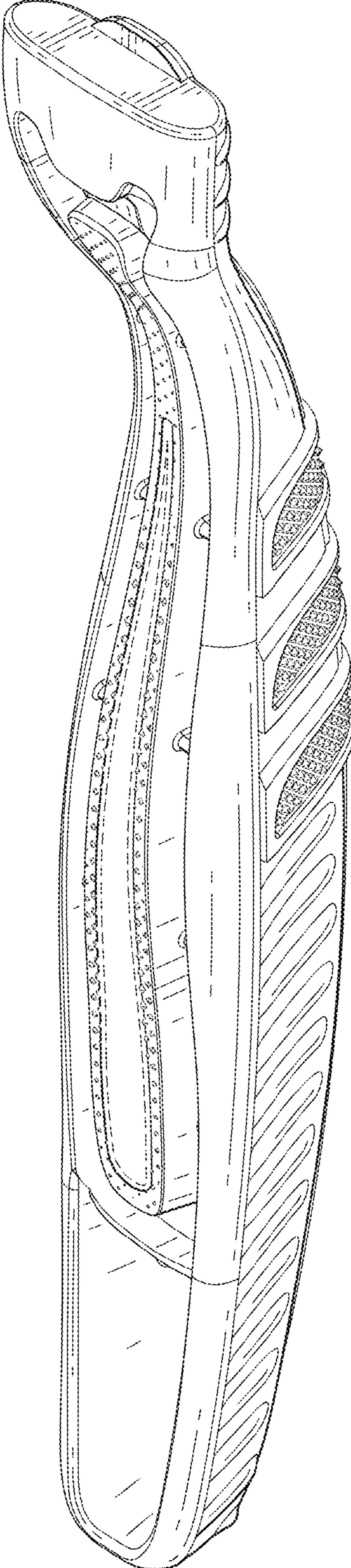

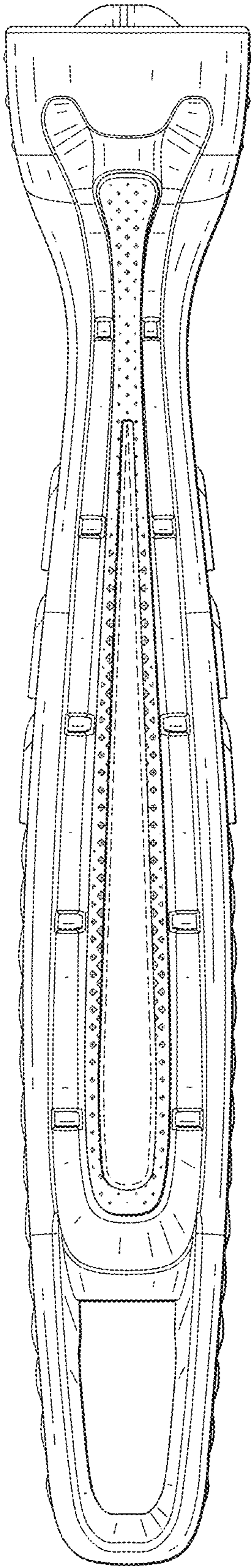

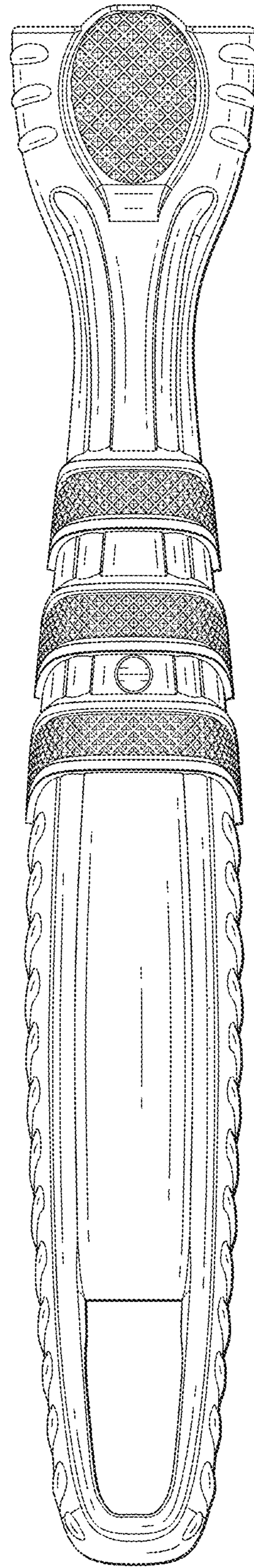

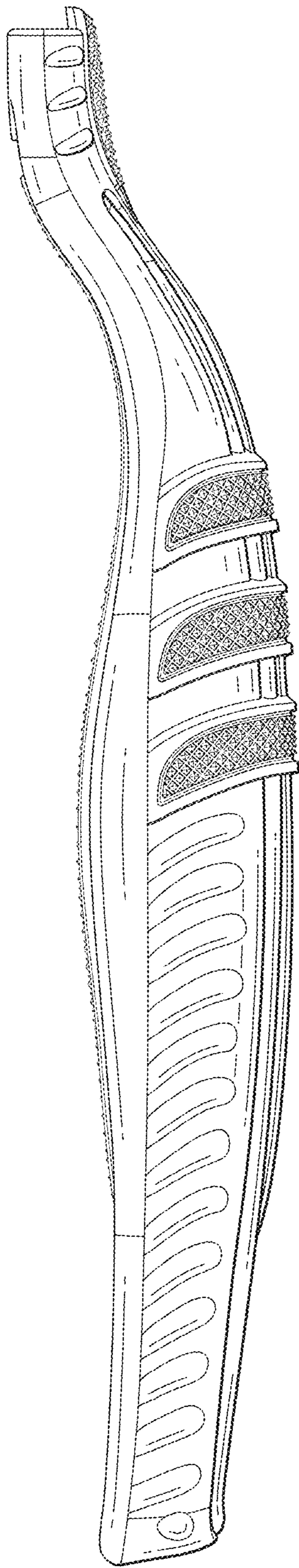

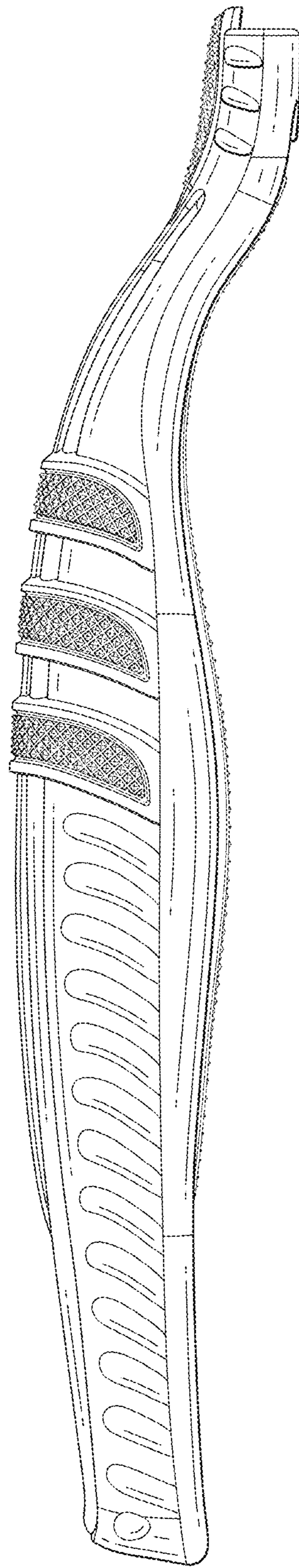

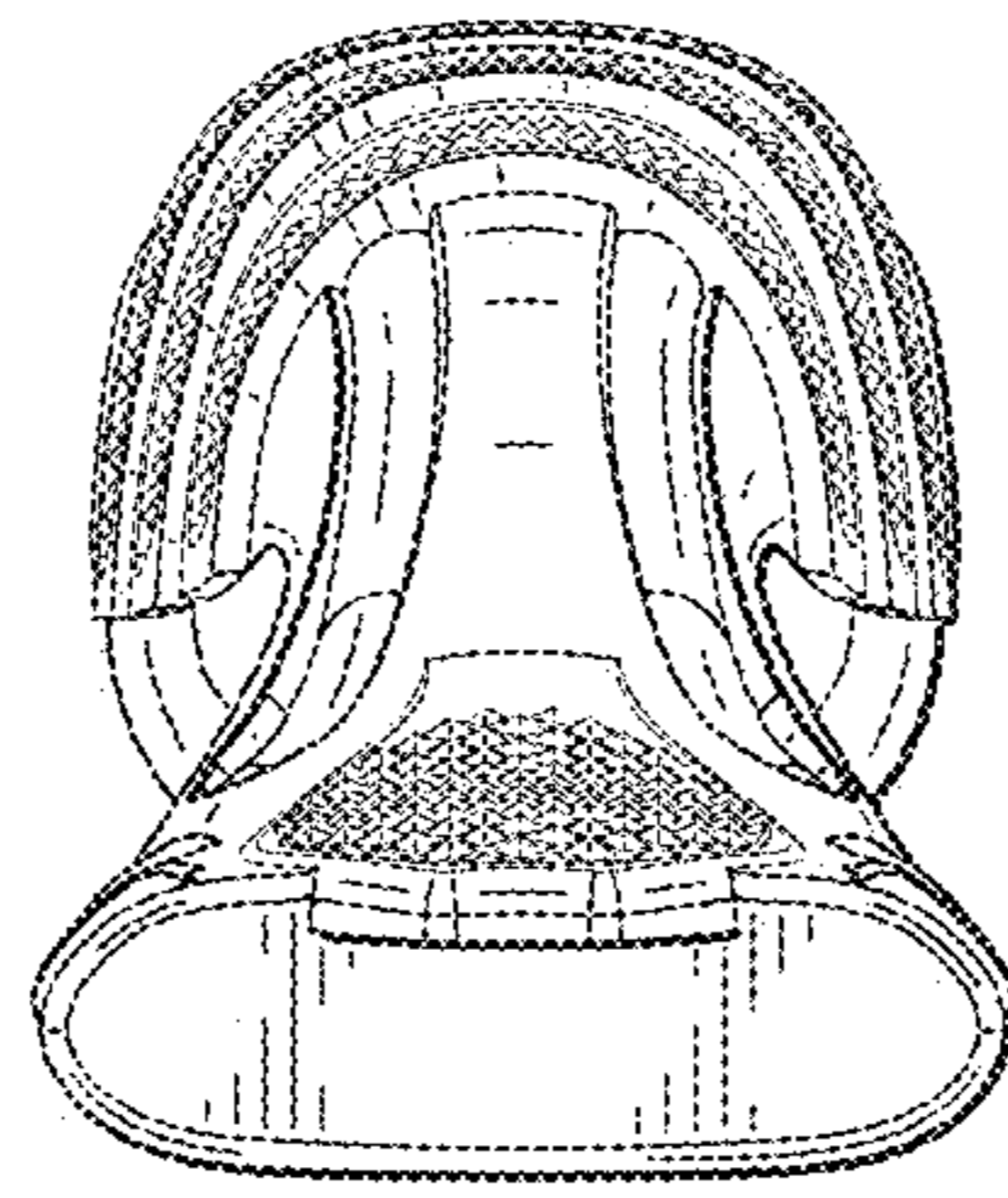

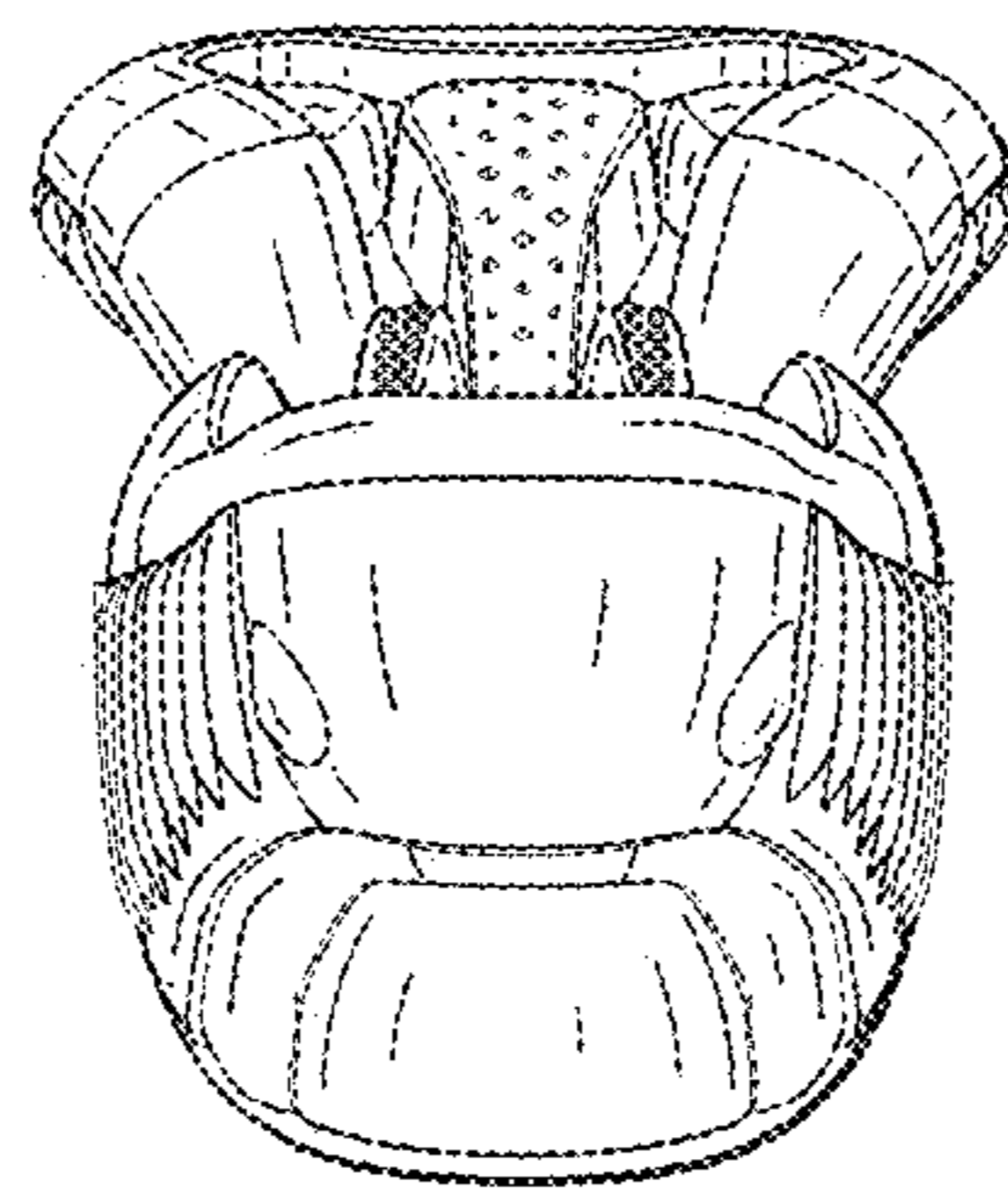
