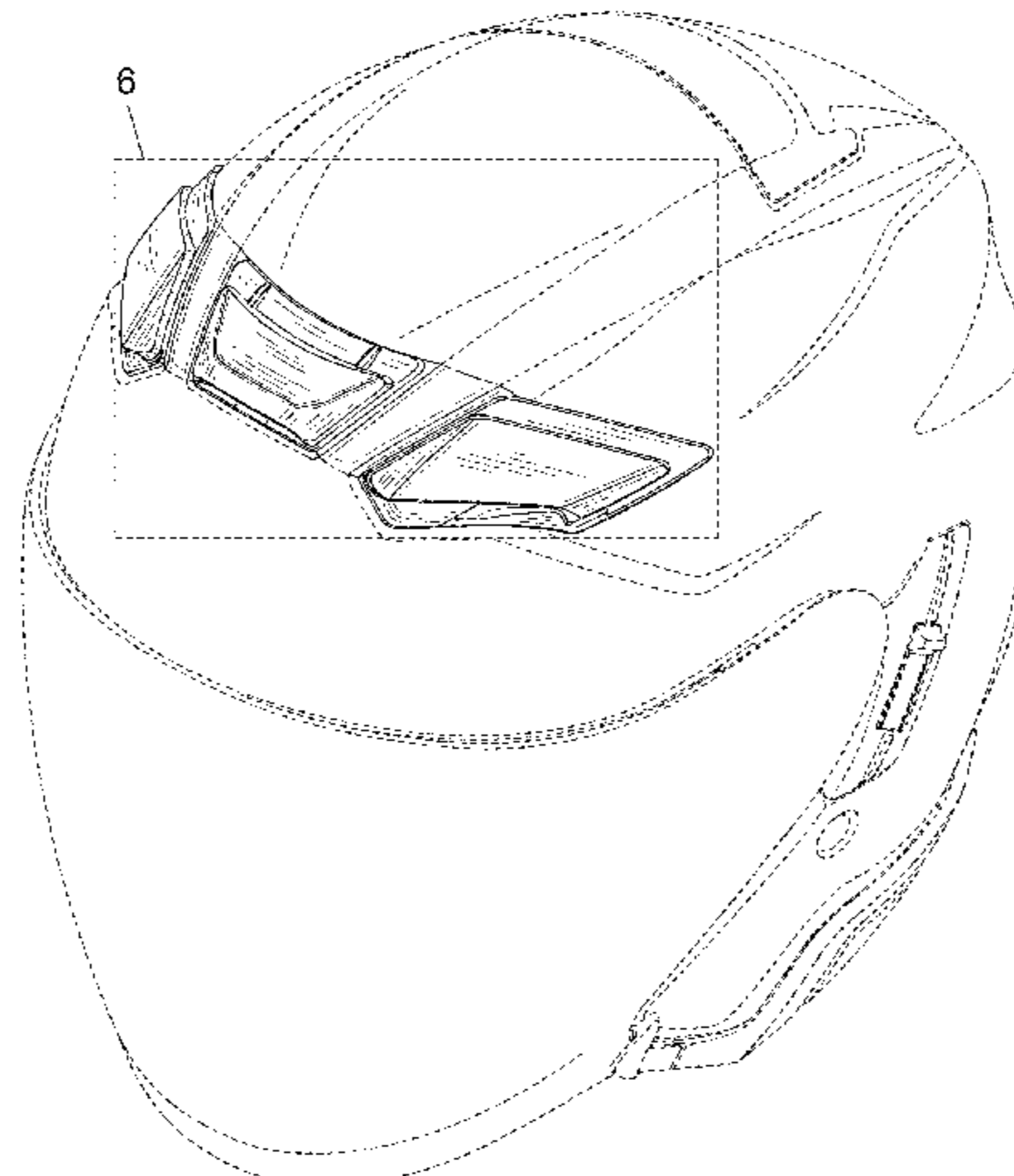
The ornamental design for a helmet, as shown and

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a
helmet showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof; and,
FIG. 6 is an enlarged view taken from within the area labeled
"6" in FIG. 1.

The broken lines illustrate portions of the helmet that form
no part of the claimed design. The dashed-dotted lines in the
drawings denote the boundary of the claim and form no part
of the claimed design.

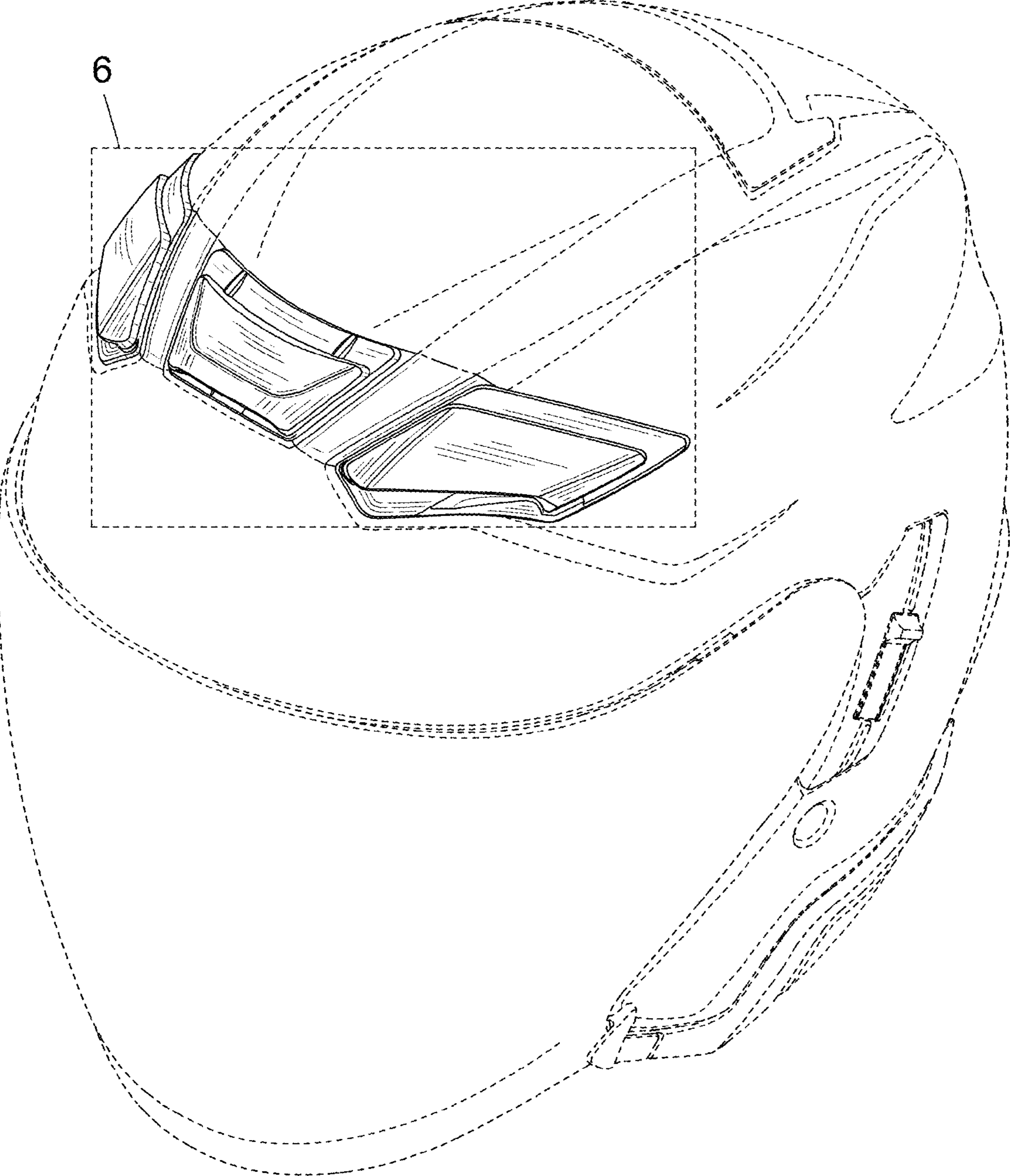

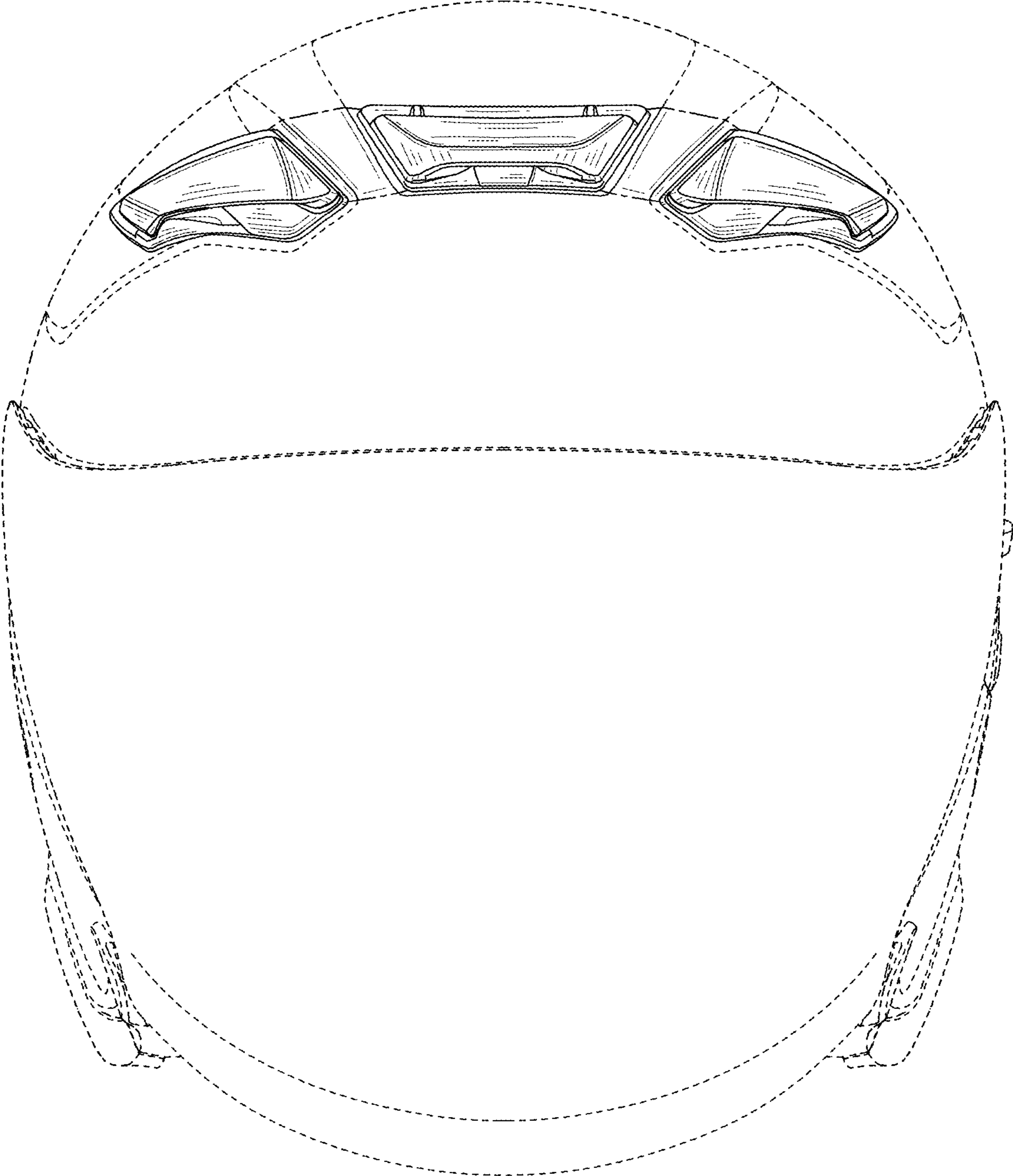
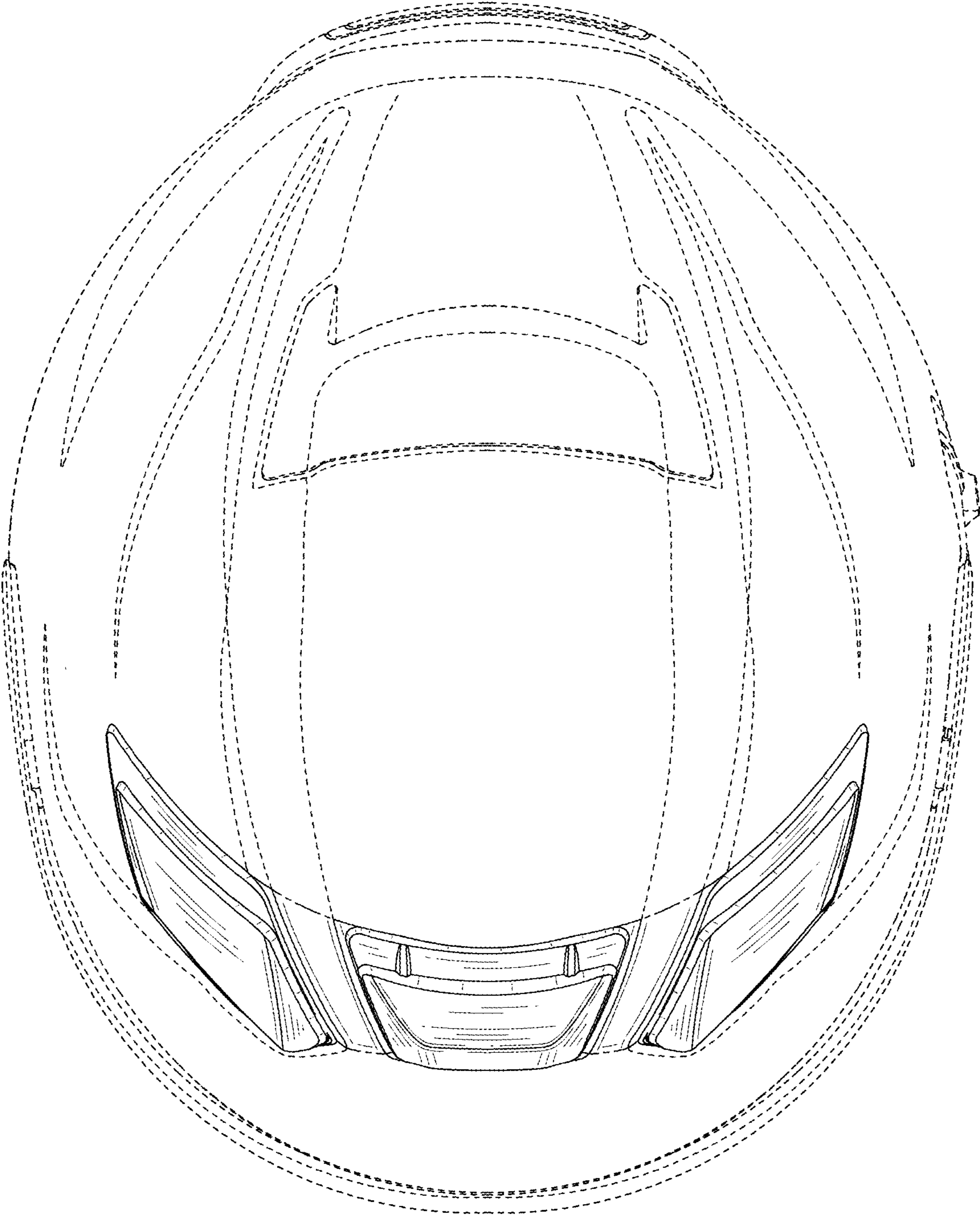

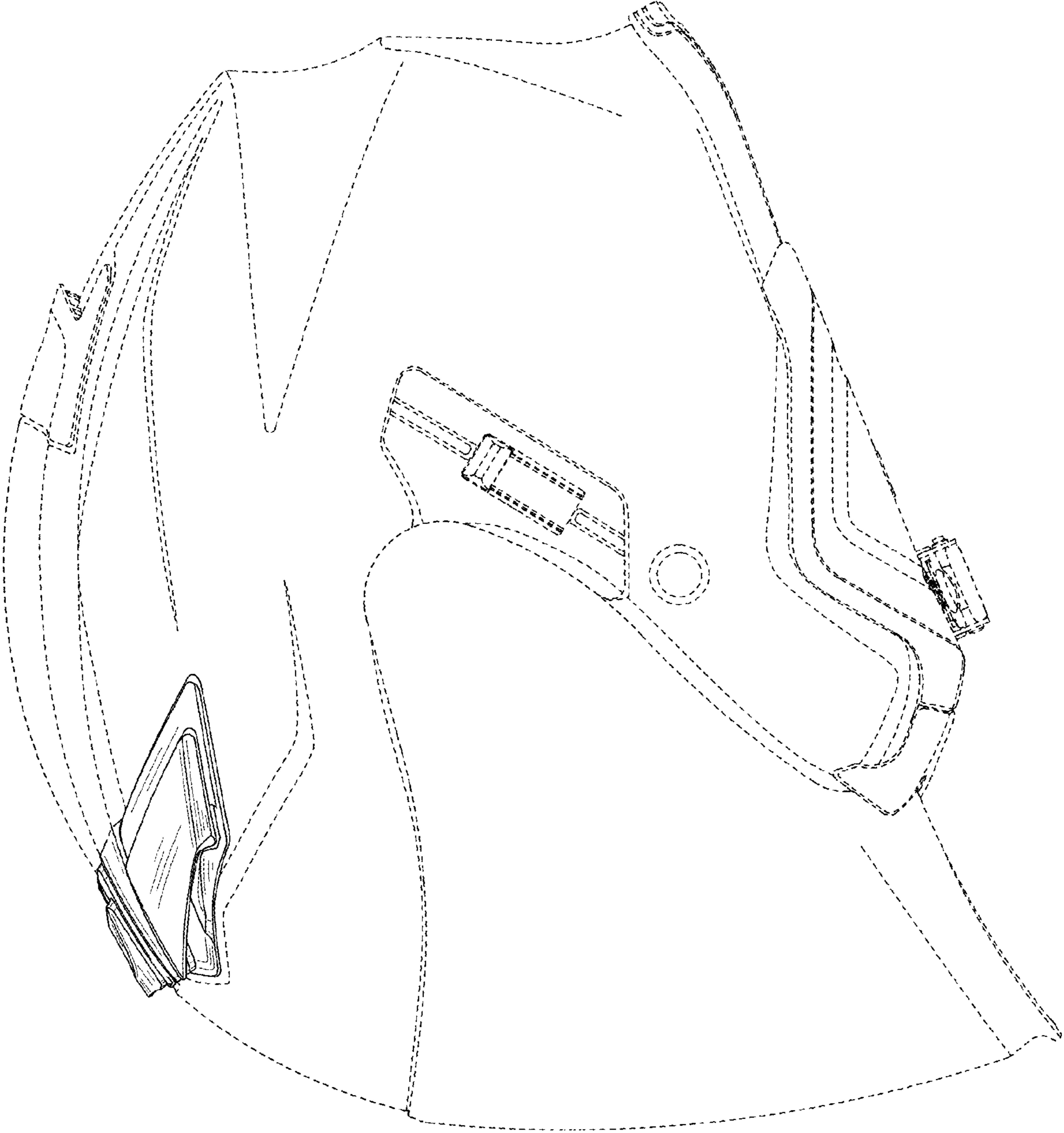

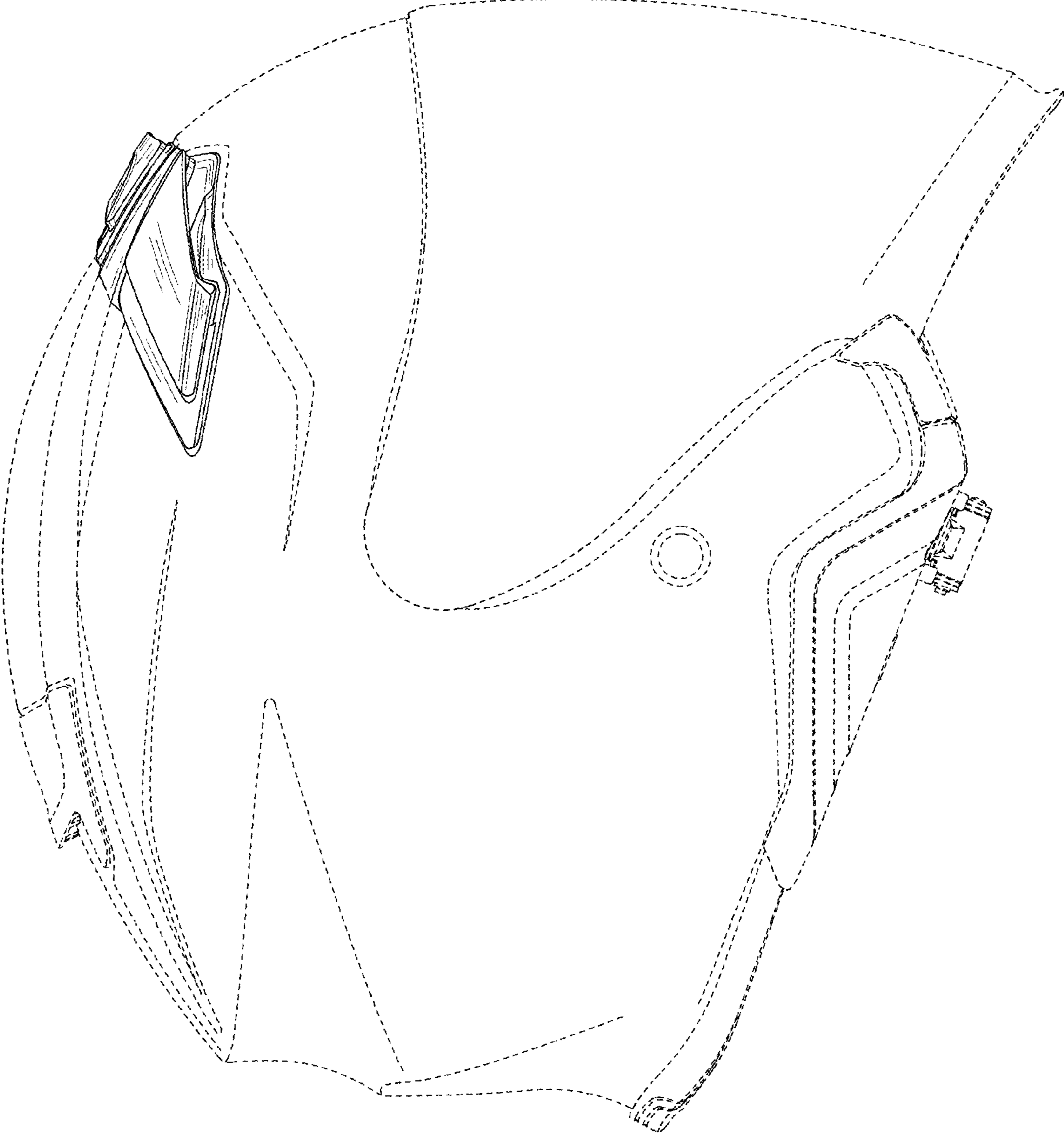

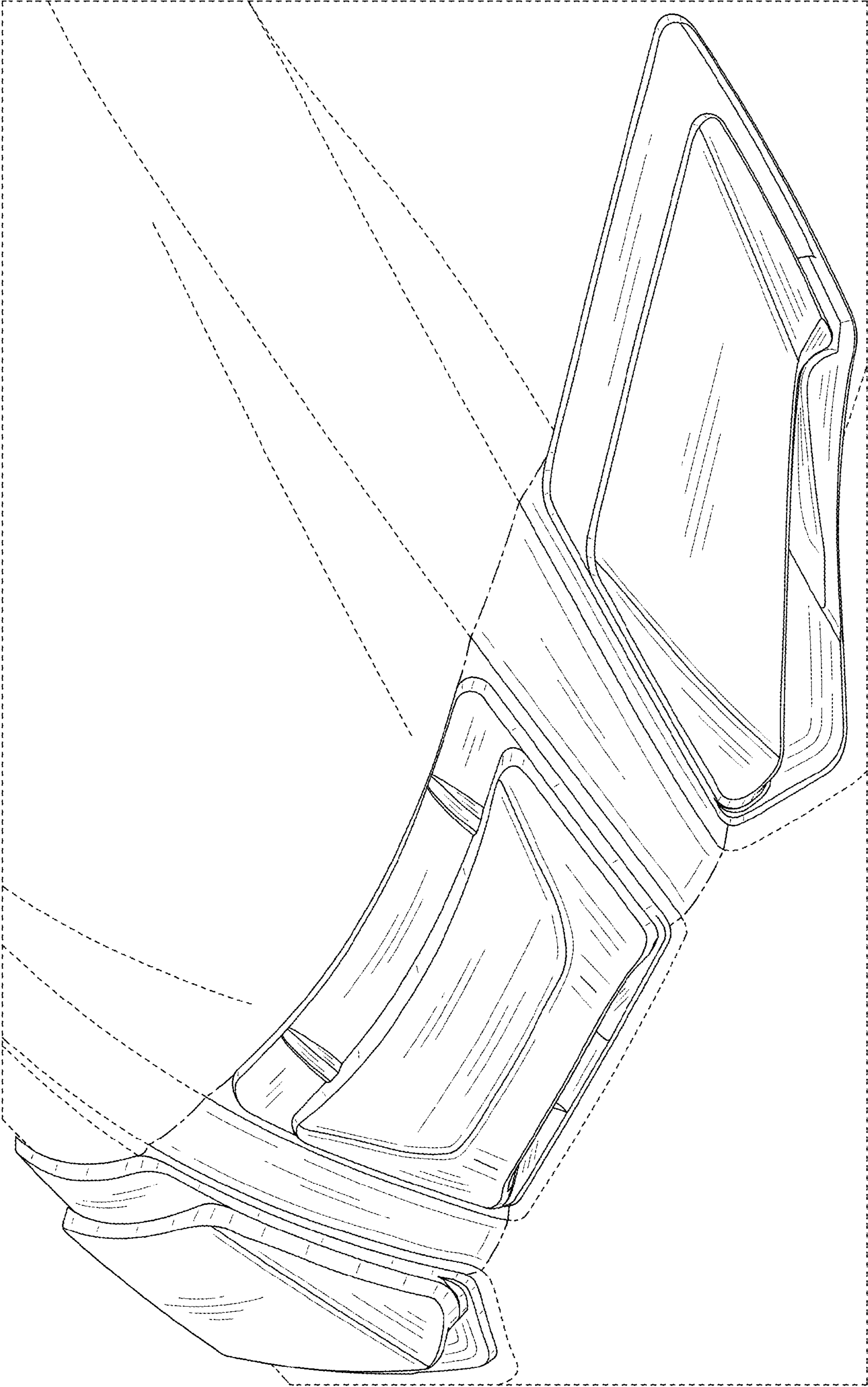
