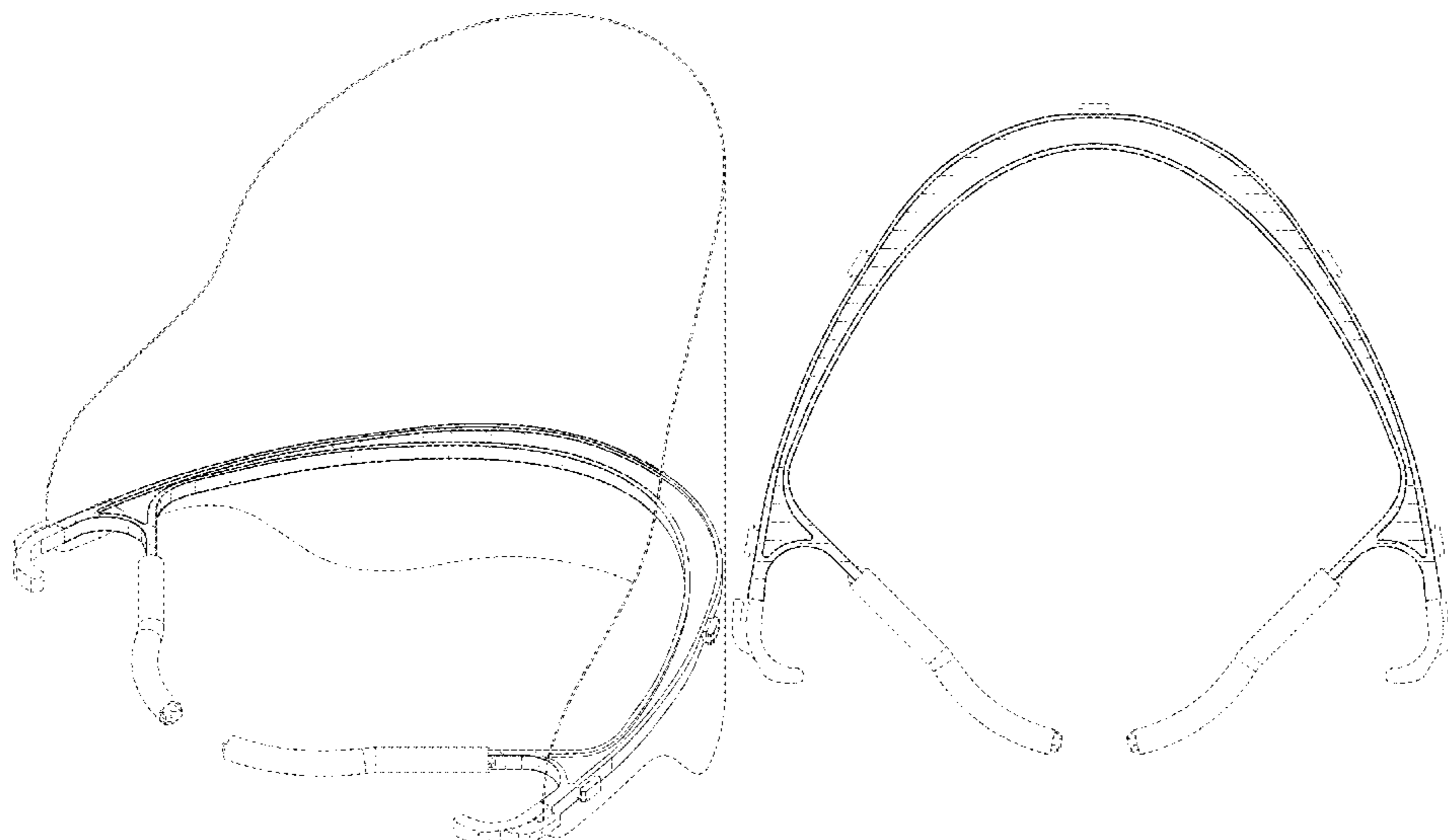
(57) **CLAIM**

I claim the ornamental design for a neck worn face shield, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of my new design for a neck worn face shield having a visor supported by a frame.  
FIG. 2 is a perspective view of the frame of FIG. 1.  
FIG. 3 is a top plan view thereof.  
FIG. 4 is a rear elevation view thereof  
FIG. 5 is a right side elevation view thereof.  
FIG. 6 is a left side elevation view thereof.  
FIG. 7 is a front elevation view thereof; and,  
FIG. 8 is a bottom plan view thereof.  
The broken line showings of the visor, visor mounts, handle ends, arm ends and arm sleeves form no part of the claimed design.

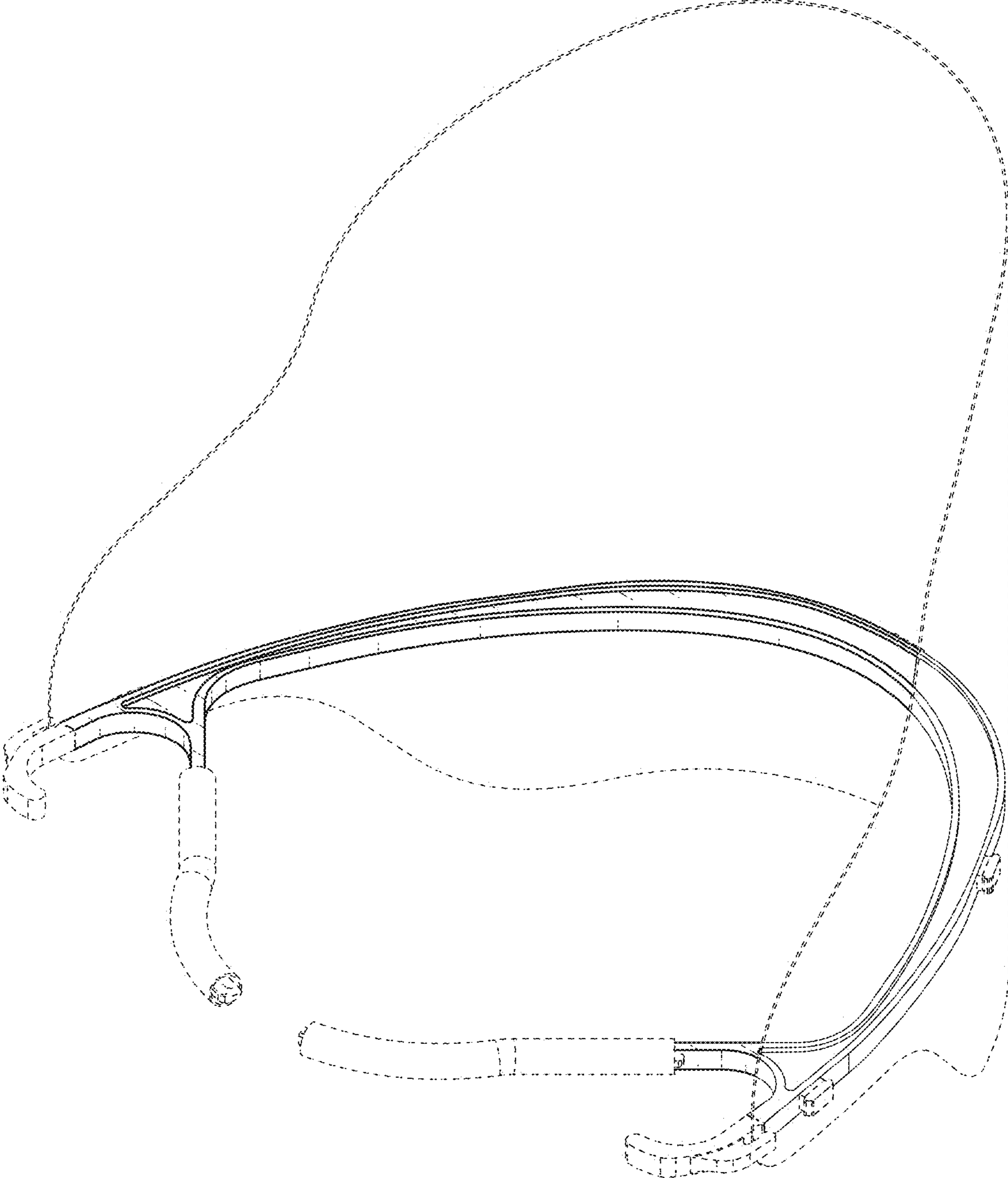

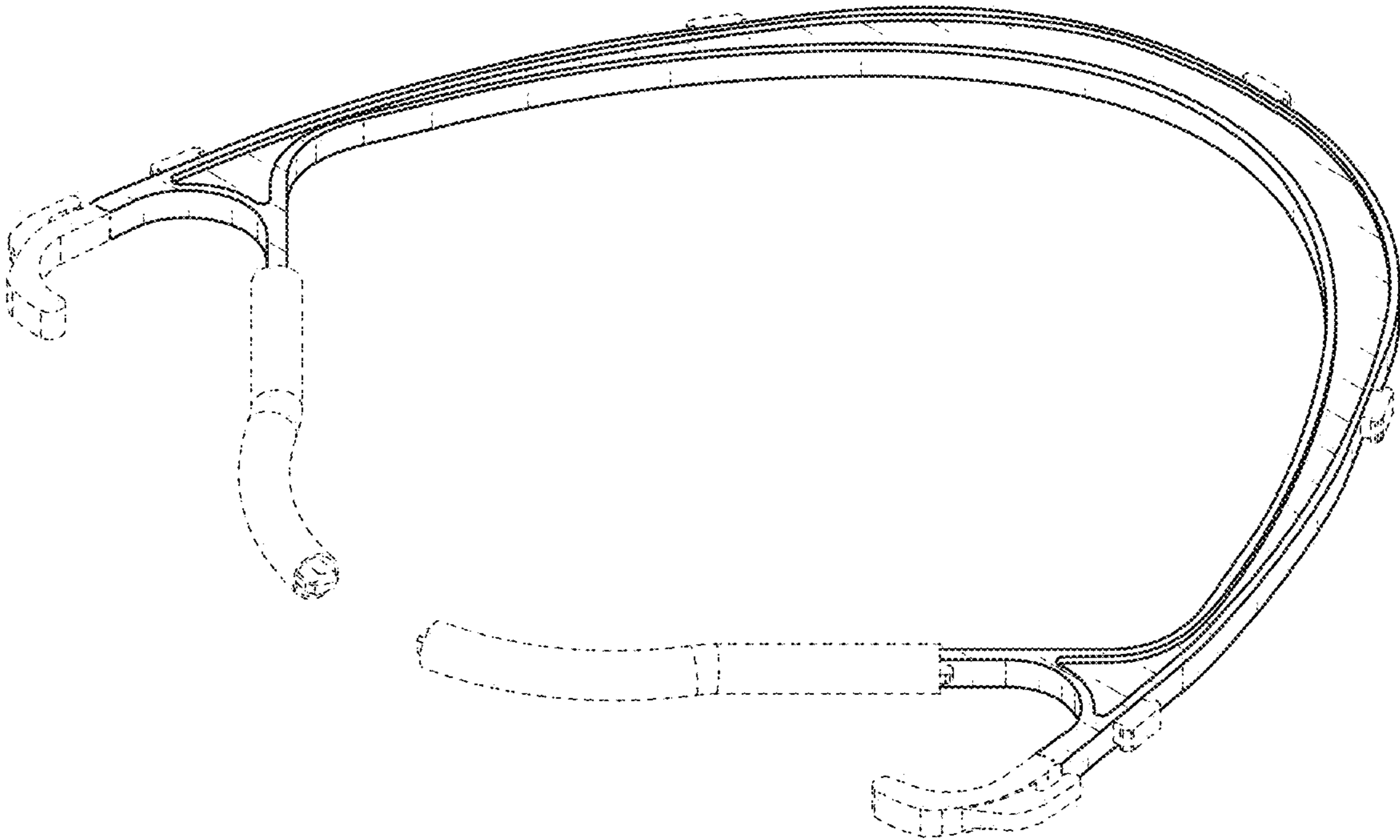

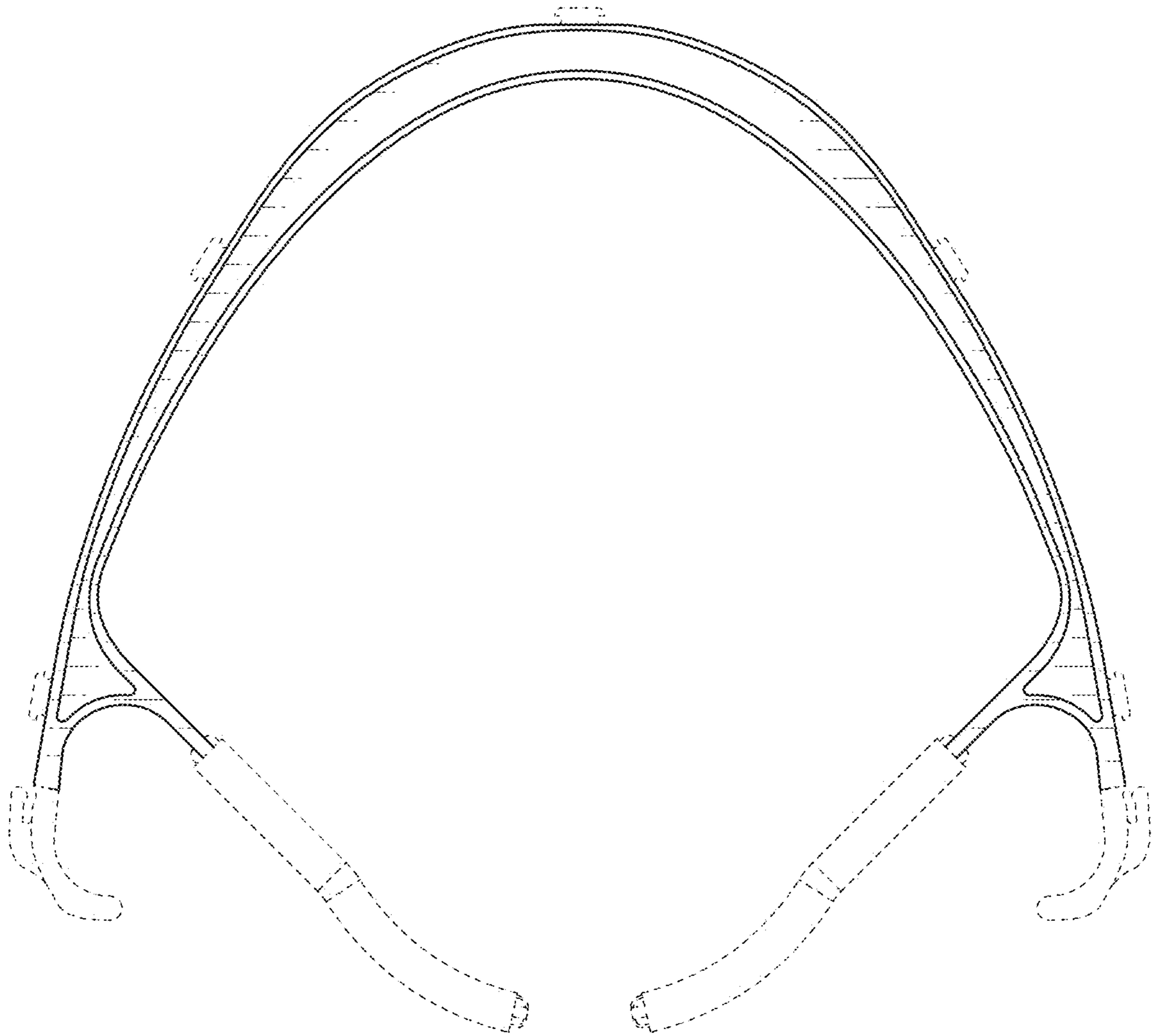

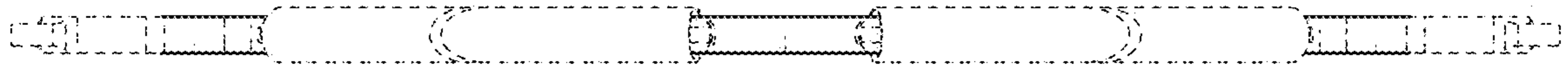

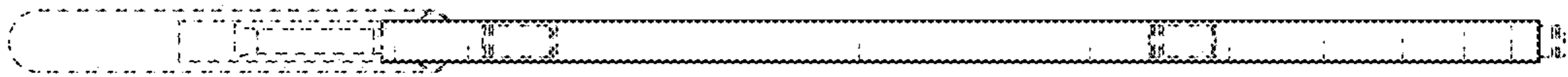

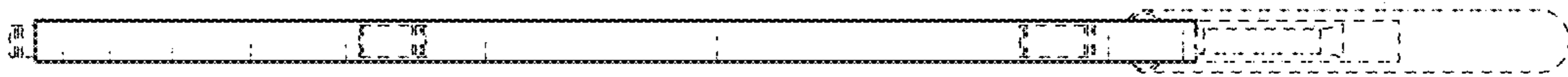

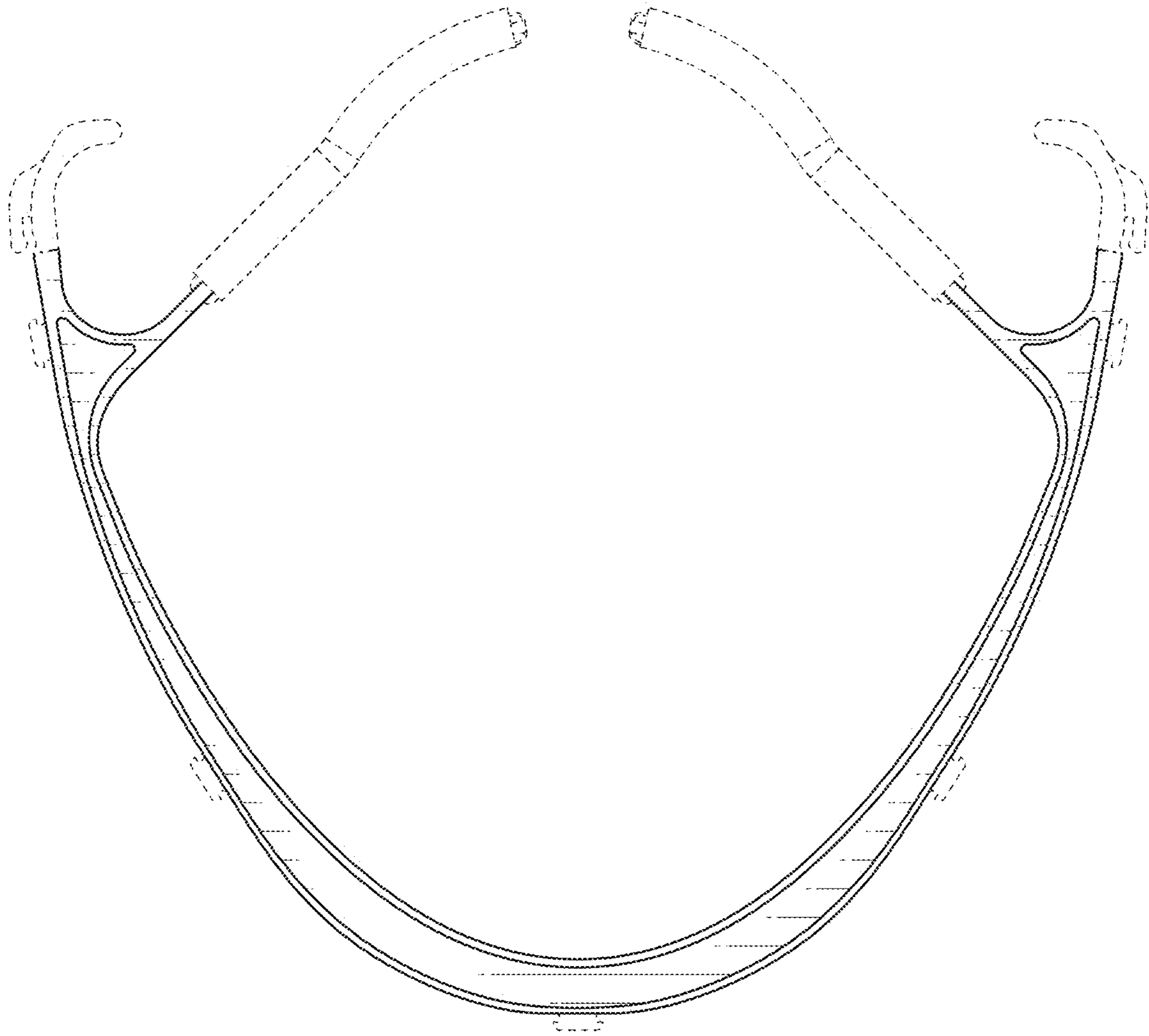
