FIG. 3 is a front view of the canine vest shown in condition of use;

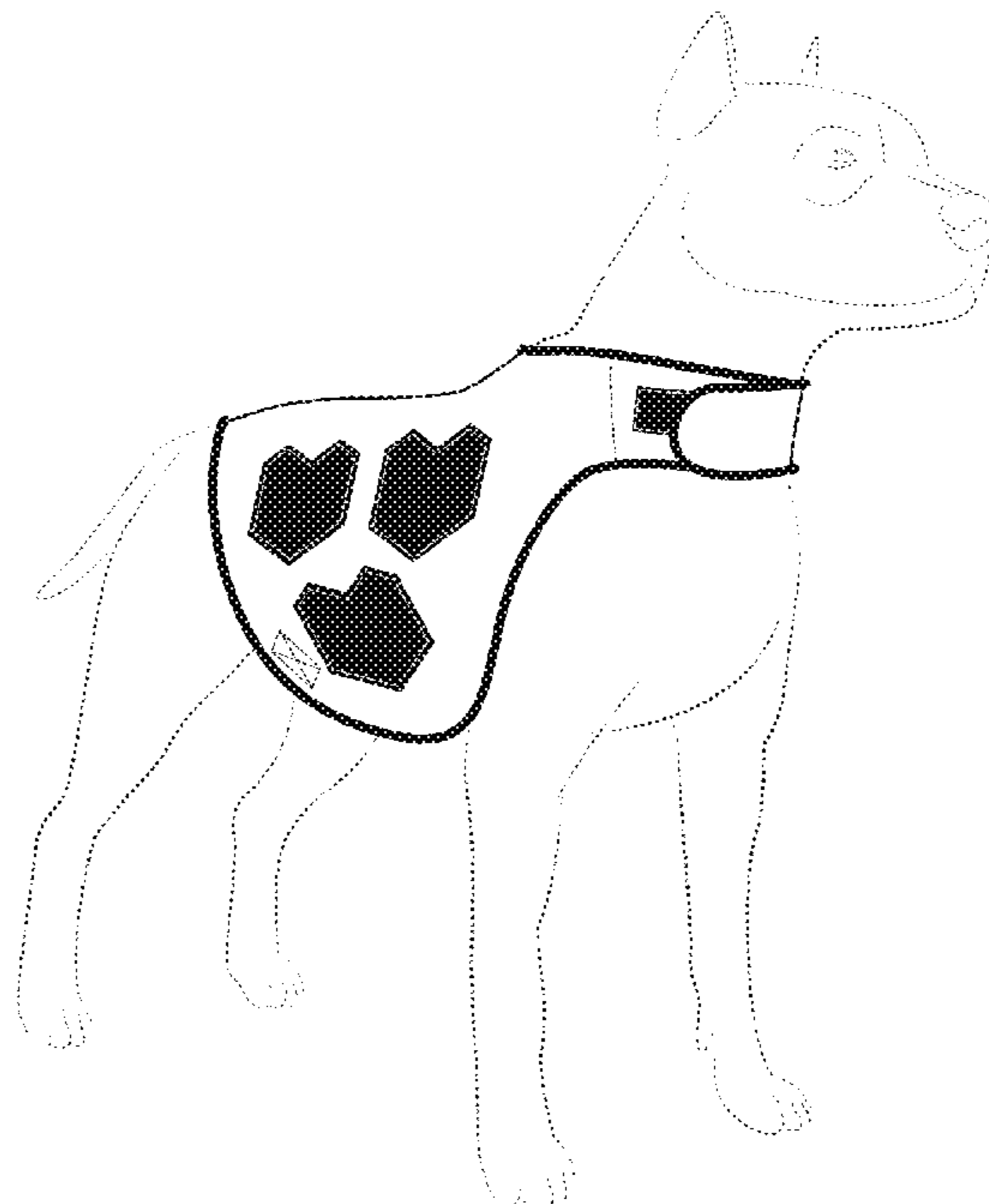
FIG. 4 is a top view of the canine vest shown in condition of use;

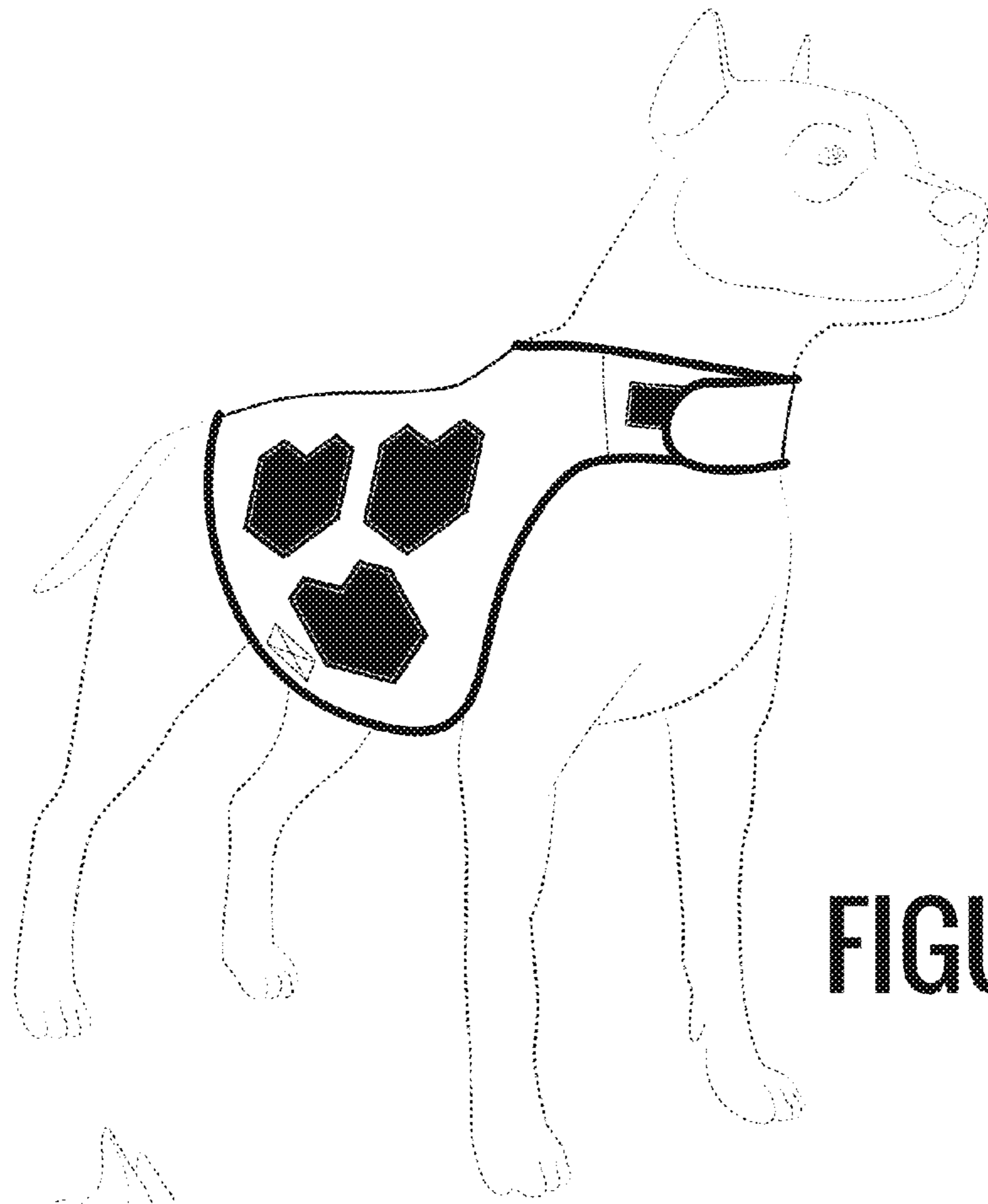

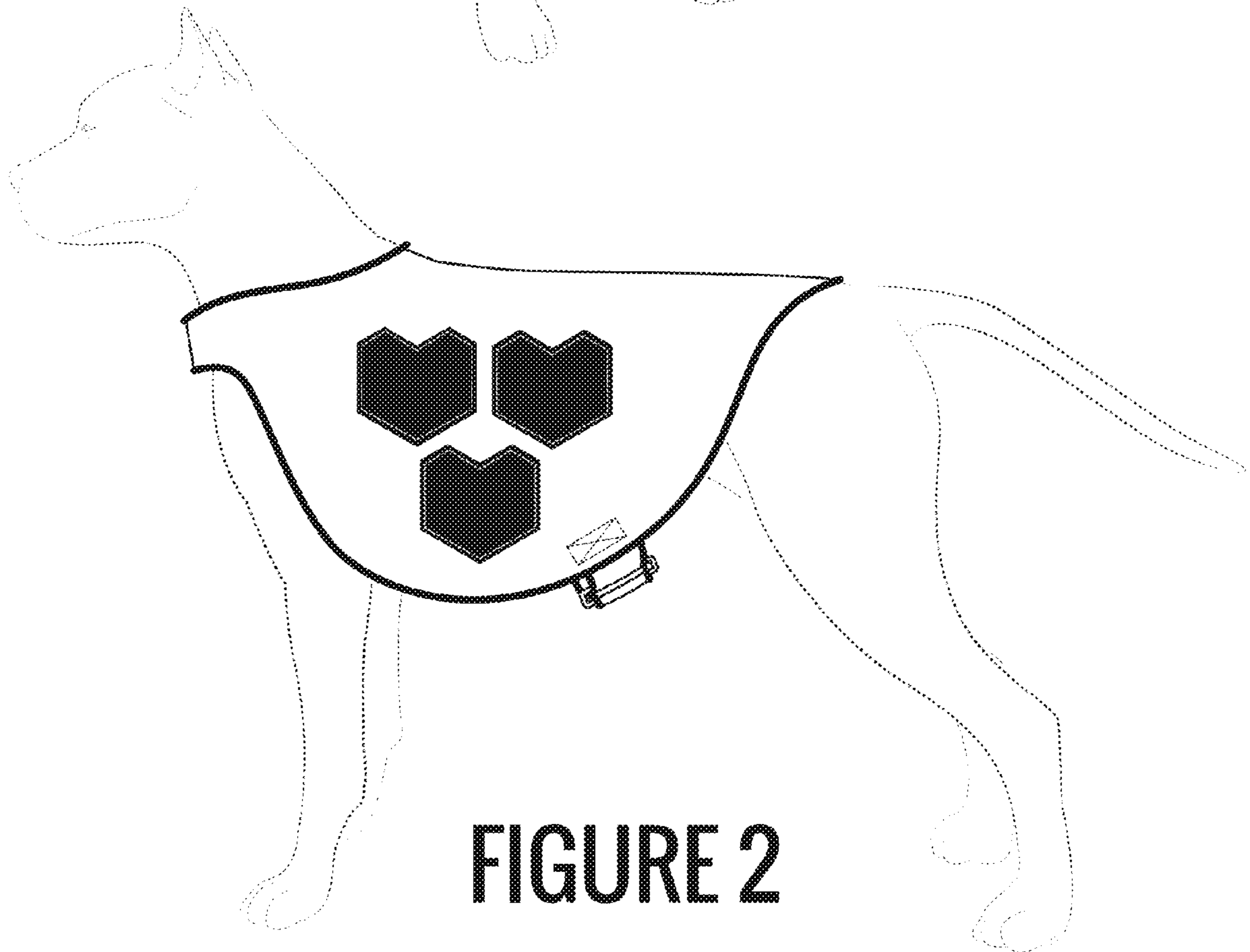

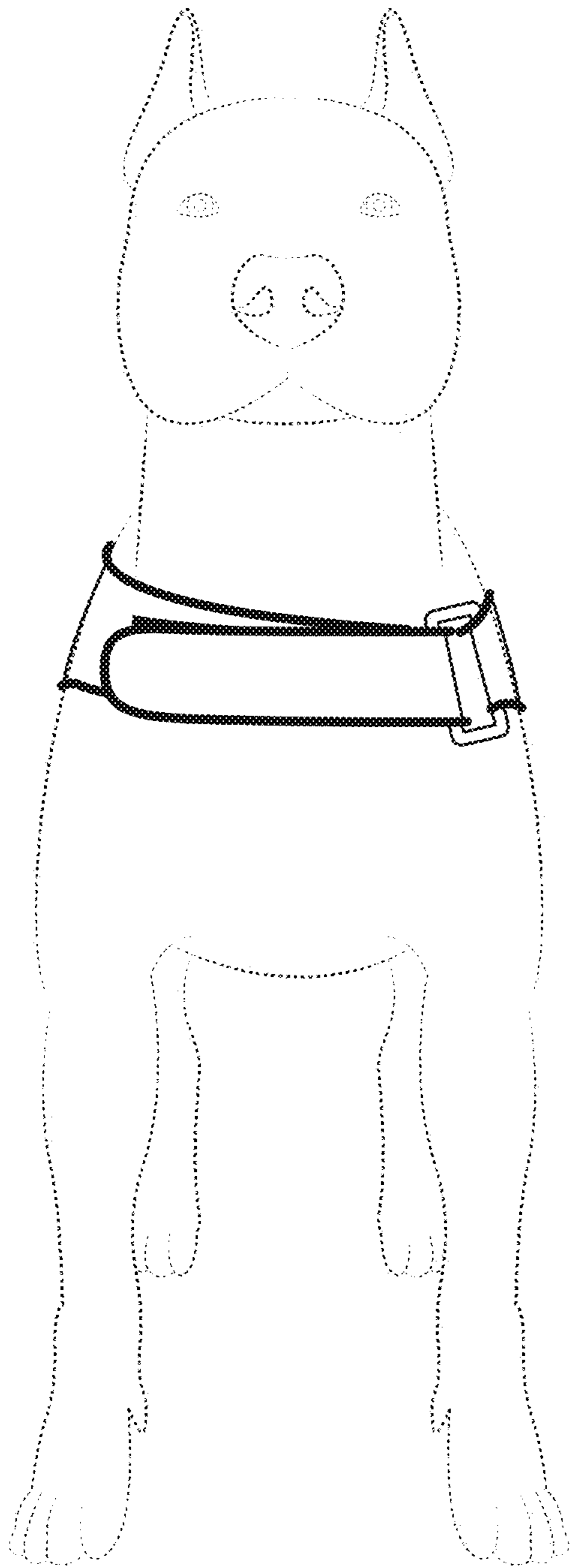

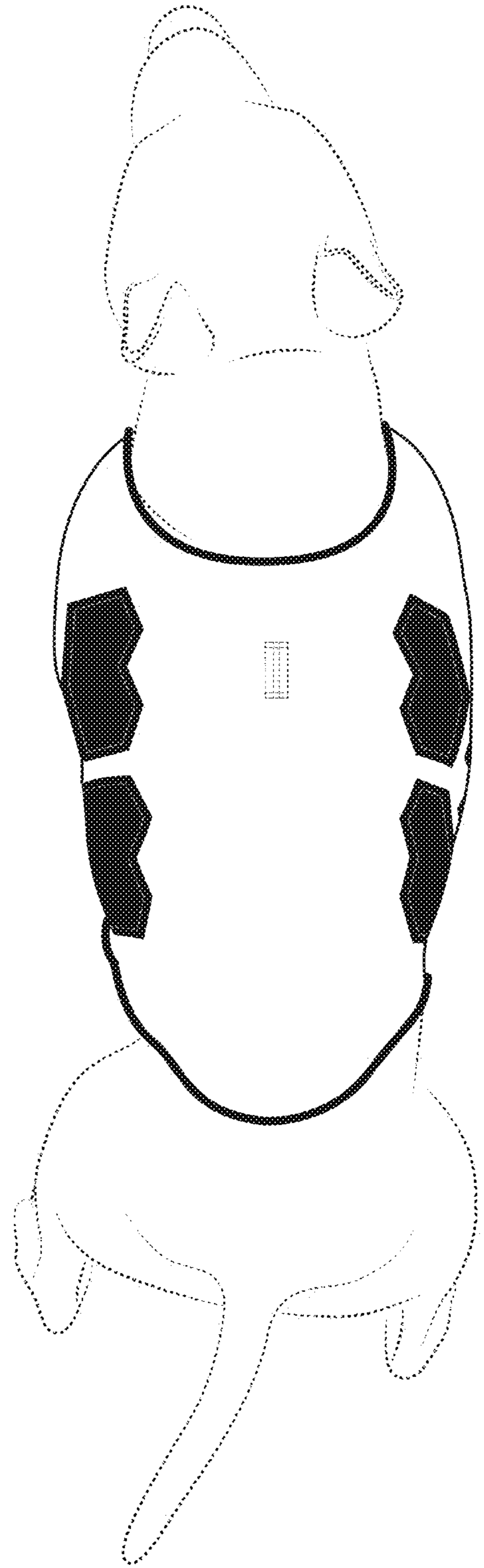

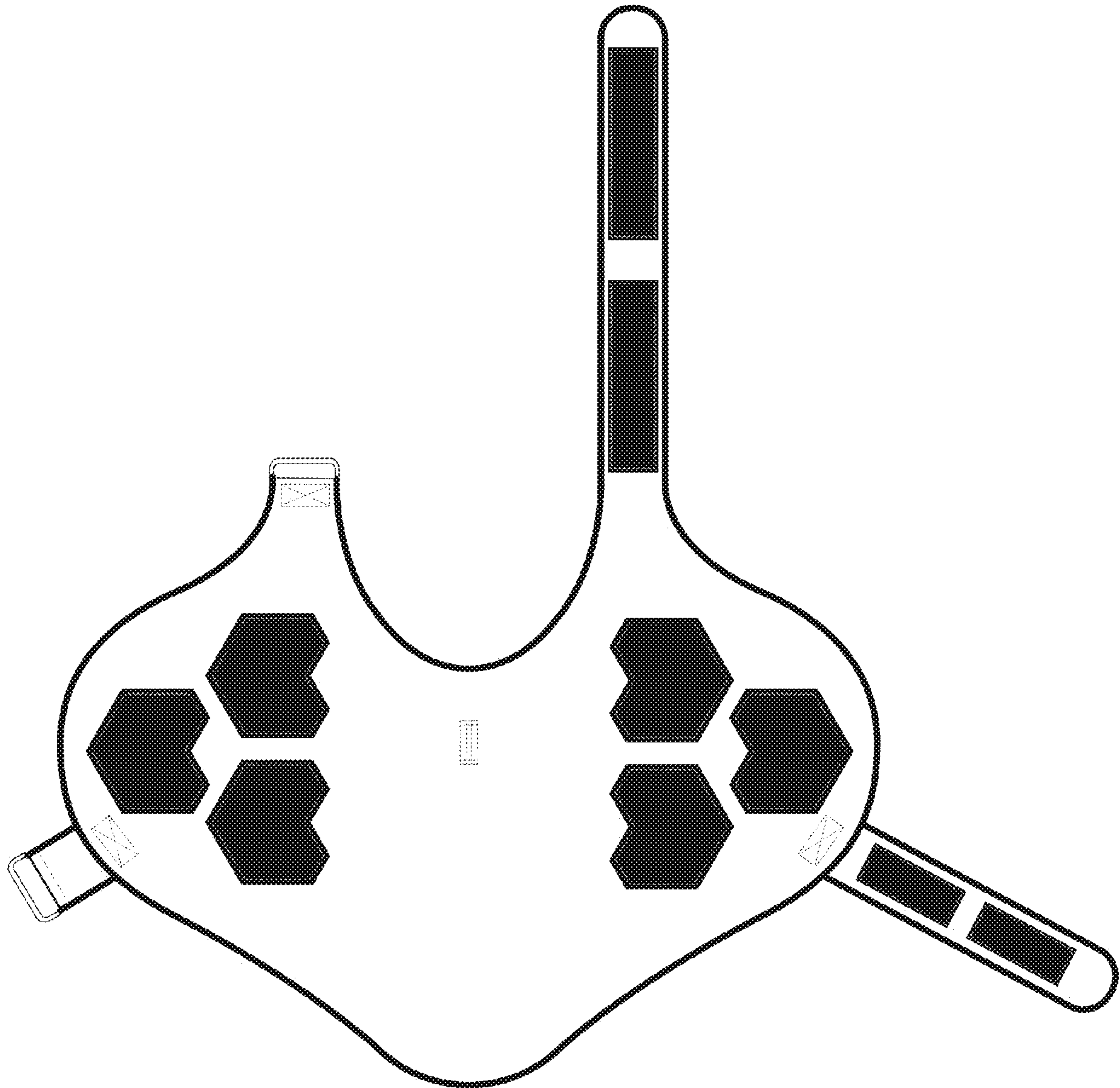

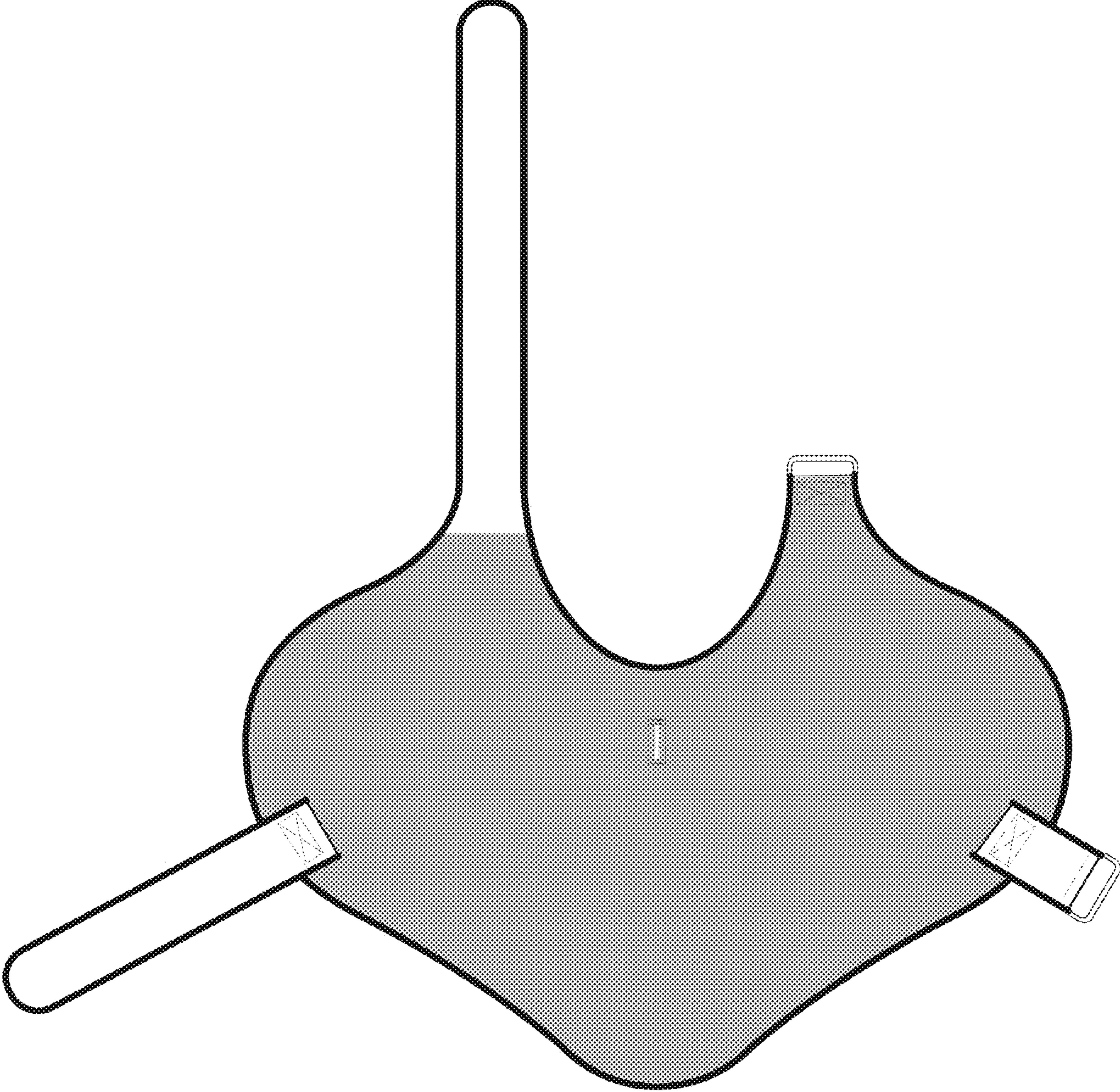
