The broken lines in the figures illustrate portions of the cleaning implement that form no part of the claimed design.

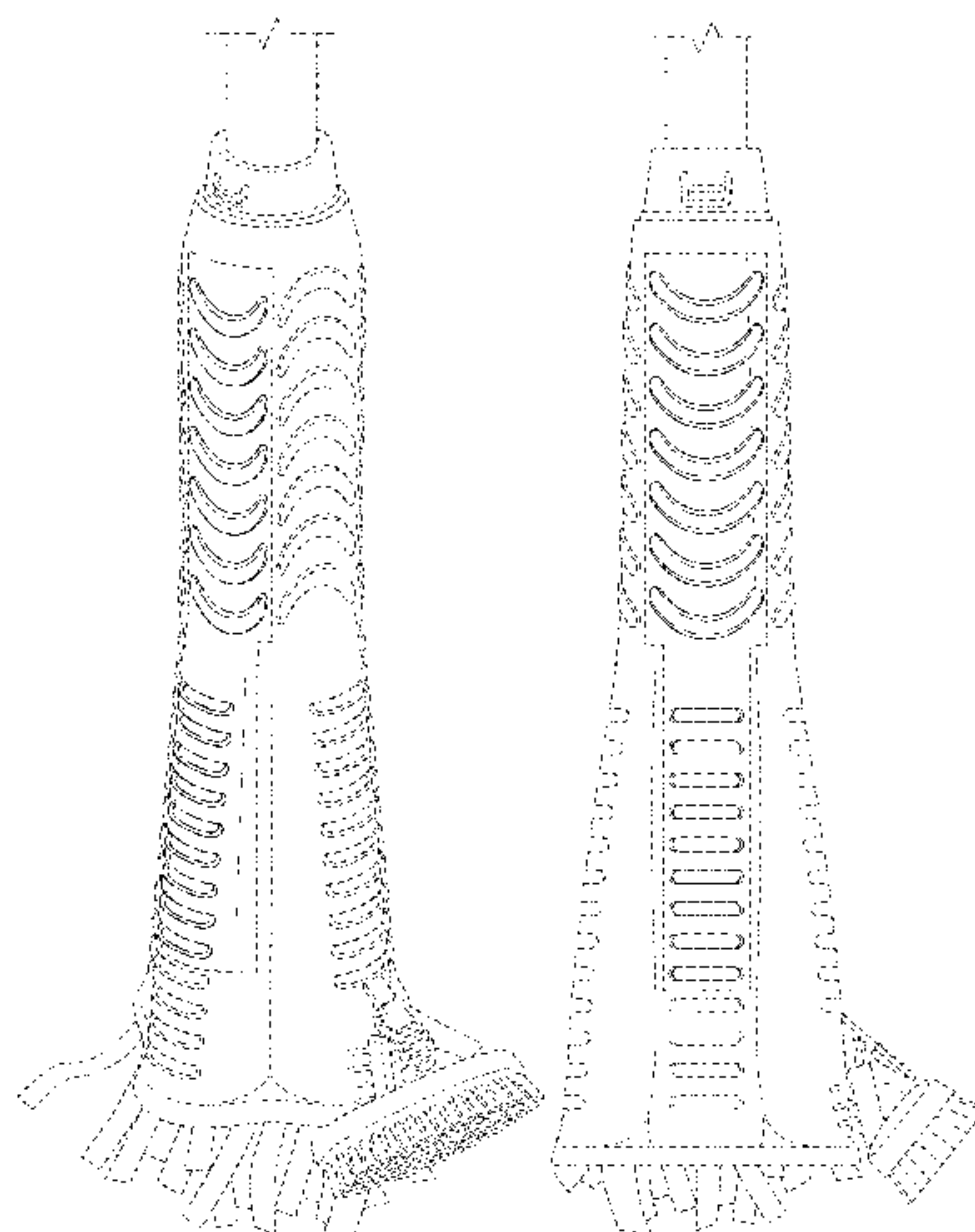

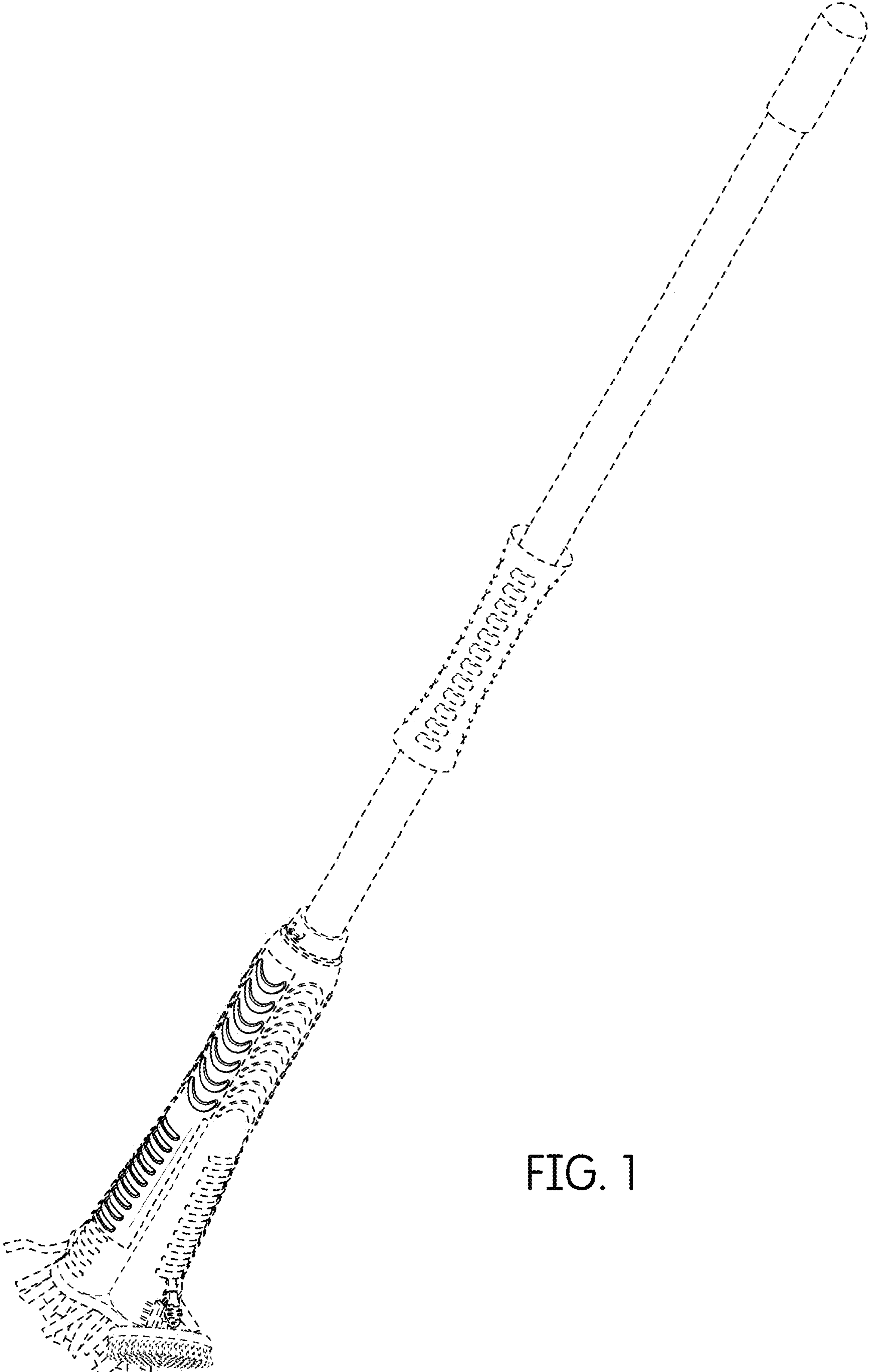

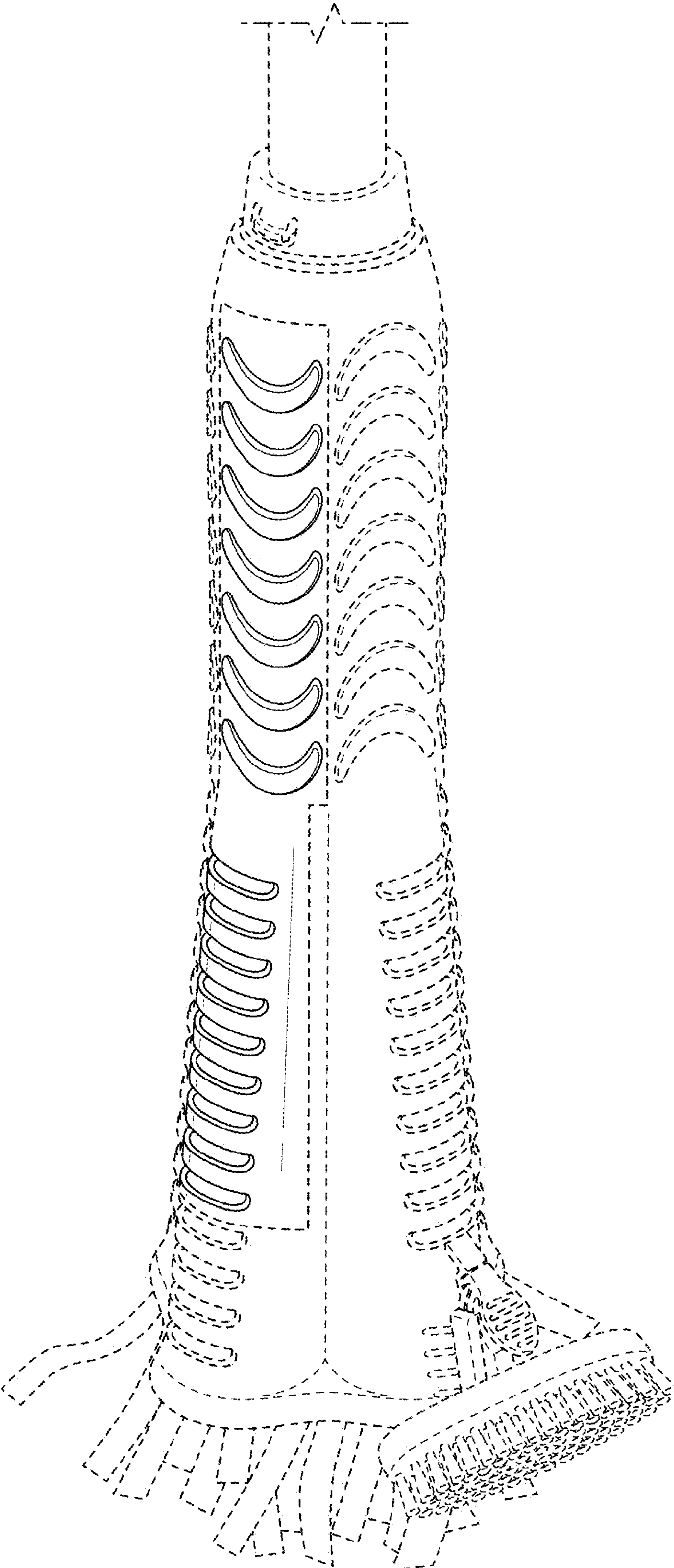

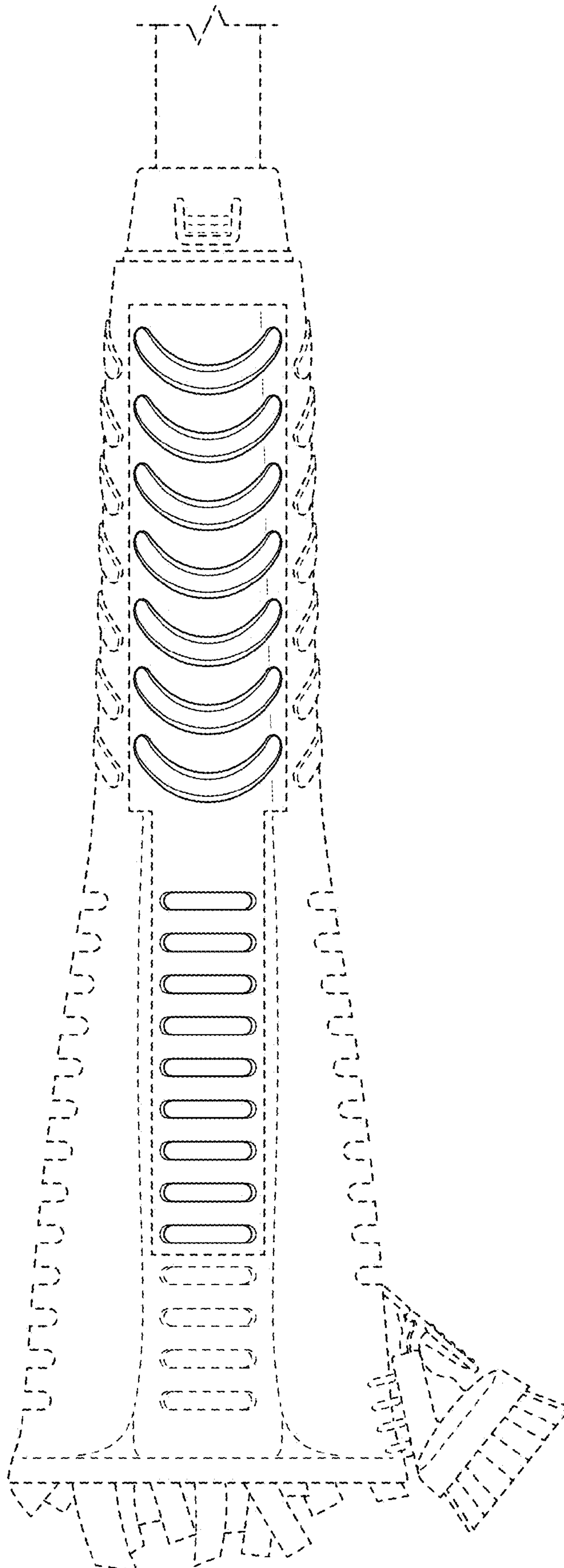

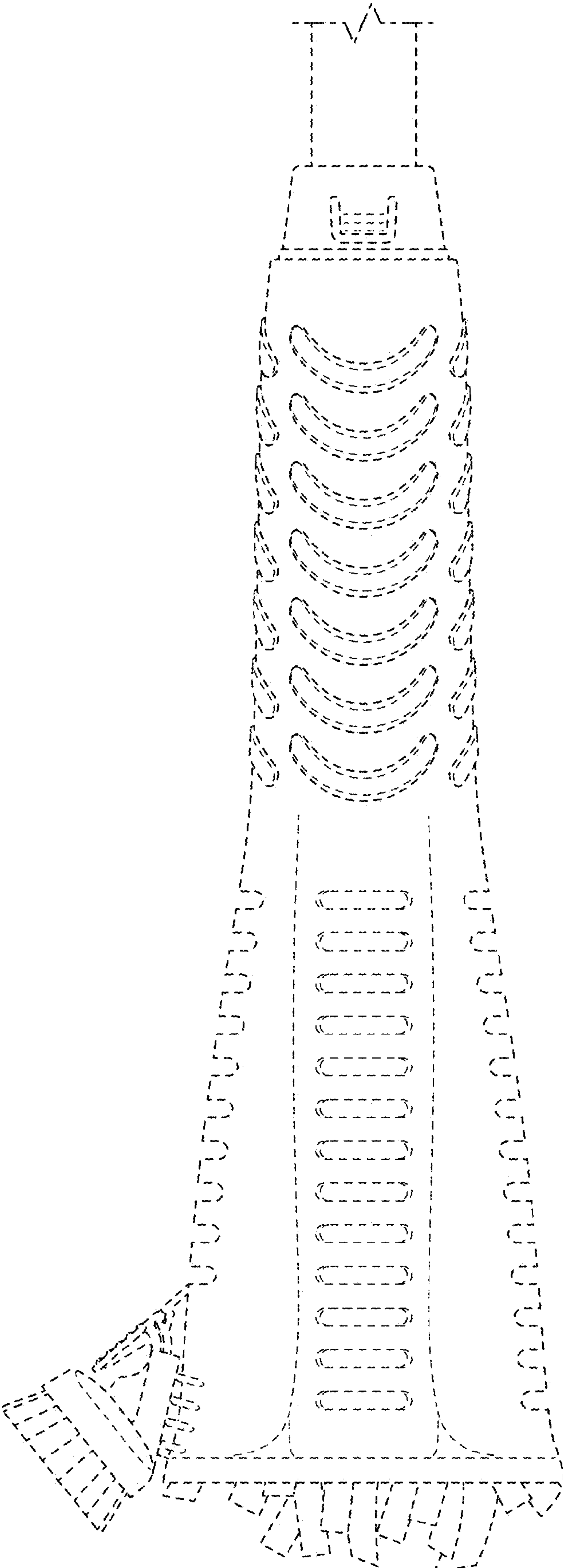

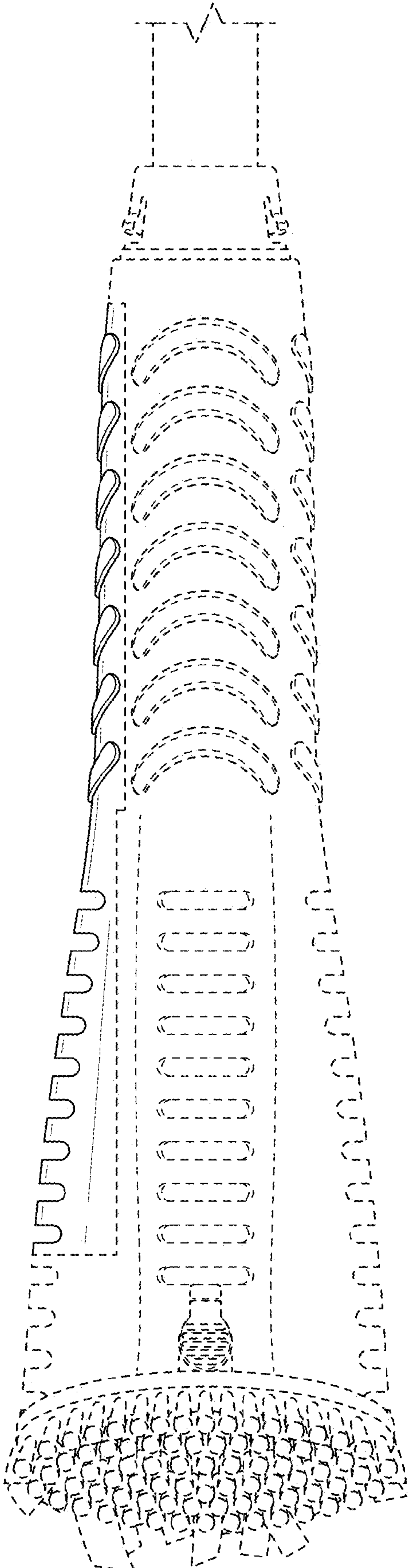

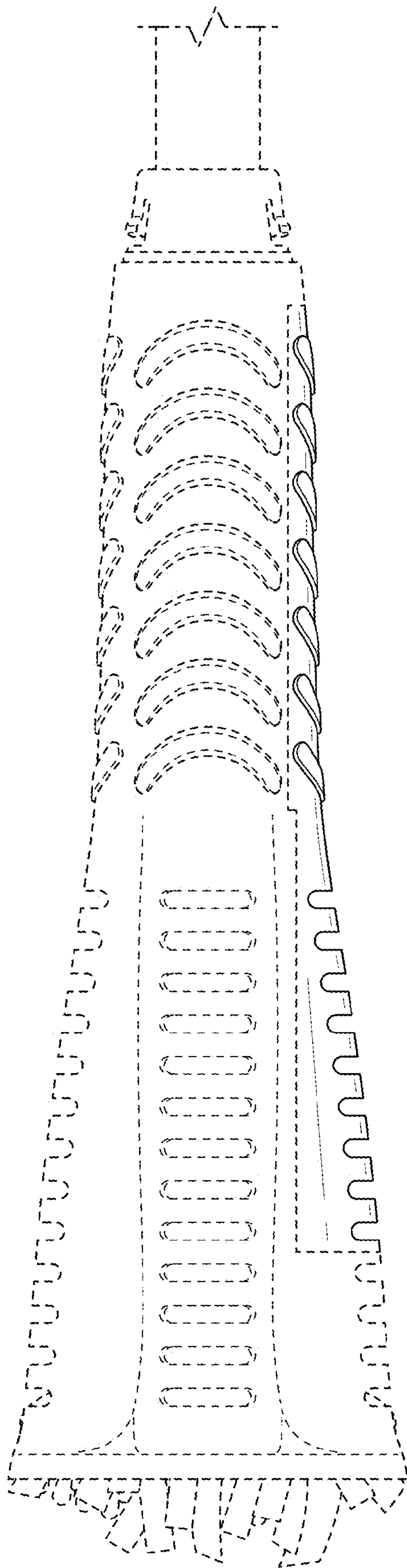

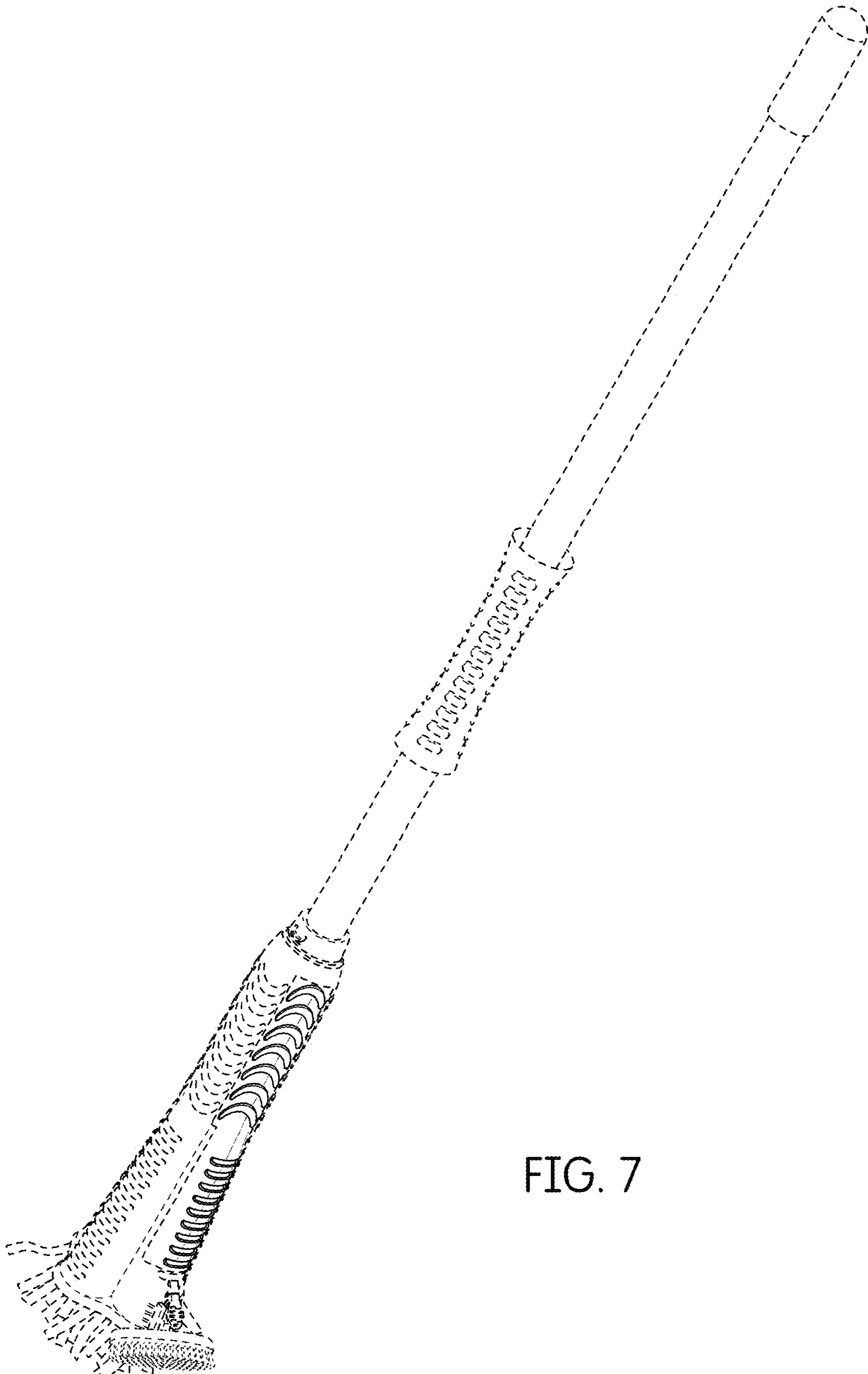

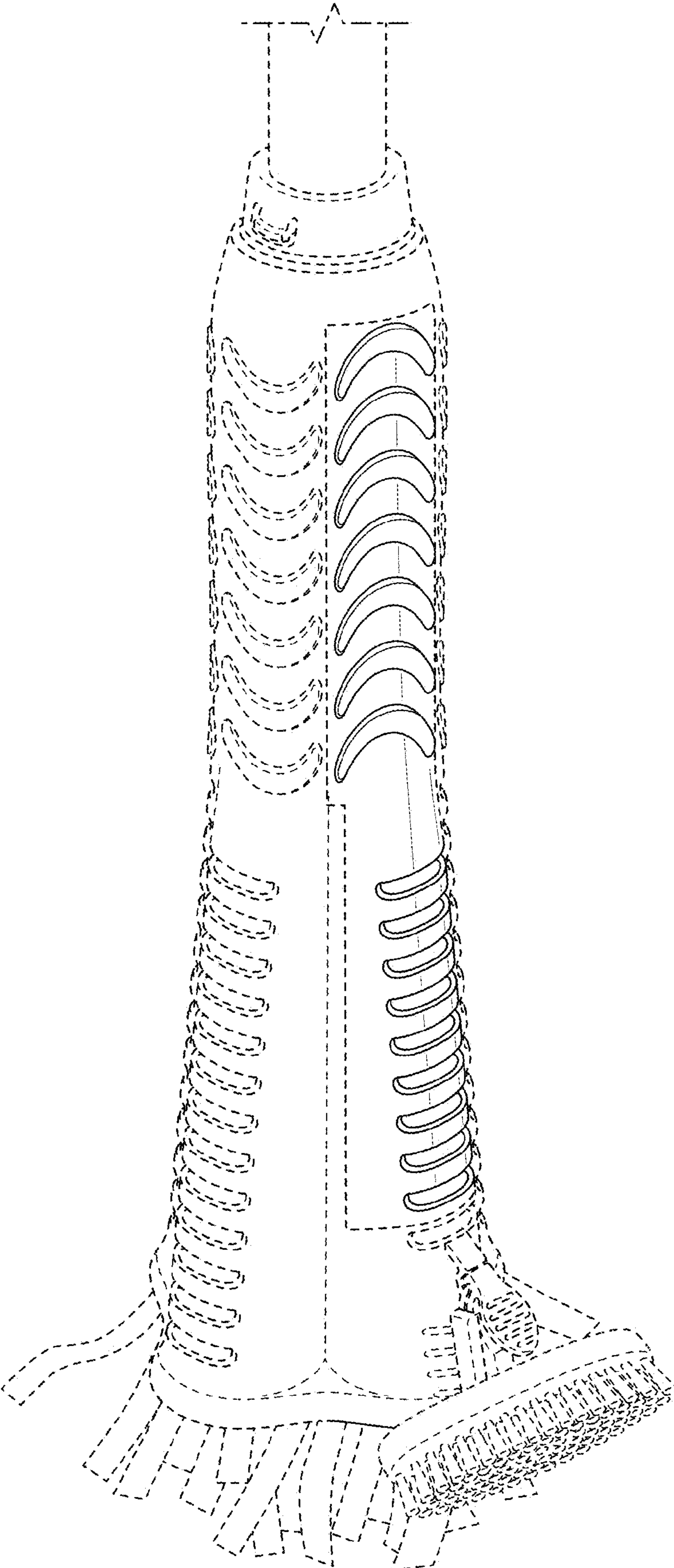

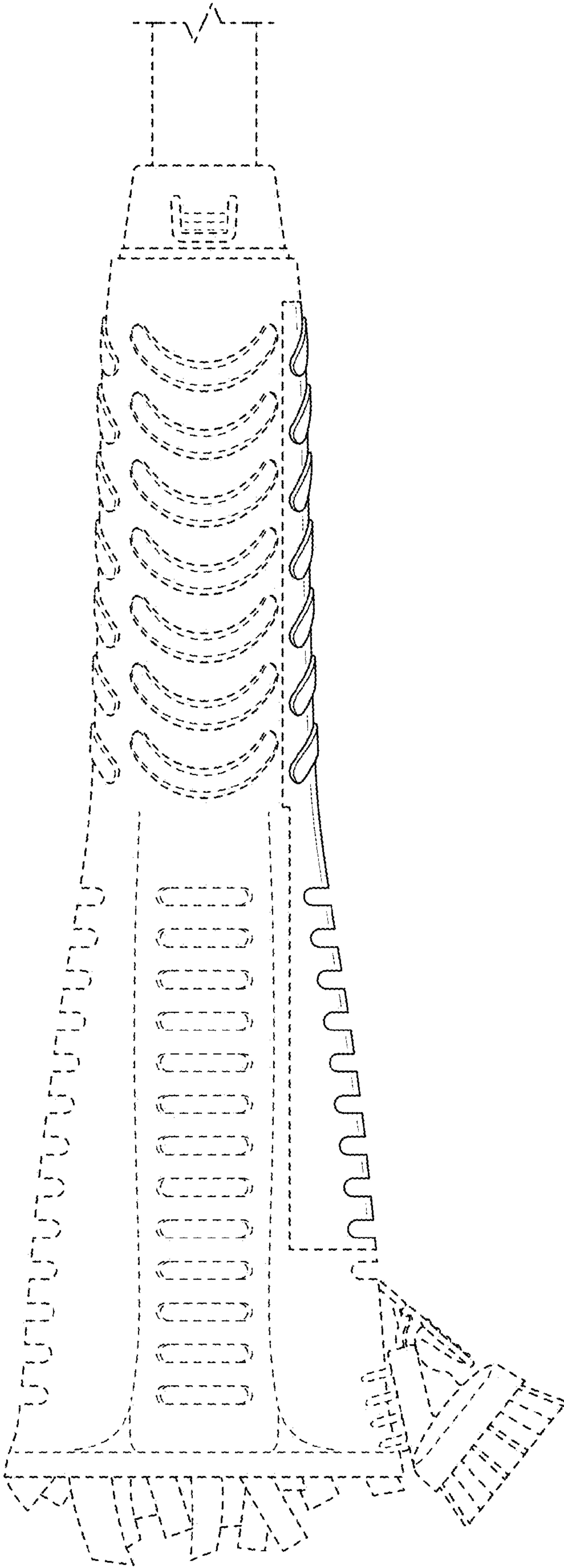

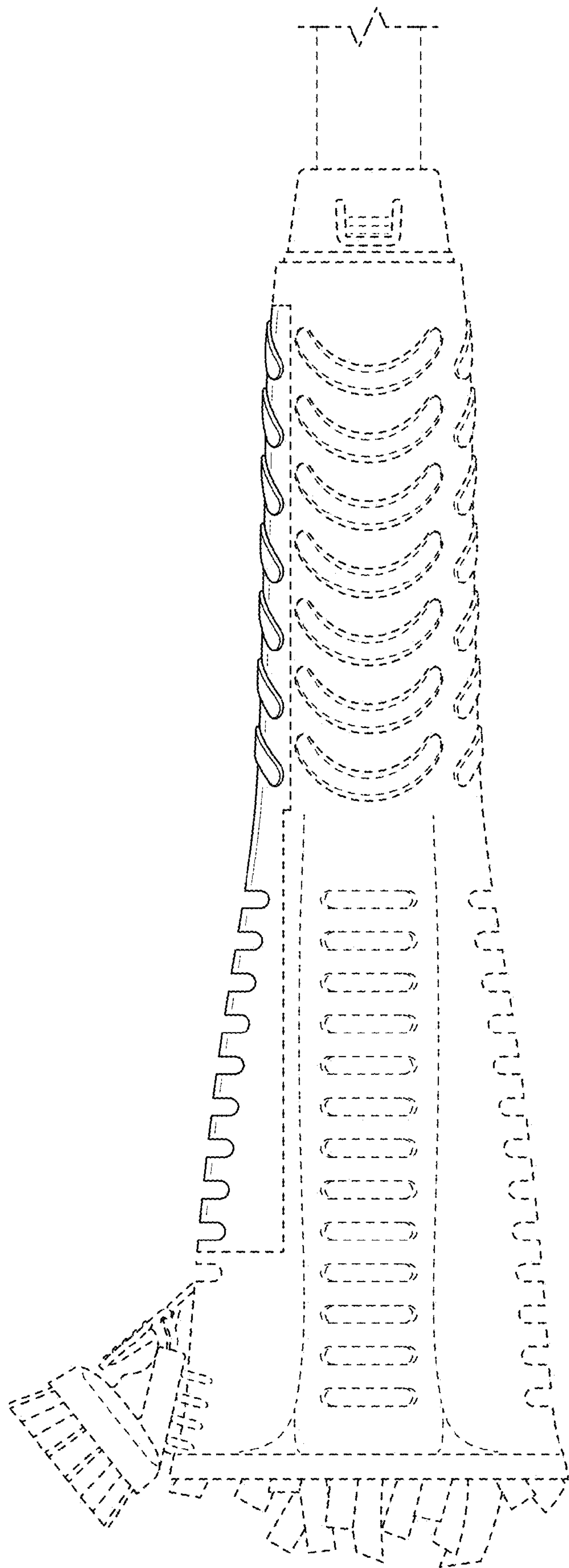

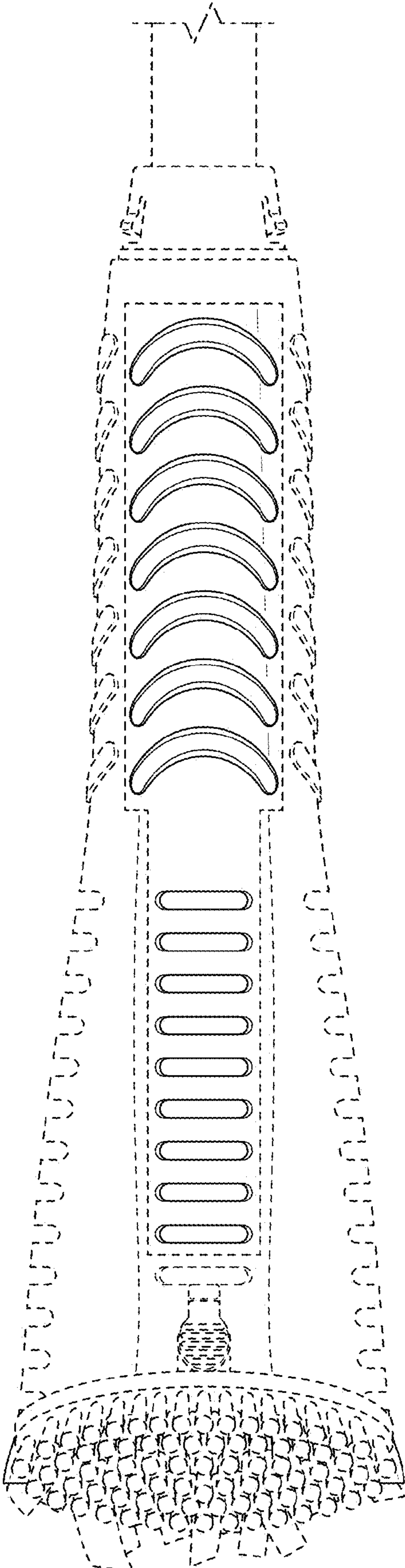

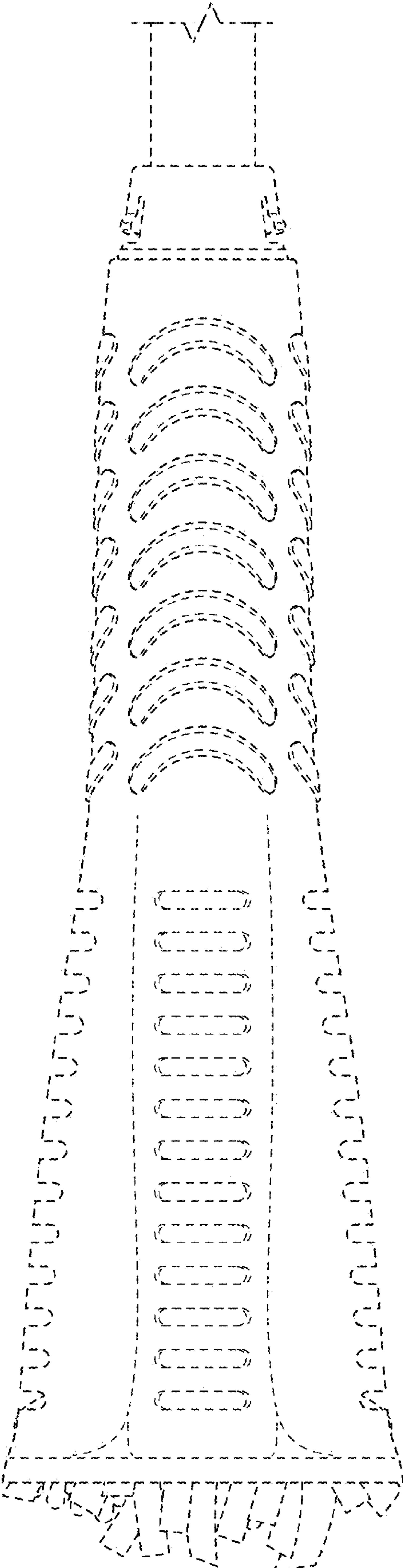
