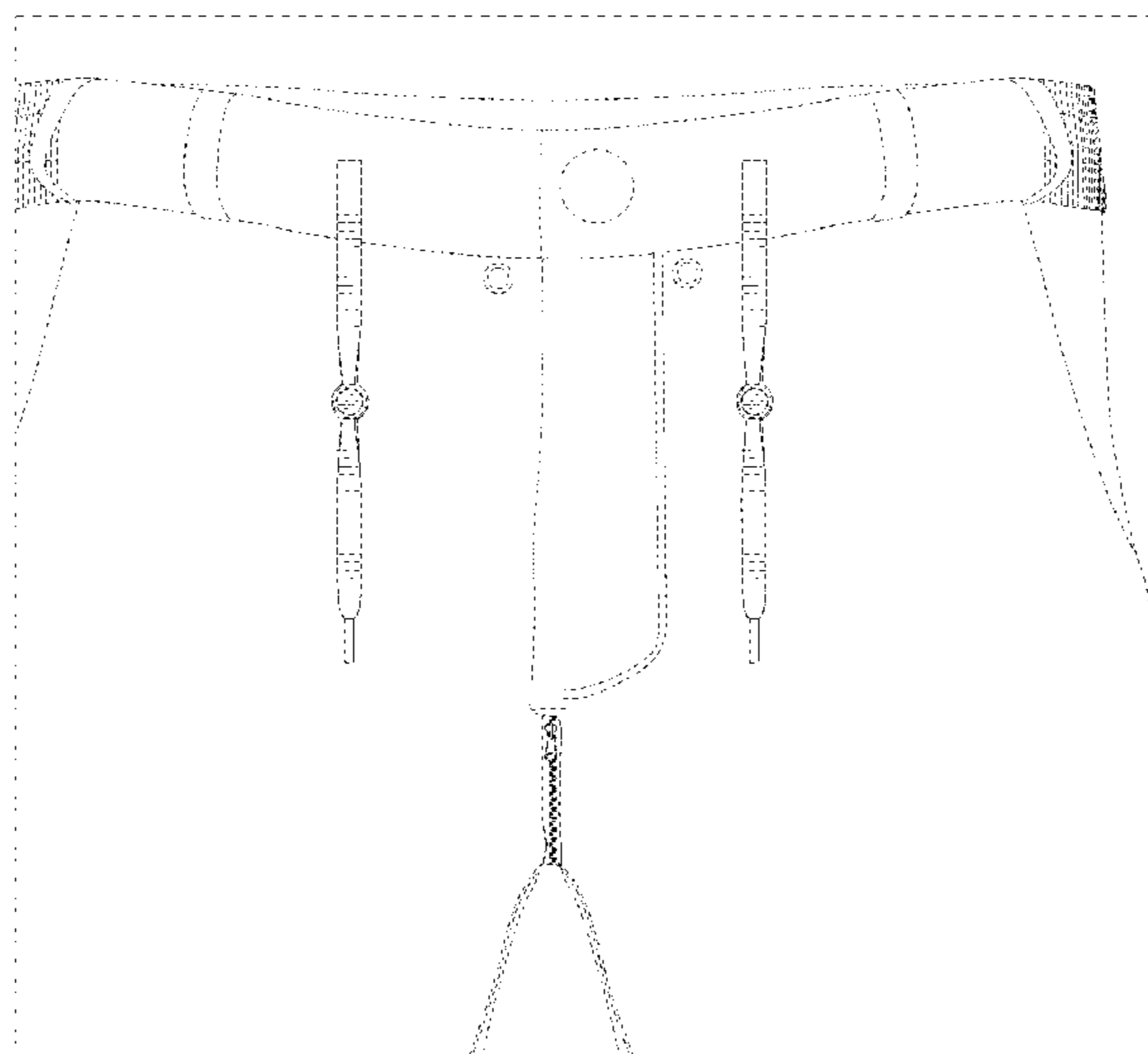
(57) **CLAIM**

The ornamental design for a pair of pants with zipper and drawstrings, as shown and described.

DESCRIPTION

FIG. 1 is a front-top perspective view of a pair of pants with zipper and drawstrings showing my new design;

FIG. 3 is a rear-top perspective view thereof;
FIG. 4 is a rear elevational view thereof;

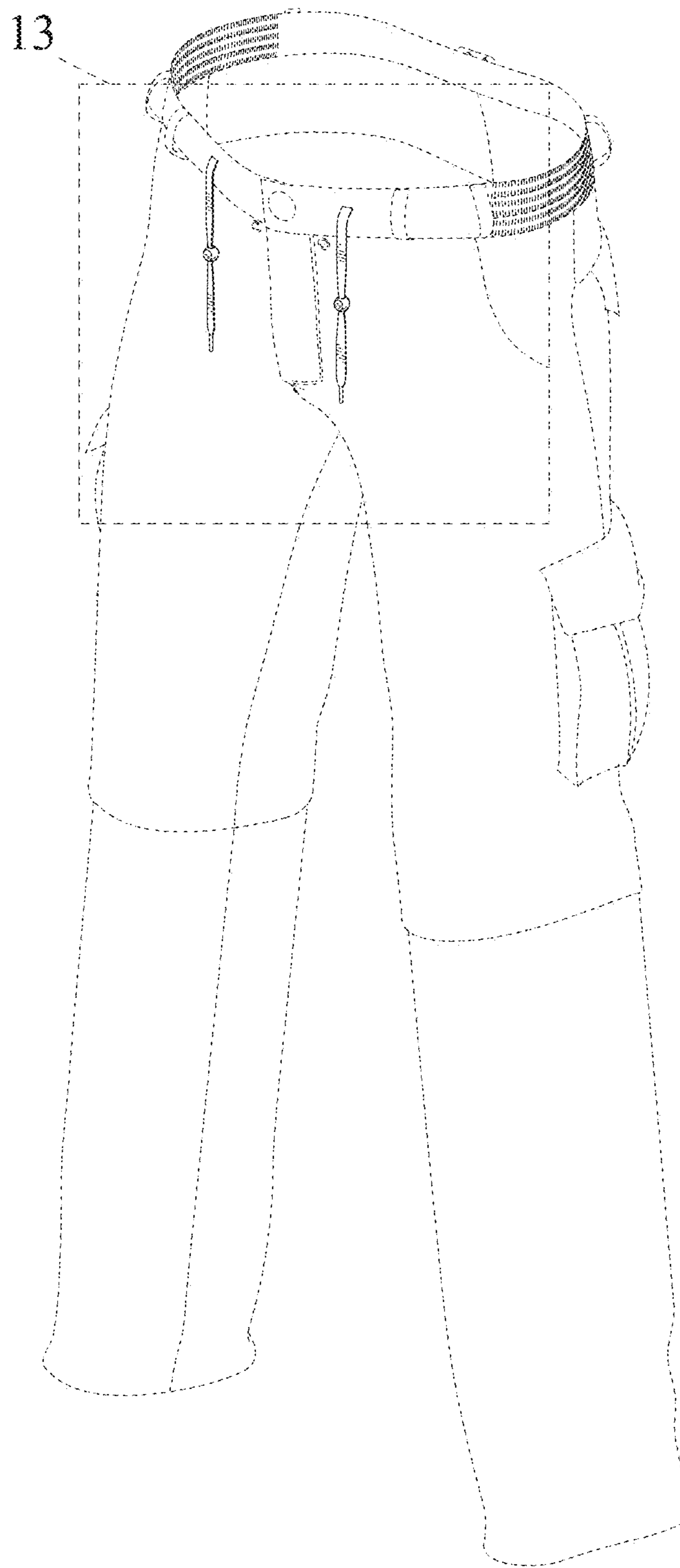

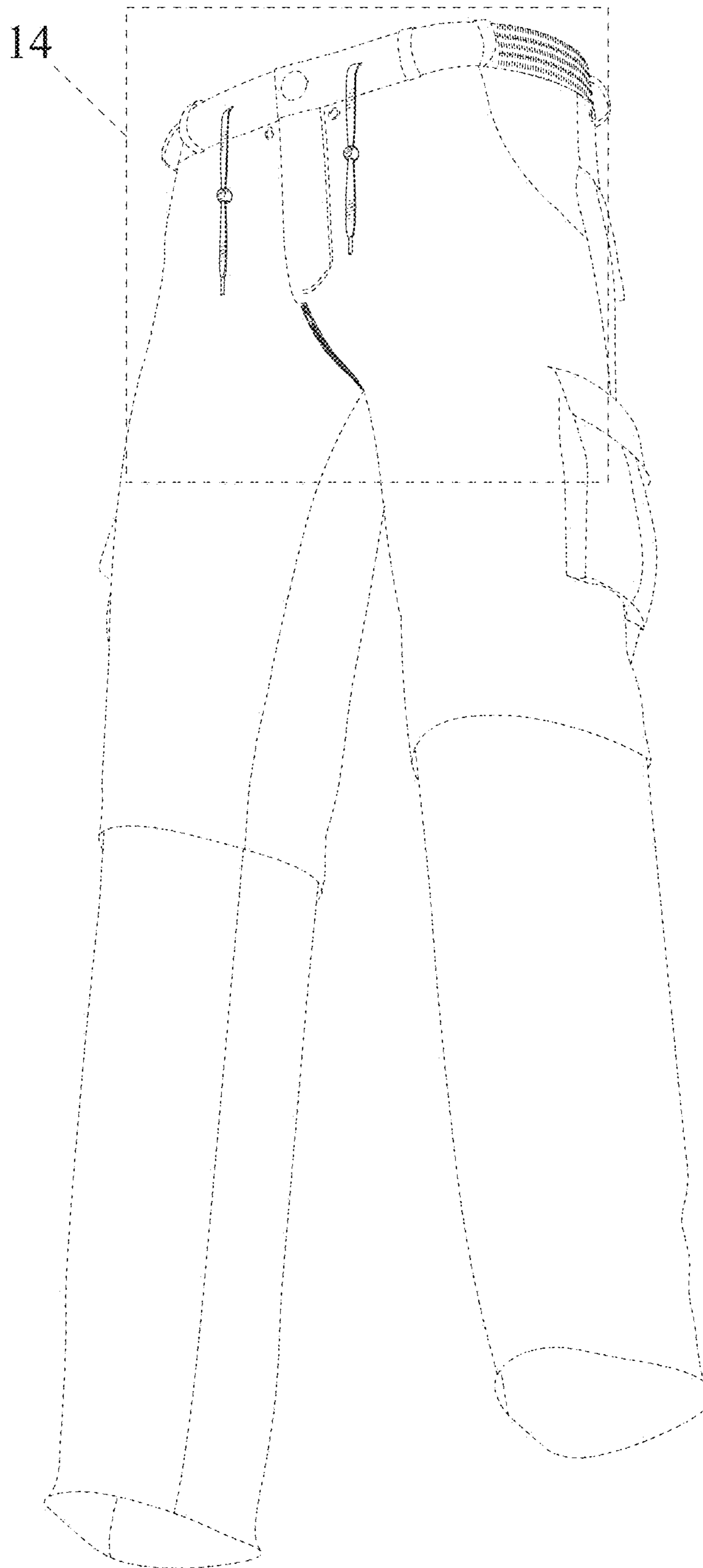

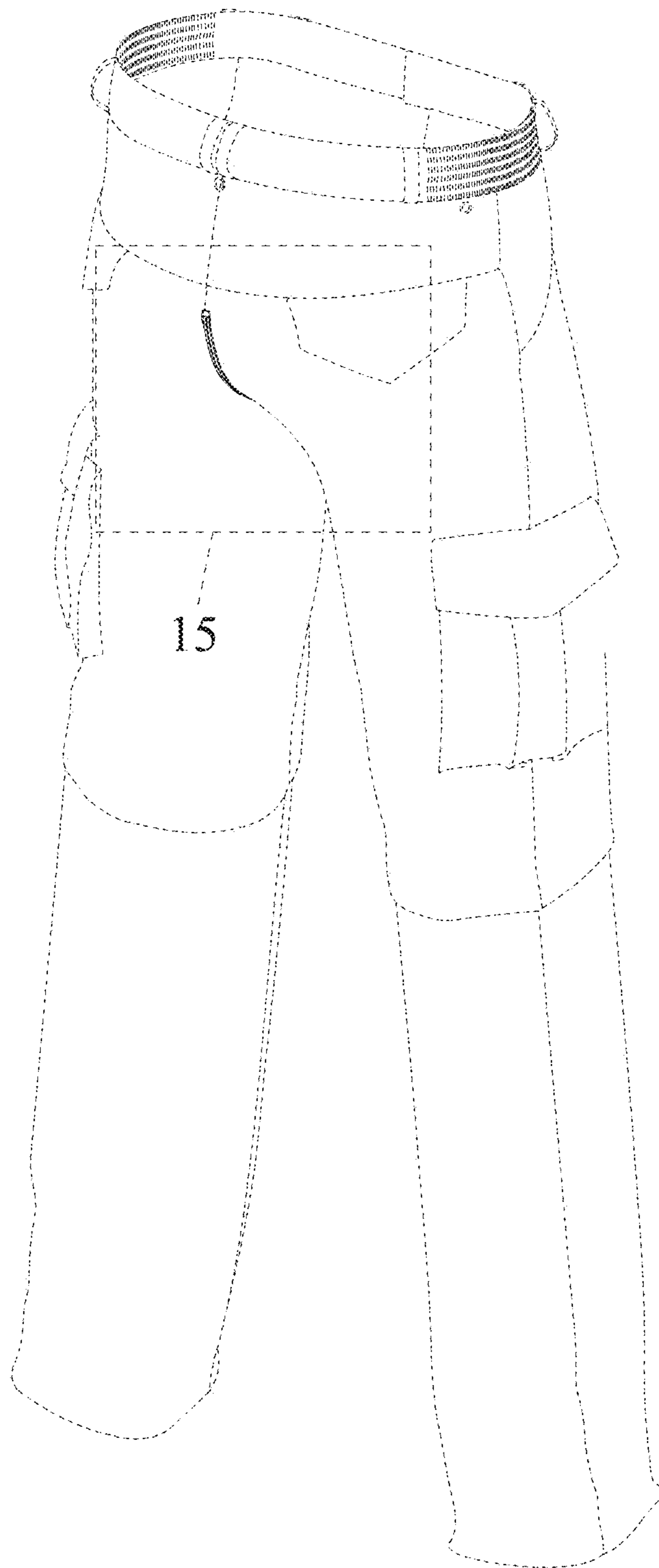

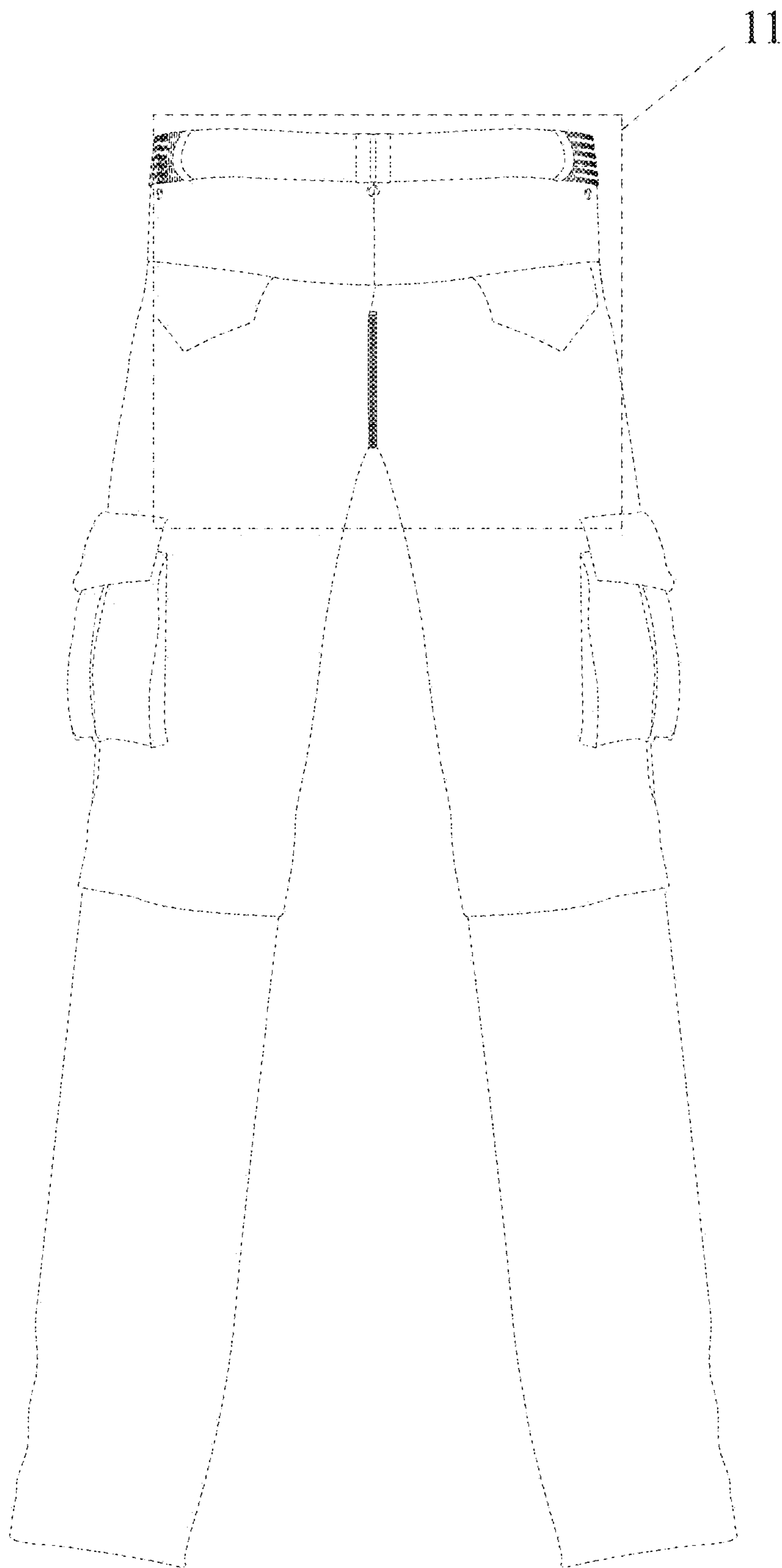

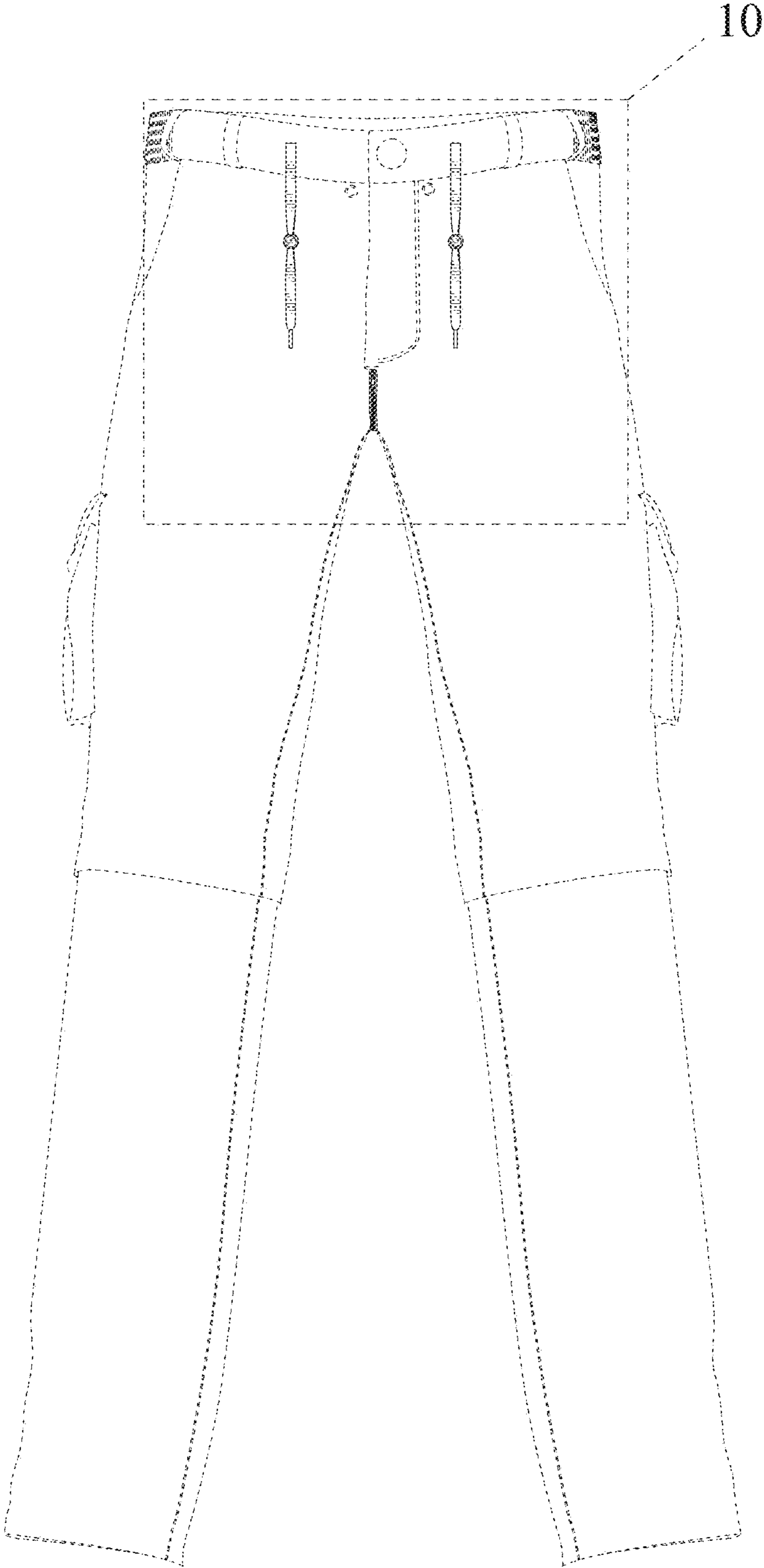

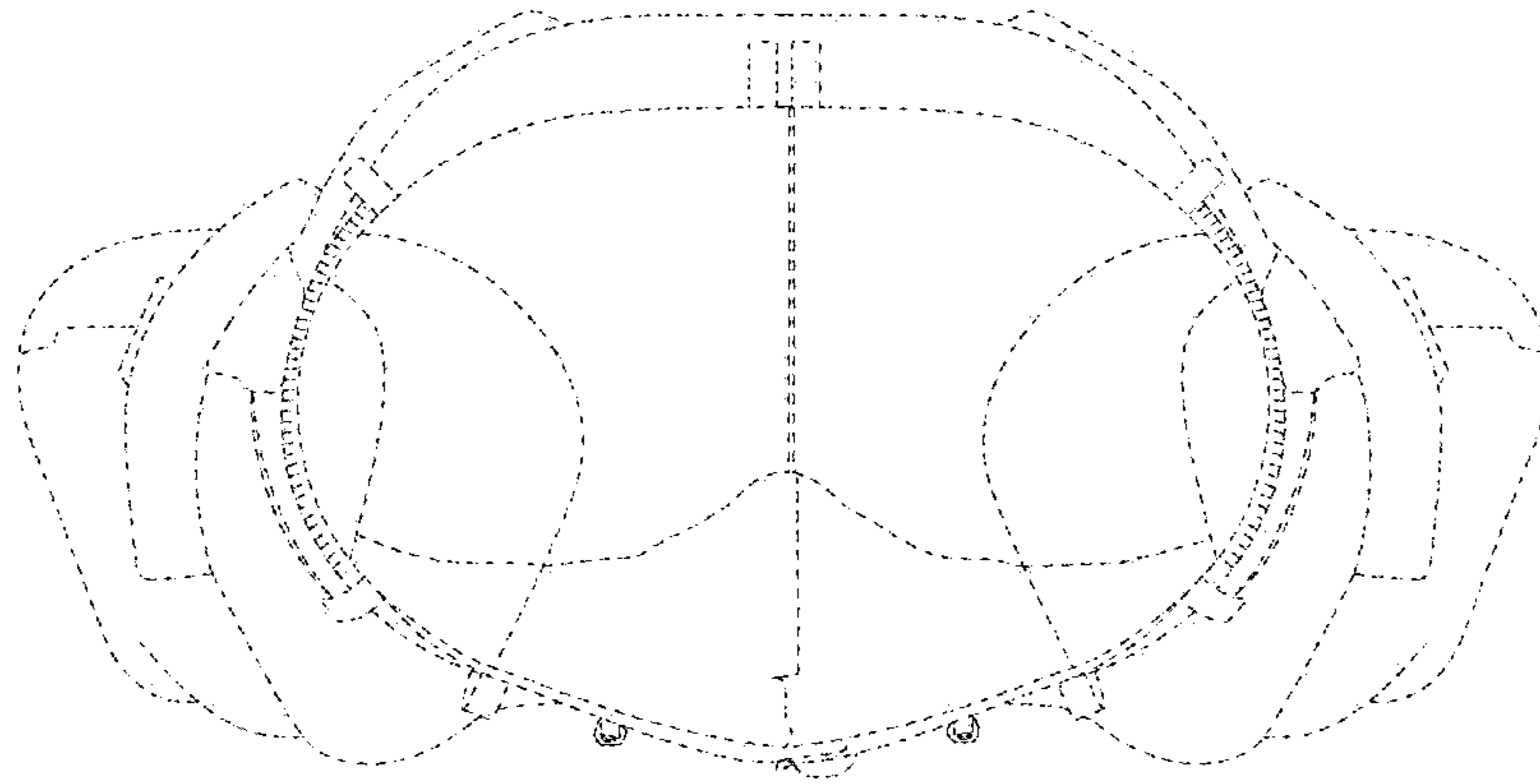

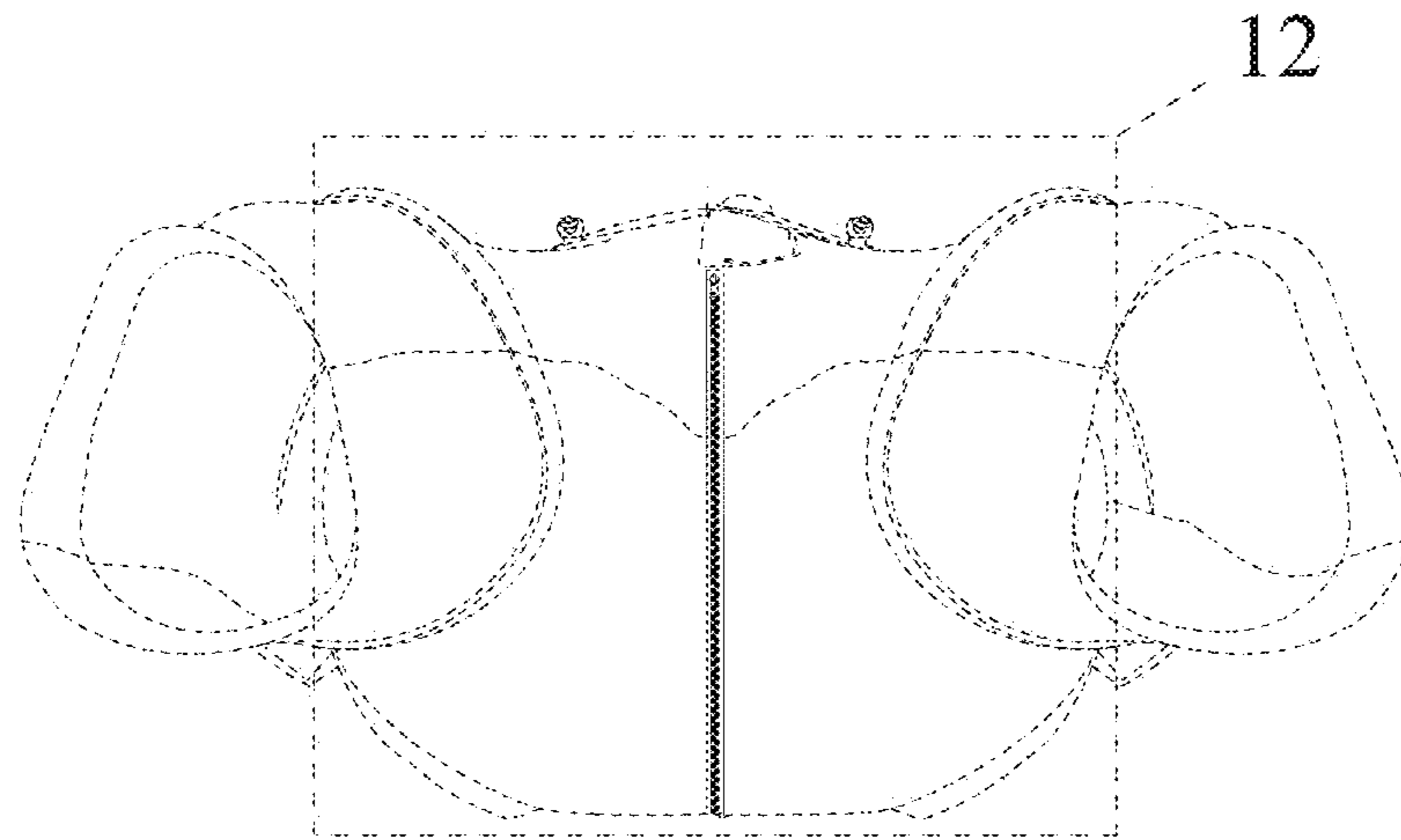

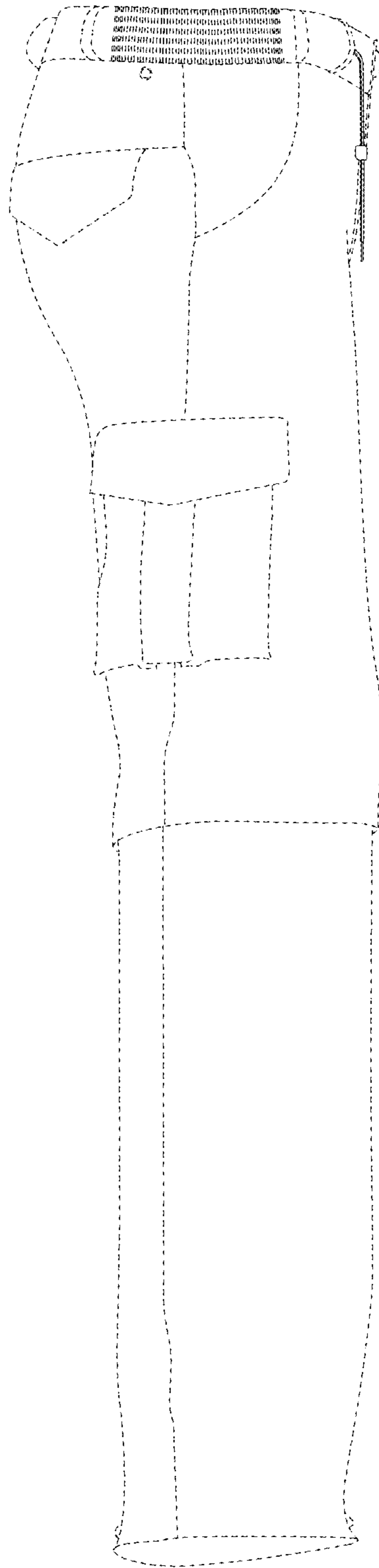

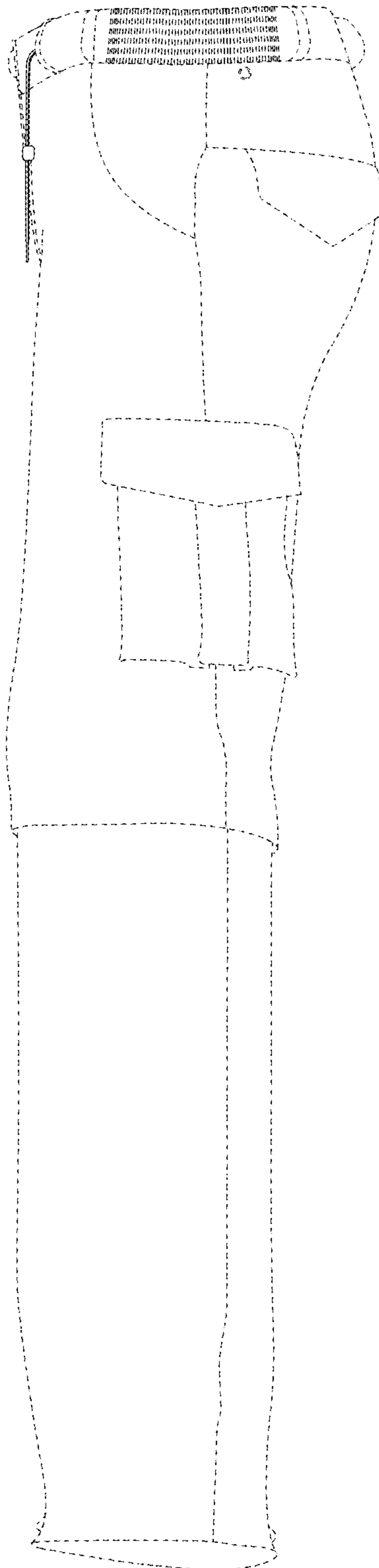

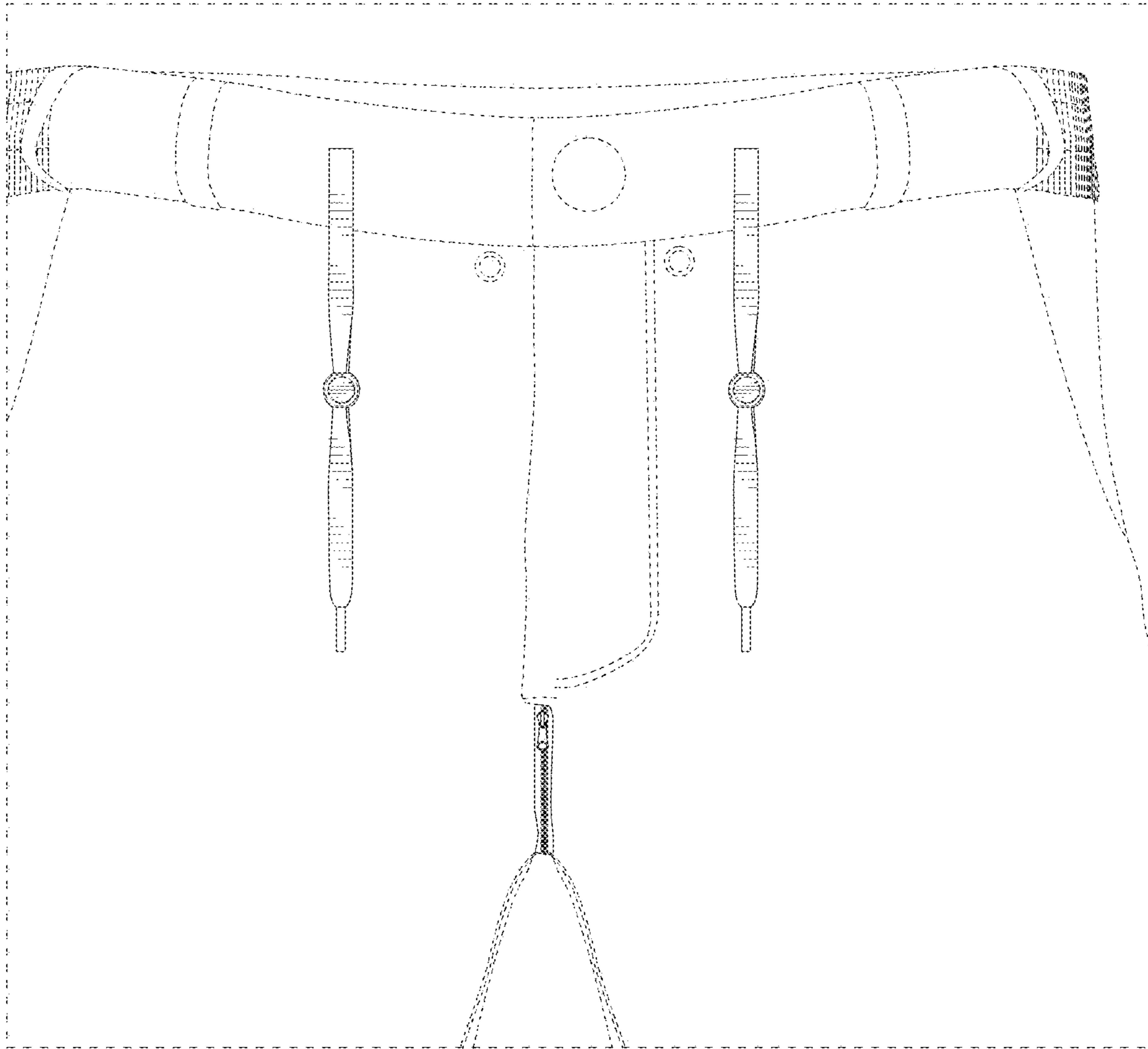

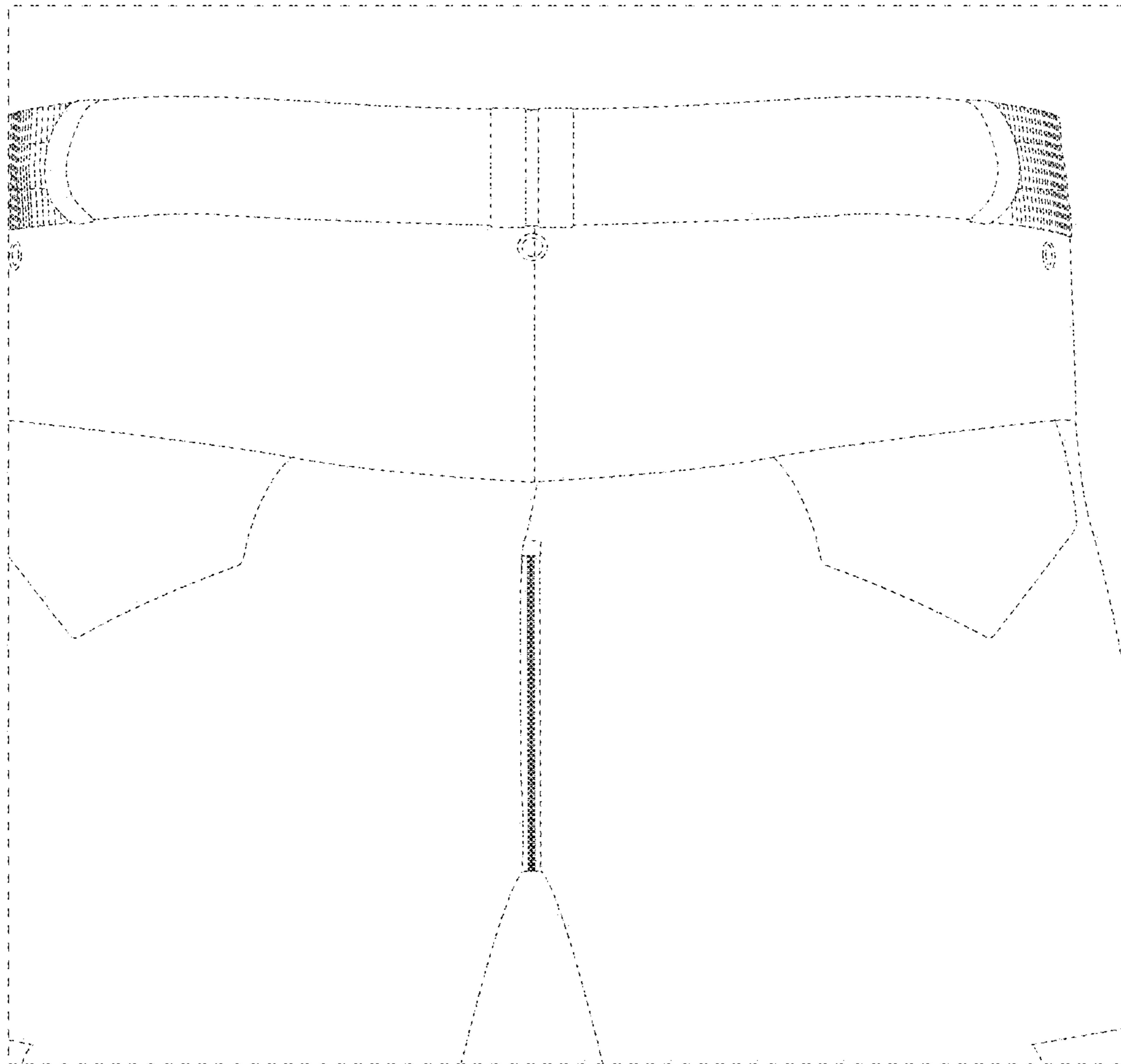

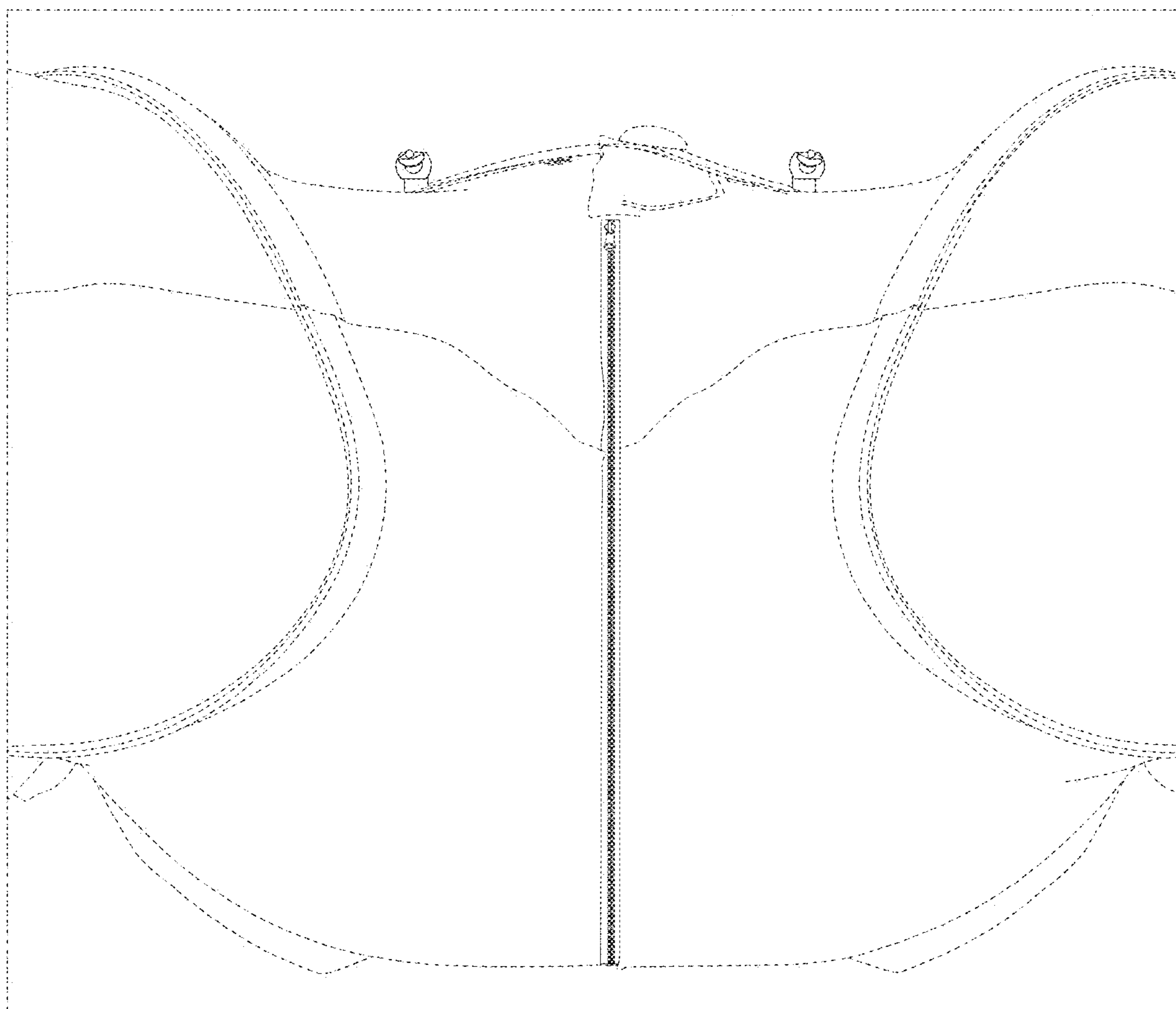

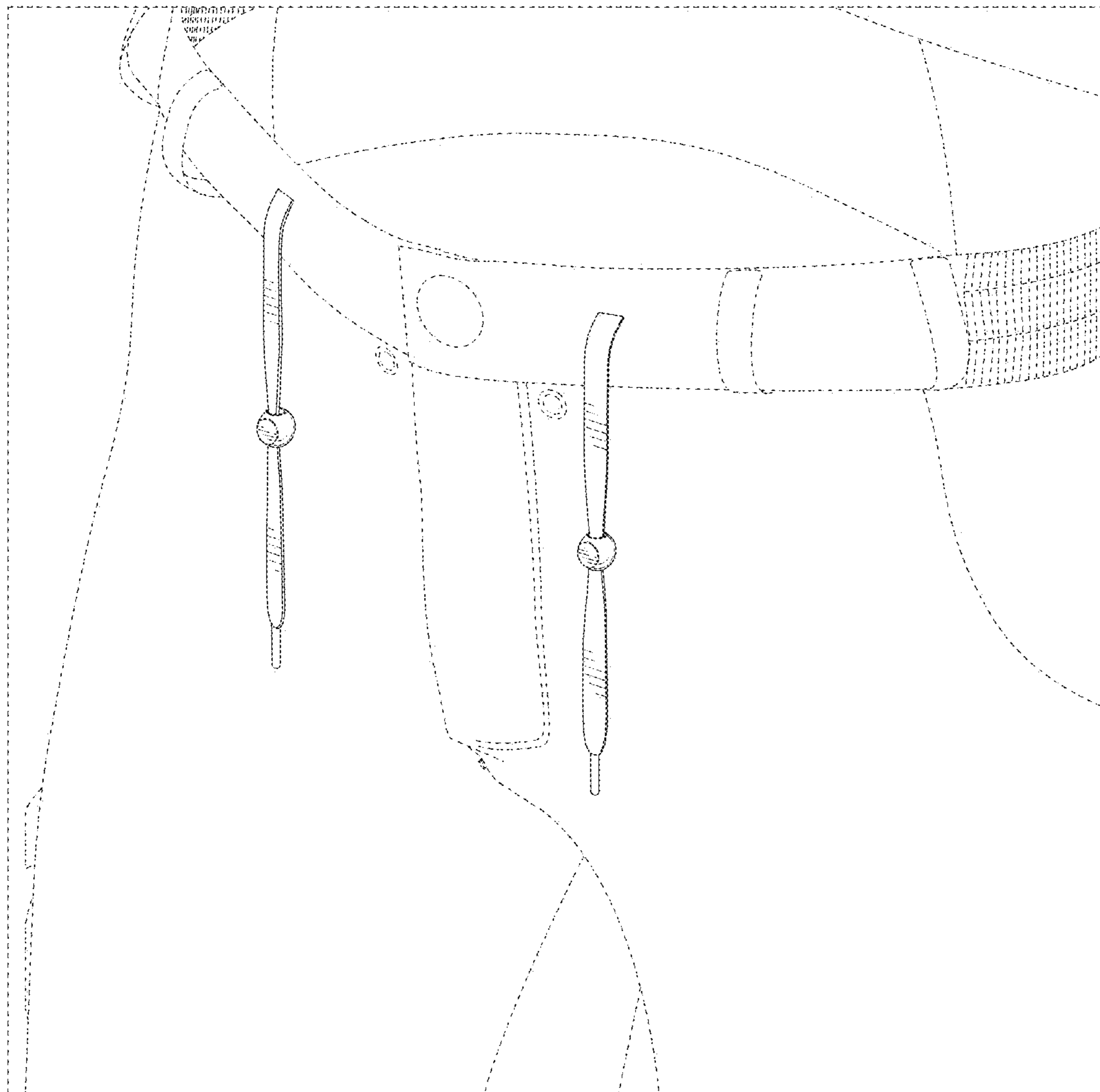

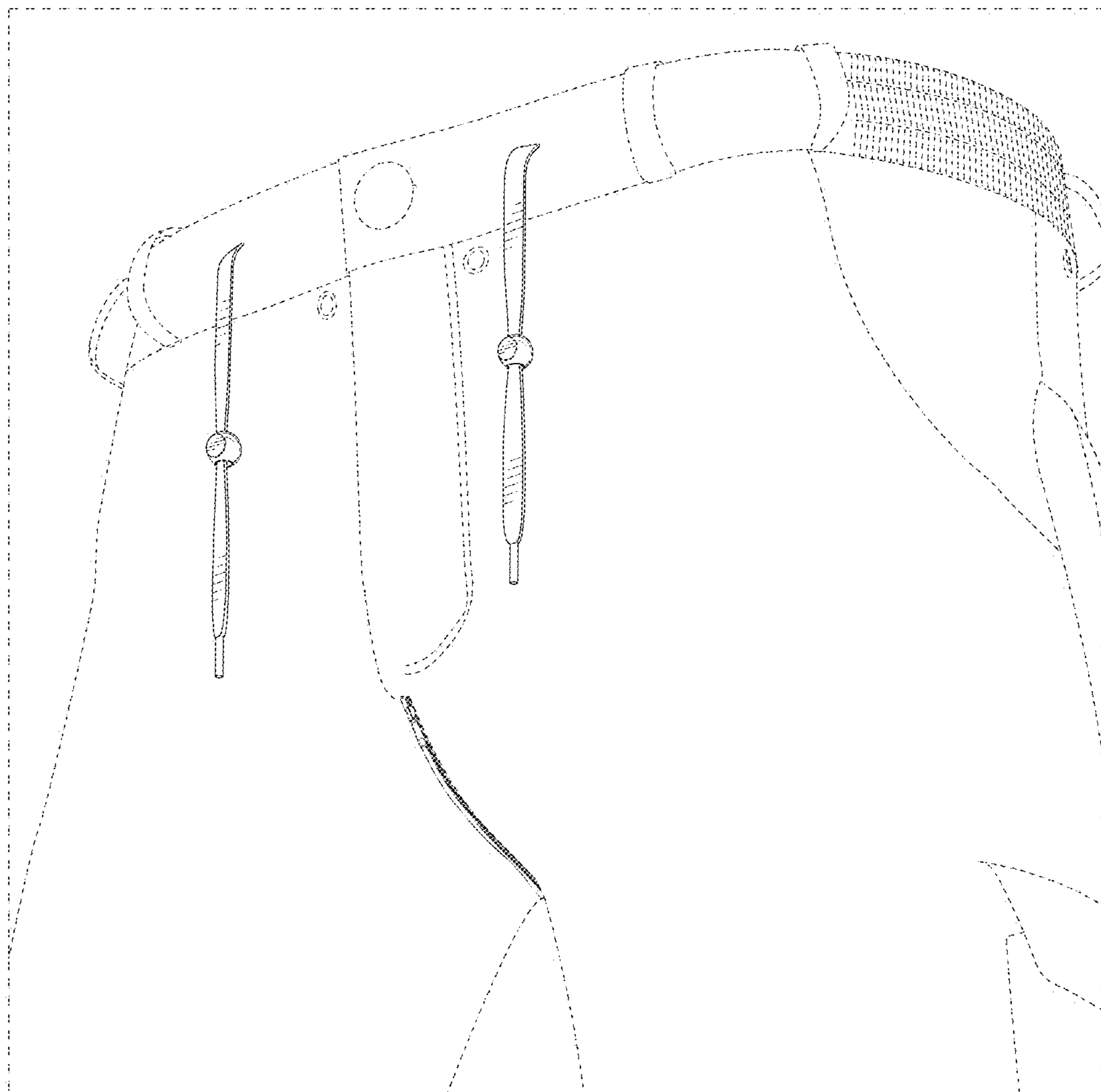
