The ornamental design for a beverage dispensing apparatus, as shown and described.

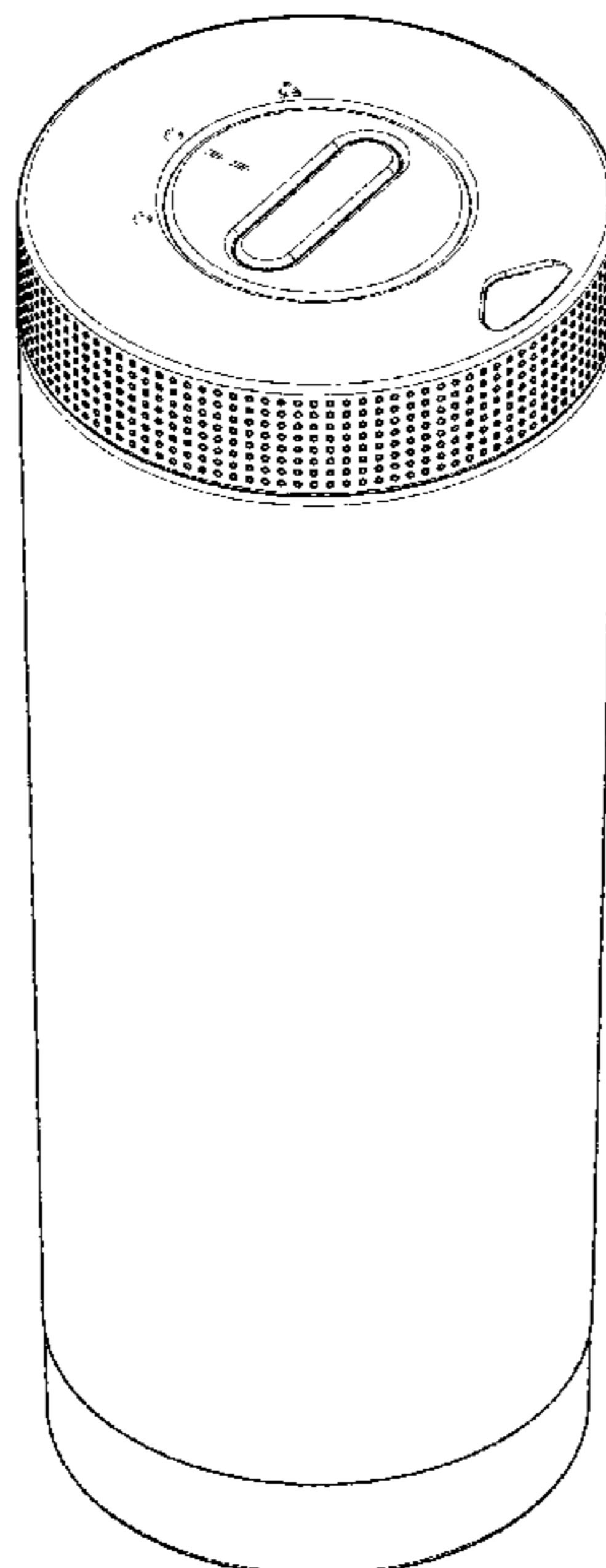
DESCRIPTION

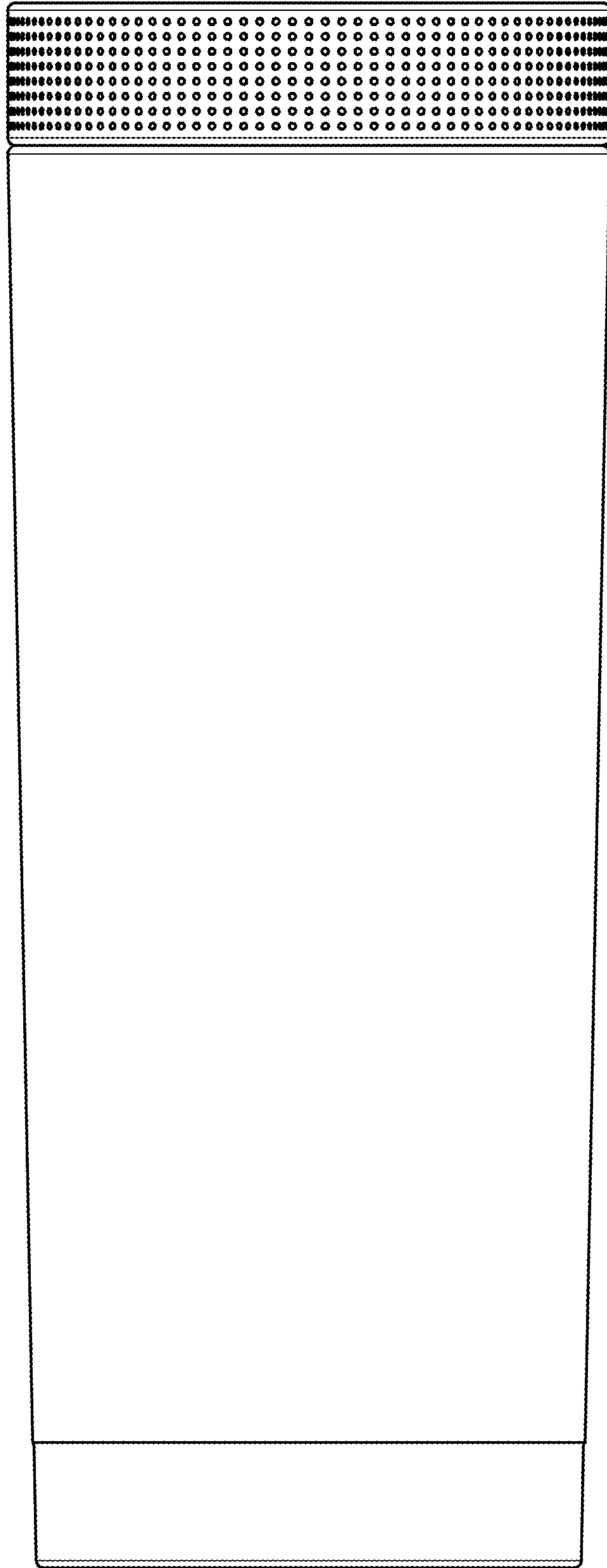

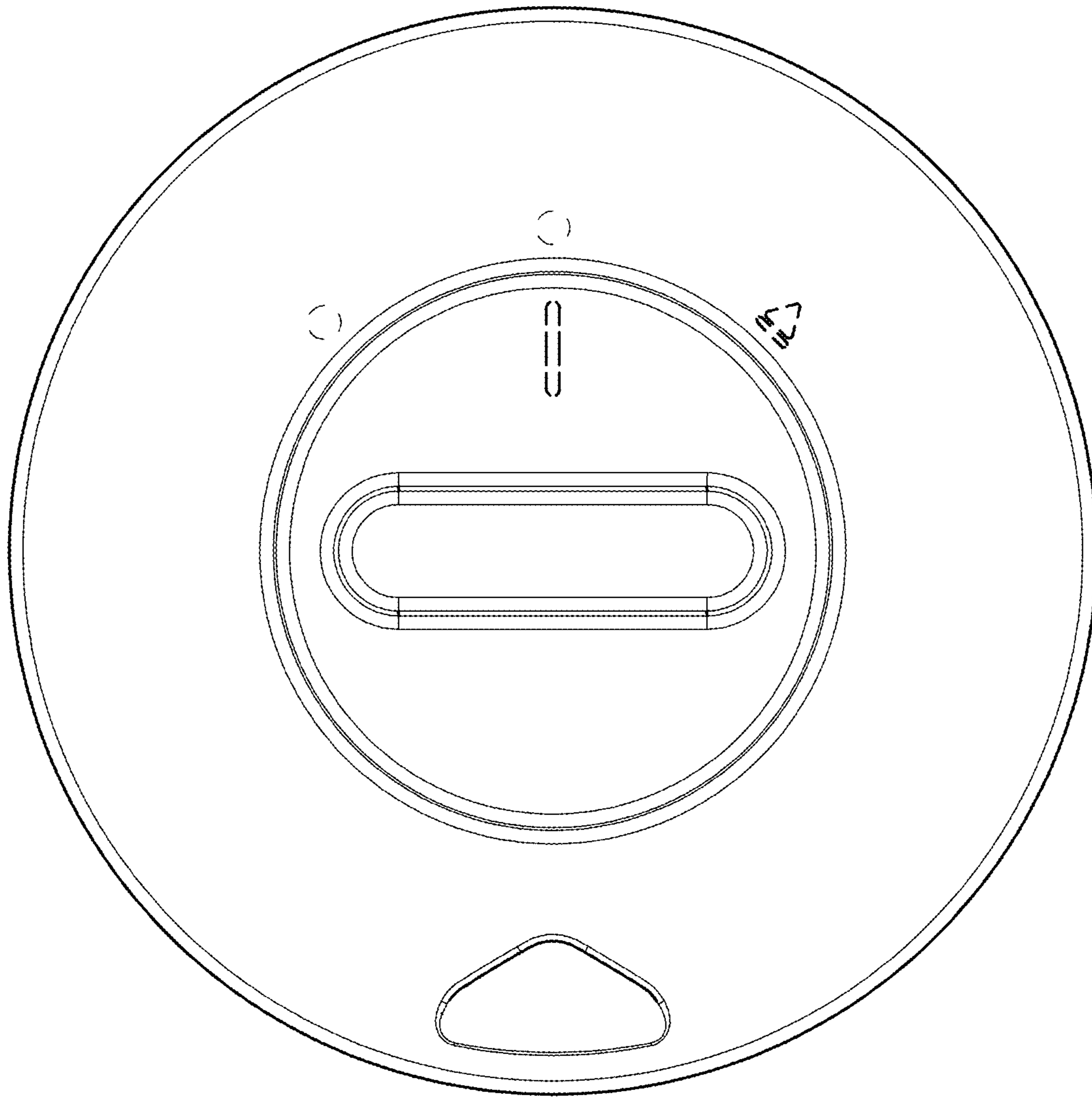

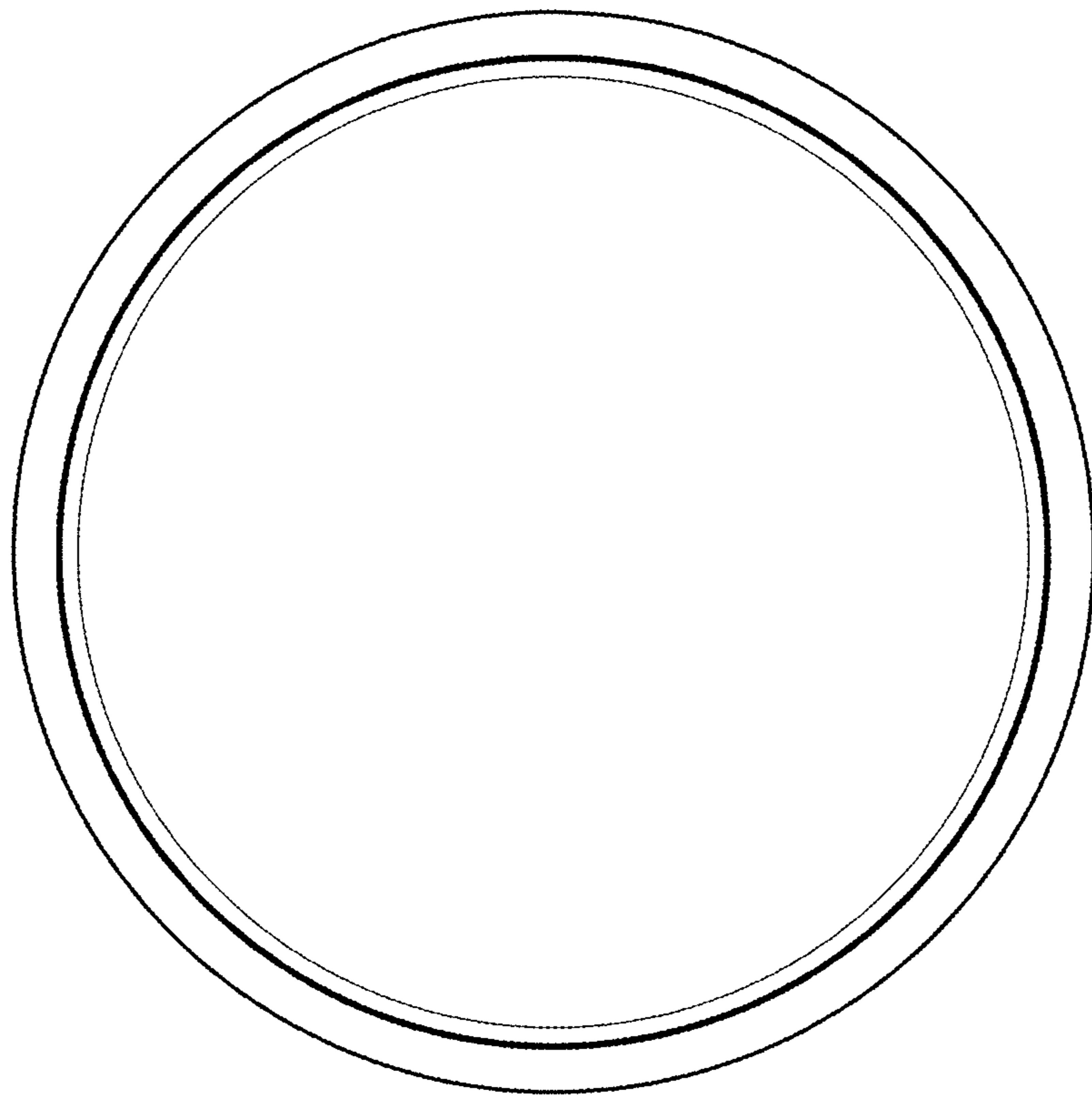

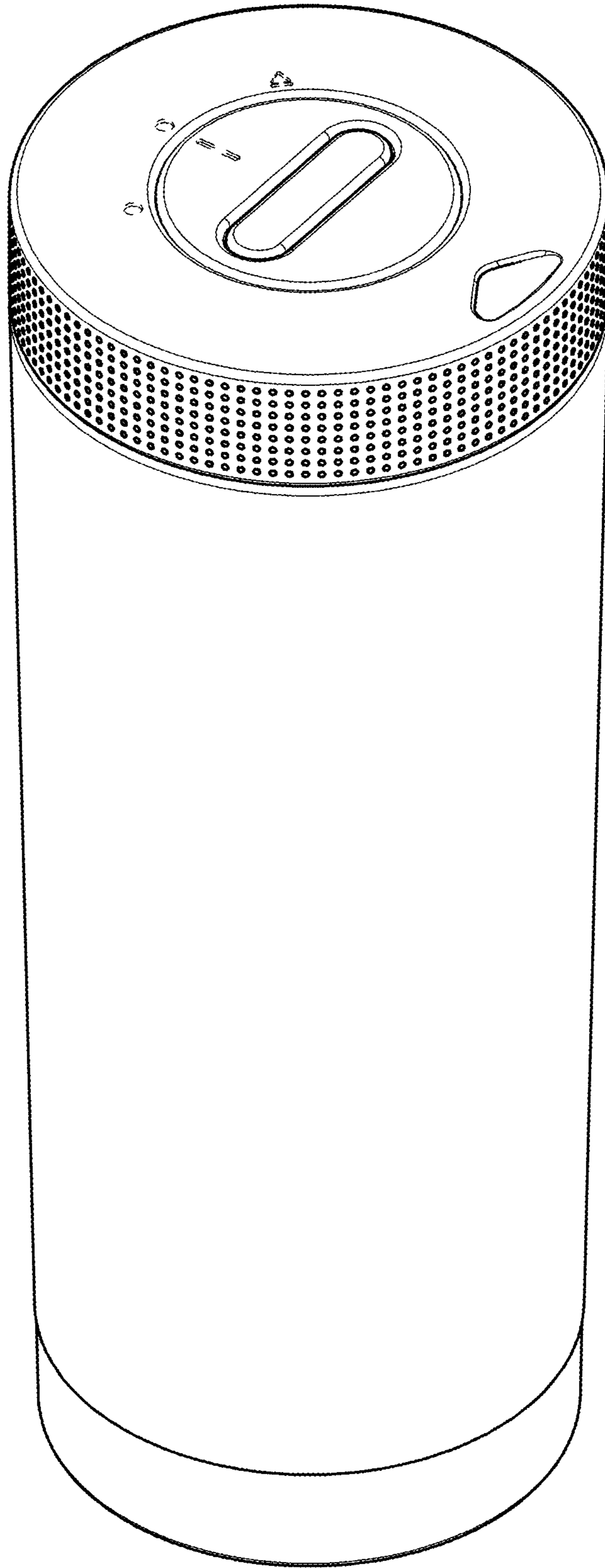
