DESCRIPTION

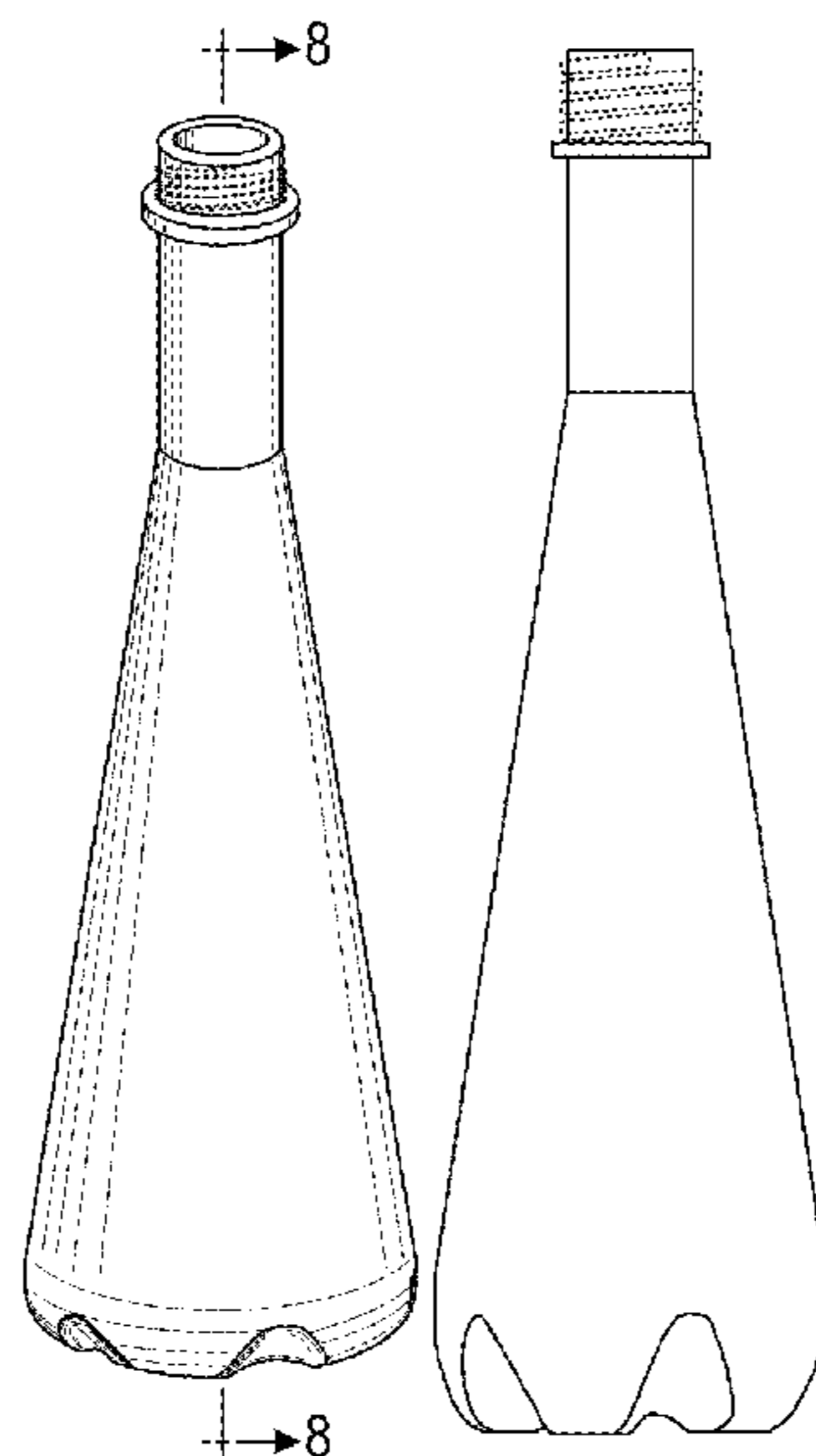
FIG. 1 is a top perspective view of a beverage bottle showing my new design.

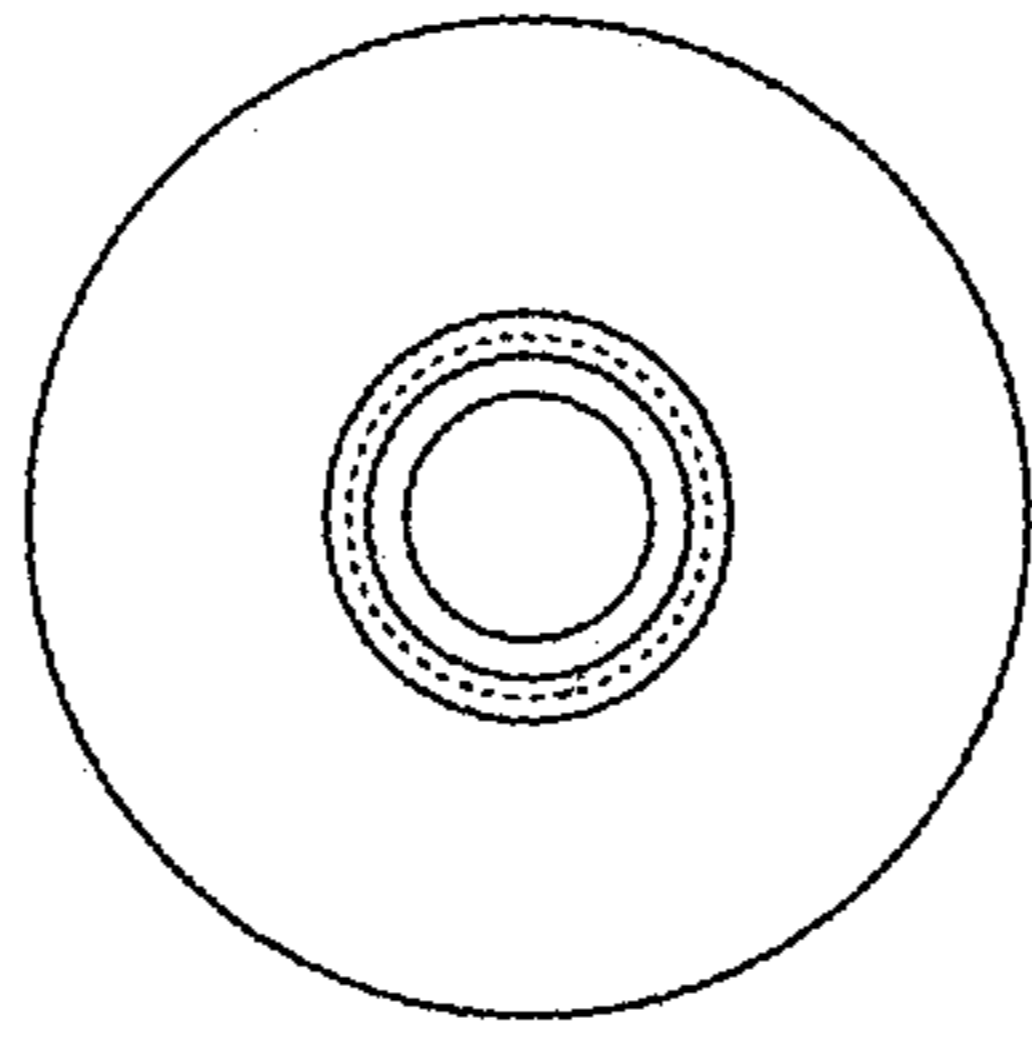

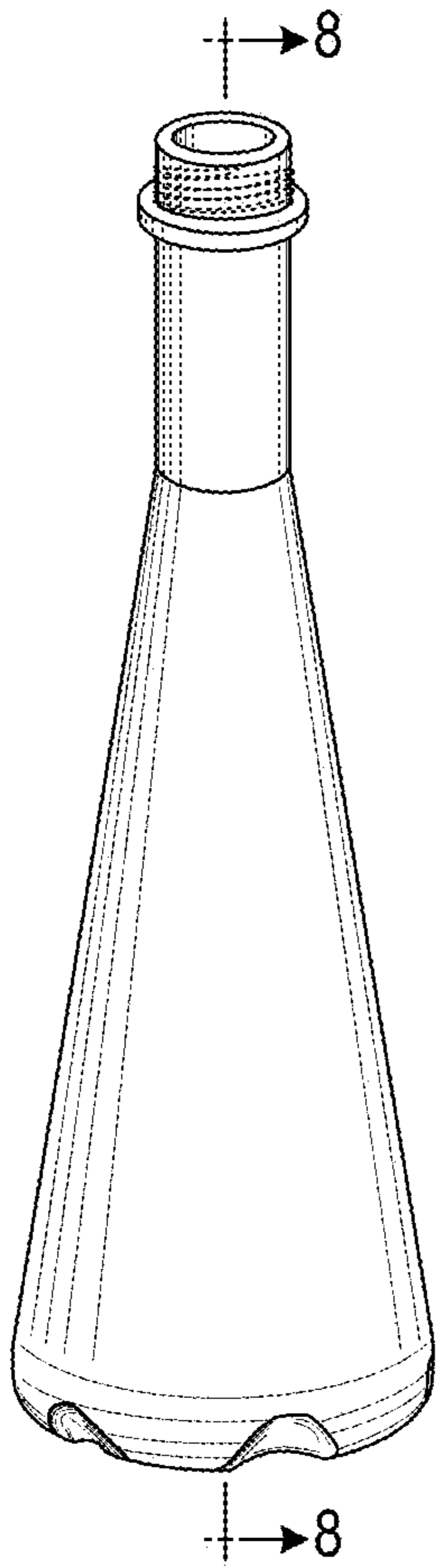

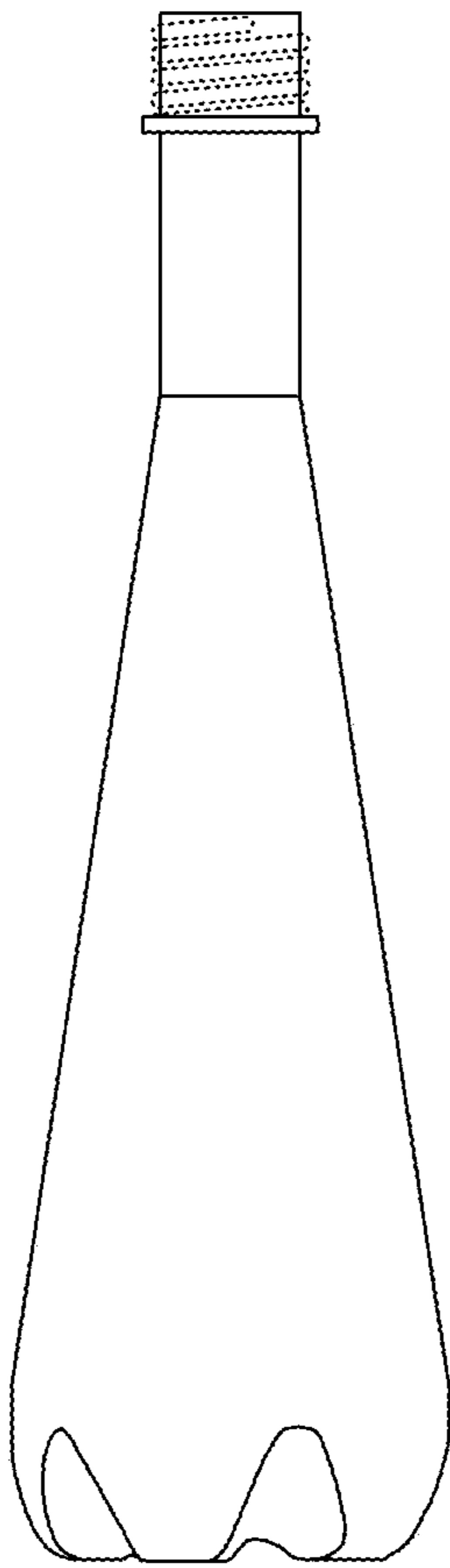

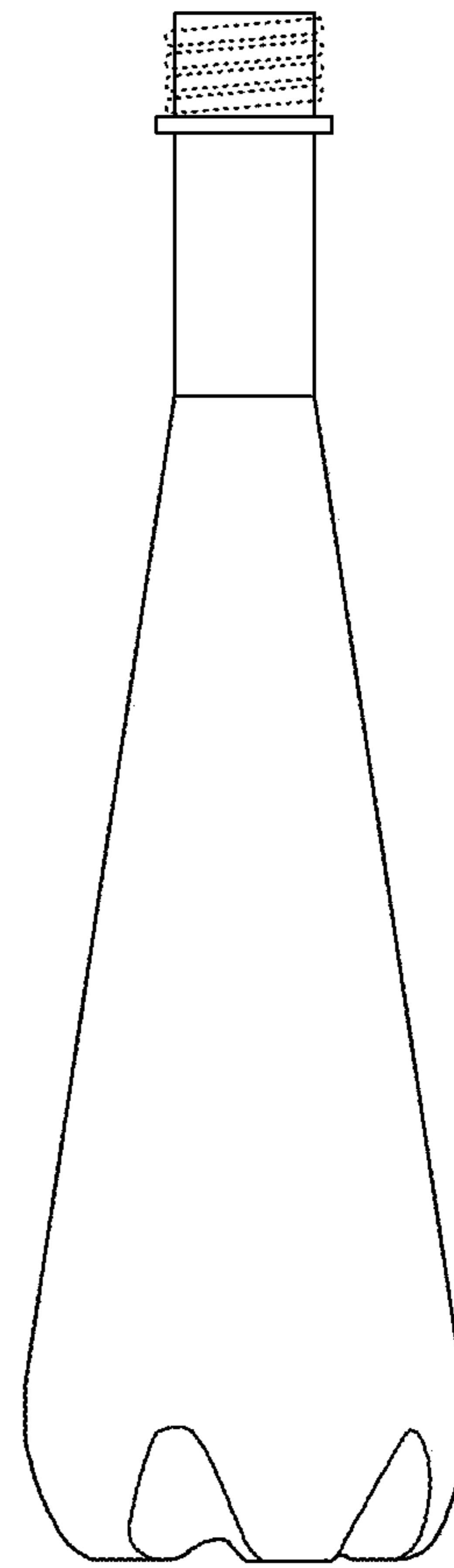

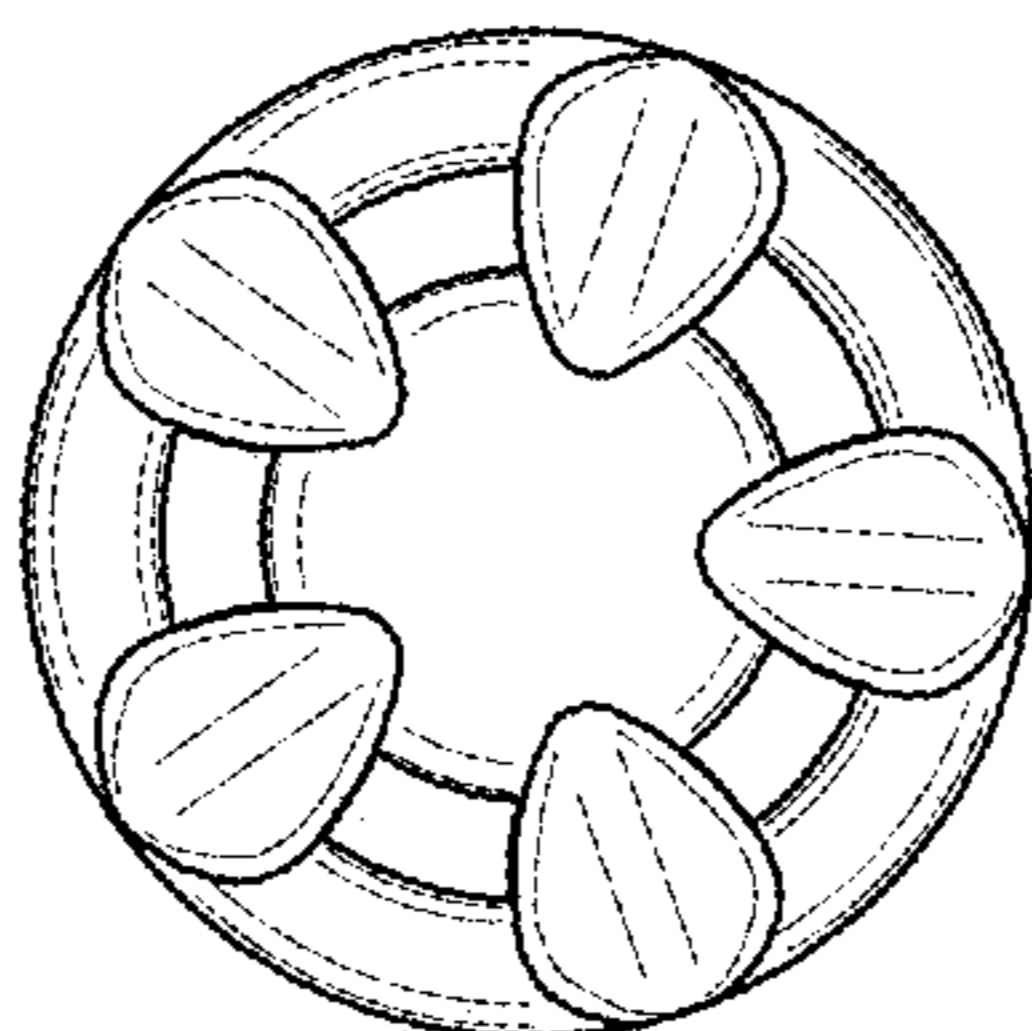

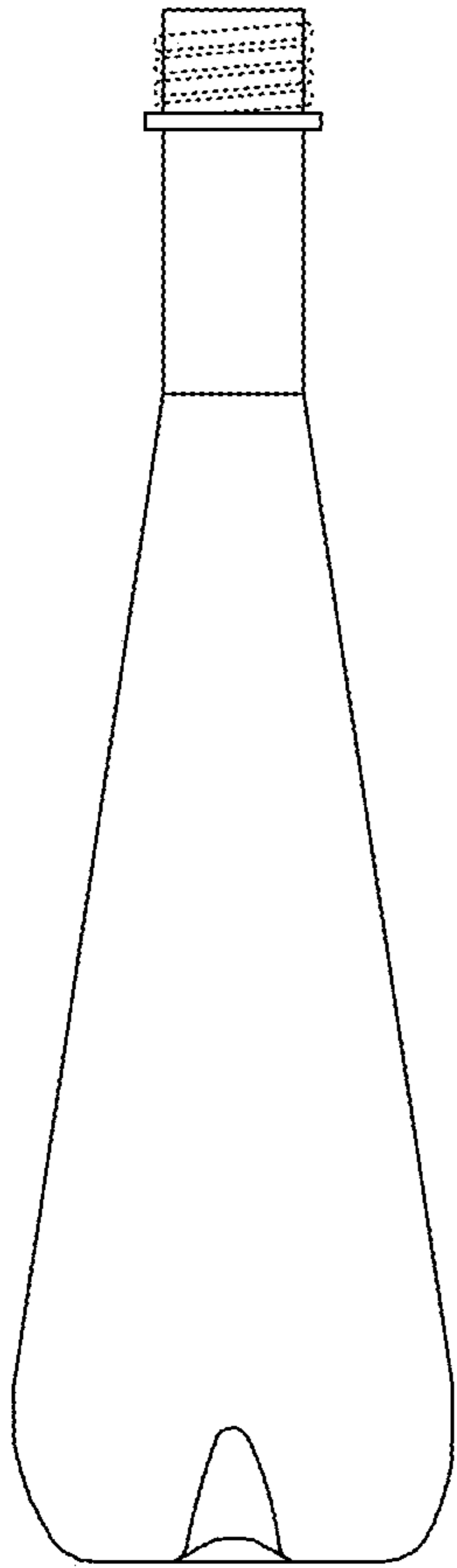

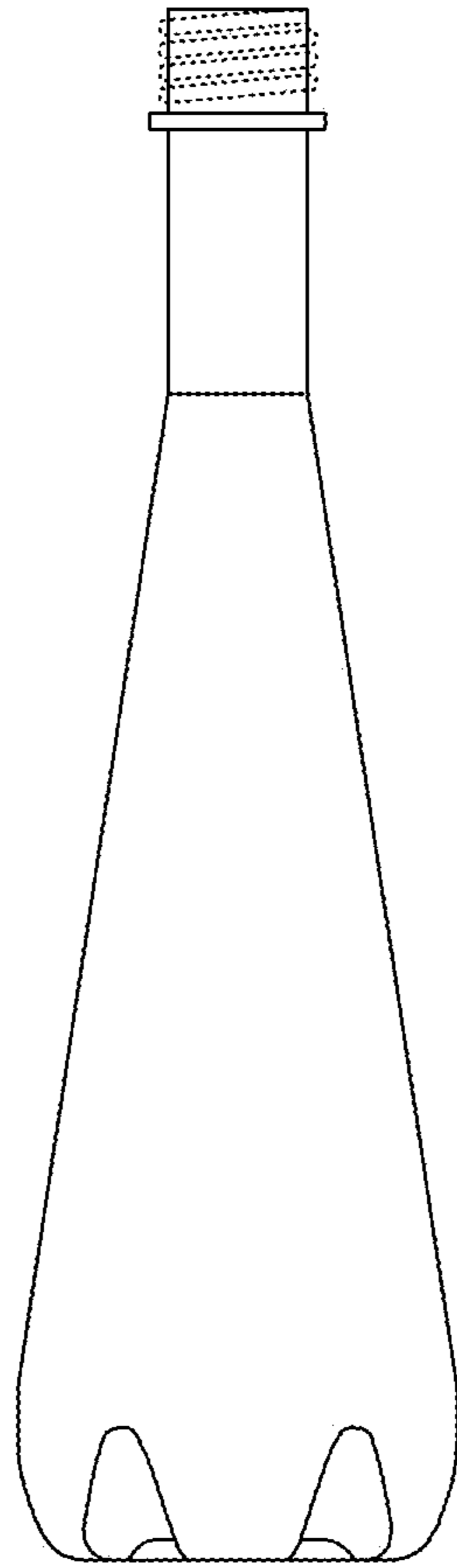

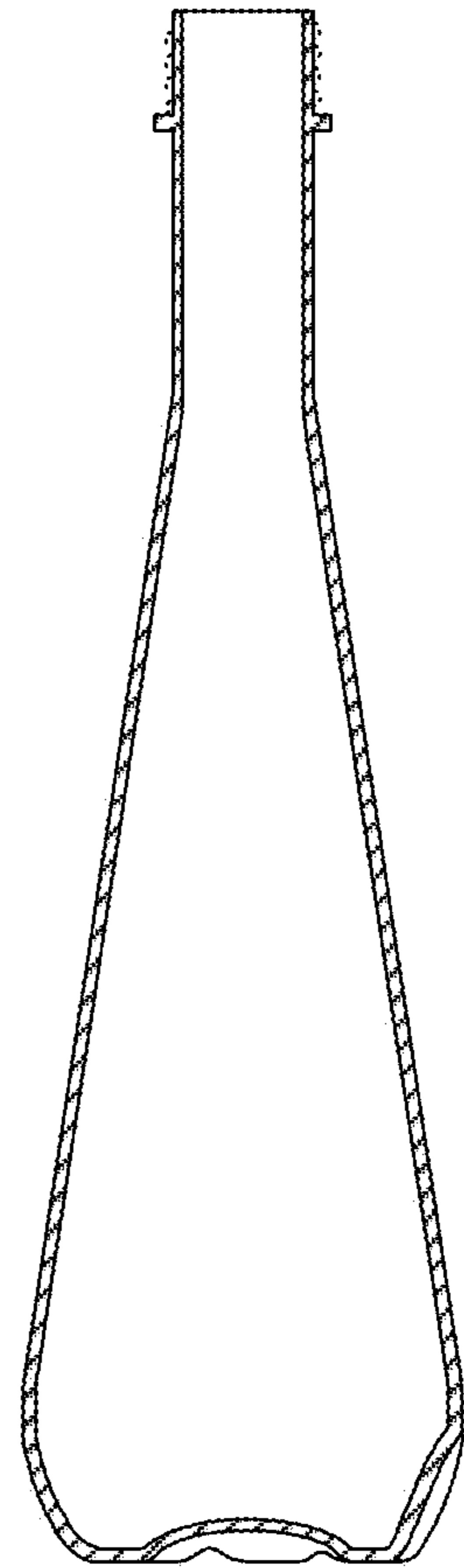
