The ornamental design for a magnetic bottle ring, as shown and described.

DESCRIPTION
FIG. 1 is a front perspective view of a magnetic bottle ring in accordance with the present design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational thereof;

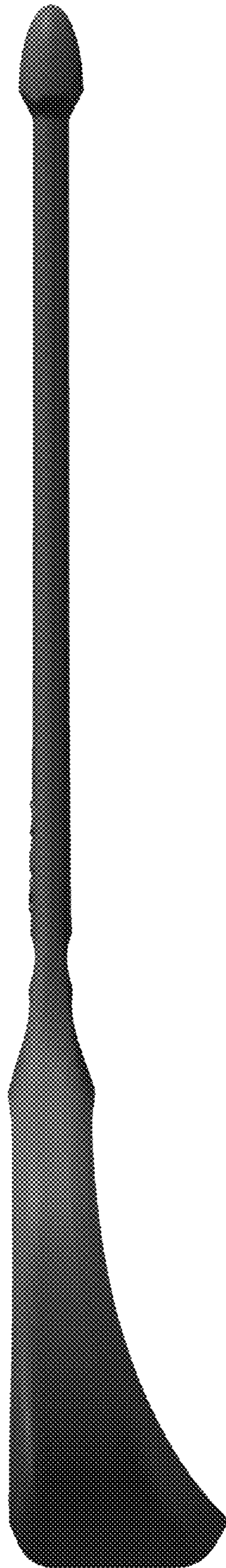

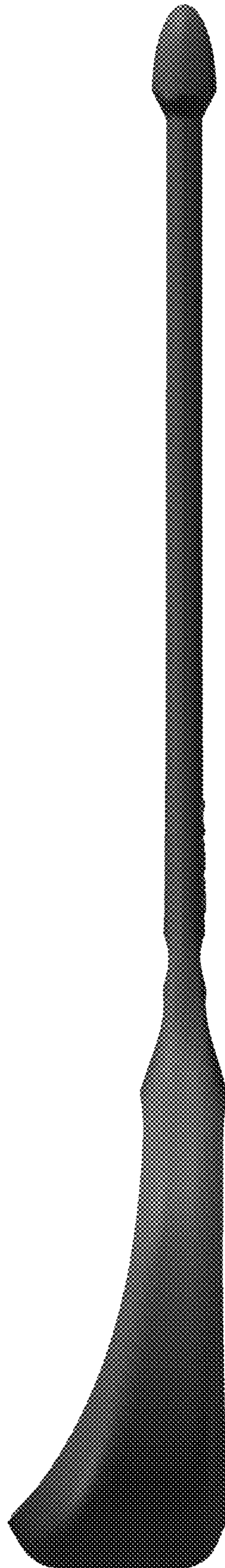

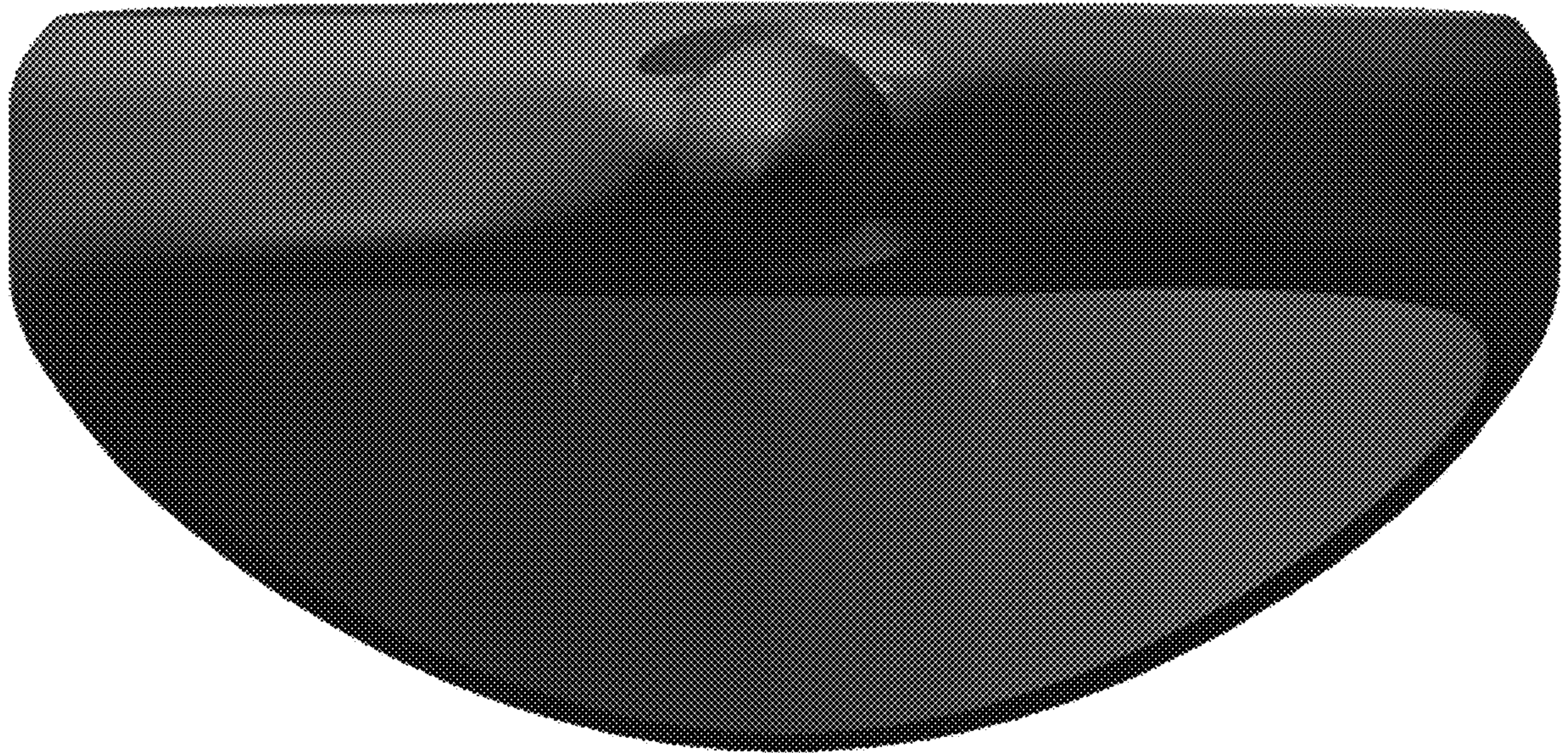

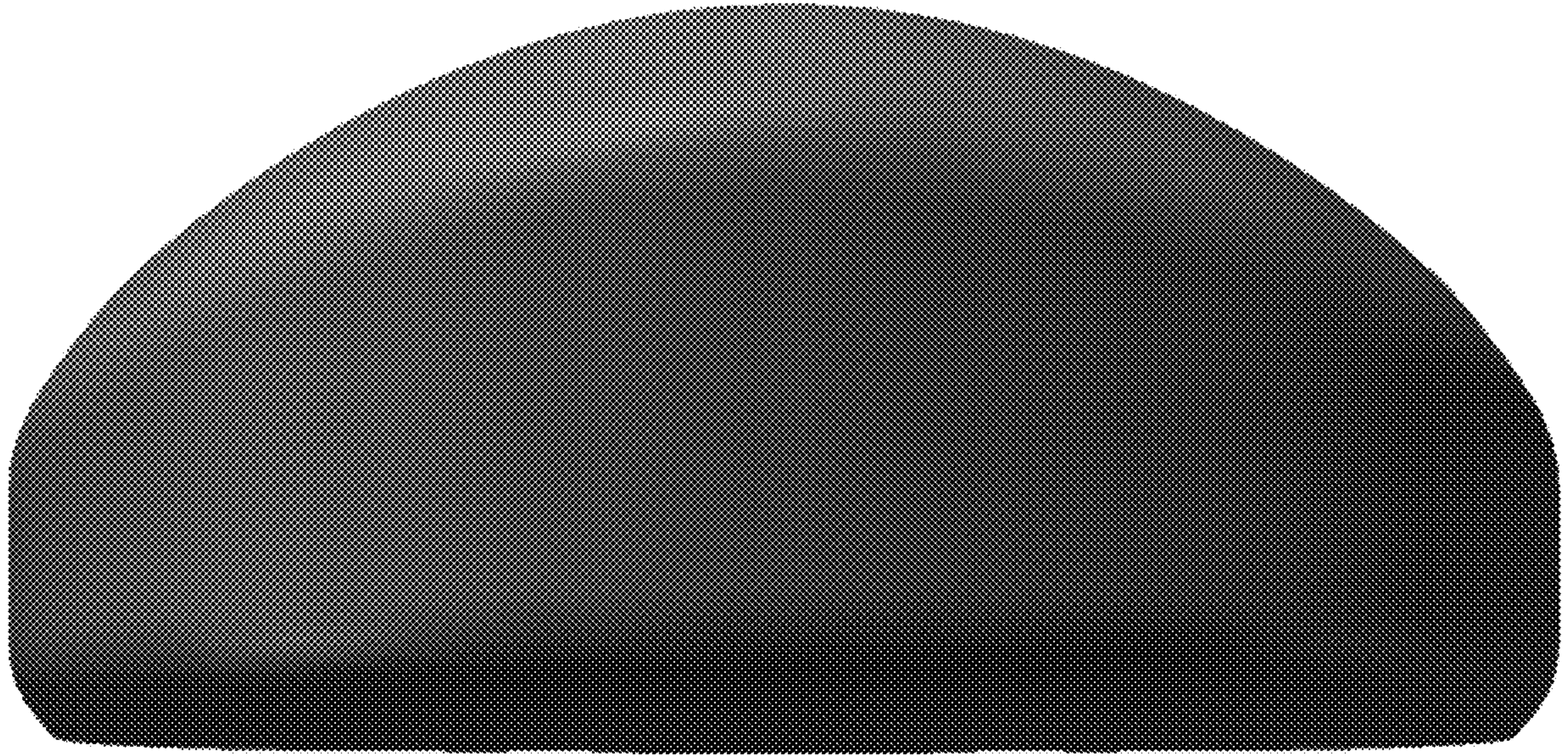
